DOZENS KILLED BY BOAT EXPLOSION AT NEW YORK

Price Situation For Better Grades of Leaf Continues To Improve

SALES STILL LIGHT HERE

Considerable Amount
of Common Tobacco
Offered for Sale
Today, But the Price
Trend for Better
Grades Continues to
Move Upward; Sales
Slightly Lighter
Yesterday

The first week of the 1932-1933
season of the Greenville tobacco
market was concluded today with
offerings still light and prices show-
ing renewed strength.

The market has made pronounced
advance each day since the opening
of the season last Tuesday in
view of the fact that considerable
common tobacco has been in evi-
dence each day.

Sales were again completed before
the noon hour today and the ware-
house floors were cleared in prepara-
tion for receipt of first offerings for
Monday.

Although the general market aver-
age for today was slightly less
than yesterday, this was said to
have been due to a large influx of
extremely common grades. Prices
for the better grades were said to
have shown a pronounced upward
trend.

The official report of sales this
afternoon gave sales as 227,194
pounds for \$23,167.25 at a general
average of \$10.20 per hundred
pounds.

Light sales are attributed to in-
stability of the farmers to prepare
their offerings for the market due
largely to unfavorable weather con-
ditions, work in cotton fields, and
a desire on the part of some to await
further development of the price
situation.

Compilation of sales extends from
Thursday to Thursday on this mar-
ket, and the official report of K. W.
Cobb, supervisor of sales, issued
early today, showed that the market
during the first three days sold
1,074,559 pounds of leaf for a total
of \$101,034.01 at a general aver-
age of \$9.40 per hundred pounds.

For the same period last season
the market sold 1,480,832 pounds for
\$108,798.85, at an average of \$7.34
per hundred pounds, the report of
the supervisor also indicated.

With the price situation showing
continued gain from day to day,
heavier sales were expected, on the
market next week. The market
is prepared to handle 1,750,000
pounds of leaf daily and this elimi-
nates the possibility of block sales.

POLICE SEEK OTHER WOMAN

Second Woman in Life of Berne Hoped to Be Able to Throw Light on Suicide

Los Angeles, Sept. 9.—(AP)—The
"other woman" in the life of Paul
Bern, brilliant film studio executive
and husband of blonde Jean Har-
low of the screen, was sought today
by police in hope she might throw
some light on his suicide.

Authorities expressed belief the
"mystery woman" is in Southern
California and may have figured
in events immediately preceding
the death of Bern last week-end
when he shot himself to death in
the Benedict Canyon home he oc-
cupied during his two months of
marriage to the actress.

Miss D. Millette, identified by the
Los Angeles Examiner as the "other
woman," checked out of a San
Francisco hotel Tuesday, the day
after Bern's body was found. She
had been registered at the hotel
since May 4.

For years the mystery woman
was known as "Mrs. Paul Bern."
She received a check regularly from
the director, the last check, accord-
ing to officials of the film studio
where he worked, being mailed to
her in San Francisco.

This "Mrs. Paul Bern," the "Miss
D. Millette of New York" who had
been staying in the San Francisco
hotel, and the Dorothy Millette
named by Bern in a will in 1929,
the Examiner identified as one and
the same person.

INDICT THREE IN BANK CASE

Durham, Sept. 9.—(AP)—Three
former officials of the defunct First
National Bank of Durham were
under indictment today on charges
of violating the bank laws.

W. J. Holloway, who was president
of the bank, was indicted by the
federal grand jury on seven
counts of misapplying funds and
making false entries. Approximately
\$100,000 is involved in the alleged
irregularities.

B. C. Proctor, cashier of the
bank, was indicted for embezzle-
ment and false entry. Both he and
Holloway were released under bonds
of \$5,000.

THREE KILLED IN AIR MISHAP

Two Fliers and Pas- senger Meet Death As Plane Crashes Into Mountain Side

El Paso, Texas, Sept. 9.—(AP)—
Tightening of his safety belt saved
George J. Davidson's life while his
three companions on an airplane
trip were burned to death when the
ship struck the side of a mountain.
Pilot W. J. (Bryant) Robbins of
the American Airways, his co-pilot,
Francis W. Briggs, and Victor El-
man, of St. Louis, a passenger, as
was Davidson, were killed. The
plane, wrecked yesterday morning,
was found early today by two other
American Airways pilots, Ira Mc-
Conaughy and Victor Miller.

Davidson, who lives in Richmond,
Calif., was burned on his hands and
face, but suffered no serious in-
juries.

The searchers found him about
two miles from the plane in the
Guadalupe Mountains, seventy-five
miles east of El Paso.

He said he was nervous as Rob-
bins tried to pilot the plane over

PITT SCHOOLS OPEN SEPT. 19

General Teachers Conference Will be Held at High School Here Friday, 16th

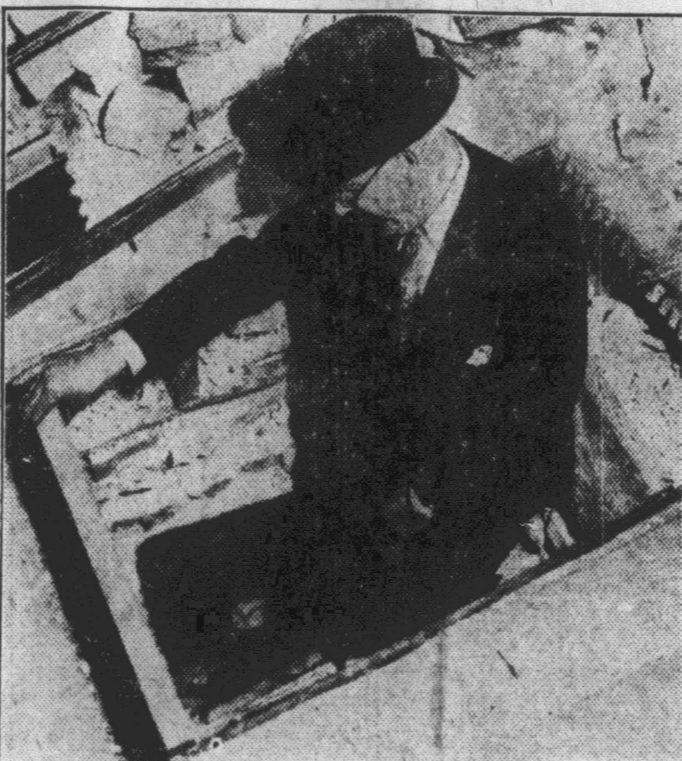
In spite of re-organization of the
transportation system in all parts of
the county, Pitt County schools will
begin work Monday, September 19,
with prospects of one of the best
sessions in history. D. H. Conley,
Director of Public Instruction, said
today.

The opening of the schools will be
preceded by a general teachers' con-
ference at the high schools here Fri-
day, September 16. At this gather-
ing preliminary plans looking to or-
ganization of the various schools will
be discussed, and when the teach-
ers return to their respective com-
mittees they will be fully pre-
pared to take up their duties and
carry on to a successful conclusion.

Nineteen institutions, involving
the largest schools of the county sys-
tem, are involved in the opening as
well as four six months' schools. The
larger institutions will operate for
the usual term of eight months.

As result of decreased appropria-
tions for transportation, it has been
necessary to re-organize the opera-
tion of trucks in many localities,
and the public has been urged by
Mr. Conley to co-operate in every
way possible to avoid unnecessary
mileage.

Republicans Turn Faces to East, Democrats West

Washington, Sept. 9.—(AP)—Bat-
tle lines for the Presidential cam-
paign still are far from complete,
but the present week has produced
signs that the Republicans are turn-
ing their faces a little more defini-
tely toward the East, while the Demo-
crats incline a little more surely
toward the West.

Of course, neither side has at all
abandoned hope of endeavor in
either East or West, but the present
phases of the struggle, considered
alone, show three interesting devel-
opments.

N. Y. MARKETS MAKE GAINS

New York, Sept. 9.—(AP)—The
financial markets recovered moder-
ately today, after yesterday's set-
back.

Cotton, which broke about \$5 a
bale yesterday, recovered nearly \$1
and the stock market, after some
further selling in the morning, turned
upward before midday.

By early afternoon several promi-
nent stocks rose \$2 to \$3. Ameri-
can Can rose \$3 to above \$62;
American Telephone \$2 to \$118;
Bethlehem Steel, \$20 to \$27; U. S.
Steel, \$15 to above \$50; Union Pa-
cific, \$2 to \$81, and Southern Pa-
cific, \$2 to \$32. Coppers were heavy
in the early trading and failed fully
to recover losses to \$1 to \$2 a share.

Despite yesterday's setback in cot-
ton it was reported in the textile
trade that mills were holding to the
higher prices for cotton goods, and
felt that their prices could be main-
tained, in view of the large volume
of business done recently, and the
improved statistical position of the
industry. The decline in raw cotton,
however, was followed by an abrupt
falling off of demand in the cotton
goods market.

TRAIN KILLS COUNCILMAN

Charlotte, N. C., Sept. 9.—(AP)—
A delayed schedule of the Crescent

RESCUE WORK IN PROGRESS

Thirty - seven Killed Outright as 92 - Foot Wooden Steamer Bearing Iron Work- ers to New Island Penitentiary is Com- pletely Shattered by Blast; Nothing Left of Vessel But Debris Floating on Oily Water; Police and Coast Guard Rush to Rescue

New York, Sept. 9.—(AP)—A
ferry carrying some 200 iron work-
ers from the Bronx to their work
on the new Rikers Island peniten-
tiary in the East river was blown
to bits by a boiler explosion today,
killing dozens and injuring many
more.

Within an hour 25 bodies had
been recovered. An hour later the
number had risen to 37. Half a
hundred were still unaccounted for
and practically all the rest were
injured.

The ferry, the 92-foot wooden
steamer "Observation," had already
made one trip to the island from
the 135th street dock when the ex-
plosion occurred and people ashore
were stunned by a terrific roar. The
ferry disappeared in a dense cloud
of smoke from which catapulted
bodies and fragments of wood and
iron.

When the smoke cleared there
was nothing left of the boat but
debris floating on the oily water.

Police, coast guard and commer-
cial boats flocked to the scene and
joined in saving the injured and
transporting the dead to shore.

Priests came to the ferry house
and kneeling among the rows of
dead administered last rites to the
dying.

Police Commissioner Edward P.
Mulrooney and Bronx District At-
torney Charles McLaughlin were
early on the scene and directed the
rescue work.

One workman, Ted Maureau, was
saved by his tardiness. He arrived
at the dock just a minute too late
to make the ferry and was stand-
ing watching it when it exploded.
He helped in the rescue of his fel-
low workers.

Captain Joseph Rogers of the
municipal ferry "Greenwich Vil-
lage," gave a graphic account of the
explosion.

"I heard a blast and saw the boat
blown to smithereens," he said.
"When the clouds of smoke and
steam had cleared away we could
see the passengers struggling in the
water over a large area. Our ferry
was in its slip at East 134th street
at the time, just two blocks from
the pier where the Observation had
backed out into the water.

"We lowered the lifeboats on our
ferry and cruised about among the
wreckage. We picked up four bodies
and ten injured persons. Other peo-
ple were putting out in small boats
and they also picked up bodies and
the injured."

Commissioner Mulrooney com-
mented that it was at this same
ferry dock that in 1904 he arrested
the captain of the excursion steam-
er General Slocum, which sank in
Hell Gate with a loss of 1,021 lives.

All witness of the explosion of
the Observation were taken by
police stations for questioning.
Among them was George Forsythe,
captain of the ferry and son of its
owner.

"The boilers exploded," he re-
peated over and over, and that was
the only explanation he had to
offer.

Warden Frederick Morehead of
the penitentiary said he had re-
ports that at least 20 bodies were
laid out on the Bronx shore and
that about 60 men were still un-
accounted for.

Warden Morehead said that no
city employees were on the Obser-
vation, all the men being employes of
the contracting firm which was
building the new penitentiary. Most

OPEN INSTITUTE AT CHAPEL HILL

Problems of Government to be Discussed at Session to Begin Tonight

Chapel Hill, N. C., Sept. 9.—(AP)—The formal opening of the Institute of Government, first projected in a meeting of 300 public officials and citizens on May 6, will be held here tonight.

For the first time in the history of the State twenty-three groups of public officials representing the interlocking, overlapping and conflicting interests of town, township, county, special district, State and Federal governmental agencies in North Carolina, will meet to discuss co-ordination of efforts of the various governmental agencies in administration.

In May the institute was formed for the continuous study of the structure and workings of government in the various governmental units of the State and the meeting tonight will mark the official opening of the group.

Roscoe Pond, dean of the Harvard University Law School, and for years one of the foremost leaders in America legal education, will speak before the group Saturday.

He will talk informally to various groups of governmental officers in private sessions, and then will address the institute as a body around noon. He will speak again in the afternoon.

Among State figures who have signified their intention of being present are A. J. Maxwell, Commissioner of Revenue; Dennis G. Brummitt, Attorney General; Judge John J. Parker, of the United States Circuit Court of Appeals; Senator J. W. Bailey; Judge Johnson J. Hayes, of the Federal District Court; Frank P. Graham, president of the University of North Carolina; and Chief Justice W. P. Stacey, of the Supreme Court.

ILLNESS WILL NOT KEKPE BABE OUT OF SERIES

By HERBERT W. BARKER (Associated Press Sports Writer) New York, Sept. 9.—(AP)—All's not well with Babe Ruth's appendix but baseball's only \$75,000-a-year performer probably will be able to steer clear of the operating table until after the world series at least. An examination revealed symptoms of appendicitis but the Babe's personal physician, Dr. Edward A. King, said his preliminary diagnosis indicated there was no necessity for an immediate operation.

As a precaution, however, Dr. King ordered Ruth to bed for 24 hours, preliminary to another and more conclusive examination when definite decision will be reached on the question of an operation.

Barring a change for the worse in the New York Yankee slugger's condition, it appeared likely Ruth would be fully recovered in a few days and certainly in time to participate in his tenth world series, assuming the Yankees win the American League pennant.

For a time it appeared as though Ruth's latest ailment would assume even greater proportions, from a headline standpoint, than his famous illness of 1925 when he was stricken with the "tummy ache that was heard around the world." At that time, however, he came back to New York on a stretcher, a victim of influenza and indigestion. He detained yesterday under his own power.

By HUGH S. FULLERTON, Jr. (Associated Press Sports Writer) Back in the long lean years, those our seasons from 1927 through 1930 when the National League champions couldn't win a world series and seldom could win a game in the great October classic, the explanation often was advanced that the close races in the senior circuit took too much out of the winners and left them easy prey for the American leaguers.

The same contrast comes up again this year as the National League race goes down the home stretch with seven teams still mathematically in the running while only three are left in the American, two of them with only the slimmest kind of a chance to overtake the New York Yankees.

After checking in with a 14-inning victory and a seven-inning tie in a long duel with Detroit yesterday, the Yanks reached the point where they need only four victories for themselves, four defeats for Philadelphia and Washington or any combination within that figure to clinch the pennant. At the same time the Chicago Cubs, leading Pittsburgh by 5-1-2 games with 18 to go, have to work on a 13 game basis to make it a certainty.

The perils of the season's last road trip affected the leaders in both circuits yesterday. The Yanks had to go five extra innings in the first game before they put over two runs to defeat the Tigers 6 to 4 and darkness stopped them in the seventh inning of the second clash with the score tied at seven-all.

Philadelphia's Athletics lost a precious game to Cleveland as Clint Brown held them to four hits to get a 2 to 1 decision over Lefty Grove. Another four hit performance, with Monte Weaver doing the flinging to ring up his 20th victory of the season, enabled Washington to turn back the St. Louis Browns, 3 to 1 and keep pace with the Yanks.

In the fourth American league contest, Ted Lyons, Chicago veteran, pitched a fine ten-inning game and then scored the winning run himself for a 4-3 victory over the Boston Red Sox.

A divided doubleheader with Boston added a half game to the Cubs' lead as Pittsburgh took another one on the chin from Brooklyn. Charley Root's six-hit hurling and a big eighth inning gave Chicago a 4-1 victory in the opener, but Bob Brown duplicated the sixth hit feat for Boston in the nightcap and a homer by Wally Berger led to a 3-2 triumph.

Pittsburgh couldn't approach Brooklyn's hitting feats and was buried under a 12 to 2 score.

A circuit drive by Don Hurst with two on base in the first inning gave the Phillies a 3-0 victory over the Cardinals in the only other National League game as Ray Benge limited the 1931 champions to three hits.

SPORTS SLANTS

The move to eliminate boxing from the program of Olympic games, while it may consist merely of earnest conversation in the official family, has gathered more momentum than ever before, due to a long series of controversies.

Boxing, of course, is a controversy to start with, no matter what shade of animosity may be displayed by the combatants or non-combatants.

It has been the cause of several of the most unfortunate incidents of the last three sets of international games.

Clout for Courtesy It involves a wide range of differences in rules as well as judgment. In Germany, for example, it is the custom among amateur boxers, after being separated from a clinch by the referee, to shake hands before they resume sparring.

The Olympic rules do not sanction this much courtesy, but one Campe, a good lightweight from Germany, reverted to native habits in the final bout and got a stiff clout on the ear for his politeness from a South African named Stevens.

Stevens won the decision and the Olympic title. Campe came out to receive hospital treatment for a dangerous injury. Under the Olympic scoring system of figuring a 25 point maximum for each man in each of three rounds, many baffling results are obtained.

Improvement Possible Judges and referees, all participating in the verdicts, represent many different nationalities. Rules and customs, as well as viewpoints, differ accordingly.

Much as the International Boxing Federation has sought to reconcile these various competitive interests, it has been unable thus far to prevent controversies. It would seem, however, that the job can be better done.

It would, of course, be a rank confession of weakness to toss Olympic boxing verboard, entirely, rather than seek uniformly acceptable methods and regulations, understandable to all officials as well as fair to all participants.

On this account, the fistie sport seems likely to survive the aftermath of dissatisfaction, left by the 1932 Olympics, but the settlement of differences should not be left to the week before the 1936 games at Berlin.

(Continued from page one) before passing out to sea. The winds were born of a tropical disturbance whose center struck the northern portion of Abaco Island of the Bahamas group Monday. Communications with Abaco have been out since, and government officials feared there may have been loss of life on the island. A government tender, carrying doctors, nurses and medical supplies, left Nassau, Bahamas, last night for the island community. The tropical disturbance moved northeastward through the Atlantic after roaring across the Bahamas at an 80-mile clip and was centered last night about 450 miles east of Washington and 250 miles south of Nantucket.

THE EDGES OF THE STORM STRUCK

the New England coast yesterday and during the night coastal shipping was held up in New England ports from Block Island, R. I., to Eastport, Maine. A 60-mile wind piled scores of pleasure craft on the beaches of Massachusetts' south shore, and Cape Cod and shell fishermen lost thousands of dollars as scallops were thrown up on the beaches and lobster cars were torn from their moorings to be broken in the surf. The storm was at its worst ashore along Cape Cod. Tides there reached record heights and the wind reached a velocity that old Cape fishermen haven't experienced for a score of years. At Woods Hole, Cape Cod, the barometer was reported to have fallen off 5.1-2 points in an hour and a half, an almost unprecedented drop, and the storm was raging with a fury that is rare outside the tropics.

(Continued from page one) opponents: Former President Coolidge, rallying support for the Republicans, puts special emphasis on his appeal to his own industrial East. The Democratic troubles in New York City have intensified Republican effort to capture the Empire State. Governor Roosevelt's plans for his first long speaking trip, beginning Monday, forecast a Western swing unequalled by any Democratic nominee since William Jennings Bryan. For the moment, the most-talked-of of these developments probably is the Coolidge surprise. In a copy-righted article in the Saturday Evening Post, Mr. Coolidge has gone the whole way of endorsing Mr. Hoover's acts collectively and in detail, of praising Vice-President Curtis, and of upholding the Republican prohibition plank. Mr. Coolidge's pronouncement, much hoped for by Hoover's leaders because of the former President's traditional popularity, is reckoned by the politicians as the first high trump to be played since the conventions. There seems good reason for believing that Al Smith is considering the production of a Democratic trump by a statement more directly defining his support of his party ticket. Smith's full intentions, however, remain much clouded in the dust-bank of New York Democratic politics stirred up by the Roosevelt-Walker incident.

(Continued from page one) dispatch sent to state newspapers said Dr. Frank Graham, president of the University, and other officials of the institution had known for months that the petition was being circulated. It described residents of Chapel Hill where the university is located as sailing, but refusing to discuss the matter when ever the petition was mentioned. "The petition was viewed here," the News Bureau dispatch said, "as just another attack inspired by David Clark, publisher of a textile magazine, whose fight on President Graham has long been a matter of record." Clark, publisher of the Southern Textile Bulletin, was not one of the signers of the petition. It was presented to Governor Gardner by L. A. Tatum of Belmont, a retired textile manufacturer. Those signing it included many men prominent in business, industry and church work in North Carolina. It asked Governor Gardner to take "the initiative" in ousting "the undesirables" at our tax-supported institutions of learning. The governor accepted the petition without comment except to say he "likely" would lay it before the university board of trustees. The university was attacked for permitting Bertrand Russell, philosopher and advocate of free love, and Langston Hughes, negro poet, to address meetings of university students.

Meantime, President Hoover and members of his Cabinet, several of whom were personal friends of Robins, awaited word from federal agencies at work in the search. Mitchell said if there was an indication that Robins had been kidnapped and transported across any State line, the Bureau of Investigation would enter the search. J. Edgar Hoover, Chief of the Bureau, said that so far it appeared that no element of ransom was involved. "Colonel Robins seems simply to have disappeared," he added. "We have no way of knowing yet whether he has been kidnapped and taken across a State line or not." Hoover added that although no special instructions had been issued, his men immediately would communicate anything they heard about Colonel Robins.

WASHINGTON, SEPT. 9.—(AP)—Anxiety over the whereabouts of Colonel Raymond Robins, prominent prohibitionist whose disappearance as disclosed by his failure to keep a White House appointment Tuesday, was heightened today by President Hoover's concern and fears of violence of violence expressed by Mrs. Robins. The blaze was discovered in a room on the top floor and spread like wildfire through the pine frame work that supported the brick exterior. Firemen said the immediate cause of the fire was undetermined. All guests fled the hostelry in safety with their baggage and the only loss was said to be the building and its furnishings. Blake Wilkins, the injured fireman, fell two floors from an adjoining building as he fought the flames, and lodged between two buildings. He was taken to a hospital where physicians said his skull was crushed. They said his condition was critical. The hotel, more than 50 years old, was owned by the Stone Haven Hotel Corp., and contained 112 rooms. The two top floors were totally destroyed and the remaining floors were badly damaged. A sprinkler system in the building had been discontinued about a month ago. Later this morning, firemen said the blaze was under control but the ruins were still smoking and flames sprang up in various places.

around thirty gallons of gas taken. It was the second time the filling station had been robbed in the last few months.

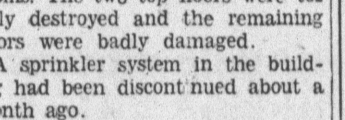

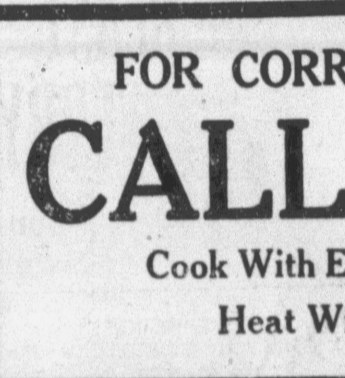
