GOVERNOR GARDNER WILL CONFER WITH STRIKERS

Curtis Boosts National System Of Marketing In Opening Campaign In Pa.

SEES NEED OF AID TO FARMER

Vice-President Devotes Himself Entirely to Discussion of Farm Problems and the Tariff Question; Charges Roosevelt with Failure To Submit Plan for Relief of Growers Of the Nation.

Fogelsville, Pa., Sept. 17.—(AP)—Establishment of a national co-operative system for farm marketing to reduce the price spread between producer and consumer was proposed today by Vice-President Curtis.

In his opening campaign speech here at the inaugural of the Pennsylvania Republican drive, Curtis, in his prepared address, devoted himself almost entirely to agriculture and the tariff.

Twice he referred to Governor Roosevelt's farm speech in Curtis' home town—Topeka, Kansas. The Vice-President closed with the statement:

"The gradual revival of business throughout the country is the best evidence that confidence is gradually being restored. This is due to the splendid work and great ability of our President, Herbert Hoover."

After making his own proposal for a national co-operative system, Curtis said:

"I have not commented upon Governor Roosevelt's farm relief plan because he has submitted none—he refers to several plans that have been discussed for years and then leaves them for further discussion."

Curtis outlined his own plan in these words:

"While this problem (agriculture) has not been and should not be partisan, yet the Republican party wishes to solve it and is anxious to bring the farmer into a situation of equality with industry. One of the problems is to reduce the spread between what the producer on the farm receives and what the ultimate consumer pays for such products."

"I have for years believed a national co-operative system would help solve the problem, and I still believe such a system properly organized and conducted would enable the farmer to get a better price for his products and at the same time do no injury to those who deal honestly in the buying and selling of farm products, while protecting the farmer against those who will not give him a square deal."

Chickens Fail, Wayne Farmer Without Paper

Goldboro, Sept. 17.—(AP)—J. G. McLawhorn of Pikeville will have to do without his daily newspaper until he finds some more chickens.

Mrs. J. B. Turner, working rural routes for a newspaper, sometimes accepts farm produce in exchange for subscriptions and McLawhorn was to give her \$10 worth of chickens for a subscription.

DEMOCRATS TO FIRE BIG GUN

Opening Kickoff Of Presidential Campaign to Take Place at High Point.

High Point, Sept. 17.—(AP)—The opening kick-off in Democracy's fall campaign for votes in North Carolina as to be booted here today by leaders from throughout the state.

Preparations for more than 5,000 guests were made by the Young Democratic Club of Guilford county, which is sponsoring the rally in the form of a barbecue at the High Point municipal lake.

Among party "big shots" who will speak are Governor Gardner and the party's gubernatorial candidate J. C. B. Ehringhaus; Senator Joseph William Bailey and Robert R. Reynolds, Senate nominee, and William B. Umstead, candidate for Congress from the sixth district.

Numerous state officials and leaders from various counties also were present.

GARNER SURE PARTY TO WIN

Texan Predicts Success as Vice-President Curtis Opens Campaign in Pa.

Washington, Sept. 17.—(AP)—Fresh expressions of Speaker John N. Garner's confidence in a November Democratic victory, today found his Republican opponent, Vice-President Curtis, opening his campaign for re-election in Pennsylvania.

He traveled to Fogelsville to make his first 1932 speech for the Hoover-Curtis ticket, preparatory to taking the stump next week.

He told friends he would discuss the agricultural and tariff problems. Garner, after conferring with Governor Roosevelt in Kansas, was on his way to New York to plan his own campaign itinerary.

But before leaving, the Texan issued a formal statement in which he said "the administration's assumption of credit for all relief measures passed by the last Congress is amazing," and predicted Democratic victory at the polls by 10,000,000 "if the swing has set in continues."

Garner's statement was given out yesterday at his Capitol office. At the other end of Pennsylvania Avenue, meanwhile, President Hoover conferred with the White House declined to say whether Mr. Hoover will go.

CIVIL COURT CLOSES HERE

Dock Hardee Awarded \$350 Damages Growing Out of Automobile Wreck.

The one-week civil term of Superior court came to a close here yesterday following completion of the damage suit of Dock Hardee, colored, against W. S. Elks and Guy Elks, of the Grimesland community.

Although the case went to the jury yesterday afternoon about five o'clock, decision awarding \$350 to the plaintiff was not returned until 8 o'clock. The verdict was accepted by Judge J. Paul Frizzelle in the office of Clerk of Superior Court J. F. Harrington in the presence of court officials and several spectators.

Hardee sued the Elks for damage to his automobile resulting from a wreck in the Grimesland territory sometime ago. The Elks, according to testimony, were attempting to pass another car and crashed into the car driven by the negro. Although Hardee's automobile was practically demolished, he escaped uninjured as did occupants of the other car. The defendants claimed Hardee was in fault.

FIND BODY OF MRS. DUBOIS UNDER HOME

Remains of Missing Wife of Jeweler are Found in Concrete Grave by Police.

Plymouth, Mass., Sept. 17.—(AP)—Charles Du Bois, wealthy jeweler dug his wife's basement tomb while she sat above and listened, unknowing its meaning.

She wrote to a friend, a Mrs. Gillett, that her husband was acting queerly, that in the cellar he would "dig for days" and be strangely silent when he came up.

It was in this basement cave that Mrs. Du Bois' body was found last night after the jeweler had committed suicide, shooting himself with the same calibre of bullet that ended the life of his wife.

Police said that Mrs. Du Bois also wrote to Mrs. Gillett that her husband apparently no longer loved her and was "like a crazy man over that other woman."

Du Bois was 39, one year younger than his wife. His home was in Tuckahoe, N. Y. The cottage in (Continued on Page Four)

TEACHERS OF COUNTY MEET

Annual Pre-School Assembly of County Teachers Held at the High School.

The annual pre-school teachers' assembly for Pitt County teachers was held yesterday in the auditorium of the Greenville High School with 182 teachers and principals present.

The meeting opened with group singing led by Supt. J. H. Rose, of the Greenville city schools. K. T. Futrell, Superintendent of Public Welfare, then presented his plan for administering local and Federal relief agencies during the coming winter.

In a very interesting and well-prepared address, Principal E. B. Page of the Bethel High School traced the development of Pitt County schools during a ten-year period up to 1932. Mr. Page showed that the county had made marked development in consolidation of schools, improvement of teacher training, improvement of attendance reduction of transportation cost, and interest in higher education.

ROOSEVELT TO SPEAK IN UTAH

Democratic Nominee for Presidency Arrives at Salt Lake City for Address.

BROWN, (Associated Press Staff Writer) Salt Lake City, Utah, Sept. 17.—(AP)—Checking off the eighth of the states he has crossed on his presidential campaign to the west, Governor Franklin D. Roosevelt left behind Wyoming with its cheering crowds and reached Salt Lake City where tonight he will advance proposals for relieving the nation's railroad situation.

SEEK ATTACK ON ASUNCION

Bolivians Demand that Airplanes Attack Capital of Paraguay at Once.

La Paz, Bolivia, Sept. 17.—(AP)—An aerial bombardment of Asuncion, the capital of Paraguay, was demanded today by crowds of people here after reports said Paraguayan troops were bayonetting Red Cross stretcher-bearers in the battle at Fort Boqueron, in the Chaco.

The battle entered its ninth day today, and officials said the Bolivian flag was still flying. The Bolivian defenders of the fort, a high official said, numbered about 2,000 and they were faced by between 8,000 and 10,000 Paraguayans, soldiers and civilians, armed with all kinds of weapons.

Reds Appeal to High Court in Ballot Case

Raleigh, N. C., Sept. 17.—(AP)—An appeal will be rushed to the State Supreme Court to determine whether the Communist party shall have a place on the North Carolina ballot in this year's general election.

J. Frank Flowers, of Charlotte, representing the party, gave notice of an appeal from the ruling of Judge N. A. Sinclair in Superior Court here yesterday denying a motion for a writ of mandamus forcing the State Board of Elections to place the Communist electors on the ticket.

FORMER PLANS HAVE FAILED

Governor to Meet the Heads of Chair Factory and Strike Representatives While On Way to Attend Political Rally; Hope for Peaceful Ending of Walkout Entered.

Raleigh, N. C., Sept. 17.—(AP)—Governor O. Max Gardner will hold personal conference at High Point this afternoon with Thomasville strike leaders and T. A. Finch, owner of the Thomasville Chair Company, in an effort to end the strike prevailing there.

The governor arranged the conferences at noon today in long distance telephone conversations with Capus Waynick, of High Point, who has acted as the governor's personal representative, and Mr. Finch.

The executive was going to High Point to attend a political rally there this afternoon but, with the possibility that his intervention "right now" might settle the strike, he arranged for the meetings before he goes to the rally, where he will speak.

Negotiations will be primarily to settle the Thomasville strike the governor said, though he will also go over the conditions at High Point with Mr. Waynick. At High Point several hundred workers of the Stehli Silk Mills on strike.

Nothing new has developed in connection with the strike of cotton mill workers at Rockingham, Governor Gardner said.

"I am very hopeful of a peaceful settlement of the Thomasville strike without further trouble or delay," the governor said.

A month and a half ago the governor made a Saturday afternoon trip to High Point, and after conferences with strikers and employees settled the strike of 6,000 hosiery workers then prevailing.

Settlement of the strike of one thousand employees of the Thomasville Chair Company apparently was no nearer today.

Meeting last night, the strikers discussed the walk-out but took no announced steps for its termination. Officials of the company said a number of workers have indicated they favor returning to their jobs.

Meanwhile, at Winston-Salem the strength of a strike at the Hanes Hosiery Mill was believed greatly dissipated by the return of approximately 900 of 1,200 employees who had walked out, protesting a wage cut.

At High Point the striking workers of the Stehli Silk Mill voted 163 to 60 yesterday not to return to work unless they attain their goal of elimination of a wage cut.

BRUMMITT IS SPEAKER HERE

Attorney General Of N. C., Addresses A Gathering on the U. S. Constitution.

Dennis G. Brummitt, of Raleigh, Attorney General of North Carolina, spoke at the courthouse here last night on the subject of "American Citizenship."

The address was in connection with observance of "Constitution Week" and was heard by numbers of prominent citizens interested in the effort to produce more interest in development of national life.

Other counties of the State were to hold similar meetings with a view to encouraging attention to the far-reaching provisions of the Constitution, and it was said that good crowds were expected to attend.

F. C. Harding presided over the meeting here. He introduced Senator M. K. Blount, who in turn presented the Attorney General as one of the leaders of public thought in this State.

Making his first public appearance here in years, Mr. Brummitt carefully reviewed formation of the Constitution of the United States, and declared it one of the greatest pieces of work known to civilization.

State Loses First Place In Birth Rate

Raleigh, N. C., Sept. 17.—(AP)—North Carolina "cheerfully" yields one of her "firsts" in losing the distinction of having the highest birth rate of any State, Dr. James M. Parrott, State Health Officer, said today.

According to recent figures issued by the Federal Census Bureau, New Mexico now has more births per thousand of population than any state in the union. This state is now second, but Alabama is only a fraction lower and South Carolina is not far behind.

"This is one 'first' we cheerfully yield to our neighbors," Dr. Parrott said, "while we devote most attention to the important job of saving a larger number of infants who are born."

Extortion Trial On in Earnest

Wilmington, N. C., Sept. 17.—(AP)—Mrs. Jessie Kennan Wise, wealthy widow known for her philanthropy, testified for the State today in the trial of two former Wilmington officials to extortion that she received letters signed "Captain Raynee" demanding \$25,000 and \$20,000 on threat of bodily harm.

Wilmington, Sept. 17.—(AP)—Wilmington's extortion plot trial, with a widely known woman philanthropist as chief state witness and two former city officials as defendants, proceeded in earnest here today with selection of a jury out of the way.

Mrs. Jesse Kennan Wise, whom the prosecution charges was the recipient of two letters demanding \$25,000 and \$20,000, was expected to take the witness stand.

Mrs. Wise was sworn yesterday, after 13 jurors had been selected and half-a-dozen witnesses testified.

The state contends P. Q. Moore, former mayor, and J. J. Furlong Sr., former police chief, sent the letters to Mrs. Wise, demanding payment upon the threat of bodily harm.

First witnesses, including three post office employees, described seeing the "extortion letters."

A negro employe at the Wise residence, Alex Stedman, was not allowed after a defense objection, to relate what he said was a telephone conversation he had about June 7 with a "Captain May Raynee" who telephoned the home.

"Captain Raynee" was the signature affixed to the ransom notes.

Discussing provisions, such as religious liberty, freedom of speech, equality of the law, personal liberty and other incorporations, the Attorney General stated that these were still adequate for protection of human right and had been readily adjusted to the constant changes of American life.

Belief was expressed that farmers of the Constitution must have had Divine guidance to have been able to create such a document. He said there is something finer behind public observance of the laws than fear of punishment, and the people were guided by loyalty to the Constitution and willingness to obey it.

He entertained no fear concerning the economic disturbance sweeping over the nation at this time and in efforts of certain forces to uproot and destroy the basis of the religious, social and economic system, declaring there was a gradual lifting of human nature already noticeable through adherence to the Constitution and its eternal principles. He said continued loyalty to the works of the forefathers would sustain the nation under all difficulties and eliminate all confusion.

After the body was placed in the concrete crypt, Du Bois entertained at gay parties in a bottle-strewn room only eight feet above his wife's body, detectives said, as they cast new light on the case before marking it "closed."

Du Bois, against whom the police had sought a murder warrant in vain because they had no corpus delicti, killed himself in a Quincy rooming house. He had shaved off his smartly curled mustache and taken the name "Ralph Anderson."

Immediately Assistant District Attorney John V. Sullivan arrested ten men with pickaxes to the Du Bois summer cottage near Great Herring Pond, with orders to demolish it if necessary in the search for New construction there had aroused his suspicions.

A few blows of a sledge laid open the funeral vault, a strong concrete box in the cellar. The body lay inside, wrapped in black cloth, a pillow underneath the head and a window cord about the waist. Medical examination showed Mrs. Du Bois died of a bullet wound about August 10, the day when police had figured she disappeared.

After DuBois was released last Monday by a judge who refused to issue a warrant for him, police questioned Miss Grace Atwood of Middleboro, blonde and youthful daughter of a wealthy manufacturer. They said she told them she had been friendly with Du Bois. He had informed her, she said, that his wife was killed in an automobile accident in Montreal. Authorities absolved Miss Atwood of any knowledge of the slays.
