YANKS LEAD IN SECOND GAME OF WORLD SERIES

Storm Wrecks Ship In The Pacific

Fate Of Crew Of Nevada Unknown As Ship Stands By To Assist In Rescue

MAIL LINER TO OFFER AID

Japanese Oregon Maru Prevented From Offering Help To Thirty-Five Men Aboard 410-Foot Vessel By Intensity Of Storm; American Liner President Wilson Speeds to Scene; Whereabouts Of Only Four Of Crew Known

San Francisco, Sept. 29.—(AP)—The fate of the freighter Nevada's crew of 35 was unknown today as a westerly gale pounded their ship to pieces on the rocks of a lonely north Pacific island and kept another vessel from lending aid.

Its small ship driven back by heavy swells, the Japanese freighter Oregon Maru stood helplessly and watched the seas smash the 410-foot craft. The Oregon Maru located the Nevada late yesterday after a 16-hour search.

Meanwhile the American mail liner President Madison sped to the scene—Amatitlanak Island in the middle Aleutian group—expecting to arrive at daylight (about 10 a. m., Pacific Standard Time).

The whereabouts of only four of the crew was definitely known when radio messages, relayed by Madison and the Coast Guard Cutter Northland, reported the Nevada had "broken in three parts."

The four men were seen on the rocks of the island by the small boat from the Oregon Maru while it was trying to reach shore. Radio messages gave no indication as to whether anyone was seen on the pinioned ship, or whether others of the crew later reached shore.

Early yesterday morning the Oregon Maru picked up an SOS from the Nevada. Immediately afterward the distressed ship's radio went silent and for 16 hours the Japanese vessel searched the treacherous North Pacific waters before locating the Nevada piled on the rocks of the inhospitable Aleutian Islands.

All of the 35 officers and men aboard the Nevada signed on at Portland, Ore., and gave that city as their home.

Capt. T. W. Johansen took the Nevada out of Portland September 16 bound for Japanese ports with a general cargo. She is operated by the States Steamship Company of Portland.

GEORGIA MILK WAR IS ENDED

Atlanta Mayor's Negotiations for Peace Accepted By Milk Producers

Atlanta, Ga., Sept. 29.—(AP)—Milk trucks rumbled undisturbed over the highways today as Georgia's milk war came to an end through the efforts of James L. Wey, Atlanta's fiery mayor and the man who made the "whiffle bat" famous.

Under the settlement, dictated by the mayor and promptly adopted by representatives of milk distributing plants and milk producers, prices paid producers by the plants are to be stepped up to 16 cents a gallon October 1st to 18 cents November 1st, and to 20 cents December 1st.

The mayor's part in settling the milk strike, which had brought some violence and dumping of milk by angry farmers, drew praise from Columbus, Ga., president of the Georgia Milk Producers' Confederation, Inc.

Mayor Key, who not long ago was the center of a controversy over his anti-prohibition views, and who subsequently defeated efforts to recall him from office, "handled the situation with gloves off, and handled it well," said Roberts.

It was during the agitation for a recall election against the mayor that he designated as "whiffle bats" those who opposed his economy program. He defined a whiffle bat as a "queer kind of bird that flies backwards, doesn't know where he came from and nothing about where he's a-goin'."

ROOSEVELT TO AIR TARIFF AT SIOUX CITY, IA.

Democratic Nominee Given Support Of Senator Norris In Address in Nebraska

Aboard the Roosevelt Special, Sept. 29.—(AP)—Governor Roosevelt, with the public avowal of his candidacy by Senator George W. Norris entered on the record, today crossed Nebraska to Sioux City, Ia., where he will discuss the long time difference of the Democratic and Republican parties on the tariff.

After Norris, independent Republican at McCook, Neb., last night publicly endorsed Roosevelt, declaring "patriotism demands that he put our country's interests before our party's interests." Mr. Roosevelt said "I rejoice in and approve the statement that Senator Norris is a better Republican than President Hoover."

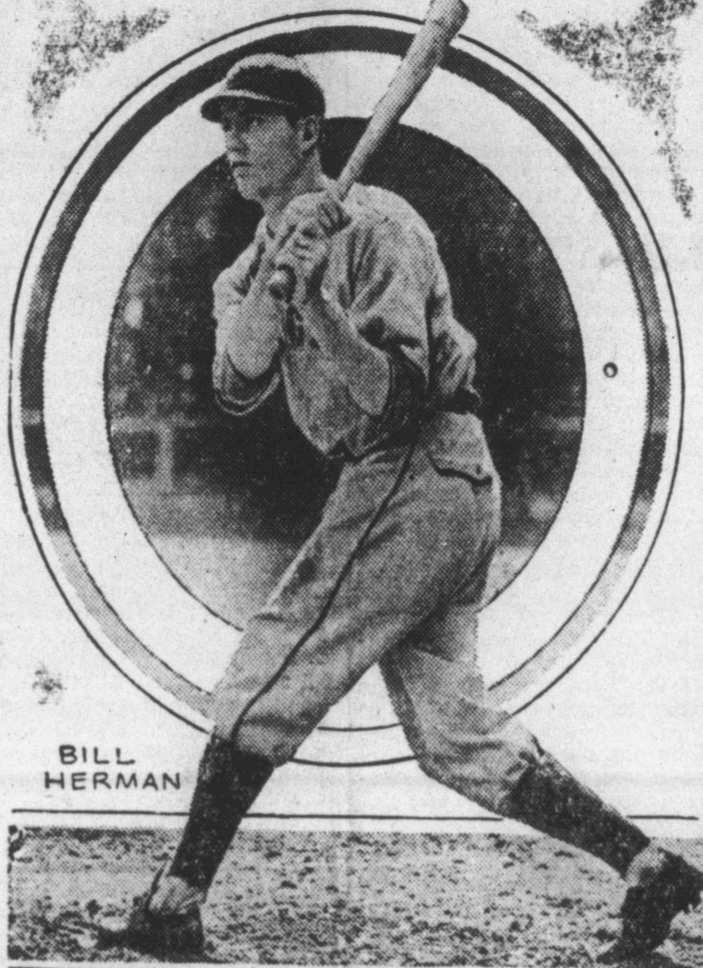
Posse Hounds Bank Bandits In Michigan

Holland, Mich., Sept. 29.—(AP)—Seven bank robbers armed with sub-machine guns twice eluded a posse of one hundred men near here this morning and were reported in full flight through western Michigan after looting the First National Bank here of between \$10,000 and \$12,000 and wounding two men.

The bandits were halted temporarily near Drenthe by the pursuing posse, but broke away after opening fire with their sub-machine guns. State police and armed citizens then pursued them to a swamp near Jamestown, west of here, but again they eluded them and sped west, closely pursued.

Washington, Sept. 29.—(AP)—Reports on the Puerto Rico storm, that trickled into Washington today, the Red Cross hearing that an incomplete survey showed 194 killed, and 10,857 injured.

Sterling and Mrs. Ferguson were opponents in the run-off, the latter leading the governor by approximately 4,000 votes. She was governor once before for one term, being elected on a vindication platform after her husband had been impeached as the State's chief executive in 1917. Sterling is completing his first term.

Asserting that France is faithful to the League's ideals and will work resolutely for the success of the Arms Conference, the Premier declined to discuss issue, declaring this is not the time and place for such discussion.

He praised the results of the Economic Conference at Lausanne at which the amount of Germany's reparations debt was limited and of the recent conference at Siresan, Italy, on rehabilitation of the Balkan States, saying they were evidence of the spirit of the League has introduced in international affairs and good omens for success at the World Economic Conference to be held next year.

The world is filled with complex and difficult problems which the diplomats must not hope to solve at once, he said, adding that the true task which he regards as most important for the League to accomplish are the reduction, and perhaps abolition of secret diplomacy and the ending of the domination by certain powers of world affairs.

Diplomacy should be open, he said, all nations should be considered on the level.

Lord Cecil, British representative, also came to the League's defense, declaring the existing troubles between Bolivia and Paraguay over the Chaco and the difficulties in the Far East would never have developed if each party to each dispute had applied faithfully the principles of the covenant.

Three brothers, Gonzalo Leopoldo, and Guillermo Freyre de Andrade were slain within their residence by a gang which rushed into the house, shot them down, and rushed out again. Miguel Angel Aguiar, the fourth oppositionist slain, was shot down when he went to the door of his home to meet the killers.

A second plot, which police said might have resulted in wholesale deaths of the family and friends of Dr. Barquez Bello, as well as high government officials, was uncovered by police yesterday in the discovery of a huge dynamite bomb planted in Colon cemetery near the plot where it was originally reported Dr. Vazquez Bello would be buried.

All the employees of the cemetery, numbering nine or ten, were arrested and held for investigation. Explosives experts today uncovered twenty-three mines containing more than 300 pounds of dynamite, all controlled by an electrical switch eight blocks away in a Chinese cemetery. There was enough explosive to have blown the whole funeral cortege to death, the experts said.

CONNIE MACK SELLS FAMED BALL PLAYERS

By GAYLE TALBOT (Associated Press Writer)
New York, Sept. 29.—(AP)—Connie Mack, venerable pilot of the Philadelphia Athletics, has started tearing apart the great baseball machine he drove to three American League flags in 1929, '30 and '31, and the Chicago White Sox, at the same time, have thrown their resources into the market for players of proved ability.

In one of the most startling deals of recent baseball history, Mack sold outfielders Al Simmons and George (Mule) Haas, and infielder Jimmy Dykes to the White Sox for cash. The price paid for the three stars was not announced but Sox officials said it was the largest amount of cash they ever have handed out and probably the greatest sum which ever exchanged hands in the American League. It was estimated the Sox put around \$150,000 on the barrel head.

Whether the sale presaged a general breaking up of the Philadelphia team, Connie Mack would not say. The consensus was, however, that the 67-year-old leader had something of the sort in mind. Just 17 years ago he wrecked a glamorous team because it had become saturated with victory. At that time he sent one of his greatest stars, Eddie Collins, to the White Sox and Collins became the cornerstone of a championship club at Chicago.

Where Mack contented himself with the bare announcement of the deal, Sox officials were less reticent. "It means we are through trying to develop a winning team with rookies," said Secretary Harry Grabner. "This is only the beginning. We are going out to get the players we want."

While Haas and Dykes are considered valuable players, Simmons is the big gun in the deal. Possessed of a nine-year major league batting average of nearly .360, he is recognized as one of the game's greatest stars. He is one of the most feared batters in the big leagues, a ball hawk in left field and, withal, a player any manager would welcome with open arms.

He fell off in his hitting during the past season, finishing with an average around .323 but he still is comparatively young and should prove a sound investment for the Sox. He was the batting champion of the American League both in 1930 and 1931.

Purchased from Milwaukee of the American Association for \$50,000 in 1924, Simmons has played in three world series with the Athletics, piling up an average of .333 in 18 games. Opposing pitchers have feared him more than any batter in the Philadelphia constellation.

Haas has been with the A's since 1928 when he came up from Atlanta of the Southern Association. For five years he has hit a commendable .307 and he has cut off many an enemy hit out in centerfield, specializing in taking them off the fence on the dead run.

Dykes is a veteran, 35 years old and an Athletic stalwart for the last 15 years but he still is pretty much of a ball player. He has played every position in the club's infield and is known as a "money" player, a dangerous man to pitch to in the tight spots.

Former Soldier Tried for Murder

Hampton, S. C., Sept. 29.—(AP)—Trial of Alfred M. Marshall, a former Army major and now a business man of Estill, on a charge of murder, neared the jury stage today.

The State contends Marshall shot C. M. Merrill, 28-year-old road construction foreman and native of Asheville, N. C., a death at Estill last May 12 in "cold blood."

Occupying the stand for nearly three hours yesterday, the former officer said he shot Marshall when the latter advanced toward him "with his right hand on his hip pocket." Marshall said he thought the younger man intended to shoot him and he fired in self-defense.

Merrill's widow testified her husband was unarmed and another State witness, Wyman Blakewood, said the shooting was without provocation. Marshall and Merrill had had an altercation earlier in the day of the shooting about Marshall's right to drive across a paving project.

B. W. McFadden, who was unable to be here yesterday, was to testify for the State today. Several other defense witnesses were expected to be sent to the stand.

Man Killed By Train Declared Suicide Victim

Henderson, N. C., Sept. 29.—(AP)—Coroner F. M. Allen returned a verdict of suicide in the death of Edward G. Wesson, 27, of Montclair, N. J., who was killed by a Seaboard Air Line freight train twelve miles north of here yesterday.

Wesson was being accompanied from their automobile and ran across the tracks directly in front of the train which crushed his body,

In the group were Dixie Roberts, main cog in Vandy's offensive, and Pete Gracely, All-Southern center. Roberts led off of his team's points in its 20 to 7 win over Mercer Saturday.

Offense is still being stressed as the Tar Heels drill for the important contest. After a rest, Stuart Chandler, quarterback, and Kay Thompson, fullback, are running in scrimmage. Coleman and Phipps continued to lock up in the half-back jobs.

Denies Walker Is Asked to Aid Libby Holman

Winston-Salem, N. C., Sept. 29.—(AP)—Denial that New York's dapper Jimmy Walker had been asked to aid in the defense of Libby Holman Reynolds when she goes on trial here for murder was made today by members of Mrs. Reynolds' counsel.

In a copyrighted story the Newark N. J. Ledger quoted A. C. Blumenfeld, New York realtor and close friend of former Mayor Walker, as saying Walker has been asked by Mrs. Reynolds' counsel to aid in her defense.

Mrs. Reynolds and Albert Walker are charged with the murder of her husband, Z. Smith Reynolds.

The story was promptly denied by Benet Polikoff, one of the Broadway toehold singer's attorneys.

"I know that Walker has never been approached by either Mrs. Reynolds or by her counsel," Polikoff said, "and that no attorneys will be employed by her in the case from outside the State of North Carolina."

Some of this State's leading attorneys, including Clyde Hoye, of Shelby, and James H. Poy, of Raleigh, have been retained by the defense in this case. Details for the trial has not been set.

Favor Return To Two Cent Stamp

Washington, Sept. 29.—(AP)—A return to the familiar two-cent stamp on first class mail is favored by the House committee investigating the postal service.

This group, a subcommittee of the House committee on postoffices, gave among its reasons, the reduced volume of first-class mail since the three-cent rate went into effect as a provision of the billion dollar tax bill intended to balance the budget.

Reconstruction Bank Loans Drop

Washington, Sept. 29.—(AP)—Bank loans asked of the Reconstruction Corporation amount 60 per cent from July 30 to September 3.

The Corporation disclosed today that during the five weeks ending July 31, 1,521 applications totaling \$346,000,000 were received from banks and other financial institutions. During the next five weeks 1,222 applications, totalling \$148,000,000 were received.

The average bank loan was said to have gone to a bank in a town of 3,000 people.

The Corporation is awaiting a legal opinion on the proposed loan to China which that nation would use to purchase 15,000,000 bushels of American wheat. It was stated that the board, which conferred at the White House Sunday on the subject,

is disposed to make the loan if it is found to be legal. An early opinion from the attorney is expected.

It also was said that whether the sale would depress the world's market must be considered. The law under which the loan would be made, it was said, appears on the surface to be clear enough to permit such a loan, but nothing can be complete legal phase of the situation.

Much of the wheat that would be sold is held privately. All of it, it is understood here, is northwestern hard wheat.

Services for "John Sharp" as he was known to white people of Mississippi and "Mama John" to his negroes, were arranged for ten a. m. with the Rev. E. J. Reynolds Jones pastor of the Trinity Episcopal church officiating.

Governor Mike Conner declared the state in official mourning and authorized the closing of state departments for the funeral.

Last night at McCook, home town of Senator Norris, Roosevelt heard the veteran legislator espouse the Roosevelt candidacy.

Speaking to a crowd of 20,000 or more at the Red Willow County Fair Grounds, Norris said: "What the country needs is another Roosevelt."

"And here he is," continued Norris, turning toward Mr. Roosevelt, who stood beside him. "The governor of New York, the next President of the United States."

Responding, Roosevelt asserted, arm sweeping towards the white-haired Nebraska "our" cause is common your support. I honor myself in honoring you.

Twilight was fast falling over the plains when Roosevelt and Norris drove into the fair grounds on the outskirts of the little city of 7,000 near where the senator was born.

Both stood in the dust of a race track, beside an auto and facing the packed grandstands, and the crowd overflow that spread across the racing ribbon an dinto the lawn inside the fence.

"During this campaign, as the Senator knows," said Roosevelt, "I have stressed the fact that my quarrel is not with the millions of splendid men and women who in the past have called themselves Republicans, but that my battle is against certain forces now in control of the leadership of the Republican party, who have forgotten the principles on which the Republican party was founded and have become representatives of a selfish few who put personal interest above national good."
