## THREE HELD IN THE SLAYING OF VETERAN

### Attendants at Veterans' Hospital Charged with Killing Tennessee Patient.

Augusta, Ga., Oct. 12.—(AP)—The death of Charles Dickinson, of Summerville, Tenn., a patient at the United States Veterans Hospital, has resulted in the arrest of three attendants on charges of murder.

Warrants for the arrest of the three, Austin Brown, Aaron F. Ott and Walston Epps, were issued on affidavits furnished by Col. R. W. Soper, medical officer at the hospital.

All three men pleaded innocence of the charge when questioned.

Colonel Soper said other attendants implicated the men under arrest, and that an autopsy conducted by physicians associated with the hospital had aroused their suspicion. Dickinson had suffered a broken rib and punctured lung. Dickinson, Colonel Soper said, was at times violent, throwing himself against the walls and jumping over tables.

The patient died Saturday and the death certificate gave pneumonia caused by an accidental fall as the cause of death.

At the arraignment it was charged that Dickinson was hit on the head by the defendants.

## Woman Killed By Priest's Car

Washington, N. C., Oct. 12.—(AP)—Mrs. Randall Grissom was instantly killed yesterday when she was hit by an automobile driven by Father E. T. Gilbert, Washington Catholic priest. The woman came to her death as she led a child across a road in front of her home about five miles from Washington. Authorities continued investigation of the accident today.

Father Gilbert was returning with two sisters from mission work in another part of the county when the accident occurred.

## Says Corn Fed to Hogs Will Pay the Farmer

Raleigh, Oct. 12.—(AP)—The North Carolina farmer who has a good crop of corn harvested may find hog feeding a paying proposition this winter due to the shortage of pork in storage. W. N. Shay, swine extension specialist at N. C. State college, said today, but present prices for hogs probably will not pay for corn which has to be shipped into the state from other sections.

With North Carolina having a generally short corn crop, Shay said the western farmer in the so-called corn belt has one of the best crops since 1925. This will enable them to feed liberally and cheaply, to such an extent that Tar Heel farmers will hardly be able to compete.

Shay said that pork held in storage as of September 1 is about three per cent less than on September 1, 1931 and over 14.034 cent below the average of five years for the same date. Holdings were nearly 12 per cent less on September 1 this year than they were one month earlier. Stockers and feeder shipments were 41 per cent less in July this year than during the same month last year, or for the average of five years.

Those who plan to feed hogs and can raise barley successfully should plant the grain now for feed and grind it next spring, when the corn supply gets short, Shay said.

He urged all farmers to hold on to their brood sows, whether they plan to feed the pigs for market or not, as a normal corn crop will likely be produced next year and the man with pigs will then be the one in position to make a profit.

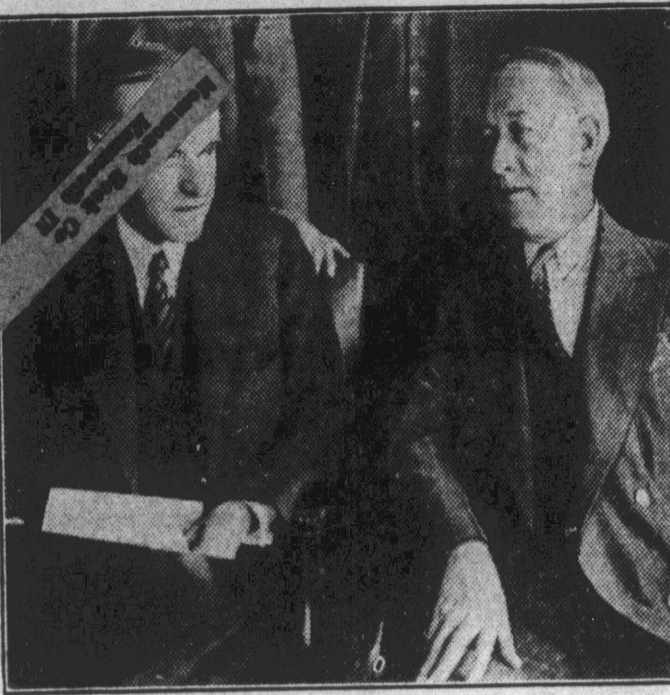

## LEAF SALES LIGHT AGAIN

### About Half a Million Pounds of Tobacco Offered on this Market Today.

With lighter sales reported on the Greenville tobacco market today, indications were that sales would be completed shortly after the noon hour today.

Unofficial figures placed today's offerings of around five hundred thousand pounds.

The official report of K. W. Cobb, supervisor of sales, showed the market disposed of 660,474 pounds of tobacco yesterday for \$96,191.14 at a general average of \$11.18 per hundred pounds.

Although the general market average showed a slight decline compared with the day before, this was said to have been caused by unusually large offerings of poor tobacco. Prices remained firm on the better grades, comparing favorably with the highest day of the week.

With the advent of crisp weather, offerings were expected to be heavy here the remainder of the week, probably as heavy as the first day when over a million pounds of the leaf was disposed of.

With conclusion of sales this afternoon, warehouses will begin clearing their floors in anticipation of heavier offerings the remainder of the week, and every effort will be made to expedite the handling of the bright leaf on the largest bright leaf market in the world.

## WISCONSIN ANGLER LANDS FIVE TARPON IN TWO DAYS

Milwaukee, Wis., Oct. 12.—(AP)—Dr. Alfred Cohn is almost convinced he merits the title of "world's luckiest fisherman" given him by friends.

In a recent visit to Fort Myers, Fla., he hooked five tarpon, averaging 100 pounds, in just two days of fishing, where many fishermen spend a whole season tarpon-fishing without getting a strike.

Cohn's accomplishment won him the Thomas A. Edison bronze medal for tarpon fishing, awarded by the Fort Myers Chamber of Commerce.

## MANY MINERS ARE ARRESTED IN COAL ZONE

### Illinois Troops Make Effort to Prevent Disorders in Coal Fields.

Taylorville, Ill., Oct. 12.—(AP)—Moving to prevent possible disorders, National Guardsmen early today raided headquarters of striking miners and placed many of them under arrest.

One hundred and eighty troops acting under the direction of Captain Meechum, arrested the miners and presented them for hearing. They were questioned individually, and officers indicated that those who did not give a satisfactory reason for their presence might be sent out of the city.

Meechum expressed determination to carry out orders of officials to prevent a parade of miners today.

## SEN. SMITH DIES IN MICH.

### Former Member Congress Dies at Age of 75 After Fine Record.

Grand Rapids, Mich., Sept. 12.—(AP)—Death today removed another U. S. Senator in the person of William Elden Smith, who became a member of important committees during his thirteen years in the House and Senate.

He died late yesterday at the age of 75. His interest in politics continued strong, although he retired from the Senate at the conclusion of his second term in 1919. His period of service embraced that period between the Spanish-American War and the World War.

As a member of the foreign affairs committee, he helped draft the declaration of war against Spain.

## NEW CAR OF HOGS SHIPPED

### J. E. Winslow, Prominent Grower, Plans to market 2000 Hogs Each Season.

J. E. Winslow shipped his second car of hogs this season yesterday and, according to reports from E. P. Arnold, county agent, he has 1,000 hogs on his farms across the river. Each tenant grows hogs on the shares and Mr. Winslow has several hundred in addition to these running through the field harvesting soybeans, peanuts and corn. Mr. Winslow plans to market 2,000 hogs each year. Each year he cures out enough meat to supply all the meat required in the operation of his farms. He has recently put in a cooling system that will enable him to kill and cure out meat any season of the year.

Hog shipments have now reached 31 cars which is the largest number ever shipped from Pitt and if farmers sit steady in the boat, a larger number will be shipped next spring, bringing in cash when it is needed. It is true that corn is scarce but it is so cheap in the west that it is being burned to save coal. Corn will be cheap even though it is a short crop with us. Keep the brood sow and give the pig a chance to make a hog out of itself.

Albany, N. Y., Oct. 12.—(AP)—Calvin Coolidge's speech in New York last night was not heard by Governor Franklin Roosevelt, Democratic nominee for the presidential, or John N. Garner, of Texas, vice-presidential nominee.

During the speech Roosevelt and Garner were here for the evening attending a motion picture show in a small theater. The governor was said to often relax himself from political activities by attending the show.

## DEMOCRATS TO 'RALLY' HERE

### Walter Murphy Will Address Voters At Courthouse Friday, Oct. 21, 8 p. m.

Plans had been virtually completed here today for the Democratic rally to be held in Greenville Friday, October 21, and present indications point to one of the greatest occasions of the kind probably ever held here before.

W. E. Hooks, of Ayden, chairman of the Pitt County Democratic Executive Committee, was in the city today preparing the first advertising matter in connection with the rally, and said he expected a large crowd to attend.

The highlight of the rally will be an address by Walter "Pete" Murphy, of Salisbury, one of the outstanding apostles of democracy in this part of the country. He will speak at the courthouse at eight o'clock and men and women from many parts of the State were expected to be in attendance.

The affair is being sponsored by the Young Democratic organization perfected here several weeks ago. It will include a "prosperity parade," something different from the usual type of parade presented in the State during the depression era. Although plans for the parade will not be completed, every effort will be made, it was said, to make it in keeping with the importance of the rally.

The Democratic campaign opened with the Hoover car parade and speaking at Ayden last Saturday at which thousands of people were present.

Mr. Hooks said some of the most prominent members of the party would visit the county from time to time between now and the November election and voters will have an opportunity to absorb many vital facts in connection with the Democratic bid for supremacy.

## COLUMBUS DAY IS OBSERVED

### Nation Celebrates the Discovery of America with Appropriate Exercises.

Buoyed by an unwavering opinion that the West was round and that the West awaited him with great riches, Christopher Columbus, aboard the Santa Maria, forced down a mutiny of his men many days at sea and discovered America. A lookout spotted the low lying land and shouted the victory cry. There on an island what is now probably known today as Watley Island, Columbus discovered Cuba and Haiti. ## SAYS THE LAW MET DEMAND

### Report of Crime Condition Presented To American Bar Association in Session At Washington; Committee Declares Prohibition Has Met the Law of Supply And Demand, Making It Easy for Gangsters to Obtain Organization at Small Risk.

Washington, Oct. 12.—(AP)—A report read before the American Bar Association in annual convention here today said organized crime as conducted by gangsters was based largely on supply and demand for the outlaw.

The report on crime conditions was presented by the committee on criminality and was caused by the unusual activity on the part of gangsters in various parts of the nation.

The committee consists of George Bowman of Milwaukee; Herbert Hunroe, of Detroit; and William Knight of Illinois.

The committee said "we do not want to be understood as supporters of a reform movement, but which simply to point out what we believe to be a fact—that prohibition brought about the condition of crime and infractions of the law which made it easy for gangsters to obtain a large personal organization at small risk and produced a demand for outlaws such as we have never had in this or any other country."

## TWO WHISKEY STILL TAKEN

A mad dog was slain by police in Greenville yesterday after biting a six-year old child. How many dogs the animal bit before he was shot is impossible to say, and people should be on their guard against strange dogs in the future.

There is an ordinance in the city prohibiting dogs from appearing on the streets unless in leash, and in face of the appearance of the mad dog, the law should be more stringently enforced.

Owners of dogs should not permit the animals to run at large. They may be perfectly sound of body, but this is no guarantee that they will not be bitten by a mad dog and suffer an attack of rabies. Public life is at stake in a situation of this kind and the law should not be disregarded.

Members of the official family of the North Carolina department of the American Legion are definitely committed to payment of the compensation certificates held by veterans of the world war.

This fact was made known yesterday by the new commander, who said an unrelenting fight would be waged by the Legion with this end in view.

With the Legion in all parts of the country more definitely behind the demand for cash payment of the bonus, it is expected Congress will witness a more determined fight in its behalf in the future.

Many posts had not committed themselves prior to the march of the bonus army on Washington but since that time they have come to the front and boldly asserted their desire for payment.

A memorial service for Col. Harry Skinner and Col. F. G. James, both one time prominent members of the bar in this city, will be held October 26th. It was fitting that the Bar Association, of which both were members, should hold such a service as a means of commemorating the fine things which these two men did in behalf of the state and nation during their lifetime.

It is fitting also that prominent members of the bar from other sections of the country should come here to pay honor to their memory in public utterance.

Colonel Skinner, prior to his death three years ago, was one of the leading men of his profession in the state. He served in many important capacities during his lifetime and rendered services of which the section is proud.

Colonel James, estimable citizen, served the county in the state legislature a number of times, and rendered service which has enabled his community to reach great heights of achievement.

Men of this calibre leave an indelible stamp upon the lives of the community in which they live, and the achievements of these two lawyers will live long to glorify public life throughout the community and state.

**CHILDREN'S LOVE**

Billy's mother frequently refers to him as her "little sweetheart." The designation is more revealing than she realizes. She admits that she loves him with devotion; that he is to her most precious thing on earth.

But when it happens that absorbed in play he forgets to give her the whole-hearted personal response to which she is accustomed she is annoyed and shows her annoyance by treating him coldly.

Returning one evening from an absence of several days (for which she had taken no trouble to prepare him) she was hurt deeply when he scarcely returned her greeting.

Billy, for his part, was hurt too. Had she not deserted him? It would be hard to tell which of the two, the mother or her four-year-old son, behaved more childishly. It would seem that the child had the more justification for his behavior.

One cannot expect a child to adjust himself to a lover-like capriciousness in his parents. He does not understand a love that goes from one extreme to another. He is unskilled at dramatizing his emotions, and cannot find his way in a situation of which he is not capable. He is merely baffled, confused and hurt.

In the long run he learns to love such a mother at one moment and hate her intensely the next. He learns to sulk and to tease by pretending indifference or to get what he wants by showing especial affection.

Children are not little sweet hearts, they are children. And they do not need passionate adoration that asks a like return, but rather quiet, steady affection which they may take for granted.

JUDGE WINSTON ADDRESSES MAJOR MAY CHAPTER. Farmville, Oct. 12.—Judge Francis D. Winston, eminent jurist of Windsor, and an alumnus of the North Carolina University, who enjoys the distinction of having served as a trustee of that institution of learning for the past 43 years, spoke along educational lines, when addressing the Major Benjamin May chapter D. A. R., at its initial fall meeting held on Monday afternoon at the home of Miss Allie Louise Fountain.

John T. Thorne of Farmville, who also hails the University as his Alma Mater, introduced the speaker. The Judge reiterated his belief in practical education and expressed gratification in the simplicity of the really great as exemplified in Edison, relating the story of a visit to him and his belief that all the waste in life will eventually be eliminated and that the perfection of inventive forces will be so great that an automobile will be run by an engine of weight so slight as to be held in one's hand.

A man of vision, Judge Winston notes the passing of the old, designates this as the Age of Change and maintains that children of the next generation will not be instructed in theories of government but will be shown which is harmful and which is good. His speech was in no wise political but in touching on that inevitable subject, prohibition, he stated that he voted for this measure and will do so again, for he reason as he said, "it beats nothing."

**Connecticut's Vote in 1928**  
Hoover 236,614; Smith 252,040

Republicans usually have been able to count upon the staunch support of Connecticut. Warren G. Harding took the state by a vote of two to one in 1920 and in 30 years the state has given the most votes to a Democratic presidential candidate but once, in 1912.

Alfred E. Smith and his prohibition views were able in 1928 to reduce the Republican majority in the state to less than 45,000. Connecticut long has been acknowledged a wet stronghold.

Democrats succeeded in the 1930 elections in obtaining narrow majorities for Wilbur L. Cross, former dean of the Yale graduate school, for the governorship and for two of their five candidates for congressional seats.

Utah has had no senatorial or gubernatorial elections since 1928. In the congressional elections of 1930 Republican candidates were elected in both districts in the state by a combined majority of 13,099 of a total of 144,349 votes for candidates of the two major parties. The combined Republican majority in the two districts in 1928 was 19,226 or a total vote of 175,034.

Utah in 1928 elected a Democratic senator, William H. King, by a majority of 20,363 and re-elected George H. Dern (D) as governor for his second term.

Silver is an issue of major importance in this year's presidential campaign, as well as in the senatorial campaign in which Reed Smoot (R) dean of the Senate, is opposed by Dr. Elbert D. Thomas (D) professor of political science in the University of Utah.

Utah has four electoral votes this year, as formerly.

**Greenville Leads Tobacco Market**  
Raleigh, N. C., Oct. 12.—(AP)—Tobacco growers in September got \$2 more per hundred pounds for the golden weed than they received in the same month last year.

The report of the Federal Crop Service issued today showed there was 66,600,614 pounds sold during September at an average of \$11.57 per hundred pounds compared with 96,259,217 at an average of \$9.60 last year.

The new bright belt average was 10.80 for 43,755,278 pounds compared with 8.70 last year.

Greenville was shown as leading all markets with 9,648,044 for September against Wilson with 9,200,020 pounds.

Total for all markets was well below last year except Kingston whose 1931 total was 9,273,843.

The report said October 1 for flue crop showed 356,000,000 compared with 665,000,000 a year ago. Crop condition 55 per cent normal compared with 71 per cent a year ago.

These government loans are being collateralized on a basis of nine and one-half cents on seven-eighths middling cotton. Those farmers who are growing a good staple cotton will be able to get an advance of around ten cents or better on their cotton.

Any receiving agent for the North Carolina Cotton Co-operative Association will issue receipts showing the cotton has been delivered.
