MRS. J. H. BOYD PASSES AWAY AT HOME HERE

Funeral Service For Beloved Woman To Be Held Tomorrow Afternoon at 2:30

Mrs. J. H. Boyd, Jr., wife of one of the city's most prominent business men, died this morning at 2:30 o'clock at her home on Seventh street. Although she had been in declining health for a number of years she did not become critically ill until last night when little hope was held for her recovery.

While it was generally known that she had been in bad health for sometime, news of her death was received with profound shock and sorrow throughout the community.

Funeral services will be held from Memorial Baptist Church tomorrow afternoon at 2:30 o'clock, by Rev. A. W. Fiechmann, pastor of the church. Burial will be made in Greenwood cemetery.

Mrs. Boyd was a member of one of the oldest and most socially prominent families of the community, and always took an active part in social and religious activities. She was of a genial and kindly manner and her splendid disposition won for her hundreds of friends in this and other parts of the country.

Before her marriage she was Miss Maida Williams, the daughter of the late Captain James T. and Mrs. Eliza Williams. She was reared in this community, being born in Greenville August 17, 1871. Aside from a few years in Baltimore, she spent her entire life here.

She was a member of Memorial Baptist Church and showed an active interest in work of the denomination. She was also a member of the Daughters of the American Revolution, United Daughters of the Confederacy, and was active in all endeavors looking to improvement of community life.

She was married twice, her first husband, W. P. Burch, died a number of years ago. Surviving the union are a daughter and son, Mrs. James Ellison of Washington, and W. P. Burch of Reidsville, who is now on business in Athens, Greece. On January 14, 1909, she married J. H. Boyd Jr., by which union she is survived by a son, Jack Boyd, III.

She is also survived by four grandchildren, Misses Lillian and Margaret Ellison and James Ellison Jr. of Washington; Ferrell Burch Jr. of Reidsville. In addition, three sisters and two brothers survive, Mrs. J. B. Hillary and Mrs. Frank Kohler of Philadelphia; Miss Hortense Williams, Jacksonville, Fla.; Earl Williams, Philadelphia, and Earl J. Williams, Oakland, California.

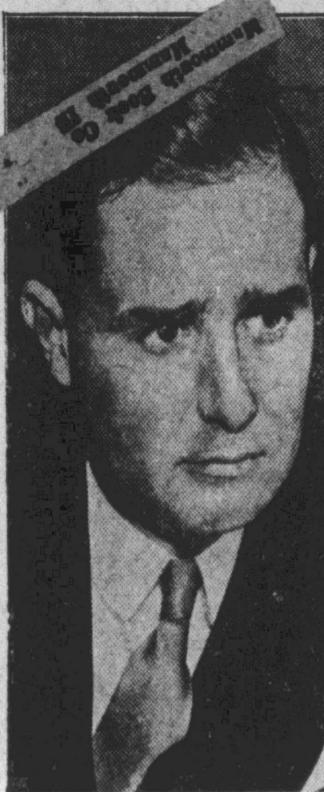
CATTLE TUBERCULOSIS IS NOT FOUND IN N. C.

Washington, Oct. 13.—(AP)—No real signs showing tubercular infection were listed for North Carolina during August as 1,598 head of cattle in 148 lots were given tuberculin tests, the United States Bureau of Animal Husbandry reported today. North Carolina is one of the nine States in the Union shown as entirely accredited territory. There are now 670,806 head of cattle in a State which have been once tested free for tubercular infection, and there are 10,619 head totally recorded as accredited in the State.

U. S. TO GIVE FOREIGN AID

Reconstruction Body Favorable To Loans With Which To Buy American Exports

Washington, D. C., Oct. 13.—(AP)—That the Reconstruction Corporation is arranging to accept proposals for loans for exports to foreign countries was asserted today by its officers.

The legal division still is considering the proposal that China be loaned money with which to buy 15,000,000 bushels of wheat. It was said the board was favorable to the proposal.

Graham Will Serve On N. C. Economic Body

Wilmington, Oct. 13.—(AP)—Dr. Frank Porter Graham, president of the University of North Carolina, has agreed to serve as temporary vice-president for the North Carolina division of the Southeastern Economic Council.

Hugh McRae of Wilmington, president of the council, announced today that Dr. Graham, at the council's request, had accepted the appointment.

Sometime during the first two weeks in November, Dr. Graham will call a state-wide meeting in the interests of the work of the council, Mr. McRae said. The gathering will be held in Charlotte.

Leaders in all lines of life in the state covering business, industry, agriculture and social fields, will join Dr. Graham in the call for the meeting, Mr. McRae said.

Raleigh, Oct. 13.—Hundreds of former N. C. State College students are expected to attend the annual fall Homecoming day to be held at the college Friday. The principal event of the day will be the annual Fair Week game between State and Wake Forest.

Two of the campus honor societies, Blue Key and Golden Chain, are in charge of the arrangements and will make every effort to insure the homecoming alumni an enjoyable time.

Friday morning's schedule calls for an inspection by the former students of the campus and buildings to see the changes and improvements made since their undergraduate days. Students will be stationed over the campus and in all buildings to direct the visitors over the campus and to point out and explain additions to equipment and curricula.

College authorities and alumni officials are extending a most cordial invitation to the alumni and promise a full and interesting day.

TWO BROKERS HEALTH BOARD ADMIT THEY KIDNAPED BOY OF DIPHTHERIA

New York Insurance Men Confess Demanding \$25,000 Ransom For Wealthy Man's Son

New York, Oct. 13.—(AP)—Two insurance brokers appeared in the police line-up today and confessed that they had kidnaped John Arthur Russell, son of a wealthy stockholder, because of financial difficulties.

The brokers, Allen W. August, 35, and George Clarke, 26, of Brooklyn, were arrested after they had returned from Cleveland.

Each is married and has a son. The Russell boy was kidnaped September 19 as he was on his way home from school. He was taken to an apartment by the abductors, who wrote a note to his mother demanding \$25,000 ransom.

Soon after the kidnaping was reported, police sent out a radio alarm. The prisoners said that when they heard of the police search they released the boy, who returned home unharmed.

FOUR HELD IN BONDS THEFT

Detectives Capture Principals in \$100,000 Larceny Case in Cleveland

Cleveland, O., Oct. 13.—(AP)—Four men were being held by detectives today as they made an effort to dispose of \$100,000 bonds in New York. One of the men was from Detroit, one from northeast Pennsylvania, and two from Cleveland. Detectives withheld information as to their names.

Detectives who had been working on the case several months said they arrested the Detroit men here yesterday as he met a Cleveland bootlegger. Together they set out to dispose of \$2,000 worth of securities. They were arrested at a downtown street corner, and later the other Cleveland man was apprehended.

BAPTISTS TO MEET HERE

Roanoke Baptist Association Chooses Greenville As Next Meeting Place

The next annual meeting of Roanoke Baptist Association will be held in Greenville on Tuesday and Wednesday after the second Sunday in October, it was decided at the twenty-five anniversary celebration which was concluded at Rocky Mount yesterday afternoon.

Rev. W. O. Blount, pastor of the First Baptist Church of Wilson, was chosen to make the opening address at next year's session. A joint committee representing both churches of Greenville will have charge of arrangements for the gathering which will bring to the city some of the most prominent members of the denomination in this part of the State.

The anniversary was celebrated in the Rocky Mount Baptist Church and seven hundred ministers and delegates, representing seventy-two churches of seven counties embracing the association, were in attendance.

One of the highlights of the session was a resolution adopted by the association to the prohibition law and supporting legislation.

Four addresses of importance were delivered during the two-day session. Dr. Arch McCree, of Salisbury, spoke Tuesday on the subject of State Mission, and presented much information concerning activities in this field.

Tuesday evening Rev. Jacob Gartenhouse, Southern Baptist missionary to the Jews, told of his experiences and result of his work. The talk was highly informative and gave his hearers an intimate glimpse of work in his field.

Dr. A. J. Barton, pastor of the Temple Baptist Church, Wilmington, spoke on the prohibition question, confining himself almost entirely to history of the prohibition movement and benefits which the nation derived from it.

HEALTH BOARD WARNS PUBLIC OF DIPHTHERIA

Dr. McGeachy Asks People To Be On Guard Against Spreading Disease

With new cases of diphtheria reported in some sections of the county, Dr. R. S. McGeachy, director of Pitt County Department of Health, warned the public today to be on their guard against further spread of the disease.

The warning was directed especially at people with children in the public schools. The health director urged parents to give particular attention to sore throats, and to keep children suffering from such a condition out of school until the nature of their illness had been fully determined.

While the situation is not alarming, Dr. McGeachy said, there is a chance of it becoming epidemic form if the public does not take every precaution to prevent such.

Twenty-eight cases of diphtheria have been reported in the county this year against forty last year, it was stated, and one-fourth of the number for this year has been reported since October 1.

Diphtheria is very dangerous, the health officers said, and the only preventative is toxin-anti-toxin. He said the health department was now prepared to administer the toxin to all children under six years of age. Administration of anti-toxin within twelve hours after diphtheria begins, the doctor said, will save the patient from death.

The health department is doing everything to cope with the situation, but all of its efforts will fail if the public fails to co-operate. It was for this reason that the director issued the warning calling on the public to be alert to the danger and to take proper steps to avoid it.

Ola Jones, wanted in Lenoir County on an alleged charge of stealing tobacco, was arrested by county officers yesterday. He was turned over to the Lenoir County officers who carried him back to Kinston to face hearing.

Full details of the case were not divulged.

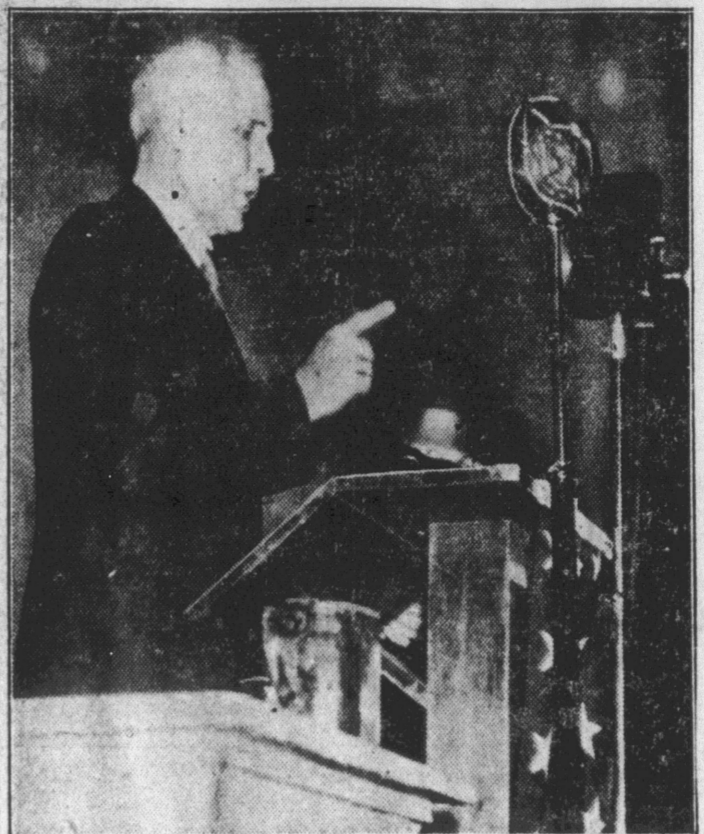

THREE INJURED IN COLLISION HEAVIER HERE

Edenton People Severely Hurt As A. C. L. Train Hits Their Truck

Golden Benbridge, of Edenton, was dangerously wounded when the truck on which he was riding was hit by the Atlantic Coast Line passenger train No. 58, operating between Kinross and Weldon about a mile north of Greenville, this morning at 10:55 o'clock.

Sarge Griffin, near Greenville, received a fractured collarbone but was expected to recover. Penridge was said to have received a fractured skull. Isaac Griffin, of Edenton, driver, slightly hurt, and Asa Griffin received a scalp injury.

The four people had been here to sell tobacco, it was stated, and were on their way home when the accident occurred. The occupants of the car said they did not see the train going in the same direction in which they were traveling. The truck was practically demolished by the impact.

The three were rushed to the local hospital for medical aid.

Although Benbridge's condition was described as critical, physicians said he had a chance to recover barring complications.

Engineer of train, B. L. Turrentine, saw the truck but could not stop.

Offerings On Tobacco Market Today Show Increase Over Those Yesterday

Sales continued light on the Greenville tobacco market yesterday but offerings were reported to be much heavier here today. Indications were, however, that sales would be completed during the late afternoon when warehousemen will begin clearing their floors in anticipation of heavier offerings tomorrow.

According to the official report issued this morning, the market yesterday sold 564,430 pounds of tobacco for \$65,439.47 at a general price average of \$11.77 per hundred pounds.

The price average showed a slight improvement over the previous day and would have been even higher had it not been for the offering of a considerable amount of the poor grades.

With weather conditions as favorable as any other period of the season, tobaccoists were looking forward to another big day tomorrow. In spite of the fifty per cent crop shortage, Greenville has registered many million pound days during the season, although offerings during the first two weeks were the lightest in years.

It was stated that there was approximately a million pounds on the floors of the warehouses this morning. Farmers from remote sections of the belt were to be seen on the floors watching progress of the sales which are conducted with rapidity and precision.

DIES IN FALL RATES ABOVE FROM PYRAMID OTHER NATIONS

American Mountain Climber Meets Death Climbing Monument In Egypt

Carlo, Egypt, Oct. 13.—(AP)—Elbridge Rand Herron, American mountain climber, slipped to instant death from the top of the great Pyramid today while trying to climb the ancient monument, one of seven wonders of the world.

Herron was a member of the German-American Himalayan expedition which recently attempted to scale Manga Tarbat. He was returning to Europe and had landed at Suez from a steamer this morning. He stopped at Carlo to spend the day at the Pyramid and intended to embark for Port Said later.

Manufacturers Of Two Countries Hail Rates As First Step Expected To Give Canada Advantage Over Other Nations, Especially United States; High Tariff Levied on American Wheat

Ottawa, Oct. 13.—(AP)—The new tariff negotiated at the recent Imperial Conference between Canada and Great Britain became effective throughout the Dominion today.

Many manufacturers hailed the new rates in favor of Canadian and British trade as marking the first step in an arrangement which is expected to give Canada the advantage over other countries, especially America and other foreign competition, and confine much British trade in the Empire.

The new schedule covers a wide list of products, a agricultural and industrial, including Canadian wheat which will enter the Kingdom free. A tariff of 4.32 per bushel on American wheat.

COAL MINER SHOT IN ILL.

National Guards Called to Help Disperse The Crowds

Taylorsville, Ill., Oct. 12.—(AP)—Ike McGuire, a miner, was shot in the face and breast by pickets who called him from his home at Hewesville today.

The firms brought national guards here to help the police disperse the crowds. The strikers returned to picket duty early this morning and six national guard companies—the largest number ever assembled here—was kept busy patrolling the highway with tear gas bombs.

Chinese Bandit Killed at Harbin

Harbin, Manchuria, Oct. 13.—(AP)—An infuriated crowd last night killed a Chinese bandit accused of killing Mrs. C. C. Woodward, an English woman yesterday, as she tried to resist the kidnaping of her three children.

The bandit was swung on a tree where the kidnaping occurred. Later his head was cut off and set up in public view.

Chinese Officer Is Mortally Wounded

Manchu, Anchioua, Oct. 13.—(AP)—Li-yi Shen, staff officer of the Manchurian Manchukuo council was mortally wounded today when he was attacked with an axe while at dinner with General Chen Shi-Yun, who succeeded General Ma-Chan Shan as governor of the district.

General Shen is also a member of the privy council.

The attack threw the government circles of Henri-Pa-Yi's regime into consternation.

Goldsboro, Oct. 13.—Mrs. Palmer Jerman, of Raleigh, former president of the State Federation of Women's Clubs, will be the principal speaker at the annual get-together dinner at 7:30 this afternoon.

The work for the coming year will be presented by the different departments of the club, American Home, Garden Club, and Literature. Other activities for the year, including working in the Red Cross sewing-romand sponsoring Girl Scout work will be presented. Mrs. C. F. Strouder is general chairman of the dinner.

HUGE WHISKEY STILL IS RAIDED IN DURHAM

Durham, Oct. 12.—A 400-gallon steam whiskey still, one of the largest captured in recent months in the county, was raided by three deputies in the Cole Mill section Tuesday and a large quantity of liquor-making paraphernalia was confiscated and brought to the court-house. A ten-horse power steam boiler, 25 cases of empty fruit jars, sixteen tubs and other equipment was seized after approximately 1,000 gallons of beer had been poured out.

Senate Seat Unlucky For Three Solons

Raleigh, Oct. 13.—(AP)—The last three state senators who have occupied seat No. 16 in the upper house of the General Assembly in the state capitol here have all died within two years after the adjournment of the session of which they were members.

The last to die was Senator Harry P. Grier of Statesville, who died at Williamston Monday.

Senator Frank Grier, 28-year-old son of the late Senator Harry Grier occupied the seat in the 1927 Senate and with a year after the session adjourned he died. His father asked to occupy the seat in 1931.

Senator Willie M. Person of Franklin, occupied the seat in the 1929 Senate and about a year after the session adjourned sine die he died.

Larry I. Moore, nominee to the Senate from the seventh senatorial district at this time, has been assigned the seat for next year's Senate. Senator-nominee Moore requested that he be given the place if elected. As his district is usually predominantly Democratic, he is expected to be elected.

FORMER SHERIFF AND BONDING CONCERN SUED

Burlington, Oct. 13.—Frank P. Rudd, former sheriff of Alamance County, and his bonding company, the National Surety Company, are named defendants in a suit for \$2,385.91, brought by the State of North Carolina in relation of Alamance County for alleged unsettled tax collections made by his office on 1928, 1929, and 1930 tax accounts.

Listed as plaintiffs are: W. S. Harris, county treasurer; F. L. Williamson, E. R. Hanford, E. C. Turner, L. E. Guthrie, and C. W. Gordon, attesting the board of commissioners of the county. The action was filed by Leo Carr, county attorney, assisted by Long & Long, of Graham. Demand for settlement has been made but payment has not been forthcoming, it is stated.

RUM WHISKEY TREASURE MAY BE FOUND BY DREDGE

Monroe, Mich., Oct. 13.—When government dredges begin the Monroe port development here, many natives will be watching the scoops for signs of an aged treasure of rum and whiskey.

Few live who recall the time, but nearly all have heard the story of how the "Favorite," out of Buffalo bound for Toledo, was caught in a storm off Monroe in 1855 and was sunk at 21 feet of water after the captain and crew escaped to the ice that skirted the shore.

Two hundred barrels of rum and 400 kegs of bourbon and rye were in the cargo. Several efforts were made to retrieve the cargo but none of them was reported successful.

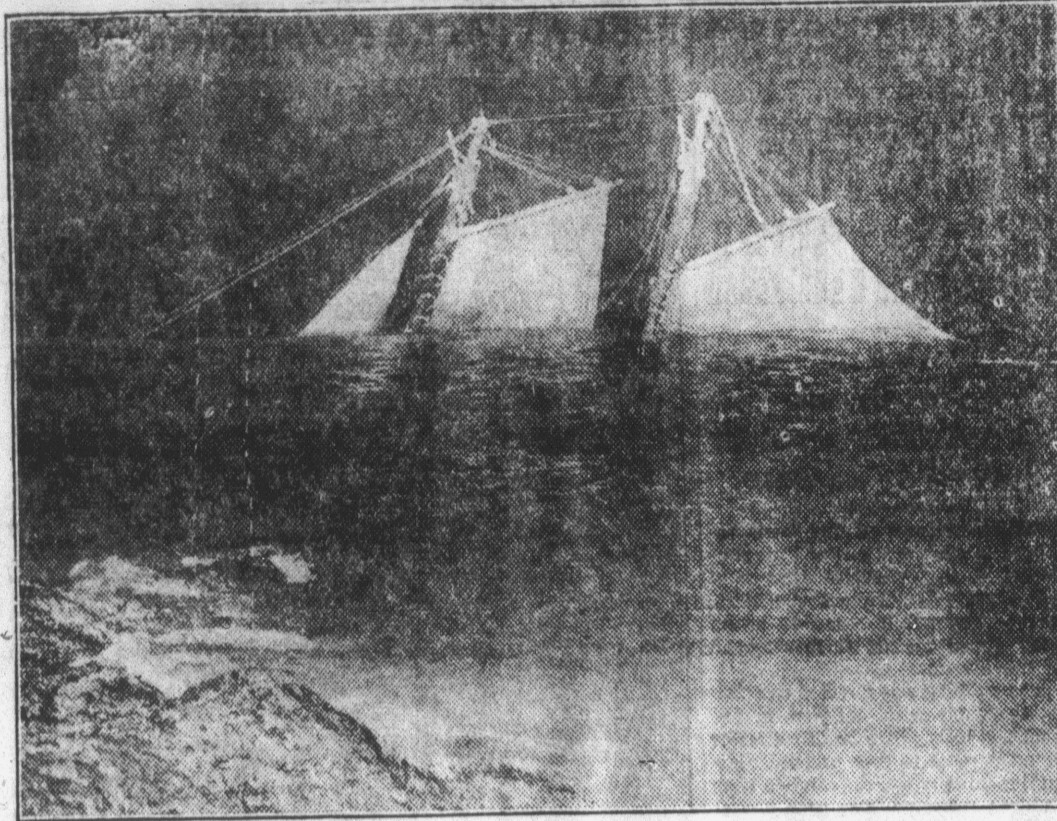

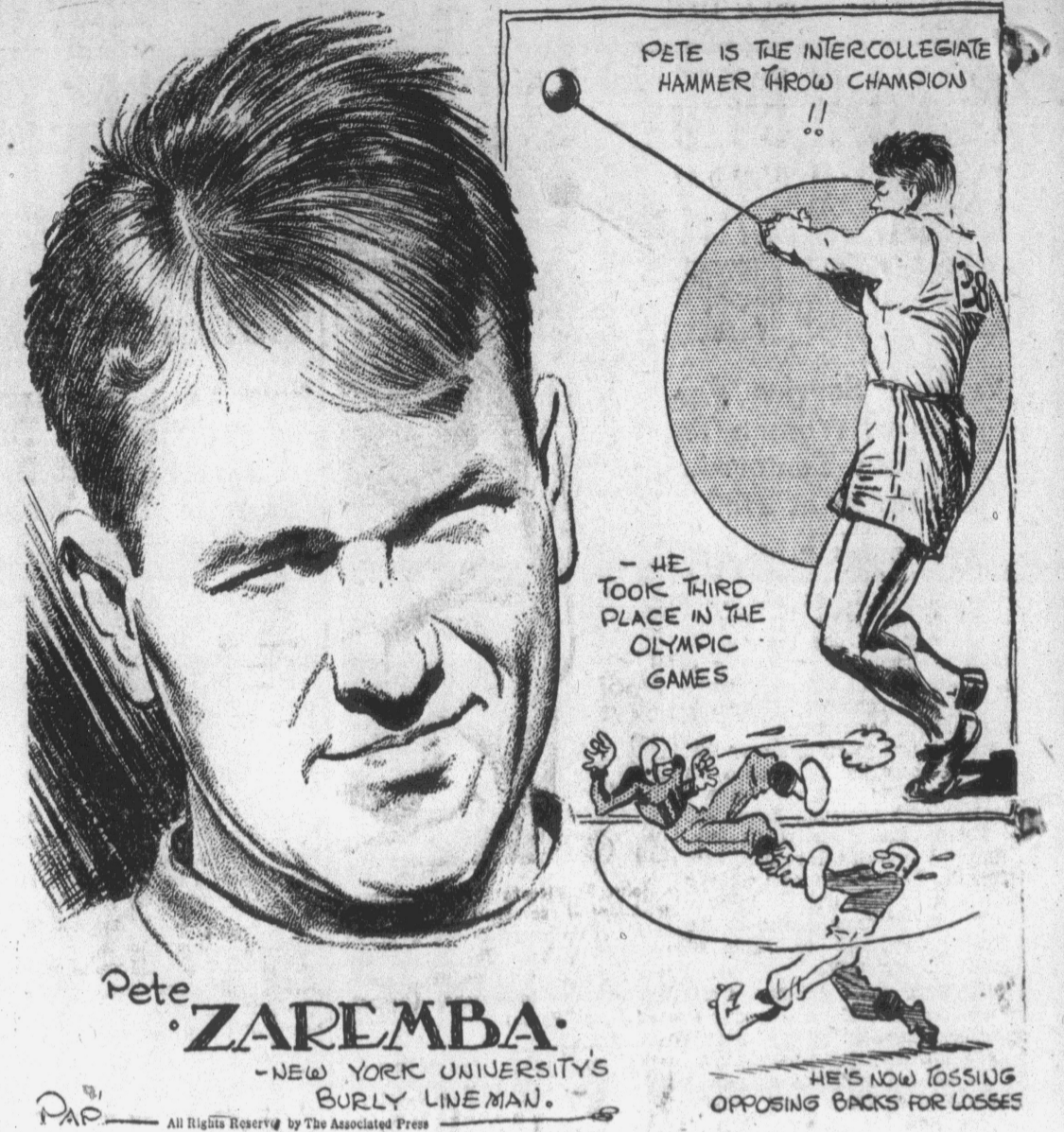

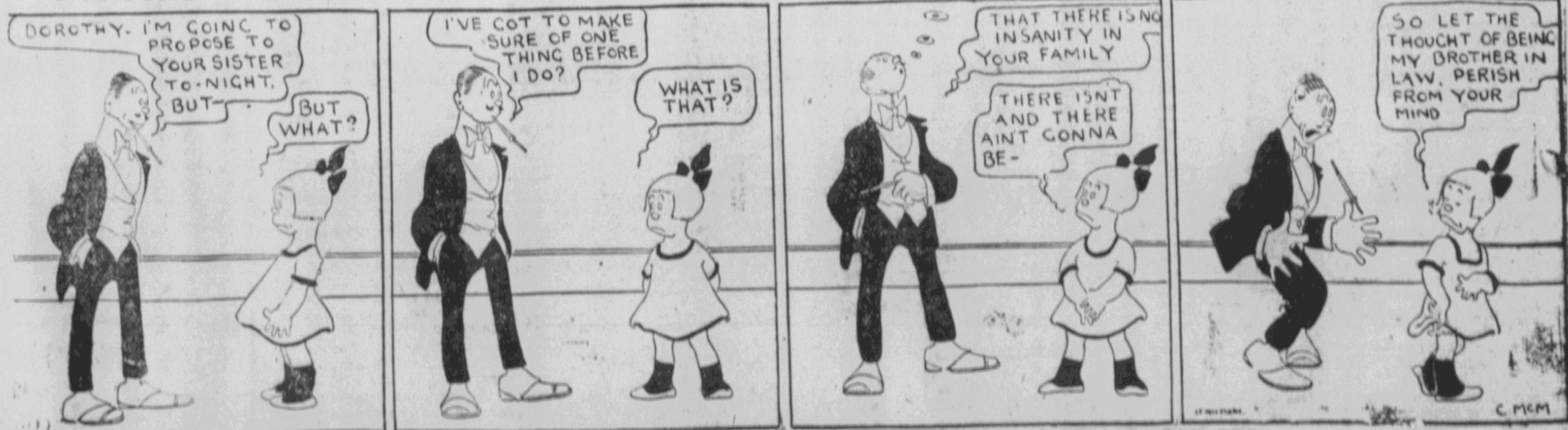

Mrs. Fleming then introduced Prof. A. D. Frank of the college faculty who spoke most interestingly on "Politicians of Today." In dealing with this subject Prof. Frank spoke of politicians as a class refraining from any personalities.

He said that the government of America today was in the hands of a small group of people—many of whom were not known even by name to the average person. As a real politician was seldom if ever an office holder. He told how the political "bosses" set up what is commonly known as "the machine" and begin operations. These men keep themselves in the background, to a large extent, but their power and influence is far-reaching. He stated that only about fifty per cent of those who are entitled to vote really go to the polls. He asserted that both parties are ready to do anything to get votes and that most politicians are "many faced," flattering the people to win their favor, thereby winning also their votes. The only thing that counts in politics is to be on the winning side.

He called those politicians who control governmental affairs "the invisible government," and said it was a dangerous thing because of the fact that they handled so much

money and had so much power. "Big Business" plays a large factor in politics, and many rich men become politicians in order to protect their own interests.

In closing, Prof. Frank said that politicians do not always give us bad government in spite of the selfish interests involved. Quoting from some authority, he said: "What we need in politics today is publicity, education and participation. If it were possible to get one hundred per cent of the voters participating in politics, going to the polls and voting in the elections, many difficulties that now confront us would be solved and the real politicians would have greater difficulty in wielding their power."

Governor Roosevelt and John Garner did not listen in on the address of former President Calvin Coolidge Tuesday night because they didn't think he would say anything that would detract from their support in the forthcoming election.

Their opinion in this connection apparently was right. Coolidge did lots of talking but the only thing he managed to leave behind him for consideration of the thousands who heard him was the fact that "extravagant Democrats" should not be permitted to gain control of the government.

The word "extravagant" cannot be correctly applied to the Democratic party in the face of the wild spending which has featured the Republican administration from beginning to end.

President Hoover made an effort to call the boys down in the last Congress, realizing that the public was watching the reckless spending with disgust, but the only thing he accomplished was the pouring of additional millions into the laps of the wealthy—big business. The President has called for economy in every department but if he has obtained anything definite it is yet to be seen.

The Democrats need not be taken aback by Coolidge charges. He had to say something, and he didn't have anything else to say he naturally tried to place responsibility for the treasury shortage on the shoulders of the opposite party, which, according to present indications, is fairly able to stand it.

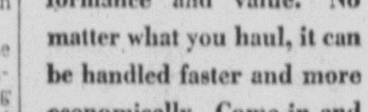

The Carolina line has been performing splendidly and consistently every game, with Underwood at center, Barclay at guard and Walker at one doing most of the searing. Its strength as a unit would be much lessened, however, if injuries kept the powerful Hodges out at left tackle.

The big fellow insists he's going to be ready, but Coach Collins is contemplating emergency shifts and taking no chances. Jim Tatum, reserve left tackle, and Bill Collins, reserve right tackle, are both being groomed for much service and are both looking good.

And in a pinch, Coach Collins can shift Frank Smith, regular right tackle who played left tackle last year, or June Underwood, star center who was converted from a regular right tackle this year, and who has played left tackle on occasions in the latter event he is getting the reserve Gordon Melver ready to step into Underwood's shoes at center. Melver got into action last Saturday and looked good under Tennessee's heavy fire.

Scanning NEW BOOKS

By JOHN SELBY
New York, Oct. 12.—Unlike Nature, the books business ordains its freshets in the fall, just after the first of October to be exact.

There has been the unusual flood, and inevitably some good books will go over the spillway, perhaps never to be recovered. Among these will not be Lion Feuchtwanger's new "Josephus."

"Josephus" is a first rate historical novel—that is one reason; a second is the clarity of the lens through which Her Feuchtwanger has viewed the tempestuous period of which he writes. The Rome of Nero, Vespasian and Titus had continually buzzing in its ear the Avengers of Israel, whose stings eventually brought down the wrath of the Empire on their heads. The emotional, racial and historical values of this situation are as tangled and yet as vital as any in history.

Herr Feuchtwanger has presented the tangle with such fairness, has maintained his epic stride with so little drum-beating on the side, that he has in the end made a distant and not particularly appealing period seem as alive and contemporary as Mayor Walker's round-trip to Italy.

The Depression
The depression affects Warwick Deeping and Catharine Brody differently. The evidence of "Smith" shows Deeping even yet a believer in what a past era considered "the eternal verities"; in the end his battered, ill and put-upon carpenter reaches a cooperative haven, opened to him by a benevolent philanthropist. Smith's path is made to seem authentic, and his steps thereon are followed with sympathy.

But Miss Brody's is a bitter and direct story of failure and privation shocking horrible and leading by a straighter path than Deeping's to murder and worse. Miss Brody does not stop by the way to theorize, although it is almost impossible to read her "Nobody Starves" without developing a theory or two for oneself. And the writing is sincerely simple, and not the affected simplicity now so madish in the literary younger set.

The Drama
In such a full week there should be (and is) something for everyone. Lee Simpson's nicely decked out "The Stage Is Set" for those interested in the theatre, for example, and Frank B. Linderman's "Red Mother" for the considerable of audience likely to relish a poetic pine stump near the Kinston road.

Norman Thomas' "What's the Matter with New York" is material for the politically minded, as is Victor Rosewater's version of what happened 20 years ago between Taft and Roosevelt, called "Backstage in 1912." And for the children there's Mrs. Martin Johnson's stories of taming quaint beasts in "Jungle Pets."

Study Past State-by-State Votes in Making Your Forecasts

New Jersey's vote in 1928 Hoover 925,285; Smith 616,162. New Jersey voted for Woodrow Wilson, president of Princeton University in 1912. But its record of Republicanism in presidential elections is unbroken since 1896. Republicans won by three to one in 1920 and 1924. Prohibition has been a paramount issue since 1920, and New Jersey's only Democratic senator since the inauguration of popular election was Edward I. Edwards, elected in 1922, and off year, on a wet platform. Governors in non-presidential since 1920 have been Democrats, and wets.

In the senatorial election of 1930 Dwight W. Morrow (R) defeated Alexander Simpson (D) with 601,497 votes to 401,007. Morrow's declaration for prohibition repeal largely removed that issue from the campaign.

Gov. A. Harry Moore (D) was elected governor in 1931 with 735,504 votes against 505,451 for David Baird Jr., (R). He succeeded Morgan F. Larson (R).

The prohibition planks of the two parties and their economic programs have been major issues in the current campaign. Republican leaders have professed a belief that a part of the personal following of Alfred E. Smith may be swung to the Republican column.

New Jersey's electoral votes are increased this year from 14 to 16.

Washington's only election since 1928 was that for congressmen in 1930. In these contests the total Republican vote in all districts was 247,723 and the total Democratic vote 167,779.

Gov. Roland H. Hartley (R) was defeated for re-nomination in this year's primaries, after a campaign in which he was assailed by some leaders within his own party. The pre-primary campaign dealt mainly with local issues. The total vote in the Republican primary was approximately 215,000 and in the Democratic primary approximately 185,000.

Washington's interest in power questions has been both Seattle and Tacoma having city owned systems. Economic programs of the opposing parties have been of major interest in the current campaign.

Washington has eight electoral votes this year. It had 7 in 1928.

Mississippi's vote in 1928 Smith 124,539; Hoover 27,153. Mississippi, which has nine electoral votes this year instead of its former 10 has voted for every Democratic candidate since the reconstruction days.

Herbert Hoover's vote in 1928 although less than one-fifth of the total, was the largest cast for a Republican candidate in 44 years. Alfred E. Smith and his views on prohibition formed the principal issue.

The Republican party offered no ticket in the state elections of 1931. Hence the vote in that year offered no direct indication of change in the status of the two parties. In the Democratic run-off primary of that year the total of votes cast for the two candidates was 316,608, more than double the total for both parties in 1928.

Redistricting of the state this year has caused a factional split among the Democrats, with two sets of candidates seeking the state's seven congressional seats. Both factions, however, are supporting the national ticket and party leaders say the dispute will not affect the presidential election.

The Republican party seldom offers a ticket in Mississippi's state elections, although it is customary to nominate congressional candidates to run along with the presidential elections.

Washington, Oct. 12.—(AP)—New Hampshire's senior senator, the witty sharp-tongued George Moses usually comes first to mind when mention is made of the Green Mountain state's representation in the Senate.

Moses' wit, wisdom, wise-cracks and satire are responsible for that.

New Hampshire's other senator, elected the same time as Moses and who has served only four months less than he—Henry Wilder Keyes—is not only less generally known, but perhaps is as little known nationally as any of the senators.

Senator Keyes, 69 years old, florid faced and with hair almost white, makes few attempts to step into the limelight of the Senate. He has served 14 years in the Senate, is secure in his seat until 1937, but it is a rare thing for him to make a speech.

To see Keyes in action it is necessary to drop in on a meeting of the committee on public buildings and grounds. As chairman he does most of his talking there.

Keyes might also be seen in action later this fall when Harvard plays Yale in their annual football game. He'll be there doing a lot of talking for Harvard.

He hasn't missed a Yale-Harvard game in years. As a matter of fact for the last 40 years he seldom has missed an important athletic event in which Harvard took part.

At Harvard he was a quarter-mile runner and a member of the football squad. Rowing, however, was his specialty.
