GOV. GARDNER RAPS REPUBLICAN PARTY HERE

Record Vote is Expected Tuesday

HEAVY VOTE SEEN IN ALL PARTS NATION

Survey of Associated Press Shows 46,965,230 Voters Will Be Eligible to Take Part in Election.

Washington, Nov. 2.—(AP)—Voting precincts in nearly every city, town and village in the United States will be the converging point next Tuesday for the greatest army of voters in the nation's history.

Approximately 7,000,000 voting places will take care of the enormous vote, it was revealed in a survey made by the Associated Press. Based on the total number of persons eligible to vote, the survey indicated that 46,965,230 people would go to the polls, an increase of four and a half million over the previous record in 1928 and over ten million of the actual votes cast in the Hoover-Smith contest.

How many of the qualified voters will exercise their right to vote is a matter of conjecture. Some election experts believe the "stay-at-home" vote normally about 15 per cent will be greater this year. Others arrived at a lower figure. It calculated on the basis of 15 per cent the actual vote will be around 40,000,000 an increase of more than 3,000,000 over 1928 when 36,789,669 total was reached.

State Baptists Will Meet Soon In Queen City

Charlotte, Nov. 2.—(AP)—Hundreds of delegates from every sector of North Carolina are expected to gather here November 15, 16 and 17 for the annual meeting of the Baptist State Convention at the First Baptist Church.

There are now something like 500,000 Baptists in North Carolina and every church in the denomination is expected to be represented at the annual State meeting.

Of unusual interest this year will be the election of a general secretary of the convention to succeed Dr. Charles E. Maddry, who resigned some months ago to become secretary of the promotion committee of the Southern Baptist Convention and who has recently been made executive secretary of the Southern convention's foreign mission board.

Since the resignation of Dr. Maddry, M. A. Huggins of Raleigh, has been acting as general secretary. The convention also will be called upon to elect a treasurer to succeed the late Walters Durham, who died several months ago, and a recording secretary to succeed the Rev. C. S. Greene of Durham, who has accepted a pastorate in Virginia. Mr. Huggins has also been acting as recording secretary.

Dr. J. Clyde Turner of Greensboro, is convention president and Dr. J. Powell Tucker of Raleigh will preach the convention sermon.

Minor League Plan To Cut Expenses

St. Louis, Mo., Nov. 2.—(AP)—Radical changes in the administration of the minor leagues through the National Association of Professional Baseball Leagues will be proposed at the convention in Columbus, Ohio, December 7, 8 and 9.

Among the significant recommendations to be made by the five members of the executive committee—William O. Bramham, chairman; Warren C. Giles, secretary; J. Alvin Gardner, Joseph F. Carr and Ross C. Harriott are the following:

Putting teeth in the salary limits by requiring the player and club president to sign affidavits to the salary paid, providing a player may be placed on the ineligible list for two years for a false affidavit and the fixing of a club 20 per cent of maximum monthly salary limit.

The lowering of the player limit as follows: Class AA, 17 men; class A, 15 men; class B, 13 men; class C, 11 men.

ASKS SUPPORT OF RED CROSS

Governor Proclaims Period of Nov. 11th to 24th for Roll Call Observance.

Raleigh, Nov. 2.—(AP)—Governor O. Max Gardner, asserting "No agency, governmental or otherwise, has performed a nobler service to our people than the American Red Cross," today proclaimed the period between November 11 and 24 as a special time for the annual Red Cross Roll Call in the state.

The text of the proclamation follows: "No agency, governmental or otherwise, has performed a nobler service to our people than the American Red Cross."

"In North Carolina alone this organization has assisted in the feeding of about 75,000 families and has helped in the clothing of at least 55,000 families. In this great work 11,000 barrels of flour and 879,000 yards of cloth have been distributed. The administrative cost of this distribution has been borne by the Red Cross."

"To continue this relief work during the coming winter, it is essential that the Red Cross receive the generous support of our citizenship. The annual roll call will be held between November 11-24 of this year. The membership goal in this state is 95,000."

"Now, therefore, I, O. Max Gardner, governor of the State of North Carolina do proclaim the period beginning with Armistice Day and ending with Thanksgiving as the annual roll call of the American Red Cross. I sincerely hope that our people will join this great organization and help the Red Cross help others."

SEES NEED OF MORE GRAINS

Short Corn Crop Has Produced Pronounced Grain Shortage in This State.

Raleigh, Nov. 2.—(AP)—Because of the prevailing short corn crop over North Carolina, a vital need exists this fall for the planting of more small grain and increased acreages of both wheat and oats, at least, should be seeded at once, Enos C. Biss, extension agronomist at N. C. State College, said today.

Blair pointed out that the harvest from these grain crops will be available next June, while another crop of corn will not be harvested before October, 1933. Oats, he said, may be fed to horses, mules, cattle and poultry while wheat may be ground for flour and also used for hogs and poultry.

In preparing for a small grain crop, well drained soil of good fertility is essential.

ROOSEVELT AIDS CHILD

To Send Crippled Girl to Georgia to Receive Treatment At His Expense.

Worcester, Mass., Nov. 2.—(AP)—There is one girl in the city whose heart is filled with happiness and joy.

She is Catherine Murphy, 5, who for two years has been corresponding with a man suffering from the same ailment—infantile paralysis. Her hero came to town yesterday—Franklin D. Roosevelt, Democratic nominee for the presidency—and while the crowd stood around in the rain Roosevelt invited the child into his car.

After a short talk with the child's parents, Roosevelt decided that Catherine should go to Warm Springs, Ga., for treatment at his own expense.

CHARGES MAN WITH SLAYING

Condemned Negro Accuses Another Of Slaying Two Men at Cummock.

Sanford, Nov. 2.—(AP)—The trial of Elvin White and Charlie Myers on a charge of double murder was continued today after a third negro condemned to die in the electric chair in the same slaying, had accused White of the crime.

Harvey Wallace, a mulatto, took the witness stand for the state as the trial opened and said White shot to death N. H. Perry and Thomas Beal in Perry's store at Cummock last June 18.

The trio fled after the shooting but Wallace was captured, tried and convicted. He was sentenced to die in the electric chair at Raleigh.

Rob Bank of \$2,000. Catawba, Nov. 2.—(AP)—Robbers entered the Peoples Bank last night and opened the vault with an acetylene torch and escaped with \$2,000.

Charles B. Gilbert, cashier of the bank, discovered the robbery when he came to work this morning. He said thieves had broken a lock on a back window and had forced the lock on the front door with an acetylene torch.

They burned a hole through the inner safe large enough to reach through. Dr. F. Y. Long is president of the bank. He stated today that the loss was covered by insurance.

Judge Completes Jail Term. Raleigh, Nov. 2.—(AP)—John H. Harward, of Erigon City, former special judge of the Superior Court, was released from the State's Prison today after completing required service of a one-year term for mutilation of court records.

The former jurist entered the prison in April and was given advantage of a 74-day reduction in sentence for good behavior. He pleaded guilty to charges that he tampered with records of the State after his daughter, Lola Harwood, had been charged with embezzlement of State funds while working in the Revenue Department.

Miss Harwood is serving a sentence of two years.

Deputy Sheriff Killed. Later, Mich., Nov. 2.—(AP)—A deputy sheriff was shot and killed and a bandit was wounded fatally and another officer was seriously wounded shortly after noon today in a gunfight which ensued when officers were sent to a farm house to question the occupants about a bank robbery last July. Three persons were arrested.

JAPS CLASH WITH CHINKS

Chinese Lose Thousand Men in Two Engagements in Manchuria.

Harbin, Manchuria, Nov. 2.—(AP)—The Japanese military position in the northern portion of Manchuria was menaced today by the Chinese wedge aimed from the north and west of the city of Tsihar.

Operations of the wedge were noted in Japanese military reports disclosing that two fierce battles had been fought near the city and that the Chinese were already in control of northwestern Manchuria and were massing their troops along the western end of the Chinese railway.

Two battles were fought Monday between Japanese reinforcements and Chinese irregulars whose presence in the area had drawn the Japanese troops here.

The Japanese claimed victory in both engagements at a cost of 33 killed and wounded. They said the Chinese dead and injured numbered 1,000.

NEGRO DRAWS PRISON TERM

Luke Daniel Sent To State Pen for Fifteen Years on Assault Charge.

Charged with criminally attacking a twelve-year-old colored girl, Luke Daniel, a Fountain community colored man, was sentenced to fifteen years at hard labor in State's Prison by Judge W. C. Harris, of Raleigh, presiding over the criminal term of Superior Court here yesterday.

Although the negro denied the charge the girl testified that he attacked her and actually accomplished his purpose.

Several other cases were disposed of during the day, but the majority were of a minor nature and only slight time was consumed in final disposition.

F. A. Edmundson, of Greenville, charged with abandonment, was ordered to pay his wife \$40 a month for the support of their family with provision that he report at the January term of court to show that he had added, by the court's ruling.

Convicted of the larceny of a small quantity of tobacco from a barn, Lee Hill, colored, was sent to the roads for twelve months.

Art Newton, colored, was given four months on the roads for setting fire to a section of woods in Fountain Township which resulted in heavy timber loss. Joe Forbes, held in connection with the same case, was adjudged non guilty.

William Smith charged with stealing articles of wearing apparel and a gun from a home while the family was away, was given twelve months on the roads.

Thomas Barrett, colored, drew six months on the roads for carrying a concealed weapon and assault.

Judgment was suspended on payment of cost in the case of Daisy Paul, charged with assault on another woman near the city.

The grand jury returned a true bill against Charles Spencer charged with breaking and entering.

SEEK JURY IN CASEY TRIAL

Eight Jurors had Been Selected As Court Opened In Kinston Today.

Kinston, Nov. 2.—(AP)—From a new venire of 150 the state and defense sought to agree on four persons to complete the jury today in the case of Herman Casey who is being tried for the second time for the murder of J. C. Causey, Suffolk lumberman.

Eight jurors, all farmers, were selected yesterday after a venire of 225 was exhausted. The court hoped to complete the jury today and begin the presentation of evidence.

Casey was fatally shot July 4, 1910, and his body was placed in an automobile on a road near here and set on fire. Casey was convicted of first degree murder in the first trial but gained a new trial after the date of his electrocution had been set five times.

U. S. DEFICIT STILL GROWS

Gross Debt of Nation Shows Increase Of Over Two Hundred Million Dollars.

Washington, Nov. 2.—(AP)—A deficit of \$529,889,093 for the first four months of the present fiscal year was disclosed today in the statement of the treasury of the United States.

Income tax receipts for the period were \$187,768,563 as compared with \$339,121,623 for the same months of the fiscal year 1931.

On the other hand the internal revenue receipts showed a tendency to increase. They were \$247,735,169 as compared with \$189,661,371 for the previous period.

Total receipts so far were given as \$559,358,377 as against \$703,629,674 last year. Expenditures thus far in the present year showed a decline under last year, the current total being \$1,189,821 as compared with \$1,364,789 during the four months a year ago.

The total gross debt on October 31 was \$20,812,541,000, representing an increase of \$200,000,000 over the total record on Sept. 30, 1932.

TELLS OF CUT IN N. C. TAXES

The Chief Executive Points with Pride to Economies of Government Made by Democrats in North Carolina; Charges Republicans With Responsibility For Low Prices of Farm Products and Suffering Among Growers.

Making what the State Democratic Committee described as the "most important speech of his campaign," Governor O. Max Gardner told a gathering of Democrats from five counties here last night that Franklin D. Roosevelt, Democratic candidate for the Presidency, "will purge the Federal Government of the favoritism that has infested it from Harding to Hoover by insisting on a new deal."

The address was heard by probably the largest crowd ever attending a political speaking here. The courtroom and balcony of the county courthouse were crowded to overflowing and an amplifying system had to be erected at the last minute to take care of those who could not get into the courtroom.

Governor Gardner was accompanied to Greenville by Mrs. Gardner. They were guests at dinner at East Carolina Teachers College where the Governor told several hundred students that the present economic upheaval would make better men and women of them and help them to more completely appreciate the value of a dollar. He was presented by Dr. R. H. Wright, president of the institution.

This was a gala occasion for the college. The students gave him a most enthusiastic welcome.

President Wright was very happy in his introductions. Congressman Lindsay Warren recognized the introduction in a few words: "I am very grateful to be here in this great institution that we have in North Carolina. Ever since it was established, I have taken a deep and keen interest in it, and in this era of travail that we are going through the same interest that I have always had will go on unabated."

Curiosity was aroused when President Wright said: "Every man who rises to greatness has some power behind the throne that keeps him going forward. Our governor is no exception to the rule." Then he presented "the governor's boss," Mrs. O. Max Gardner. Mrs. Gardner won all hearts with her gracious manner as she smilingly rose and said "the governor advises me to tell you all to marry a governor."

While here the Governor and his wife were the guests of Colonel and Mrs. E. G. Flanagan at their home on Evans Street.

The speaking was preceded by a parade from Colonel Flanagan's home to the courthouse. The parade was led by members of the highway patrol, the police department, the high school band, which were followed by numbers of automobiles.

W. E. Hooks, chairman of the Pitt County Democratic Executive Committee, presided over the meeting, and called to the attention of the people the importance of re-electing their approval for Democratic candidates in the forthcoming election.

He recognized Congressman Lindsay Warren of Washington, who also urged the voters to go to the polls in large numbers and help the Democrats emerge victorious.

F. C. Harding presented Governor Gardner. He announced the administration of the Republican party in this State and declared that conditions had been such that the people under Democratic rule. He called attention to the 45 new rail routes and said the government was for once striving to give aid to the people.

# FLORIDA WILL PLAY 5 STARS AGAINST UNC

Chapel Hill, N. C., Nov. 2.—Carolina's coaching board of strategy, which played such a big part in last week's 12 to 0 victory over State, had a protracted session this morning, with Head Coach Chuck Collins and his associates, Bob Petzer and Bill Cerney, visibly worried over the Florida game here Friday at 2:30 o'clock.

"The boys looked good enough against State," says Coach Collins "but what if they suffer a let-down in form or spirit Friday?"

The most important cause for worry, however, is three of Florida's guards, Tommy Lane, "Pug" Brya and Al Osroed, and two of its best backs, Al Rogers and Jimmy Dorsett, were benched last Saturday when Florida lost to Georgia. These boys are back in heavy action this week, and Coach Collins figures Charlie Bachman to have a team of great potential power due for an "on-day" and a comeback Friday.

The 'Gators tied the Tar Heels 0 to 0 last year, and have a large sprinkling of veterans back from that team including the wheel-horse backs, Al Rogers, Bill Culler and Jimmy Hughes, and the great center, Bill Perazzi.

The latter is slated for a real duel with June Underwood, Carolina's star center, and Rogers will get a fine chance to show his great punting ability when he engages Henry Burnett, Carolina's sensational little left-footed kicker.

The invaders also have one of the finest crops of sophomore talent they have had in years. Tommy Lane and "Welcome" Shearer have already crashed first string line berths, and the backs have been even more out-

standing. Herb McAnly ran 105 yards for touchdown against Sewanee. Stoltz is already being called a "second Crabtree." And Henderson and Moyer passed Florida to touchdowns against mighty Georgia.

Florida's PolinalwanireMihrdhrdltuu Coach Collins is working Carolina's linemen overtime in an effort to prepare a defense to snare and stop these speedy drivers, while further priming and polishing the Carolina offense to make that last yard against a superb goal line stand like Florida makes.

The star punters, Burnett and the fine place-kickers, Lassiter, are working long and hard at their specialties, for the issue may turn on toe-work if Florida cashes in on its potential power and comes back Friday as Carolina came back against State last week.

Coach Collins is fairly well satisfied with the defensive play of both Carolina lines, but he is trying to perfect the blocking and timing and to instill still more drive and punch into the offense.

Charlotte, Nov. 2.—(AP)—After playing ball with the big, bad boys across the railroad tracks, the University of North Carolina has come back to its own ard for the remainder of the football season to show its "brother's tricks it has learned."

Brother N. C. State got the first lesson Saturday, and a sad and stern one it was. By their 10 to 0 victory the Tar Heels served notice on this section that maybe they can't lick Vanderbilt, Georgia Tech and Company, but Florida, Davidson, Duke and Virginia had better watch out.

The victory tumbled the Wolfpack abruptly from the State and Southern Conference undefeated ranks and put the Tar Heels well in the running for the State championship. Duke is the unquestioned leader in that conference now, but if Chuck Collins' charges can take Davidson and the Blue Devils, the crown is theirs.

The Tar Heels are about as devoid of individual stars as they have been in a decade, but Collins seems to have the team functioning as a machine now.

A great welcome awaited Duke's valiant Blue Devils as they rolled in from the hills of Tennessee. If there were any doubting Thomases they learned Saturday that Duke is part of the cream of the Southern Conference.

Freddie Crawford, brilliant tackle, undoubtedly is this State's leading candidate for All-Southern honors. His defensive play has been sterling all year, but Saturday he decided to take a hand at the offensive and snagged a Vol pass, returning it 70 yards for a touchdown to set Duke in motion. A drop-kick knocked the

Devils out of a 13 to 13 tie which would have messed up the Southern Conference picture.

Charlie Pearce, Davidson's seasoned left-footed, left-handed back, gave one of the finest performances of his grid career when the Wildcats and Clemson tied, 7 to 7, Saturday.

Undeafening Delaware, Wake Forest uncovered a new scoring threat in Myers, fullback, who punched across the only touchdown and then bucked over the extra point for the 7 to 0 victory.

North Carolina opens this week's schedule by receiving Florida at Chapel Hill Friday. State and Davidson clash at Charlotte Saturday and Duke and Kentucky mingle at Durham. Wake Forest goes to Washington to meet Catholic University.

Catawba's Indians, tutored by that sports veteran, Charlie Moran, were several leaps ahead of the field today in the Little Six Conference and its only undefeated member. The Indians bumped off Guilford 20 to 7, Saturday, while Elon, getting its conference baptism, lost to Lenoir-Rhyne, 12 to 7.

Catawba meets Erskine at Due West this week; Elon plays High Point at High Point, and Guilford and Lenoir-Rhyne clash at Hickory. Although he went scoreless this week, Bob Cox, of Duke, continued to hold the scoring lead in the Big Five with twenty-seven points. Captain Lowell Mason, Duke, and Ray Rex, State, are next in order with twenty-four points.

## Hints on Contract Bridge Up-to-Date

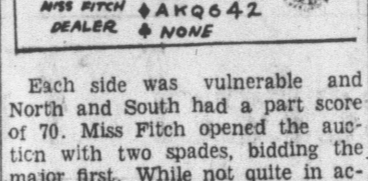

Clue In Overall

A bid by an adversary often gives a declarer a tip on how to make a difficult contract. Indeed, an overcall may prompt the declarer to redouble successfully.

Two outstanding New York women players won a large rubber by making five diamonds redoubled vulnerable after a vulnerable ad-

versary had bid two no trump. The offer of no trump enabled the declarer, Miss Florence Fitch, secretary of the Deschappelles Club, to determine what adversary had in one suit.

Miss Fitch had Mrs. Hilda Maude Zontlein as partner in the following deal:



Each side was vulnerable and North and South had a part score of 70. Miss Fitch opened the auction with two spades, bidding the major first. While not quite in accordance with requirements for an original two bid, Miss Fitch's hand was a powerful two-suiter with slam possibilities if partner should have an average hand.

West and North passed and East bid two no trump, a fatal step. Had East passed, Miss Fitch would have made game and rubber with a point, total considerable less.

Over the two no trump Miss Fitch bid three diamonds. West stepped in with an offer of three

hearts. North's hand was so weak that she dared not choose between spades and diamonds. She passed. Each bid four hearts and Miss Fitch bid five diamonds, which East doubled on high card strength in either suits. The dealer redoubled. It was a chance taking redouble, prompted wholly in view of North's silence, by the two no trump bid from East.

The declarer lost two heart tricks at the start and then took out trumps. She deduced that the two no trump bid by East over the original two spade bid could mean nothing but possession by East of at least four spades to the knave.

With trump trumps in the dummy it was easy to finesse so that all the spades in the declarer's hand took tricks. West and East making only two hearts.

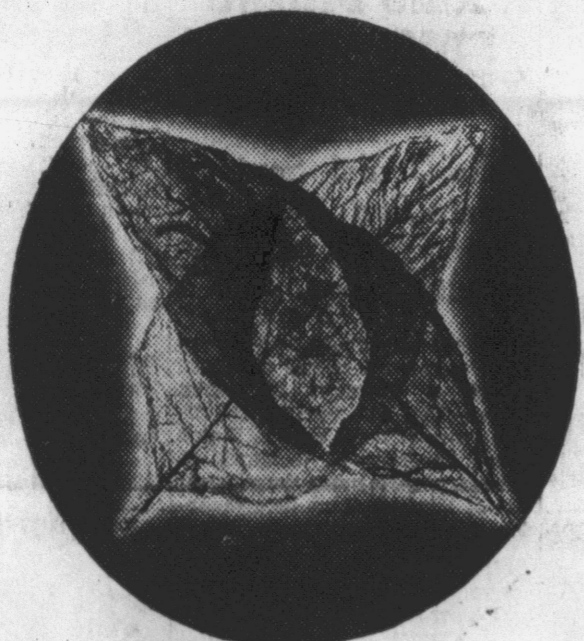

of the season will be light, although a few more million pound days may be in evidence from time to time as farmers from a long distance join growers of this community in marketing their offerings.

The official report of sales made public today by K. W. Cobb, supervisor of sales, indicated that the market yesterday sold 364,228 pounds of leaf for \$46,171.94 at a general average of \$12.68 per hundred pounds.

The highest price average of the season was set on the market Monday when over a million pounds of leaf was disposed of. The price situation continued strong yesterday on good grades of tobacco, but the average was not as high as the day before due to the marketing of considerable common tobacco generally accompanying the tail end of the crop.

### Talks to Parents

#### THE THREATENING TONE

By Alice Judson Peale

A two and one-half-year-old child who had picked an object off the floor and was about to thrust it into his mouth was told by his mother: "Don't put that dirty thing in your mouth. You'll get sores!"

Whereupon the child burst out crying: "I don't want sores. Please, Mummy, don't give me sores!"

The warning had been interpreted as a threat. The child thought quite logically that if it was to get sores it must be mother who would give them. For just as mother to the little child is the author of all comfort and pleasure, so, too, she must be able to punish in whatever way she chooses.

One wonders how often well intentioned warnings are misinterpreted in this way. Certainly a mother's tone of voice on such occasions frequently gives the child reason to think he is being spoken to in anger.

Many a groundless fear of childhood and a good deal of sulen contrariness could doubtless be traced as a reaction to some such misunderstanding. The young child still is so inarticulate that the cause is brought to light only by accident.

It is best to avoid the use of the threatening tone. The child responds to it emotionally rather than purposefully. It is besides unnecessary. The child's natural confidence in his mother will lead him to relinquish an undesirable sort of play simply because she quietly asks him to and distracts his attention at the same time into other channels.

Only when he is able properly to appreciate cause and effect in the immediate situation is there any sense in a more pointed warning. Even then the mother's voice should suggest caution rather than fear.

A six-year-old boy who followed his mother about like a devoted puppy and who had known from her only gentleness and love suddenly was whipped by her one day for some minor wrong-doing. He never forgave her. He is now a grown man, but the feeling of hate and cold antagonism that grew out of the incident have remained.

How is it that one child will remember bitterly a single spanking

and hold it his entire life against the parent who administered it while another who is cuffed and knocked about nevertheless develops no lasting grudge and is able still to feel love toward those who have beaten him?

The child's sensitiveness to such experience probably is due not only to varying inborn factors, but also to the atmosphere in which it spends its first years.

In many homes the child is treated with the utmost gentleness and indulgence until he loses his baby appeal. Then suddenly he becomes painfully acquainted with a new parental attitude, and it is this sudden change which does the damage.

The blows and punishments which begin to descend find him thoroughly unprepared. The effect is deeply shocking and the parent-child relationship often never recovers from the blow.

It always is dangerous to make an about face in discipline, for the child it is bound to seem both shocking and unreasonable. If your child seems less obedient than he should be, prepare him in advance for the fact that in the future you will expect more of him.

Show him in little ways that he must change in order to keep your approval. Don't simply lose your temper, let fly and then try to persuade yourself that it was high time you did something of the sort.

#### NAILING A LIE

That no stone is being left unturned by the Republicans in their frantic efforts to regain the odds in what is almost a certain losing fight for them is clearly shown in the following item taken from the front page of this week's Literary Digest that nails as a lie such last-minute propaganda evidently sponsored by the Republican politicians:

The Digest says:

On October 15 a New York brokerage house sent this statement over its wires:

It was manufactured out of the whole cloth with the obvious intention of influencing either the betting odds, or the stock market, or to throw discredit on the Literary Digest straw-vote figures.

President Hoover is trying to throw a scare into people by declaring that chaos would reign supreme throughout the country in case his party is defeated in the next election.

Speaking in New York Monday night, the President held up a picture of ruin in every field of life if the voters should accept the policies of Franklin D. Roosevelt, Democratic nominee for the presidency.

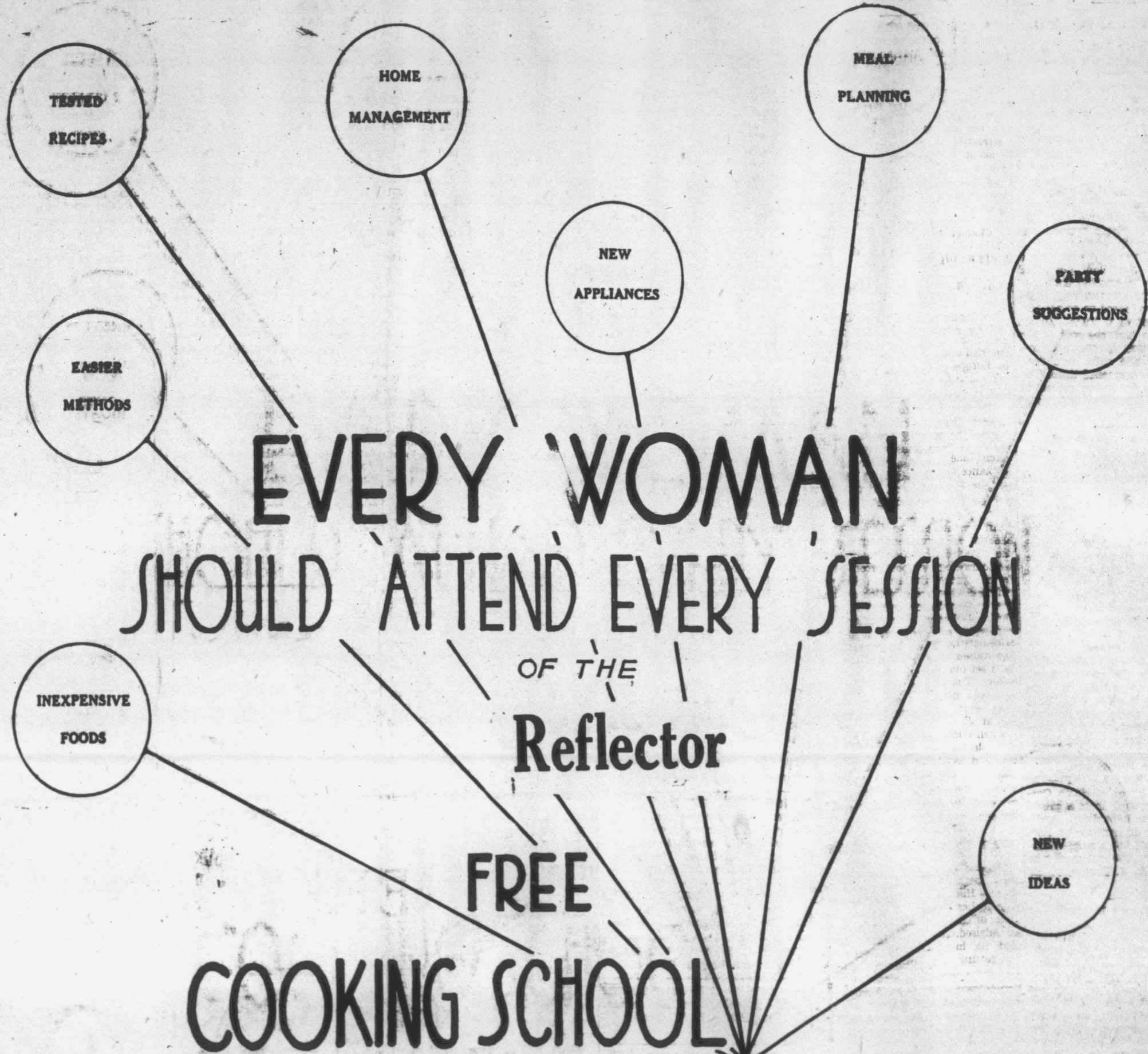

All class AA clubs shall have on their active player list at all times during the playing season; not less than two "non-class" players; class A, three; others six, and each club in classes B, C and D be required to own outright and at all times not less than ten contracts on their active player roster.

An amendment to the National Association agreement, striking at the practice of major league clubs withdrawing support from their farms during the season by providing that where any club assumes the ownership or operation of a club of lower classification and withdraws such support during the season it shall not be permitted to have a working agreement, or part or complete ownership of a minor league club at any future time, except upon posting a guarantee equal to double the maximum salary limit per club.

Elimination of the broadcasting of home games. Discontinuance of the payment of transportation of players reporting where clubs train on their home grounds, as there is no rule requiring such expenditure.

SEES NEED OF MORE GRAINS (Continued from Page One) Blay needs to be selected, Blair said. The seed used should be shallow and preferably a legume such as soybeans or cowpeas might well be disked into the land before planting the grain. Use some acid phosphate fertilizer in the Piedmont and Mountain section and let the due from the cash crops surface to the coastal plain.

To planting wheat and oats, Blair said it is better to use a grain drill than to broadcast. Five pecks of oats an acre or 2 to 3 bushels of wheat. If seeding by hand 8 pecks of wheat should be used. Fulghum and Norton oats were specially recommended. Purple straw or red heart wheat was said to be best for coastal sections and any standard variety further west.

For a full crop, Blair advised against grazing the small grain this winter. He also advised a top dressing with nitrate of soda next March.

(Continued from Page One) meetings. The subject of last night's message was "Christ's Eternal Challenge." Using these challenging words of the Lord Jesus recorded by the Apostle John (John 21:22): "Follow thou me" as the basis for the sermon, the following points were made concerning them:

Some 1000 years ago the Lord Jesus Christ challenged men with these words: "To the ordinary folk of his day they were spoken. He offered them no earthly fame, no financial reward. Indeed, He warned those to whom He spoke that, in following him, they would face persecution, misunderstanding, separation and death. Yet they left all and followed Him. In His name they opened continents, brought civilization to peoples, and wrought righteousness. But even today these great things can be accomplished today if people, young and old will only hear His voice and accept this challenge.

"Follow thou me."

What does acceptance of this challenge involve? First it requires leaving sin. What is sin? "Sin is the transgression of the law." In Proverbs 6:17-19, God, through the ancient wise man, reveals seven things that are regarded as sins, and that He hates. This is God's estimate of these matters. He despises a proud look, a lying tongue, hands that shed innocent blood, a wicked imagination, feet that are swift to do mischief, a false witness, and he that soweth discord among his brethren. (Continued from Page One) of the national administration with the frugality of the North Carolina administration.

He referred to a debate he heard in 1922 between Republican Senator Jeter Pritchard and Locke Craig for the Senate. Pritchard, he said, declared "that the hide of a bull calf was worth more under McKinley than a 1,200 pound steer under Grover Cleveland." The debate took place in the House of Representatives while the Governor was a student at State College.

"Now I submit," said the Governor, "if it was fair to contrast the price of farm products under McKinley and Cleveland, that it is nothing but proper to tell the farmers of North Carolina and Pitt County the difference between agricultural prices under Herbert Hoover and under Woodrow Wilson."

Taking Pitt County as an illustration, he pointed out that in 1919,

under Woodrow Wilson, the crop value of Pitt County reported by the U. S. Census, was \$21,000,000. In 1931, the crop value of Pitt County, under Herbert Hoover, had fallen to the "bankrupting value of slightly more than \$4,000,000."

"Here is a loss of \$17,000,000," Governor Gardner asserted; "a sum sufficient to pay the present annual property tax bill of Pitt County for over forty years."

He then pictured the situation in North Carolina. In 1929, in the first year of Mr. Hoover's administration, the crops of North Carolina sold for \$293,000,000. In 1931 the value of all the crops in the State had dropped to only \$144,000,000.

"Thus we see," stated the speaker, "that during the administration of Herbert Hoover the farmers of North Carolina have lost approximately \$15,000,000 in the annual value of their crops—enough to pay the entire bonded indebtedness of the State of North Carolina."

He declared that today the philosophy of Senator Pritchard stood discredited, and that nobody believed the Republican party has a monopoly on prosperity.

In a speech in Des Moines several days ago, the Governor stated, President Hoover delivered a speech reiterating the promises he made in 1928.

"Wheat immediately declined 15 cents a bushel," he said, "to the lowest price of all times. Cotton dropped \$12 a bale, and corn fell from the dizzy height of 20 cents a bushel to the price of fuel. They are burning corn in Iowa because it is cheaper than coal."

While the administration at Washington increased the cost of Federal Government debt by nearly \$900,000,000, the Democratic administration in North Carolina has reduced the cost of government by more than \$10,850,000, the speaker declared.

"In order to get some idea of the stupendous cost of the Federal Government under Herbert Hoover, let us compare it with the total value of all crops, of every description, grown in the United States," the Governor stated.
