ROOSEVELT WILL WIND UP HIS CAMPAIGN TONIGHT

City People Urged to Vote Early in Election Tuesday

Election Officials Hope To Make Way for Heavy Vote from Rural Sections

LARGE VOTE ANTICIPATED

W. E. Hooks, Democratic Chairman For Pitt County, Says National Election Vote May Be As Large if not Larger than Primary; Much Interest Centers in Presidential Race; State and County Offices Get Attention.

Balloting is expected to be brisk in the national election in Pitt county tomorrow and people living in Greenville and surrounding towns were today urged by W. E. Hooks, chairman of the Pitt County Democratic Executive Committee, to go to the polls early and make way for people from the country who are expected to vote in unusually large numbers.

The chairman said he was anticipating probably the heaviest vote ever before cast in a general election. He said it was quite likely the total would go beyond the primary in June when a new record was set for the state.

Pitt county rallying to the polls in exceptionally large numbers, cast a total of 7,500 ballots in the primary and Mr. Hooks said he believed the general election would see a figure equalled if not exceeded.

Interest in cities and rural community centers around the election of a President, although state and local tickets hold considerable thought.

In Pitt county, where the Democratic vote has always been in preponderance, it was believed Franklin D. Roosevelt, Democratic nominee for the presidency, would pick up the greatest vote ever recorded by a candidate for this office. Other Democrats were also expected to share in the victory.

The Republican party, as customary in a general election, as making a bid for legislative posts, the office of sheriff, two seats on the board of county commissioners and other offices, but it is generally conceded that Democrats nominated for these posts in the last primary will be elected as nomination in the past usually has been equivalent to election, because of lack of Republican strength.

In his final plea to the public last Saturday, Mr. Hooks urged the people to give undivided attention to the important business of voting tomorrow. He said it was the duty of everybody to exert his privilege of expressing an opinion as to the kind of men to fill the offices of government for the next term and urged voters to go to the polls in large numbers.

With Democrats confident of a sweeping victory, and Republicans making claims of their ability to hold office at the national capital, the returns from all parts of the nation will be watched with great interest tomorrow night. It will be the biggest day the nation has known in four years and as the outcome vitally affects the economic life of people in every field of endeavor, it is natural to presume that voting will be everything expected.

INSULL GOES TO HOSPITAL

Utilities Magnate To Rest in Athens while Waiting Extradition to American.

Athens, Greece, Nov. 7.—(AP)—Samuel Insull will remain in a hospital while his lawyers are arguing his extradition to the United States. He had his baggage moved over from his hotel today and sent out word that he would not see anyone until he had had time to rest.

On Saturday the Court of Appeals of Greece ruled that he must remain under detention until it has been decided whether he is to be returned to America to answer indictments arising from the collapse of the giant Middle-West utilities concern which he controlled.

It was stated by officials that Mr. Insull had not been convicted of any crime yet, and until he is, the Greek government will not set upon the presumption of his guilt.

MANY LET OUT OF PRISONS

Mussolini Grants Amnesty to Thousands of Prisoners in Italian Jails.

Rome, Nov. 7.—(AP)—Political prisoners, both those confined to penitentiaries and deported to penal island institutions to the number of 1,234 have been released from confinement by Premier Mussolini's decree of amnesty, the most extensive ever promulgated in this country.

Between 15,000 and 20,000 of the prisoners confined were released, the government said, and several hundred thousand were affected by the decree either by release or reduction of sentence.

HEAVY VOTE EXPECTED IN THIS STATE

Democrats Anticipating Spirited Balloting in Spite of the Inclement Weather.

The North Carolina Presidential vote was claimed today by both parties as final vote-getting efforts were underway or tomorrow's election. There was a decided let-up in forensic activities on the eve of the election. No speeches of either party were scheduled as usually are made on the last day by both parties.

With cloudy and rainy weather prevailing and unsettled weather conditions predicted for tomorrow Democratic and Republican leaders were not sure of a record-breaking vote as they have been expecting in recent weeks, but said balloting would be heavy.

HOOVER HITS SNOW STORM

President's Train runs Into Snow Fall while Crossing the State of Colorado.

Aboard President Hoover's Special Train Bound for Palo Alto, Nov. 7.—(AP)—President Hoover's campaign across the Continental Divide led him today through a snow storm.

Shortly after midnight the high mountain ground across which the Chief Executive's train traveled began to whiten and when Laramie was reached at 1 o'clock the snow had drifted into the Presidential car vestibule to a thickness of about a quarter of an inch in some places.

President Hoover was not cognizant of the storm until he arose this morning, but he had been warned by a weather-wise native of Colorado that "there was smell of snow in the air."

GIVES VIEWS ON AMENDMENTS

Julius Brown, Local Attorney, Tells Of Issues to be Voted on Tomorrow.

Julius Brown, Greenville attorney, today gave his views on the four amendments to be voted on in tomorrow's election. The amendments involve the State Constitution, and Mr. Brown in his discussion of each, shows why some would benefit the state and why others would not.

The discussion in detail follows: First Amendment.—The first amendment proposed to the Constitution, and which will appear first on the ballot, is to increase the term of office of sheriffs and coroners from two to four years, their terms of office now being fixed by the Constitution at two years. I cannot see how the body of the people can profit by or be benefited by this amendment, and on the other hand, they might and will suffer therefrom if it should become a part of the Constitution. We have no recall and referendum, which was much discussed several years ago, but our recall has been at the ballot box. There is no limit on terms or number of terms a sheriff or coroner may hold, provided the people elect them. Therefore, if a good officer, he or she may not fear the frequency of elections; but if they fall in their public trust, then the people should not be long delayed in a chance to vote them out.

OTHER TOWNS TO HEAR HIM

New Yorker to Make Speech at Beacon, Scene of his First Campaign Speech 22 Years Ago; Plans to Visit Several Towns in the Hudson River Valley, Formerly Known as Republican Strongholds.

Hyde Park, N. Y., Nov. 7.—(AP)—Twenty-two years ago Franklin D. Roosevelt, known chiefly as a young man with interest in politics, chugged down Hudson River valley in a not too reliable automobile to make his first campaign speech at Beacon.

Few Democrats and no Republicans believed he would be elected to a seat in the Senate because the district in which he campaigned had always been overwhelmingly Republican.

Today he visited the section as a Democratic candidate for the Presidency, and tomorrow voters of the nation will decide whether he will achieve the high honor.

Beacon is one of the several sections he will visit on a motor trip scheduled to leave his farm below home at 3 o'clock. He will speak on Beacon's public square, scene of his first major effort, as a campaigner for political honors.

Mr. Roosevelt will speak tonight at Poughkeepsie.

TRADE SHOWS GROWTH, U. S.

Trade with Foreign Countries Shows Big Increase Over Previous Year.

Washington, Nov. 7.—(AP)—The United States in September had a favorable balance in foreign trade of \$33,575,305 compared with \$9,843,806 in September of last year. The total value of exports last September was announced by the Commerce Department as \$132,026,055, while imports were given as \$98,447,750.

Accumulative figures for the nine months' period ending in September showed a favorable balance of \$173,175,352, as compared with a favorable balance of \$223,100,438 for the same period last year. Exports for the nine months' period were reported as \$1,188,929,041, while imports were \$1,015,748,689.

America Lacks Revolt Ardent, Says Executive

By STANLEY P. RICHARDSON Moscow, Russia, Nov. 7.—(AP)—Taking new stock of the world status of communism, the Communist International acknowledges there's no "direct revolutionary situation" in the United States and other leading countries.

It calls for increased energy on the part of the various Communist parties to hasten development.

In a declaration reflecting its disappointment that the world economic crisis had failed to bring about the long-heralded downfall of capitalism, the executive committee of the agency directing Communist propaganda urges more "revolutionary activity" among workers.

"The tabulation of capitalism is at an end," says a resolution adopted at the executive committee's twelfth plenary session, the first since April, 1931, "but there still is no direct revolutionary situation in the most important countries."

"We must not count on the automatic failure of capitalism. We must rely upon the revolutionary activity of the workers."

The resolution outlined specific programs to be followed by Communist parties in various countries. With reference to America it said: "The Communist party of the United States must mobilize the masses to fight for social insurance, against wage reductions, for immediate relief to the unemployed, assistance to farmers, the rights of workers and the self-determination of the black belt and for the defense of the Chinese masses and the Soviet Union."

Describing the present time as a transitional period which will lead to collisions between classes and countries—to revolutions and wars—the "Comintern" claims that revolutionary forces are growing in all capitalist countries but adds: "But in the very important countries like the United States, England and France, the speed of the revolutionary movement, though increasing, is still behind the tempo of international conditions." 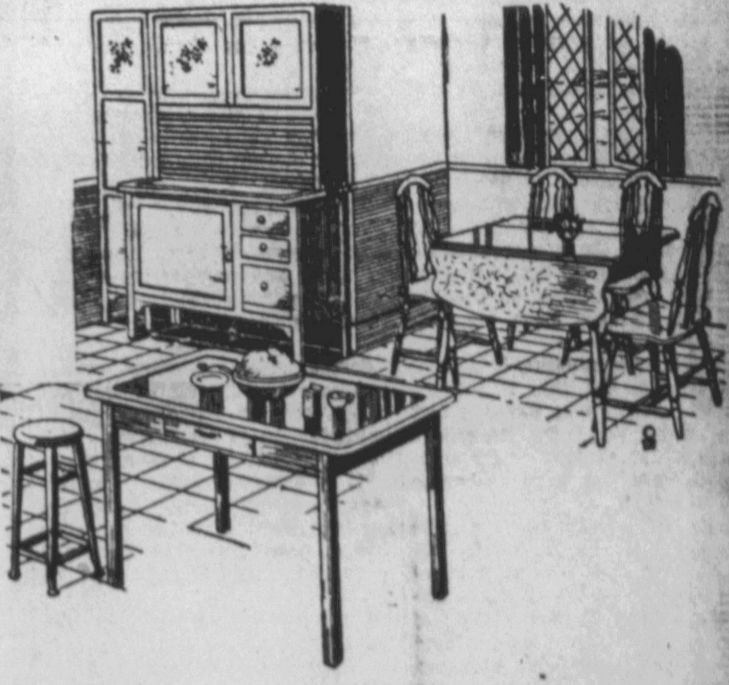

GIVES HIS VIEWS ON AMENDMENTS
 (Continued from Page One)
 ence has not required or even caused a request for a lengthening of the term. Our Registers of Deeds hold for two years. In fact the term of all county officers is for two years, except the Clerk and that was probably made four years as his is a judicial office; and the request for the proposal to lengthen the terms of office of sheriffs and coroners is not justified or required by history or experience. As a rule, the shorter the term, the better the officer.

Article 1 Section 28 of the Constitution is as follows: "Elections should be frequent. For the redress of grievances and the amending and strengthening of the laws, elections should be often held."
 It cannot be said that the people have suffered by the frequent election of sheriffs and coroners, and the Constitution in the Declaration or Bill of Rights declares that elections should be frequent and there is nothing to justify or require a change, therefore the amendment proposed should be defeated, as I see it.

Second Amendment.
 The second amendment proposed to the Constitution and which will appear second on the ballot, is intended to amend the Constitution so that in the future amendments or proposed amendments to the Constitution may be voted on at special elections. At present proposed amendments can only be voted on at general elections.
 There are several reasons why the proposed amendment should not be approved by the voters, among them are as follows:
 1st. Every special election called for that purpose would carry a heavy expense to be born by the State.
 2nd. History and experience has shown that the greatest number of

voters vote at general elections, and the Constitution should not be amended, unless every opportunity is offered to the people to express their views and approval or disapproval thereof. Then at special elections those interested, or with a special interest in the adoption of the amendment would make a special effort to get out voters who would vote for the amendment while the masses have rarely had anyone interested in getting them out in their interest and probably would have but few interested in getting them out and the result would be, the Constitution would be amended at a special election by a small vote and a small percentage of the qualified voters, and such was not intended by the founders of our government.

Third Amendment.
 The third amendment proposed to the Constitution and which will appear third on the ballot, is intended to amend and strengthen the Constitution so as to protect life insurance for widows and children against creditors of the insured. The object of this amendment is to protect and safeguard life insurance which a husband and father has provided for his wife and children from creditors during the lifetime of the insured (the father). The Constitution as it is now written protects the funds or insurance after the death of the husband and father for the widow and

children when it is made payable to them. But prior to the death of the insured the insurance is subject to the claims of creditors, especially where the right to change the beneficiary or beneficiaries has been reserved in the policy of insurance. Every father and husband should have a right to provide a fund (insurance fund) as a safeguard and shelter for his wife and children against the pitfalls of life and the ebb and flow of business. The amendment should be approved, as I see it.

Fourth Amendment.
 The fourth amendment proposed to the Constitution, and which will be fourth on the ballot, is to amend the Constitution so as to provide for Solicitorial Districts. The object of the amendment or proposed amendment is to allow the Legislature to create Solicitorial Districts in any number it may deem proper and to create Judicial Districts in any number it may deem proper. If so amended it could increase the number of Judicial Districts of the State, and not increase the Solicitorial Districts. Or if it deemed proper it could create many more Solicitorial Districts in which case the salaries of the Solicitors would probably be reduced.

It is generally conceded that we have enough Solicitors, but that we should have more regular Judges of the Superior Court. As it now stands we cannot increase our number of Judges without at the same time increasing the number of Solicitors. It would be well for the Legislature to have that power, and the amendment ought to pass.

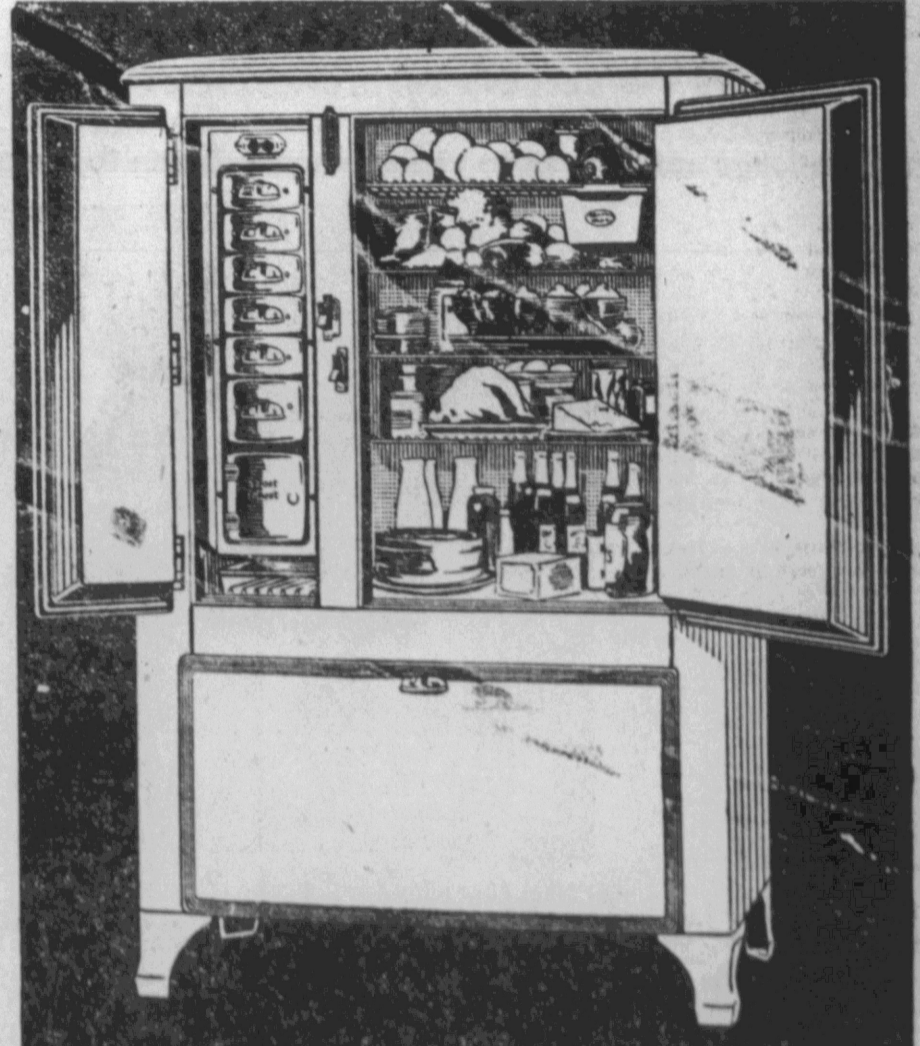

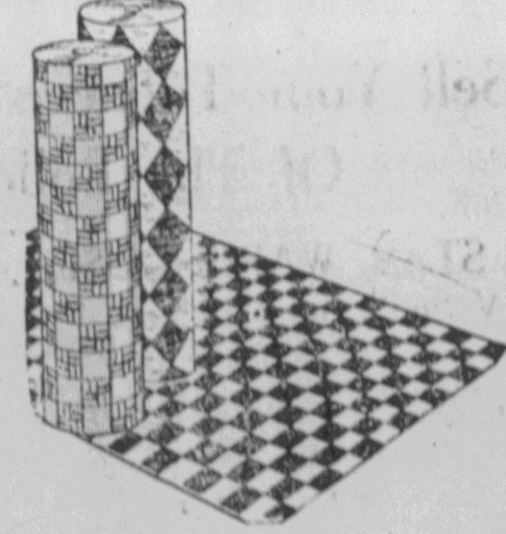

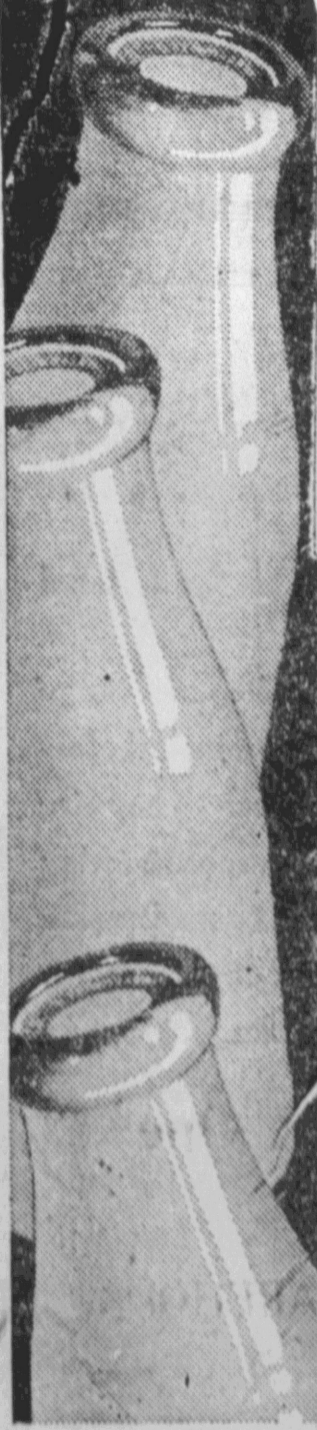

Farley Predicts Victory Tuesday

New York, Nov. 7.—(AP)—On a day-before-election statement today the Democratic National Chairman, James A. Farley, expressed opinion that "at no stage of the presidential campaign had the extent of victory he expects for Franklin Roosevelt and John N. Garner appears so overwhelming as it appears at this moment."

He said last minute reports from precinct chairmen over the country giving the best estimate as to the outcome of the district in conclusive. The vote by which Roosevelt and Garner will be elected "will surpass the fondest hopes and most optimistic predictions."

"Indications are that majorities will be much larger than had been anticipated by the local leaders in each of their districts," Farley said.

"Every bit of news that has reached headquarters in the last few days compel us to revise upward the enormity of the sweep by which Roosevelt will be elected."

"By the same token, indications force us to revise upward the number of Democratic candidates for the Senate, House of Representatives, governorships, legislature and local offices who will sweep into office by this great expression of popular sentiment."

"I have always known Roosevelt would be elected. That has not been in doubt a single moment since the Chicago convention as it may be remembered, that I said I have not much doubt about his nomination."

A Washington Daybook

By HERBERT PLUMMER

Washington, D. C., Nov. 7.—Apparently that young, robust diplomat, Francis White, Assistant Secretary of State, has succeeded again in bringing together two belligerent Latin-American nations for an amicable discussion of their difficulties.

Paraguay and Bolivia have consented to call a halt in their warfare in the Chaco. And it was young Mr. White, acting in his capacity as chairman of the neutral nations seeking a peaceful settlement of the Chaco dispute, who pulled the trick.

This is not the first time the 40-year-old Assistant Secretary of State has acted with success as a mediator between countries in disagreement. He has built up within the past few years a considerable reputation around the State Department for what his friends call his tact and diplomacy in quieting those coun-

tries to the south who have shown an inclination to fight.

His Specialty

Latin-American squabbles are White's specialty. As Assistant Secretary, he acts as a sort of general supervisor of relations between these countries, having been promoted to his present job from that of chief of the Latin-American division in the department.

When Guatemala and Honduras got into the celebrated boundary dispute it was White who got them together and paved the way for a settlement with Chief Justice Hughes acting as the neutral presiding member of the board.

When the Tacna-Arica controversy was at its height and looked for a time, as if it might explode, it was White who patiently worked with the Chilean and Peruvian diplomats in Washington and brought it to an amicable close.

And now with the Chaco situation looking more hopeful than it has in months, he may be on the threshold of his greatest victory.







Demonstrators Clash With Police Washington, Nov. 7.—(AP)—Sixteen persons were arrested and an officer sent to a hospital as a result of a clash on Capitol Grounds between a group of demonstrators and police.

The group comprising one hundred marched up the hill toward the Supreme Court building to demand freedom for eighteen negroes of Scottsboro, Ala. for attack on two white women.

Authorities had told the demonstrators that they would not be allowed to parade. There was a short but sharp struggle. Night sticks, rocks and fell. In a few minutes most of the marchers headed back the way they came.

Set Aside Negroes' Sentences. Washington, Nov. 7.—(AP)—The Supreme Court today set aside the death sentence imposed on seven negroes at Scottsboro, Alabama.

The ruling by the court means that the case will go back to the Alabama court for a new trial. The high court upheld the contention of counsel for the negroes, convicted of assaulting two white girls that they had not had a fair trial.

Justice Sutherland reviewed the case in detail and the ground on which the appeal was taken. He said it was necessary in deciding the case to consider whether the right of the men to have counsel was denied and whether this infringed the due process caused by the fourth amendment.

Justice Sutherland said from the time of their arraignment to the beginning of the trial they had been denied counsel at a time when such representation was of vital importance. All other grounds for setting aside were passed over by the justice as of no matter weight.

New York Cotton

New York, Nov. 7.—(AP)—Cotton futures opened steady two to three higher on unfavorable weather reports and foreign trade buying.

December contracts after selling up to 643, eased off to 634. Prices worked down to 630 for December and 657 for May, or about 5 to 10 points lower. Trade buying continued on a scale downward and the market at mid-day was quiet with rallies of a point or two.

RAT BANQUET BEGINS DEC. 10

(Continued from Page One) share of the \$200,000,000 loss each year in this country. In many of the campaigns conducted in New England, farmers have reported an average loss by rats of \$40 a year. The use of special campaign baits seems to have been an excellent investment.

The rat is one of the most prolific breeders among animals, having six to ten litters a year with an average of ten young to the litter. If one pair of rats were allowed to multiply at the normal rate of three years, and if all the animals lived, there would be 359,709,462 rats alive at the end of that period. No wonder that rats have spread over all the earth within a comparatively short time. The rapid multiplication of rats, as well as their migratory habits, makes it essential that everyone co-operate in this organized drive on December 10.

This bait is prepared in cans at a central point and shipped out to different counties. This material is relatively harmless to human beings, domestic animals and poultry.

but is very toxic to rats and horses. It is the fastest poison known to the U. S. Biological Survey, which is supervising this campaign. The regular combination package of three kinds of bait provides sufficient material to cover the average farm or other property making one hundred small baits. It is necessary simply to expose the baits according to the directions on each package. This plan will make it very easy to get rid of rats at the low cost of fifty cents, as under a co-operative arrangement, each person using the baits will be asked to share the wholesale cost of the materials. To obtain these baits it is necessary to order them in advance. Write or telephone your order to the County Agent before November 22 and you will be advised where to call for the bait on the afternoon of December 10. If you wish your rats to partake of this banquet, do not neglect to order your baits right away as these prepared baits at this low cost will not be available after the campaign.

Poultry Short Course This week there is being held a Short Course in poultry production at State College. On Monday, November 7, such topics as Poultry Outlook, Selection and Mating of Breeding Birds, Care and Management of the Poultry Flock, and Standard Judging of Poultry will be given over to such topics as Balanced Poultry Feeding, the Year Poultry, Grades of Feed Stuff, Grades of Feed Stuffs Going into Poultry Mash and Utility Judging of Poultry. Wednesday, November 9, will be given over the subject of Marketing. At this meeting the poultry work done by county Mutual Exchanges will be discussed, along with the value of advertising, Capon Production and Marketing, Egg Grading and Standardization, and Demonstration of Capon Sticking and Pickling.

Thursday, November 10, is Breeder's Day, and will be discussed at the stock judging pavilion, Polk Hall. Selection and Mating of Barred Plymouth Rocks, Rhode Island Reds and S. C. White Leghorns will be discussed and will be followed by a Poultry Judging Contest in which three pedigreed cockerels will be offered as prizes.

Friday, November 10, is Hatching Day. The question of the Value of Blood-Testing, the Duty of the Hatcherman to the Supply Flock Owner, Benefits of Proper Incubation, and a Discussion of Incubators and Incubation will be conducted.

It is hoped that the farmers of this County who are interested in poultry work will attend at least one of these meetings and will take along some friends. It is not necessary to spend the whole week since specific subjects are treated each day. Farmers have an opportunity to select the subjects which they are interested in and make up at least a one-day trip. Meals can be had on the campus at a reasonable cost. Those who wish to stay over will be able to secure rooms nearby at a reasonable rate.
