## BRITAIN REMAINS QUIET ON WAR DEBT QUESTION

### Fishing Boat Capsized In Storm On Potomac Saved By Patrol Vessel

### NO TRACE OF CREW FOUND

Sea Still too Rough  
for Rescue of Sea  
Rover Following the  
Towing of Rapahan-  
nock to Port in Vir-  
ginia; Seaman Die  
in Attempt to Swim  
to Safety.

Norfolk, Va., Nov. 23.—(AP)—The fishing schooner Rapahanock which was capsized Monday night during a storm in the Potomac was picked up by a Coast Guard patrol boat and towed to Reedsville Va. today, the Coast Guard headquarters here was notified.

No trace of the crew was found, according to the report.

The condition of the sea was still too rough for the Coast Guard cutter to pull the fishing schooner Sea Rover off a sand bar near Little Island where she went ashore yesterday, according to word received at Norfolk.

The cutter was standing by upon receipt of last accounts waiting for better weather.

John Highwater, of Brooklyn, was drowned when he attempted to swim ashore from the Sea Rover.

### Two Brothers Beat Robbers At Own Game

Wilmington, Nov. 23.—(AP)—The Wooten brothers, Albert and Kenneth, who run a filling station, have been robbed twice in two days, and today were only three cents behind the game.

One night recently a negro held up Kenneth and started rifling the cash register. Kenneth flashed a gun and made the robber drop the cash and 55 cents of his own money.

The next night two white men held up Albert and got 58 cents and a rubber check, fleeing without searching the operator who had the proceeds from his business in his pockets.

### J. H. Taylor Buried Today

J. H. Taylor, 80, died at the home of his son, L. F. Taylor, two miles west of Greenville, this morning at 10 o'clock. Funeral services were conducted this afternoon at 3 o'clock at Trinity cemetery near Chowchilla.

He was survived by his widow, Mrs. Mary A. Ange Taylor, and two sons, L. F. and J. S. Taylor, all of Pitt County.

The deceased was a member of the Grimesland Methodist Church and had made his home there until about six months ago when he moved with his son.

### TWENTY CASES BEFORE COURT

Two Day Session Of  
County Court is Re-  
quired to Finish the  
Docket this Week.

After being idle last week because of confusion in Superior Court cases, County Court started its regular weekly session yesterday and continued work today.

The docket of twenty-odd cases was expected to be completed during the afternoon. Charges ranging all the way from larceny to violation of the national prohibition law were given consideration yesterday and several of a similar nature awaited hearing today.

Judge W. L. Whedbee presided over the session.

Noah McLawhorn, young white man who has been held in jail here the last several days for investigation in connection with the mysterious slaying of his father Armistice night and on a charge of selling whiskey, was fined \$50 and cost, or given 90 days on the liquor charge.

George and Ida Beasley, colored, charged with possession of whiskey for the purpose of sale, were given hearing and the man was fined \$25 and cost and the woman was found not guilty. They were arrested by city officers several days ago with several gallons of contraband whiskey in their possession.

Charged with reckless driving, sentence was suspended on payment of cost in the case of J. A. Jones.

Tom Parker, colored, was required to pay cost on a charge of assault with a deadly weapon.

When he agreed to go back to his family and support them, Penner Jones had judgment suspended on payment of cost on a charge of abandonment.

Clara Foreman, charged with larceny, was released on payment of cost.

Ed Beamon charged with driving drunk, was fined \$50 and cost and had his license revoked for ninety days.

Judgment was suspended on payment of cost in the case of Dick Edwards, charged with assault. The charge grew out of an automobile wreck.

### SEIZE AUTOS FOR TAXES IN SO. CAROLINA

### Charleston Officials Begin Concerted At- tack to Collect State Taxes.

Charleston, S. C., Nov. 23.—(AP)—City officials today continued their drive for collection of property taxes from automobile owners with a total of 628 cars seized for taxes since the drive opened Monday.

Officials intimated today that one thousand persons had paid up to avoid loss of their machines, and Secretary Irvin Stinberg estimated that there were 3,500 cars in the city on which 1932 taxes had not been paid.

### BUNDLE DAY ON SATURDAY

Scouts to Make An-  
nual Canvass For  
Clothes for Poor At  
End of Week.

Attention was called again today to Boy Scout Bundle Day to be conducted in this city next Saturday under direction of Ensign Joseph Willett, director of the Salvation Army.

The campaign to provide clothes for the poor was to have been held last Saturday but was postponed until this week on account of rain.

The purpose of Bundle Day, an annual affair throughout the nation, is to provide as much clothing as possible for the indigent population.

The Scouts raised considerable wearing apparel last year, but the collection this year was hoped to be much larger because of the increased seriousness of the situation among the poor people.

Ensign Willett expressed hope that the people would respond liberally to this call for aid and contribute freely of any second-hand clothing they may have on hand.

All bundles to be contributed to the movement should be placed on front porches early Saturday morning so the Scouts may speed up the collection as much as possible.

Spent More in Europe

### RELIEF DRIVE IS COMPLETED

Committees Finish  
Canvass for Funds  
for the Poor During  
the Day.

The solicitation of funds for the relief campaign in this community during the winter months was completed today but a detailed report of the canvass will not be available before Monday. It was made known today by Mayor R. C. Flanagan.

The canvass headed by J. S. Picklen, was to have been completed Monday and Tuesday, but owing to the fact some of the committees were unable to cover all of their territory in the required time work was extended until today.

Although it was impossible to say how the campaign came out, Mayor Flanagan expressed hope that the people had contributed in such a way as to permit the committee to take care of the demands of the poor during the trying days ahead.

In a statement announcing the drive last week, the mayor enumerated the seriousness of the situation among the poor this year and asked the public to give as liberally as possible.

Persons who did not contribute during the canvass and are desirous of during their bit toward relief of the indigent, are urged to get in touch with the mayor or some other members of the committee at once and make their contribution.

In spite of the supplementary government appointment to this cause, the committee realizes that it faces a monumental task in providing for the needs of the unemployed during the cold winter months, and it is going to tax their resources to prevent dire distress and suffering.

### Late News Flashes

Picks War Debt Commission  
Washington, Nov. 23.—(AP)—President Hoover proposed today to Congressional leaders that the war debt problem be put up to a commission but without authority to reverse European obligations and he met courteous but determined opposition from both parties.

While there was no united front against him among conferees, neither was there a symptom of agreement at the end of the half hour meeting in the cabinet room.

There was no sharp debate but a wide variety of viewpoints were evident. Democrats led by Speaker Cramer consulted with Governor Roosevelt after the conference but refrained from making a statement. Secretary Mills also visited the next president at his hotel headquarters after the Democratic delegation had left. He said he got a very positive reaction from Mr. Roosevelt on Pres. Hoover's suggestion but declined to state what it was.

Plans had been virtually completed today for the community's observance of Thanksgiving Day tomorrow.

The highlight of the observance will be the annual union service of Thanksgiving at Immanuel Baptist Church at 10:30 o'clock at which the community will express appreciation for blessings of the past year.

Rev. A. W. Fleischmann, pastor of Memorial Baptist Church, will deliver the sermon and a special offering will be taken for the various orphanages supported by the different denominations of the city.

The service is always one of the most inspirational of the year and hundreds of people were expected to be in attendance.

Of great importance to the poor will be the annual dinner to be given by the Salvation Army at Johnson's Warehouse tomorrow afternoon. Plans have been arranged for the feeding of a proximately seven hundred people, Ensign Joseph Willett, director of the Salvation Army, said today.

Assisting in preparations for the dinner will be various churches and other organizations of the city. State Theater was to give a matinee this afternoon to help provide food for the dinner. Each person admitted was requested to bring the equivalent of 25 cents in food.

Delhi, India, Nov. 23.—(AP)—An American girl, Nila Gram Cook, who recently embraced the Hindu religion, has written a letter to Mahatma Gandhi announcing her intention to join him in his next fast.

The Indian Nationalist recently went through a six-day period of fasting to enforce upon his followers recognition of the equality of Hindi lower classes or untouchables. The girl wrote that the conscience of the upper caste through the world may be roused by Mr. Gandhi's fast.

### HIGH OFFICIALS WILL NOT TALK

Statement Attributed  
to Administration at  
Washington that the  
British will Pay Dec-  
ember Installment  
But Will Make No  
Further Payments  
until Revision is Con-  
sidered Fails Draw  
Government Leaders  
Out.

London, Nov. 23.—(AP)—Officials of the government refused today to comment on a statement attributed to the administration at Washington that the British government had indicated it would meet its war debt payments up to December 15, but would make no further payment until the United States considers revision of the debt situation.

Government spokesmen would not say whether the statement in Washington expressed the British position on the debt question.

Washington, Nov. 23.—(AP)—To a suggestion that the War Debt Commission be re-established to conduct a fresh examination of the debt problem, Governor Roosevelt today replied that the subject was one for the present Congress to consider if Mr. Hoover should recommend it.

The exchange took place at the now historic meeting between President Hoover and the President-elect before a crackling log fire in the austere red room of the White House.

The New York governor, it was said by one in a position to know what happened, declined to make any commitments, and for the most part made his role in the conference that of a listener.

Mr. Roosevelt's position was outlined as unchanged from the attitude he expressed in answering Mr. Hoover's invitation to the conference—that any immediate action on the war debts was the responsibility of those now in executive or legislative control of the government.

President Hoover a year ago proposed to Congress that the debt commission be re-established. Such a storm of protest was raised among the legislators—arising in some cases from administration spokesmen—that the proposal was never brought to a specific head.

### John May Dies Near Black Jack; Interment Today

John C. May, 66-year-old farmer, died at his home in the Black Jack community yesterday afternoon at 5:30 o'clock. Funeral services were conducted at 2 o'clock this afternoon from the home of his daughter, Mrs. Dave Boyd, by Rev. Pate Wriggs, and interment was made in the Dave Boyd burying ground.

He is survived by his widow, one son, J. T. May, and a daughter, Mrs. Dave Boyd, all of the Black Jack community.

Mr. May spent the major part of his life in the Black Jack neighborhood, and was held in high esteem by numbers of friends who received news of his death with sorrow.

WASHINGTON UNIVERSITY  
LOSES ENDOWMENT RECORD

St. Louis, Mo., Nov. 22.—(AP)—Once owner of the largest unencumbered endowment among American colleges and universities, Washington University has slipped to fifteenth place as a result of decreased income from investments and smaller donations, articles in the Alumni Bulletin of the school revealed.

A campaign will be pressed among graduates for contributions to the alumni endowment fund.

For a time the blaze which reached two houses, threatened the business district. The warehouse was completely destroyed. Whether tobacco in it for sale today was injured was not known.

### LUMBERMAN TO CONGRESS

Former Lumberjack  
Named to Seat in U.  
S. Senate in State  
of Washington.

Seattle, Nov. 23.—(AP)—A former lumberjack, Major E. S. Grammer, heretofore unknown in political circles, was preparing today to take up his duties in the United States Senate from the State of Washington.

The white-haired lumberman was named yesterday by the governor to fill the unexpired term of the late Senator Wesley L. Jones, who until his death last Saturday has represented the State since 1899.

Grammer is a Republican and a close friend said he is convinced prohibition is a failure.

### LIGHT SALES OF TOBACCO HERE

Price Situation Con-  
tinues Firm Here  
with Offering Much  
Scrap Leaf.

Sales were comparatively light on the Greenville tobacco market today and warehouse floors were cleared around the noon hour.

Sales yesterday were lighter than the near normal offerings Monday, it was indicated in the official report of K. W. Cobb, made public today, showing the market disposed of 373,488 pounds for \$48,930.66 at an average of \$13.10 per hundred pounds.

While offerings the last several days have been composed largely of scraps, the price situation has remained fairly firm at times, showing as much strength as the highest point of the season.

Although the major part of the crop has been sold, tobaccoists expected sales to be fairly heavy from now until December 21, the date set for the closing of the Eastern Carolina belt.

Farmers in all sections have been urged to market the remainder of their crop as rapidly as possible so that every pound will have been disposed of.

### Wider Weevil Infestation Seen

New Orleans, Nov. 23.—(AP)—Wider boll weevil infestation is forecast for the cotton field next year by the American Co-operative Association. Members of the association reported today 69.6 per cent of cotton squares in the field at the end of picking time this season had been punctured by weevils making a 25 per cent increase over last year.

Mississippi led in the reported infestation with 95 per cent and Georgia was second with 91 per cent. North Carolina reported infestation of 61 per cent.

### HERE'S HOW TO SPEND YOUR DOLLAR FOR FOOD

Washington, D. C., Nov. 23.—(AP)—If you are trying to cut the family food bill and keep up the family health at the same time the Bureau of Home Economics suggests this proportion of expenditures for every dollar:

One-fourth for milk; one-fifth for vegetables; another fifth for cereals, bread, beans; one-fifth for fats and sugars; an dthe rest for other foods such as eggs, meat, fish and the usual staples such as salt and coffee.

Members of the Athletic Association urged that as many people as possible attend the final game to-

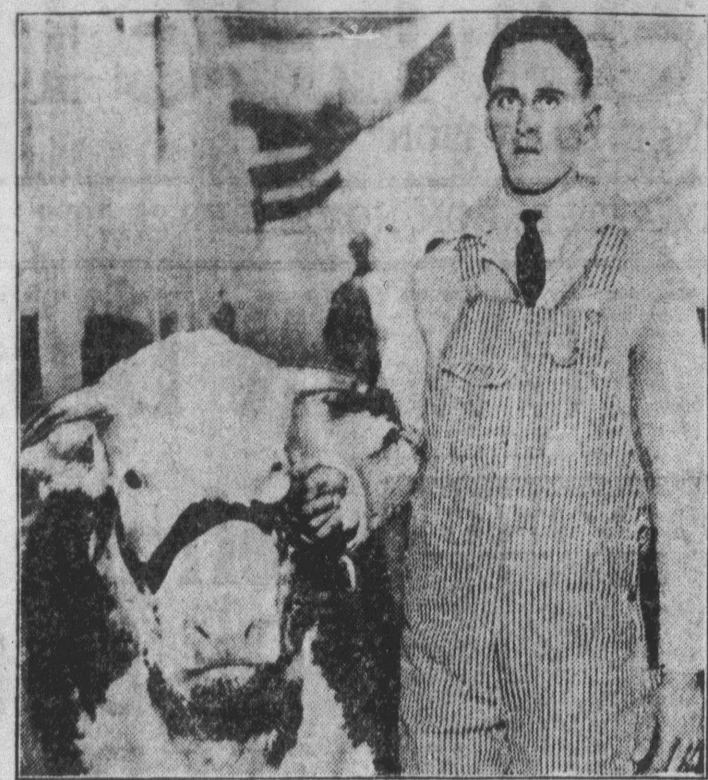

## GENERALS TO MUSTER FULL POWER, DUKE

Durham, N. C., Nov. 23.—For the first time this season the Washington and Lee Generals will be able to muster their full strength against Duke when these two teams meet in the Duke stadium on Saturday afternoon.

The Generals got off to a slow start this season, due to injuries, but they have steadily improved and their recent victory over Virginia revealed their return to form. Last week they were credited with outplaying Maryland, losing by one touchdown.

Within all injuries, which have greatly hampered them cleared Washington and Lee will bring a full squad to Durham and put on the field their best, conditioned team of the year.

While the Generals have been losing some games, they have displayed a brilliant aerial and rushing attack. Their tricky double passes and forward passes behind the line gives them a deceptive offensive. With this improved strength, a 165-pound triple-threat star in Sawyers should make things very interesting for the Devils.

Coach Jimmie DeHart, who is to return to the Duke stadium for the first time since he left here two years ago, will be able to assemble a heavier team than the Blue Devils. The Generals' line will have a 186-pound average compared to the 187-pound Duke line average. Their backfield will average 163 pounds as compared to the Devils' 159-pound average. This gives the Generals the advantage in weights.

According to scouts' reports, W & L's backs have power, as proved by their sustained drives down the field against V. P. I. Kentucky and Virginia. The Generals' have garnered an impressive number of first downs, excellent in this department over their opponents.

Saturday's game will mark the end of the football season in North Carolina, and will be the only Big Five engagement of the day.

## CAROLINA IN SHAPE TO GIVE VA. BIG FIGHT

Chapel Hill, N. C., Nov. 23.—The Carolina football squad has been looking ahead all week to its Thanksgiving Day game in Virginia's handsome new stadium, reviving the South's oldest continuous and most colorful Thanksgiving rivalry.

The Cavaliers have a habit of saving their best game for Carolina, and the Tar Heels are expecting one of the hardest contests of the season, although they rule slight favorites by virtue of recent victories over N. C. State, Florida and Davidson.

The Carolina veterans can well appreciate that fact from last year. The Tar Heels were heavy favorites then, but it took Johnny Branch's brilliant 60-yard punt return to win that great game by the narrow margin of 13 to 7.

Again, Virginia had no game scheduled this week, and can spend ten days practicing and pointing. But the Tar Heels, much as they would like to do the same thing, have had their hands very full with their State championship game with Duke, and will have only two days' practice at home next week.

The Carolina-Virginia rivalry dates back to 1892 and has produced 38 games, many of them classic battles. Carolina has held the upper hand of late, but Virginia dominated in the early days. The whole series shows Virginia twenty wins and Carolina thirteen, with three ties. Carolina's 14 to 13 victory in its stadium dedication battle in 1927 is one that the home fans aren't likely to forget for many moons.

The Tar Heels started the present season slowly, but found themselves near mid-season, and have shown considerable power in consecutive victories over N. C. State, Florida and Davidson.

The team is built around twelve lettermen, including several regulars from last year. Coach Collins, who uses the Notre Dame system, has developed one good offensive line two stout defensive lines, and three good backfields.

Smith began final trainings for the clash Monday when he spent the afternoon having the Wolves look over the ground plays used by the Gamecocks in past games. A part of the drill was devoted to new plays that the Wolves will offer in competition.

State's backfield talent will be in tip-top shape to meet the invasion by the South Carolinians. All were out for work yesterday and in good physical shape and in high spirits. Smith used as his No. 1 backfield Monday, the combination composed of Don Wilson, quarter; Robert McAdams, left half; Roscoe Roy, right half; and Mope Cumiskey, fullback other stipulations in said instrument

ed against Duke and brought praises from Wallace Wade, Duke's famous coach. Wade declared this backfield of Smith's to be the finest to face the Blue Devils this fall.

McAdams, Roy and Cumiskey have played brilliantly all season. Cumiskey is ranked among the South's best fullbacks and McAdams and Roy are being groomed for All-State posts. When they face the Gamecocks they will face a team boasting one of the heaviest and most powerful lines in the South and two of the fastest backs in South Carolina.

It is a community wide fight and demands the earnest consideration of every community cognizant of the destruction wrought by rats each year.

It should be a matter of gratification to tobaccoists to note the way farmers are bringing their tobacco to market in response to the appeal for rapid marketing of the remainder of the crop.

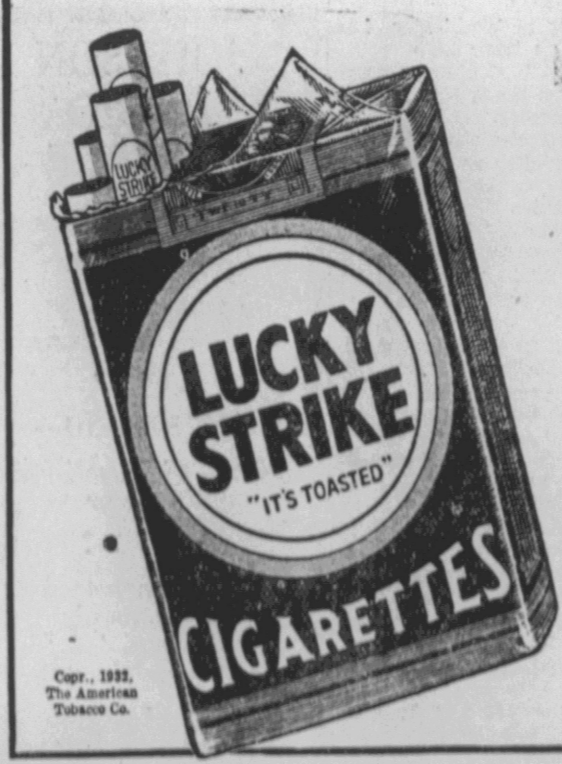

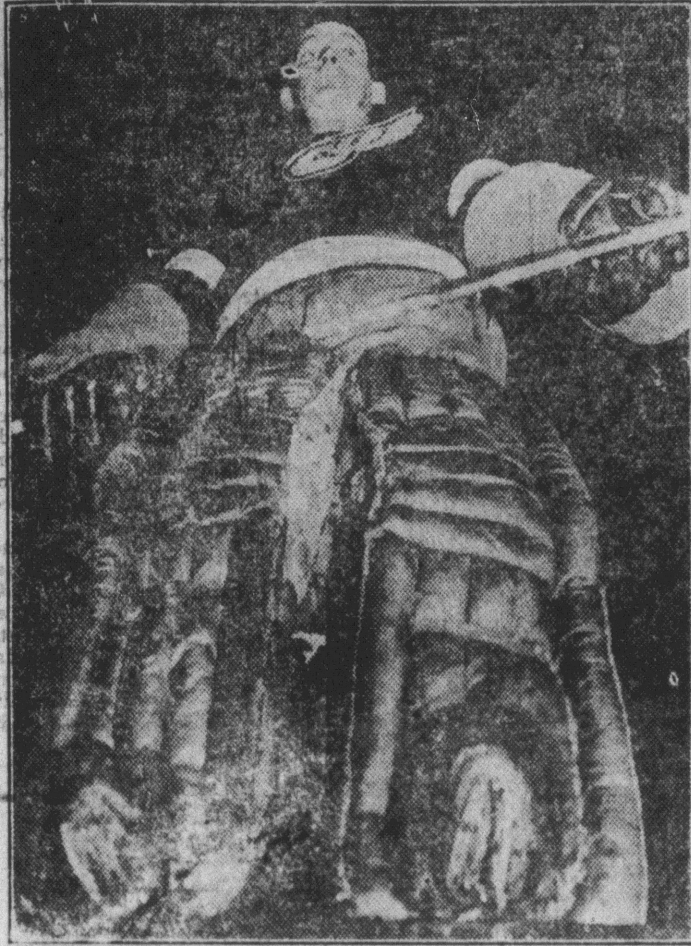

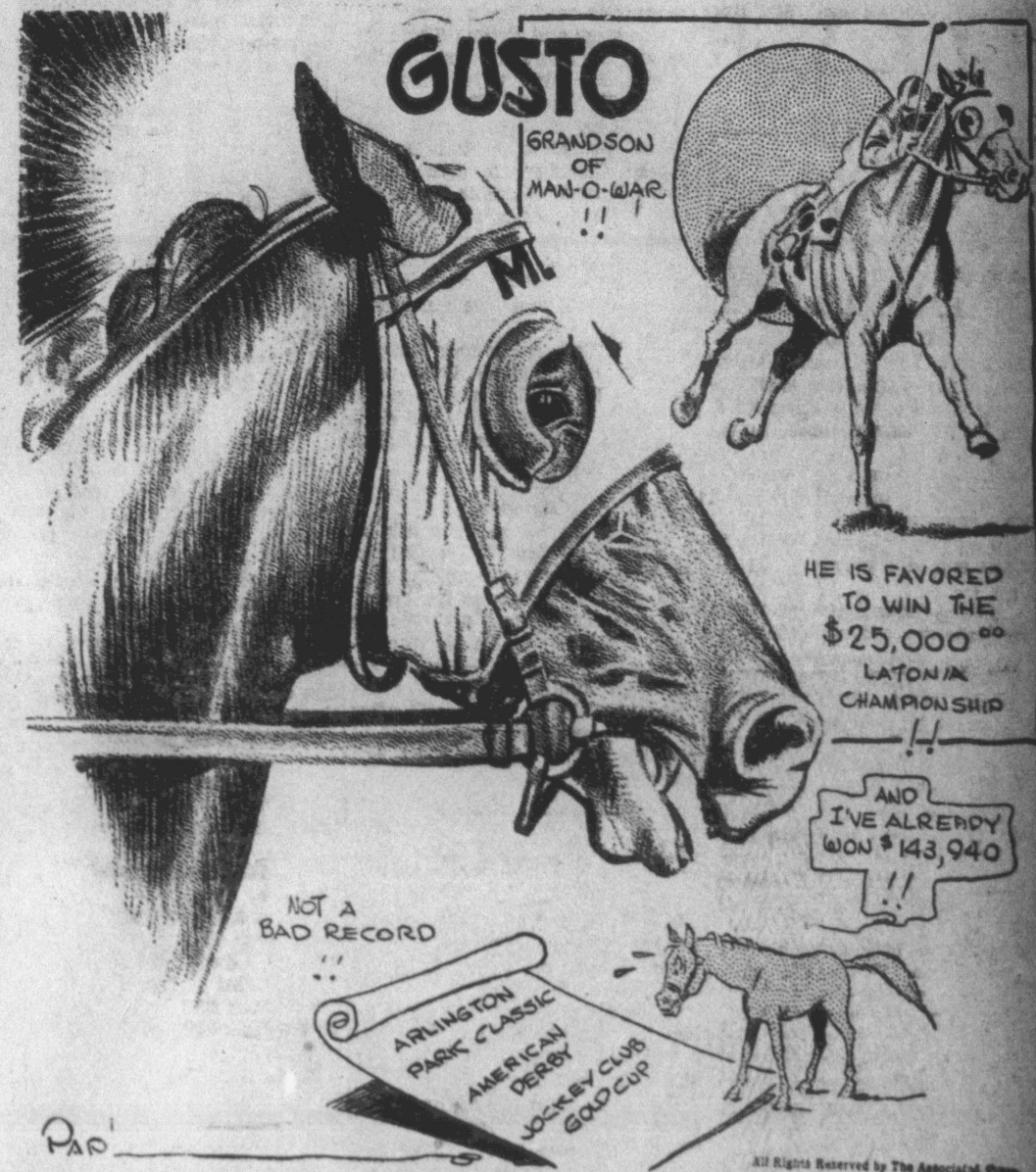
