## HOUSE COMMITTEE BEGINS WORK ON NEW FARM BILL

### Domestic Allotment Plan To Be Included In Draft Of Farm Relief Measure

#### MILLERS ARE AGAINST PLAN

Packers Also Say that Instead of Benefiting Growers, Allotment Plan Would Result in Still Lower Prices; Leaders Of other Organized Agricultural groups Endorse Plan.

Washington, D. C., Dec. 21.—(AP)—Preparation of a farm relief bill embodying the domestic allotment plan was undertaken today by the House Agriculture Committee. With its long hearing concluded the committee hopes to draft a measure acceptable to farm leaders and producers for prompt action in the House after Christmas.

Representatives of the packing industry and some millers, however, have opposed the domestic allotment plan contending that instead of benefiting the farmer it would result in lower prices.

On the other hand, leaders of organized agricultural groups endorse it providing it is worked out to give the farmers generally a value of over-planting for most of their crop.

Under the tentative measure which forms the basis of the hearing, the allotment plan would apply to wheat, cotton, tobacco and hogs, and pay producers a bounty on their share of domestic consumption out of a processing tax levied on millers, packers and both processors.

At the final hearing last night dairymen asked to be included.

#### Bishop Cheshire Still Unchanged

Charlotte, N. C., Nov. 21.—(AP)—Hospital attaches here said the condition of Bishop Cheshire, stricken with blood poisoning several days ago, and reported yesterday as semi-conscious, was unchanged today.

#### DEPOSITORS SLOW IN CASHING CERTIFICATES

Wilson, Dec. 20.—Depositors of the defunct First National Bank have presented only \$44,000 in dividend certificates for payment since Thursday when a 15 per cent dividend was made available. The certificates are being redeemed at the National Bank and holders will be paid their dividend on presentation of their voucher.

A D. Shackelford, executive vice-president of the National Bank, said today that approximately 95 per cent of the money obtained on certificates was deposited in the new bank. He also said that the vouchers which are interest bearing, are slow in coming in and expressed the opinion that holders had rather retain the certificate and receive the accumulated interest when it is finally cashed.

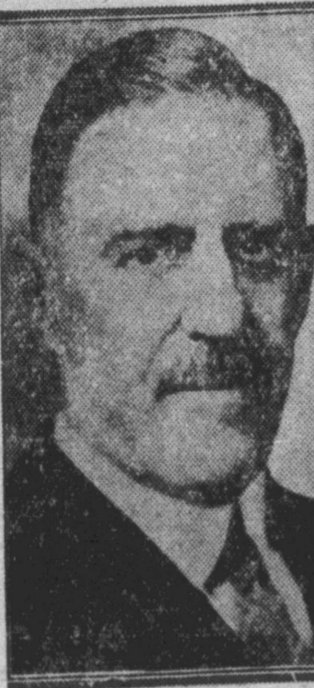
#### CLEMENCY GRANTED TO HEAD OF LARGE FAMILY

Smithfield, N. C., Dec. 21.—(AP)—A sickly wife, now about to be confined, and seven small children, contributed largely to inducing Judge W. C. Harris to be lenient with Joel Neal, a white man about forty years of age, who lives near Garner. Neal frankly stated he was assisting Lester Carter and two negroes in making liquor, in Clayton Township, during the summer of 1932, about the month of July, in order to pay the doctor's bills for his ailing wife. There was evidence that the negroes were being paid one dollar a day for their work at the still and the two white men owned the outfit. Neal was not caught by the officers when they made the raid, but he voluntarily came in the next day and surrendered, all of which largely contributed to the final disposition of the case. He was sentenced to serve eighteen months upon the road, and this is suspended upon good behavior for two years and upon payment of the court costs during the term.

### MANY ALIENS ARE BARRED FROM THE U.S.

Stimson Says Immigration Laws Held Out 500,000 During Depression.

Washington, D. C., Dec. 21.—(AP)—Secretary Stimson today reported to President Hoover that as a result of the emergency bar against immigration, over 500,000 aliens who normally would have entered the United States "during the economic depression have been held out."

The Secretary of State reported this result had been accomplished solely through enforcement of existing provisions of the law principally by clauses excluding persons likely to become a public charge.

Bringing down his total into smaller figures, Stimson said that during the fiscal year ended June 30, 1932, only 12,697 quota immigration visas were issued as compared with a total annual quotas of 153,831.

## Local Market Closes Today With Good Lead Over The Tobacco Belt

### DOLE DRAWS HOT DEBATE

Robinson and Bullard Engage in Verbal Tilt on Veterans' Measure.

Washington, D. C., Dec. 21.—(AP)—Whether disability allowances to veterans whose troubles did not originate in service constitute a dole, today precipitated a dispute before the Joint Congressional Veterans' Committee between W. M. Bullitt and Senator Robinson Republican, of Indiana.

Bullitt is appearing for the National Economy League which is urging reduction of about \$450,000,000 in veterans' expenditures, described such payment "as pure dole" given to a man not because he was once disabled, but because he was once in the service.

Robinson leaned across the committee table and almost shouted at Bullitt: "The allowances are not based on charity; I think that is a perfectly outrageous statement. You did not have any such idea in 1917, did you?"

### PRICES SHOW UPWARD MOVE

Common and Medium Grades of Tobacco Sold Higher than In any Other Period Of last Four Years; The Market Draws From a Greater Territory than Ever Before; Early Close Due To Crop Shortage.

The Greenville tobacco market closed today after one of the most successful seasons in history.

Tobaccoists and friends of the market were rejoicing over the fact that the market closed the season with a definite poundage lead over the entire belt.

It is the first time the belt has closed before the Christmas holidays in history. This was due largely to the fifty per cent crop reduction caused by plant disease and unfavorable weather conditions the first of the planting season.

Sales for the season issued today by K. W. Cobb, supervisor of sales, showed the market had sold a total of 39,444,170 pounds of leaf this season for \$4,776,304.45 at an average of \$12.11 per hundred pounds.

Sales for the week were given at 553,790 pounds for \$48,214.55 at an average of \$9.33 per hundred.

Last year the market sold 66,237,808 pounds of leaf for \$6,212,638.19 at an average of \$9.38 per hundred. Competitive bidding was stronger this year than in recent years and it appeared that all companies seemed interested in bidding on every pile offered.

Final analysis of the market appeared that common and medium tobaccos sold unusually high this season in fact higher than in the past three or four years.

Greenville drew from a greater territory this year than ever before. Tobacco was brought here from as far as Canada. A farmer from Union county, in the extreme western section of the state, also marketed a part of his crop here.

The first time probably that a grower completely crossed the state to dispose of his offerings.

Major sales were light the major part of the season, the market had many million pound days and on two or three occasions sales went beyond the two million pound mark.

Because of the increased facilities for the handling of bright leaf old time block sales have been almost completely eliminated on this market. Five sales running simultaneously and warehouse space the market is able to sell nearly two million pounds of tobacco daily without blocking. This enables farmers from a long distance to sell their tobacco and return home the same day.

Capture of the sales lead this year makes twice Greenville has held the distinction. The same honor was won last season when the market emerged with the poundage lead. The margin is more comfortable this year than last, however, and tobaccoists were congratulating themselves upon the achievement in the face of the most pronounced crop shortage of years.

### CHURCH DETERMINED TO BALANCE BUDGET

Kinston, Dec. 21.—The congregation of the local church of the Disciples of Christ is trying to balance its budget. The congregation has been divided into fifty teams seeking finances. Forty-nine of the teams are headed by women. A material reduction in the deficit of the church was announced today. Under the guidance of the women chairmen the teams have resorted to unique means to raise funds. One group conducted a sale of used goods contributed by members of the church and merchants.

### LABOR BODY GETS IN ROW

Fight Between Whites and Blacks in Alabama Draws Criticism of Union.

Tallapoosa, Ala., Dec. 21.—(AP)—The battle between white posers and negroes in southern Tallapoosa County drew criticism today from International Labor Defense as a new at the Share Croppers' Union while conflicting reports of the dead, injured and arrested persisted.

Officers blame the disturbance that started Monday when four sheriff's deputies reported themselves wounded in a brush with a band of approximately one hundred negroes as they sought to attack a negro farmer's livestock on radical incitation.

But the International Labor Defense issued a formal statement from southern headquarters in Birmingham charging that affair was a planned measure to break up a growing organization of the Share Croppers' Union, the organization of which is consisting both of white and colored tenants, croppers and poor farmers around their immediate needs.

### Negro House is Destroyed by Fire Last Night

The home of Charlie Forbes, colored, on Ford Street, was destroyed by fire last night, entailing loss estimated by firemen at \$600. The cause of the blaze was not determined. The family awoke to find nearly the entire house ablaze, and the flames had made such headway when the alarm was sounded that the firemen found it impossible to save the single-story building. Most of the furnishing were also destroyed.

### SCHOOL BOY RUN OVER BY TRUCK AND KILLED

Enfield, Dec. 21.—On Thursday night, December 15, Rodney Butts, aged about fourteen, was accidentally killed by a school truck which he was trying to board. The accident occurred on the grounds of Aurelian Springs High School where people were gathering for a minstrel show. The boy jumped on the back of the truck, without the driver's knowledge, and fell off. A hind wheel of the truck passed over his chest. He was picked up by the bystanders, but only mumbled a few words and died almost immediately after being carried to the store of John Liles.

### AYDEN UNFORTUNATE ARE BEING CARED FOR

Ayden, Dec. 20.—The less fortunate families, and especially the children of the town, have been taken care of for Christmas. All churches and their organizations have prepared to give food and toys and the H-Y Club under the direction of W. M. Jenkins has collected and repaired old toys in their after-school workshop for that purpose. The Rotary Club, as is their usual custom, will distribute food and toys.

### LEGION GIVEN OYSTER FEED

Commander Lanier Entertains at Roast at Local Armory Last Night.

Members of the Pitt County Post of the American Legion were treated to a delightful oyster roast at the armory on Cotanche Street last night.

The host was no other than J. Con Lanier, commander of the Post, who at this time is being boosted by the local organization for Commander of the North Carolina Department of the American Legion.

Between 75 and 100 members of the organization from all sections of the county were in attendance and the way they made oysters disappear would have brought joy to some of the oyster dealers who are finding business on the ebb at this time.

Tables had been provided in the center of the armory, and from this vantage ground hundreds of oysters, piping hot, were opened and sent on their mission of mercy to the gastronomic regions.

Some of the boys ate so much that they turned red in the face and positively were forced to quit, while others took it by easier stages and disposed of enormous quantities.

Big guns, army trucks and tanks standing silently in one section of the armory formed an appropriate setting for the occasion, and many of the men who braved the hail of shells overseas, were reminded very keenly of that terrific encounter when they gazed upon the implements of war.

Commander Lanier taking his place in one of the high trucks, called attention of the Legionnaires to the fact that the State Commander would be present at the next meeting of the Post, and asked that alal dues be paid so that the organization might be able to make a good showing at that time.

### Mit Gets \$6,000 for Relief

Raleigh, Dec. 21.—(AP)—Allotment of \$228,400 in emergency relief funds to the state's 100 counties was announced today at the office of Dr. Fred Morrison, state relief director.

Checks for the fund have been mailed to all counties.

The allotment was the second made from the federal loan of \$571,000 advanced to the state for use in December.

Allotments to counties included: Beaufort \$2,400; Pitt \$6,000; Wilson \$3,000; Wayne \$4,000.

### PITT OFFICERS TO QUIZ BERRY

Man Held at Goldsboro Believed Connected with attempted Robbery.

A report from Goldsboro this afternoon was to the effect that the automobile captured by police early yesterday morning was today identified by Fountain citizens as the car used in the attempted robbery of the Bank of Fountain, Pitt county, last week.

Either Sheriff Sam Whitehurst or Chief of Police George Clark was to go to Goldsboro today to question Joe Berry of Raleigh in connection with the unsuccessful attempt to rob the Bank of Fountain last week.

Sheriff Whitehurst was reported sick this morning and there was some doubt as to his ability to make the trip to the Wayne capital. In case he is not able, Chief George Clark said he would make the trip himself and attempt to learn more about Berry's activities in this part of the state.

Berry was captured by Goldsboro officers yesterday morning after a spectacular chase from Goldsboro to Princeton. The car in which he was riding with another man contained firearms, various tools such as would be used in safe robberies and a strong box stolen the night before from the Texaco plant at Kinston. The second occupant of the car escaped.

The automobile was said to have carried bullet and shotgun holes, and this led to the belief that the same car was probably used in the attempt to rob the Bank of Fountain last week. The bandit car was said to have been hit in the exchange of gunfire between police and bandits. Two of the robbers were also believed to have been hit. A Fountain policeman received a bullet wound in the leg but was not seriously hurt.

Officers talked over long distance telephone to Goldsboro authorities last night, but nothing definite was accomplished beyond obtaining information as to the kind of tools which Berry had with him and the nature of the gun holes in the car.

### TAKE NO ACTION UPON ALLEGED ILLEGALITY

Dobson, Dec. 21.—(AP)—A surly County grand jury, sitting here during the December term of Superior Court, has adjourned, and so far as could be learned today, took no action in connection with alleged irregularities in certain precincts of the county during the primary last June.

Solicitor Carlisle Higgins is understood to have presented to the grand jury a transcript of the testimony taken during the investigation conducted by Attorney General D. G. Brummitt.

### Beer Bill Sails Blithely

Washington, Dec. 21.—(AP)—The 32 percent beer bill sailed blithely through toward passage in the House of Representatives late today, judging from the vigor with which members shouted down amendment after amendment to lighten both its alcoholic content, and the tax to be imposed.

One attempt after another to alter the measure as approved by the committee carrying as it does a \$5 a barrel tax, was frustrated by a 30-0 vote on the floor of the House of debate.

### LET COUNTY AUDIT HERE

Commissioners Consider Other Matters at Special Meeting Last Night.

The Board of County Commissioners met in special session at the courthouse here last night and awarded contract for the audit of county books.

The contract was given to Perkinson Greathouse & Company, of Rocky Mount for \$750, and calls for two separate and distinct audits during the year.

The committee for the County Home was empowered to hire a matron for the Home in an effort to improve living conditions of the inmates.

J. N. Williams was authorized to hire a janitor for the courthouse, but the selection had not been made today.

Further attention to pruning of expenses of the administration was not considered last night, but is scheduled to come up for consideration at the first meeting in January.

### SPINNING OF COTTON OFF

November Report of Operations Slightly Less Than Previous Month.

Washington, D. C., Dec. 21.—(AP)—The cotton spinning industry reported today by the Census Bureau to have operated during November at 96.9 per cent capacity on a single shift basis compared with 97 per cent during October this year and 85.8 per cent during November last year.

Spindles in place November 30 totaled 31,464,872, of which 24,349,506 were active at some time during the month with the average on a single shift basis being 30,493,073 compared with 31,489,918, 24,587,732 and 30,537,208 for cotton this year. North Carolina reported 1,572,367,535 active spindles hours, and the average per spindle in place follow: 1,572,367,535 and 255.

### NEEDY LABORERS CONSTRUCTING POOL

Kinston, Dec. 21.—Officials here are considering using needy laborers to construct a swimming pool on the Emma Webb playground at the northern edge of the city, the workers to be paid out of unemployment relief funds.

Depression caused plans for the pool to be abandoned two or three years ago. Members of the city council believe it could be constructed for a few thousand dollars now. There is no public swimming pool here. Children have used the muddy Neuse River for bathing and the treacherous stream's whirlpool and deep holes have claimed many lives.

# About NEW YORK

New York, Dec. 21.—About once a season it seems to me a pretty good plan to devote a few days and nights to guiding a couple of out-of-town friends on intensive sight-seeing trips around the city.

Just about once is enough, for playing the guide is exhausting, a bit expensive and takes up plenty of time if it's done right. But it has its rewards for the fellow who makes a business of observing the variegated New York scene.

Of course, the visiting firemen must meet certain requirements. They must not come from some inland village with a chip on their shoulders, studiously blasé and ready to belittle everything from our skyscrapers, which never have been able to rise completely out of sight, to our night life, which is sometimes pathetic in its attempts to be gay.

It is essential that they have no more than a normal repression upon their enthusiasm. They should not be of the sort who gurgles and gapes to the point of embarrassing their guide—nothing is much more of a pain in the neck. But they should at least permit themselves measurable expression when they are delighted, amazed or shocked by what they see and hear.

Given a couple of such out-of-towners, it seems to me that any one who knows New York would find some of their enthusiasm contagious on rubber-neck ventures. Their reactions to "the sights refreshen the viewpoint of one who has been long in the city. Familiar things which have lost their fullest thrill take on a new wonderment through the eyes of strangers.

The color of the foreign sections is retouched by the explorative spirit. The globes of Broadway are polished by a thrill that is new and genuine. And I confess unashamedly that there is a kick in renewing acquaintances with museums and such other places as many chronic New Yorkers seem to look upon.

**The Younger Generation**  
Some fond parents who live in Forest Hills have a precocious daughter in, as they say, the "cute" age.

The other afternoon there was a children's matinee at a movie house out there, and arrangements were made for a nice little boy in the neighborhood to escort the little girl to the theater. The lad arrived, span and chesty—quite evidently determined to make an impression on his lady.

Later the blase young miss returned, but without her galant. Her mother wanted to know why in the world little Horace let her come home alone.

"Aw, he got put out o' the picture show."

# A Washington Daybook

Washington, D. C., Dec. 21.—President Hoover's desire to reward Walter Newton, a member of his secretariat, with a Federal judgeship is another example of how this position has been a stepping stone in the careers of many who have held it.

Newton, however, doesn't stand much chance of getting on the Federal bench. Democrats in the Senate have announced they would refuse confirmation of all Hoover's appointments, leaving the field clear for Roosevelt after March 4.

Some of the secretaries to Presidents, however, have had their careers dated from the time they served at the White House.

For example, there's the case of Everett Sanders, secretary to Calvin Coolidge. While he had been a member of Congress before going with Coolidge, the contacts that he made at the White House had much to do with his being chosen chairman of the Republican National Committee.

**A Stepping Stone**  
Outstanding leaders of the country in the past got their starts in this manner.

John Hay was one. He served as assistant private secretary to President Lincoln from 1861 to 1863. Then followed a long and brilliant career in the diplomatic service.

In 1879 Hay was appointed Assistant Secretary of State. In 1898 President McKinley made him his Secretary of State.

When Grover Cleveland was governor of New York he had as his secretary Daniel S. Lamont. When he was elected President he brought Lamont to Washington as his secretary.

**Cortelyou Rose High**  
Perhaps the most outstanding example, with the exception of John Hay, is that of George Bruce Cortelyou. In McKinley's administration Cortelyou was a stenographer at the Postoffice Department. He was brought into the White House to do stenographic work.

Theodore Roosevelt made him his secretary when he became President. In 1902 he was made Secretary of Commerce and Labor. From 1905 to 1907 he served as Postmaster General. And from 1907 to 1909 he was Secretary of the Treasury.

**HOLLYWOOD SIGHTS AND SOUNDS**

Hollywood, Dec. 21.—(AP)—Clyde Beatty will be one film star who never uses a double and probably couldn't if he wished.

One of the films in the current zoo cycle is "The Big Cage," based upon the life story of this 27-year-old Ohioan who has thrilled hundreds of thousands with his daring in exhibitions with lions, tigers, leopards and other wild beasts.

Beatty himself is starred and after watching him demonstrate his act recently I dare say none of Hollywood's intrepid doubles would swap places with him even for an instant.

Armed only with a chair, a long whip and a pistol loaded with blank cartridges, Beatty presents 140 lbs. of sheer courage and determination as he stands alone in the cage surrounded by two or three dozen snarling animals any of which may leap at him from behind at any moment.

Aside from being constantly alert, muscles taut, Beatty doesn't look nervous in the least, and it's no tame, toothless aggregation of movie

animals he has around him. He cracks his whip, infuriates them, and they charge. He feeds them off with his chair and just in case they get too mean he fires his pistol in the air, driving them. But his mastery of the beasts seems more mental than physical and an onlooker would suspect that this young man never enjoys himself more than when he is in the cage, in a lather of perspiration from his exertions.

Yes, even in Hollywood, where jobs are as scarce as the next place I don't think Mr. Beatty will have any competition in his particular art.

In the early days of the talkies much confusion was caused on the sound stages by the intrusion of insects, birds, bats and other winged creatures difficult to locate and put out. Their noise interfered with recording, of course.

But now here is a studio actually in trouble because it can't find a bird to "sing its heart out" on a limb near the scene of an airplane crash—one of those dramatic contrasts you know.

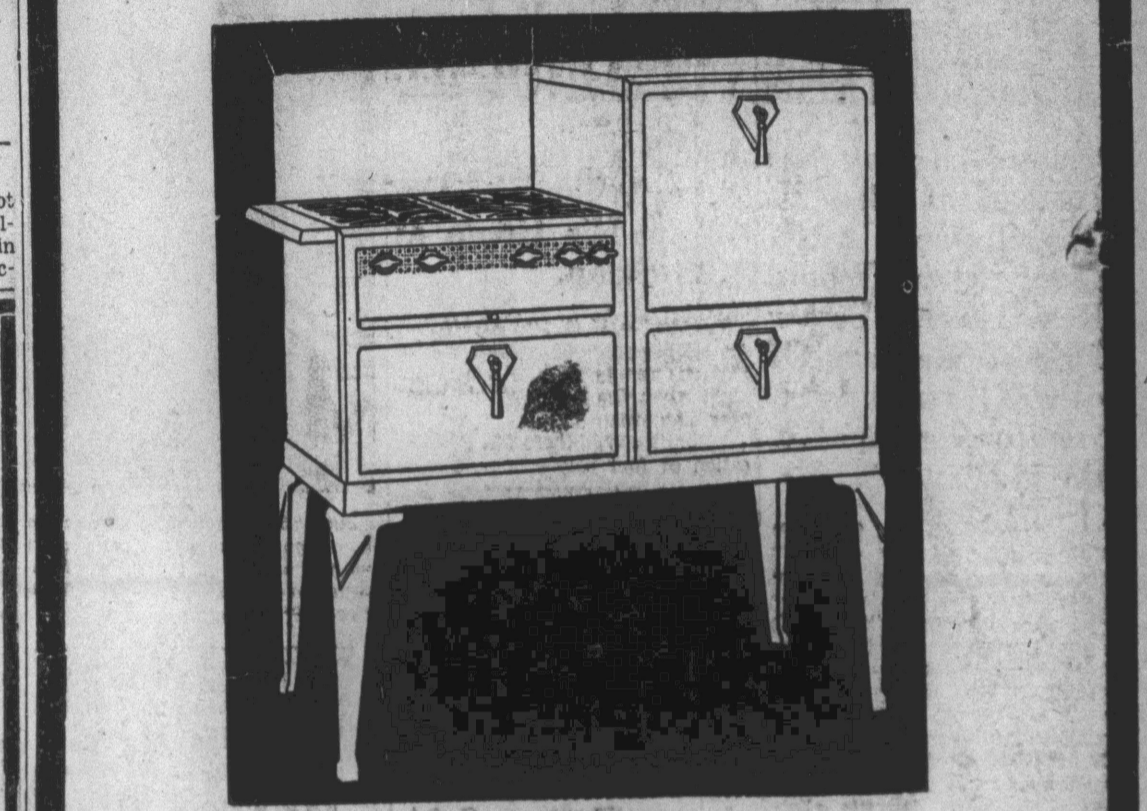

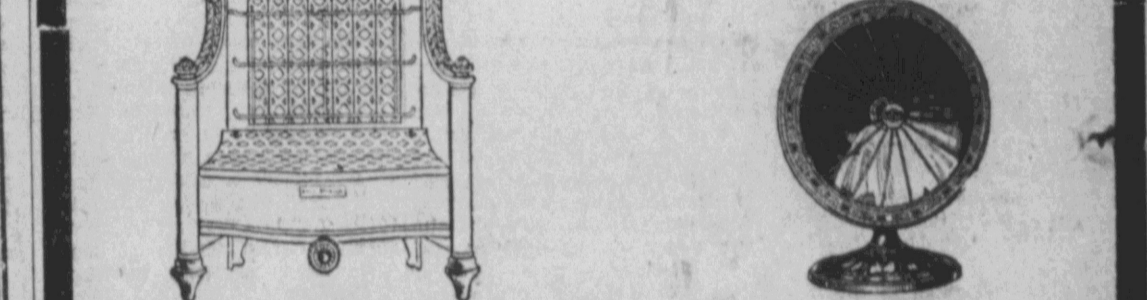

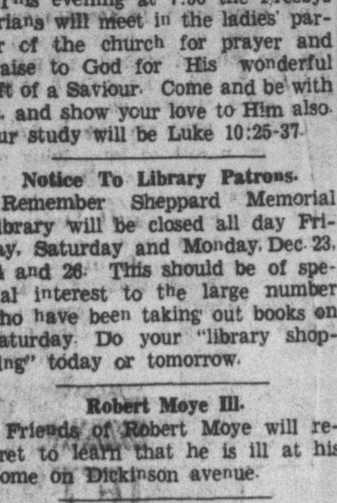

## PROPOSES REVISION OF TAX ON MERCHANTS

Charlotte, N. C., Dec. 20—Efforts will be made by a group of North Carolina merchants to obtain a revision of the State license tax on wholesale and retail merchants. H. A. McLaurin, auditor of the Bell chain stores, revealed yesterday. Mr. McLaurin said merchants of the State believe the tax law is unfair to many merchants.

Under the present law, the tax is based upon bracketed gross sales. The brackets are for \$125,000 each after the first \$125,000. Mr. McLaurin and those with whom he is associated believe that the tax should be on actual sales.

Under his plan, merchants would pay a fixed amount for the first \$5,000 or \$10,000 and a stated amount for each additional \$1,000 or fraction thereof.

**FRUIT AND VEGETABLES IMPORTANT IN WINTER**

Washington, D. C., Dec. 21—Do not fail to eat vegetables and fruits as regularly in winter as in summer, advises the Bureau of Home Economics.

The citrus fruits—oranges, tangerines, grapefruit, lemons—are rich in vitamins. Raisins, prunes, dried apricots are especially important for their iron content.

One of the cheapest vegetables, always easy to store for winter, is cabbage. Turnips and carrots also are important.

## Kitchen Needs High Windows

Kitchen windows should extend as near the ceiling as possible. Then, when the top sash is lowered, the upper part of the kitchen can be aired and there is less accumulation of odors near the ceiling. Windows set high from the floor permit the placing of equipment under them.

One of the most curious and misguided notions in this observer's direction is that Eastern sports experts conducted some sort of a campaign or hatched a plot to "put over" Pittsburgh as the selection for the Rose Bowl game.

Southern California had good grounds than were generally conceded, but the fact is Colgate was the popular preference of Eastern critics for the inter-sectional classic.

Ohio State was beaten only by Michigan. Nebraska's only defeat of a championship season was at the hands of Minnesota and by the margin of one point.

Pittsburgh was a marked team after toppling the Army and double-marked after upsetting Notre Dame, yet finished undefeated and scored upon onul b Arm and Pennsylvania.

# Talks to Parents

**ABOUT CARELESSNESS**

Is your child one of those who leave their clothes where they fall, who regularly lose their sweaters in the course of the winter, who cannot keep gloves and papers when it is time for school?

The problem is an irritating one. The loss is, always discovered when there is need for getting off in a hurry.

Then either you nag from long habit or you help him look for his things. You probably pick up his clothes after him because experience has taught you that it saves energy and anything else is useless.

Here are a few suggestions that may be helpful in dealing with this difficulty:

When he loses his ball or his lunch in a paper bag, let him wear last year's outgrown sweater or a discarded cap.

Don't help him find his books when he has misplaced them. Insist that he get off to school on time anyway with or without his books.

The explanations he will have to make at school, the difficulties in which he will find himself there, will teach him the value of what you have already told him many, many times, that when he is through with his home work he should put his books in a particular place.
