U. S. MARINES QUIT MANAGUA

Last Forces Leave the City as New President Begins his Term of Office.

Managua, Nicaragua, Jan. 2.—(AP)—The last of the United States Marines were leaving here today and Juan Facaca became the first president in nineteen years to start his term of office without their reassuring presence.

An American-trained native guard of 2,500 strong will henceforth have the task of controlling this largest but most sparsely populated Central American republic to itself.

In his inaugural address here yesterday the new president stated that after today the country will be without marines and that the country will again assume complete sovereignty.

REPORTS ON SOCIAL PROBE

President's Research Committee Reports After Three Years of Study.

New York, Jan. 2.—(AP)—A warning that the alternative to closer co-ordination of the social forces of American life might be a dictatorial system in which violence might subordinate technical intelligence was contained in the report of the President's research committee on social trend submitted today.

The committee appointed by President Hoover in 1929 has spent three years studying changes on institutions affecting all phases of life. Its finds based on facts gathered by five hundred investigators occupied 268 pages written by research experts.

One alternative to a constructive social initiative, the committee said, might be a prolongation of the policy of thrift and some readjustments as times goes on.

THREE MISSING IN PASQUANK

Searching Parties are Seeking Fishermen Who Left Home last Saturday.

Elizabeth City, N. C., Jan. 2.—(AP)—Three men missing since Saturday after starting a fishing trip at the mouth of the Pasquotank River were being searched for today.

The men were: W. F. Deans, Frank Miller and B. F. Markham. Alarm for their safety was heightened as wind of almost gale proportion swept the section Saturday night.

Saturday afternoon the trio left in their boat, leaving word they would return during the afternoon.

When they failed to appear a search was begun, several boats were sent to the scene of the camp and others joined in the search. A searching party found their camp Sunday. They also found a group of duck hunters who reported seeing the fishers Saturday. Since that time no word of their location has reached here.

MAN SLAIN BY HIS WIFE

Charleston Fireman is Shot to Death While Lying in Bed at His Home.

Charleston, Jan. 2.—(AP)—James B. Gray, 40, Southern Railway fireman, was shot to death as he lay asleep at his home here today, and a few moments later his wife walked into the street and surrendered to an officer and admitted the slaying.

Gray was shot three times in the head and twice in the body as he lay in bed.

ELEVEN LIVES LOST IN SOUTH ON NEW YEAR

Eight of Them Died in Automobile Mishaps; One Fatality in North Carolina.

Atlanta, Ga., Jan. 2.—(AP)—Eleven persons were killed in accidents in the South started its new year. Eight died in automobile mishaps, one in a motorcycle crash, one was burned fatally and another died of a wound inflicted by the accidental discharge of a gun.

North Carolina reported one fatal accident.

FIRE LOSS DROPS HERE

Flames Cost the City \$20,000 Less in 1932 Than During Previous Year.

The fire loss in Greenville during the past year showed a pronounced decrease over the previous year. It was reported today by the annual report of George Gardner, chief of the fire department.

The total loss for the year was \$236,555, over \$20,000 less than the preceding year. The loss for 1931 was \$260,534 and in 1930 was \$49,317.

The loss in both 1931 and 1932 was heightened by the destruction of tobacco warehouses along with considerable amounts of tobacco. Eliminating them, the city's loss probably would be among the smallest.

In 1931 the loss of the Star and the state, if not the smallest. McGowan & Cannon's warehouses and with the store of B. G. Abeyoung caused a loss of \$219,570, leaving only \$41,264 damage for the remainder of the fires during that year.

The loss of the Banner warehouse during the latter part of 1932 was estimated at \$185,000. The remainder of the fires cost the city only \$51,555.

The Banner warehouse fire was one of the most disastrous in years in that nearly a million pounds of tobacco were destroyed. The building had been used in recent years alone for store purposes. It was erected shortly after the world war by the Cooperative Association which sold it to local men when it went out of business.

SCHOOLS OF COUNTY OPEN

BOOST WOMAN FEDERAL JOB

Mrs. Lyman Cotten is Mentioned for Post on the Civil Service Commission.

Mrs. Lyman Cotten, daughter-in-law of the late Mr. and Mrs. R. R. Cotten, of Greenville, is being prominently mentioned for a position on the Civil Service Commission in the re-organization of government when Governor Franklin D. Roosevelt assumes the Presidency of the United States, according to information received here.

Mrs. Cotten, daughter of the late Representative John S. Henderson, of Salisbury, and a sister of Dr. Archibald Henderson, educator and author, was mentioned as a probable choice for one of three members of the Commission in a news story received from Washington.

She is well-known in Greenville, having visited here from time to time during the last several years, and is considered eminently qualified for the position.

The Civil Service Commission is composed of three persons at this time, two men and a woman, and is due to come in for re-organization when Roosevelt goes into office. It has been said that Thomas E. Campell, head of the Commission, will retire with President Hoover, and Democrats will name his successor.

NEW OFFICIAL BEGINS TERM OFFICE TODAY

Executive Says Hopes Federal Legislation Will be Arranged to Make Easier for New Year to Benefit from Federal Funds; Says Credit Sound but the Unemployed Must Have Relief.

Albany, N. Y., Jan. 2.—(AP)—The inauguration formally as New York governor, Colonel Lehman called upon the Federal Government to aid the Empire State in caring for its destitute unemployed whose number he estimated at more than a million and a quarter.

The former banker who entered politics four years ago as lieutenant-governor during the Roosevelt administration called unemployment relief the most serious problem confronting the city.

He expressed hope that the Federal R. F. C. act will be changed in a way that will make it easier for "us to benefit from this Federal source in meeting needs of our unemployed."

NIGHT CLUB OWNER SHOT

Larry Fay Killed by Doorman While Trying to Relieve Unemployed.

New York, Jan. 2.—(AP)—Slain by the doorman of his garish midtown night club, Larry Fay, high-powered Broadway racketeer, was a victim of his own modest gestures at unemployment relief, police said.

Fay was shot through the heart last night as he attempted to mollify a man whose salary had been cut to make room for another employee.

1933 Seen as New Deal Year By Party Leaders

By BYRON PRICE Washington, Jan. 2.—(AP)—A spirit of change sweeping in its manifestations and immeasurable in its possibilities, rings the keynote of the nation's life as history turns a page to 1933.

Almost everywhere the old order has fallen into disarray. Not only have the people turned out a political party nationally dominant for a dozen years, but important groups the country over are denying the accepted axioms of the past, and asking for reversal and experimentation.

In a large sense, Franklin D. Roosevelt and the "new deal" appear a symbol of the times. Both in executive positions and in Congress, newsmen are now the tremendously important factor as unrest clamors in nearly every city and Washington responds to the tramp of organized dissenters from things as they have been.

predict with confidence. One view is that the grove of American experience is too well worn to be greatly altered. Another is that 1933 will be remembered as marking distinctly the end of an era, and 1933 as the dawn of a new day of hope. Certain it is that the ingredients for an epochal alteration of the whole pattern of political and industrial life are present in the ferment which the old year leaves to the new. A multitude of grave ponderings has arisen as to the entire eternal triangle of the citizen's relationship to government, the government's relationship to business, and business' relationship to the citizen. Many public men are convinced the nation has reached the end of its patience over the mounting cost of government, and that decentralization, return of power to the states, and a drastic pruning down at Washington are about to make real history.

ABOUT TOWN

Greenville, like the rest of the world, is off on another new year, and everybody is hopeful the swaddling infant will bring forth more brilliant accomplishments than the previous years.

We will deny that 1932 was the worst year from a financial and business standpoint experienced by the present generation, but the old spirit of American optimism has not deserted us entirely and we go into the new year with the hope of improvement before the year is very old.

Many of us have learned to deprive ourselves of things we enjoyed during the days when money was plentiful and jobs easy to obtain. This probably will cause many of us to appreciate more fully the things that come to us in 1933.

Failure someone has said, is a stepping stone to greater achievement and going by this rule, all of us should be brilliant successes this year because we certainly have been subject failures the past two years or more.

The possibilities of America are unimpaired and the nation's prospect of throwing off the robes of depression is just as bright as any past period of the kind when people wondered as we are wondering, "Where to go from here?"

We have always been able to emerge triumphantly from defeat and disaster, and the depression which we are now preparing to leave behind probably has been a refining influence, causing us to gain a keener appreciation of the true values of life.

The fire loss in Greenville, we are happy to learn was not as severe in 1932 as in 1931, according to the annual report of George Gardner, head of the local fire department.

The major part of the losses in both years was caused by the destruction of tobacco warehouses. Eliminating these losses the entire loss of the city probably would be less than any other town of similar size in the state.

The fire loss in 1931 was nearly five times as great as the previous year when the department handled only minor blazes. Two warehouse fires during the year caused the total to run higher than any other year in the memory of the oldest inhabitants.

The fire company is to be commended for its splendid work in major conflagrations the past two years. Had it not been for the equipment and skill of the fire-fighters it is impossible to estimate what the losses would have been.

Money spent for fire prevention is wisely invested, and the fire companies who see that the city department is maintained at the highest stage of efficiency at all times are to be commended for their vision and ability to meet the needs of the city and community.

Members of the Board of County Commissioners meet here tomorrow for purpose of further cutting down the expenses of the county government. Any action which the body takes in this connection will be received gratefully by the citizenship generally so long as the efficiency of government is unimpaired.

The commissioners went into office sometime ago with the avowed determination to operate the government as cheaply as possible and relieve the hard-pressed taxpayers and that they mean to live up to their promise to the people was evident by the excellent start made in the initial meeting.

Taxes must be cut in proportion to the ability of the people to pay and when that is done everybody will be in a much happier frame of mind.

### Bill To Committee

Washington, Jan. 2.—(AP)—The Senate judiciary committee today referred the House prohibition bill to a sub-committee for a limited hearing on its constitutionality.

To expedite consideration of the measure the committee instructed the sub-committee to limit argument to three hours.

The bill was sent to the same sub-committee which is now drafting a prohibition repeal resolution.

Senator Blaine, (R) of Wisconsin, heads the committee.

That certain lot or parcel of land lying and being situated in the Town of Ayden, Ayden Township, Pitt County, North Carolina, fronting on Third Street and beginning at the southeast corner of the prop-

erty of Dr. W. H. Dixon on said Third Street; thence running with the line of W. H. Dixon a northerly direction 140 feet to the Tingle corner; thence at right angles and along the J. R. Tingle line in
