Smoot Works On As His Service In Senate Nears End

Washington, D. C., Jan. 4.—Reed Smoot, of Utah, dean of the Senate, who will be seventy-one years old January 10, is winding up his last three months as a Senator in the same manner he has spent the last twenty-nine years on Capitol Hill—with hard work.

The fact that he is on the last lap of an unbroken term of service in the Senate that dates from March, 1903, hasn't caused this tall, slender, soft-spoken Senator to lessen his pace at all.

Hard work, now as always, is his rule. He still keeps long office hours, and everybody in Washington knows that they are the longest of any Senator or Representative "on the hill."

Home Work, Too
Nor does work stop when he leaves his office. It is continued at home. It has always been a puzzle to those who have watched him during the years how he manages to keep going as he does. Especially was this true during the long and seemingly endless fight in the Senate on the Smoot-Hawley tariff bill.

Prior to the consideration of that bill, never before had a single man handled a tariff measure by himself. It had always been apportioned out among the Senators, each member being responsible for a certain scheduled or portion of a schedule.

Smoot tackled the job alone and saw it through—a job that entailed some 21,000 items. The bill itself contained fifteen schedules, the free list, the special provisions, and the administrative provisions.

He had sole charge of debate and was responsible for a complete explanation of every item and stood on the floor of the Senate every moment that it was up for consideration.

PATROL WILL REMAIN HERE

Highway Officers Accept Offer to Move Into Office of Sheriff Whitehurst

The local unit of the State Highway Patrol will not move to Tarboro as at one time contemplated after they had been deprived of quarters by the Board of County Commissioners, but will accept the late invitation of the commissioners to share the office of Sheriff Sam Whitehurst.

This statement was made this morning by Lieutenant Lester Jones, who immediately began preparations for moving into the new quarters.

ORDER CASE REMOVED TO OFFICIAL COURT

Greensboro, N. C., Jan. 4.—A writ of certiorari was issued in Federal District Court today to compel the removal from Person County Superior Court to the Federal Court of the damage suit brought by Mrs. Ethel Ashby against E. R. Leary, O. L. Smith, R. B. Morton and the city of Durham.

Ground for the order is that Morton is a prohibition enforcement officer of the Federal Government and that of the two assisting him, Leary and Charles A. Reap, are not.

Ground for the suit is a claim that while Mrs. Ashby, who then was Mrs. C. W. Wilkins, was on December 11, 1931, with her husband walking along a highway north of Roxboro, they were hit by the car containing the three officers, who ostensibly were in pursuit of a liquor car.

U. S. DEFICIT STILL MOUNTS

Government Ends First Half of Fiscal Year With \$1,159,286,502 Deficit

Washington, Jan. 4.—(AP)—The government ended the first half of its 1932-33 fiscal year December 30 with a deficit of \$1,159,286,502. In the six months starting last July 1, the government collected from all sources \$1,022,885,840 and spent \$2,182,172,342. While the new billion dollar tax measure increased miscellaneous internal revenue \$117,000,000, income taxes dropped \$272,000,000, more than neutralizing the gain of the new tax levies.

In the six months miscellaneous revenue brought in \$387,360,027 as compared with \$270,571,381 in the first half of the previous fiscal year. Income taxes fell off to \$343,227,856 from the \$615,324,342 collected in the same period of the previous year.

The highest income tax levies in the revenue bill has not begun to be reflected in the government revenues and they were effective on the 1932 income and the first payment of taxes for last year will be received by the treasury on next March 15.

POLICE TAKE RAP AT PRESS

Public Records Denied Richmond Papers As Mayor Severs Relations

Richmond, Va., Jan. 4.—(AP)—Police records were denied Richmond reporters today as both the police department and Mayor Bryce continued their "severance of diplomatic relations" with the press.

Meanwhile, counsel for the Richmond Times-Dispatch was proceeding under the instruction of Vincent Byers, editor, to seek a court order to secure access to public matter.

Mayor Bryce whose official action, particularly in his dealing with the unemployment council, had been criticized by both local papers, announced he would sever "diplomatic relations" and continue his policy until such time as the "press can again best serve the interests of the city."

He said he was growing weary of the open hostility and destructive criticism of Richmond papers.

MANY LIQUOR CASES HEARD IN PITT COURT

Judgment Continued In Case of Mrs. Maybell Edmunds, Reckless Driving

With a new judge and solicitor on the job, County Court got down to business yesterday morning following induction ceremonies and disposal of twenty of the thirty-five cases today. Work was continued today and it was indicated the remainder of the cases, consisting largely of violations of the prohibition law and larceny, would be completed during the afternoon.

Judge Dink James and Solicitor Jack Spain were administered oath of office in impressive exercises, marked by considerable oratory and the adoption of resolutions paying tribute to the retiring judge, W. L. Wheeler.

Immediately after Judge James had acknowledged the greetings extended by members of the bar and had pledged his best efforts to the community, court delved into the docket consisting of a number of liquor cases which had been brought over from the Christmas holidays.

Judgment was continued in the case of Mrs. Maybell Edmunds, of Scotland Neck, charged with reckless driving in connection with running over and breaking the back of Wesley Johnston, nine-year-old son of Mrs. F. V. Johnston, several days ago.

The youth, who was crossing the street on skates was hit by Mrs. Edmunds' car, knocked down and dragged into a vacant lot as the car swerved from the street. Mrs. Edmunds admitted she did not have any brakes and didn't have money at the time to have them fixed.

She did not have money with which to pay a fine in court, and Judge James reserved judgment until the next sitting of the court.

TWO KILLED IN FIGHTING ON TUESDAY

Score of Persons Arrested as Fighting Flares Anew Among Hostile Union Miners as Men Return to Work This Morning; Considerable Arms and Ammunition Seized; Snipers Busy on Main Streets of Kincaid

Taylorville, Ill., Jan. 4.—(AP)—Fighting broke out anew among hostile union miners as members of the United Mine Workers started for the shaft of the Peabody Mine No. 7 at Kincaid this morning.

From both sides of the mine shafts burst out two men who were seriously wounded and others reached cover amid a shower of machine gun bullets and buckshot.

Deputy sheriffs who patrolled the Taylorville-Kincaid highway all night as a result of yesterday's fighting in which a man and a woman were killed, reported they were targets for snipers from houses and other places of concealment.

They arrested a score of persons and confiscated many guns.

Thomas Hickman and Fulton Smith were wounded this morning by snipers who they said shot from the second floor of a business building on Kincaid's main street.

Co-workers many of them from other towns made up a full working force at 7:30 o'clock and the mines resumed operation.

AUDITOR FILES CHARGES AGAINST TAX COLLECTOR

Elizabeth City, Jan. 4.—Further charges of irregularities in the accounts of C. E. Bailey, employed by the county commissioners to foreclose on delinquent taxpayers, was made by C. C. Pritchard, county auditor, in a four-page report filed with the commissioners at the regular meeting Monday.

In his report the auditor charges Bailey has failed to turn over to the sheriff or clerk of the court a total of \$135 for taxes, although the deeds for the property have been signed by Bailey as having been paid.

On November 2 similar charges against Bailey of failure to turn in county funds were made by the auditor. On November 2 and 5 Bailey made good shortages amounting to \$884.33. On November 7 the auditor reported the matter to the county commissioners, showing that while Bailey had given the impression that the shortages arose from failure to turn in partial payments, only one of the several checked on had been a partial payment.

We have worked projects in Pine-top, West Edgecombe, and soon will have them for Speed, Mayo, Conover, Leggett and Whittakers." Mrs. Wiggin with her force of assistants has been kept busy all of this fall attending to the needs of the needy in this county.

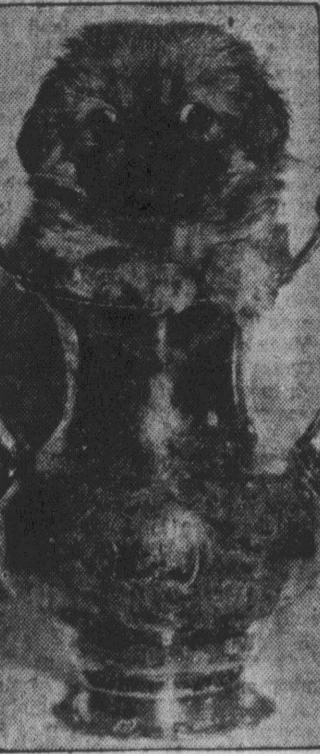

Washington Daybook

Washington, D. C., Jan. 2.—Those habits of the House galleries who followed the beer battle just before Christmas were reminded of days long past as they gazed at the struggle going on below them on the floor.

For sometimes in the rear of the chamber on the Republican side, sometimes half-day down on the Democratic side, and at other times on the front row there could be spotted a slight, frail man on crutches whom they all recognized instantly.

He was William D. Upshaw, of Georgia, for eight years a member of the House, candidate for the Presidency in 1932 on the prohibition ticket, and the man who with persistent regularity unfurls the white banner of prohibition.

He was back on the floor again—of course without the power to speak his mind, but exerting all the influence he had to defeat the beer proposal.

The sight of Upshaw on the House floor at the time recalled to mind a statement he made in his valedictory address to the House following his defeat back in '97.

"Dry constitutional Democrats," he shouted to his colleagues, "desire peace, but they should never put their signatures to an agreement written on the upturned head of a beer keg—unless that keg is empty."

The House lost a star prohibition performer when Upshaw departed. There are still Congressmen who are as strong in their views on prohibition as is Upshaw, but there have been none since as colorful perhaps as he.

Upshaw never lost an opportunity to plug in for the cause.

He sensed the dramatic and made full use of it.

They still talk about the time he is said to have found an empty liquor bottle by the elevator one night as he was leaving his office. He pocketed the bottle and awaited an opportunity to make use of it.

Lincoln's birthday came around and he took it to the floor of the House. Being recognized by the Speaker, he went to the well and began a speech.

The other sent up by Scarborough and Williams would reduce the governor's pay from \$10,500 to \$7,000 annually and would place other executive officers who form the council of state on a \$3,000 basis.

Organization of the two divisions was a formality. The House named Reginald Harris of Person and speaker and Senator Willie Clark of Edgecombe was named president pro tem of the Senate.

Veto Faces Philippine Bill

Washington, Jan. 4.—(AP)—President Hoover today referred the Philippine bill to Secretary Hurdley for report and there was strong indication of an impending veto of the measure.

The secretary of War, after discussing the bill which would give the islands independent use in ten years, left the White House to prepare his report declaring the measure will not solve the difficulties of the problem, but accentuate them.

By ROBBIN COONS Hollywood, Jan. 4.—Unlike the other movie constants who help keep the name of Bennett before the public, Connie Cummings displays a decided lack of interest in clothes.

When a studio designer undertakes to make her a fashion plate for movie purposes, it is no difficult task. She wears delicate creations very well. But in private life, she declares, people and books interest her more than clothes, and her hats are the despair of her mother and her friends.

Her interest in books is genuine—she was late for her presentation as a Wampus baby star in 1931 the reason being a new book she hated to close.

Hollywood Reads And so the subject of books—never can it be said that Hollywood, even that part of Hollywood which lacks Miss Cummings' voracious interest in literature, does not read. But this pre-filming interest in a book is peculiar to Hollywood. My book-seller friend cited W. H. Hudson's "Green Mansions" as a recent example. For years a steady but not a rapid seller, this volume suddenly enjoyed great demand as soon as Radio announced it would film it.

Ambitious actors always study novels to be filmed in the hope of finding a part for themselves in them. This is the first step in getting a job, and the easiest. After that, it's simply a matter of convincing the casting director that one is the ideal, the only actor for that part—if it isn't dropped entirely in the screen adaptation.

Books Rarely Stolen Books rarely are stolen from movie property departments, and to book-lovers whose fingers itch when they wander through a bookstore, no matter how honest and temptation-free they may be in other respects, that may seem unbelievable.

It is to be hoped that Lawson Robertson's plan to run Bill Carr in the 100 and 200 meter dashes next spring does not interfere with the prospect of a renewal of the Olympic champion's duel with Ben Eastman of Stanford at 400 meters in the intercollegiate outdoor championships.

Presumably Eastman will continue to run the 400 as well as his best event the 800 while Dink Templeton is coaching him. Easterners who did not have the pleasure of seeing any of the sensational trio of the races these two days ran on the coast last summer certainly would feel discriminated against if the did not have the opportunity next May to see whether Carr's mastery was true or just a mirage. They had to pinch themselves to be sure it was the real thing last summer.

Despite Templeton's ouster last season the East as well convinced Eastman's "inviolability" at the 400-meter or 440-yard distance and received with as much surprise as the West although with a different emotion the stunning setbacks to the great Stanford runner by a boy who had never run the distance outside of a relay race in the East.

Consequently if we can have an Eastman-Carr encore at Harvard Stadium in the spring it will be highly attractive not only from the artistic but also the financial viewpoint. Carr it would seem could combine the 200 and 400 quite nicely.

Eyes Relay Record Carr will continue to anchor Pennsylvania's mile relay team this winter. In addition to which Robertson will send his crack quartet of miles out after the world indoor four-mile relay record. One of Buffalo's big indoor club meets may be selected for this record attempt. Only one of Pennsylvania's miles is eligible for varsity competition this year, Dan Dean, but the others can join him in any available open competition this winter. Gene Venzke, the indoor record-holder, is a freshman at the Quaker school, heading toward a come-back after his disappointing failure to make the Olympic team. The other two, Carl Conant and Bill McKniff, are taking post-graduate work.
