CHILD DIES FROM RABIES

Bitten by Mad Dog in December, David Barnhill Succumbs At Home Here

After being bitten by a mad dog here about thirty days ago, David Barnhill, five-year-old son of Mr. and Mrs. C. H. Barnhill, died at his home here this morning at 4 o'clock from hydrophobia.

The child, who had recently completed the anti-rabies treatment, was taken west Friday night and physicians held out little hope for his recovery after that time.

Funeral services will be conducted from the Barnhill home tomorrow afternoon at 2 o'clock by Rev. Dennis Alexander, pastor of the Bethel Free Will Baptist Church and burial will be made in the family burying ground at Everetts.

Pall bearers will be: W. A. Hill, J. R. Geeranus, W. A. Small, and Jim Seiger.

Surviving are the parents and two sisters, Mary Lucy and Emma Louise Barnhill.

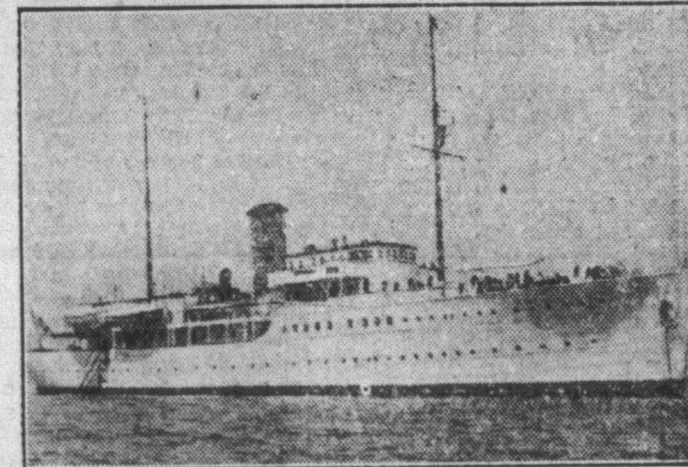
The child was playing on the porch of his home about the middle of December when he was attacked and painfully bitten about the face by a dog which dashed from the street onto the porch. A negro youth was said to have been bitten in another part of town by the same dog but his condition was not described as serious.

Police slew the rabid animal a short time after his attack on the child but not until after several other dogs were believed to have been bitten.

The episode caused police authorities to issue a warning prohibiting dogs from appearing on the streets unless in leash under penalty of death.

The police have made an effort to rigidly enforce the order since that time and while several dogs have been slain, it was said the citizenship was co-operating in the effort to throw a safeguard around public life.

NEGRO SLAYS SWEETHEART

Police Seek Perry Little For Shooting Lucy Sugg to Death Last Night

Jealously over "another man" was believed to have resulted last night in the slaying of Lucy Sugg, twenty-two-year-old negro, at the home of a neighbor in Newtown, colored residential district in the western part of the city.

The woman was shot to death by Perry Little, colored, who escaped and so far had successfully evaded capture.

An entire load of gunshot was fired into the woman's head and death was instantaneous.

The shooting took place at the home of Fannie Rogers and came as an aftermath of a day of quarreling between Little and his sweetheart.

After length quarreling the woman fled to the home of the neighbor supposedly for the purpose of escaping the wrath of Little. She had been there only a short time when Little appeared levelled a shot gun at his sweethearts and fired. The entire load took effect in the head, almost completely demolishing the skull.

Little ran after he had fired and despite considerable searching on the part of police had successfully evaded capture up until the noon hour today.

Police said the negro, only a short time ago completed a sentence in another county for the severe cutting of his wife.

PITT SCHOOLS OPEN TUESDAY

Impassable Condition of Roads Causes Deferral of Opening; Cnty Schools Open

The county school system which failed to open last Friday because of the heavy snowfall, will not be able to resume work until tomorrow it was stated today at the office of Donald Conley, director of public instruction.

It had been planned to re-open schools today but impassable conditions of many of the county roads made this impossible, the school head said.

City schools, which abandoned work at noon time Friday, got down to work in real earnest this morning and attendance was believed to be near normal, although a check up had not been completed during the morning.

Decision to close the county system last Friday morning came after the snowfall of the night before had made it impossible for the school buses operating to and from thirteen of the largest schools to make their regular runs. The melting snow since that time has converted some of the county roads into loblollies and the bus will not be able to operate until this condition has been improved by the road forces.

It was the first time of the winter months that weather conditions had interfered with the operation of public schools, and while officials regretted the delay hundreds of children were elated Friday over the opportunity to get out into the open and enjoy the form of winter sport so rare in this immediate part of the state.

Late News Flashes

Filibuster Continues Washington, Jan. 16.—(AP)—Despite predictions on both sides that enough votes are pledged to override President Hoover's veto of the Philippine bill, Senator Long of Louisiana continued his filibuster in the Senate today by using the island issue to block all other business, especially the Glass bank bill.

Long advocated rejection of the veto by declining to let it come to a vote in the fifth day unless agreement was reached to invade the bill. Even without additional support he predicted the bill would be passed over the veto but some senators disputed it and said it all depended on the number of voting. It takes two-thirds majority to pass over a veto.

Meanwhile Glass, author of the bill which has been the unfinished business since January 5, held in abeyance an effort to invoke drastic

cloture rule. He preferred to wait until the senator had had enough to ask the cloture rule.

No Agreement On Beer Bill

Washington, Jan. 16.—(AP)—A week's delay for the Collier-Blaine bill to legalize 35 beer and wine was forced today when the Senate judiciary committee failed to reach an agreement.

The committee spent two hours discussing the favorable subcommittee report to modify the Volstead act but reached no vote.

Norris said it probably would be approved next Monday when the committee holds its next regular meeting.

BANKER HELD FOR SHORTAGE IN TENNESSEE

Knoxville Man Indicted For Misapplying Funds Of Holston Bank

Knoxville, Jan. 16.—(AP)—J. B. Ramsey, former president of the Holston Union National Bank which closed November, 1930, was indicted in Federal Court here today of charges of misapplying \$230,000 of the bank's funds and making false entry charges. Ramsey was also charged with using \$150,000 of the bank's money for running an investment concern known as the Holston Union Company.

DAUGHTER OF WILSON DEAD

Mrs. Jessie Sayre Dies Following Operation At Hospital In Cambridge

Cambridge, Jan. 16.—(AP)—Mrs. Jessie Wilson Sayre, daughter of President Woodrow Wilson, and a life-long worker of social service and the cause of world peace, died last night. She was 45.

Mrs. Sayre was the wife of Joseph B. Sayre, newly-appointed State Commissioner of Correction and a member of the Harvard Law School faculty.

Death followed a gall bladder operation performed in a hospital here.

DEFER HEARING IN AUTO DEATH

James Davenport to Face Preliminary Trial Here Wednesday Morning

The hearing scheduled today for James Davenport, of Beaufort County, charged with manslaughter and reckless driving in connection with running over and killing William Robert Cayton, Grimesland district school child, was continued until Wednesday morning at 11 o'clock here today.

The case was ordered continued by Justice of the Peace C. B. Rowlett when the defendant asked for an extension of time.

The school child, ten-year-old son of Mr. and Mrs. David Cayton, came to his death when he left the school bus near Chicoc Creek bridge and was hit by the car driven by Davenport as he started across the road.

Davenport claimed the accident was unavoidable, but he was charged with manslaughter and reckless driving following an investigation conducted by Sheriff Sam Whitehurst. He was said to have been driving at the rate of forty miles an hour and failed to stop as provided by law when passing a school bus in the process of taking on or putting off passengers.

ENDS HIS LIFE WITH MONOXIDE GAS

Winston-Salem, Jan. 16.—(AP)—William Henry Matthews, 32, penned a note to each member of his family and then ended his life here today with monoxide gas from the motor of his automobile.

Matthews' body was found in the garage at his home about 11 a. m. in lay beside his automobile. The motor was still running.

Authorities said it was a clear case of suicide, and an inquest was unnecessary. They did not disclose the contents of the notes.

HITLER WILL VISIT BERLIN

Socialist Leader To Confer on Charges Dealing With The Chancellorship

Berlin, Jan. 16.—Adolph Hitler, leader of the National Socialist party, was expected today to confer with government chiefs, but sent word from Wilmar he would not arrive until tomorrow.

The conference will be held here to determine the policy of Hitler with the government.

Upon the parley hangs the possibility of dissolution of the Reichstag or the alternative appointment of Herger Straffe, international Socialist organizer, as chancellor with Hitler's approval.

Changes made by the Hitler part in the German state of Lippe dealt elections yesterday were believed a refutation of assertions that his power was on the wane. Only the day before it was believed that General Von Schleicher might step out to make Atraffe chancellor, forcing Hitler to decide to support the cabinet.

DEATH NOT IN BOOTLEG WAR

Sheriff Says Slaying at Hartford Not Caused by Flareup Among Bootleggers

Hartford, N. C., Jan. 16.—Sheriff Emmett Winslow today said the slaying of Anderson Layden, 35, on a road three hundred yards from his home Friday night had no connection with the bootlegging war that took three lives last summer.

The sheriff said his investigation disproved early belief that Layden's death was connected with the ambushing of Mr. and Mrs. Claude Elliott and the fatal shooting next night of Linford Castle. These deaths were believed to be the outgrowth of fear among bootleggers that their stills would be reported to officers.

CHILDREN PICK OWN TOYS. THESES WRITER LEARNS

Columbus, O., Jan. 16.—(AP)—Roland B. Smith has emerged from a mass of statistics gathered for a master's degree at Ohio State University to announce that toy makers and retailers have been directing their advertising all these years at the wrong target.

Proud fathers and indulgent mothers, he concludes, seldom decide what toys the child shall have and yet it is to the parents that the advertising has been directed.

He studied 609 youngsters between six and twelve years. Ninety-six out of every one hundred children, he found, "have some choice in selecting their toys and of the ninety-six, twenty-eight are accorded complete choice by their parents." Smith also found that seventy-eight per cent of the children read or look at the daily papers, other than the comic sheets.

With the presentation of the administration revenue bill to the legislature tonight the lobbyists in Raleigh will begin to earn their pay by their efforts to see to it that those interests wealthy enough to employ lobbyists escape their just share of taxation passing it on to those sources not able to employ special lobbyists to represent them. Of course, when the legislature starts to work on a revenue bill no line of business or no individual thinks that it can afford to pay the necessary tax, but if our state is to keep on operating it must have money and certainly it must get the money from sources where it is available. Higher income taxes, especially in the upper brackets together with the repeal of the law that now exempts stocks in foreign corporations from taxation are steps that should first be taken to raise enough revenue to balance the budget, but first of all it should be seen to that expenses in every department have been cut to a minimum.

ABOUT TOWN

Granting permission to the president to make proposed change in various departments would have caused the government additional expense because it is a well defined fact that Roosevelt will have some ideas about rearranging government offices when he goes into the White House.

It places them in position to live comfortably in spite of prices paid for major crops and that is exactly what the majority did not do until the live at home movement got under way.

Governor Ehringhaus is in sympathy with the farmer, realizing as he does that the economic condition of the farmer is essential to the welfare of every branch of business. Others high in the business life of the state realize the same thing and are doing their best to convince the farmer of the advisability of protecting himself against low prices.

Appointed industrial commissioner of New York state and city in January, 1929, by Franklin D. Roosevelt, she administers affairs of the largest labor market in the nation.

Her brown eyes carry and kindle enthusiasm, her well-groomed figure moves with and inspires energy as she directs a department dealing with 1,500 to 3,000 callers daily; publishing statistics second only in volume to the federal labor department, and administering welfare laws.

"Advanced social and labor legislation has been the making of the Democratic party in New York," Miss Perkins recently said.

In private life she is Mrs. Paul C. Wilson. Her husband is a sociologist and statistician.

FARM NOTES

(By E. F. ARNOLD, County Agent) The Regional Agricultural Credit Corporation of Raleigh, N. C. has advised the county agent that his office will be supplied with application blanks for crop production loans by the middle of this week.

These loans will require in addition to crop lien adequate security to take care of the loan in case of crop failure. Farmers who desire to make applications for loans under these terms may do so at the county agent's office this week.

This office is also advised that seed loans as made last year will be available around the first of February. As heretofore, the only collateral required will be a crop lien. This office will again assist the farmers in securing these loans when made available.

Tobacco. During the past two weeks 159 farmers have reclaimed 211,14 lbs. of tobacco seed. Most of those having seed reclaimed are landlords and of course have seed reclaimed for all of their tenants. The total number of farmers and tenants using reclaimed seed is estimated to be around 8500. Farmers who anticipate having seed reclaimed are urged to do so at once as not to interfere with the work of assisting farmers in securing loans when made available.

Good tobacco growers consider that good plants constitute half the battle in having a good crop of tobacco. Therefore, great care should be taken in selecting plant beds and the seed to be sown on these beds. Farmers should select good soils, well protected, with the southeast exposure, for growing plants and should avoid carrying trash tobacco to the seed bed in any way. Tobacco trash will carry disease to the plants and consequently reduce the price for seed.

Tobacco beds planted in well protected places will aid the farmers in bringing plants back more quickly in case blue mold should get in the bed. In cases where blue mold is found in plant beds, farmers last year got best results by using 50 gallons of water to the 100 yards of bed every four days. From two to three pounds of nitrate of soda should be used in each 50 gallons of water. Plant beds sown reasonably early in well protected places can more readily overcome blue mold than in unprotected places.

Curb Market. The Pitt County Mutual Exchange continues to operate the curb market house on Oatcote Street on Tuesday and Saturday. You will find it a comfortable house in which to shop with the farmers of this section. They continue to offer the buying public of Greenville a large variety of food for the table at reasonable prices.

Sea gulls that forage in the gulf off the Louisiana coast are getting lazy or wise, says the Department of Conservation. Instead of flying home at sundown they ride in with the tide.

HELPS FOR HOUSEWIVES

COD LIVER OIL IS HELD NECESSITY FOR CHILDREN. Washington—Cod liver oil is rated not a luxury but an indispensable food for young children, which not only will prevent rickets but also will protect the child in other important aspects.

It should be included in the diet of all children under two years of age. To provide three to four teaspoonsful a day will cost 15 to 25 cents a week, Federal child experts estimate.

Varnish Kitchen Wallpaper. If ordinary wall paper is used in the kitchen a coat of varnish brushed on after it is hung will help prevent steam from loosening the paper and will give it a more durable finish.

Make Dining Nooks Attractive. If meals are served in a corner of the kitchen it is suggested to have a light that illuminates that part only. Then after other lights are put out the dining corner seems to be shut off from the rest of the room and makes a more attractive nook for the meal.

Milk Improves Cooked Rice. Washington—Both the flavor and the food value of rice may be considerably improved by cooking it in whole or skim milk or in half milk and half water or by adding rich milk after it has been cooked. Rice will sometimes absorb as much as four times its volume in milk. U. S. food experts say. This makes it especially nourishing for children and invalids. Beef or chicken broth may also be absorbed by rice in the same way.

Housekeeping Tips. To remove water stains from glasses or vases, rub with vinegar applied on a cloth and wash well in hot water and soap suds.

To remove tea, coffee or cocoa stains from china, wash with soda applied on a damp cloth.

Make the pot holders round so that there will be no trouble with the corners catching on fire in the stove blaze.

Place a piece of camphor gum in the drawer or box used for storing silver, and this will aid in preventing tarnishing.

To aid silk hose in retaining their color, since them in one quart of cold water to which two table-spoons of vinegar have been added.

To cut fresh cake or bread use a knife which has been dipped in hot water.

Little chick gravel may be substituted for bird gravel for the canary.

A date palm, which produces no dates, but which has a fig tree growing from its side, has been found at Key West, Fla.

Great Cy Young Now a Gentleman Farmer in Ohio

Columbus, O., Jan. 16.—Baseball fans who can hark back to the days of 1890 will recall a tall, lanky youth in the pitching ranks of the old Cleveland Spiders in the National League.

Twenty-one years later, in 1911, that rookie pitcher was destined to leave the big leagues with an all-time record of 511 games won out of 873. He was Cy Young—that grand old man of baseball.

Edwin T. Young, or Cy, after his retirement from the big leagues came back to Peoli, a hill town in eastern Ohio, to settle down on a farm near the place where he was born sixty-six years ago. With one man to help him, Cy operates a 160-acre farm which his wife's grandfather, David Miller, homesteaded from the government in 1820. But Cy says he's "no great shakes" as a farmer.

"I manage to keep busy with our sheep, hogs, chickens and other stock, but I'm not much of a farmer. I do enjoy life down here in the hills, and when I get the urge I can always drive to Cincinnati or Cleveland to see a ball game," he says. The mantel of Cy's fireplace in his home is lined with silver cups and trophies, testimonials of his pitching ability in the big leagues. One of his valued possessions is a parchment scroll on which his record is inscribed in black and gold. The closing statement on the scroll: "Baseball will be no more when Cy Young is forgotten."

Cy started his 511-game march with Cleveland and pitched his last on October 6, 1911, at Brooklyn. He also holds the record for pitching three no runs, no hit games. The first was against Cincinnati on September 17, 1897; the second against the Philadelphia Americans on May 4, 1904, and the third against the New York Americans on June 30, 1908.

And so while young rookies in the big leagues set out to break Cy's records, the old pitcher enjoys life down on the farm among the hills where he was born.

Says Seed Loan Will Be Passed During Monday

Washington, D. C., Jan. 16.—Representative Lindsay Warren stated today that he had been assured by Speaker Garner that he would permit the Seed Loan Bill to be passed under suspension of the rules on Monday. At a meeting attended by Senator Smith, of South Carolina, Representative Jones, of Texas, chairman of the House Committee on Agriculture, and Representative Warren, a new bill was prepared which will carry approximately \$120,000,000 for the loans this year, as a survey of the nation showed such an amount to be necessary. In order not to endanger the immediate passage of the legislation, Mr. Warren withdrew his insistence that the fund be handled by the several Regional Agricultural Credit Corporations, so the Department of Agriculture will handle same as formerly. Mr. Warren, who introduced the Seed Loan Bill on the opening date of Congress, believes the measure to be one of the most important to be passed by Congress at this session, and has repeatedly stated that without same it would be impossible for a large part of the country to start a crop. Repayment of former loans has been very high. In North Carolina collections amount to about 93 per cent.

LUMBERTON NEGRO FATALLY WOUNDED

Lumberton, N. C., Jan. 16.—Solicitor Carlton, Lumberton negro, aged about thirty, died in a Lumberton sanatorium early yesterday from wounds received five hours earlier when shot by Tom Cotton, negro, also of Lumberton. It is allowed that the negroes had been engaged in a gambling game and that Cotton charged Carlton with getting a drink of liquor without paying him for it. They had a quarrel on the Fairmont road, southern edge of Lumberton, at 2 a. m., and Cotton shot Carlton in the back with a load of buckshot. Cotton was arrested at 6 a. m. by Lumberton policemen, McRaney, Stephens and Page, and is now held in jail pending the outcome of a coroner's inquest scheduled to be completed today. Coroner D. W. Biggs summoned a jury today to view the body.

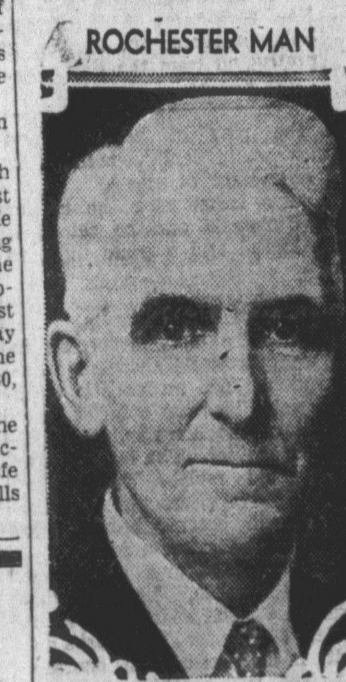

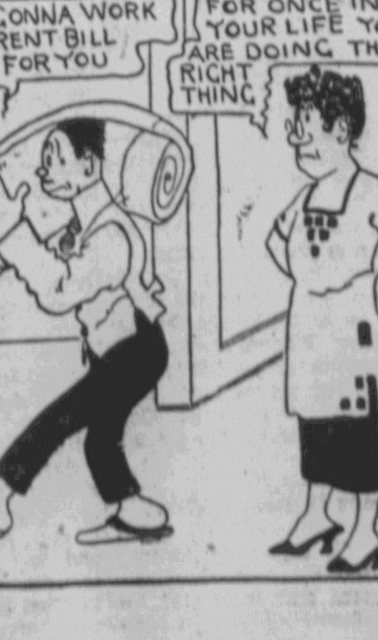

WILL REDUCE TOLLS OVER CHOWAN RIVER

Edenton, Jan. 16.—A reduction in the tolls on the Chowan river bridge has been announced here by Lloyd E. Griffin, state senator from this district. According to Senator Griffin the State Highway Commission has agreed to reduce the tolls effective in 10 days.

Tolls on passenger cars would be reduced from 75 cents to 50 cents, one way, and from \$1.25 to 75 cents for a round trip, according to reports of the committee favoring reductions. The \$3 toll on trucks would be reduced to \$1 and smaller trucks would pay 75 cents, one way.

This reduction was the result of the action of a committee composed of Senators Lloyd Griffin and Dudley Bagley and Representatives W. J. Berryman of Chowan county, and W. T. Culpepper of Pasquotank.

A definite schedule of rates will be announced later, according to Senator Griffin. This does not mean the end of the fight for removal or at least further reductions in the bridge toll. It is also planned to make an effort to secure special rates for Sundays and holidays.

HOLLYWOOD SIGHTS & SOUNDS

Hollywood, Calif., Jan. 7.—The studios' anxiety to get their "money pictures" into the theaters as quickly as possible is shortening the lives of the cycles in screen fare.

A cycle last year had a perceptibly lower influence on production schedules. Studios following up a hit from another week sometimes waited several weeks before actually beginning production on their "original ideas."

This year the trends rise and pass almost before they have time to be noted as such. The chain gang themes were used by three studios, and two of the films resulting already are being seen. The third will be released shortly, and although Paid Munt's vehicle, "I Am a Fugitive," was a bit hit, no other stu-

dios are attempting to follow suit. Instead they're going after different brands of entertainment, suspecting that the chain-gang fever will have run its course before any more movies can be made on the subject.

Sheila Keeps Busy

Sheila Terry, for whom a brighter movie future looms, has had the rather unusual experience of playing in twenty-five pictures during her nine months in the films.

Of these, of course, only a few have had her in roles better than hits. She has the second lead in "Madame Butterfly," and has been featured in "Scarlet Dawn" and "You Said a Mouthful."

Nearly all her other appearances have been walk-ons—as secretaries usually, roles in which she had a line or two to say.

In one film she began with a fairly good role, only to have it cut to one appearance and the one line of dialogue before shooting began.

Good Experience

Her experience, typical of the fate of new players during their apprenticeship, she regards as valuable.

"You learn to crawl before you walk," blond Sheila says. "And breaking into pictures is the same thing. I don't think I'll play any more secretaries, but I was glad to do them—every one was training."

In Hollywood, Calif., Jan. 7.—These intricate jigsaw puzzles offer no challenge comparable to that question facing movie studios when they hand out screen credits to writers.

Screen stories tagged as "originals" by one author, may be, in final form, the work of four or five or six. Whose work is the more important is a question, often, for a Solomon to decide.

What usually happens, of course, is that the writer originally assigned the job, with a contract calling for screen credit, gets it, no matter how many story doctors have been called in—and this is true even though in final screen form the story bears no resemblance to that contributed in the first place by the man who takes the bow.

Glory Wanted

If there were any solution more fair and just, the studios would be able to silence much resentment on the part of writers who are not content merely with their checks but want glory too.

In talks as never in silent pictures screen-writing has become a group enterprise. With talkies came dialogue writers, stage craftsmen and playwrights, who teamed up with writers experienced in screen technique.

Even so, there is little "collaboration" in the literal sense of the word. One man's story may pass through half a dozen hands before it reaches the screen, and none of the six other writers confers with the first.

Even in the established teams—like William Slavens McNutt and Grover Jones—there is a "division of labor" which is not an actual "working together." Usually in such teams one man specializes in dialogue, the other in action and business.

This Team Collaborates

One team, comparatively new, that actually collaborates—that is, works together on every detail of its works—is P. J. Wolfson and Allen Rivkin, who in their fourteen months' association have turned out ten screen stories, most of them "originals."

Wolfson and Rivkin, both 29, became a team when they met at Universal and decided to work together on a story for Mae Clarke. The result was "Night World."

Wolfson came from New York, where he had been a pharmacist, after the movies bought his novel, "Bodies Are Dust." Rivkin had been a studio advertising and publicity man until with Ben Markson he wrote "Is My Face Red?"

New York, Jan. 16.—This city which matures most of the nation's art movements has encouraged few modernists who interest and amuse more than young Russel Wright, from Lebanon, O. And few who have made modernism pay so well.

Wright is a messiah of the "glass age" in design—an age which may never see, which many may not want to see at all, but which nevertheless whets our curiosity so end.

When we are educated to appreciate the beauty of mechanism, then, says this 27-year-old designer, will we be ripe for the glass age.

Wright goes into raptures over automobile engines, clock wheels—all sorts of works that make things run. His might be described as a Russian attitude—the glorification of the machine. He can't see why we should cover engines with hoods and clocks with cases.

He has plans for a glass piano which, he dreams, will smash the traditions of piano makers.

"The play of hammers and strings in a piano is quite beautiful," he says. "The piano is a machine. There is no reason why we should go on covering up this beauty with so-called decorative period cases."

The sounding board is the only wood essential to tone in a piano. Now the shell is made of veneer—pressed wood—with a finish as hard as glass. Tests have shown that this shell might just as well be made of glass.

"I would start from scratch in the designing of a modern piano—with the mechanism. The shell would be something purely utilitarian, just to hold the works, and of glass, to leave their beauty exposed. Watch-

Washington, Jan. 16.—(AP)—At the request of Senator Smith, democrat of South Carolina, the Senate agriculture committee today agreed to defer action of the domestic allotment farm relief bill until he has conferred with President-Elect Roosevelt.

Smith planned to do this immediately.

After some discussion the committee recessed until tomorrow.

Five Held in Kidnapping

New York, Jan. 16.—(AP)—Examination of the activities of two policemen and three others, accused in a kidnapping, gave rise today to a report that Dr. John P. Condon, "Jabe" of the Lindbergh case, would view the men to determine if any of them were members of the gang to which he paid money for Cal Lindbergh.

District Attorney William Geaghan, of Brooklyn, revealed that he was examining police rolls back as far as February 1 last to determine when the two cops had been off duty.

The Lindbergh baby was kidnapped March 1, 1932.

Hoover May Speak Again

Washington, Jan. 16.—(AP)—Secretary Mills after a conference with President Hoover at which he said financial matters were discussed, stated Mr. Hoover might make a statement on this matter or send a special message to Congress in the next 24 hours.

The secretary said it was not decided when Mr. Hoover might make the statement but there was a possibility it might come before night-fall. He declined to say whether it would be a message or statement.

Mills planned to discuss fiscal matters tonight. The President has been described as saying the situation is critical and there is need of speedy action by Congress.

Stock Market

New York, Jan. 16.—(AP)—The stock market again crept forward at the start of a new week.

GOLD AND SILVER ARE MINED IN CAROLINAS

Washington, Jan. 11.—(AP)—Although their production of precious metals was small as compared with that of other States, North Carolina and South Carolina were not barren of gold and silver in 1932.

A report by the U. S. Bureau of the Mint today showed that in the year just ended, North Carolina produced 508 ounces of gold worth \$10,000, while South Carolina produced 508 ounces worth \$1,200. The Tar Heel State produced 9,095 ounces of silver valued at \$2,565 and South Carolina produced four ounces worth one dollar.

The nation's total gold production will be 2,507,587 ounces, valued at \$51,836,400, and its silver production was 24,425,089 ounces, valued at \$6,887,875.

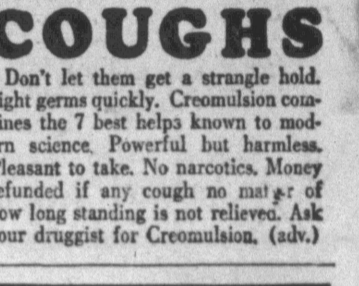
