SEN. SMITH TALKS FARM RELIEF WITH ROOSEVELT

Four Persons Bitten As Mad Dog Runs Wildly Down Street Of City

MANY DOGS SLAIN AFTER BEING BITTEN

Police Issue Order For The Slaying of Every Dog Caught On The Streets of The City in an Effort To Protect Public Life; Scour City For Animals Believed to Have Been Bitten

A new mad dog scare spread over the city today with the reported biting of four persons, two white and two colored, by a rabid animal which ran down principal streets of Greenville, snapping at everything in sight before finally being killed in the western section of the city.

The ultimatum was issued by Chief of Police George Clark, who issued a similar statement the middle of December when a child was bitten by a dog in the western section of the city.

Chief Clark said his men would do everything in their power to throw a protection around public life with the increased seriousness of the mad dog scare and declared that no animal caught on the streets would be allowed to go free.

Running madly down business and residential streets shortly before the noon hour the dog bit a Mr. Jones on the hand, Eugene Martin and J. B. Moss, colored, on the legs and then attacked W. H. Norris, Dickinson avenue drugist, without inflicting injury.

The animal was pursued to the western section of the city in the vicinity of West Greenville school and killed. Six other animals believed to have been victims of the rabid dog's bite were also killed.

Police said they believed several other dogs had been bitten and a keen lookout was being maintained this afternoon for the appearance of dogs showing the slightest indication of contact with the mad dog.

City authorities called on the citizenship to help prevent a recurrence of the mad dog epidemic by muzzling their dogs and keeping them off the streets.

C., Jan. 17.—Oscar Stridge, acquitted of felonious assault upon a young widow at the October term of Superior Court was being sought by Sheriff Vic tor Meekins last night on a warrant sworn out by 18-year-old Blanche Mann, of Nag's Head, charging felonious assault against her last night.

Judge R. Hunt Parker expressed disapproval of the jury's release in October, told the young man he had the wrong slant on life and issued orders to the sheriff for his arrest on his own testimony of transporting whiskey. The recorder's court released him two weeks later on payment of costs.

Fayden was arrested by J. Ross Joyner, Fayetteville police chief, on a warrant sworn out by J. H. Nolen, of Chapel Hill.

Nolan said the Cumberland County official illegally acquired a safe, 135 feet of electric wire, one filing cabinet, 18,000 score sheets, a machine, several toolboxes and personal papers belonging to a client. He valued the property at \$2,000.

TRAPPED MAN DIES IN FIRE

Burlington, N. C., Jan. 17.—(AP)—John Phillips, of Gaffney, S. C., was burned to death last night in a fire which damaged a boarding-house here.

HOUSE PASSES SEED LOAN BILL

Measure Providing Farm Loans Passed Under Suspension of Rules

Washington, Jan. 17.—Under suspension of the rules the House of Representatives yesterday passed the Seed Loan bill for crop production during the year of 1933. The bill was passed by a vote of 274 to 91.

Representative Lindsay Warren who introduced the seed loan measure, said on the first day of the session took part in the debate and replied to Snell of New York and Stafford of Wisconsin. Mr. Warren said the bill was vital and absolutely necessary and its failure would mean disaster.

Big Appropriations Cut Recommended For N. C. By Budget Commission

Fayetteville, N. C., Jan. 17.—(AP)—Drastic cuts in State appropriations, including the proposed lowering of all State salaries to about two-thirds of the 1931 base, were recommended to the General Assembly by the Advisory Budget Commission last night.

All teachers would be cut along with other employees. Total reductions of about \$22,500,000 for the next biennium are suggested.

General fund appropriations would be set at \$48,242,795 for the 1933-1935 biennium as compared with actual estimated expenditures of \$55,621,748 for the current two-year period.

Highway fund expenditures suffered the sharpest cut. The recommendation sets the figure at \$33,500,000 for the next two years, including the \$10,000,000 for the 1933-1934 fiscal year.

Two persons die of poison. Mother and daughter succumb to undetermined illness in Georgia.

Atlanta, Ga., Jan. 17.—(AP)—Mrs. Virginia Frazier Pratt, prominent young Atlanta woman and her ten-year-old daughter, Virginia, were found dead today and her son, Nathaniel, 12, is in a hospital, seriously ill of what hospital authorities said was poison.

The body of the mother and her daughter were discovered by the nurse who resided in the home which is located in the Emory section midway between Atlanta and Decatur.

The son was taken to the hospital in an unconscious condition. Hospital authorities said they had not yet been able to determine the nature of the poison.

Mrs. Pratt was the daughter of the Rev. and Mrs. B. F. Fraser. Her father is a well-known member of the North Georgia Conference of the Methodist Episcopal Church and holds a pastorate in Atlanta.

Rocky Mount, N. C., Jan. 17.—Fillmore Saunders, 20, was in a critical condition here last night with a fractured skull sustained when a fast moving Atlantic Coast Line train struck the car he was driving at a street crossing here early Sunday.

Wilbur Herring and R. H. Mann, other occupants of the car at the time of the accident, were painfully bruised and cut, doctors stated, but their injuries are not considered serious and they were released after treatment.

Police said Saunders drove his car through the gate into the path of a northbound passenger train. The car was struck broadside and knocked from the track by the engine. All of the windows were shattered and the car nearly demolished.

None of the occupants was able to give a coherent account of the accident, police stated.

Well Known Grower Of Chicod Township Succumbs to Year's Illness

W. A. Stocks, well known Pitt county farmer, died at his home in Chicod township this morning at 7 o'clock following illness of one year.

Funeral services will be conducted from his late home tomorrow afternoon at 2 o'clock and burial will be made in the family burying ground near Littlefield. Rev. W. H. Laughlin will officiate.

Mr. Stocks was one of the best known growers of his community and spent all of his life in this section. He was a member of Pleasant Hill Free Will Baptist church and evinced much interest in the work of the denomination until illness prevented active service.

He is survived by his wife and ten children: Gladys, Wilbur, Leroy, Blanche, Dorothy, May, Athelene, Bernice, Mack, Mary, and William; his Mother, Mrs. Rebecca Stocks, of Greene county, and three brothers, O. C. Stocks of Greene county, and Elias and J. A. Stocks of Pitt county.

Man Arrested in Running Gunfight With Officers Near Cookeville

Cookeville, Tenn., Jan. 17.—(AP)—Two State highway patrolmen, one dressed as a woman, followed instructions contained in a letter demanding \$20,000 for a Cookeville banker under threat of death to his daughter and captured three men under fire last night.

Sheriff Alex Bruton said the letter was written to Stacy Wildth, an officer of the First National Bank of Cookeville, and directed Mrs. Wildth to an appointed place with the money in her automobile.

Sergeant Van Wodson, of the State highway patrol, dressed to impersonate a woman and with Wayne Harris and himself in the rear of the Wildth car and fifteen miles from here, the sheriff said they were signaled by a paged car.

They rushed the car and the occupants drove away. Sheriff Bruton continued firing as they went. Officers overtook the car after a chase of ten miles.

MRS. SNIPES GIVES BIRTH

Daughter Born to Woman Sentenced To Life Imprisonment in S. C.

Columbia, S. C., Jan. 17.—A daughter was born today to Mrs. Patricia Ferguson Snipes, whose death sentence for the slaying of a York officer was commuted to life imprisonment.

After commutation of the death sentence Mrs. Snipes, already the mother of a six-year-old son, was transferred from the penitentiary to State Hospital. The baby was born at 10:48 a. m.

Authorities said no inquest was necessary. His wife and two sons survive.

\$2,000 SUIT IN COURT HERE

Mrs. Thigpen Sues Insurance Company For Failure to Pay Policy

Superior Court was occupied today with a suit for \$2,000, brought by Mrs. Floye Thigpen against the Jefferson Standard Life Insurance Company for recovery on a policy carried by her husband, the late Lex Thigpen, at the time of his death several months ago.

The suit was the result of the failure of the company to settle the claim at the time of the death of Mr. Thigpen, it being claimed that the policy was allowed to lapse before the last two payments were made.

The defendants also contended that the insured was in good condition and capable of carrying on his business at the time the policy was allowed to lapse.

The plaintiff contends that her husband was mentally incapacitated by reason of a stroke of paralysis suffered two years before his death and that he did not have sufficient mind to keep up with his business and paid no attention to the two last premiums.

The case was begun yesterday morning and was expected to be completed sometime this afternoon. The introduction of evidence continued during the morning and argument was expected to get under way after the noon hour.

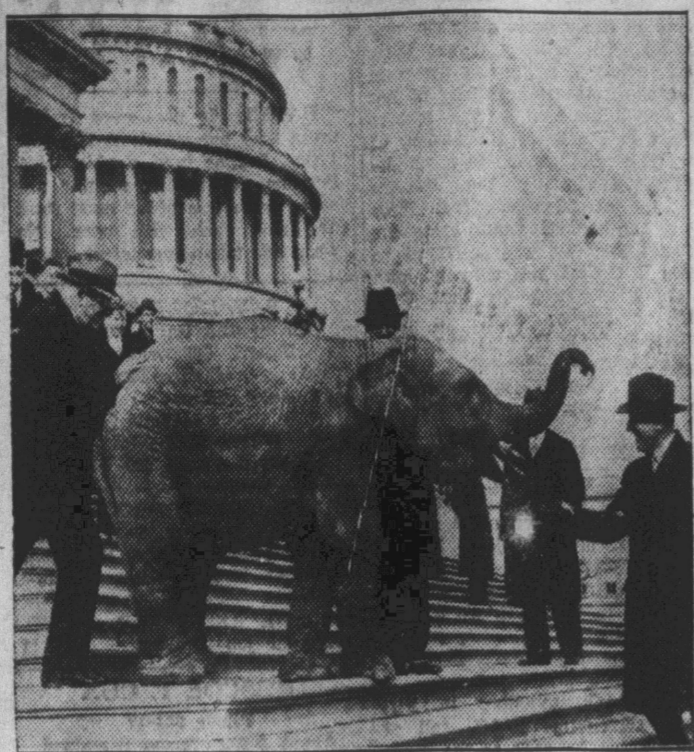
"Life" was the subject of the lesson-lesson in all churches and societies of Christ, Scientist, on Sunday, January 15.

He was the son of a rent-share farmer in Alabama, yet when he was just a boy his father predicted that he would be in Congress before he was forty. And he was.

He didn't finish his high school work until he was 33, yet at his present age of 44, he holds a master's degree from Stanford University.

That Stanford degree was for only one purpose—to equip him for Congress. He set out from Alabama for California in an old car with his wife and four children, \$100 in borrowed money and \$7,000 in debts.

They arrived at Palo Alto with three pennies in capital.

It's too early to predict the effect of the latest major ones, two Peruvian stamps printed backward, but there's certain to be a great deal of head-scratching as to how and why they were printed that way.

The first of these to come to light was the 1-sol value, showing a group of llamas, issued by Peru late in 1932. Now a used copy of the 10-centavo value of the same issue, also printed in reverse, has turned up.

It is uncertain whether the errors were intentional or otherwise (governments have been known to make a mistake in order to cash in on the collector's interest) or how many stamps were affected.

South American dealers are reported to be asking six times the face value, which is 15 cents, for the 1-sol variety in wholesale lots, which probably would mean a retail price of close to \$2 in New York. The comparatively small rise leads to the suspicion that a large number

House Kills Tax Bill Raleigh, N. C., Jan. 17.—(AP)—While the House today debated and killed the Powell-Planagan bill to abolish tax penalties in the State, the Senate held another short session and added one State-wide measure.

The Bowle measure came before the House on the minority report last night. The House Finance Committee had given the bill an unfavorable report by a margin of 62 to 47 to place the bill on the calendar.

Under the bill the penalty on 1932 taxes would have been abolished. The vote was 62 to 54 against the measure, Massey, of Rowan, changing his vote from aye to no in order to be able to move to reconsider.

The death-blow was dealt a few moments later when Representative Clincher moved that the Legislative Council be applied and the House supported him.

This prevented future consideration. The upper House approved the Long bill to allow a state board of health to restrict the sale for vital statistics and to simplify the system. The House approved a bill reducing salaries of all legislature employees who formerly got more than \$250 a day.

This afternoon the finance and appropriations committee were scheduled to begin work. They had before them the budget committee report and about two score finance raising measures.

Agrees With Hoover. New York, Jan. 17.—(AP)—A united front by President-elect Roosevelt and President Hoover on American policy in the Far East was indicated today by the Democratic leader.

Asked to comment on the report from Washington that he had reaffirmed the policy that this nation shall not recognize territorial gains Roosevelt said any statement relating to any foreign situation must come from the secretary of state of the United States.

"I am, however, wholly willing to make it clear that an American foreign policy must uphold the international treaty," he said.

"Sleepy Jim" never played with the Green Bay Packers or any other professional outfit after leaving Notre Dame. No doubt they would have liked to had him in the backfield but Crowley, under Rockne's guidance, hitched his career to a coaching staff that is still on the ascendant.

"Rock's" Prize Pupil He is only thirty years old now, but football men will tell you that Crowley is the closest approach to a Rocke, as a coach and as an individual figure, that has come out of Notre Dame within the last ten years. He was successful as an assistant to Harry Mehre at the University of Georgia before becoming head coach at Michigan State in 1929.

He combines a keen wit and personality that is a striking reminder of the man under whom he learned most of his football. The chief difference is that he is taller and has a big mop of hair. He got his nickname from a habit of taking a nap just before any crucial event. On the gridiron, however, Crowley was more slippery than sleepy. He was the "decoy" among the Four Horsemen and a good blocker. His hobby is golf.

Violets Do Fadeout The somewhat strange feature of the football situation in the Big Town is that New York University, which first seized the opportunity of the boom days to build up football prestige, now is the only one of four leading metropolitan colleges without a commanding figure as head coach.

In the blunt words of the chairman of athletics, N. Y. U., after letting Chick Mehan go to Manhattan a year ago, has been not only de-emphasizing the sport but "deodorizing it." Howard Cann, a graduate, is the football coach of the Violets.

Raleigh, Jan. 17.—N. C. State begins its drive for the Big Five basketball crown Wednesday night when the Terrors meet Carolina in the Tin Can at Chapel Hill following a freshman game between the two schools at 7 o'clock.

The State cagers have been busy this winter with out-of-state foes, and the game with Carolina will be first with a North Carolina team for the season.

Carolina has met and defeated Wake Forest and Davidson in Big Five competition this winter. In addition, the Heels have wins over Guilford and V. P. I.

Ray Semon's Red Terrors have defeated Atlantic Christian, Furman and V. P. I. and have lost to George Washington and Catholic University this season.

Friday night of this week the Terrors meet Duke University here in the Frank Thompson in another Big Five test.

BIG APPROPRIATIONS CUT RECOMMENDED FOR N. C. BY BUDGET COMMISSION (Continued from page one) This would be a total cut of about \$7,500,000 annually, but is a reduction in expenditures for highways proper of \$9,500,000 each year.

Agricultural fund appropriations were recommended to be \$491,290 as compared with expenses for this biennium of \$694,000.

Total appropriations from the three funds, not including receipts which departments and institutions are empowered to expend, are recommended to be about \$82,250,000 for the biennium as compared with expenditures of \$104,815,000 the current period.

General fund appropriations recommendations are based on reducing expenditures about \$3,000,000 annually, the report says. A cut of salaries and wages of at least 15 per cent below the present scale is contemplated.

The report points out this cut would place all employees, including teachers on a scale of approximately 32 per cent below the pay standards of July 1, 1931.

Charitable and correctional institutions did not share the cuts to the same extent as other divisions of the government.

Educational institutions suffered very severe reductions. No permanent improvements are recommended. The report stated that a general fund deficit of \$12,600,651 will likely exist June 30, 1933. Credit balances of the agricultural and highway funds will be \$3,127,000 with \$1,300,000 of the highway fund committed.

New York Cotton

New York, Jan. 17.—(AP)—Cotton futures opened steady, one point higher, and closed at 6.33 and 6.07, while July advanced to 6.33 and active months showed gains of two to six points.

Trading was quiet later in the morning. Prices sagged to 6.02 for March. Later the market steadied on trade buying and prices at midday were unchanged to five higher.
