JAPAN WILL NOT ALTER POLICIES IN MANCHURIA

Statement Of Roosevelt Fails To Deter Country From Sticking To Plans

CHINA JOYOUS AT APPROVAL HOOVER POLICY

League of Nations Plans Final Meeting To Discuss Situation; Committee Disappointed Over Efforts at Conciliation; Concern Manifested at Washington Over the Possibility That Jehol Fighting May Effect Foreign Interests

President-Elect Roosevelt's assurance that his administration will adhere to the principles of the sanctity of treaties will not alter Japan's six policies in Manchuria, a government spokesman said today.

China, however, received the Roosevelt message with a great satisfaction as approval of the Hoover policy in the Near East.

The military situation remained unchanged and both armies in the Jehol section and northern China apparently awaited better weather before renewing activity.

Japanese newspapers in Darin published the assertion that the city of Chankaiwan, captured by the Japanese two weeks ago, is already under the rule of Manchukuo as result of the movement sponsored by the Peace and Order League organized by residents of the city.

At Geneva the League of Nations Committee of Nineteen prepared for what may be its final meeting on the Japanese dispute, apparently discouraged at the lack of success for conciliating the two powers.

Some concern was manifested at Washington over the possibility that the fight in Jehol might extend south and involve large foreign interests.

China Will Dispute Air Control With New Ships

Hangchow, China, Jan. 18.—(AP)—Rapid strides are being made here in China's effort to build a military air corps as a guard against repetition of enemy attacks upon her towns and countryside.

Back of a high barbed wire fence, the China Aviation Institute, with the help of American civil fliers, is training pilots for the Nanking government. General Huan Pin-Heng, who learned to fly in the United States, is commander of the air force.

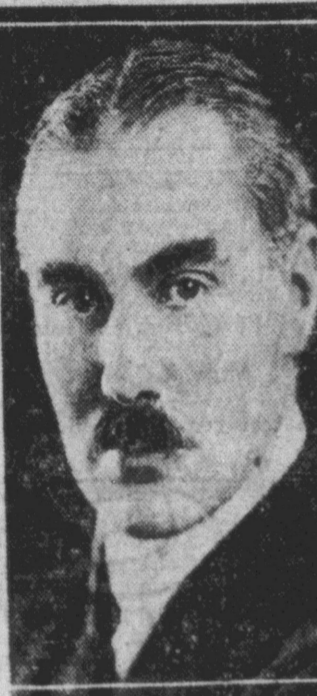
That the hoped for crops is to be used also for civilian purposes is included in the program of the school, but it is an open secret that the chief object is military.

HOLD MAN IN CHILD'S DEATH

James Davenport Bound Over to Superior Court at Hearing This Morning

Probable cause was found against James Davenport, of Beaufort County, charged with manslaughter and reckless driving, in connection with the running over and killing Robert Clayton, ten-year-old school child of the Grimesland district about two weeks ago, when he was given preliminary hearing before Magistrate C. B. Rowlett here this morning.

He was bound over to the next session of Superior Court under bond of \$2,500. Bond was provided and the young man was released.

The accident occurred near Chicod Creek bridge when the child left a school bus and started across the road. He was hit by the car driven by Davenport and died in a Washington hospital that night from a fractured skull. (Continued on page four)

BIG SPEAKERS FOR INSTITUTE

Interesting Personalities to Address Press Meeting at Chapel Hill

Chapel Hill, N. C., Jan. 18.—A number of interesting personalities are listed among the speakers scheduled to address North Carolina newspapermen at the Thursday and Friday sessions of the annual Newspaper Institute.

The speakers and their subjects offer a variety that should have some appeal to every newspaper man or woman in the State.

Dr. Albert S. Keister, professor of economics in the Woman's College of the University of North Carolina, who is to speak Thursday morning at 10 o'clock on "New Sources of Revenue for North Carolina," has been teaching economics for twenty-one years.

A native of Dayton, O., he was graduated from Otterbein College and did post-graduate work at Columbia and Chicago, winning his doctorate at Chicago. Before coming to the Woman's College of the University in 1914 he had taught at Cornell College and at the University of Chicago. He did special research work for the North Carolina State Tax Commission in 1928 and 1930. He is the author of a volume entitled "Our Financial System" (Macmillan) and of numerous articles.

WRIGHT TALKS TO STUDENTS

College President Stimulates Thought On Problems of Democracy

President Wright made a strong talk to stimulate the students at East Carolina Teachers' College to think about the problems that affect democracy in the form of government. He briefly reviewed the tendencies in government today from Washington to Greenville, throwing out the idea that there is danger of citizens shifting personal responsibility in the government upon the centers of government. There is danger when the people begin to talk of the government instead of our government, and many have begun to feel that it is all right if they can "get by."

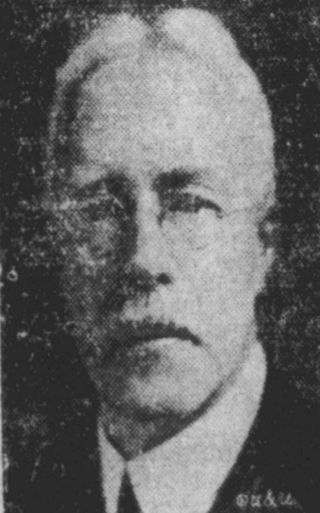
He said: "The founders of this government of ours endeavored to establish a government where all the people would be interested in their government and would feel that the government and the responsibility belonged to them. A Democracy is a government of the people and that government is intended to be of the greatest possible service to the people. Anything that is done that removes from the people authority in a government of the kind really eliminates the true spirit of a democracy in its technical sense."

In developing the material side he feels we have neglected the "spiritual values," and education, Dr. Wright believes, is one of the greatest of these spiritual values.

He implied that this problem we are facing would not be solved in a day, and the young people in the

BILLS SEEK CUT OFFICES

Twenty-One Measures in General Assembly Would Abolish Many Depts.

Raleigh, N. C., Jan. 18.—(AP)—Twenty-one bills to abolish some public office or function have been introduced in the 1933 Legislature thus far.

The proposed abolishes ranged from tax on liquor laws to the office of the president of the North Carolina Railroad. One of the bills that would abolish tax penalties had been killed.

Among those pending are bills to abolish the Department of Conservation and Development, the Corporation Commission, the Industrial Commission, Local Government Commission, Ship and Water Commission, Department of Personnel, Historical Commission, office of State Game Warden, Department of Budgets and Contracts, all juvenile courts and one hundred offices of County Superintendents of Education.

THIRTY DOGS KILLED HERE

Police Slay Canines Following Appearance of Mad Dog Yesterday

Thirty-odd dogs have been killed in Greenville since the reported biting of four persons by a mad dog here yesterday about the noon hour, George Clark, chief of police, stated today.

Although the rabid animal was slain, he was believed to have bitten several other dogs, and realizing the seriousness of the situation, the police head warned that all dogs caught on the streets would be killed.

It was the second time within a month that a mad dog raging down principal business and residential streets had terrorized the community.

The appearance of the first rabid animal during the middle of December resulted in the biting of the five-year-old son of Mr. and Mrs. C. H. Jarnhill, who died early Monday morning as result of hydrophobia.

Although the child was administered the full dosage of anti-rabies treatment, he was unable to withstand the inroads of the disease.

A negro youth was reported bitten at the same time, but responded to the anti-rabies treatment and was reported to be getting along all right at this time.

Two white persons and two negroes were bitten as the maddened animal ran down the street yesterday foaming at the mouth and snapping at everything he came in contact with.

W. H. Norris, Dickinson Avenue druggist, and member of the Board of Aldermen, had a narrow escape from injury when the dog attacked him. His trousers were torn, but the dog's teeth did not penetrate the flesh.

The Wake Senator was author in 1931 of a bill to tax nine essentials which missed only a vote on its last Senate reading of becoming law.

The measure would tax tobacco, soft drinks, theater admissions, playing cards and a score of other things. The rate was 20 per cent.

Hindsale said the proposal this year would be practically the same as that of the previous session.

Judge Henry A. Grady, of Clinton, who is conducting a two-week term of Superior Court in this city, will stress the civil form of government in his charge to the new six months' grand jury next Monday morning, it was made known today.

Judge Grady will speak on the subject, "The Meaning of the Civil Form of Government," and has asked that all officers of the county be present to hear what he has to say.

The judge's charge to the grand jury is always the highlight of a criminal court session, and especially in view of the fact that juries are chosen now only every six months, and a tremendous crowd was expected to present.

Preceding the address, a new six months' grand jury will be chosen. Following the address, court will begin delving into the one-week criminal docket, consisting of two murder cases and a charge of criminal assault. Many other minor charges are to be considered, principally among them being numerous violations of the prohibition law.

Court this week is confining its attention to consideration of civil cases.

**House Kills Tax Bill**  
Raleigh, N. C., Jan. 17.—(AP)—While the House today debated and killed the Powell-Flanagan bill to slash tax penalties in the State, the Senate held another short session and added one State-wide measure.

The Bowie measure came before the House on the minority report last night. The House Finance Committee had given the bill an unfavorable report by a margin of 62 to 47 to place the bill on the calendar.

Under the bill the penalty on 1932 taxes would have been abolished.

The vote was 62 to 54 against the measure, Massey, of Rowan, changing his vote from aye to no in order to be able to move to reconsider.

The death-blow was dealt a few moments later when Representative Turner moved that the Legislature clinch be applied and the House supported him.

This prevented future consideration.

The upper House approved the Long bill to allow a state board of health to restrict the sale of vital statistics and to simplify the system.

The House approved a bill reducing salaries of all legislative employees who formerly got more than \$250 a day. This afternoon the finance and appropriations committee were scheduled to begin work. They had before them the budget committee report and a two score finance raising measures.

**Agrees With Hoover.**  
New York, Jan. 17.—(AP)—A united front by President-elect Roosevelt and President Hoover on American policy in the Far East was indicated today by the Democratic leader.

Asked to comment on the report from Washington that he had reaffirmed the policy that this nation shall not recognize territorial gains Roosevelt said any statement relating to any foreign situation must come from the secretary of state of the United States.

"I am, however, wholly willing to make it clear that an American foreign policy must uphold the international treaty," he said.

JAPAN WILL NOT ALTER POLICIES IN MANCHURIA

Statement Of Roosevelt Fails To Deter Country From Sticking To Plans

CHINA JOYOUS AT APPROVAL OF HOOVER POLICY

League of Nations Plans Final Meeting To Discuss Situation; Committee Disappointed Over Efforts at Conciliation; Concern Manifested at Washington Over the Possibility That Jehol Fighting May Effect Foreign Interests

President-Elect Roosevelt's assurance that his administration will adhere to the principles of the sanctity of treaties will not alter Japan's six policies in Manchuria, a government spokesman said today.

China, however, received the Roosevelt message with a great satisfaction as approval of the Hoover policy in the Near East.

The military situation remained unchanged and both armies in the Jehol section and northern China apparently awaited better weather before renewing activity.

Japanese newspapers in Darin published the assertion that the city of Chankaiwan, captured by the Japanese two weeks ago, is already under the rule of Manchukuo as a result of the movement sponsored by the Peace and Order League organized by residents of the city.

At Geneva the League of Nations Committee of Nineteen prepared for what may be its final meeting on the Japanese dispute, apparently discouraged at the lack of success for conciliating the two powers.

Some concern was manifested at Washington over the possibility that the fight in Jehol might extend south and involve large foreign interests.

Paris, Jan. 18.—(AP)—Maurice Chevalier and his wife were granted a divorce today on reciprocal grounds.

China Will Dispute Air Control With New Ships

Hangchow, China, Jan. 18.—(AP)—Rapid strides are being made here in China's effort to build a military air corps as a guard against repetition of enemy attacks upon her towns and countryside.

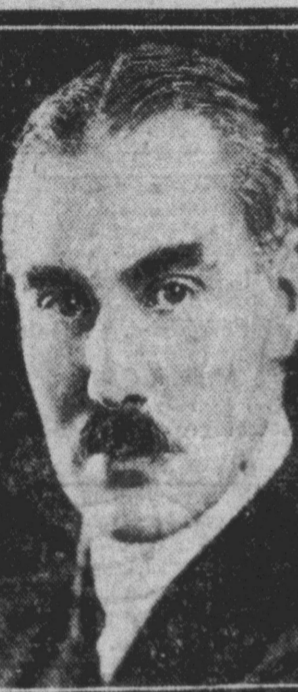
Back of a high barbed wire fence, the China Aviation Institute, with the help of American civil fliers, is training pilots for the Nanking government. General Huan Pin-Heng, who learned to fly in the United States, is commander of the air force.

That the hoped for crops is to be used also for civilian purposes is included in the program of the school, but it is an open secret that the chief object is military.

T. V. Soong, Minister of Finance and brother-in-law of Chiang Kai-Shek, executive head of the Nanking regime, is credited with having caused the school to be established. It was in his privately owned plane that Christy Mathewson, Jr., one of the American instructors here, had a tragic crash at Changhai.

It is said that as Dr. Soong watched Japanese fliers swarm over Shanghai last February, dealing death and destruction to the Chinese defenders of Chapel, he decided China was to have an air corps.

Interesting Personalities to Address Press Meeting at Chapel Hill

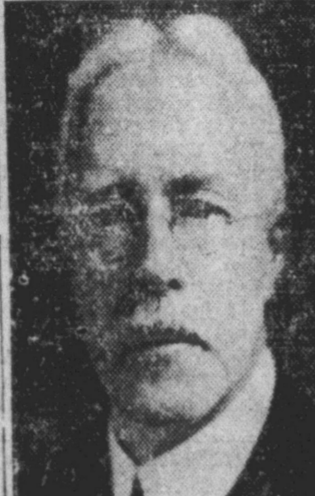

WRIGHT TALKS TO STUDENTS

College President Stimulates Thought On Problems of Democracy

President Wright made a strong talk to stimulate the students at East Carolina Teachers' College to think about the problems that affect democracy in the form of government. He briefly reviewed the tendencies in government today from Washington to Greenville, throwing out the idea that there is danger of citizens shifting personal responsibility in the government upon the centers of government. There is danger when the people begin to talk of the government instead of our government, and many have begun to feel that it is all right if they can "get by."

He said: "The founders of this government of ours endeavored to establish a government where all the people would be interested in their government and would feel that the government and the responsibility belonged to them. A Democracy is a government of the people and that government is intended to be of the greatest possible service to the people. Anything that is done that removes from the people authority in a government of the kind really eliminates the true spirit of a democracy in its technical sense."

In developing the material side he feels we have neglected the "spiritual values," and education, Dr. Wright believes, is one of the greatest of these spiritual values.

THIRTY DOGS KILLED HERE

Police Slay Canines Following Appearance of Mad Dog Yesterday

Thirty-odd dogs have been killed in Greenville since the reported biting of four persons by a mad dog here yesterday after the noon hour, George Clark, chief of police, stated today.

Although the rabid animal was slain, he was believed to have bitten several other dogs, and realizing the seriousness of the situation, the police head warned that all dogs caught on the streets would be killed.

It was the second time within a month that a mad dog raging down principal business and residential streets had terrorized the community.

The appearance of the first rabid animal during the middle of December resulted in the biting of the five-year-old son of Mr. and Mrs. C. H. Barnhill, who died early Monday morning as result of hydrophobia. Although the child was administered the full dosage of anti-rabies treatment, he was unable to withstand the inroads of the disease.

A negro youth was reported bitten at the same time, but responded to the anti-rabies treatment and was reported to be getting along all right at this time.

Two white persons and two negroes were bitten as the maddened animal ran down the street's yesterday foaming at the mouth and snapping at everything he came in contact with.

W. H. Norris, Dickinson Avenue druggist, and member of the Board of Aldermen, had a narrow escape from injury when the dog attacked him. His trousers were torn, but the dog's teeth did not penetrate the flesh.

Following the address, court will begin delving into the one-week criminal docket, consisting of two murder cases and a charge of criminal assault. Many other minor charges are to be considered, principal among them being numerous violations of the prohibition law.

Court this week is confining its attention to consideration of civil cases.

WAKE SENATOR BACK ON JOB AFTER ILLNESS

Measure to be Presented to The Upper House Tomorrow; Similar to Bill Which Nearly Passed in 1931; Tobacco, Soft Drinks and Many Other Things Will be Taxed

Raleigh, N. C., Jan. 18.—(AP)—Senator John Hindsale of Wake County, who has been ill with influenza for nearly two weeks, returned to his seat in the upper House of the General Assembly today and said he would introduce a luxury tax tomorrow.

The Wake Senator was author in 1931 of a bill to tax nine essentials which missed only a vote on its last Senate reading of becoming law. The measure would tax tobacco, soft drinks, theater admissions, playing cards and a score of other things. The rate was 20 per cent.

Hindsale said the proposal this year would be practically the same as that of the previous session.

A SEAT in the CABINET?



GEORGE H. DERN Editor's Note: This is the ninth of a series of articles briefly picturing men and women mentioned for posts in the Roosevelt cabinet.

High among those names chalked down by political speculators for the next secretary of the interior is that of Gov. George H. Dern of Utah.

He went to the Democratic national convention last June with the support of several western states for the vice presidential nomination but withdrew his name after the Roosevelt-Garner coalition had been effected and second Garner's nomination for the vice presidency on behalf of Utah.

Championship of state title to natural resources including water and mineral deposits, as against federal control, has marked his administration.

Governor Dern has been an ardent advocate of the policy of federal reclamation. In private life his training was in the mining industry. He was at one time general manager of the state's largest gold mine and with others perfected processes for refining ores now in general use.

Interesting also was the speaker's mention of the sculptor who used color in eyes and lips after the Italian fashion; of Charles Niehaus' "movement in stone" in "The Driller," a piece of work which made one cringe; say that all public monuments should be of this type; and of Solon H. Borglum, the westerner whose animal figures are truly original.

This paper takes its place in the series of the year on the development in the various arts in America in the last half century.

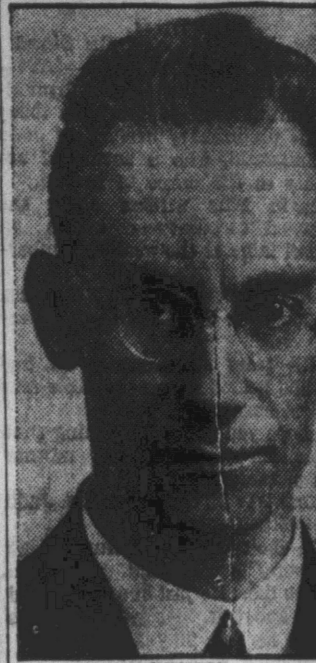

SEEK BETTER TERMS ON BUNCOMBE'S DEBT

amounts of well rotted organic matter from non-leguminous plants and at the same time promote the growth of the highest quality tobacco.

So handle the crop and soil that the crop will not be reduced in yield and quality from nutritional troubles.

Practice only the best cultural methods.

Space the crop in the field to best fit the soil and fertilizer treatment.

Harvest, cure, and handle the crop in marketing to get the most out of it.

Carefully field select and save seed for planting purposes from year to year.

Put in and handle the plant-beds so as to get strong healthy plants for transplanting.

Each grower should keep down his acreage of tobacco to what can be handled properly.

Select good soils, well protected, with a southeast exposure, for growing plants.

Fertilize the seed-bed liberally. Scatter uniformly over it 30 pounds of wheat, rye or oat straw as soon as the bed is planted to 100 square yards and then cover with the best grade of canvas with 25x25 strands to the inch.

Seed one ounce of good reliable seed to 300 square yards of bed.

Care should be taken not to carry trash tobacco to the seed-bed in transplanting to the field.

Space and top so as to encourage maximum yield of cigarette types.

Grade according to Government grades before offering on markets.

Grow enough food and feed crops for use of all people and livestock on the farm.

Require tenants to plant a garden and produce pork, poultry, potatoes, peas, etc., in sufficient quantities for home use.

BANK OF STOKES MAY SEEK FEDERAL LOAN

Winston-Salem, Jan. 18.—(AP)—Efforts to purchase collateral notes and mortgages held by Stokes County in connection with the closed Bank of Stokes today revealed that negotiations are under way looking toward filing an application for a loan for the bank from Reconstruction Finance Corporation.

Charles Davis, a cashier of the bank which had its home office at Walnut Cove and branches at Danbury, King and Germantown, and which closed November 18, 1930, and L. L. Aycock, of Fremont, liquidating agent, suggested to the Stokes commissioners that collateral held by the county be surrendered on a basis of 20 cents for each dollar on deposit when the bank closed.

The commissioners refused to do this. When the bank closed the county had on deposit \$178,161.65, and was due \$9,195.55 on accrued interest.

Collateral, put up by the bank to guarantee deposits, totaled \$225,223.48.

Representatives of the bank are making abstracts and other records required by the Finance Corporation with a view of filing application for a loan.

Cost of veterans aid—\$28,000,000. Of course there may be inequities and abuses in this matter. If so, they should be corrected. Yet how can cutting the veterans improve business? In most cases reducing federal aid to veterans would result in increasing local aid to their families.'

"Taking a part or portion of this statement, yet how can cutting the veterans improve business?—how similar is our state under date of December 16, 1932 in Charlotte: 'A cut of 20 per cent of federal expenditures now paid to veterans of all wars will not, in our humble opinion, bring back employment, but will lessen same. Only through restoring the purchasing power of the twelve million of our unemployed and their families, will farm and commodity prices increase and bring back to this country better times.'

"And Babson's statement, 'In most cases reducing federal aid to veterans would result in increasing local aid to their families'—how similar to our statement that this would add additional burdens to the over-taxed taxpayers of our state cities and counties by casting thousands of our disabled comrades back upon their respective communities.

"The American Legion, department of North Carolina, is backing to the limit the entire national legislative program of the American Legion."

# Stock Market

New York, Jan. 18.—(AP)—The stock market took on a rather pale complexion today as business statistics failed to provide optimism. Price changes were narrow, and in the main the undertone was steady.

Prices weakened in such lines as Steel and Cude Oil and the uncertainty of the forthcoming dividend action seemed to turn a damper on the market enthusiasm.

Woolworth joined the recent say in chain store issues with a loss of about two points.

National Biscuit declined well over a point.

American Telephone and Santa Fe lost about a point and issues losing fractionally included United Aircraft, Standard of New Jersey, Sears-Roebuck and Montgomery Ward.

The Can, Tobacco and Chemical stock was steady to firm and Corn products rose a major fraction.

Such issues as Steel, General Motors, Dupont and Allied Chemical were unchanged. Stocks veered off in the late trading and Nomours losses of fractions to a decline of more than two points were recorded. Transfers were 700,000 shares.

The Senate approved the pay cut bill already passed by the House which reduced all legislative employees \$1 a day except those previously getting less than a day.

Under suspension of the rules the House adopted a joint resolution asking Congress to regulate the value of money and fix commodity prices but the Senate did not consider the proposal.

It was introduced by Cameron and Moore and Davis of Hyde.

The Senate passed a bill by Mar. shall of Cabarrus prohibiting officers of the law from getting witness fees. He said it would save counties from \$100,000 to \$200,000 annually. For the second time, in spite of opposition of five prominent women the House judiciary committee approved two bills to make it easier to be married in the state.

The joint finance committee this afternoon was to consider the budget commission proposal to divert \$2,000,000 from the highway to the general fund.

Senator Burgin of Davison sent in a bill to make the members of the Board of Conservation also serve as the state park commissioners and Senator Sumners of Onslow offering a bill to relieve delinquent taxpayers by low interest rates on tax sales.

Rep. Masenburg of Polk proposed to restrict the state so as, to give Mecklenburg, Buncombe and Guilford an extra member of the lower house with New Hanover and Rockingham losing one.

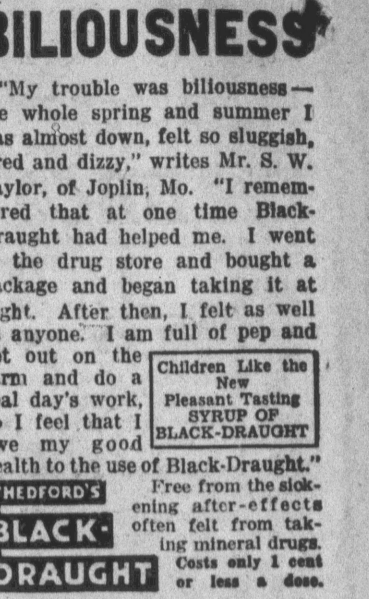
