JURIST SAYS NATION PLUNDERED BY FAVORED FEW

Small Champions Cause Of Farmer Address At The Courthouse Here

SEES HELP IN FARM MEASURE IN CONGRESS

Believes Farm Legislation Recently Passed by House if Enacted Into Law Would Improve Present Situation; Farms Must be Given Same Protection of Manufacturer to Forge Back on High Ground

John H. Small, prominent Washington City attorney, and former Representative of the U. S. Congress, championed the cause of the farmer in a speech delivered at the courthouse today at the noon recess of the Superior Court.

Discussing the farm relief legislation recently passed by the Federal House of Representatives, the speaker expressed the hope that it would be enacted into law and serve to increase the market price for principal farm products.

He spoke on the subject, "Some Important Economic Issues," and was heard by a crowd that nearly filled the courtroom. P. C. Harding, Greenville attorney, introduced the speaker, paying tribute to his service to the people while a member of Congress and since his retirement.

Mr. Small prefaced his remarks with the statement that he had no political campaign to support, and came here purely for the opportunity to meet old acquaintances and talk to people he is intensely interested in.

He said, in part: "We are living today in a different world from that of 1915. The World War had its inception in 1914 and the United States entered into conflict in 1917. Since the Armistice many established governments in the world have been changed either by revolution or peaceful methods. The autocracy of Germany has been the Soviet Republic. The great military power of Germany has been crushed and Emperor Wilhelm deposed and they have set up their republic.

"Spain, one of the oldest monarchies in the world, has exiled its king and is attempting to govern themselves. Great Britain, for more than a hundred years the mistress of the seas, and dominant financial power, has lost much of her foreign trade, has abandoned the gold standard, and the English pound is at the lowest price in history. The people of England are making a desperate struggle to maintain their autonomy. In this continent substantially every central and South American republic is suffering from revolution and are engaged in civil war. Fortunately, Mexico seems to be an exception.

"Poverty rules the entire world. It is difficult to find any people whose industry and finances have not been seriously crippled. Their buying power has been reduced to a minimum. International trade is confined to a few essential products, and as a result the shipping of the world is struggling to keep afloat. The prices of all commodities have so greatly declined that in many instances they are selling below cost of production.

"This depression differs from those of the past because today hard times prevail all over the world. People of no country have escaped."

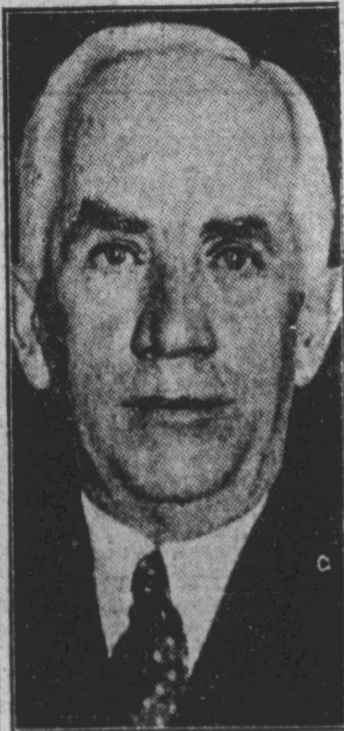
A little later Mr. Small discussed the present plight of agriculture, and particularly as it affected Eastern Carolina.

"The prices of our two principal market crops, cotton and tobacco, have yielded no profit for the last two years and many farmers have not sold their crop for enough to pay the cost of production," he stated.

"This created an unhappy condition for the farmer who was in debt as it has for all other fellows and much property has been sacrificed under mortgage. Several causes have contributed to curtail the market the market prices of cotton and tobacco, but one of the main factors has been the destruction of our for-

JUDGE MOORE PASSES AWAY

Superior Court Jurist Dies at Asheville After Week's Serious Illness

Asheville, N. C., Jan. 23.—(AP)—Judge Walter Moore, of the North Carolina Superior Court, died in his apartment here today. He had been seriously ill for a week.

Judge Moore, who made his home at Silver, conducted court here until a week ago when illness forced him from the bench. His health had been poor for several months.

Tentative funeral plans called for funeral services at Silver tomorrow afternoon.

Judge Moore was well known throughout the State. He served as Speaker of the House of Representatives of the North Carolina General Assembly thirty years ago.

STATE MOURNS MISS KELLEY

Prominent Woman Educator Dies After 52 Years in Public School Service

Franklin, N. C., Jan. 23.—(AP)—Friends of North Carolina public education of the State today joined with the citizenship of Franklin in mourning the death of Miss Elizabeth Kelley, Miss Kelly, who had devoted the most of her fifty-two years to public school work, died at her home here last night after an illness of several months.

DR. JOE DIXON PASSES AWAY; BURIAL TODAY

Prominent Physician Succumbs to Illness in Richmond Sanatorium

Dr. Joseph Dixon, 68, prominent Greenville physician, and a director of the North Carolina Joint Stock Land Bank died at the Tucker Sanatorium in Richmond, Va. Saturday night following declining health extending over a period of several years.

Entering the sanatorium on January 16 for treatment, his condition became critical last Friday morning and little hope was entertained for his recovery. Two of his sons, Jake and Ben, were at his bedside at the time of death.

Funeral services were conducted from his late home this afternoon at 2 o'clock by Rev. W. H. Brunson, pastor of the Ayden Christian Church, assisted by Rev. W. A. Ryan, pastor of the Eighth Street Christian Church of this city. Burial followed in the family burying ground at Ayden.

ORDERS WAR AGAINST GANG

Wilmington, N. C., Jan. 23.—(AP)—Saying an organized gang was operating in Wilmington, Judge N. A. Sinclair, today told county officials "You have got to make war against them."

He referred to numerous robberies reported and said: "You are getting them, but not all of them. This old town's Superior Court has been right wise with perjury. But the juries were good and not even perjury could fool them."

HOME LOAN BANK OFF TO A BAD START

Washington, Jan. 23.—The Federal Home Loan Bank of Winston-Salem seems to have gotten off on the wrong foot, but officials here hope to have it functioning well in the near future.

Thomas W. Ellett is temporarily in charge at Winston-Salem. A successor at Hugh H. Gordon, the executive vice-president who resigned, will be named soon there is no indication here as to who it will be. A report that Oscar K. Laroque, who came here from Raleigh, and was later sent to Winston-Salem, and from there resigned, would succeed Gordon was soon-poised at headquarters here.

Frank A. Case, of Miami, Fla., one of the directors named at the outset, has had a difference with Chairman Fort and a successor to him will be appointed.

The directors of these banks do not receive salaries. Two men sent from here to Winston-Salem to look into the trouble there, then Mr. Laroque and Mr. Gordon resigned. This was followed by confusion, but Chairman Fort expects to have the situation cleared up.

TO ABANDON N.C. RAILROAD

Interstate Commerce Commission Authorizes Abandonment of Seaboard Line

Washington, D. C., Jan. 23.—(AP)—The Seaboard Air Line Railroad today was authorized by the Interstate Commerce Commission to abandon the Raleigh-Charleston Railroad from Lumberton to Lake View, S. C., a distance of twenty-three miles.

The Raleigh and Charleston line had been operated at a loss on July 31, 1932, owed the Seaboard \$487,000. The abandonment does not affect a portion of the road which runs through Proctorville, N. C., and Smithboro to the south of Marion, S. C.

Hearing on the petition was held by the North Carolina Interstate Commerce Commission which did not make any representation. Protests were filed by merchants and citizens of Barnesville and Marietta.

Sheriff Scull Dies at Ahoskie

Ahoskie, Jan. 23.—(AP)—Funeral services will be held tomorrow for Sheriff Bismark Scull, 61, who died at his home here after lingering illness of several years.

Scull was just beginning his sixth term as sheriff, and last year was elected head of the State Sheriff's Association.

Late News Flashes

Senate Pushes Banking Bill. Washington, Jan. 23.—(AP)—With the House driving through a flurry of minor legislation the Senate pressed ahead today with the Glass banking bill.

Signs of the filibuster were dwindling. Three controversial phases of the measure were in line for vote but Senator Thomas of Oklahoma, failed to gain in the support of his filibuster associate, Long, and there was some hope the bill might move to a vote in the near future.

The Blaine-Collier bill went to the House with approval of its judiciary committee barring amendments to prohibit advertisement in dry states and to prohibit sale to children. The committee vote for approval was 8 to 6. Resolutions approved by Senate finance committee calling for studies of the measure. Democrats hope

Police Break up Effort to Enter Home Grocery Store Last Night

The robber, believed to have been white, observed the police car patrolling the street in close vicinity to the store and beat a hasty retreat in spite of the fact that he had already broken open the front door.

Police believe the man was picked up by a car stationed close by as an extensive search failed to reveal his whereabouts or the direction in which he went.

DYNAMITE BLAST KILLS BRIDGE WORKER

Albemarle, Jan. 23.—Charlie A. Wells, 50 year old resident of Misenheimer, died at Yadkin hospital last night from injuries received Friday afternoon at Stokes Ferry Bridge. Wells was engaged in digging a foundation for a pier for the new bridge when a dynamite blast loosened a rock overhanging the pier falling upon him and crushing his hip, pelvis bone and left leg.

In addition to his wife, Wells is survived by ten children, the oldest about 18 years of age. His mother and several brothers and sisters also survive.

SAMPSON FARMER IS KILLED BY NEGRO

Clinton, Jan. 23.—Walter Lee, well known Sampson county farmer, was shot and instantly killed by Richard Allen, negro, at the home of Allen in Mingo township about 1:30 Saturday night.

Allen went to the home of Frank Blackman, justice of the peace, immediately after the shooting and surrendered. He is now in the county jail here and will be given a preliminary hearing next Tuesday. Allen states that he was awakened by his dog barking. That he took his gun and went to the back door, opened it and fired the gun without looking out. When the gun fired he heard something fall and went out to investigate. The body of the victim was about five feet from the door steps with the back of the head blown away. Lee was about 25 years old and is survived by his widow and two children. Allen also is about 25 and married. Both lived in the same community.

Cotton Ginning Moving Rapidly

Washington, D. C., Jan. 23.—(AP)—Cotton of the 1932 crop ginned prior to January 16 was reported by the Census Bureau today to have totaled 12,418,310 running bales, including 66,003 round bales counted as half bales and 7,420 bales of American-Egyptian Ginning to January 15 a year ago totaled 16,996,382 bales, including 539,483 round bales and 10,868 bales of American-Egyptian.

Prior to January 16 North Carolina reported ginning 668,157 bales.

SAYS PEOPLE OF COUNTRY ARE ASLEEP

Opening Criminal Court Here Today Judge Grady Asserts People Are Letting Millionaires Run the Nation Because they Don't Care Anything About Government; Address Opens Program Launched by Institute of Government

"Very few people care anything about government, so long as it lets them alone, and that is why millionaires and international bankers have taken charge of the federal government," declared Judge Henry A. Grady of Clinton speaking at the opening of the criminal term of Superior court here today.

"The people have gone to sleep and let their government be taken over and plundered by the favored few," the distinguished jurist asserted as he drove home a message dealing with "The Civil Form of Government."

The address was a feature of the opening of court and a program put on under the direction of the local unit of the North Carolina Institute of Government. At the request of Judge Grady, scores of public officers from all sections of the county attended, as did members of the faculty and student body of the Greenville high school.

Prior to the address which also took the place of the regular charge to the jury, the regular six months grand jury was drawn. It is composed of the following men representing virtually all parts of the county:

B. B. Sugg, foreman; F. L. Little, J. L. Kilgus, B. F. Manning, Henry McLawhorn, J. F. Young, Lacey Bundy, W. O. Manning, W. R. Holland, Garland Manning, B. M. Lewis, J. H. Bundy, H. L. Hodges, Charles James, E. D. Manning, W. C. House, J. O. Williams, T. F. Hart, P. C. Harding, member of the local bar, presided over the Institute of Government program, and at the conclusion of Judge Grady's charge introduced Dr. R. H. Wright, president of East Carolina Teachers College, M. K. Blount, former state senator, and J. B. James, member of the local bar, who made brief talks dealing with the importance of more fully informing the public of the laws of the country.

After discussing the Constitution, Judge Grady declared that "government is nothing but the Co-ordination at work."

"We see it," he said, "going on about us every day. In recent years it has become very burdensome to a great many people. The Constitution is more or less permanent. Government changes from time to time, and it is easier to change the government than to change the Constitution. When government becomes so burdensome that the people are unable to live under it, they have a right to change it; they have a right to change the Constitution. Government can be changed every two or every four years by ballot. The Constitution can be changed also in the same manner, or it may be done by revolution, which is a costly process. The ballot box is the cheapest and saner method provided the people know what they want. If they do not know, then neither method is worth while. Any change executed in ignorance is worse than no change at all. Until amended or abolished the Constitution is the supreme law of the land."

"Some of you gentlemen have been elected to positions of trust and honor; you have taken an oath that you will be faithful and bear true allegiance to the State of North Carolina, and to the constitutional powers and authorities which are or may be established for the government."

ABOUT TOWN

The effort of President-elect Roosevelt to restore trade with foreign countries will be made at the conference to be held with representatives of Great Britain.

This news will be received with interest by business men in all sections of the country who realized all along that the Republican policy of high tariff was gradually isolating us from other countries.

By obtaining a debt moratorium for Great Britain during the depression it is said Mr. Roosevelt hopes to obtain in exchange a reciprocal trade agreement and attention to tariff.

This is something the government leaders have neglected in recent years and it is almost assured that anything which Roosevelt attempts to do in this direction will meet with pronounced success. Other nations think along the same lines as America in this connection and it is likely the Roosevelt plans will go through without the slightest hitch, save those thrown in his way by opposition at home.

The legislation is taking its time about consideration of the plans for reorganization of government but it is certain something of the kind will result from the bill to be considered this week.

The plans are the most extensive in history of the state and probably will bring about a big reduction in expenses as well as overlapping of effort.

Any economies along this line will be received with interest by the public—that great mass of people who have borne the burden of taxation for so long, and if the load can be lifted, here's hoping something will be done.

The principal object of the movement, however, is to balance the budget and get the state financial back into the high waters of financial ease. It is a big job and one that is taxing the best brains of the country, but eventually it will be solved and then it will not be so long before the people will feel some relief at least.

Growers who obtain government crop loans this year will be required to first convince the government that they will cut down on their money crops.

This means Uncle Sam realizes the necessity of curtailed production of tobacco, cotton and other farm products and will not lend money to those proposing to plant annual acreage.

Barriers should give the matter serious consideration. It is one of the most important questions that has confronted the country in years.

Although effort has been under way for some time to convince growers that reduction of crops is necessary for the recovery of the industry.

It is hoped that the government has positively declined to grant loans with production agreements if it is possible that something will be accomplished. Many growers depend largely on the amount of money they are able to borrow from the government every year, and if this should be cut off through obduracy to accept the condition upon which loans are made they will find shedding the burden they have ever seen.

The salvation of agriculture lies not in planting more money crops but in a determination to reduce until the country is able to eliminate some of the surplus which has been increasing so swiftly the last several years.

One of the annual trade days usually held in Greenville each year will be inaugurated sometime in the near future, according to plans now under way.

This will afford the public an excellent opportunity to buy goods at greatly reduced prices. People from a distance will not only be able to obtain the best goods on the market but should save enough to defray cost of transportation and more in some cases.

A SEAT in the CABINET

Daniel J. Tobin, who as a strong,

laughing young Irishman, began his career as a teamster in Boston, now is among those whom political speculators are talking about as a possible secretary of labor in the Roosevelt cabinet.

Tobin rose rapidly in labor circles. In 1907 he was elected president of the International Brotherhood of Teamsters, Chauffeurs, Stablemen and Helpers.

Almost immediately he went to Chicago to find out why there had been strikes there in his organization. He was credited with devising a method for the laborers and employers to work together, and the strikes ceased. He has continued in the role of arbitrator.

For 11 years he was treasurer of the American Federation of Labor, resigning in 1928.

His office is at Indianapolis. He has the unanimous endorsement of the executive board of the American Federation of Labor for the cabinet post.

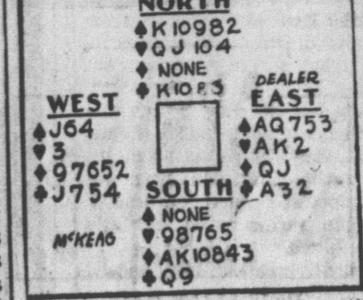

Hints on Contract Bridge Up-to-Date

NINE-HIGH STRAIGHT FLUSH. By Tom O'Neil. An overall of the opponents' suit after a penalty double by partner figured in a deal of freak distribution which Walter H. McKeag of the Marine and Field Club of Brooklyn recalls with pleasure. He made four hearts doubled on a five card suit headed by the nine spot after some hectic bidding. Here was the hand:



East offered a spade and south two diamonds. West made a nice hopeful pass, fearing to double the diamonds lest there be a jump somewhere. North passed and east with a wealth of high card tricks, repaid his spades. A better thing to have done would have been to double. Then west could have made a strength pass and McKeag might have been in trouble.

South and west passed the two-spade bid and north doubled. East passed. South disliked the idea of east playing two spades doubled, and so he bid three spades, showing no losses in spade and trying to force north to name his best suit. West passed and north bid three no trump, which east doubled. South with his void and doubleton could not stand for the no trump contract, which could easily have been set. In view of north's inferential denial of diamonds and his no trump offer, it seemed to south that north must have heart support.

Those New Rules. A tragedy of the new rules: A and B, vulnerable, were out on a limb. When A was doubled at two no trump, B went to three spades. C doubled that. Then B went to three no trump, which C also doubled. B thought and though so long that C got the idea that the auction was over. She led a diamond. B gleefully said that he had not passed or bid after the double, demanded a new deal and got it, thereby escaping a penalty of 2,000 or more.

England's Royalty Studies Problems Of Idle Workers

LONDON, Jan. 22.—(AP)—Unemployment kept the royal family busy in 1932 and promises to repeat in 1933. Led by the Prince of Wales, one of whose first speeches of the year was an appeal for social service, the family showed high interest in the welfare of idle workers. The Prince made four tours of study conditions of the unemployed and plans are being made for more surveys this year.

Town Hall Radio Connect Filipinos To Island Capital

Manila, Jan. 22.—(AP)—Governor General Roosevelt's radio plan to reach isolated villages among the 7,000 islands of the Philippines was launched when the legislature appropriated money for the purchase of receiving sets by small municipalities.

The measure provided that part of the receipts from the \$5 a year license fee imposed on the 60,000 owners of radio sets should be used to install public receiving sets and to pay government time on a private broadcasting station here. The receiving apparatus will be purchased for not more than one thousand town halls over a period of years. The bill says that the broadcasts must give weather reports, warn of the course of typhoons and dispense information on agriculture, taxes and similar subjects.

Scanning New Books

By JOHN SELBY. New York—(AP)—The literary prizes, their givers and their recipients together constitute a jolly little puzzle. Particularly in Europe, there are almost as many prizes as authors, it seems. But not all is log-rolling, for there has arrived "Susanne." "Susanne" is a novel of every-day life in Denmark by a Dane named Johannes Buchholtz. With "Susanne," Buchholtz won "the first Danish prize" in the "Inter-Scandinavian Novel Contest" the publishers inform us. No dates are given. It was a happy award. The novel has probably the most trite of all the familiar plots: the daughter of the small-town baker who married a rich, but unfaithful husband, and managed to keep on loving him. The pace is slow—but never halting—there are no extraneous aids for the consumer as the popular novelists so adeptly furnish.

Good Little Town

But there are several unimportant but fascinating Danes in the book, and a background that has not been done to the death. There also is a very artfully arrived at impression of freshness; one seems to be living for time in a good little town on the Danish coast, to be smelling the fresh bread in the Dresden baker's shop, the salty breeze from the sea. Such a sensation is worth having. As is the impression one gathers from Joseph Hergeshimer's Palm Beach stories, assembled from the files of a well-known weekly publication and published as "Tropical Winter," Hergeshimer found certain features of the too-rich class which goes to Palm Beach pretty awful. He goes at them unmercifully. Their strange houses, innumerable servants, newly rich extravagance and complete lack of intellectual movement annoy him most, he says. The net impression is discouraging, of course, but that it truly reproduces Hergeshimer's beliefs cannot be doubted. Technically, there is achieved a curious effect. After only a few stories (there are ten) the reader's mind is filled with a remarkable collection of objects like an "abstract composition" by an ultra modern painter. It is the result of taking one after another a series of stories with the same feeling and background, but different characters. Individuals do not obtrude; only a crazy pattern of cross purposes.

Queen Elizabeth

Ordinarily it would seem necessary to dig out a considerable mass of new material, or to stroke from a curious angle in order to write an important new biography of Queen Elizabeth. But it isn't. Moma Wilson has produced, in limited space, a first-rate biography of Elizabeth, clear, beautifully written and proportioned, and not without its distinctive color. The biography is one of a publisher's series.

Talks To Parents

REAL TASKS. By Alice Judson Peale. Probably one of the reasons that the child in the progressive school or kindergarten behaves so well and is unhappy if he must miss a day is that his school world is so scaled that what he finds to do is real. As such a school the children soon learn to take off their wraps and hang them up properly. They learn to wash their hands and comb their hair. They help to serve the mid-morning lunch and clear it away. If a child spills something he wipes it up as a matter of course and is pleased with himself for doing it well. A child waters the window plants and feeds the canary and goldfish which, obviously, would die if he did not take care of them. It is plain that even grown-ups cannot rate these activities as "just play." The children are proudly aware that their work is real and necessary, and their self-respect is enormously raised thereby. This consciousness that they, too can do things that have real value, that are important just as are the things with which adults are constantly occupying themselves, makes them feel less keenly the inferiority of being a child. The child is thus encouraged to learn to do all the things that the grown-ups do. With increased ambition and self-confidence he learns to take responsibilities at school which amaze the mother at home who still sees her child as an utterly dependent and irresponsible little creature. SPORT SLANTS By ALAN GOULD

Life may not be so spectacular at times in the track and field coaching profession, but to our industrious friend, Harry Hillman of Dartmouth, it seems far, far safer than the hazardous occupation of football coaching.

Prompted by the fact that the University of Oregon this January honored William Hayward, its noted track coach, after thirty years of service there, Hillman gives us a collection of figures that indicate track coaches may have to worry about old Pop time but not the call of the wild head-hunters.

When they move over to make room for a younger man in the profession, as Keene Fitzpatrick of Princeton and Walter Christie of California have done, after forty years and more of active coaching, it is of their own free will and preference.

Of course there have been and still are a number of football coaches still profitably engaged after long if also contemptuous terms of office. Warner, McGee, Stag, Cowell, Yost, Zuppke, McGurin, Cavanaugh and a few others have service records of twenty years or more, although two of these, Stag and Cavanaugh, have stepped out for the time being.

It's Settled Life But track coaches on the whole seem to lead a more settled life. Besides Fitzpatrick and Christie, Hillman points out there is Jack Moakley, 33 years at Cornell; Steve Farrell, retired at Michigan last year after more than 30 years at Yale, Maine, Ohio State and Michigan; George Conners, at Exeter and Yale for close to 30 years; Tom Keane, around 25 years at Syracuse; Dean Cromwell, 23 years at Southern California; Harry Gill, at least 25 years at Illinois; Charles Seeley, at Williams for close to 30 years.

There are others, like Lawson Robertson, 16 years at Pennsylvania; Johnny Masee, 19 years at Bowdoin; Eddie Farrell, going into his ninth year as Harvard's head coach; Jack Ryder of Boston College, who has been tutoring the boys altogether for over 20 years; Henry (Indian) Schulte of Nebraska, in the game nearly 20 years. Bernie Wefers is still actively coaching, after 30 years of it, and Ernie Hjerberg at Rice, nearing 70, has been in the game here and abroad, North and South, for 35 years.

Hillman himself has been 23 years at Dartmouth, but he doesn't look it. He was the Olympic hurdling champion over 28 years ago. He is secretary-treasurer and one of the most active organizers of the Association of College Track Coaches of America.

Eighteen-Year Grid Regime At a time when the tenure of football coaches is causing some alarm, being subject apparently to a "nine-year jinx" on the West coast, it is interesting to discover that the dean of gridiron mentors on the Pacific Coast has lasted twice that long. He is R. V. "Big" Borleke, head coach at Whitman College, a member of the Northwest Conference for the past eighteen years.

This doubles the record of Pop Warner, as well as Paul Schliser, just resigned at Oregon State. Alfred McVay of the Walla Walla (Washington) Daily Bulletin tells us that Borleke, with only about 250 students from whom to pick his teams, has successfully coached basketball as well as football at Whitman.

(Continued From Page One) eign trade by the existing, exorbitant protective tariff.

"We have erected a tariff wall which has prevented the people of Continental Europe and other countries from selling their products with us and in retaliation they have curtailed their volume from buying from us to the bare necessities. As you may ask how this affects the market price of our cotton and tobacco, the answer is easy. We only consume about one-half of the cotton and tobacco which we produce and the balance we must sell in the markets of the world. If the people of other countries are unable or not inclined to buy from us, the market is depressed. The main cause of the low prices from cotton and tobacco is therefore apparent. But the farmer has to buy the things that he needs in a protected market. He must not alone pay the prices fixed in the world market, but an additional sum by reason of the protective tariff."

Mr. Small discussed the farm relief legislation recently passed in the Federal House of Representatives under the leadership of Representative Jones of Texas and expressed the hope that it would become a law and serve to increase the market prices of the principal farm products. However, he said, there can be no permanent remedy until the farmer in the sale of his product shall be placed on an equality with the manufacturer who sells to him the commodities which he must buy.

The speaker said it was entirely practical for Congress to enact a law fixing a differential which could be added to the world market price of cotton and tobacco as to these commodities which he sold in the domestic market and consumed in the United States. If a high protective tariff promotes public welfare as its advocates contend, then the whole country should be willing that the farmer receive an equal degree of protection.

(Continued from Page One) Dixon was prominent in the business and financial realm of the State. He was of an affable and agreeable nature, and was beloved by hundreds of people in this community where he spent the major part of his life.

Dr. Dixon was born in Greene County January 7, 1865. He was the son of the late Congressman and Mrs. Joseph Dixon, of Greene County. He received his education at Kings Mountain Academy, the University of North Carolina, and the Medical College of Virginia. After receiving his M. D. degree from this latter school he began the practice of medicine in Ayden where he practiced for seventeen years. In 1899, he moved to Rapidan, Va., and lived there for eight years. After leaving Rapidan he took up post-graduate work at New York Polytechnic Hospital and then moved to Greenville where he has been practicing since 1918. Dr. Dixon was a director of the North Carolina Joint Stock Land Bank at the time of his death, having been a member about six years.

In 1894 he married Miss Gay Coward, of Greene County, who with the following children survive him: Ben and Jake Dixon, of Greenville; Joe Dixon, a student at State College; daughters, Mrs. W. B.
