DEMOCRATIC LEADERS CONFER WITH ROOSEVELT

Party Leaders Assemble At Warm Springs For Birthday Celebration

DEBT RELIEF PLAN ON WAY TO BRITISHERS

Politics and Cabinet Selections Expected To be Taken up as Pres.-Elect Celebrates His 51 Birthday; James A. Farley Among First to Arrive; Indications that Cabinet is Rapidly Taking Shape

Warm Springs, Ga., Jan. 30.—(AP)—Arrival here today of intimate Democratic friends of his fifty-first birthday party gave President-Elect Roosevelt opportunity to talk over politics and possibly cabinet selections.

There is no sign he is worrying about choices for the official family, but it is expected he will talk over some of these posts as well as other appointments.

Mrs. Phelps Dies At Macon

Mrs. Cora C. Phelps, 79, died Saturday at the home of her daughter, Mrs. J. M. Coleman, in Macon. Death was due to a complication of ailments following a period of failing health. She had been confined to her bed for the past two weeks.

Funeral services were held Sunday at 3 o'clock at the First Baptist Church in Henderson, of which the deceased had been a member for many years. Interment was in Elmwood Cemetery.

Surviving are the daughter with whom she lived, and three sons, James Phelps, of Durham; Jack Phelps of Chicago, and Wallace Phelps of Greenville. Her husband died many years ago.

Mrs. Phelps was well known in Greenville, having visited here several times.

Mrs. W. W. Phelps and Miss Florence Phelps of this city, attended the funeral.

KIDNAPING CHARGES AGAINST BANDIT GANG

Kansas City, Mo., Jan. 30.—(AP)—Kidnaping was added today to charges against a bandit gang which robbed a woman bank messenger of \$14,000, wounded the North Kansas City marshal, disarmed a posse and escaped in stolen motor car Saturday.

Police here were advised Bert Conroy, night watchman, and John Newman, traffic patrolman of Knoxville, Iowa, were abducted by four men, one wounded, who drove into the town last night in a coupe with a flat tire and asked their help in changing it. At a service shop, however, the men selected another car and drove off in it, with the officers as their prisoners.

SOLONS FACE BUSY PERIOD AT RALEIGH

Appropriations For Public Schools Faces Committee This Week

Raleigh, N. C., Jan. 30.—(AP)—If the General Assembly live up to its rapid fire schedule it assigned itself, this will be the last preparatory week of the current session.

At the opening of these the lawmakers ordered the Finance and Appropriations Committee to report the tax and money spending bills by February 6.

The chief accomplishment of the two committees so far has been to learn how hard a job they have got. Each still has several hearings.

What to do about the appropriations for schools and the State institutions, including the University, is scheduled for this week's work of the Committee on Appropriations. The University will be heard at a public session Friday.

The week begins with a bang tonight when the Senate begins consideration of the re-organization committee's important bills to change the set-up of the State government.

For these weeks' interest is less economic, the House offers another sort of show.

The Sullivan bill to allow Sunday baseball is on the calendar and is expected to be debated.

For the standpoint of action this should be the best work of the session thus far.

W. R. WHICHARD ARREST TWO PASSES A WAY ROBBERS HERE

Prominent Norfolk Business Man Succumbs to Severe Attack of The Heart

Willis Robert Whichard, well-known Mason and Shriner, died Saturday afternoon at 2:25 o'clock at a Norfolk hospital after an illness of about a week. He was stricken with a heart attack more than a week ago while at a Masonic meeting. He had been undergoing treatment at the hospital since. Saturday a second attack proved fatal.

Mr. Whichard was sixty years old, a native of Whichards, N. C., and a resident of Norfolk, Va., for twenty-five years. For the past fifteen years he had held the post of recorder of Khedive Temple A. A. O. M. M. S., and was a member of a number of other fraternal organizations in some of which he had filled offices of high honor. He was past master of Stonewall Jackson Lodge, A. F. & A. M., and held membership in Royal Arch Chapter No. 1, Order of the Knights Templar, Order of the Scottish Rites bodies of which he was treasurer, Royal Order of Scotland and was a thirty-third degree Mason.

He is survived by his wife, Mrs. Ella Keel Whichard; a son, J. Cecil Whichard; two brothers, H. Walter Whichard, of Norfolk, and L. R. Whichard, of Whichards, N. C., and a granddaughter, Frances M. Whichard.

Funeral services were held Sunday afternoon at 3 o'clock at the Shrine Mosque, Freemason Street and Montello Avenue, and were conducted by the Rev. Sparks W. Melton, pastor of the Freemason Street Baptist Church.

Late News Flashes

Pass Reserve Bank Bill. Washington, Jan. 30.—(AP)—Without record vote the House today passed the bill to allow Federal Reserve banks to use government securities as collateral for bank notes and turned immediately to consideration of whether it will extend the federal gas tax for another year. The Glass-Steagall bill was the first of the three the House planned to consider under suspension of rules. The measure, already approved by the Senate, would extend the power of the reserve banks which already have another year.

MARRIAGES DROP IN PITT

Big Decrease in Issuance of Marriage Licenses Since Christmas Holidays

Although the art of love-making has flourished probably as usual in the county since the Christmas holidays, the serious business of getting married has shown a pronounced drop during the period.

Applicants for license to marry have trickled into the office of the register of deeds here from time to time since Christmas, but the influx of the lovebirds has not been nearly as active as before and during the holidays when records of many years standing were scattered.

From five to six licenses have been issued each week since Christmas compared with from thirty to forty for the two weeks preceding and during the holidays.

Employees of the office of the register of deeds attribute the general reduction of business to depression usually following the observance of the Christmas holidays and anticipate a revival of the trek to the office with the coming of springtime, which in the phraseology of those susceptible to palpitation of the heart, is love time.

Four applications for licenses to wed were made here Saturday. Three of the couples were white and one colored. They were: Lyman Jones of Carolina township, to Miss Virginia Boyd; David Nobles of Carolina, to Miss Minnie Allen Griffin; D. L. Jones of Farmville to Miss Louise Fussell; Gerald Jenkins to Nerle Daniels, both colored.

SEVENTEEN-YEAR-OLD BOY OPERATES 40-ACRE FARM

Acton, Indiana.—(AP)—Harold Toon is only seventeen years old but sports his mother and younger brother by operating a forty-acre farm, and finds time besides to win prizes at state and county fairs with his livestock.

Harold was only thirteen years old when his father died, and has operated farms since. Since he wanted to be a farmer Harold joined a 4-H Club, sold most of the livestock and replaced it with purebred cattle and hogs.

MANY CASES HANDLED IN COURT HERE

Approximately Sixty Actions Disposed of In Criminal Court Last Week

Approximately sixty cases were disposed of in the one week session of criminal court which came to a close here last Saturday morning. It was revealed today by records in the office of Clerk of Court J. F. Harrington.

The charges ran all the way from minor cases of larceny to criminal assault and murder and hundreds of people from various parts of the county were on hand each day as witnesses or spectators.

The most important charge handled during the week was that of Herbert Rogers Pictolus township negro, who was set at liberty by a jury Friday afternoon after he had been tried for criminally attacking Mrs. Mattie Waters, white, of the Pictolus area. The trial lasted nearly two days and the jury was out three hours.

Windsor Taft, colored charged with second degree murder, was sentenced to from 7 to 10 years in State prison the latter part of the week following his conviction Tuesday. He was charged with slaying another negro in the Farmville section about a year ago. The charge was changed later to manslaughter, but the sentence remained unchanged.

In addition to these, a score of more persons found their way to prison or the roads following conviction of charges of robbery and breaking and entering.

Among these was Joe Berry of Raleigh held in connection with the attempted robbery of the Bank of Fountain and the Bank of Winterville, the latter part of last year. He was sentenced to from seven to 10 years in state prison. T. C. Poole, held in connection with the Winterville affair had prayer for judgment continued until he faces trial on similar charges in other counties.

Although a true bill was returned against James Davenport, of Beaufort county, arrested sometime ago for running over and killing Robert Clayton, school child of the Grimesland district, he was bound over to the next term of court under bond. The child was killed as he left a school bus and started across the road.

Charges of embezzlement and arson against T. E. Beaman were continued until the next term of court. True bills were returned by the grand jury in each charge and bond of \$1,000, was allowed in each case.

The murder case of T. H. Barnhill, of Bethel, charged with slaying Jess Barnhill, his ward for the alleged purpose of obtaining \$10,000 insurance, was continued until next term. It made the second time this case has been continued, the first time resulting from lack of evidence on the part of the state and the second time because of the illness of an important witness.

RANCHERS ADOPT DUCKS TO FIGHT TICK PEST

Sydney, Australia. (AP)—In Queensland and in the north of New South Wales ducks have assumed a new importance and are being bred in thousands.

It has been discovered they have a keen appetite for cattle ticks, vermin which cost ranchers millions of dollars annually.

Flocks of trained ducks now mingle with the cattle. Every time a beast lies down the ducks swarm over it and make short work of the ticks.

Brazil Has New Gold Field

Curitiba, Brazil. (AP)—The geological bureau of the ministry of agriculture announces it has found indications that new gold fields in this southern Brazil state are richer than the famous Murro Velho mines in Minas Gerais.

Small Cut In Belgian Army. Brussels. (AP)—Belgium's army in 1933 will be 81,500 strong, including 23,000 volunteers, 34,300 conscript recruits and 4,200 reserves called for special duty. The total is 1,500 under 1932.

WILL SUCCEED SCHLEICHER WHO RESIGNED

Fascist Leader is Surrounded With Cabinet of Conservatives by President Von Hindenburg; Hitler will Pursue Policy of Friendship for United States and Italy; Admires Both Countries

Berlin, Jan. 30.—(AP)—Adolph Hitler, leader of the German Fascists was made Chancellor of Germany today.

He succeeded General Kurt V. Schleicher who resigned last week.

By granting the ambition of his political life-time, President Von Hindenburg surrounded him with a cabinet of conservatives. Hitler placed his best men in the cabinet.

The new chancellor, only 41, took the appointment in his stride for power. Hitler's closest advisers said he would pursue a policy of friendship for the United States which, with the exception of Italy, he admires more than any other foreign country.

WILLETT TO LEAVE CITY

Two Women to Take Charge of Salvation Army Activities in Greenville

Ensign Mary Anderson and Lieut. Nadine Summers arrived in Greenville today to take charge of Salvation Army activities. They will take the place of Ensign Joseph Willett and wife who have been transferred to the Charlotte division of the organization.

Miss Anderson is from Anderson, S. C., where she has been in charge of work of the organization for the last several years. Miss Summers, daughter of Ensign Summers, who was in charge to the work here several years ago, recently completed training at the Salvation Army school in Atlanta, Ga., and since that time has been assisting her father who is in charge of activities of the army in that city.

Ensign and Mrs. Willett were to leave Greenville for Charlotte during the week. They have been here about a year and during that time made numbers of friends through their effort to improve the scope of the work.

The new workers said several changes would be made in operations here and that economy would be the watchword as they attempt to render a high type of service in the field of Christianity and general relief work.

Grand Jury now says we have "considerable losses" in. If our county is to sustain losses of the taxpayers' money and the taxpayers must bear the burden, certainly they are entitled to know the full details and the reasons for the transactions through which the losses came. In behalf of the taxpayers of the county we would welcome complete information as to those transactions including the official reports as to the actual worth of the securities at the time of purchase, the sources from which securities were purchased and the agency or agencies through whom the purchases were made.

THE TAXPAYERS SHOULD KNOW

The report of the Grand Jury submitted to Judge Grady Saturday was one of the most comprehensive reports of its kind submitted here in a long time and there are matters in the report that we feel should have even further attention by the Grand Jury or the Commissioners, or both. While there are several of these matters, today we call attention to only one phase of the report, that dealing with the condition of the sinking fund.

On this matter the Grand Jury report was as follows:

We view with alarm and desire to call attention of the County Commissioners to the condition of the sinking fund investments of the county. For the period ending June 30, 1930, these investments amount to \$29,209; year ending June 30, 1931 amounts to \$91,573; year ending June 30, 1932, amounts to \$173,411.57, six months ending December 31, 1932, amounts to \$219,499.74. A detail examination of these investments indicates that there is now considerable loss to the county in some of these investments. We are mentioning this urgent matter to emphasize the importance of properly safeguarding such portion of the Sinking Fund of the county that has not been invested.

As we see it, money in our sinking fund is money that has been collected from our taxpayers to be held in trust to retire our bonded indebtedness as it comes due and every precaution to protect these funds should be taken at all times. The Grand Jury states that at the present time there is "considerable loss" to the county in the investment of these funds which means that in the end the taxpayers of the county must pay again to bring this fund up to a sufficient amount to take care of the bonds when they become due. Of course, we are aware that there are provisions of law under which these funds can be invested while being held by the county, but in view of the loss apparent to the Grand Jury and in view of the fact that these investments appear from the reports to have been made mostly within the past two years when all securities were shrinking in value, we are wondering whether or not these securities were worth what was paid for them at the time of the purchase by the county and under whose authority and recommendation same were purchased. We agree with the Grand Jury that every effort should be made to protect the funds we have that are not already invested, but we likewise believe that the Grand Jury or somebody with authority should fully investigate the conditions surrounding the purchases of those securities that the

It was fitting that Sir Ronald Lindsay should have conferred with President-elect Roosevelt before returning to England to present his views on the debt question. As Roosevelt will be the leader of thought at the conferences to be held after he goes into office, it is proper Sir Ronald should go back to England with all information relative to Roosevelt's position on the question. The time for a definite understanding on this problem has come and the sooner the foreign powers realize that America wants her money and will not cancel the debts accumulating during the war, the sooner each nation can get down to the business of mapping out a definite program for recovery. Roosevelt is in sympathy with the foreign powers and he hopes with Britain's influence to be able to establish better trade relations with other nations and at the same time build up a greater spirit of faith and understanding on questions which have been rather vague and hazy in the past.

The recommendations of the grand jury seeking more careful driving of automobiles while approaching school buses is very timely and should be given the consideration of people in all parts of the county. Two lives have been claimed by reckless and careless driving the last year and unless people awaken to the danger of running by buses without stopping the toll will continue to increase.

The state has provided legislation throwing a protection around children while boarding or leaving the buses but if it is disregarded and not enforced it will never serve the purpose for which it was passed.

It is a direct violation of the law to pass a bus while it is taking on or unloading passengers. Everybody not acquainted with this legislation should inform himself and attempt to abide by the law. Had drivers in the two accidents reported in this county stopped, the children probably would be living today. Human life is far too precious to be sacrificed in this way and it is hoped the action of the grand jury calling for observance of the law will sink deeply into the hearts and minds of the citizenship.

Roosevelt is busy mapping out plans for running the government when he takes the oath of office in March. He has other members of the party assisting him and when he enters the White House everything will be in line for rapid action.

The President-elect is to give domestic issues first consideration. He probably thinks conditions at home are serious enough to demand the best thought and quickest action if it is possible to give and the public will watch developments with interest.

Economy will be the watchword of the administration and much expense of government is expected to be eliminated when the new chief executive takes office. Government reorganization is a big problem but one that must be effected if the future is to witness recovery from the period of financial embarrassment experienced at this time.

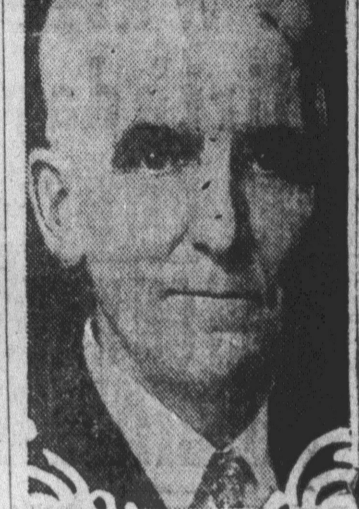

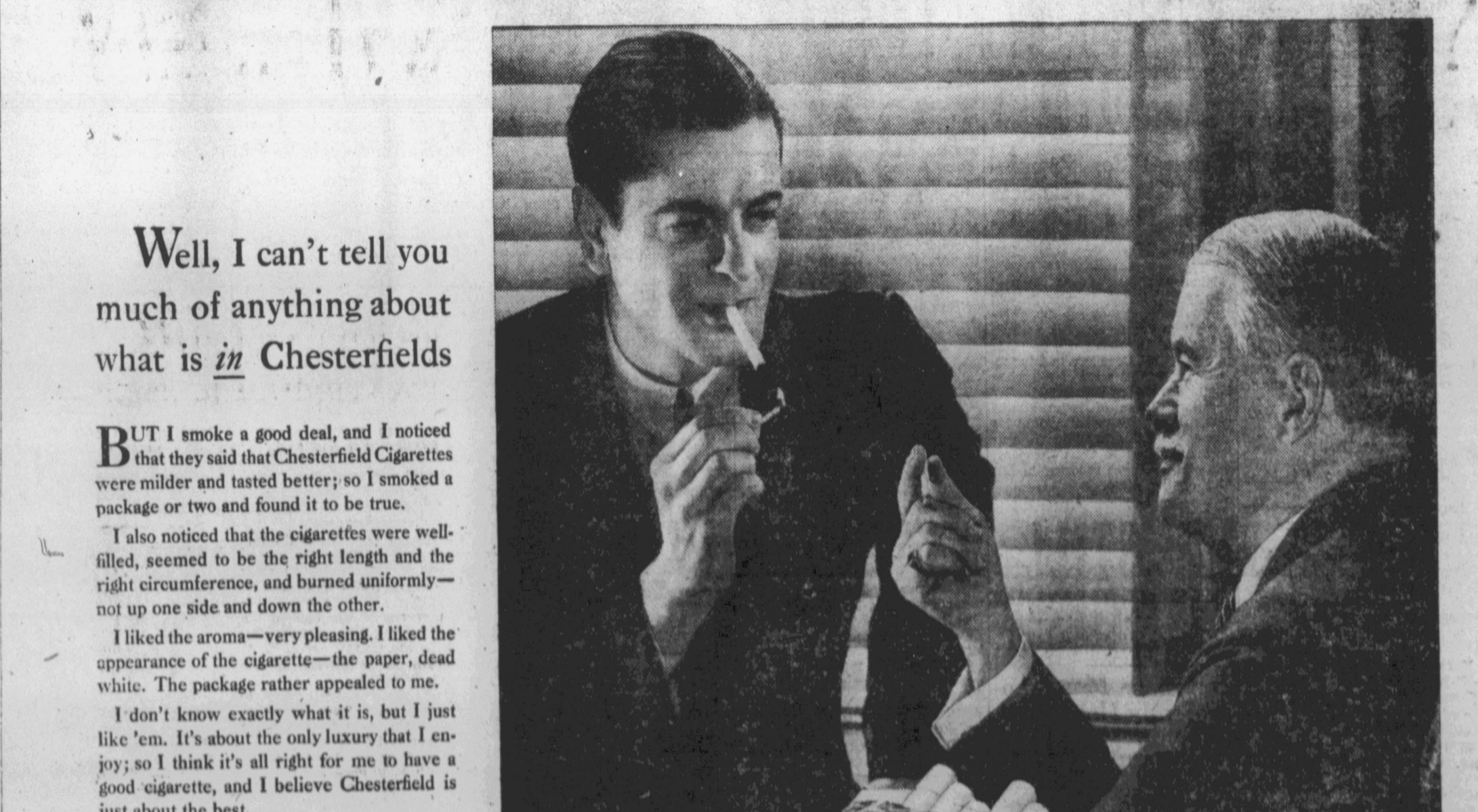

NEW BOOKS FOR SHEPPARD MEMORIAL LIBRARY. The reading public in Greenville and vicinity will no doubt be interested to know that an alcove in the Sheppard Memorial Library is being filled with books given in memory of Mrs. Mary Nelson Smith, formerly known to the older generation as Mrs. Polly Smith. Mrs. Smith was a pioneer educator in Pitt county, teaching in the public schools and also at a later time conducting a private enterprise school of higher grade to which prospective teachers from all over the county went as boarding pupils. Several people now living in or near Greenville were pupils in her school and know of the work she did. The books thus far given in her memory have been given by members of her family but any friend who wishes to contribute a volume or two to the collection may do so.

Among the books already donated are the following: As source books of United States history is a 10-volume set of the Messages and Papers of the Presidents; one volume of government documents on The Formation of the Union, and the history of the War Between the States, by Alexander H. Stephens, vice-president of the Confederate government. In the literary line is a beautifully bound edition of Shakespeare in ten volumes, a set of the Poets in some thirty volumes, the writings of Charles Kingsley, and Miss Mulbach's works. Because Mrs. Smith was descended from English Nobles with a Church of England background, she was a staunch member of the Episcopal Church and as vigorous and active in her religious life as she was as an educator. This alcove of books to her memory therefore includes a copy of the Schofield Bible, Cruden's Concordance of the Bible, The Expositor's Bible, a Bible commentary in six large volumes, the Cambridge Bible in 37 volumes, Geike's Hours with the Bible—7 volumes on the Old Testament and 2 volumes on the New Testament, 3 volumes of Bible Stories for children, Pappini's Life of Christ, The Student's Life of Jesus by Gilbert, Crises of the Christ, by G. Campbell Morgan; The Life Abundant by Dr. Bell, some of Dr. Fosdick's books, several books on the Church and Church History, and a number of other books of interest and value.

An oil portrait of Mrs. Smith has been donated to the library by Rev. W. E. Cox, a grandson and one-time rector of St. Paul's Episcopal Church here. This portrait is hung by the alcove of books and was given in her memory.

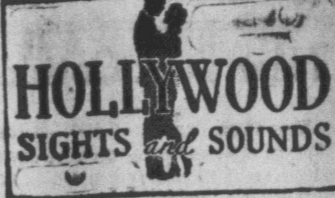

Words spoken after the cloture vote are not expected to be forgotten or forgiven easily. They may be the forerunner of momentous events of the future.

OL' MAN RIVER SHORTENED 10 MILES BY NEW CHANNEL. Vicksburg, Miss.—(AP)—The Mississippi River is ten miles shorter than it was recently.

A man-made channel at Diamond Point, twenty miles south of here, clips that distance off the river's length.

C.—(AP)—If anyone doubted that a delicate situation exists in the Senate at present, then it must have been dispelled during the dramatic period following the vote on the question of applying cloture on the Glass-banking bill. The Senate perhaps has had fewer tense moments than that immediately following Vice-President Curtis' announcement that the motion to shut off debate had been defeated.

The vote had been so close—a switch of one would have changed the result—that it had left nearly everyone in the chamber gasping. Had the show stopped right there it would have been enough to satisfy the hundreds thronging the galleries.

But when Thomas, Robinson and "Kingfish" Long himself got to mixing it, these galleries were treated to a spectacle seldom seen on the Senate floor.

It was so ordinary exchange of words between Joe Robinson and Huey Long. Robinson was visibly enraged during the whole encounter. His voice thundered his indignation.

Feelings held in check for a long time found expression during that comparatively short verbal battle. Robinson made sharp thrusts at Jim Watson and George Moses, to whom he charge a large share of the blame for the defeat of the cloture resolution.

His thunderous demand of the "kingfish" by what right he had to speak for the Democrats of the country was delivered in a somewhat terrifying fashion.

One need only glance at the vote on the cloture petition to get some idea as to the muddled state of affairs in the Senate. With such old regulars as Smoot, of Utah; Watson, of Indiana, and Moses of New Hampshire—even though they are "lame ducks"—voting with Long and the insurgent Republican outfit, one is almost forced to blink his eyes to realize it.

Anything Can Happen. Veteran Senate observers are almost unanimous in their opinion that the situation in the Senate is such now that almost anything can happen.

Words spoken after the cloture vote are not expected to be forgotten or forgiven easily. They may be the forerunner of momentous events of the future.

OL' MAN RIVER SHORTENED 10 MILES BY NEW CHANNEL. Vicksburg, Miss.—(AP)—The Mississippi River is ten miles shorter than it was recently.

A man-made channel at Diamond Point, twenty miles south of here, clips that distance off the river's length.

"I made protest to the committee (the campaign fund investigating committee) with great reluctance," Broussard told his colleagues. "I have served here for 12 years. Many members have known me for 12 years. I hope I have never done anything in this body to cause me to lose the respect of any honorable gentleman here."

"I didn't claim I was nominated. I don't claim any office. The state of Louisiana has been degraded to such an extent I feel the corruption, bribery and intimidation, even of bankers of the state, that such a man is afraid to offer himself for public office."

London, Eng., Jan. 30.—(AP)—A report which could not be confirmed immediately that Robert Hinkler, missing British flier, had been found alive in the Alps, was received today by the committee which has been directing search for him for three weeks.
