## ITALY ACCEPTS INVITATION TO TALK WAR DEBTS

### Rioting Follows In Wake Of Hitler's Ascendancy To The Chancellorship Of Germany

#### TWO PERSONS ARE KILLED AROUND REICH

Police Kept Busy Dispersing Communist Bent on Rebellion; General Strike Sought by Opposition; Nazi Students Riot at Berlin; Scores Wounded in Nationalist-Socialist Demonstrations

Berlin, Jan. 31.—(AP)—The ascendancy of Chancellor Adolph Hitler today crystallized a bitter feeling dividing the nation.

Two persons were slain and several seriously injured and others were arrested in clashes throughout the Reich during the day after the dynamic Nazi Nationalist-Socialist head regime came into existence. Police were kept busy today dispersing Communist gatherings to protest the elevation of Hitler to the chancellorship and confiscated inflammatory literature.

The Communist central committee published an appeal for a general strike and Communist handbills seeking open rebellion were confiscated in Magdeburg and the Communist newspaper "Rote Shane" was suspended in Dresden.

Berlin streets were the scene of university student demonstrations at noon by uniformed Nazi students from the university. About 500 demonstrators marched by the Bourse building shouting "profits" and other abusive words were hurled at Bourse members.

Nationalist-Socialist demonstrations in which scores were wounded also occurred at Dusseldorf, Halle, Schweinfurt, Offenbach and Hirschburg.

Two men appeared at the home and inquired about glasses sold the farmer's wife seven years ago by an itinerant salesman. After the "operation" which appeared to remove a film from the subject's eye, "Dr. Pierce" revealed his fee as \$58.50, but cut the price to \$52.50 because the "ten-year guaranteed" glasses had been changed by a local physician before expiration of the "guarantee."

#### DEATH CLAIMS H. L. FORLINES

Winterville Citizen Succumbs to Three Months' Illness Early Today

Henry Lee Forlines, 77, died at his home in Winterville this morning at 6:30 o'clock after illness extending over a period of three months. Funeral services will be conducted from the home Wednesday afternoon at 2:30 by Rev. M. A. Woodard, of Winterville. Free Will Baptist minister. Burial will follow in the Henry McLawhorn family burial ground near Winterville.

Mr. Forlines was a native of Halifax County, Virginia and moved to Pitt county thirty-one years ago and engaged in the early development of the tobacco industry in this county. He was looked upon as one of the foremost tobacco planters of his community.

For the last several years he had been engaged in the operation of a grist mill at Winterville.

He is survived by his widow, Mrs. Cordelia Forlines; five sons, H. J. Forlines, Winterville; R. F. D. 2; M. C. Forlines and O. G. Forlines, of Winterville; J. L. and D. O. Forlines, of Greenville; Mrs. Grover McLawhorn, near Winterville; Mrs. Grover McLawhorn, of Stokes; Mrs. W. W. Whitburn, of Greenville; Route 1; Mrs. W. O. Allen, Greenville; Route 2; two brothers, Hiram and Tom Forlines, both of Halifax County, Virginia. He is also survived by forty-three grandchildren and three great-grandchildren.

#### CALL PUBLIC MEETING HERE

Health Situation to be Discussed at The Courthouse Friday At 3:30

A public meeting has been called for the court house Friday afternoon at 3:30 o'clock to discuss the tuberculosis situation prevailing in this county.

The meeting is being sponsored by the public affairs committee of the Kiwanis Club in an effort to enlighten the public as to the danger of the disease, and men high in the medical profession of the state will be in attendance.

Representatives of the State Department of Health and Education will be present, and men who have spent their lives in the battle against tuberculosis will deliver informative talks dealing with the subject.

The meeting is the aftermath of a warning issued sometime ago by the Pitt County Department of Health in which the public was urged to be careful in employing young negro nurses or servants.

The statement said tuberculosis was quite active among young negro women and that the situation would become more serious unless they were subjected to complete physical examination before being employed in homes as nurses or servants.

Dr. R. S. McGeehey, director of the Department of Health, said they had been studying the tuberculosis situation for some time, and that the rate of infection had shown a pronounced increase the last few years. He stated the only way to handle the problem was to avoid a distressing situation was to inform the public of the danger and convince them that physical examinations were absolutely necessary.

Members of all women's organizations of the city, as well as teachers and public officials were urged to attend the meeting Friday and obtain information which will be of great value to the public health of the community.

#### NEW PREMIER IS OPPOSED

Edouard Daladier Faces Opposition From Socialist in French Chamber

Paris, Jan. 31.—Edouard Daladier, radical Socialist party leader, today completed the formation of the new government to succeed that of Joseph Paul Boncour whose cabinet resigned last Saturday. The Socialist, angry at the new Premier's break with them when he decided to form a cabinet without their participation, voted this afternoon against defraying credit to the party in the Chamber of Deputies.

Since the ministry is dependent on the Socialist party support the tenure of office is precarious and the Socialist vote today showed discontent.

Premier Daladier will perfect the cabinet to the Chamber of Deputies Friday. The cabinet was composed of seven members of the cabinet of Premier Boncour, who was overthrown Saturday, except for a few new faces.

#### ONLY DEBTS MENTIONED IN MESSAGE

Mussolini Authorizes His Government to Proceed With Plans For Taking Part in Series of Discussions When Roosevelt Takes Office; Communiqué Eliminates All Questions Except Debts

Rome, Jan. 31.—(AP)—Italian government accepted the offer today of the United States Government for discussion of the war debt situation as soon as possible after President-elect Roosevelt takes office.

The acceptance was made without reference to other questions, but announced instead that Premier Mussolini had given favorable answer to the American government's offer. The communiqué said:

"The head of the government has given instruction to the ambassador at Washington to respond favorably to the offer of the American government for discussion of the debts."

### Neutrals Try To Halt Warfare Around Leticia

(By The Associated Press)

Continued presence of Peruvians and their flag in Leticia has brought to Amazon waters a fleet of small but heavily armed Colombian vessels carrying an expeditionary force charged with dispossessing the invaders.

The situation threatens to involve Peru and Colombia, traditional allies who side by side won their independence from Spain more than one hundred years ago, in a war for which neutral statesmen say they can find no reason.

Peru backs citizens. The crisis might have been avoided early last year, observers have said, had Colombia come to terms with a Peruvian citizen named Vigil who tried to sell his large land holdings in the Leticia corridor to Colombia. Bogota authorities decided, however, that his price was too high. After the negotiations broke down, Senor Vigil rallied his neighbors, led them to Leticia and occupied the town.

Peru, while disclaiming any official connection with this occupation, is charged by Colombia with sending territory to aid its citizens

to resist the evicting force. Brazil Offer Falls. Secretary Stimson, backed by Great Britain, France, Germany, Italy, Japan and the League of Nations, has upheld the justice of Colombia's case and warned Peru that any effort to prevent re-establishment of Colombian sovereignty in Leticia would violate the Briand-Kellogg anti-war pact.

Brazil and Ecuador, neighbors of the disputants, have sent troops to the frontiers to guard against violations of their neutrality. Colombia wants Leticia back while Peru, which ceded the territory by signing the Solomon-Lobano treaty of 1922 supposedly settling a century-long boundary controversy, wants the territorial question reopened.

See Treason in Treaty. Brazil has offered to receive Leticia from its Peruvian occupants and hand it back to Colombia on condition that negotiations for the boundary revision begin at once. Colombia accepted this proposal while Peru agreed only if Brazil would occupy Leticia until after negotiations.

## THE COURTS SHOULD CO-OPERATE

Taking up another phase of the Grand Jury report dealing with the county's finances we find the following paragraphs:

We are informed there is now uncollected \$6,777.38 in fines and costs imposed by the county and Superior Courts. The county sorely needs these funds and we recommend prompt collection of same to be turned over to the proper officers.

On the face of this report it would indicate that the sheriff has fallen down badly on his job of collecting costs and fines levied upon offenders in the county and Superior Court but upon investigation of the detailed figures in this matter we find a lack of co-operation on the part of the courts that prevents the collection of the major part of these items and places the courts in the position that the offenders have reached the belief that when the court metes out a fine if it does not require payment immediately the case is settled and the offender is free to go his way without molestation until he commits some other offense and is again hailed into court to be taxed with another fine that he will never have to pay.

In checking over the list we find there is to date unpaid \$4,458.77 in costs and fines from the County Court and \$1,818.61 from cases from the Superior Court. Several of these cases extend back for nearly five years and never a cent has been paid by the defendants especially those with somewhat regular court records, while we find that where partial payments have been made they were to a great extent by those first offenders who felt that they owed this money to the county and voluntarily made payment on same. We also find that out of a total of over \$8,000 in costs and fines recorded less than \$1,800 has been paid, leaving uncollected more than \$6,000, as set forth by the Grand Jury report. This total is made up by items ranging from \$6.30 to \$228.75 and there appears upon the list the names of many persons who could pay these items and, would if they knew that they must pay or serve time for their crimes.

If a judge desires to mete out fines to the guilty defendants who appear before him that is his privilege and if he desires to give such defendants a certain length of time in which to make payment, that is likewise his privilege, but if this latter course is followed, then certainly it is up to the judge to see to it that these cases stay on the

docket until they are finally settled and if settlement is not made in the specified time capias should be issued bringing the defendants into court again and forcing settlement of the fines and costs or meting our other punishment in keeping with the crime for which each defendant was found guilty. If defendants were aware that this action would be taken, if they did not pay their fines and costs under the terms specified, they would make a greater effort to meet the payments and not only would the county be that much better off financially but respect for the courts would be increased.

Our suggestion to the judges in both the County and Superior courts is that when an extension of time is to be given a defendant in which to make his payments that the case likewise carry a jail sentence or road sentence that will become effective automatically by failure of the defendant to meet his payments as prescribed. If this plan is followed and the sheriff is required to see to it that the defendants are immediately placed in custody upon their failure to pay, we believe that most of these fines and costs will be paid promptly.

As things now stand, only those defendants who want to pay, pay and the others laugh it off and go ahead doing as they please. In the end the county loses the money that is justly due it, the sheriff gets credit for not taking care of his job and the courts lose the respect of the people.

This is a matter that can easily be remedied by the proper co-operation on the part of the judges and court officials, and for the common good of all we urge that steps be taken to correct the existing conditions.

## POLITICS

By BYRON PRICE

One of the oldest questions of statecraft—how far a responsible government can afford to go against the prevailing winds of popular opinion—is destined to present itself with singular acuteness in the impending negotiation over war debts.

No one should suppose it merely will be a matter of statesmen sitting down together and making an agreement which to them, as reasonable men, seems just. Instead they must forever ask themselves, with respect to every proposition that is presented, "Will the people at home stand for this?"

Even under normal conditions, this situation would be a difficult one for negotiators who were striving for a solution both sides could accept. It is rendered even more difficult in the present instances by the world unrest, when many millions are disposed on general grounds to distrust and repudiate public men and all their works.

Some public men, on both side of the Atlantic, have even found it advisable to preface the negotiations by a reaffirmation of the most extreme viewpoints.

Speaking at Leeds, the British chancellor of the exchequer, Neville Chamberlain, inferred that so far as the British government was concerned, the starting point of the discussions would be a request for outright cancellation.

On the following day at Washington, the Democratic leader of the House, Representative Rainey, predicted there would be "no reduction" of the debts and that the conference "won't amount to anything."

Chamberlain is a member of a government of none too secure tenure, although it commands a strong majority in the House of Commons. Rainey is a candidate for speaker of the House. However much you discount their remarks, though, on the score that they were for "home consumption," they still sound an ominous note. They do not indicate a narrowing of the gap.

Not one, but several, of President Hoover's cabinet officers have been saying privately for a long time that radical adjustments would be advisable. So have many members of Congress, although they voted otherwise.

## ILLUSION:

This very old illusion was invented by Indian fakirs. The secret was unearthed in 1849 by the great magician, Robert-Houdin. At that time, ether had just been discovered, and little was known about it. Houdin claimed that he had discovered that this new anesthetic could make people light as air. To prove it, he caused the subject to rise into the air and float apparently suspended. He passed a hoop around the body to show there were no wires or supports.

## EXPLANATION:

There are many, many explanations for this old trick. One is that the girl wears a concealed harness, which ends in a socket between her shoulder blades. This is attached to a piston below the stage. The piston is pushed up from below, causing her to rise in the air. The piston is invisible, because it is covered with mirrors which reflect surrounding draperies, similar to the background. The magician can pass the hoop over her body because it is cut in one place. It can be pulled apart for a second when it passes the piston.

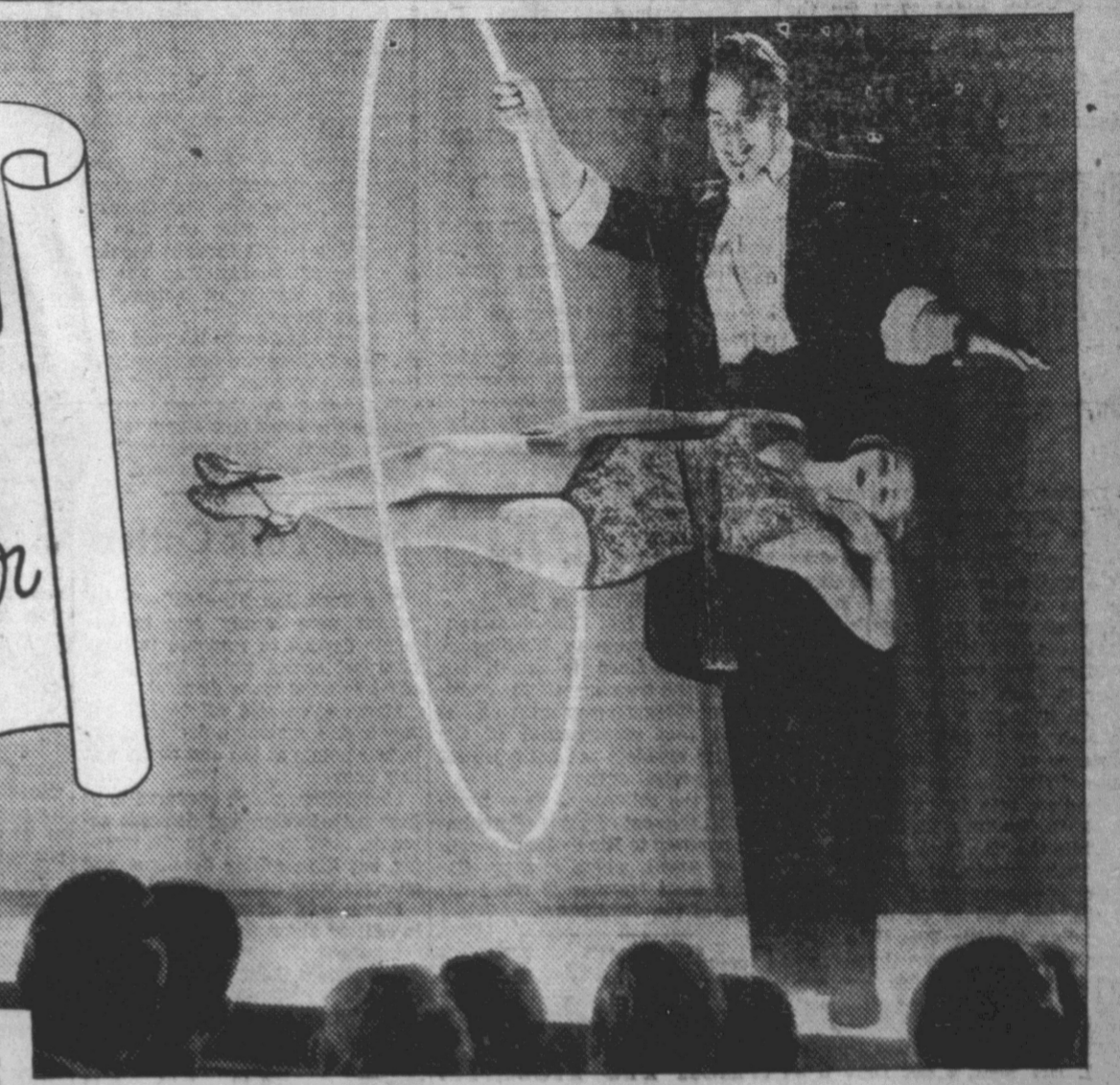
