SPEED PLANS FOR WORLD ECONOMIC CONFERENCE

English Prime Minister Assures Nations Confab Will Be Held In Summer

SIX POINT PROGRAM IS FOR RECOVERY

Leading Officials Arrive in London to Discuss Plans For World Conference to Bring Return of Prosperity; McDonald Will Preside Unless Move is Started To Bring Deliberations to America

London, Feb. 9.—(AP)—Aroused to new hope for the return of prosperity the nations of the world have been advised by Prime Minister Ramsey MacDonald that the world Economic Conference would be held as early as possible.

A survey by Associated Press correspondents in various European capitals shows that the conference preparatory commission with its work completed has outlined a six-point program for recovery.

Leading officials are arriving in London to discuss the conference arranged with Great Britain.

That McDonald will preside over the first session of the historic making conference in July in St. James Palace, is likely unless a movement is started to move the conference to Washington.

The World Economic Conference will bring to London representatives of more than fifty nations, including famous men and women, not only scholars, economists and world financiers but also picturesque national figures.

LEAS TO MAKE FINAL STAND

Tennessee Men Plan Final Effort to Prevent Return to North Carolina

Jamestown, Tenn., Feb. 9.—(AP)—Colonel Luke Lea and son, Luke Lea, Jr., under technical arrest here, today engaged in a series of conferences with counsel over habeas corpus proceedings to make the last stand against return to North Carolina to face charges of violation of State banking laws.

A court writ ordering Lea and his son to appear here next Monday for hearing, prevented immediate extradition. The two men were convicted in North Carolina courts in 1931 for conspiracy to violate banking laws in connection with the failure of the Central Bank and Trust Company at Asheville.

SHAD BILL AROUSES STORM OF PROTEST

Wilmington, Feb. 9.—Passage by the legislature of a bill to prohibit shad fishing off the coasts of Brunswick, New Hanover, Pender and Onslow counties has aroused a storm of protest at Southport, where shad fishing is one of the major industries.

The bill was introduced by Representatives Newman and Grant of New Hanover. Its proponents claim it was aimed at fishermen from states north of North Carolina, who set stake nets in the ocean and seldom visit them, leaving thousands of fish to be eaten by sharks and crabs, with resultant threat of depletion of shad.

Tuesday, the first day after passage of the bill by the State Senate and its enactment into law, the Southport fishermen evaded the law by removing their nets three miles off shore, outside the pale of state authority.

SEE DANGER IN TREASURY BILL

Customs Bureau Declares Measure Severely Cripple Operations

Washington, D. C., Feb. 9.—(AP)—The Customs Bureau notified the Senate today that passage of the treasury bill as it stands with its drastic economies would necessitate the discharge of 1,500 men June 30, would open the Canadian and Mexican borders to liquor smugglers and close all forty on the inland customs offices except the one at Chicago.

REVOLUTION FACES CUBA

Something Big Reported to be Brewing Among Exiles of Nation

Havana, Cuba, Feb. 9.—(AP)—Confidential government sources today admitted they had reason to believe something "big" is brewing among Cuban exiles in the United States and South American nations.

An attempt to overthrow the regime in August, 1931, was cleaned up by Machado's army of 12,000 men and resulted in the flight of former President Mario Menel, now directing activities of Cuban exiles in Miami.

HUNT FOR MEN BURIED ALIVE IN THIS STATE

Crews Attempt to Find Bodies of Seven Men Buried In Quarry

Fletcher, N. C., Feb. 9.—(AP)—Crews haggard and weary after working all night in zero weather, kept doggedly today at their efforts to rescue the bodies of seven men and whose lives were snapped out by an avalanche of stone and earth yesterday at the Blue Ridge quarries yesterday afternoon.

PUSH HIGHWAY TRAFFIC LAWS

Highway Patrol Says Automobile Criminal Must be Dealt With Severely

The punishment of the automobile criminal must be certain and severe if he is to be curbed, the State Highway Patrol said today in a statement continuing its campaign to reduce the number of automobile accidents in this state.

The statement was issued by Lieut. Lester Jones, of the local highway division and deals with the inadvertent violator of traffic laws and the automobile criminal.

The statement follows: "The inadvertent driver means to be careful and competent, but he is congenitally a poor driver, or is slow in his reactions, or is absent minded, or is easily distracted from the business of operating a car. Because of him, many severe accidents occur. The solution in his case is a licensing authority which passes on every driver's license, refusing those who are mentally or physically incapable of safe driving, no matter how good their intentions may be. He must be educated. The licensing feature being the only method now known.

"The automobile criminal presents an entirely different problem. He may be a good competent driver in all respects save one—deliberate disregard for the rights and safety of others. In his case, intent—that old arbiter of any criminal act—is present. He drives recklessly or under the influence of intoxicants. He runs away after accidents. His punishment must be certain and severe if he is to be curbed.

"On the one hand the inadvertent violator, who should be helped and do not belong in the courts—on the other, the intentionally dangerous, who are a real menace to public safety. It is suggested that legislation recognize these factors, and should be given serious consideration in every state as a constructive step toward solving the problem of automobile accidents."

CARE FOR NEEDY SICK PROBLEM IN CRAVEN

New Bern, Feb. 9.—Doctors in Craven county are not willing to attend charity medical cases for the price of three cents per mile allowed them by the county welfare department. Mrs. John L. Whitford, county welfare officer, told Craven county commissioners Monday. And Dr. N. M. Gibbs, county physician, told the commission that he should not be expected to take care of all the medical work in the county among the 1500 persons on the welfare department's lists for his present salary of \$50 per month.

WINTER AGAIN GRIPS SECTION

Second Cold Attack Since Visit of The Groundhog Visits Community

The groundhog, in the opinion of his supporters, has been fully justified for fleeing back to his place of hibernation after seeing his shadow the first of last week.

For the second time since the appearance of the woodchuck, a cold wave swept over this section today, sending the mercury hurtling to the lowest stage of the winter.

The new attack of the elements was felt more keenly than any other by the populace because it followed temperatures which would have been considered proper for the summer months.

The icy breath of winter was whipped over the section last night on a high north wind which continued today with slightly diminished fury. B. T. Clark, director of the government weather bureau here, said the reading this morning showed a temperature of 18 degrees, a fall of 42 degrees from the ready of 60 yesterday. The mercury dropped to 16 degrees in the attack of the ice man the first of the week. Although leaden skies yesterday afternoon threatened to give rain, snow or sleet, the wind dissipated the clouds last night and fair weather prevailed today.

Two Women Slated For Post In The New Administration

SIX FIREMEN VICTIMS OF HOTEL FIRE

Men Buried Alive as Rear Wall of Omaha Hotel Collapses During Blaze

Omaha, Neb., Feb. 9.—(AP)—Six firemen were believed to be dead today and at least eleven others were injured as their mates brought under control fire which destroyed the Mallard Hotel, an Omaha landmark. Firemen sought in the debris for the bodies of five men. After five hours of work only the body of Captain Ed. Smith had been recovered from the ruins. He had been killed in the collapse of the rear wall which buried him and three others.

Two more were buried under the debris in the basement. Senior Captain George Cogan and Fire Inspector Caren Urban were trapped after the explosion brought the roof down on them as they stood on the first floor carrying them to the cellar.

Fireman Walter Hovel, who had entered the shop with them, was rescued an hour later. A representative of the National Board of Underwriters had been inspecting the building with Urban and left a few seconds before the cave-in.

Rescuers talked with Cogan but were unable to reach him or Urban, and at 7 a. m. no hope was held out that they would be rescued alive.

Chief Cogan helped rescuers in an effort to save his brother, and stimulants were passed to the trapped man in the hope they might minimize the effects of the 15 degrees below zero weather in which they worked.

SOUP KITCHEN ROBBED HERE

Big Amount of Food Obtained From Pantry At Third Street School

J. H. Rose, superintendent of city schools, said this morning he had discovered the "meanest man" in the world.

Last night a thief entered the soup kitchen at Third Street school, stole half of the food supply in the pantry and then escaped.

The food was being used in the feeding of children of the poor and consisted of meats and a large quantity of canned goods. The thief broke through a window on the east side of the club house in which the food supplies are kept, broke the lock off the pantry and accomplished his unholy mission.

KING WINTER VISITS STATE

Zero Temperatures Reported in Many Sections of North Carolina Today

Charlotte, N. C., Feb. 9.—(AP)—King Winter put North Carolina on the spot today.

He wrapped his icy fingers around the State from the mountains to the sea and squeezed the temperatures down as low as 5 degrees below zero in the mountains.

An Appalachian College student, Miss Mindexter Long, fell unconscious in the extreme cold while on her way to class in the afternoon. The low reading was 5 degrees below zero.

Aheville has a low mark of zero and other mountain cities were as cold if not colder.

Lights now fell throughout the extreme west during the night, but failed to prevail today.

The cold wave will continue for awhile at least. The weather forecast was fair and continued cold.

HOSIERY MILL MEN WALKOUT

Additional Employees Of Mill at Burlington Strike Over Wage Question

Burlington, N. C., Feb. 9.—(AP)—The finishing department of the Standard Hosiery Company mill closed today affecting 150 employees after 11 strikers who quit last Tuesday refused to return to work over wage trouble. Mill officers said that finishing would be done elsewhere.

Other departments of the mill were not affected by the walkout of employees of the drying and boarding department.

TWO ARE CONVICTED ON A DOUBLE CHARGE

Smithfield, N. C., Feb. 9.—Lucy Hinnant and her husband, Robert Hinnant, filling station operators, of Selma, were brought before the recorder's court and convicted of violation of the prohibition law and maintaining a house for immoral purposes. They were adjudged guilty upon each of these charges and judgment was reserved until later in the week. Mrs. Hinnant's plea that she had the liquor for her own personal use and that she was then ailing was not a satisfactory reason why the court should acquit her, in the face of evidence that on Christmas Day when this raid was made, drinking glasses were found, liquor was found in the house and barn and some intoxicated men were present when the officers arrived.

Late News Flashes

Today in the Legislature. Raleigh, Feb. 9.—(AP)—The Senate today passed a bill to allow divorce in North Carolina after two years separation and approved a bill to abolish the state corporation commission. The committee did little in the morning but this afternoon appropriations of county, city and town had meetings scheduled. Approval of the divorce bill in the Senate was 35 to 11 and the measure was sent to the House. The abolition of the present corporation commission of three members and creation of a public utilities commission was approved 28 to 20. The margin would assure passage of the bill on final reading but opponents hoped to be able to kill it. A House judiciary committee this morning named a special committee to consider drafting of legislation for stricter control of motor trucks on highways of the state. MRS. OWENS MENTIONED FOR MINISTER

Mrs. Perkins of New York Regarded as Certainty For Post Of Commissioner of Labor; Mrs. Owens Set For Minister to Denmark; Appointments Will Set Precedent in U. S.

Miami, Fla., Feb. 9.—(AP)—The plans of the new Democratic administration to give a new deal for women in the government service brings two names prominently into the picture, Miss Francis Perkins, of New York, for Commissioner of Labor, and Mrs. Ruth Bryan Owens, of Florida, for Minister to Denmark. It was said they were definitely fixed for the two appointments which will set a precedent in government life.

No woman has ever received formal appointment to high government office.

Mrs. Owens is the daughter of the late William Jennings Bryan, who returned for the third time to the Democratic in a Presidential campaign. She is completing a term in the House for which she was drafted from renomination in the last election.

Miss Perkins is the Commissioner of Labor of New York and her selection by Mr. Roosevelt for a Cabinet post is regarded as a certainty.

BLOUNT HITS AT SALES TAX

Former State Merchant President Says Measure Would Mean Bankruptcy

J. H. Blount of Greenville, in commenting on the proposed sales tax now before the General Assembly as the means of balancing the budget, says:

"It is better to have an unbalanced budget than to single out one class as a means of relieving all others. This proposed general sales tax cannot be passed on to the consumer and will mean bankruptcy for thousands of merchants who are now barely able to keep their doors open. As evidence of the present financial stress of the merchants of this state, there are thousands of stores in the cities and towns either vacant or barely able to pay sufficient rent to cover taxes on the property. The chief source of revenue to our cities and largely to our counties is from the ad valorem tax on store property. Seventy-seven towns and thirty-four counties are now in default and this is largely due to the inability of the owners of business property to meet their taxes. Property in towns and cities carry a double burden—the payment of taxes to the county and to the city. The chain stores are having their burdens, too. Many of them are going into bankruptcy because of their inability to carry on with their leases. This throws the property back to the owners and with absolutely no income therefrom, the taxes, insurance and repairs on this property make a burden greater than he can carry. It is unfair to tax the merchants as a class and thereby relieve large corporate interests that hold lands and property in this state. If it is necessary for us to have a sales tax, it is much more desirable to have one in the form of a selected commodity tax on certain articles which can be passed on to the consumer. Included in these articles should not be the necessities of life. The merchants are willing to share their part of the burden, but it would be grossly unfair to undertake to pass the larger portion of the burden sufficient to balance the budget from a gross sales tax. ## SHOULD CORRECT MISTAKES FIRST

It seems that all eyes at Raleigh are turning to the general sales tax idea with the apparent realization that it must be a sales tax or nothing, but again we urge that before the legislature attempts to pass any other kind of tax it remove from the statute books that abomination that exempts stocks of foreign corporations from ad valorem taxes. This piece of legislation passed to favor the rich has not only placed heavier tax burdens upon real estate and other visible property but has been an incentive to the holders of cash to invest their money in foreign corporations instead of home enterprises. While we are not an advocate of mob rule we cannot help but feel that the overburdened taxpayers of this state would be within their rights to decline point blank to accept further taxation at the hands of the legislature so long as this law, passed especially for a privileged class, remains on the statute books. It was a grave mistake when this act was passed and the legislature's first duty is to correct this mistake.

1000 bonds for roads that we constructed and then turned over to the state. There are other counties in the state in a similar condition and the taxpayers in each of these counties are paying taxes upon their real estate to retire these bonds while the state receives all the revenue derived from motor vehicles. If the legislature really wants to give some relief to the taxpayers let it pass a measure that will suspend construction of new roads for the present and let the savings be turned over pro rata to these counties that have these bonds outstanding and in that way relieve the taxpayers of a portion of their present taxes to mature these bonds. These counties built the roads for the state while in other counties the state built the roads and paid for them with state money. Now would it not be a fair proposition that a part of the gas tax money should be turned back to these counties to apply on their road bonds placing them on a par with the counties whose roads were paid for by the state.

We reiterate, it is dangerous to divert the road money to other sources so long as the counties still owe for roads. In reality it is the state's debt and the state could and should take care of it in the manner outlined above.

## ABOUT TOWN

That conference of governors called by President-elect Roosevelt should be filled with great possibilities.

The incoming president evidently is trying to gain a clearer understanding of the problems of the various states so he will be able to begin a movement looking to regaining prosperity.

If there is anything this country needs at this time it is prosperity and it is to be hoped the governors get in line with Mr. Roosevelt and do their part to make this possible.

The nation is at the turning point at this time and if we do not take a start in the right direction it is impossible to say what will happen. Roosevelt realizes this and is doing his utmost to improve the situation before things take a turn for the worse.

## ROAD MONEY SHOULD GO FOR ROAD BONDS

The joint committee of the General Assembly has favorably reported the bill that would suspend all highway construction during the next two years except such projects as would come under the heading of emergencies. In view of the present conditions in our state's affairs the move is a good one but let us issue a warning against the diversion at this time of the highway funds. If the roads are not absolutely necessary at this time do not build more roads, but let the money saved in this way be applied to the road bonds of the various counties. Money collected from gasoline taxes is purely road money and in view of the fact that it is paid entirely by those persons using the roads, regardless of how much more the same persons pay in other forms of taxation the money should not be used for anything else so long as the roads are not paid for. It is not fair for us to have to pay an ad valorem tax to take care of road bonds and then have to pay a gasoline tax and have it diverted to other sources. If this money is not to be needed for road construction let the state use this fund to help those counties who have outstanding road bonds meet their payments on same. In the case of our own county, we have outstanding \$1,800,-

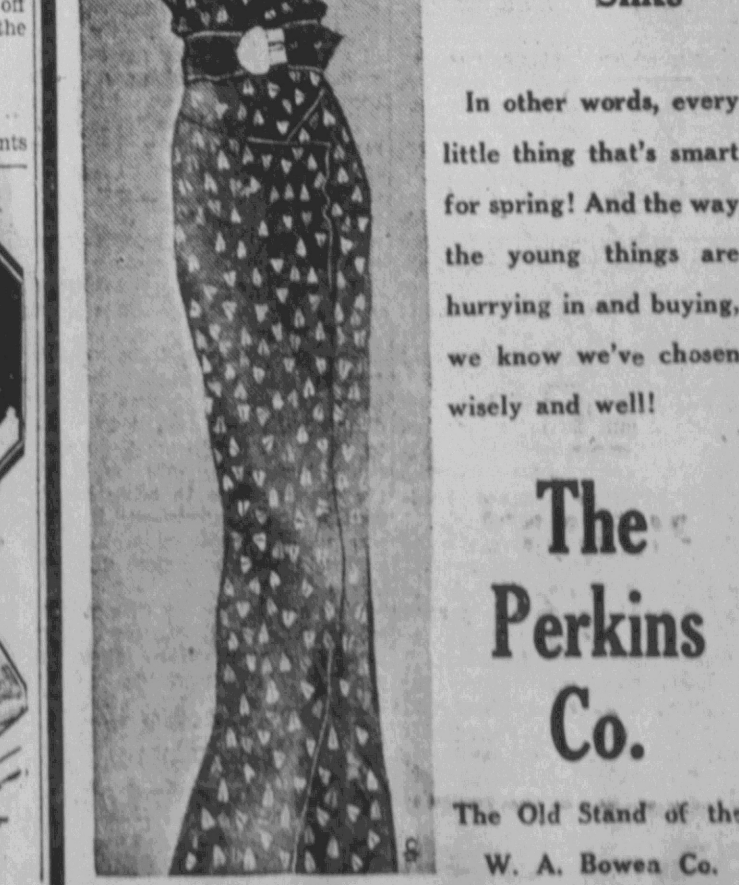

SPORT SLANTS By ALAN GOULD

It's always refreshing to talk football, even in the middle of this balmy winter, with Andy Kerr, the mighty little Scotsman who not only produces great football teams at Colgate, but thinks the colleges can economize a great deal on scouting, believes the rules-makers should try doing something more for the offensive side this year and favors making the game more fun for the boys.

"I believe the boys as well as the spectators, like the games with lots of scoring," suggests Andy. "Certainly the game has been becoming more complicated from the angle of trying to crack the other fellow's defense. We not only have to teach the ball, but several different ways to do it, according to how the defense shifts."

"Let's open up the game a little more. For instance, bring the ball in from the side-lines, not 15 yards, but to the middle of the field, without the loss of a down."

"This will sound radical to you, but I would also like to see a change to permit a twelfth man to be on the field, for the attacking side, just to call the plays and be in a detached position to watch the other fellows. Naturally he wouldn't run or block. When the ball changes hands, he could go off to join the linemen, while the other side sent its twelfth man out to do the master-minding."

"Baseball teams have coaches on the base-lines while the team is at bat. Why not give the offensive side a similar advantage in football?"

Makes For Freer Scoring

The non-scouting agreement which Kerr negotiated with Tulane's athletic authorities for the Colgate-Tulane game, in New York next November is a move toward economy as well as more interesting football.

"The colleges, many of them, have been spending too much time and money on scouting," says Kerr.

"There's an illustration for you. Out on the coast, as you know, the 'big game' is between Stanford and California every year. They prepare for it, talk about it and scout each other all season. So last season they wound up in a scoreless tie, the most uninteresting thing in football."

"Then we came along with our all-stars for the annual East-West charity game in football. Naturally we couldn't scout for that one. We had a general idea about each other's system, but that was all. The result was a free-scoring, exciting game in which five touchdowns were scored and as many more narrowly missed."

Lot of Hocus-Focus

"Scouting is all right, but I would like to see it restricted, for the benefit of the game as well as the money it will save."

"Gyration and Colgate, nearby rivals, could agree to scout each other in only two games, for example, and do it with a minimum of expense."

"It's a waste of time and money, anyway, to scout teams in most early season contests. At Colgate we have our football pretty well systematized. I'm always glad to show our standard formations to the other fellow any time he wants them. Most of this secrecy is just a lot of hocus-focus, anyway."

UNEMPLOYED PUT TO WORK BEAUTIFYING CITY'S PARKS

Neenah, Wis.—(AP)—This city is having its face lifted and aiding its depression victims at the same time. Several score unemployed have been given work transplanting elm, oak and maple trees from a woods ten miles from town to city parks and parkways, under supervision of landscape artists and foresters.

The trees originally were selected for transplanting at the Century of Progress exposition in Chicago, but that plan was abandoned. Previous to this project the city's relief work included a tree-tr
