Peru has philatelic as well as international troubles.

Two days after the 10-centavo stamp bearing the portrait of President Luis M. Sanchez Cerro appeared, the Peruvian authorities came across a law forbidding the use of a living person's picture on the nation's issues.

So all of that value which had not been sold—there were 7,000,000 printed—were ordered burned. And some dealers raised their prices a hundredfold—from the equivalent of \$0.15 to the equivalent of \$1.50.

The series is to include 7 other values, of which the 2 and 4 centavo, showing the extinct volcano El Misti; the 1 sol, showing the Simon Bolivar monuments at Lima; and the 2 centavo, showing a blacksmith, to be used locally as a tax to aid the jobless, have been issued to date. A new 10-centavo design to replace the one that ended in a bonfire is expected.

There won't be any such trouble with the portrait of King George on the stamps of the Bechuanaland Protectorate, pictures of British rulers being common features of British stamps.

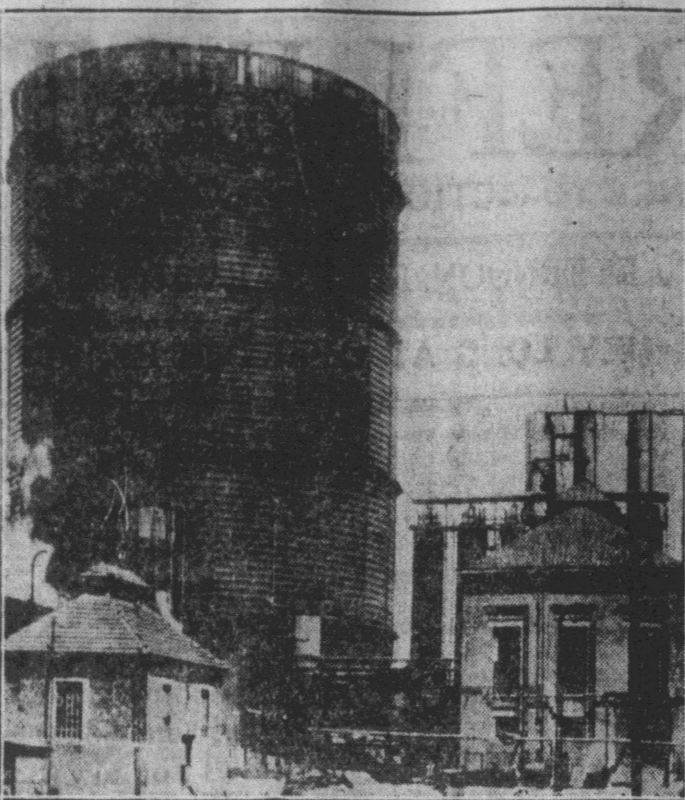
The series includes 12 postage values, ranging from half-penny to 10 shillings, and three postage-due stamps, of half-penny, 1 penny and 2 penny values.

A portrait of the king appears above a pastoral scene.

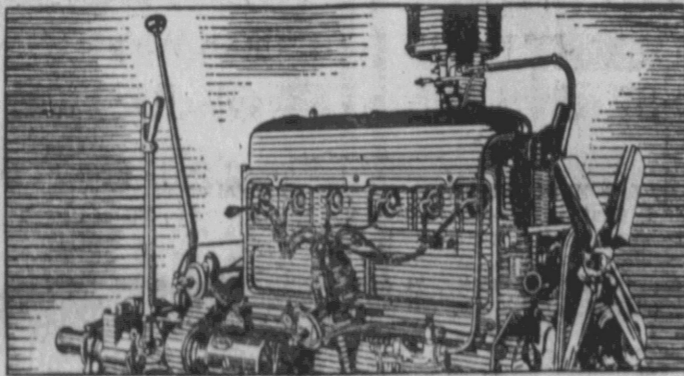

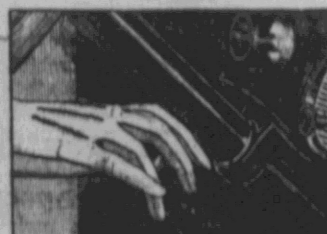

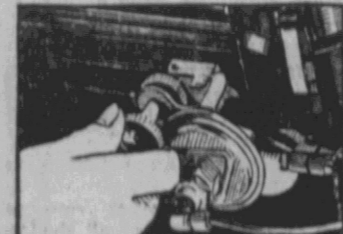

'Penny Auction' Speed Farm Mortgage Relief; Horses Sell For Quarter, Wagons For A Dime

Bowling Green, Ohio—(AP)—"How much an I bid for this cow?" "Two cents!" "I'm bid two cents—who'll give me four?" "Four cents!" "Sold!" To the farmer standing over there.

Thus go the "penny auctions" which Mid-West farmers originated as a means of "defating" indebtedness and which now have spread eastward to Ohio.

While national and State legislation is being pressed and the insurance companies have come forward with nation-wide moratoria on farm mortgages, the "penny auction" in Ohio has been aimed at preventing farmers from losing chattels and goods on which finance companies have advanced loans.

Two Sales Bring \$16.17 The situation has become most acute in the northwestern Ohio, where neighbors of Wallace Kramp bid in implements and livestock for \$14 that had been mortgaged for \$800, aid repeated the performance for Cecil Kistner, whose \$400 loan was "satisfied" for \$2.17.

In each case the property was returned to the borrower with instructions to keep it under a "99 year lease." At the Kramp auction a mortgage holder was warned not to bid while at the Kistner sale. A nose swinging in the barn-door was the subject of a great deal of jesting.

At these auctions announcement is made of other sales to be held by "the same company." Leaders of the movement usually start the auction by making speeches, and the bidding starts off at a brisk pace with a great deal of joking and shouting.

Two Cents Top Bids "Two cents, three cents," four or five will call out when the auctioneer puts up horse, cow, harrow or wagon.

Kelvinator Men Met Here Today The annual meeting of Kelvinator dealers from North and South Carolina was held here today with the Carolina Kelvinator Company, distributors for the district, as host.

New York Cotton New York, Feb. 15—(AP)—Cotton futures opened today unchanged to two points higher with offerings small and a fair trade demand.

When the bidding gets up to six cents—or perhaps a little more—there are shouts of "Sell it, sell it!" and the auctioneer cries, "Sold!"

The auctioneer enters into the spirit of the occasion, and inquires, "Don't you men know I am working on commission?"

"Terms strictly cash and no discounts," the clerk announces, and the successful bidders walk up then and there, give their names and hand over the change.

At the Kistner auction, the auctioneer "passed the hat" for the farmer.

Legal complications have entered into at least one of these auctions, while two finance companies have announced a sixty-day moratorium on foreclosures, with indications that other lending agencies may follow.

Although there is no formal organization, Ralph Weaver has taken a prominent part at sales held so far.

"My brother and I lost our \$40,000 farm after we had paid \$14,000," he explains. "The company had \$6,000 in it. We had our lives in it."

Hundreds of farmers in the section, Weaver says, borrowed to pay taxes and produce crops from finance companies when banks were unable to accommodate them.

These companies charge a higher legal rate of interest than do credit agencies to which the farmers have been accustomed.

Meanwhile, Dr. Carl Watson, member of a State board appointed by Governor George White, has selected six men to be known as the Wood County Farm and Home Protective Committee, to undertake debt conciliation. Similar groups are being urged elsewhere.

Y. R. Weitz, associate professor of rural economics at Ohio State University, has reported that mortgages are borne by one-fifth of Ohio farmers, many of whom are unable to meet the interest amounting to \$15,000,000 annually.
