Night Battle Marks Beginning Of New Jap Drive Against Chinese

Make Known Intention to Wipe Out Northern War Lord; Major Engagement Imminent

(By The Associated Press)
Following a night battle at the Jehol village of Chaoyangfu, thirty miles west of Chinchow, the Manchurian Japanese war machine moved into the Chinese province today while the Manchukuo government, established with Japanese assistance, prepared a twenty-four-hour ultimatum calling upon Chinese forces to withdraw from the province.

Although a war office spokesman at Tokyo described the battle at Chaoyangfu as an isolated affair, reports from other points bore out that a major offensive was imminent. The spokesman said: "Wait five or six days when the real show starts and the lid will be lifted."

A dispatch reaching Peiping from Mukden said at least two divisions of Japanese troops numbering about 20,000 were engaged in the Jehol drive. The Mukden dispatch said the cannonading during the night Chaoyangfu battle was plainly heard there and that the city was full of troops and warfare paraphernalia. Reports also reaching there of an engagement along the Chinchow Railroad at Kailu. The Japanese military command there said that the annihilation of the troops of Chang Hsio-Liang, North China war lord, had been decided upon and that he will hereafter menace Manchukuo. It was thought that the occupation of Tenstin and Peiping might be involved.

Reports from London told of the sale of a number of antiquated British ships to Japan for scrapping purposes, but there was much speculation as to whether they might be used for Far Eastern combat.

Geneva, Feb. 21.—(AP)—The League of Nations report condemning Japanese Manchurian policies and declaring against the recognition of Manchukuo was presented for adoption by a special League assembly this afternoon.

Foreclosure On Land Prevented

Greene County farmers in large numbers gathered to stand by a dispossessed farmer in Jason Township, when the news came that C. T. Mitchell was to be ejected from the farm on which he had lived many years and reared his family. The farm on which he lives is said to be worth \$10,000 in average time. Some years ago he gave a mortgage for \$2,800 on this farm to a merchant. It is a five-horse farm with 80 acres cleared. When the prices of products went down, Mr. Mitchell could not meet his payments. The mortgage was foreclosed and was bought in by the mortgagee for the amount of the mortgage. He then rented it to Mr. Mitchell. Last fall the new owner had an opportunity to sell it and gave notice to Mr. Mitchell that he must leave on December 15. When the notice was given Mr. Mitchell he said: "I will not get off the land this fall or any other fall. I have lived on it all my life and raised my family here and do not propose to be dispossessed."

The next step was that the new owner of the land applied to a magistrate in Snow Hill, who issued ejectment papers for Mr. Mitchell, and they were put in the hands of the sheriff to execute. The news spread in the neighborhood that the sheriff was coming out to put Mitchell off the land. Whereupon neighbors from Greene, Wayne and Lenoir to the number of between seventy-five and one hundred gathered and built a big bonfire on the farm and announced that they did not propose to permit the sheriff to eject the man from the place where he had lived all his life. A neighbor went to Snow Hill and told the sheriff about the bonfire and the gathering of the neighbors and that they had determined not to permit Mitchell to go to serve the papers, and negotiations were initiated by people who wished to have no trouble by which Mr. Mitchell could continue to live on the land and pay rent.

81 KILLED BY AN EXPLOSION AT SHANGHAI

79 Girls and Two Men Victims of Factory Blast; 120 Others Injured

Shanghai, Feb. 21.—(AP)—Eighty-one persons were killed, 120 injured and ten were missing today after the explosion of two gasoline vulcanizers in a Chinese rubber factory east of Shanghai.

Of the 120 injured, twenty were taken to hospitals while the remainder were only slightly injured. The figures appeared to be search total of the blast as rescuers virtually completed their search of the ruins. Police believed earlier that the toll might be two hundred. Of the dead, seventy-nine were girls and two men.

The bodies of the victims were placed in a vacant lot near the factory while relatives sought to identify them. Most of the bodies were badly burned.

ROTARY MEET LAST NIGHT

Prof. Carl Adams and Dr. R. H. Wright Address Weekly Meeting of Club

An address by Prof. Carl Adams, chairman of the community service committee, and an appeal by Dr. Robert H. Wright in behalf of more than forty students who will be unable to remain in college unless they receive outside help, were features of last night's Rotary meeting. The meeting was presided over by Rev. A. W. Fleischmann, club president.

Mr. Adams' address centered upon points of interest to the community welfare. He related in a graphic manner the story of the discovery of insulin and how it became a very material benefit to the welfare of man. Then a comparison was drawn between this work, and the resulting attitude on the part of the organized medical profession and another piece of work purposed to benefit mankind today. This work is being done by a former citizen of Greenville in conjunction with other fellow workers in the far west, and solely designed to aid in maintaining the health and recovery of men who suffer from one of the dread maladies with which men are afflicted. Yet, in spite of that effort, an attitude of pronounced opposition, and open fighting is assumed by the organized medical profession. It is a queer attitude on the part of those who ought to have men's welfare at heart. Another point of interest drawn to the attention of the hearers concerned the real attitude of most citizens toward the affairs of government. The major portion of the taxes is paid by a very small per cent of the people. To whom then shall the major portion of the power to operate governmental agencies be given? Only by constructive educational processes can we hope to have an intelligent approach to these problems.

Dr. Robert H. Wright, president of East Carolina Teachers College, presented the matter of the pressing need of the present hour to aid a large number of students financially. In order that they might remain in the school. The faculty of the institution will present three one-act plays this Friday evening with the purpose of securing such funds as may make it possible for these young people to remain in school. The whole-hearted support of the people of the city will materially help in accomplishing this purpose.

Secret Service Eyes To Guard Inaugural

Washington.—(AP)—On Inauguration Day, unless plans are changed, an automobile guarded more carefully than any gold-laden armored car will swing out of the White House drive promptly at 11 o'clock.

In it will be the man with one more hour to serve as the nation's chief executive, and at his side the man who is to fill that office for the next four years.

Behind the car which carries President Hoover and President-elect Roosevelt to the capitol for the inaugural ceremony will be two other automobiles—possibly more—filled with quietly dressed men whose eyes will search the faces of everyone along the line of march.

They will be the secret service men whose one duty is to guard the safety of the President. Fresh in their minds will be the desperate attempt made upon the life of the President-elect at Miami. They will be alert for the slightest suspicious movement in the crowds.

The attempted assassination at Miami, the capital assumes, will cause a redoubling of the intensive precautions which always surround the President, and which are never more thorough than at the inaugural ceremonies.

At noon, as President-elect Roosevelt takes the oath of office, the watchfulness will focus on him but take in also the slightest gesture of anyone close to him.

It is customary, after the inaugural ceremony, for one secret service man to accompany the outgoing executive to the train as a mark of courtesy. It is considered quite likely that this bit of etiquette will be something more than that this year, and that an enlarged detail will accompany President Hoover to his train.

The others of the secret service detail will escort the new President to the White House, and for the next four years will spend their waking hours not far from Franklin

Michigan Bank Holiday May Be Continued Longer

Detroit, Feb. 21.—(AP)—Michigan's extraordinary bank holiday ends officially tonight at midnight, but it is virtually certain that another proclamation by Governor Wm. A. C. Wood, in the meantime, will either extend the duration of the holiday or limit the amount that may be withdrawn from the accounts for a further period.

After intimating a definite announcement would be forthcoming last night, the governor postponed it when the State Senate failed to act on a House amendment of its own resolution designed to grant a financial dictatorial power to the governor. There seems to be no reason to doubt that the Senate will concur in the amendment today, thereby placing in the hands of the governor unprecedented power to keep banks closed or to limit withdrawals during an emergency that the resolution declares exists at this time.

Doughty Daladier Combats Budget

Paris.—(AP)—The French budget, that restless political force of explosive possibilities which has become the heritage of Edouard Daladier's new government.

Upon whether the new premier can tame the fractious thing depends, political experts say, the life of his regime.

Daladier, "bombaraded into the premiership" at the early age of 48, when a budget vote blew Joseph Paul-Boncour out of power, has a reputation for aggressive action.

He gained this while holding such varied portfolios as those of colonies, education, public works and war. He has been a minister six times.

In addition he was, from 1929 to 1931, president of France's largest and most aggressive "bourgeois" party, the Radical-Socialist.

Daladier got an early start in politics. Native of Carpentras, his career as a school teacher led him to Vaucluse, in the south. He soon became mayor of that city.

When just over 35, he was sent to the chamber of deputies for the first time in 1919. He has sat in the house ever since, being returned by the same constituency in 1924, 1928 and 1932.

His legislative and administrative exploits show an unusual range of interests. Among them are:

Reporting out and securing the adoption of the bill causing resumption of trade relations between France and Soviet Russia.

Authorship of a scheme for reorganization of the French army—which, however, met with disapproval from the general staff.

Sponsorship of a plan for compulsory education in continuation schools.

Providing free high school education for all poor youths deserving it.

Daladier has been a Herriot disciple during practically all of his political life. He once split with him over a question of internal party management, but that was later patched up.

Daladier supported the burlly mayor of Lyons in his stand on payment of the American debt installment, and went down with him to defeat on December 14, 1932. However, in secret cabinet meetings he is understood to have expressed some reservations as to his chief's attitude.

Despite long residence in Paris, first on the aristocratic Champs-Elysees and later in the silk-stocking suburb of Garches, Daladier remains a "home town boy" to the vineyard proprietors and peasants of his own Rhine valley. Whether minister, premier or just ordinary deputy, he has an ear ever open to their wants.

CUT SALARIES OF OFFICERS

Elective Officers, Jurors and Court Stenographer Get Wage Cut

In a special meeting yesterday the Board of County Commissioners put into effect a 10 per cent cut in the salaries of the county's constitutional officers and made cuts in the pay of jurors and the court stenographer.

At a former meeting a special committee was appointed to go into the matter of salary cuts with the elected officials and yesterday's meeting was to hear the committee reports and the court stenographer.

While the elective officers' salaries are fixed by statute the board asked whether or not in view of present conditions these officers would accept the cut, indicating that in case of refusal of the officers voluntarily accepted the cut, making the second of its kind in the past two years, having accepted a 10 per cent cut during last year.

The pay of the court stenographer, formerly \$10 per day, and expenses with provisions that she was entitled to a week's pay if the session lasted but one day, was changed to \$5.00 per day and expenses not to exceed \$2.00 per day with provision for payment only for the number of days worked.

The pay of regular and talsman jurors was reduced from \$2.50 per day to \$2.00 per day, with an allowance of five cents per mile to and from their homes provided.

Enough Legislatures In Session to Ratify Prohibition Repeal Bill

Washington, D. C., Feb. 21.—(AP)—Fifteen States spurred on by a desire to be the first, today definitely set out on the road toward repeal of the prohibition amendment a few hours after Congress put the question to them. President-Elect Franklin D. Roosevelt gave encouragement within a few moments after the House Monday with a fifteen vote margin voted to let the people decide whether prohibition should prevail as a law of the land after thirteen years trial and controversy.

But with his expression of gratification at the House concurrence with the Senate the President-elect interpolated further hope that the present Congress in its dying days would fulfill another Democratic platform pledge by legalizing beer.

Enough legislatures are now in session to strip all the liquor laws from the Constitution except that provided for in the new amendment which protects dry States against the importation of intoxicants. Forty-two are now meeting and two more, California and Florida, convene in the spring. Only Louisiana, Mississippi, Virginia and Kentucky will not meet for a year or more.

Wyoming was way ahead of the rest of the country, for its legislature has already passed and its governor signed a bill to provide for the constitutional convention. Other States in which the action has begun in some quarters are Massachusetts, New York, Ohio, Wisconsin, Georgia, New Jersey, West Virginia, Arizona, Missouri, Delaware, California, Michigan, Iowa and Pennsylvania.

Washington, D. C., Feb. 21.—(AP)—Edward B. Dunford, general counsel for the Anti-Saloon League, said today that his organization would immediately challenge in the court any law passed by Congress to set up or regulate State conventions to vote the repeal of the Eighteenth Amendment. Dunford expressed the opinion that the conventions provided by the State legislatures would be constitutional, but stated that they would challenge the constitutionality of any act of Congress to establish the conventions.

The measure for Congress to set up the conventions is now pending in the House and leaders vary in their opinions as to the method the writers of the Constitution intended should be taken in establishing the conventions.

SEES DELUGE OF RUM IN EVENT OF REPEAL

x Cary, N. C., Feb. 21.—"It would take over forty-five rows of automobiles eight feet apart stretched clear across the continent, each containing one hundred gallons of liquor to transport the yearly consumption, if the present population drank as much per capita as government figures say was consumed per capita in 1917," said Miss Lily Grace Matherson, national field secretary of the W. C. T. U., who spoke in Cary Methodist Church on Sunday evening, February 19, "and yet they tell us there is more drinking now than before prohibition."

Miss Matherson gave a short sketch of the origin of the W. C. T. U., which is now nearly sixty years old and is operating in fifty-two nations.

"It has always stood for child welfare and religious ideals," she said, "as she told how alcohol injured mind and morals. 'Prohibition is not a political issue, but a moral one, and whoever disregards the Eighteenth Amendment is disloyal to his country and to his God. Other nations are working toward what the United States has already accomplished and are looking toward our country as a beacon light. Shall we fall them by going backwards?'"

Miss Matherson returned to Cary this afternoon for a conference with a group of women from the different churches for further discussion of the subject.

COMMUNITY GARDEN PLANNED AT OXFORD

Oxford, Feb. 21.—Preliminary plans for a community garden project to aid in feeding destitute town families during the summer and winter months and a shifting of town families with farm experience to rural sections, were made at a meeting of welfare committees with agricultural leaders and town officers held in the court house Saturday afternoon.

The committee expects to develop a plan under which no application will be given and unless he has shown some effort by March 15 to ward beginning a garden to grow his own food and feed during the spring and summer.

Hundreds of persons jammed the hall of the House to capacity before the formal legislative session while dry leaders of the state urged the House judiciary committee No. 1 not to consider a change in the state prohibition laws without submitting the question to a vote of the people.

The committee took no action on the proposals now before it including legislation for taxation purposes of beer and wines without a referendum, submission of the question to the voters of repeal of the prohibition laws, and consolidation of the question to a vote of the people.

For many years we have contended that if North Carolina is to get on its feet financially it must, in addition to cutting expenses, get its chief revenue from the sources most able to pay. The News and Observer under the heading "Why The Big Deficit?" hits the nail squarely on the head, and we pass on the following editorial to our readers with our utmost approval:

Why is there a big deficit in the State Treasury?

1. The answer is plain. Because for ten years the State has given immunity from taxation of any kind for \$196,000,000 of the most valuable and best-paying property in the State.

2. Because, while South Carolina collects hundreds of thousands of dollars annually in a production tax from the power companies, North Carolina gets nothing, nothing, nothing. The Mellon concerns, for example, do not sell power. They generate it. The present emergency affords an opportunity for them and other prosperous power companies to pay the same character of tax that South Carolina levies. The only reason this tax has not been levied all these years is because the power companies have been given special privilege.

3. Because the Legislature two years ago failed to levy a tax on tobacco, soft drinks, moving picture shows and other luxuries. Why didn't they levy it? The answer is plain. Because the tobacco and betting and picture corporations and their attorneys and lobbyists had more influence than the people.

This year lobbyists are not seen in the open, but they are not idle. The powerful and rich organizations are resolved, no matter what happens, that no new taxes shall be levied on power, tobacco, soft drinks, moving pictures or other luxuries and non-essentials unless the identical percentage tax is levied on popcorn and coffee and the articles which are bought and used by the poor. They won in 1931 and are chiefly responsible for the present big deficit. If they win again, who can predict that it will not result in an unbearable burden on merchants or a tax too heavy on those least able to pay it?

"Ability to pay" is the only sound rule of taxation.

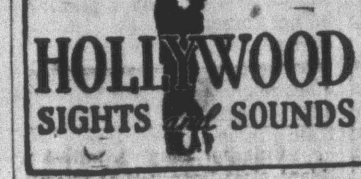

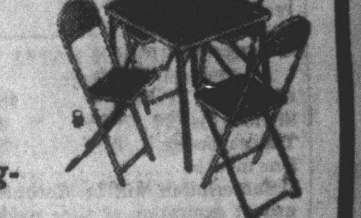

POLITICS

President-elect Roosevelt established something of a record for keeping his own counsel during the six weeks preceding his inauguration.

At the hour President Hoover signed the proclamation calling the Senate into special session March 4 for the purpose of inducting Vice President-elect Garner into office and of confirming the Roosevelt cabinet slate no names but that of Democratic National Chairman James A. Farley were certain on that slate.

Whether Mr. Roosevelt could have surrounded his cabinet plans with as great a mystery had he not gone as far as dodging the reporters and politicians completely for 10 days is to be doubted. It was a happy device for that purpose.

Out of this blank wall as to Roosevelt appointments generally as well as out of intimations from supposedly authoritative sources grew the notion that it might be quite a while before the wholesale job of filling federal political vacancies was well under way.

The natural construction put upon all this was that Mr. Roosevelt and his advisers contemplated using the "cease and desist" program at the special session so soon to follow his inauguration. That has been a powerful weapon in presidential hands in the past.

Yet the history of President Taft's record in that means of compelling congressional action shows the danger that lurks in any such effort to drag a reluctant house or senate into following presidential commands.

It should be recalled also, that President Taft invoked the patronage club when only a handful of insurgent house members were to be dealt with. He had no such party majority in either house as President Roosevelt will know.

That special session of the first Roosevelt congress will have Democratic party majorities of 22 in the senate and 191 in the house. In addition there are perhaps a dozen senate votes, nominally Republican, to go along with Roosevelt reconstruction policy bills at the start of it. A similar situation exists in the house.

Anti-Prohibitionists Stir Brookhart To Old-Time Fight Spirit

Washington, D. C.—It had begun to look as if one of the Senate's most colorful figures—Smith Wildman Brookhart—might wind up his period of service on Capitol Hill without having an opportunity for an opportunity for another of his characteristic displays of fighting spirit.

For some reason the Iowa Senator has been rather quiet since he returned to the Senate after being twice defeated for re-election. Illness kept him absent much of this session, and what time he has been present he has remained more or less in the background.

But just as the short session was nearing the end his opportunity came. The Blaine resolution looking toward repeal of the Eighteenth Amendment was just the kind of thing to set him off.

Sheppard, of Texas, co-author of the amendment, was the first to jump into the fray, but Brookhart was doing his part.

It was Brookhart who sidetracked all attempts to get an early vote on the repeal resolution. He met the first request for an immediate vote with the statement that it would take two weeks after March 4 to answer all the statements made by anti-prohibitionists on the "booze" question. And he objected to the second request on the ground that "it is just a little bit worse than the first."

Thus it was the Iowa who paved the way for the mild-mannered Sheppard to pick up his speech on the League of Nations that he began ten years ago and outlined to fewer than half a dozen Senators in a conversational tone the whole history of that organization.

Under Their Control Brookhart and his allies must have chuckled at the position in which they found themselves. It was ideal for throwing out the threat of a filibuster.

FACTS ON FILING INCOME TAX RETURNS

Washington, D. C.—Feb. 16—(AP) The phalanx of the nation's most well-to-do—the income taxpayers—are marching by the government's coffers these days thumping in their dollars.

In the last fiscal year, ending June 30, 1932, they paid \$1,057,000,000 compared with more than twice that amount in 1929. For the present fiscal year ending June 30, 1933, government estimates put receipts at \$690,000,000.

Exemption have been lowered this year to bolster the falling receipts. In 1932, single persons had an exemption of \$1,500, and married persons, an exemption of \$3,500. These have been reduced to \$1,000 and \$2,500 respectively.

Retires To Be Increased These rates probably will add two to three millions to the total number of returns, but may not materially raise the number paying since incomes, both corporation and individual, have declined considerably.

If you fall in any of the three following classes you must file a return, although exemptions and deductions may save you from paying a tax:

- (1) All single persons having a net income of \$1,000 or more. (2) All married persons having a net income of \$2,500 or more. (3) All persons and businesses having a gross income of \$5,000 or more, regardless of net income.

Net income is income after deduction of expenses necessary for running a business, such as cost of goods, salaries paid out, office expenses and so on. Gross income is income before these expenses. Wage and salary receivers generally have no such expenses so that the salary or wage is next income.

A traveling man however, who paid his own expenses and was not reimbursed for them by his company might deduct them from his net income.

Many Claiming Exemptions Never before, tax officials say, has the public been so anxious to take advantage of every possible exemption, looking for deductions that would have been passed over hurriedly not so long ago as inconsequential.

For the purpose of indicating possible exemptions and deductions, consider, for example, a single man receiving a net income of \$1,500 and a married man receiving \$3,000. Each would first take his personal exemption of \$1,000 and \$2,500 respectively, leaving a taxable net income in each case of \$500.

A single person may also be the head of family and be entitled to favor, all such federal taxes which the married person receives. A bachelor supporting his mother in his own home or other dependents would be the head of a family. He may further claim \$400 additional exemption for such dependents.

Exempt \$400 For Dependents Likewise the married man may deduct \$400 for each of his dependents. Suppose however, that neither of the income receivers in this example had dependents. They would then have a taxable income of \$500. This may be reduced by other deductions.

The taxpayer, for example, gives to his church perhaps a dollar a week, or a deduction of about \$50, leaving \$450 taxable income. Other deductions include amusement taxes, electric power taxes, in fact, all such Federal taxes which are paid by the consumer and not by the manufacturer.

Josephus Daniels, Raleigh publisher, urged the committee to make provision for the current legislature to submit prohibition to the people and for the convention on the proposed federal resolution passed by Congress yesterday, while Dr. William L. Poteat, president-emeritus of Wake Forest College, told the committee that passage of the Murphy-Bowie bill legalizing beer and wines meant the return of the saloon.

The House Appropriations Committee submitted a tax penalty bill which abolishes penalties up to the date of tax sales and allows counties and municipalities to arrange for redemption of land sold for taxes during the past five years at 6 per cent interest since the date of the certificate.

The Senate sent back to the House the much amended measure amending the present laws requiring physical examination for persons applying for marriage licenses. The House passed the bill to repeal the present statute while under the Senate bill the applicants may either file an affidavit that they are free from disease or take a physical examination. This would also apply to couples going out of the state to get married but who expect to return to the state to live.

Without much ado the Senate dealt the Corey bill to require a state automobile driver's license. The measure was defeated by a vote of 28 to 21. The measure included a mandatory jail sentence for convicted drunken drivers.

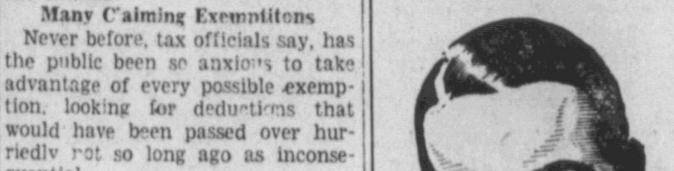
