WET AND DRY JAPANESE HALTS FIGHT LOOMS IN HER DRIVE IN THE SOUTH TOWARD JEHO

Dry Organizations Being Formed Throughout The Southern States

Atlanta, Ga., Feb. 23.—(AP)—Prohibitionists and anti-prohibitionists in the South are girding for the conflict over the proposed repeal of the Eighteenth Amendment. Militant dry organizations have been formed on a State-wide basis in Tennessee, Alabama, Mississippi, South Carolina and Georgia and plans are being made to organize other States, many of which have been bone-dry for years.

Meanwhile the legislatures in North Carolina, South Carolina, Arkansas and Georgia have taken steps toward putting into effect the Congressional provisions provision for conventions to ratify or reject the repeal with delegates to be named at the ballot boxes.

The battle lines will be drawn by both sides in this contest. Many prohibitionists have expressed the opinion that the South will remain dry. Anti-prohibitionists generally are said, however, to believe the people want a change and so far little has been done toward perfecting fighting units, but their leaders still have time.

Ultimatum Is Delivered To Chinese Nationalist Government At Nanking

Mukden, Manchuria, Feb. 23.—(AP)—Strong indications that the Japanese have postponed their offensive into the Chinese province of Jehol until the League of Nations passes upon recommendations which have been drawn up concerning the Manchurian dispute, were seen today in the lull in preparations to occupy Peipiao. In addition there were heavy storms in Jehol province in southern Manchuria. These were impending preparation movements for the offensive.

Meanwhile hope was expressed by optimistic Japanese leaders that a peaceful settlement of the Jehol problem could be obtained. One section of the Japanese forces, advised stated, halted temporarily 150 miles south of here. The other section of the Japanese offensive pointed toward Kailu, the northeastern gateway to the province. Bombing planes accompanied the latter.

Shanghai, Feb. 23.—(AP)—Japan officially informed the Chinese National Government today that unless the Chinese troops withdraw from Jehol Province the Japanese and Manchukuoan forces will expel them forcibly. S. Ueyamura, acting Japanese Consul-General at Nanking, informed Lo Wen-kan, Chinese Foreign Minister, of the demand.

Favor Measure To Incorporate Bar Association

Raleigh, N. C., Feb. 23.—(AP)—A bill to incorporate the North Carolina Bar Association received a favorable report today at the hands of the House Judiciary Committee No. 1. The bill provides for a council composed of the Chief Justice of the Supreme Court and six members of the bar to hear all cases of disbarment of members. The defendant may appeal to a Superior Court judge but will not be allowed a trial by jury.

Grounds for disbarment include commission of a criminal offense, solicitation of business and any other unprofessional conduct. The committee set the membership fee at \$3 while the original bill called for a fee of \$5.

ALASKA PORT SEVERE TO BE BASE OF FISHING FLEET

Ketchikan, Alaska.—(AP)—Enactment by the State of Washington of an income tax law may result in the eventual transfer of the Alaskan fishing fleet's winter base from Seattle to this port.

Ketchikan interests are organizing vocational and recreational winter-time pursuits to encourage the move. But outfitting here the fishing industry would escape the payment of the income tax.

Lame Ducks Can't Take All Blame In Congress

When the time comes finally to clear away the debris of the depression, and consider political readjustments to make future depressions less painful, one question certain to arise is what to do about Congress.

Already there is a widespread conviction that the manifest failures of the present session have not been due entirely to temporary causes, but have involved weaknesses inherent in the system.

The first impulse was to blame everything on the "lame ducks," with the consoling reflection that this would be the last "lame duck" session and that the new amendment to the Constitution would make a repetition of the legislative follies of 1932-1933 impossible.

The fallacy of that is that the figures who have loomed largest on the stage have not been repudiated at the polls, but men only recently commissioner or re-commissioned in public office.

Those in the key positions on committees dealing with budgetary matters, for instance, nearly all appear more or less permanent fixtures on Capitol Hill. Certainly Speaker Garner can be called a "lame duck," nor Senator Joe Robinson; nor, for that matter, Huey Long nor Louis T. McFadden.

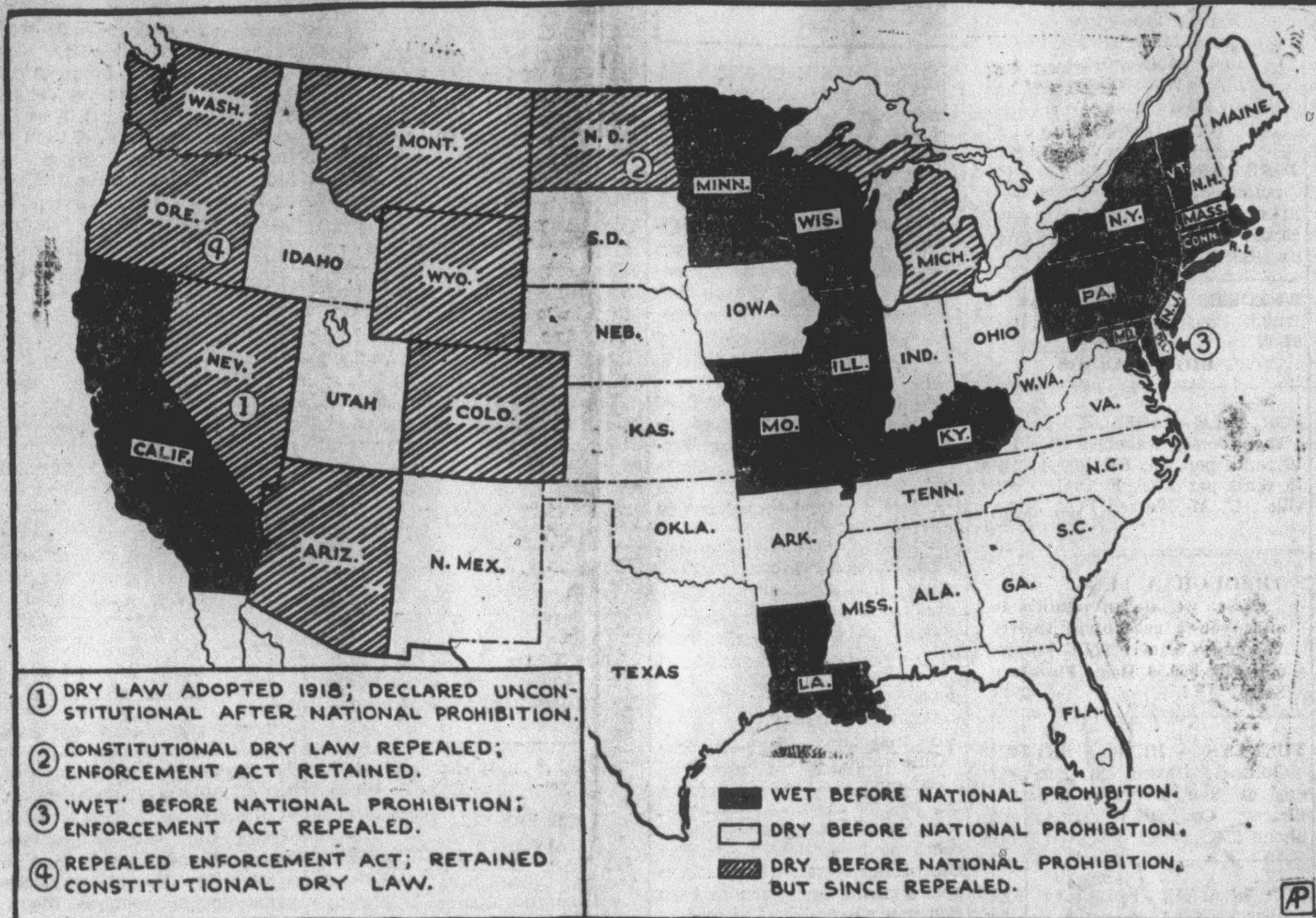

SUBCOMMITTEE TO REPORT NEW LIQUOR BILL

Measure Providing Medicinal Whiskey In This State Gets Favorable Vote

Raleigh, N. C., Feb. 23.—(AP)—A General Assembly sub-committee was today ordered to report legislation dealing with prohibition repeal or modification in North Carolina as the House Judiciary Committee No. 1 favorably reported the Murphy bill to legalize medicinal whiskey for this State.

The House Judiciary Committee directed Representative Grant, of New Hanover; Murphy, of Rowan, and Martin, of Buncombe, to take the various bills they now have on the wine, beer and whiskey card, draft them into one or more new measures to be submitted to the full committee.

A favorable vote on the Murphy measure which proposes legalizing medicinal whiskey on the same terms as now allowed by the Federal government came without discussion. It was generally agreed that any measure drafted by the sub-committee would include provisions that any proposed change in the State prohibition laws must be submitted to a vote of the people before it can become effective.

Campbell Ready To Return Home

Daytona Beach, Fla., Feb. 23.—(AP)—Sir Malcolm Campbell, British racing driver, who yesterday hung up three new world's speed land records, announced definitely today that he would make no more trials here this year and would leave for New York Tuesday to sail for England March 3.

NEW LOANS ARE MORE LIBERAL IN PROVISIONS

Washington, Feb. 23.—Senator Bailey said today that North Carolina's record in dealing with the Reconstruction Finance Corporation is as good as that of any other State and better than a majority of them. The State borrowed approximately \$26,000,000 and returned \$11,000,000.

Under the amended act, the so-called Wagner bill, the state will get more money and Senator Bailey thinks that it should be ready to demand a fair share of the additional funds, and to take advantage of the more liberal provisions.

The new act eliminates the self-liquidating feature, and that makes it much easier for states, cities and counties to get funds for needed projects for the public good.

Ads Boost Fruit Sales

Los Angeles, Calif.—(AP)—In celebrating what is termed its "silver anniversary of advertising," the California Fruit Growers' Exchange announced it has virtually created a market for five times the volume of citrus fruits it marketed twenty-five years ago.

DEFECTIONS FROM DRY LISTS WEIGHED BY OPPOSING CAMPS AS FACTOR IN COMING BATTLE

Washington.—(AP)—The prohibition question, put back on the doorsteps of the state by Congress' passage of the resolution to submit to the states to repeal the eighteenth amendment, will find changed attitudes in some states after 19 years of the dry law, if legislation during that period is any criterion.

When national prohibition was ratified January 16, 1919—one year before it took effect—32 states were "dry" in the sense that they had constitutional or statutory measures against the liquor traffic. Since then, eight of these states have taken various kinds of action that anti-prohibitionists interpret as indicating a shift from "bone-dry" sentiment.

States which had some kind of state law against liquor traffic when prohibition was placed in the constitution and hence were officially "dry" were: Alabama, Arizona, Arkansas, Colorado, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Maine, Michigan, Mississippi, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, Washington, West Virginia, Wyoming.

Since then, Arizona and Colorado have repealed dry laws from their state constitutions; Michigan repealed the dry law in its constitution, and provided for a commission to control liquor traffic after repeal of the 18th amendment; Montana and Washington have repealed dry laws from their statutes; Nevada's statutory dry law adopted in 1918 was declared unconstitutional in 1926; North Dakota has repealed the dry law from its constitution but retains a state enforcement act; Oregon has repealed its state enforcement act but retains a dry law in its constitution. Delaware's constitution provides for local option and under this law all of the state but Wilmington was dry when national prohibition was adopted. Later Wilmington also went dry. A state enforcement act was adopted and later repealed.

History of the prohibition situation by states since adoption of national prohibition follows: Alabama: Has retained its statutory dry law. Arizona: Constitutional dry provision repealed by referendum Nov. 8, 1932. Arkansas: Has retained its statutory dry law. California: Wet before prohibition, so far as state laws were concerned. State enforcement act repealed by referendum Nov. 8, 1932, and provided for state liquor regulation when and if lawful under U. S. laws. Colorado: Constitutional dry law repealed by referendum Nov. 8, 1932. Connecticut: Wet before prohibition, so far as state laws were concerned. Now has state prohibition enforcement act. Dred repeal in referendum Nov. 8, 1932. Delaware: Has repealed state prohibition enforcement act, though state went entirely dry under local option after 1919. Florida: Has retained its constitutional dry law. Georgia: Has retained its constitutional dry law. Idaho: Has retained its constitu-

BANKERS HOLD MEETING HERE

Group One Annual Meeting Concluded With Banquet Last Night

Bankers from thirty Eastern North Carolina points gathered here yesterday in the eighteenth annual convention of Group One of North Carolina Bankers' Association. The convention began with registrations at Proctor Hotel early yesterday afternoon followed by a business session in Sheppard Memorial Library and concluded with a delightful banquet at the Woman's Club last night, at which Charles M. Johnson, treasurer of North Carolina, delivered the principal address.

The afternoon session was presided over by D. E. Oglesby of Farmville, retiring chairman, and the meeting was taken up with a round table discussion of banking problems, hearing of committee reports and other business, including the election of officers for the ensuing year. Paul P. Brown, secretary of the North Carolina Bankers' Association, addressed the meeting on pending legislation and its effect upon banking and the State.

The following officers were elected: Chairman, W. E. Griffin, cashier of the Citizens National Bank of Elizabeth City. Vice-Chairman, John Mitchell, cashier State Bank and Trust Company, Greenville. Secretary-treasurer, Wm. H. Hardcastle, assistant cashier, Hertford Banking Company, Hertford. J. H. Waldrop, cashier Greenville Banking and Trust Company, was elected district committeeman to the North Carolina Bankers' Association.

The banquet at the Woman's Club was an affair of much enjoyment and merriment, with Prof. R. C. Deal, of the faculty of East Carolina Teachers College, acting as toastmaster. Orchestra music and vocal solos by Miss Fenbur of the college, accompanied by Mrs. R. A. Tyson, Jr., added to the occasion.

Following a four-course banquet, there were short addresses by the outgoing and incoming officers. Next came a short address by Dr. R. H. Wright, president of East Carolina Teachers College. The speaker of the evening, Hon. Charles M. Johnson, was introduced by Mayor R. C. Flanagan. Mr. Johnson went into details of the affairs of State and gave much refrain from demanding more in the way of State help and State functions than they can afford to pay for in the way of taxes. He reviewed the financial situation and declared that North Carolina's credit was still good and would remain so for he felt confident that the present Legislature would succeed in balancing the budget. He paid tribute to the men who compose the present General Assembly and declared that when they have finished their job the State would realize that they had performed a tremendous undertaking and performed it well and to the interest of the State as a whole.

PRES.-ELECT PICKING MEN FOR KEY JOBS

ROOSEVELT BUSY WITH TASK OF CHOOSING ASSISTANTS TO CABINET OFFICERS

Hyde Park, N. Y., Feb. 23.—(AP)—In the seclusion of the family estate on the Hudson River, President-elect Roosevelt is scanning the Democratic list of the multitude of men and women he must pick to take over key positions of the government after March 4. He has a long list from James A. Farley, National Chairman, who is superintending the patronage.

Many names becoming definitely fixed in the line-up are as follows: William Phillips, Massachusetts, appears to be the probable choice for Under-Secretary of State, and Professor Raymond Moley, war debt expert, is expected to be the First Assistant Secretary of State. In the Treasury Department Howard Bruce, of Maryland, is regarded as the probable under-secretary. Arthur O'Brien, of Washington, is in line for Assistant Secretary there. Under Postmaster James A. Farley, James O'Mahoney, of Wyoming, and William H. Howe, of South Dakota, are expected to serve as first and second assistants respectively.

TENNIS STAR TURNS DOWN INVITATION TO WIMBLEDON

Johannesburg, South Africa.—(AP) Induce Mrs. Bobbie (Heine) Miller to change her mind and accept the official invitation to represent South Africa in the Wimbledon tennis championships in June. She declined the first invitation to captain the team.

In view of her successes against the touring British team this winter, South African selectors are most anxious to include Mrs. Miller in the team for Wimbledon.

WAYNE COUNTY NEEDY WILL PLANT GARDENS

Goldboro, Feb. 23.—Efforts are being made by civic and relief organizations of Goldboro to promote gardening among families of the needy and unemployed.

At ten o'clock Wednesday morning, Charles A. Sheffield, assistant director of agricultural extension of State College, Raleigh, spoke in the community building in Goldboro about the growing of gardens. He told of the possibilities of individual and community gardens in helping to carry out the relief program of the state. He told what is being done in other places and what may be done in Wayne county.

Textile Grades Hold Positions Raleigh N. C., Feb. 23.—A recent survey reveals that six graduates of the Textile School of N. C. State College hold positions as presidents of Southern textile concerns, and 389 men who hold degrees from the Textile School, more than 70 per cent are now connected with some branch of the textile industry.

MAY RE-OPEN PROBE INTO BERN'S DEATH

New Investigation Into Death of Jean Harlow's Husband Now Apparent

Los Angeles, Calif., Feb. 23.—(AP)—A re-opening of the investigation into the death of Paul Bern, motion picture producer and husband of Jean Harlow, screen star, appeared likely today, as a result of a secret investigation started by two members of the grand jury.

The jurors, acting upon their own initiative, have obtained a copy of the transcript of the inquest into the death of Bern and have been studying it several days, it was learned. New information received by the two from a private source is reported to have been the incentive for the present study of the circumstances surrounding the producer's death.

District Attorney Huron Pitts said he knew of no reason why the investigation of the case should be reopened.

TRUCK DRIVER GETS JUDGMENT FOR \$10,000

Jury Gives Second Judgment Against Truck Company As Result of Accident

A dozen cases were disposed of in yesterday's session of Civil Court being held here this week with Judge J. Paul Frizzelle presiding. While the cases all were of more or less importance, the majority of them consumed only a short time for hearing which enabled the court to dispose of so many in one day.

The major case on yesterday's docket was that of Marvin Bethea, colored, against Smith and Best, operating as the Smith Transfer Company, in which Bethea was awarded judgment for \$10,000 as a result of injuries received in the truck collision near Franklin, Va., in which Sheppard Smith, of Farmville, met his death. In Monday's session of court the administrators for Sheppard Smith's estate were awarded judgment of \$20,000 against the truck company. Bethea was driver of one of the company's two trucks that figured in the accident.

Other cases disposed of yesterday were as follows:

Mrs. Sadie Oakley was granted divorce from Tom Oakley. Gurney P. Hood, Commissioner of Banks, in a case of First State Banking Company against W. L. and Pearl D. Lyons was awarded judgment of \$24.03 with interest from March, 1931.

Scotland Neck Building Supply Company was awarded judgment of \$970.63 against E. J. Conklin with provision that if defendant paid \$100 each six months for a two-year period totaling \$400 the judgment would be considered satisfied in full.

A claim of Riverton Lime Company against Forbes Hardware Company was non-suited in view of the fact that the parties had already been discharged from bankruptcy. Acme Candy Company was awarded judgment of \$93.10 against J. L. Brown.

Mrs. Virginia H. Joyner and husband, W. E. Joyner, were awarded judgment of \$2,336.50 against the North Carolina Mortgage Company and the Jefferson Trust Company.

Farmville Oil and Fertilizer Company was awarded judgment of \$437.11 against R. L. McLawhorn. The case of Joe Joyner and Vini Smith against King Mutual Life Insurance Company, when called for hearing was reported to have been settled out of court. The amount of settlement was not made known.

J. J. Perkins was awarded judgment against Mrs. Nancy Elks and others in the sum of \$343.16. L. G. Cooper, receiver for Greenville Supply Company of this city, made his final report to the court and the receivership was discharged.

Students Trade With College

Raleigh, N. C., Feb. 23.—A number of students at N. C. State College sell enough farm produce to the college dining hall each year to pay a large part of their expenses, according to L. H. Harris, steward at the college.

Harris prefers to trade with students who have produce to sell and always gives them refusal in contracting for college foodstuffs. Last year, he says a student supplied the college with all the meal it used and this year he expects to buy virtually all the sweet potatoes, meat, chickens and eggs from boys now enrolled at the college.

FOUR ARE HELD FOR ROBBERY

One of Robbers in Hospital Nursing Shotgun Wound in Back

Two women and one man were held in jail here this afternoon pending arrangement for bond and another man is in a Kingston hospital with a shotgun wound in his back as a result of the robbery of Niles Manning at his filling station in Swift Creek township east of Grifton Tuesday night.

A habeas corpus proceeding before Judge J. Paul Frizzelle, presiding over civil court here, during the noon recess of court failed in its effort to get the three held here released from responsibility in the crime and the bonds of the two women were placed at \$500 each while that of the men were placed at \$1,000 for appearance at the April term of criminal court here.

Those held are Frank Banks, in Kingston hospital, bond \$1,000; Blanche McGowan, former resident of Vanceboro, bond \$500, and Helen Parron, bond \$500. Relatives of Banks were present for the hearing today and it was expected that they would arrange for bond for him in order that he might be removed from the hospital as soon as his condition would permit. Mrs. Johnson, wife of the other man in the case arrived in court just the hearing ended and whether or not she would arrange bond for her husband was not known early this afternoon.

According to reports of the affair the two men, former operators of a night club in Norfolk, accompanied by the two women, former employees of the club, called at Manning's filling station Tuesday night with the statement that they wished to see his son with reference to selling him some bonds. The son not being present, the quartet began a drinking and petting party and Manning invited to join in accepted the invitation. Blanche McGowan said that after the party had progressed for some time Manning made advances to her and offered her money to spend the night with him.

It was a little later as the McGowan woman sat upon Manning's lap that one of the men is charged with hitting him over the head and robbing him of \$147.00 in cash.

Manning not being completely knocked out, a scuffle followed in which he procured his shotgun and fired at Banks as he fled from the filling station. Immediately following the shooting the others in the party fled and were later arrested.

Late News Flashes

Today In The Legislature.

Raleigh, Feb. 23.—(AP)—Abolishment of the present Corporation Commission was voted today by the upper division of the North Carolina General Assembly and finances and prohibition dominated the other legislative business. A lengthy debate again preceded the action on the substitute measure to do away with the corporation commission of three elective full time members and replace them with one elective full time utilities commissioner and two appointive associate commissioners to serve on a per dem basis when needed to sit on a hearing. The passage came on a 34 to 11 vote and the bill went to the House which

deferred action on a similar bill on its calendar.

The House passed several minor state-wide bills in a long session. One would create a commissioner of pardons and paroles to replace the executive council already abolished by the legislature.

A joint meeting of the two finance committees voted to try to reach a decision this afternoon whether the revenue bill is to be based upon an eight months school term and able to decide whether a general sales tax or a commodity tax would be included. Reports outside the state committee meeting was that it was likely a general sales tax on retail (Continued on Page Four)

SMITH BILL SHOULD BECOME LAW

The House Agriculture Committee did well yesterday to approve the Smith bill that would provide for a government pool of cotton for the farmers as an incentive to less production this year in the hope of increased prices. Now Congress can do its part by pushing this matter through its final passage. If the measure is to be of any real benefit to the farmer this year it must have immediate attention and despite reports to the contrary we sincerely hope that the measure will receive the presidential approval. There are but a few more days left before the present session of Congress comes to an end and unless the House acts at once there will not be time for re-passage in case of a presidential veto.

IT WILL HELP

Approval yesterday by the House Coinage Committee of a plan for the United States Treasurer to purchase a quarter of a billion dollars worth of silver to be made into silver dollars upon which new currency is to be issued, is in our opinion, a step in the right direction toward increasing the circulation of money at this time. A quarter of a billion dollars more money should certainly have a tendency to help ease the present financial situation a little at least.

LET US HOPE SO

The statement by State Treasurer Charles M. Johnston here last night that he was confident that the Legislature would balance the budget, straighten out the present financial tangle and be ready to adjourn within another three weeks, is certainly good news to most of us. It is to be hoped, however, that in so doing the legislators will not find it necessary to put into effect a general sales tax in this state. There are too many sources able to pay, for the poorer class of our people at this time to be burdened further by a tax upon the necessities of life. No doubt the passage of the sales tax would prove the easiest way out for the legislature but, as we see it, there is also a right way and while the right way might be the harder route for the legislators we again urge them to follow this route by "getting the money where the money is."

Lawrence P. Jacks in his book on "Education Through Recreation," predicts a great recreational university in which the whole man can be educated. The brief review of Dr. Jacks' book brought out the fact that happiness must come from within, the creative part awakened, the skill-lunger satisfied and not by happiness poured in from the outside, like the filling up of an empty barrel.
