Japanese 'Big Push' To Run Chinese From Jehol Under Way In Full Swing

Offense Carried on From Three Points; League Nations May Ask Arms Embargo Against Japan

(Associated Press) Japanese military commanders said the "big push" to wrest Jehol from Chinese rule began today, and that its offensive drives into the province were increased from two to three, Chaoyang, second largest city of Jehol Province, fell and the army in that sector continued to advance toward Jehol city about 150 miles to the southeast. The Japanese reported using bombing planes for the first time, although Chinese reports said bombarding of the city from the aid had gone on for three days. The new advance midway between the two main advances was reported to have been launched from Changwu toward Cuocong, 700 miles southeast of Kailu, the northern offense occupying Kailu, 250 miles northeast of Jehol city. Reports said the Japanese met no opposition. A new League of Nations committee charged with carrying forward an attempt to settle the Sino-Japanese dispute, discussed a concentrated arms embargo on Japan and there were many expressions of approval. The Japanese cabinet decided to consider the question of the world's disarmament, economic and labor conferences separate from its decision to secede from the League of Nations. General Nobuyoshi Muto, Japanese supreme military commander and diplomatic representative in Manchuria, warned the Chinese military rulers that if he cared to assume an aggressive attitude against the Japanese army the warfare may spread south of Jehol.

COURT STILL IN SESSION TODAY

Lumber Company vs Fleming Suit Proves Long Drawn Out Affair

The progress of the term of civil court here under Judge J. Paul Prizzelle was slowed down yesterday by the Northside Lumber Company vs. Mrs. Louisa Fleming suit, the case taking up practically the entire day and being resumed this morning.

Prior to the beginning of the Lumber Company vs. Fleming case the court granted C. L. Farmer a divorce from his wife, Eva Farmer, and rendered a judgment against Metropolitan Life Insurance Company of a monthly annuity of \$20 in favor of L. A. Stocks during the period of his disability.

The lumber company case against Mrs. Fleming is the outgrowth of a contract she had with the lumber company for repairs and remodeling of a house. The plaintiff is suing for \$1,150 while the defendant claims that payment was refused because of failure of the lumber company to carry out its contract resulting not only in great delay causing loss of rents but in inferior work and materials, resulting in having to rent the house for less money when it was ready for occupancy. The defendant has set up a counter claim against the lumber company of around \$2,000.

Witnesses for the plaintiff consumed all the court's time after the case was called yesterday and continued this morning, indicating that today's entire session if not longer would be required for the completion of the case.

Representatives from the board of county commissioners, Kiwanis Club, Red Cross, Parent-Teacher Associations, women's clubs and other civic organizations made short talks endorsing the program and pledging the co-operation and assistance of their respective organizations.

The principal speaker, Miss Lois Dozier, who is director of relief work in ten counties, outlined the program of individual and community gardens and emphasized the necessity for gardens and canning.

"The Federal Government cannot play Santa Claus forever," she said. "We have to get together and help people to help themselves."

ONE WOMAN IN ROBBERY CASE FREED ON BOND

Blanche McGowan, of Vanceboro, Arranged Bond Yesterday And Released

Blanche McGowan, one of the four persons held in connection with the robbing of Niles Manning of \$147 at his filling station in Swift Creek Township last Tuesday night, was released yesterday upon furnishing the required bond of \$500. Two others of the quartette, Frank Johnson and Helen Parron, remained in jail here in default of bonds of \$1,000 and \$500, respectively, while Frank Banks was still in a Kinston hospital as a result of wounds received from a shotgun in the hands of Manning.

At a special hearing before Judge J. P. Paul Prizzelle, during the noon recess of civil court here Thursday the parties were ordered held for the April term of criminal court upon charges of robbing Manning and conspiring and planning to commit said robbery.

The robbery was said to have occurred after the quartette calling at Manning's filling station had indulged in a drinking party in which Manning joined. After the party had progressed considerably Manning was said to have been hit over the head and robbed, but recovering before the parties made their getaway, he grabbed his gun and fired at them, striking Banks in the back.

Held On Charge Of Stealing Gas. Paul Griffin, young white man, was given a hearing before Mayor Flanagan this morning and bound over to County Court on a charge of gasoline stealing. Bond was fixed at \$200.

Griffin was arrested Thursday night on a warrant issued earlier in the week as a result of a series of gasoline robberies from parked cars in this city. Dick Everett, another one of those charged with a part in the robberies was given a hearing earlier in the week and bound over to County Court also.

DISPOSE OF DISPUTES ON POSTOFFICE SITES. Washington, Feb. 25.—Two prolonged disputes over North Carolina public building sites were disposed of today by the Treasury Department when the A. F. Prevette lot, on C Street, between Ninth and Tenth Streets, North Wilkesboro, was purchased for \$15,000, and the Scottville lot, on Morhead and Main Streets, at Reidsville, for \$22,500.

Delegations have expended considerable sums coming to Washington to discuss with Treasury officials the respective values of these lots for sites. Spirited contests over them have been waged here for months. Today, Perry K. Keith, Assistant Secretary, who is going out with the Hoover administration, secured the purchases of lots in sites in all parts of the United States. He is trying to clean the slate for his successor.

DAILY TAR HEEL AT U. N. C. CELEBRATES 49th BIRTHDAY. Chapel Hill, Feb. 24.—The Daily Tar Heel, the only college daily newspaper in the south between Texas and Pennsylvania, yesterday celebrated its 49th birthday.

Starting on February 23 as a weekly publication sponsored by the Athletic Association, the Tar Heel during the past decade became a tri-weekly and in 1929 began its career as a daily.

Its first editor was the late Charles Baskerville of New York, and its first managing editor was Walter Murphy of Salisbury.

Today the Tar Heel has an editorial and reporting staff of more than 50 members and supplies the student body, faculty and townspeople with a service that embraces both local and outside news.

The Tar Heel this year is edited by Charles G. Rose Jr., of Fayetteville; George Wilson of Charlotte, is managing editor; R. D. McMillan, Jr., of Red Springs, is business manager; and Thomas C. Worth of Raleigh, circulation manager.

TWO YOUTHS BOUND OVER FOR ROBBERY

Luther Dunn and David Dudley Held Under \$500 Bond For Store Breaking

Luther Dunn and David Dudley, two young white men, who reside on the north side of the river, were given a hearing before Mayor R. C. Flanagan yesterday afternoon and bound over to the April term of criminal court under bond of \$500 each on a charge of breaking into and robbing the store of J. A. Watson Thursday night. Dudley furnished bond and was released, but Dunn was placed in the county jail in default of bond.

The goods was taken from the store included 1,000 pounds of sugar and a quantity of cigarettes. Following the arrests of the youths several hours after the robbery most of the cigarettes were recovered and the youths told the officers that the sugar had been sent to Beaufort County to be used in the manufacture of liquor. Beaufort authorities were called to go to the place where the sugar had been delivered and to hold same for Pitt officers. Yesterday Pitt officers who went for the sugar recovered 425 pounds of same and learned that the other part of the 1,000 pounds had already been put into the mash for moonshine liquor before the Beaufort County officers arrived on the scene early Friday morning.

Dairymen Make Much Progress. Raleigh, N. C., Feb. 25.—Ten definite accomplishments by dairymen of North Carolina for the year 1932 are recorded by John A. Arey, dairy extension specialist at State College. He lists them as follows:

There was an increase by 26 per cent in the production of creamery butter over the year 1931. There was an increase by 20 per cent in the production of cheese over the previous year.

There was an increase of 14 pounds of butterfat per cow considering the cows in the herd improvement associations. Dairy farmers began the use of economical trench silo, digging 41 during the latter part of the year.

Seventy old barns were remodeled. Seventy-five cooling tanks for milk and cream were constructed. At the request of dairymen, there were mailed blue print plans for 286 barns, 95 milk houses and 30 safety bull pens.

There were 238 pure bred dairy bulls placed. One new creamery was established. One new cheese factory was established.

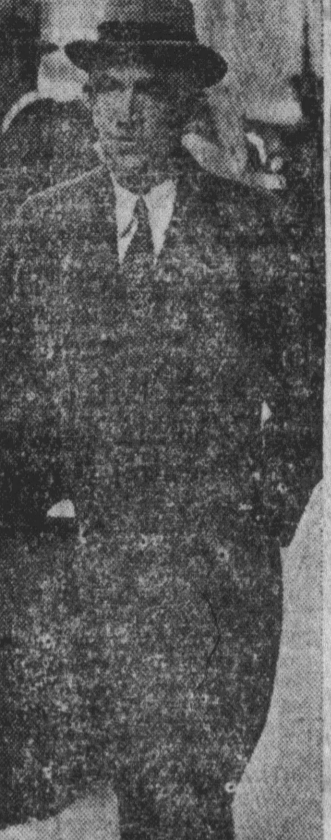
These ten items of advancement show that dairying is steadily but surely winning a stable place in the farm life of North Carolina, Avey says.

ASKS \$69,000 BECAUSE OF ACCIDENT INJURIES. Wilmington, N. C., Feb. 24.—Mrs. Grace W. Lertz, in a suit filed in Superior Court, asks damages of \$69,000 for injuries suffered in an automobile accident in 1930. Defendants are Hushes Bros. Inc. and the members of the firm: Miss Julia McLaurin, the A. M. Manufacturing Company, and D. B. Hill.

Mrs. Lertz complains that she suffered a broken back and other severe injuries when the car in which she was riding, driven by Mrs. McLaurin, overturned after a collision with a car owned by the A. M. Manufacturing Company, left at the Hughes establishment by Hill, a salesman, for repairs, and being operated by a negro workman for the Hughes Company.

LARGE TEXTILE OWNER IS DEAD

One of Western Carolina's Leading Figures Passed Away at Lincolnton Today. Lincolnton, N. C., Feb. 25.—(AB)—Daniel Efrid Rhyme, 81, textile manufacturer, banker and philanthropist, died at his home early today after an illness of several months. Rhyme had been ill from complication of diseases, and yesterday his condition became critical, although for the last several days his strength has been gradually ebbing.

He was president and director of the First National Bank here and owned the Piedmont Wagon Company, Hickory; owned the Rhyme Cotton Mill and stock in nineteen other mills in Lincoln and Gaston Counties.

Mr. Rhyme was known as the "Grand Old Man" of the Lenoir-Rhyme College, the name given the institution in 1924 as a recognition of his aid to it.

Funeral services will be held here tomorrow and burial will be made in the family cemetery at Chapel Church, near Gastonia.

BARNUM DESCENDANT IS NAMED DEFENDANT. Bridgeport, Conn., Feb. 24.—(AP)—Nancy Barnum Clark Carrier, of Brevard, N. C., granddaughter of P. T. Barnum, was named defendant today in a \$45,000 suit brought against her by the Wachovia Bank and Trust Company of Asheville, N. C., for a note she indorsed for the Brevard bank.

The papers, filed in Superior Court, charge Mrs. Carrier, whose husband is a director of the Brevard bank, indorsed a note for \$40,000 borrowed by that institution from the Wachovia Bank, when the Brevard bank closed the plaintiff sued on the notes.

It is alleged that the Asheville bank obtained a judgment against Mrs. Carrier in the general county court, Buncombe County, N. C., for \$38,939.60. The judgment has not been paid, the plaintiff charges, and several pieces of property of Mrs. Carrier in Bridgeport have been attached.

ECONOMY EFFORT IS MADE AT WHITE HOUSE. Washington, Feb. 25.—An economy effort was recently evidenced in a White House reception. The reception originally was scheduled for February 18, but a readjustment of dates to February 18 was made necessary by the thirty-day period of official mourning for the late Calvin Coolidge.

Instead of having new invitations engraved the cards are quite elaborate and costly—the "6" in the original was typed in 1931 to make an "8" for the second numeral in the date.

GEN. ASSEMBLY IN ANOTHER WORKLESS DAY

Legislators Consume Twenty Two Minutes For State Business Today

Raleigh, N. C., Feb. 25.—(AP)—Bill's to create a State Relief Commission and to promote efficiency in public schools were introduced in the lower House of the North Carolina General Assembly today as both branches held their customary Saturday local bills sessions. The total time consumed for the formal meetings of the two divisions was twenty-two minutes and about fifty of the 170 members were present.

Representative Everett, of Durham, sent in the measure to create a commission to handle all public State relief funds and Representative Arndt, of Catawba, introduced the school bill aimed at salesmen.

In the House an effort was made to send the Senate bill to abolish the Corporation Commission to either the Committee on Corporations, Committee on Regulation of Public Utilities when it was received in a Senate message, but Speaker Harris sent it to the re-organization Committee. Representative Martin, Bundcombe, asked that the bill go to the Corporations Committee instead of the re-organization group which drew the original opposition measure as a joint committee of both Houses. Taylor, of Mecklenburg, suggested that it go to the Utilities Committee. Speaker Harris ruled that discussion of a State-wide measure at a local bill session was out of order.

In the Senate one new bill was introduced and six passed. The House got two new bills, an anti-sales tax petition from citizens of Reidsville and passed several local bills. Under the Arndt school bill all persons would be prohibited from taking up the time of school teachers or pupils during school hours for the purposes of selling, explaining or advertising anything. Arndt set forth that salesmen now retard the efficiency of the schools by taking up the time of the teachers in explaining some advertising, subscription or other scheme.

The Everett bill would allow the State Relief Commission to arrange for farms whereon to place unemployed persons for production for themselves. The Governor, Secretary of State, Attorney General, Commissioner of Welfare, Auditor, Treasurer, Commissioner of Agriculture and Superintendent of Public Instruction would comprise the relief group.

Regular business of the Legislature will be resumed at an afternoon session Monday. The meeting is being held in the afternoon instead of at night as customary to allow legislators to attend the Southern Conference basketball tourney here Monday night.

PAINTER PROBABLY IS FATALLY INJURED. Charlotte, Feb. 25.—(AP)—Frank Barlow, 28, Gastonia painter, was probably fatally injured yesterday when he fell from the flagpole on the Hotel Charlotte to the roof 25 feet below. He was carried to a hospital with a fractured skull, broken shoulder and internal injuries.

Barlow had worked about half way down the pole when a hook holding ropes supporting the swinging seat on which he was sitting gave way.

The painted struck his head on a concrete base at the foot of the pole when he fell.

MUCH INTEREST SEEN IN TEACHING ACTIVITY. Wake Forest, Feb. 25.—An uncommon amount of interest is being displayed by seniors at Wake Forest College and graduates who have returned in meeting the requirements for public high school teachers' certificates in North Carolina.

In addition to the 52 members of the graduating class who are making preparation to teach next year, four outstanding graduates of recent years have enrolled this spring to get off their practice teaching and certain professional courses required for certificates.

SNAKE CHARMER DIES FOLLOWING OPERATION. Marion, N. C., Feb. 25.—Samuel A. Hurd, 57, Nebo, near Marion, well-known snake charmer immune to the poison of the deadly rattler, succumbed to the ravages of disease Friday noon following operation for gallstones in the Marion Hospital.

He played with snakes as one would fondle kittens. He was bitten many times by the most venomous rattlesnakes, but without serious effects. He was quiet, unassuming, dependable and highly respected in the community. The funeral was held today at Nebo.

PROTECT HOME-OWNED UTILITIES

We do not see how Rep. Tam Bowie's bill that would permit power companies to come into towns that own their own utilities, ever got past its first reading in the House 44 to 42, but we wish to thank Rep. Flanagan of this county, for his quick action in getting a reconsideration vote on this measure 59 to 24.

We have always been against letting the power companies get hold of our electric light plant and if this measure were to pass the legislature, it would be a simple matter for the power company to get control. Under this measure together with the present form of regulating rates the power company could come to this city, put in its own system, cut rates, despite the fact that it maintained them elsewhere to take care of the losses here, until they forced the municipal plant out of business or so far into the red that the people would agree to sell it. Then would come the fun for the power company, the misery for us, for our rates would no doubt present plan in order to pay go higher than under the big dividends on millions of dollars worth of watered stocks.

What the power companies in this state need is more real honest regulation rather than to be allowed to go even further toward getting complete control of the state.

This Bowie bill and any other bill seeking to give further advantages to the power companies in this state should meet a determined opposition every time they raise their head in the legislative halls.

In its issue of this week the News-Leader, local weekly, took Senator Arthur Corey to task for introducing a bill in the Legislature to appoint as constable in Aiden township a man who had just been defeated for office in the recent primaries. Nobody knows how many justices of the peace there are in North Carolina, or how many more this Legislature will create. Under the present antiquated law and practice, a large number are elected by the people, a large number are appointed by the Legislature, a large number can be appointed by the Governor, and the clerks of court name still others.

What is the result? If a man is defeated by the voters of his community, he often gets an appointment! This ought not so to be. The legislators are digging into every recess to make reforms and reductions. Here is a position of supreme local importance that cries aloud for reformation. The office of justice of the peace is a position that should be—as in the past and is now filled by honorable men in many places—filled only by the high-type 'squire who made local justice something of which to be proud. However, in many places, when almost anybody can get a commission, there have crept into this position not a few men who have lowered the position of justice of the peace into one of trade and traffic, where injustice and oppression prevail in the interest of fees. In some towns and cities unworthy squires actually are virtually employed as debt collectors and succeed by threat of criminal action.

Will nobody in the Legislature seek to put an end to such scandals protect the public and restore dignity to the office?

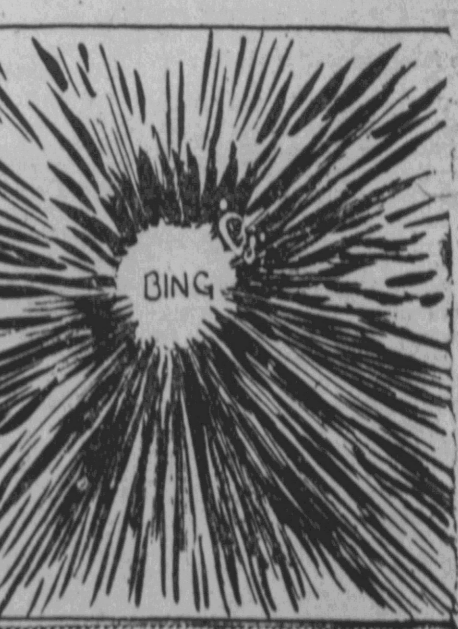

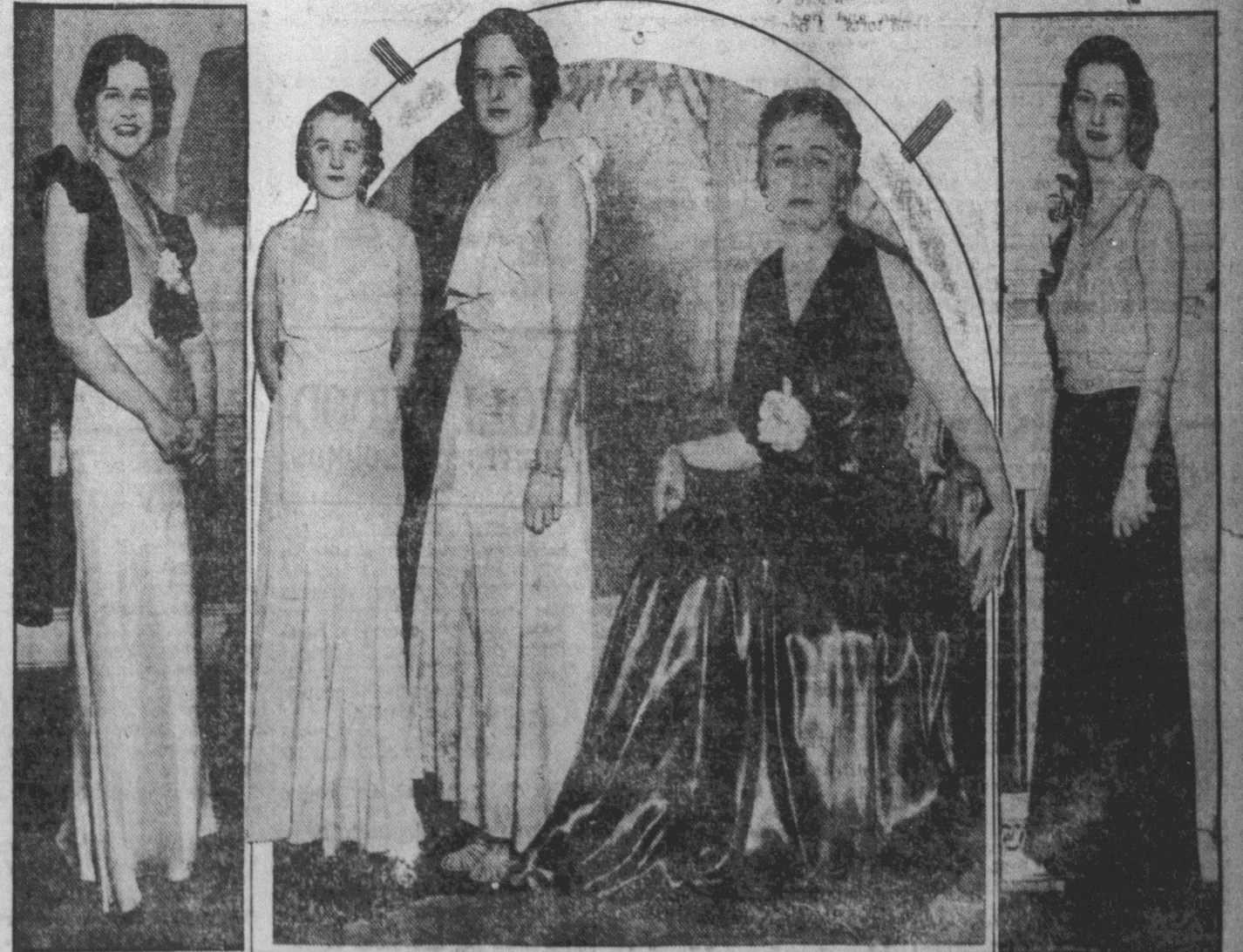

They were such unworriedly, unsuspecting girls, he said—those Colleens who flocked into the port of New York before America's immigration bars were tightened. It was a great problem to look after the arrivals, and see that they were delivered into the right hands...

And this help should be given before he becomes fretful and cross, before he learns to get pleasure out of teasing mother and makes a habit of dawdling.

The moment it is plain that fatigue is making over-hard a task which he ordinarily does with ease, he should be helped. There are occasions when it is best to take the whole task right out of the child's hands and do it for him.

It is particularly important to make things easy at bed time, for only in a calm, happy frame of mind will the child drop off quickly into a sound night's sleep.
