CITY FATHERS HELD MEETING LAST NIGHT

Several Matters of Minor Nature Given Hearing at Regular Meeting

The Board of Aldermen in regular monthly meeting last night called a city election for the first Monday in May to elect a new mayor and five aldermen, decided to extend street paving on West Third Street and heard several other routine matters. The matters handled by the board included:

J. S. Ficklen was reappointed a member of the Water and Light Commission to succeed himself for a period of four years. Resolutions were adopted by the board for the draft of a bill to be presented to the legislature changing the city school charter to permit the collection of the district school tax by the county tax collector instead of by the county tax collector as is now done. Other resolutions that would change the Water and Light Commission charter to permit its taking over the storm sewers of the city and one seeking to change its name to that of Utilities Commission, were adopted.

Decision was reached to extend paving on West Third Street between Pitt Street and the railroad, and also to provide sidewalks as a necessity for children who must pass this route to and from school.

An expenditure of \$100 for space in a tabloid booster edition being prepared by Renfrow Printing Company was voted and another \$100 was voted for the purchase of equipment for R. F. C. work being done in this city. The relief projects will include the proper draining of Green's Mill run adjacent to the city as a means of ridding the city of mosquitoes.

The Carolina Motor Club in charge of the sale of city auto license tags was instructed to advise all city owners that license must be purchased within a week or warrants would be issued for those operating cars without them.

Assistant Tax Collector W. L. Patrick was instructed to issue warrants for all businesses that had not paid their privilege license taxes. It was voted to donate \$10 per month to the local branch of the Salvation Army for the remainder of the fiscal year.

Richard Williams was designated as referee for the coming city election, and W. Druce Warren was given a contract for the city tax listing. Bids for the tax listing were as follows: D. Sorrell Spain, \$168; L. H. Bowling, \$165; W. B. Warren, \$140, the contract going to the lowest bidder.

Messenger Boy Reported Missing

L. H. Perkins, former employee for the local Postal Telegraph station, left the office yesterday afternoon to deliver two messages and has not since been heard from. He was last seen about 1 o'clock, and when he did not return at 2:30 o'clock, an investigation was under way. He was reported as leaving home after dinner, but after that time has not been heard from. A check up at the local telegraph office reveals no shortage in his accounts and his disappearance is a complete mystery. When last seen he was wearing the regulation Postal Telegraph uniform with the exception of the overcoat.

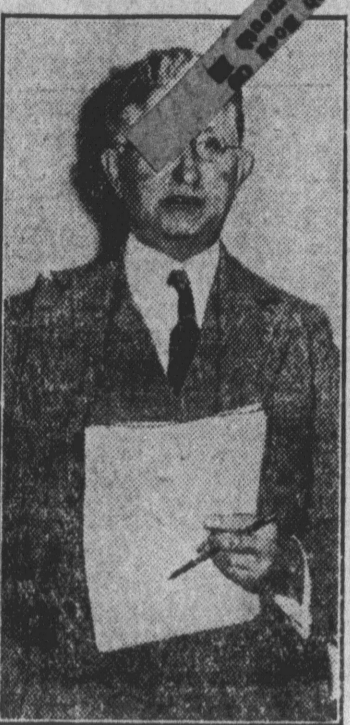

WASHINGTON ALL READY FOR INAUGURATION

Death of Senator Walsh Adds Sombre Note to Atmosphere of Gaiety

Washington, D. C., March 3.—(AP)—With a tear on his lip and a prayer of ascendant hope in his heart, the nation turned its capital city into one vast parade ground today as it prepared to welcome its new President amid the tumult of an inauguration unmatched in years. In tens of thousands from ever State the fellow-citizens of Franklin D. Roosevelt were pouring into Washington to see him take up his duties at noon tomorrow the duties of that high office in which President Hoover was spending his last full working day. But the death of Senator Walsh touched the heart of high and low alike and injected a sombre note into the atmosphere of gaiety.

Although in the main the plans are unchanged, The Roosevelts will not take part in any purely social activities.

Many of the incoming delegations brought their bands and made a holiday of the downtown streets decked with blazing flags and bunting. In groups and troops they took in Washington. Hundreds gathered to get a glimpse of Mr. Roosevelt, newly-arrived here from New York, on his way from his temporary headquarters at the Mayflower Hotel, to the White House, half a dozen blocks away, to pay the customary courtesy call to President Hoover.

Goldsboro, N. C., March 3.—At the meeting of the Wayne Advisory Health Council at the health department on Wednesday, Miss Gertrude Well read the address given by Mrs. W. B. Waddill at the recent Social Service Conference in Durham. Mrs. Waddill has for the past twelve years been superintendent of public welfare in Vance county and was president of the conference. Her address was on the marriage laws, sterilization laws, and child welfare. An open discussion followed the reading of the paper.

Assistant Engineer Returns

Sanatorium, March 3.—A. M. Stephenson, assistant engineer at the North Carolina Sanatorium, whose right hand was crushed badly when caught in moving machinery at the power plant several weeks ago, necessitating amputation of the fingers of that hand, has returned to Sanatorium from Highsmith Hospital, Fayetteville, where he was taken soon after the accident.

Report Mayor Cermak Better

Miami, Fla., March 3.—(AP)—The condition of Mayor Anton J. Cermak, of Chicago, was described as the best since a week ago, by his personal physician and son-in-law, Dr. Frank J. Kelly today. The physician's statement followed an official bulletin which said the mayor had a comfortable night, sleeping most of the time and awakening better. His pulse at 7 a. m. was 110 and respiration 28, the bulletin said.

PASS LAW FOR PROTECTION OF BANKS IN STATE

Gives Commissioner Power to Declare Holiday or Limit Withdrawals

Raleigh, N. C., March 3.—(AP)—Governor J. C. B. Ehringhaus of North Carolina, said today I shall not declare a bank holiday in North Carolina and Commissioner of Banks Gurney P. Hood said there would be no moratorium on banks in this State.

Governor Ehringhaus said the action by the Legislature empowering the Commissioner of Banks to authorize the limiting of withdrawals of bank deposits was a precautionary measure against the necessity of declaring a State-wide banking holiday.

Raleigh, N. C., March 3.—(AP)—A bill giving the State Commissioner of Banks power to authorize banks to limit withdrawals of deposits and suspend business was enacted by the North Carolina General Assembly today. The measure introduced in the House immediately following the opening of the session this morning was quickly passed under a suspension of the rules and sent immediately to the Senate where it received similar action.

Commenting on the legislation, Commissioner of Banks Gurney P. Hood said that the measure would not apply to new deposits. News had reached him, he said, that the North Carolina Bank and Trust Company had already imposed a 5 per cent limit on withdrawals at all its offices in the State this morning.

CHINESE FALL BEFORE DRIVE OF JAPANESE

Tales of Fleeing Leaders and Mutiny Troops Come From Jehol City

Chinchow, Manchuria, March 3.—(AP)—A picture of utter collapse of what was left of China's hold on Jehol province, with troops in revolt and leaders fleeing was brought here today by military and press dispatches.

Major-General Wawara, commander of Japanese forces, continued his advance on Jehol City after capturing Chingchuan, only sixty miles to the east, and asserted that the fall of the capital was only a matter of hours. Despite a blizzard his troops relentlessly continued their drive while Japanese reports said that Chinese troops in Jehol City had mutinied and the city was in chaos.

The governor of Jehol was missing and Chan Tso Hsiang and Wan Fu-Lin sent to Jehol by the north China war lord, had suddenly fled to Peking in defiance of their orders.

SLAYER OF CHILDREN RETURNED TO HOSPITAL

Graham, N. C., March 3.—(AP)—Mrs. Elsie Dollar, who killed two of her children and wounded a third because, she told officers, she did not want them to become "public charges" was re-committed to the State Hospital at Raleigh today for a year's further observation. Mrs. Dollar was brought here from the hospital several weeks ago to stand trial on a charge of murder. When a case was held Judge Clay Moore, Solicitor Leo Carr and Dr. J. W. Arbuckle of the State Hospital, agreed that she should undergo further treatment there. Shortly after the slayings, Mrs. Dollar was judged "incompetent" to be tried and sent to the Raleigh hospital. She was ruled sane and returned here for a year's observation.

Japan's Moves In Jehol Countered By 'Robin Hood' General Tang You-Lin

Chinchow, Manchuria.—(AP)—In his efforts to add the province of Jehol to Manchukuo's territory, Japan is being blocked fiercely by General Tang Yu-Lin, "opium king of Jehol."

He is the warlord of the disputed area, bigger than the state of New York, and is said to be worth \$10,000,000 (silver) much of his wealth being in huge stocks of opium. He also is credited with large property holdings in various parts of China and with interests in numerous business enterprises.

General Tang's principal personal possession is a fleet of fast American automobiles. In Jehol is captured by March 70, the date set by the Japanese. Tang, it is expected will pile his treasures of opium and gold and the ladies of his harem into these cars and speed them through the night over the desert into Mongolia or southward to Peiping.

Tang Yulin has some of the characteristics of a "Robin Hood." He has been known for years as one of China's "benevolent bandits" who would never kill for money but who would fight to the death for the mere thrill of fighting. He is a former associate of Marshal Chang Hsiao-Liang, a graduate of Mukden Military Institute. His palace, which cost \$1,500,000 was one of the show places of Mukden. His real estate and business enterprises are vast.

Tang is a portly, round, good-natured, but exceedingly shrewd Chinese, who rules Jehol with one hand while he smokes his opium pipe with the other. In the 50's, he wears a long black, drooping mustache, Mandarin robes, a black skull cap and a pigtail. He loves to eat and drink and to be entertained. He is showy and demonstrative. He wears a big oval pearl in his silk skull cap and a huge diamond ring on his right hand. In conversation he has a habit of twirling his fingers so that his big 8-carat diamond fairly dazzles his visitors.

For many months Japanese secret agents have been trying to buy his allegiance and have endeavored to persuade him to throw in his lot with the new state of Manchukuo. But he decided to remain loyal to his former associate, Marshal Chang.

In any event he has massed 40,000 of his best troops at strategic centers. These soldiers have been equipped by Marshal Chang's regulars, reports here saying there are 100,000 to the latter. Dressed in ancient Mandarin robes of silk and wearing an inscrutable, ironical smile, Tang Yu-Lin sits serenely in a great, orrery-monastery near Jehol City, waiting the outcome.

TWENTY FOUR STATES ACT ON BANK MATTERS

Twenty-four States are now taking protective steps of one sort or another with regard to banks and depositors. The actions range from holidays, mandatory and optional, to legislation giving banks the power to limit withdrawals if they deem it necessary. Holidays of varying duration were yesterday and early today in nine States. They were Texas, Washington, Oregon, Idaho, Arizona, Nevada, Utah, Wisconsin and New Mexico. At Washington while President-elect Roosevelt was preparing to put his hands to the helm of State and Herbert Hoover was getting ready to relinquish it, the situation was receiving close attention.

In the great money centers of New York and Chicago as well as in other sections, business went untroubled by the difficulties elsewhere. In many States where holidays have been declared or restrictive action taken, officials said the banks were sound but must be protected from withdrawals.

Washington, D. C., March 3.—(AP)—Loans aggregating more than a million dollars for North Carolina institutions were approved by the Reconstruction Finance Corporation in January.

LOCAL BANKS IN BEST SHAPE IN MANY YEARS

No Indications of Any Necessity For Restrictive Action by Banks Here

Despite action in some sections restricting withdrawals of bank deposits, there is no indication that any such action should have to be put into effect by the banks of this city.

The local banks, according to recently published statements, are in the best condition they have been in for many years with liquid assets to take care of any demands that might be made upon them. Those in close touch with the banking situation here have no fears that any action from today's legislative action permitting restriction of deposits will be felt here.

The law passed today merely affords greater protection for bank depositors in that it empowers banks to prevent panicky runs by invoking the restrictive withdrawal plan. Even with a bank working under the restrictive plan, the same does not apply to any funds deposited after said plan is invoked by the bank as such funds can be deposited and withdrawn at will by the depositors.

QUAKE TAKES HEAVY TOLL

Over 1,200 Persons Perish as Result of Earthquake in Far East

Tokyo, March 3.—(AP)—More than 1,200 persons were known to have been killed by the earthquake, tidal wave and fire that devastated a section of the northeastern seaboard of Honshu Island, the largest of the Japanese archipelago early this morning. Full extent of the casualties had not been determined at eleven o'clock tonight, but the governor of Iwate, which suffered the most heavily, reported 1,119 dead in Iwate alone, mostly north of the Miyako coast, about 300 miles northeast of Tokyo.

The total dead rose to 1,238 with reports from the provinces of Miyagi, Amori and Hokkaido. Miyagi is on the east coast, Amori is a province north of Honshu Island and Hokkaido is a smaller island north of Honshu.

Burned To Death In Car Crash

Greensboro, N. C., March 3.—(AP)—Jack Trotter, 20, son of one of Greensboro's most widely known families, was burned to death early today when his automobile was wrecked on the western outskirts of the city, and John Ellison, his companion was brought to a hospital unconscious from burns. Authorities are investigating the crash, the cause of which has not been determined.

WILL CONTINUE INVESTIGATION OF UTILITIES

New Administration Will Take Up Investigations Started by Present Congress

Washington, D. C., March 3.—(AP)—Congressional investigation of public utilities holding companies in the next Congress was assured today when the Senate approved a House proposal.

A resolution of Senator Barkley, Democrat, Kentucky, speedily agreed to provide that members of the Senate and House Interstate Commerce Committees together shall continue the investigations started by the present Congress. The purpose of the inquiry is given as to obtain information necessary as a basis for legislation.

The committee will have full power to subpoena and authorize investigations into the control and financing of interstate utilities except the railroads.

Local Inspector To Help Farmers Apply For Loans

Regulations for 1933 governing crop production loans have been issued by the Secretary of Agriculture and are now available to farmers in this county upon request to Herbert E. Lane, Field Inspector of the Crop Production Loan Office. Mr. Lane's office is in the courthouse.

Instead of writing to Washington or to one of the regional loan offices, Mr. Lane announced, farmers can obtain the necessary application blanks for loans, and detailed information about the requirements, direct from him. Applications will then be reviewed by the county advisory committee, then certified and forwarded to the regional office at Washington, D. C., for final approval and action.

The regulations this year specify that only those who cannot get loans elsewhere are eligible for loans from the \$90,000,000 funds authorized by Congress. Loans can be used only for crop production, and the borrower to reduce his acreage of cash crops 30 per cent under last year, unless he does not intend to plant more than eight acres of cotton, two and one-half acres of tobacco, eight acres of peanuts, twenty acres of corn, twelve acres of sugar beets, two and one-half acres of truck crops, eight acres of potatoes, thirty acres of wheat.

The maximum period of wheat, rice, or forty acres of wheat, one borrower this year is \$200; or, in the case of tenants, the total of all loans to tenants of any one borrower within a single county cannot exceed \$1,200. The actual amount advanced by the authorities will depend upon the borrower's requirements. A first lien or mortgage on the land will be required. The regulations require that loans be repaid before October 31, 1933. Interest at 5 1/2 per cent, deducted in advance, will be charged.

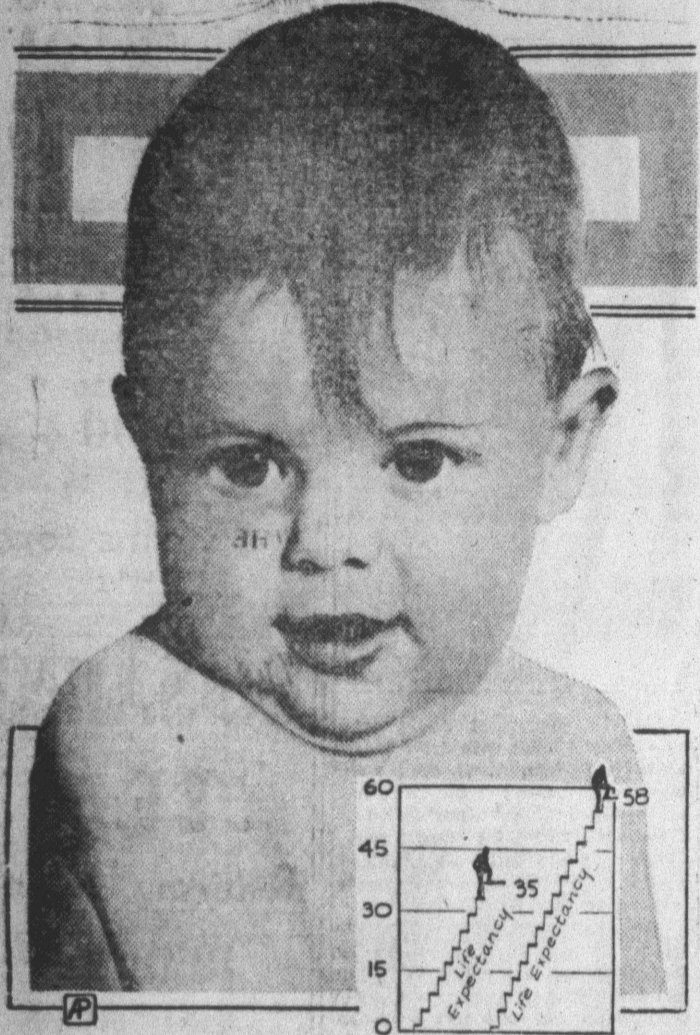

Healthy Babies Make Healty Nation



If all babies were as healthy as this one, one of the nation's ten biggest problems would be partly solved. vigorous health. These two things are, perhaps, most responsible for our increased stature. Another reasonably sure way to improve our health would be to raise our standard of living, for the poor have higher death and disease rates than the well-to-do. City dwellers do not yet have as good health in general as country folk. The growing number of sedentary occupations indoors must also be an influence counteracted in part by the growing participation in outdoor sports.

Another important factor is the increasing knowledge of the chemical nature of food and the mineral needs of the body.

Women Outlive Men
The expectancy of life for women despite the hazards of child-bearing (which are unduly large in our country) is greater than that of men. It seems probable that this is due to the nature of man's occupations. Specific occupational diseases and the general industrial wear and tear on life are problems to be dealt with.

The problems of illness is as well appreciated as that of any social problem by our people, and as much effort and money go into it as into our other efforts toward ameliorating our lot. Yet it must be included in a list of ten major problems. The effort and appreciation are still not enough.

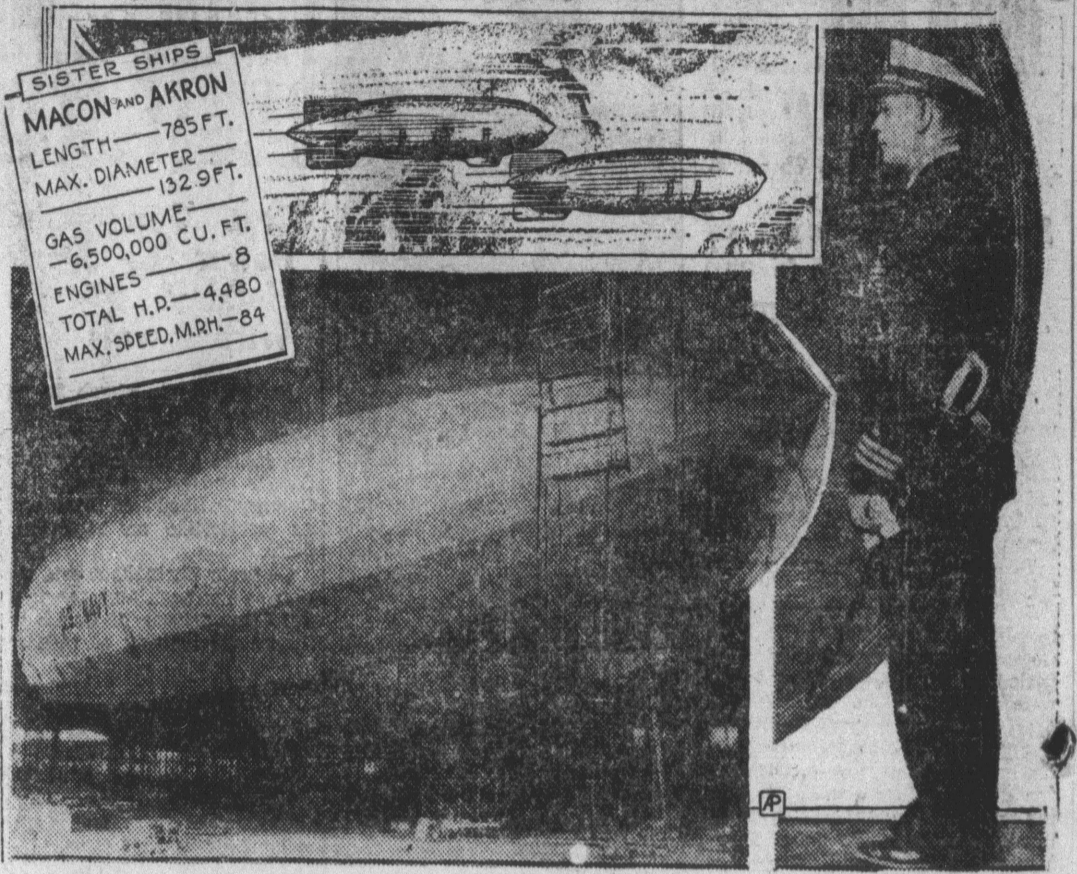

MACON SOON READY FOR AIR TESTS; GEORGIANS TO SEE CHRISTENING MAR. 11

Akron, Ohio.—(AP)—The U. S. S. Macon, sister ship to the Akron, is scheduled to begin breathing gas into her lungs preparatory to test flights pretty soon.

Her completion and acceptance by the Navy will mark the fulfillment of the five-year program that was launched in 1927 when the government announced a design competition that resulted in the building of the world's two largest airships and dock at a cost of nearly \$8,000,000.

Georgians Expected
A delegation from Georgia and the city of Macon is expected to take part in the christening ceremonies March 11. Mrs. William A. Moffett, wife of Rear-Admiral Moffett, will officially christen the ship.

Commander Alger H. Dressel, whose first appointment in the Navy came from Theodore Roosevelt will be the skipper. He will direct a crew of fifty-four men on the Macon. Dressel has been in charge of the Los Angeles and is being detached from

the commander's post on the Akron to take over the new ship. Previous to his air assignments, Dressel spent three years in Asiatic stations and during the World War, was awarded the Navy Cross for service as commander of a destroyer.

Although the Macon, in outward appearance, is virtually a "Chinese copy" of her sister ship, she nevertheless presents many changes and refinements which engineers have made as a result of their experience in building the Akron.

The Macon outriggers supporting the propeller shafts will carry a cowling, to cut down wind resistance.

Radiators Faired
Engine radiators that were carried on the Akron outriggers to get sufficient cooling, have been faired into the sides of the Macon to cut down resistance. When closed as in the case of an idle motor, they will be hardly larger than "blisters."

Ships Identical
In length, height, gas volume and weight the two ships are identical. Floated by 6,500,000 cubic feet of non-inflammable helium gas, 785 feet long, 132.9 feet in diameter, driven by 4,480 horsepower, capable of speeds of more than 80 miles an hour, with a cruising radius of 13,000 nautical miles at 40 knots, carrying five airplanes and seven machine gun emplacements, the sister ships comprise the two finest aircraft of this type in the world.

DON'T BE FOOLISH

There is an old saying that a burned child dreads fire, and wherever there is a mention of banks many of our people who have had unfortunate experiences heretofore begin to get panicky. In view of the adoption today by the State Legislature of laws that would permit bank holidays or restricted withdrawals we feel it necessary to warn our people against any hasty judgment and foolish action.

To begin with our local banks are in the best condition they have been in in many years and if the depositors called for their money the banks would be in position to pay it but the point is that the people would then have no safer place to put it and at the same time would be helping to cripple every kind of business and industry in the community. We assure our people that at present there is no need for any bank holiday here and no need for any restrictions on withdrawals and there will continue to be no need whatever for any such action unless the people make it necessary themselves by trying to run to the banks to get out money that they do not need for immediate use and have nowhere to put it without taking it clear out of circulation at a time when we need more money in circulation rather than less.

Business is hard enough now because of shortened finances and certainly if our people are foolish enough to make the banks shut down on them, then things will be worse. Honestly, we do not believe that our people at present are even inclined to let themselves in for a panic of this kind, but we are taking this precaution ahead of time, realizing that there are always those who would spread rumors that might tend to get the best of the judgment of our people.

Again we say, money in our local banks is, we believe, safe, and unless you need it for some immediate purpose don't try to draw it out. Let it stay there in order that the wheels of industry in our city and county can continue to turn.

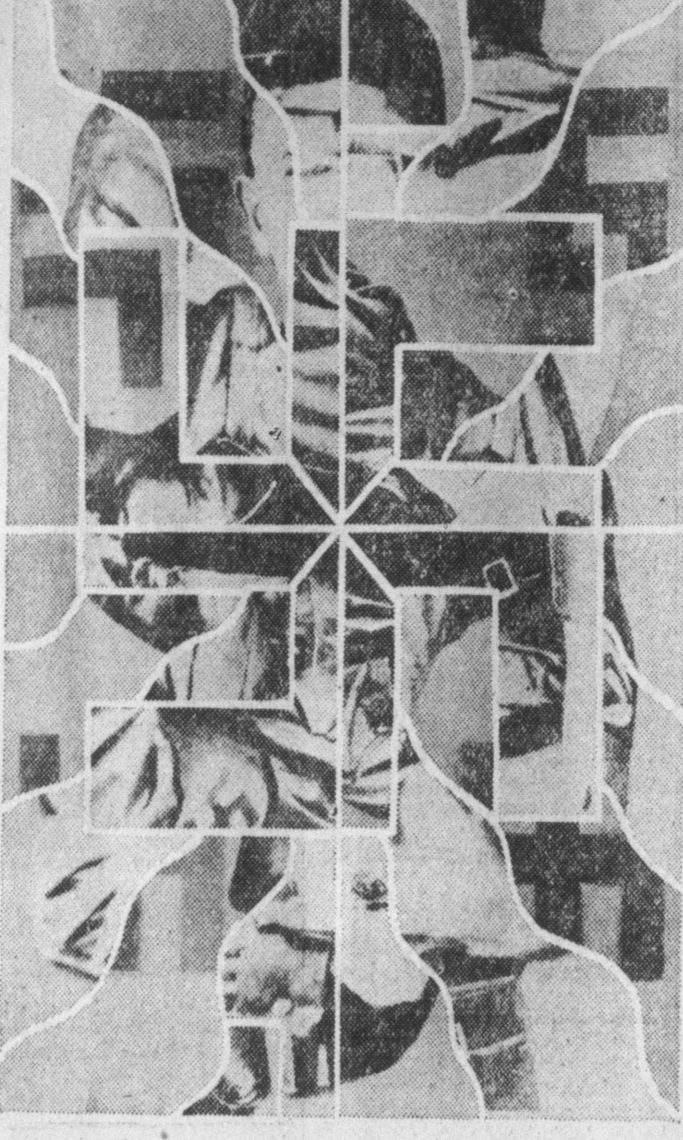

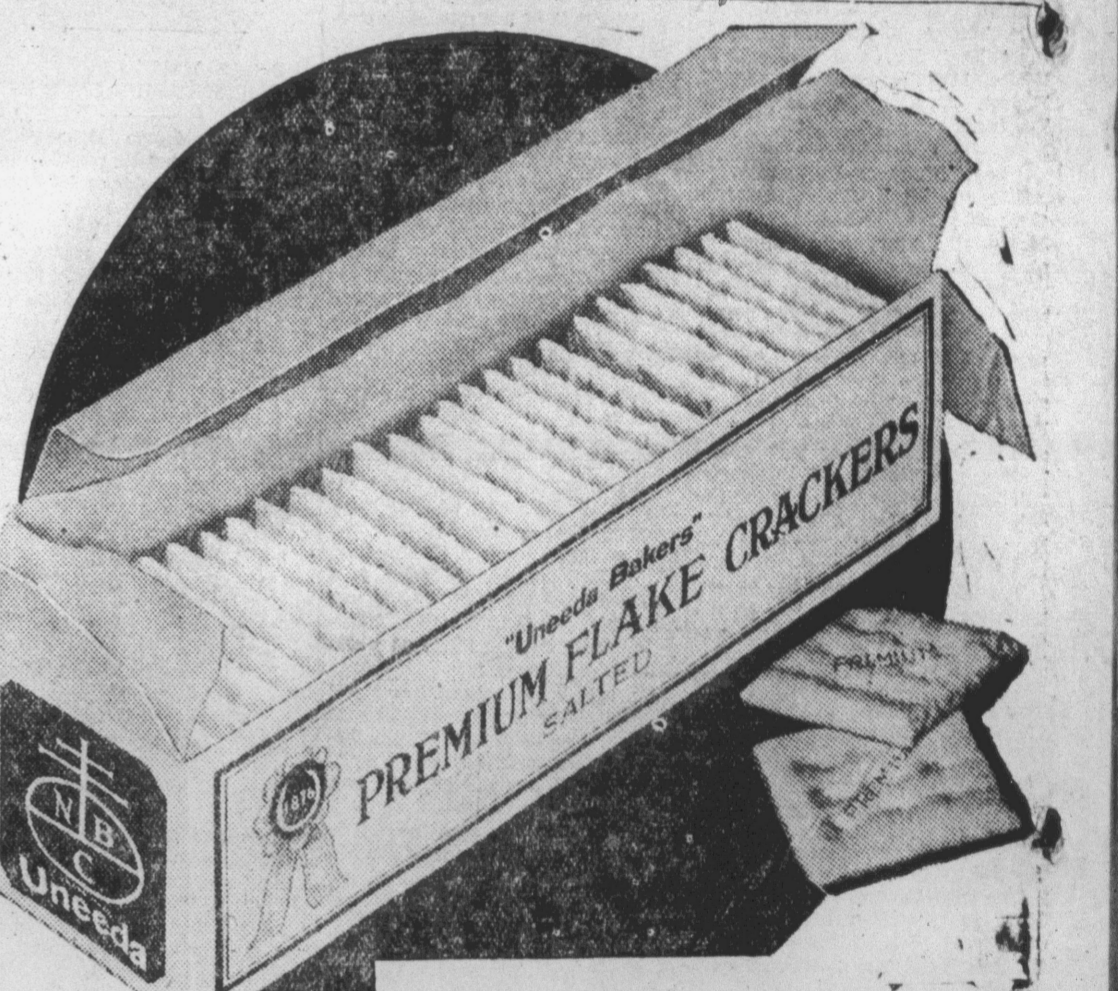

Washington Daybook

By HERBERT PLUMMER
 Washington — (AP) — Had the present short session of Congress met when there were fewer economic problems confronting the nation and the world, it might not have received much of the criticism hurled at it from every quarter. So much has been expected that perhaps actual accomplishments have not brought the credit that in ordinary times would have resulted. In normal times the paramount duty of the short session is to deal with the appropriation bills which supply the funds for the conduct of the government. There are 12 of these measures, composed of 111 or more major items, and usually the full time of a short session is required to dispose of them. In the present session, however, these bills were regarded generally as just so much routine when the other staggering problems pressing for solution were borne in mind. The anxiety in the country over the activities of the national lawmaking body is and has been such a problem as has never existed before.

Since the first day of the session for its deliberations on capitol hill have hovered the tremendous shadow of war debts, discontent on the farm, the unbalanced budget, the pruning hook of government economy and prohibition—to mention only a few.

In contrast with what this present session has had on its hands and mind, the problems which beset other sessions—even the post-war Congress of 1918-19—must seem like kindergarten exercises to the members. Accomplishments have been made at this session. Legislation has been passed that some see as leading to widespread changes in the policy of the whole nation in the future.

The recent action, for example, of both houses in approving the proposal for submitting the question of repeal of the 18th amendment to the states has cleared the legislative desk of admittedly one of the most vexing and controversial issues.

Then there's the disposition of the Philippine question. The islands have been given the hope of ultimate independence by the present Congress, an action of perhaps tremendous import.

And there are others. In better times the present record of the last "same duck" session might have been pointed to with pride by many persons.

About NEW YORK

 New York—There has been a great deal of talk about the 6,300-seat music hall in Rockefeller Center some day blossoming out as the new home of Metropolitan opera. Although business picked up for the music hall after the inaugural Roxy extravaganza died away and a policy of films supplemented by stage shows took effect, the talk about the opera persists.

Opera is in the doldrums, and one of the suggested panaceas is a movement to win wider public interest by more Democratic presentation. If that can be accomplished, the music hall, as it stands, probably would be a fine home for opera. In patterning the huge hall, S. L. Rothafel omitted most of the architectural features that make for audience class distinctions at the old opera house.

What, No Horseshoe?
 But many believe that only a handful of people go to the opera because they really care about the music and singing in what Mr. Paul D. Cravath called "perhaps the last of our Victorian expressions."

The rest, when they go, want to see the good old-fashioned sights and mainly the hoity-toity diamond horseshoe. To revive opera, they argue, the social glamor of the institution must be polished up to its former sheen.

If the latter theory is to be upheld—and if opera does move into the music hall—the architects will have to get busy.

There is no place for a diamond horseshoe in the auditorium now. The three stubby balconies break off so far in the rear of the house that a row of bejeweled mezzanine perchers would be lost to view. And a few dozen glittery Van Astor-bills sprinkled among the several thousand commoners in the orchestra seats would cut no figure at all.
