BANKS RESUME OPERATIONS IN NUMBER OF STATES

N. C. Institutions Will Be Permitted to Re-open Wednesday, Hood States

GOVERNMENT RESTRICTIONS TO PREVAIL

Banks Will be Permitted to Receive Deposits, Currency May be Changed But No Gold Certificates Will be Paid Out; Exchange Markets Of World Remain Closed Awaiting Developments in America; Britain Does Not Consider America Off Gold Standard

(By The Associated Press)

State after State announced the re-opening of banks today in line with the ruling of Secretary Woodin permitting the transaction of essential business.

Deposits may be made, currency may be changed, but no gold certificates shall be paid out.

In the van among the States announcing re-opening were Ohio, South Carolina, Kansas, California, Florida, Michigan and New York.

Exchange markets of the world still were awaiting developments in America before resuming the transaction of trading in the dollar, but a high banking authority in London expressed confidence Britain did not consider the United States off the gold standard.

The Reichbank fixed the dollar rate at 4.16 marks. No clear-cut house script was actually incirculation, but prospects were that New York and other States might release this medium of exchange shortly.

States which had given governors wide powers to regulate banking included New York and Massachusetts. New York expects to set up a corporation for the issuance of script.

Silver advocates in Washington started a cry for an adequate currency rate on silver. Aaskan merchants went on the gold dust basis resurrecting scales to weigh the gold of prospectors. Kansas City merchants and street-car motormen said they were taking in many silver dollars and old bills.

Manufacturers of script said they had little to fear from counterfeiters because of the intricate design of the new money. Chicago will carry a picture of Abraham Lincoln. New York will have its own coat of arms and Philadelphia will boost the lines of Benjamin Franklin.

Raleigh, N. C., March 7.—(AP)—Gurney Hood, State Bank Commissioner, said at his home here today he expected to be ready to allow North Carolina banks to re-open tomorrow under such regulations and limitations as are promulgated by the Federal Government.

The Bank Commissioner said he did not think his plans would be in shape to allow any bank to re-open for business today.

Hood, who has been working almost continuously on the bank situation for sometime did not go to his office this morning until several hours later than usual, but said everything had been done necessary to enable banks to open under restrictions tomorrow.

MOVE TO HURRY UP CIRCULATION OF SCRIP

PUSH UNION IN GERMANY

Teutonic Powers of Germany and Austria Given New Impetus Today

Vienna, March 7.—(AP)—The movement for union of the Teutonic nations of Germany and Austria—a frequent cause of alarm in neighboring countries since the war—was given new impetus today.

Hitlerites held a mass meeting throughout the country in celebrating the victory of the chancellorship in the German election.

Meanwhile, the question was debated whether the parliamentary government would be eliminated. Officers empowered to call Parliament in session resigned last Saturday after a stormy meeting over the treatment of railroad workmen.

A semi-official newspaper, Reichpost, said Parliament abolished itself and not even President Milas can reassemble the body.

DOUGLAS IS GIVEN OATH

New Director of The Budget Delves Into Work of Balancing Finances

Washington, March 7.—(AP)—Lewis Douglas, former representative from Arizona, today took the oath of office as federal director of the budget.

A moment after Mrs. Brownie Keer, chief clerk of the budget, had administered the oath, he flung himself into his task of helping to find ways and means for bringing the government expenditures within revenues.

For several days past he has been at work on it unofficially in seeking to formulate proper regulations.

GETS FELLOWSHIP FOR YEAR IN PALESTINE

Wake Forest, March 7.—P. B. Upchurch, 1929 Wake Forest College graduate, formerly of Apex, has just been granted the Two Brothers fellowship of Yale University to spend next year in Palestine at the School of Oriental Research, according to a letter received here by one of his major professors, Dr. A. C. Reid. The stipend is \$1,500.

GOVERNORS RETURN HOME

Leave Washington After Conference With President Roosevelt

Washington, March 7.—(AP)—Twenty-six governors and representatives of twelve others were homeward bound today pledged to cast aside politics and sectional interests and support President Roosevelt's relief program.

Announcing a point in the federal clearing house he would use for relief, Mr. Roosevelt added: "I hope to get that set up in the next two or three weeks."

Leaving his manifold activities long enough to appear before the governors, Mr. Roosevelt told them he "was grateful for what the States have done in this emergency."

DENY RELIEF FUND RUMORS

Head of Department Says Nothing to Report of Irregularities Here

Rumors of irregularities in the handling of Reconstruction Finance Corporation funds used for work relief in this county were declared today to be without foundation by K. T. Futrell, director of the Welfare Department, who is in charge of distribution of the fund, as well as others connected with the relief program.

The relief head asserted that charges of misappropriation of funds which gained considerable circulation throughout the city over the week-end absolutely unfounded and that records in the Welfare Department indicated all money paid out had gone into proper channels.

The rumors which gained circulation Saturday were to the effect that Chief of Police George Clark, who has charge of the relief program in the city proper, had been jailed on charges of misappropriation of funds and that his brother John as well as others engaged in relief activities, were also involved.

The reports spread like wild-fire, and yesterday afternoon on the streets of the business district as well as homes were agog with gossip in connection with the rumors.

Realizing the seriousness of the rumors, members of the relief committee attempted to trace their origin and believed today they had partly accomplished their purpose.

Last Saturday morning, Chief of Police Clark carried Mrs. Clark to Duke Hospital for treatment. While he was away a colored woman appeared at the police department and asked for Mr. Clark, stating she needed help.

Somebody sitting in the office jokingly told the woman Mr. Clark had been carried to Raleigh and looked up. The woman is believed to have come back to negro town and told numbers of people that the "law" had been locked up. The statement, it was said, repeated and magnified several times, and when it finally reached the business district it had been twisted into such grotesque form that it appeared there had been some gross irregularities in the handling of Reconstruction Corporation funds appropriated to this county for the conduct of relief work.

WOODIN GIVES REGULATIONS FOR BANKING

Treasury Head Says Banks Will be Permitted to Perform Necessary Function

Washington, March 7.—(AP)—Secretary Woodin in regulations issued today ruled that any national or state bank may exercise its usual banking functions to the extent that is absolutely necessary to meet the needs of the community for food, medicine and other necessities in the relief of distress, payment of salaries and wages and necessary expenditures for maintaining employment and other such purposes.

Woodin also ruled that any banking house may deliver to the owner properly identified federal documents or securities held for safe keeping and where settlement for checks charged to accounts on or before March 4 may be completed when the settlement does not involve payment of money or currency.

He also ruled that any bank having foreign branches may invest collateral in the United States to secure advances of such branches provided the action does not involve transfer of currency from the United States.

MINISTER IS CLUB SPEAKER

Rev. A. W. Fleischmann Delivers Principal Address to Rotarians

Rev. A. W. Fleischmann, president of the Rotary Club, was the principal speaker at the regular weekly meeting of the club here last night. He spoke on the subject: "Rotary's Four-Lane Highway" and brought out many points of interest in connection with objectives of the organization.

BIG RUSH FOR FARM LOANS

Another Large Crowd On Hand Today to File For Federal Seed Money

Applications for farm seed loans continued to pour into the farm department here today following the opening of the filing period yesterday.

Over two hundred growers were on hand to apply for loans yesterday and a similar number were present this morning awaiting their turn for filing.

About forty applications were actually completed yesterday. E. F. Arnold, director of the farm department, stated today. The maximum speed for filing is about fifty applications a day, the farm head said. Three special stenographers have been employed to assist in the work.

Growers have from now until April 30 in which to file applications for loans, Mr. Arnold said, and there is no occasion for rush. Applications are usually approved within two weeks after being passed on by the local committee, it was stated.

The maximum individual loan obtainable from the government this year is \$300, although it is possible for an entire farm to obtain as high as \$1,200. The majority of the applications filed here yesterday ranged all the way from \$100 to \$200.

LOCAL BANKS IN OPERATION

Institutions Functioning Under Plans Given By Federal Treasury

Local banks began operations today under provisions laid down in the modified plan laid down in the announcement of Secretary of Treasury Woodin.

Under this plan the banks are opening new accounts, accepting for deposit currency, government bond coupons, government checks and other forms of exchange that can be immediately converted into cash. These deposits are guaranteed to the depositors one hundred cents on the dollar and are subject only to checks drawn on such new accounts. Drafts with bill of lading attached are being delivered upon payment in cash.

The balances on all accounts at the time of declaration of the banking holiday will remain intact and are not subject to any withdrawal until official permission is given by the government, and then on such terms and restrictions as the government may prescribe.

While no statements could be obtained from any banks here because of the lack of any information except that contained in press reports it is the belief that outstanding checks against the old balances will have to be replaced by checks upon the new accounts to be honored at the banks in case there are restrictions placed upon the old balances.

This opinion is expressed in view of the fact that outstanding checks against an old account would in many cases far exceed the amount available under restrictions, and in such cases the first check cashed would deplete the available balances and leave no funds with which to take care of the other checks.

Late News Flashes

Today In The Legislature. Raleigh, March 7.—(AP)—Abolition of the state corporation commission and replacement of public utility commission was voted by the assembly today, as financial legislation was temporarily left aside.

The House enacted into law one further emergency fiscal bill passing without debate a measure already approved in the Senate which allows building and loans to demand 30 days notice before funds are withdrawn.

The transfer of the highway patrol to the revenue department was voted in the Senate, just as the House adjourned. Representative Newman sent forward a money bill calling for expenditures of \$83,000,000 in the next biennium. The measure was set as special order for Friday.

On oral vote the House passed without change the Senate measure to abolish the corporation commission of three members effective Jan. 1, 1934. After debate the Senate passed the Ingram bill to take the highway patrol from the highway department and put it under the revenue department. The patrol will take over the duties of gas and oil inspection service of the department of agriculture and take over the motor theft bureau.

SEES PROSPECT FOR PROSPERITY'S RETURN

Burlington, N. C., March 7.—The May Hosiery Mills will run this week and pay off in cash, according to a statement today by W. H. May, president of the large hosiery. Beyond this week—"that depends altogether on what the administration has done," Mr. May said.

"One man's opinion is as good as another," Mr. May added. "I do believe, however, that a national policy, adequate to meet the situation, will at once restore national confidence, national business, and national prosperity."

The fact that the large May Hosiery pay-roll will be released in the city in cash this week is due to "a feeling" that officials sensed last week.

In addition he ranks third on the public lands and surveys committee—an important one for the West—and ahead of him is Pittman, of Nevada, and Kendrick of Wyoming.

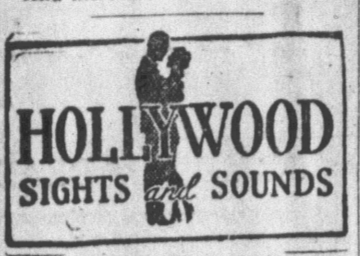

Arrangement was made Saturday for the meeting of payrolls in the three largest industries with cash from the banks. Various firms are in addition issuing to employees credit orders for goods against firms indebted to them.

CHILDREN UNDERNOURISHED COLLEGE PROFESSOR SAYS

Los Angeles, Calif.—(AP)—Eighty per cent of the children in the Los Angeles school system are scientifically undernourished, says Dr. P. A. Bonquet, professor of nutrition of the University of Southern California.

He bases his statement on an eight-year period of research on the symptoms of malnutrition in the behavior and appearance of children.

"Too little attention is devoted to a study of nutrition," says Dr. Bonquet. "The principal cause of sub-nutrition is the lack of importance given to the meal time period in the daily occupation of the child. The dining-room offers an opportunity to teach the highest socialization, and the knowledge of the properties of the food consumed is a practical life education in itself."

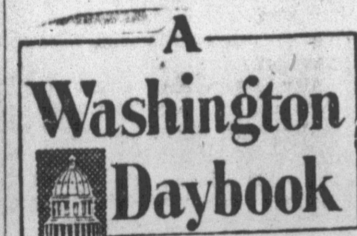

By Tom O'Neil. Forcing bids, requiring partner to keep bidding until a game contract or its penalty equivalent is reached, sometimes succeed when made with out sufficient strength, but great is the delight of a player who finds that a force upon him was well justified.

William E. Zontlein of New York, opened a hand on bare minimum requirements and his partner bid and made an easy grand slam that was as certain as almost anything can be in the game.

Zontlein NORTH dealer: S—none; H—K Q 4 2; D—K Q 7 5; C—Q J 7 6 5 2.

WEST: S—K Q 9 7 6; H—J 9 6; D—10 9 8 2; C—9.

SOUTH: S—A 10 5 4; H—A 5 3; D—A J 7; C—A K 8.

North opened with one club and South pondered a bit. The hand was too big for a three no trump bid. A jump in clubs might not produce the maximum result. There was no biddable suit.

South decided to see if North's clubs were rebiddable, and he bid two spades, a shaded suit, as a force.

North responded with three clubs and South gleefully jumped to seven no trump. West led the spade king and South spread.

Oliver A. Lanchantin of Brooklyn made an opening two forcing bid which was a bit anaemic, and was properly carried to grand slam, vulnerable, by his partner. Lanchantin fulfilled his contract by careful play.

Recognized Strategist. A recognized strategist, critic and student of tariff and fiscal matters, he has served longer in Congress than any other member of the party above the Mason and Dixon line. He represents the same district as did Abraham Lincoln and Stephen A. Douglas.

Most of those years in Congress have been spent by Rainey in hard work with only occasional moments in the limelight. He has been a dependable man for his party, a good rough and tumble debater on the floor of the House.

When he speaks his voice is friendly, almost soft, but direct. His flowing black bow tie and heavy mane of silver hair contribute to his picturesque.

As Speaker he may not be as colorful as some of his predecessors, but many predict that he will be reasonably successful because he knows the game. And the way he has played the game for the last 28 years in the House has earned him the confidence and respect of his colleagues.

His friends predict that he will bring to that position a mature and deliberate leadership. They describe him as substantial in both mind and body, just about the kind of a man he looks to be—patient, tolerant, amiable, intelligent and careful.

Early Session Likely. As Speaker of the Seventy-third Congress his task will be one of great responsibility. He will assume control of an overwhelming Democratic House and must see to it that President-Elect Roosevelt's legislative program is put through in the special session.

From present indications the test of his leadership will come quickly, for it looks as if the special session of the Seventy-third Congress, because of economic conditions, will be called within a few weeks instead of mid-April, as originally planned.

Some observers believe that he will make of the Speakership more and advisory position than actual leadership. Upon the shoulders of the Democratic leader may fall the actual job of directing the forces of the party in the House.

No Depression For Texas Community

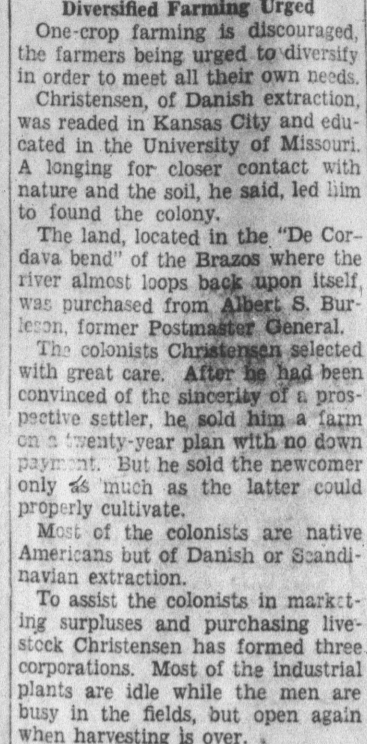

A colony founded by John B. Kristensen, Kristenstad comprises 6,000 acres in a sharp loop of the Brazos River not far from Fort Worth. Through foresight and careful planning, Kristensen has made the community virtually self-supporting.

While farming is the basic occupation of Kristenstad, industries utilizing raw materials have been established and any member of the colony may buy shares in them.

Metal merchandise checks redeemable at the Kristenstad general store are the principal medium of exchange. Some United States money finds its way into the colony when farmers dispose of surplus produce in Fort Worth or other nearby towns; however, they are prohibited from such trade until they have set

Democrats' Control Gives Pittman Wide Selection Of Posts

By HERBERT PLUMMER. Washington—(AP)—That one-time Alaskan sourdough and gold-hunter, now senator from Nevada—Key Pittman—must be having a hard time making up his mind as to just what political plums he'll take when the Democratic caucus actually gets around to perfecting its organization in the coming special session of Congress.

Pittman has been the Democrats' perennial candidate for president pro tempore of the Senate—that body's highest elective office.

Now the path is cleared for his election. But other obstacles have arisen.

When President Roosevelt reached into the Senate and took the late Thomas J. Walsh of Montana and Claude A. Swanson of Virginia into his cabinet, Pittman found himself pushed to dizzy heights in Senate seniority.

The removal of Swanson placed him in the No. 1 position on the foreign relations committee. The death of Walsh puts him in the same place on the mines and mining committee.

Before that, in his own right, he was No. 1 man on the committee on public lands and surveys and the highest ranking Democrat on the territories and insular affairs committee.

He stands No. 2 on the Interstate Commerce committee. On this committee only Senator Smith of South Carolina outranks him, and Smith is No. 1 on the agriculture and forestry committee.

In all, therefore, Pittman has his choice of the chairmanship of four of the Senate's major committees, a probable choice of a fifth and, in addition, the office of president pro tempore.

Take the foreign relations committee, for example—the job that Senator Borah of Idaho has held and in which he took such pride. If Pittman doesn't take the chairmanship here's what may happen:

Joseph T. Robinson of Arkansas is next in line. Robinson, however, is the Democratic leader of the Senate, Walsh of Montana was next in rank, but death removed him even before he began his cabinet service. Harrison of Mississippi is next, but he is in line for the chairmanship of the all-powerful finance committee and would scarcely think of giving that up. Then comes George of Georgia the next in line.

SPORT SLANTS

The next and probably the last time Glenn Cunningham races Gene Venke on the boards this winter, it is not likely the chunky Kansas miler will be so misled by over-confidence as he was on the occasion of his first defeat of the season in the national championship 1,500 meter thriller at Madison Square Garden.

They are billed for their fourth and final duel of the indoor campaign in the Knights of Columbus meet, on the eleven-lap Garden oval, March 15. It will be a "sell-out," for this rivalry between Gene and Glenn is the most noteworthy in foot-racing since Paavo Nurmi and Jole Ray were running the boys dizzy back in 1925.

Lacking as much finishing "kick" as his rival Venke nevertheless has demonstrated his gameness. Under Lawson Robertson's able conditioning the Pennsylvania boy may be expected to be at his best for the "Columbian Mile."

Cunningham, on his third trip East, will not let his friends make the mistake they did the last time of conceding victory in advance and of ballyhooing an attempt of the Kansas flier to go on for 1,500 meters to the mile in a record attempt.

He should be satisfied to run his race, stick close enough to Venke to be in a position to put on the last-lap pressure and let the timekeepers do their own worrying. In trying to get the pole position too quickly in the championship 1,400 Cunningham ran himself ragged, got an elbow poke in the eye and stumbled at least twice.

The race was a hair-raiser, but poorly run. In their anxiety to win, like a pair of boxers throwing all caution to the winds and slugger toe to toe, Gene and Glenn forgot all their usually skillful tactics and literally ran each other into the boards.

Metcalf Heads Sprinters

If there's a smoother piece of running machinery in the country than ebullient Ralph Metcalf we have not seen or heard about it this winter.

The Marquette flier, as we have remarked before, looks unbeatable for 1933, barring accidents. He might have been the world champion last year but for the fact he reached his peak in the final Olympic trials and national championships, instead of the Olympic games.

Metcalf's eyelash victory over Emmett Toppino for the indoor sprint crown at 60 meters shows he is getting away faster than ever. He settles quickly into high-gear and figures to pull away from Toppino, Wykoff and the rest, at any distance from 60 to 200 meters.

Likely Looking Lad

Stanford University's dynasty of weight-lifters, consistent point winners from Hartranft, Hoffman, Krenz and Rothery up to the present crop headed by Gray and Laborde, seems likely to remain intact, according to the latest report of my chief scout at Palo Alto.

Gordon "Slinger" Dunn, a mere stripling standing 5 feet 6 and weighing 240 pounds, is making arrangements to transfer from Menlo Junior College to Stanford for the next quarter.

Working out under "Dink" Templeton, the Indians' head track and field coach, Dunn already has heaved the shot 50 feet 10 inches and soun the discus 151 feet 2 inches. He lives in Fresno and was a state high school champion in both events in 1930. He will be quite an athlete when he grows up.

Lure Of Pro Golf Draws Dewey Byrd

Birmingham Ala.—(AP)—One of baseball's premier golfers, Samuel Dewey Byrd, youthful New York Yankee outfielder, had no intention of being lured into professional golf—at least for several years to come.

"I get a bigger kick out of a single, than any golf stroke I could make," said Sam, a day or so after he had equalled the Roebuck course record of 65, six strokes under par for the 6,370 yard lay-out.

Byrd, who is only 25, figures his best baseball is ahead of him, and he has several more years to worry about his batting average, before he considers what he will do on retirement.

"I don't get steamed up over golf, but baseball—" said Sam, "the character of the other fellows, the crowd cheering and razzing, it gets you to going."

"Golf is a fine conditioner. It develops the wrists, keeps the shoulders and legs limbered up through the winter, and it is easier to get down to form for baseball in the spring."

After the last man is out in the fall, Sam heads for Birmingham and within twenty-four hours is tuning up his golf game.

"It takes me about a week to get my swing back; in that time I am hitting them on the nose," he said. He won a driving contest at New York City two years ago with a drive of 319 yards.

With his older brother, Curdy Byrd, pro at the Hillcrest Country Club here, Sam picked up golf while cadging over the Roebuck course as a boy.

Although he goes to "big brother" when his shots fall, he usually beats him in match play. The 65 was made in a foursome with Curdy, "Big Ed" Wells, Yankee pitcher who winters here, and Johnny Morris, a promising amateur.

In the bewildering forest of current national problems one brilliant light is burning, and it gives infinite hope to the new administration. It radiates from the particularly auspicious, non-partisan, non-sectional support which has rallied around Mr. Roosevelt.

The pre-inaugural period passed with only sporadic and unimportant rekindlings of the bitterness of the campaign. Selection of the cabinet aroused a minimum of hostile comment.

As March 4 rolled around the ordinary sniping of such ears of political change died out almost entirely.

In his own party the new President has managed to keep his status, as leader of no particular faction, but friend of all. The insurgent Republicans have not been so happy in years. Even the old-line Republicans show an extraordinary disposition, in view of the seriousness of public problems, to keep silent where they cannot praise.

So strong was this trend that the first history making act of the Roosevelt regime actually took place before the Roosevelt administration began, when Congress finally manifested a majority willingness to give the new President a sweeping grant of power over governmental organizations.

The second act of the unfolding drama is Mr. Roosevelt's dealing with the bank situation—a matter in which he was assured in advance of the earnest good wishes of every community from Wall street to the smallest country town.

What is to come next cannot be fully foretold, but one thing is impressive: The inaugural outpouring at Washington appealed to the old-timers as something far more than a party jubilee. It had much of the air of a serious public pledge of help.

The files in the ointment are so few as to be conspicuous.

The strong words of President Green of the American Federation of Labor, saying he never could become reconciled to the appointment of Miss Frances Perkins to the labor secretaryship, may be political portents or may reflect only a passing disappointment.

The federation was much surprised at this choice. It had its own candidate, and its leaders put their own interpretation on an interview they had with the President-elect.

Because of this apparently they hoped against hope to the last that a labor leader would be made secretary. But their dissent from Miss Perkins coincided with a great chorus of praise from women.

Another organized group—that of the ex-soldiers—already is looking with manifest apprehension on reported plans not only to sidetrack

the bonus, but to cut into present veteran allowances.

When you sum it up, Mr. Roosevelt's expectancy of support from the country generally appears, at this stage, so much above normal as to be almost epoch-making in itself.

New Books

New York—(AP)—The advent of what is known (for want of a better adjective) as a distinguished novel is an occasion for bell-ringing in any time—particularly now. There will be such goings on for Marjorie Kinnan Rawlings' "South Moon Under."

The book really is distinguished. It is set apart most obviously by its unshakable locale, the interior of Florida. A number of things combine to give it a flavor of its own, one of the chief things being the author's deft use of dialogue. There is a great deal, and it never jars.

It is a story of simple people, but not too simple. So it gets in among the reader's elemental emotions and stirs them mightily. The woman Pietry is so alive and tangible that her death (told with fine simplicity) is almost a personal loss, for the reader.

The interplay of emotions and the necessities of daily life make a pattern every line of which has the inevitability that is the goal of good fiction.

And the prose is admirable, supple and often glowing.

Ring Lardner's familiar rookie baseball hero has returned and with him the equally familiar girl back in the home village. The rookie (this time Danny) is again stupid and struggling and the girl (this time she is called Jessie) is again devoted and at times a little difficult.

It is Mr. Lardner's function to bring to life this formula again and again. In "Lose With a Smile," he does it with the uncanny skill of that vaudevillean who flings knives at the beautiful girl on innumerable stages.

Speaking of functions, it is that of Alan Villiers to set down all he knows and can discover about sailing ships, which represent to him the most worthwhile part of the sea, and which he feels will disappear entirely in another dozen years.

The latest of his considerable series of books about life "in sail" is "Grain Race," the story of one of those epic contests between towering barques, racing with grain between Southern Australia and the English channel. It is not only a worthy narrative; often it becomes a disquisition on ships and their gear that has a quaint fascination for the landbound.

State Banking Situation. (By The Associated Press)

Banks in Charlotte, Durham and Elizabeth City opened today under federal restriction of emergency banking holiday but those in Dur-

ham and Elizabeth City closed after being open five hours when advised by a ruling of Commissioner Hood that no banks in the state may legally open till the holiday expires.

Charlotte's six commercial banks, the National Bank of Durham and two banks in Elizabeth City were first to take advantage of modification of the federal emergency law issued by Secretary Woodin.

Shortly after the banks opened, Hood announced his plans. Four of the national banks remained open until regular closing time despite the announcement.

Charlotte bank executives held they were acting under federal laws and were within their rights. While open the banks allowed free access to safe deposit vaults, handled drafts cashed government checks, provided means for safekeeping of valuables and accepted payment on obligations to individual banks.

What Banks Can Now Do. (By The Associated Press)

Under regulations issued by Secretary Woodin banks are permitted to exercise the following functions: Handle drafts or other documents on shipments, transportation of food and other products.

Accept payment on accounts or in settlement of obligations due by customers. Make change.

Allow customers free access to safety deposit boxes. Cash checks drawn on the U. S. Treasury on condition that no gold certificates be paid out.

Return with restriction all cash and checks and items delivered for deposit or collection after the last closing of business hours and which have not been entered on the bank books.

Pay out without restriction new deposits made on trust funds accounts on condition that no gold certificates be paid out.

Complete settlement of checks charged to account on or before March 4, provided paying does not involve money or currency.

Return to customers documents and securities held for safe keeping. Exercise usual banking functions to provide for necessities of communities, food, medicine, relief of distress, payrolls and expense to maintain employment.

Deposit collateral in United States to secure advance to branches in foreign countries.

Authorization revocable at discretion of the secretary of treasury. Banks are authorized to continue to act as trustee, executor, administrator and other estate functions, provided no currency is paid out.

TO PROBE PUBLIC SALES BY CHURCHES

The Secretary of the Chamber of Commerce learned this morning that the States was planning to investigate the various articles that church auxiliaries and societies are selling to the public. The investigation is being made because a group of women in a number of cities are selling and delivering hosiery and other articles. The State contends that they are subject to a tax under Section 121 of the Revenue and Machinery Act. The section reads as follows:

"Any person, firm or corporation who or which shall carry from place to place any goods, wares or merchandise, and offer to sell or barter the same, or actually sell or barter the same to other than merchants, dealers, or those regularly engaged in the mercantile business, shall be deemed a peddler, and shall apply for and procure from the Commissioner of Revenue a State license for the privilege of transacting such business, and shall pay for such license the following tax: Peddler, on foot, for each county, \$25; peddler, with vehicle propelled by motor or other mechanical power, for each county, for each vehicle, \$100. Counties, cities, or towns may levy a license tax on the business taxed under this section not in excess of that levied by the State."

The Chamber of Commerce maintains a library of the revenue laws and will be glad to advise the members of any organization the amount of taxes they are subject to pay before they obligate themselves to sell various articles.

WANT JOHNSON TO REMAIN AS MINISTER

Kinston, N. C., March 7—The First Baptist Church here hopes the Rev. Talmadge C. "Casey" Johnson will become its regular pastor. He was called last summer to serve as supply pastor for ten months. Why, was not explained, but persons outside the church recalled that it had had fifty or more pastors in a century, and that no one stayed more than a few years.
