PRESIDENT PROPOSES RE-OPENING BANKS

Roosevelt Recommends Expansion Of Currency In Message To Congress

MAKES APPEAL FOR ACTION AT EARLY MOMENT

Proposal Also Presented For Reorganization of Weak Banks to Enable Them to Re-open; Seek Control of All Banks by Executive Branch of Government to Protect Depositors; Asks For Adequate Currency To Take Care of Emergency Situation

Washington, D. C., March 9.—(AP)—President Franklin D. Roosevelt in his message to Congress today proposed immediate re-opening of all sound banks and provision for currency expansion during a bank reorganization.

"I cannot too strongly urge Congress of the clear necessity for immediate action," he stated.

The text of the President's message follows:

"To the Senate and House of Representatives:—

"On March 3 banking operations in the United States ceased. To review at this time the cause of the failure of the banking system is unnecessary. Suffice it to say that action has been completed to step in and improve the position and business of the nation.

"Our first task is to re-open all sound banks. This is an essential preliminary to subsequent legislation directed against speculation with funds of depositors and other violations of positions of trust.

"In order that the first objective for the opening of banks for re-summation of business may be accomplished, I ask Congress for the immediate enactment of legislation giving to the executive branch of government control over all banks for the protection of depositors.

"Authority forthwith to open such banks as have already been ascertained to be sound and other such banks as rapidly as possible and authority to reorganize and reopen such banks as may be found to require reorganization to put them on a sound basis.

"I am asking for an amendment to the Federal Reserve Act to provide for additional currency to adequately secure as becomes necessary to meet the demand for currency and as the same time to achieve this end without increasing the unsecured indebtedness of the government of the United States.

"I cannot too strongly urge upon Congress the clear necessity for immediate action.

"Continuation of the strangulation of bank facilities is unthinkable. Passage of proposed legislation will end this condition and I trust will in a short time result in the resumption of business activities.

"In addition it is my belief this legislation will not only lift all unwarranted doubt and suspicion in regard to banks which are one hundred per cent sound, but will mark the beginning of new relations between the banks and the people.

"Members of Congress, I am confident, will realize the grave responsibility resting upon me and them. In the short space of five days it is impossible for us to formulate complete measures to prevent recurrence of the evils of the past. This does not and should not justify delay in accomplishing the first step. At an early moment I shall inform Congress of other measures which I regard as of immediate urgency.

"With action taken thereon we can proceed to the consideration of a rounded program for national restoration.

"FRANKLIN D. ROOSEVELT, White House, March 9."

Late News Flashes

Senate Considers Roosevelt Plan. Washington, March 9.—(AP)—President Roosevelt's emergency bank bill submitted to Congress today is carrying out a program of controlled expansion of currency and resumption of normal banking under his regulations.

The bill would ratify the executive orders issued by the President and continue his authority over the banking situation; provide for the concentration of the nation's gold supply in federal reserve banks; penalize hoarding, and provide for controlled expansion of currency. The bill was introduced by Senator Glass of Virginia.

Senator Robinson, the Democratic leader, said he was convinced the bill was sound and that if passed today will assure opening many banks both national and state, which are preparing to accept him.

CLINICS MAKE FINE SHOWING
Twenty-seven children operated on at Winterville School Yesterday

Twenty-seven children were operated on in the adenoid and tonsil clinic conducted by the Department of Health at Winterville yesterday. It was announced today by Dr. R. S. McGeachy, director of the department.

It was the third of the series of clinics being conducted in the various schools of the county in an effort to improve the health of the children who are retarded in their studies because of adenoids and tonsils.

The first two clinics were held in Grimesland week before last and fifty-five children underwent operations. The situation in that community was described by health authorities as more severe than any other section of the county by reason of the fact that examinations disclosed more children suffering from adenoids and bad tonsils.

Public health workers were at Pactolus today making examinations in preparation for a clinic to be conducted in the school there next Tuesday. A classroom is being set aside in each school for clinic activities and due to this privacy considerable progress has been made in the health work.

The clinics will continue until every large school in the county has been visited. Threat specialists of Greenville are in charge of all operations, assisted by the health director and employees of his department.

The clinic program is the most far reaching ever conducted in this county and was expected to improve the health of children whose parents are financially unable to pay for medical attention.

DANIELS IS SLATED FOR FEDERAL JOB

Raleigh Man May Head New Government Group; Shipping Also Boosted

Washington, D. C., March 9.—(AP)—Joseph Daniels, Secretary of the Navy in the Wilson administration, was understood in informed circles today to be slated for the chairmanship of the government group to include the Interstate Commerce Commission the Shipping Board and another branch of the Commerce Department.

Such consolidation would bring together the major constitutional agencies of the Federal government. It has been indicated for sometime that something of the sort was being considered by the President.

Daniels, publisher of the Raleigh News and Observer, was Secretary of the Navy while Franklin D. Roosevelt was Assistant Secretary. (Continued on Page Four)

THREE-CORNERED RACE FOR POSITION OF MAYOR
New Bern, March 9.—Three candidates have announced themselves officially in the race for the mayoralty of New Bern, subject to the Democratic primary, which has been called for Tuesday, April 4. These are former Mayor Albert H. Bangert, Leon C. Scott and William C. Chadwick.

Although no other political announcements as yet are forthcoming, it is understood that the campaign will be lively, due to the three-cornered race for mayor. Most of the present aldermen will seek re-election it is believed. The other three elective officers will seek another term and probably will not have any opposition. City Clerk Frank T. Patterson, Tax Collector Edward Clark and Chief of Police A. L. Bryan.

NEW TAX MACHINERY IS PLANNED IN VANCE
Henderson, N. C., March 9.—It was understood today that virtual agreement had been reached at a meeting of the Vance Board of Commissioners last Monday on a plan for separating the collection of taxes for the county from the office of the sheriff and creating the new office of tax collector. A bill to provide for that is expected to be offered in the General Assembly by Senator D. P. McDuffee, who discussed the matter at the board meeting.

Under the plan as rumored today, the sheriff would have nothing to do with tax collections, and his salary would be cut from \$3,240 as at present to \$2,500. The tax collector would receive a straight salary of not less than \$2,000 and not more than \$2,500 and would pay his own expenses.

Zangara Pleads 'Guilty' To Murder Of Mayor Cermak

PRESIDENT AND CONGRESS STAND AS ONE ON PLANS FOR IMPROVED FINANCES

Washington, March 9.—(AP)—President Roosevelt and leaders of the new Congress stood as one today in his campaign to set aside the immediate obstacle to the normal security of currency.

Their agreement was reached in a get-together meeting last night after midnight and was hailed by both as something that would speed the re-opening of banks.

Although details of the announcement of the currency plan to be presented to Congress today, it was said the new money was already in the making and will be issued and based on the government's obligations.

No gold is behind the currency but the soundness of the government's obligations will be guaranteed by:

- Continued check of gold.
- A budget balancing at the earliest opportunity.
- Retirement of inherited deficit.
- A drive to make gold hoarders lose their grip on the hoard by March 13th.

The fact that government bonds are redeemable in gold.

The people who sat in the meeting when this plan was agreed upon saw no question but that this would give sounder money.

Senator Glass of Virginia, one of officialdom's outstanding advocates of sound money, was one of the conferees who approved the step.

GERRIG ONE GAME NEARER SCOTT'S ENDURANCE MARK
Chicago.—(AP)—Lou Gehrig, Yankee first baseman, has been moved one game nearer his ambition of surpassing the consecutive game record of Everett Scott, as the result of a ruling by President William Harridge of the American League.

Harridge held that a game played last August 1 between the Yankees and Detroit should count in Gehrig's record of games played, although the contest was riddled and played because Umpire Dick Nallin allegedly permitted certain players to bat out of order.

This gave Larrupin Lou a total of 156 games for the season (the Yanks had one tie contest) and a grand total of 1,197 consecutive games. Scott's record is 1,207.

PLEA FILED BY COUNSEL FOR SLAYER

HOUSE FROWNS ON DRY REPEAL
Raleigh, N. C., March 9.—(AP)—An unfavorable report was given today to three bills aimed at modification or repeal of prohibition laws when the Judiciary Committee No. 1 of the lower House of the General Assembly of North Carolina reversed its previous position on the question.

Unusually an unfavorable report is taken to mean the death of a bill. After very brief discussion the committee agreed to frown upon the Cover bill to repeal the Turlington Act, the State's stringent prohibition law, but it was announced that an opportunity for a favorable report would be offered the House for adoption.

No debate on the merits of the bill will be had on the floor unless the minority report is adopted.

Quickly on the heels of this came reversal of the committee's previous position on the Murphy-Bowie bill which had been twice before reported.

The act would have legalized light wines and beer by legislative act and provides for taxing sales of the beverages.

Then without too much ado, though principal opposition of the bill because it did not include referendum to throw-down act came for the proposal to legalize wines and beer and to tax them if the people voted for them.

The action on the three measures to repeal the liquor bill on the House side of the Assembly where main action or modification of the prohibition laws has been seen. The single proposal was contained in the Murphy-Waynick bill to call a special election to name a convention to consider a resolution to repeal the Eighteenth Amendment.

A public hearing on the measure will be held this afternoon by a Joint Committee on Constitutional Amendments.

HOME OF T. E. FARRELL IS DESTROYED BY FIRE
Sanford, N. C., March 9.—Monday morning the home of Mr. and Mrs. T. E. Farrell, on Highway No. 1, ten miles north of Sanford, was completely destroyed by fire. The contents were also burned, as were the outhouses in the yard containing feed, and the smokehouse in which was a supply of meat.

It is not known how the fire originated, as the family were away at the time. Mr. Farrell is a patient at the Lee County Hospital, and Mrs. Farrell had left home a short while before to go to the hospital. The loss was partly covered by insurance.

THE BEGINNING OF A NEW DAY

Under the plans outlined to Congress today by President Roosevelt such banks as are allowed to re-open immediately virtually have the stamp of approval of the United States Government which should be sufficient to allay any fears that the people of a community might have as to the safety of their banks. Of course, the present plan is just a preliminary step toward a complete re-organization of the banking facilities of our nation on a stricter and sounder basis which is necessary if the banks are to be permitted to serve their respective communities without the hindrance of fear among the people.

There must be a restoration of confidence on the part of our people if the nation is to move forward and we believe that the present action of President Roosevelt is the first step toward complete restoration of that confidence and the beginning of a new day in our land.

THERE IS BUT ONE RIGHT WAY

On many occasions we have called attention to the present inequalities in our tax system in violation of our constitution, whereby the privileged classes have been enabled to escape their just share of the tax burdens while the burdens of the masses have been increased to make up the difference. So long as these discriminations continue to exist there is little surprise that the masses of the people have been burdened beyond their capacity to pay and those few among them who are still able to pay the present system under which they are being forced to carry the burdens of the rich and as a result are declining to pay their taxes.

The news and Observer in the following comment points out that the violation of the Constitution in the statute that exempts stock in foreign corporations from ad valorem taxes and likewise the present efforts at revaluation of the property in the state under plans in strict violation of the Constitution:

There is now pending in this General Assembly a proposition with considerable support, in plain violation of two provisions of the State Constitution. They are:

1. That the revaluation of property may be reduced horizontally or that the valuation of property cannot be reduced below 3 1/2 per cent of its present assessment. Either of these provisions is contrary to the State Constitution, which in Section 3 of Article 5 prescribes that it shall be assessed "according to its true value in money." No horizontal reduction, or any percentage reduction can be enacted into law without a

clear violation of the Constitution. 2. It is proposed to give exemption from all ad valorem tax on foreign stocks, levying on such property only a six per cent tax on the dividends paid. This is the present law, which replaced the 1923 statute which gave to owners of such property complete exemption from taxation. Both are in direct violation of the Constitution, Article 5, Section 3, which reads: "Laws shall be passed taxing by A UNIFORM RULE all moneys, credits, investments in bonds, stocks, joint stock companies or otherwise; and also, all real and personal property according to its true value in money."

The former complete exemption and the present negligible tax on the income (kept secret) are indefensible in justice as well as directly in violation of the plain words and meaning of the State Constitution.

ing matters as the regulation of banking, the promotion of commerce the maintenance of a sound currency. Everywhere the great question was: How will the new President measure up to the emergency?

Seeking Leadership There were hopes, of course, that the new Congress would be better than the old, but those who spoke of it at all ended by tying in their hopes, also, with the man in the White House. The question was: Will the incoming legislators show a united front behind an administration program for real rehabilitation?

This trust to a single leader in time of trouble has been characteristic of every national crisis. It is the President who can make or mar, whose strength or weakness is almost all-important, in spite of all the labor of the fathers to devise a system of government free from dependence on any single man.

Almost immediately Mr. Roosevelt proved how ineffective the constitutional curb of power is in practice. At a moment when Congress was not even in session he availed himself of an old statute to close every bank in the country, suspend for the time being gold redemption of the currency, and authorize the use of script in place of currency.

And scarcely anyone uttered a single word of criticism of his act. Whatever the Constitution may say, the people had learned to look to a single leadership, and they did so unflinchingly again.

An Eloquent Story The full story of the new President's personal part in this event has not been disclosed by the surface developments, eloquent as they are.

It was Mr. Roosevelt himself who found the statute, who looked into the financial problems involved, who worked his proclamation into its final draft, and even directed in detail how and when it should be made public.

His approach to the special session of Congress testifies further to the depth of his determination to court responsibility, and assume leadership, whether he actually attains it, and with what wisdom he exercises it—these appear today the central considerations of American destiny.

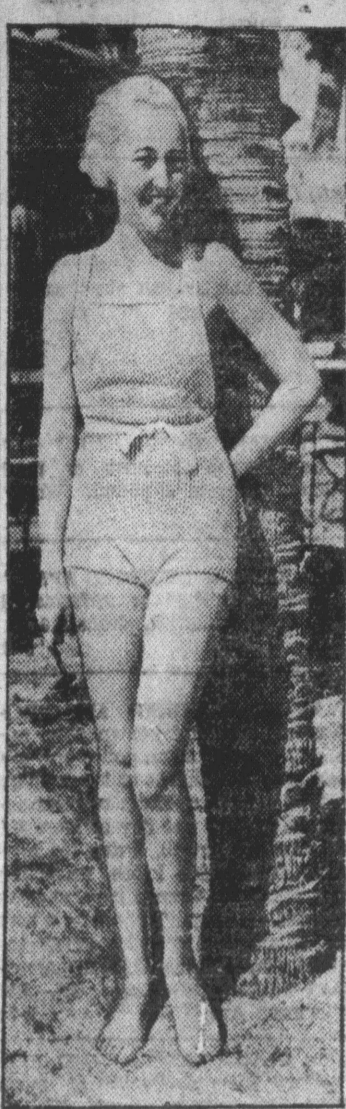

A Washington Daybook

Washington—(AP)—Another fight to discard that most cherished of all congressional traditions—the rule of seniority—appears in the offing once more as the time draws nearer for the ascendancy of the Democrats to power.

Previous attempts haven't met with much success. Both houses of Congress have clung firmly to the belief that a good congressman is made largely by experience and practice.

A newly elected member of the House from Oklahoma by the name of Will Rogers is gunning against the rule of seniority this time. He has proposed a caucus of those who will sit in the House for the first time in the coming 73rd Congress.

Promoters, however, have been quick to see the value of the seniority rule once they have gained a secure footing in their district.

For when a congressman gets his constituents in the habit of returning him to capitol hill, as Champ Clark of Missouri, a former speaker of the House, expressed it:

"He is as certain to rise as the sparks are to fly upward. No human power can keep him down."

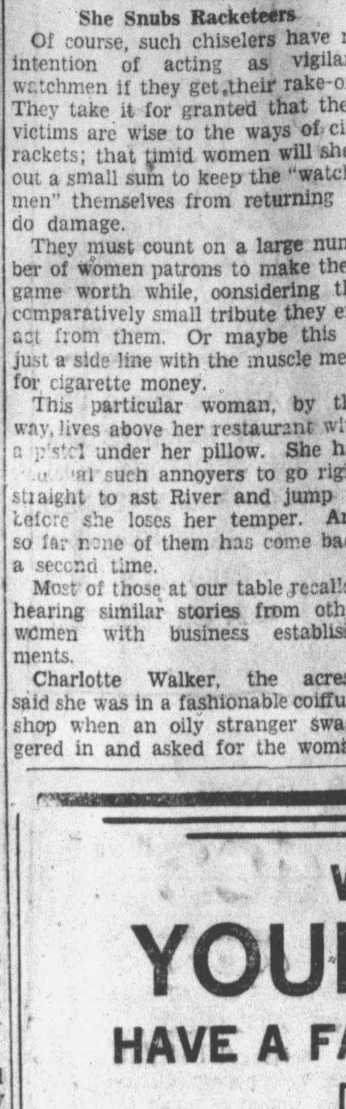

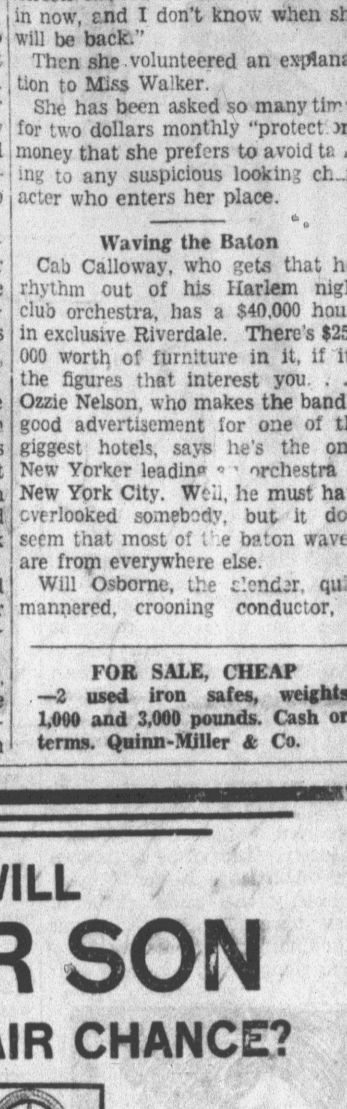

The mere fact that a "run-out" plays is the orthodox procedure on first or second down, along the sidelines, presented the chance for a smart quarterback to do the unusual, but this is strictly a minority view of the proceedings.

All things considered, it would appear about time the offense got a "break" in football and the rule-makers have recognized this by enacting the new rule to bring the ball in automatically ten yards at any time it is dead or goes out of bounds within that zone.

Modern Ball Players Are 'Babied' Too Much, Says Old Time Catcher

Minneapolis—(AP)—Add to the chorus of baseball's ancients crying out against the "softness" of modern baseball the voice of Jack Zalusky, star catcher for the New York Yankees and Chicago Cubs 30 years ago.

Modern diamond athletes are "babied too much for their own good," says Zalusky, now a guard at a Minneapolis bank. "Now-a-days when a player gets a minor injury they immediately drag him off to a hospital. In my day when some one got hurt they just wrapped a rag around his wound and he kept right on playing."

"And not only that," Zalusky adds, "too much care is taken to see that they don't get over-worked. When I broke into organized ball with Louisville in 1900 I caught 174 games without missing an inning. This was in spite of various split fingers and spike cuts."

"Our pitchers often worked three or four games in a row, and for one man to pitch a double-header wasn't unusual. Today a pitcher working two games in one day or two successive days is regarded as a phenom."

Despite modern tales of "inside baseball," Zalusky insists the present-day games isn't as "scientific" as it used to be. He calls Willie Keeler the most scientific batter of all time.

The game of today, Jack says, would be improved immeasurably if the players would put "heart and soul" into their work.

"Their primary purpose now," he says, "appears to be making money, not playing ball. In our days we played for the love of the game and practiced hours before and after the game."

Senate leaders plan to submit the measure to committee after re-organization of the Senate with a view to reporting it back in an hour and passing it in time for House action.

The bill, Robinson said, ratifies orders heretofore issued by the president and secretary of the treasury, and penalizes heretofore member banks to pay to the federal reserve gold bullion or gold certificates owned by the bank and to receive coin or currency, and advocates a heavy penalty for non-compliance.

Among other provisions the measure authorizes reorganization under safeguards and for a period of segregation of new deposits in banks of such class, the new deposits so segregated to be subject to withdrawal as the comptroller permits.

There is provision for reasonable expansion of the currency based on government bonds and assets and issuance of reserve notes.

In the provision extending the president's power, the bill providing in time of war or emergency declared by the president, he may regulate transactions in foreign exchange, transfer of credit between banks, institutions. He would also be authorized to require any persons engaged in any such transaction to furnish under oath complete information relative to transaction of contracts.

A penalty of \$10,000 fine or ten years in jail is provided for violation.

The emergency bill would permit banks to get circulating notes from the federal reserve in return for United States obligations, notes, drafts, bills of exchange and banking acceptances.

Notes would be given to banks of full value of United States obligations and 90 per cent of sound value of notes, drafts, bills and bankers acceptances.

Climbers Race Fliers In British Rivalry To Reach Top Of World's Highest Peak

By OSCAR LEIDING

London—(AP)—Two great adventures, which may develop into a race, are pointing toward the conquest of Mount Everest.

Lottiest known peak, its head towering 29,141 feet, Everest is to be assailed by land and air expeditions.

First away to the task no one has yet accomplished, though many lives have been lost in attempts, was the van of the land expedition headed by Hugh Rutledge, a retired officer of the Indian civil service.

The other seekers for the glory to be first in the conquest, compose an air expedition, financed by Lady Houston, England's "Lady Bountiful."

It includes the Marquis of Clydesdale, member of Parliament for East Renfrewshire; Air Commodore P. F. M. Fellowes, who will be in charge as technical expert, and Flight Lieutenant McIntyre. They are flying to their base in light planes.

Two airplanes will be used, with the main base at Purnea, about 160 miles from Mount Everest. The effort to photograph the world's highest peak from above is planned to take place this month.

Longer is the task of the land party, which expects to reach the base camp north of Everest in April and have nearly two months to make its attack before the monsoon.

This is formed to scale the peak afoot was formed by a joint committee of the Royal Geographical Society and the Alpine Club.

Altogether the expedition will number 14, including L. R. Wager, a member of the British Arctic air route expedition of 1930-1931, and Thomas A. Brocklebank, who stroked the Cambridge crew to victory for the third successive year in the 1931 varsity race.

Unsuccessful attempts to scale the monarch of the Himalayas were made in 1921, 1922 and 1924 and there is a dramatic possibility for both expeditions that they may find traces of Mallory and Irvine, two climbers who never returned.
