## FEDERAL RESERVE BANKS RESUME BUSINESS TODAY

### Banks In Centers Where Clearing House Facilities Exist To Open Tuesday

#### OPENING WILL BE EXTENDED TO OTHER CITIES

**President Roosevelt Tells Nation "We Have Provided Machinery to Restore Financial System; Normal Operations To Be Extended to Virtually All Sections of The Country Wednesday"**

Washington, D. C., March 13.—(AP)—The normal process of money exchange was in order for America today with the assurance from President Franklin D. Roosevelt that "we have provided machinery to restore our financial system."

"It is up to you to support and make it work," he told the nation. "The banks will take care of all needs."

Plenty of currency on "adequate security" was in the institutions permitted to resume full-time operation today in the twelve Federal Reserve Bank cities, the President assured. "Confidence and courage are the essential s of success in carrying out plans," the President said. "You people must have faith. You must not be stampeded by rumors or guesses. Try to smile in banishing fear. It is your problem no less than it is mine. Together we cannot fail."

So today the clearing houses of the Federal Reserve financial institutions in the cities where they are located resumed normal functions—provided they continued to meet requirements and took all possible steps to prevent withdrawals by hoarders.

Tomorrow in 250 or more additional cities where recognized clearing house associations exist normal functions of business of banks will be continued and Wednesday the process extended to other communities.

**Local People Reported Safe In California**

Although a number of Greenville people were in the California earthquake zone, none were believed to have been injured.

Reports received by relatives here indicated that Misses Mary Andrews and Gretchen Barker escaped without injury in Los Angeles. The same was reported of Mrs. R. M. Garrett, who is visiting relatives in California.

Although no word had been received from Major W. R. Wilson, instructor in military tactics at one of the schools destroyed by fire during the series of earth tremors, relatives here believed he was unharmed. He was said to live quite a distance from the school and probably was home when the school was wrecked, by fire.

**MORE FIGHTING IN GRAN CHACO AREA**

Asuncion, Paraguay, March 13.—(AP)—The Paraguayan war office, in a bulletin today, said the third Bolivian division had been overwhelmingly defeated after a 32-hour battle with Paraguayan forces in the Gran Chaco, where the two nations have been in conflict for several months.

The communique declared the Bolivians suffered more than one thousand casualties while fleeing from Paraguayan cavalry.

Bolivian troops it was added, had launched a general attack in the Fort Saavedra section, where heavy fighting was going on. In the vicinity of Fort Nanawa, Paraguayan forces were said to have annihilated a company of Bolivians.

La Paz, Bolivia, March 13.—(AP)—Newspapers here today announced that Bolivian soldiers had captured Fort Altiplano, in the Gran Chaco territory.

### Roosevelt Asks Light Wine-Beverage

Washington, March 13.—(AP)—In a surprise message of two sentences President Roosevelt asked Congress today to enact beer legislation immediately.

Democratic leaders of both houses let him know at once they would follow his recommendations.

Vice-President Garner referred it to the Senate finance committee. Rep. Rainey turned it over to the House ways and means committee.

The prospect was that within a few days both branches would approve the legislation and put taxes on beverages named to bring in \$150,000,000 a year toward balancing the budget.

Called at the White House, "The briefest presidential message in history," President Roosevelt's 73 words were:

"I recommend to the Congress the passage of legislation for the immediate modification of the Volstead act in order to legalize manufacture and sale of beer and other beverages of such alcoholic content as is permissible under the constitu-

tion; and to provide through such manufacture and sale by substantial taxes a proper and much needed revenue for the government.

"I deem action at this time to be of the highest importance."

The Democratic leadership and anti-prohibitionists expressed confidence the vote to pass the bill without much ado was to be had.

"I hope it may be disposed of as promptly as it may be found practical," Senator Robinson of Arkansas, Democratic leader, said, adding that "we will have to get this economy program out of the way first, however."

Few members knew the message was coming. When A. E. Scheewe read the first line shortly after the noon meeting hour the House burst into wild applause. Persons in the sparsely filled gallery joined the members. A few rebel yells were shouted. At the conclusion of the short message some members applauded. Others shouted and smiled broadly.

### WIFE SHOTS HUSBAND HERE

**Mrs. Herman Evans Fires on Mate When He Attacks Her With a Chair**

Herman Evans filling station operator in the southern section of the city, was seriously shot by his wife when he was alleged to have attacked her at their home on Twelfth Street Sunday night. It was divulged at police headquarters this morning.

Evans was in the local hospital with a ragged bullet wound in his stomach, and while his condition was serious, belief was expressed he would recover.

The trouble started, police said, when Evans went home in an intoxicated condition. After allegedly choking his wife, Evans was said to have advanced upon her with a chair. She brought a pistol into play, firing a single bullet into his stomach.

The woman was said to be confined to her bed today suffering from shock and a badly bruised throat. No action had been taken against Mrs. Evans in view of the fact that she was said to have shot in self-defense.

### INCOME TAX PERIOD SHORT

**All Returns Must be Filed Before March 15, State Revenue Head Says**

Raleigh, N. C., March 13.—(AP)—North Carolinians should make their income tax returns before March 15, whether or not checked with the returns may be cashed, Allen J. Maxwell, State Commissioner of Revenue, said today.

Mr. Maxwell issued the following warning:

"As the banking situation may not be entirely cleared up by next Wednesday, March 15th, the final date for filing income tax returns, taxpayers are advised to file their returns in the usual way, and checks with such returns filed by March 15 will be accepted for collection and, if necessary, held temporarily until banks on which checks are drawn are open for clearing.

"When such checks are drawn against adequate credit balance, no penalty will be imposed or interest charged for temporary delay in making collection on account of existing restrictions upon banks.

"Unless proper return is made, however, within the time specified, taxpayers will be liable for penalty and for interest beyond March 15th."

### Hoarders Face \$10,000 Fine, Treasury Says

Raleigh, N. C., March 13.—(AP)—The State Bank Commissioner estimated today that there is now \$25,000,000 hoarded in North Carolina, and said that new regulations received from the Secretary of the Treasury makes the hoarding of gold, gold certificates and currency a felony, punishable by a fine of \$10,000.

The statute includes payments by a bank to customers for hoarding purposes.

### PUSH EFFORT FOR REOPENING STATE BANKS

**Applications From Various Institutions Studied in Office of Hood**

Raleigh, N. C., March 13.—(AP)—Plans for getting banking machinery in North Carolina in motion moved forward today as applications for permission were studied at the office of Gurney Hood, Commissioner of Banks.

Hood announced that license for unrestricted opening in this State before Wednesday would be granted in no case except where necessary to supplement Federal license.

He declared that when licenses for unrestricted opening are issued the banks must be in sound condition. All applications are to be examined by bank examiners will be re-examined by a committee of three bank examiners and will be dispatched by bank examiners to the Bank Commissioner and then will be sent to the governor for his approval.

In case applications are disapproved, institutions may appeal to an advisory commission whose ruling is final.

**Extend 300 Student Notes**  
Ann Arbor, March 13.—The world's largest collection of Michigan students who paid 60 per cent of their tuition in the fall and gave notes for the balance due at the beginning of the second semester have been set at rest by action of the board of regents, who voted to renew the notes at their recent meeting. Granting of credit for study is conditional to final settlement of the note.

**JAPS REPORT FIERCE FIGHT**

**Five Hundred Chinese Killed in All Day Engagement at Hsifeng-kow**

Chinchow, March 13.—(AP)—Japanese reports said today five hundred Chinese were killed in a battle which lasted all day Sunday at Hsifeng-kow, one of the passes in the Great Wall of China.

The Japanese casualties were listed as 13 killed and 31 wounded.

**Kupei-kow, China, March 13.—**  
(AP)—(Delayed in Transmission)—As a dramatic sequel to the capture of Kupei-kow, gateway from Jehol to Peiping, the Japanese have sealed this most important pass in the Great Wall, cutting off scores of thousands of Chinese irregulars, volunteers, deserters and brigands remaining in the Jehol province.

Some of these are preying on peaceful patriots in the province which is being brought under the government of Japanese of Manchukuo. The Japanese military leaders admit it probably will require months to eradicate these.

The Chinese population of Jehol seemed genuinely relieved when the Japanese arrived. It was more afraid of the Chinese guerrillas and also the hundreds of criminals released by the retreating Chinese who threw open jails.

Concerning fears that the Japanese would continue advancing on Peiping, where there are large American and other foreign colonies, Lieut.-General Yoshikazu Nishi told the Associated Press, "I have positive orders from Tokyo not to invade Peiping unless the Chinese challenge us."

## New Earth Tremor Causes Additional Damage In The Southern Part of California

### LONG BEACH SUFFERS ONLY REAL DAMAGE

**Sections of Department Store Fall Into Street But Nobody is Hurt; Disturbance One of The Heaviest Since The First Shock Last Friday; Other Cities Describe New Tremor As "Pretty Heavy"**

Los Angeles, Calif., March 13.—(AP)—Dawn of the third day after the earthquakes Friday brought another tremor which sent thousands of Southern Californians out of bed at 5:19 today and caused slight damage in the Long Beach area where most of the destruction of the original disturbance occurred.

Telephone in police and newspaper offices range frequently for the first few moments after the last disturbance bringing in anxious inquiries.

There were no further casualties reported, although a short time before the shock the coroner's office reported the death of the 118th victim, Henry Ufen, 45, of Los Angeles.

Often died in the General Hospital from injuries received Friday night when he was hurled into the air beneath the wheels of an automobile. His was the fourth death reported in Los Angeles.

The tremor this morning was felt with varying intensity in all of the devastated areas, but the only reports of damage came from Long Beach where about fifty-three were killed in the first earthquake shaking. Sections of the coping of a large department store fell into the street at Broadway and Pine in the heart of the business district of the city. No one was hurt.

The disturbance at Long Beach was one of the heaviest since the first shock, and likewise in San Pedro where damage had been extensive.

Pasadena, Santa Ana, Inglewood, Santa Monica and Compton joined in description of it was "pretty heavy."

**Three Fires Over Week-End**

Three fires over the week-end did damage which firemen estimated at around \$4,000.

The most destructive of the blazes was that which badly damaged the Key Brown building at the corner of Eight street and Dickinson avenue formerly occupied by the Ricks Tire and Battery Company. Flames originating in a drug store adjoining the battery company spread through that building and burned through to the second floor before finally being brought under control by firemen. The cause of the fire was undetermined. The loss was estimated around \$3,500 or \$4,000.

Saturday evening a small blaze in a doorway of Johnston's warehouse in tobacco town was extinguished by a passerby and the fire department was not called out. The fire was believed to have been started by a cigarette carelessly tossed into the doorway.

About midnight Saturday a small blaze did damage of about \$4 worth at the home of Della Perkins in the colored section of the city.

**Rev. T. M. Grant and Rev. Albea Godbold Speak at Methodist Church**

The speaker said that our English is not sufficiently flexible to carry over the meaning of the Greek of the New Testament, therefore we lose some shades of its meaning.

The text, "From henceforth let no man trouble me; for I bear in my body the marks of the Lord Jesus." Paul was trying to get some great lesson across to the Galatians, and in order to do this he spoke in terms of the experience of the people. He compared himself to a slave that had been branded. Those slaves that had been branded for some religion had been branded for the Christian religion. Paul was seeking to let the people know that there was no question about his apostleship. Religion is progressive in this revelation of Paul.

The Galatians had learned much about contemporary religions. These about religion that was released by particular ceremonies. Paul believed in the possibility of man's nature having fellowship with God. We do not reach God through nature having fellowship with God. We do not reach God through abstract thinking but through experience. Great experiences do not come to one through religious ceremonies, but when one is big enough to suffer.

**NEGRO HELD FOR ASSAULT**

**Poss Taft Charged With Critically Injuring Joe Glover in Dispute**

Poss Taft, colored, was held in jail here today charged with hitting Joe Glover in the head with a stick of wood and seriously injuring him.

Taft was at first thought to have sustained a fractured skull and little hope was held out for his recovery, but his condition had greatly improved today and he had a chance to live.

The two men engaged in a dispute the police said, and Taft picked up a piece of wood and attacked Glover.

Taft will be held in jail for preliminary hearing which probably will be given as soon as the full extent of the injuries of Glover has been determined.

**McDONALD CONFERS WITH ARMS CHIEFS**

Geneva, March 13.—(AP)—Prime Minister Ramsay MacDonald of Great Britain, who has come here with his foreign secretary, Sir John Simon, in an attempt to break the deadlock in which the world disarmament conference has found itself, conferred today with a number of delegates to the conference. They were Hugh Gibson and Hugh Wilson of the United States, Count Rudolf Naldy of Germany, and Baron Pompeo Ololisi, of Italy.

The contract for the new structure was awarded to C. B. West, local contractor, and all materials to be used were purchased locally, it was stated, by representatives of the concern this morning. The project will cost \$60,000.

### Greenville Declared New King Of Bright Leaf Belt

Raleigh, N. C., March 13.—(AP)—Wilson for years perched on the throne in North Carolina's tobacco market kingdom by reason of leading all markets in sales, has been displaced and a new monarch, Greenville, sits on the throne.

Wilson laid claim for many seasons to the title, "The World's Largest Tobacco Market," but no more can the slogan be used.

During the "scarce" season of 1932-1933 Greenville sold 35,152,106 pounds of tobacco for farmers and had total sales of 39,353,988 pounds at an average of \$11.99 per hundred pounds.

In 1931-1932 the market sold 58,671,183 pounds at \$9.40 per hundred.

Wilson, where producers' sales aggregated 77,783,672 pounds for 1930-1931 with total sales of 85,884,616 pounds for that season, watched Greenville forge to the front as the best that the former world's largest market could do this year was to muster 33,891,238 pounds of producer's tobacco and total sales of 37,644,338 pounds. The Wilson average, however, was \$12.37 per hundred this season and \$9.05 last.

There were 136 warehouses operated in forty-one markets this season.

**SIZE SHORT ON ALIMONY**

**Taylor Jailed Here Today Because of Failure to Meet Court Order**

William Sizemore, local tailor, was jailed this morning for failure to pay alimony to his wife as provided at a recent session of Superior court here.

He was said to have been \$45 behind with his payments when the court order for his arrest was issued last Saturday. He was given until today, however, to make settlement and when he failed to do so the sheriff placed him in jail to await action of the court.

Size, who told the court he had had six wives in his day, is a veteran of the Spanish-American war and was active in the formation of a veterans camp here sometime ago. He has lived in Greenville for a number of years, and during that time was said to have acquired the majority of wives who were disposed of through the divorce route.

**DESTRUCTIVE FIRE IN NEW HAMPSHIRE**

Somersworth, N. H., March 13.—(AP)—The worst fire in Somersworth's history swept through an entire business square today leveling six buildings to the ground and doing damage estimated at \$200,000.

Fifteen business establishments and four families lost everything as the fire, believed to have started from either a defective chimney or overheated stove in a garage, swept through the Knights of Columbus Hall, a four-story converted hotel and other buildings.

**DON'T HOARD**

While the recent government orders against hoarding have been taken generally to apply only to those hoarding gold, attention is called to the fact that the law against hoarding applies to gold, gold certificates or other currency. In other words, if you have large amounts of cash or amounts beyond your reasonable needs in your possession or hid away either in the old sock or in safe deposit boxes you are guilty of a felony under the anti-hoarding law. Money is meant to perform but one function and that is to be a medium of exchange. When it is drawn from a bank to be stored away out of circulation it proves of no value to anyone and it is to prevent this practice that the government has taken a hand.

Under the present banking reforms the government intends to make sure that your money will be safe in the banks or if you do not wish to put it into the banks there is the postal savings system or government bonds into which you can put funds not needed for use at this time. With the facilities for safeguarding your surplus funds there is no necessity or reason for the hoarding of money of any kind and the government is going to see to it that this money comes out from its hiding places.

**RINGS UP 1,000 POINTS IN COLLEGE CAREER**

Pittsburg, Kansas. (AP)—Ernie Schmidt, star center for Pittsburg Teachers' College, has closed his collegiate basketball career with exactly 1,000 points to show for four years of competition.

**Fixed-Date Easter Being Debated By Churches' Council**

New York, March 13.—Easter, the calendar's wandering child, is receiving the churches' attention from a new angle.

Shall it come to roam through March and April, coming one year when snow is on the ground and another when spring flowers are in full bloom?

**Variation Termed Nuisance**  
Or shall the churches, forgetting tradition, agree to a fixed date, thus placing themselves in alliance with various groups who contend that the feast day's variable occurrence is a nuisance to business, financial and educational systems?

These are some of the questions which the research department of the Federal Council of Churches, acting on instructions from the council's executive committee, is trying to answer.

In doing so the department is studying the attitude of the council's twenty-six denominational members to calendar reform in general as well as to the stabilization of Easter in particular.

**Calendar Change Involved**  
The survey is being undertaken at the request of the Universal Christian Council of Life and Work, at Geneva, acting at the instance of the League of Nations, which has long been studying the question of a new calendar.

Proponents of calendar reform point out that under the present system Easter can fall on any one of thirty-five dates.

Furthermore, they say, the clothing and millinery trades make Easter a pivotal point. If it falls early, people won't buy spring outfits; if it falls late, they may wear winter clothing till Easter, then change to summer styles, neglecting spring outfits entirely.

A variable Easter, they argue, disrupts school vacation schedules and effects communication programs.

**Many Nations Approve**  
The League of Nations reports that twenty-six governments, including France, Germany, Spain, Great Britain and the United States, have endorsed its act for the stabilization of Easter.

The Sunday following the second Saturday in April has been suggested by some governments as suitable for the observance. A fixed date, such as Sunday, April 8, which would be possible if a perpetual calendar should be adopted is preferred by some groups and individuals.

King George has consented to the sale of a gramophone record of his Christmas Day broadcast to the Empire on condition that the proceeds go to the British "Wireless for the Blind" fund.

## HOLLYWOOD SIGHTS AND SOUNDS

Hollywood, Calif. — When major studios release features that are more or less alike in theme what is known as a "cycle" in films is born.

But if two studios making two reel comedies release virtually the same picture the coincidence is likely to be called plagiarism.

It was Ernest Pagano, Educational's scenario chief, who pointed out this difference the other day explaining whytwo reels don't come in cycles.

**Getting There First**  
"We beat everybody to the technology idea in making Technocracy," he said. "We also had in mind a comedy on women's wearing of men's clothes—to tie in with the Marlene Dietrich fad—but Bryan Foy fled the title, 'She Wears the Pants' first; so were dropping it."

Current events so popular as feature subjects, don't rate so highly in the slapstick plants. Topics of the day lend themselves readily to dramatic treatment, but many people see no humor in them, according to Pagano.

Pagano doesn't like slapstick himself, but admits it gets laughs where subtler comedy fails. "Slapstick with a reason is all right," he says, "but meaningless falls and blows are meaningless."

Cycles in features, by the way, have come in for much recent attention. First M. C. Levee, with other remarks on the sad state of the industry, labeled "cycles" the producers' feeble alibi for their practice of copying each others' ideas.

**Newspaper-Like**  
Then Jack Warner, producer chief of the studio that all but specializes in topical features, announced his organization would continue to "anticipate trends and cycles" through use of the "reportorial system" of screen writing.

In other words, it will send out screen writers as "reporters" on unusual situations to bring back their data and concoct screen are therefrom. Two features already have been produced in this manner.

The "reporter" it seems, submits

his facts to a screen "gally editor" and "rewrite men" for working into screen play form.

In another sense, the "rewrite man" has been responsible for a great many of the screen's "cycles"—just as Ernie Pagano pointed out. Only in the world of features they call it a "cycle," and not plagiarism.

## New Books

New York—The people who go to pieces and see things have rather the better of the book man; this week.

One of the most sensitive books of the lot is done by an English cooperation lawyer named J. J. Hall, who went adventuring in quest of health. And curiously his adventuring was done in the American southwest.

He and his wife held two ranch jobs in the neighborhood of Santa Fe, N. M. But mostly they made friends of the Indians, of whom Mr. Hall writes with a friendly detachment impossible to most Americans, and with rare sympathy and understanding.

There is plenty of information about the desert folk in the book, and a great number of incidents worth reading—notably the Good Friday procession of the Holy Penitents. And there is at least one major conclusion suggested, which is that the effort to graft a white man's education onto the red man's mind is futile and wrong. The book is called "Enchanted Sand."

**South Pacific Again**  
Young Hassoldt Davis went to the South Seas, chiefly Tahiti and Bali, taking along the idea that probably most of the writing about those localities was "bunk." In Tahiti he concluded that the natives "were free because they lack a moral conscience, and in Bali that it is well to purge oneself of the heart."

But in between "Islands Under the Wind" contains a lot of ruthless realism that is pointed and colorful reading.

Quite different is the gentlemanly account of a career at sea in Pryce Mitchell's "Deep Water," gentlemanly and manly, too. Mr. Mitchell is a believer in the tents of Christianity, and lived his beliefs. No reader of tales about Cap Horn ships, weevily hard tack and bucko mates will fail to see that this is a radical departure in salt water narrative.

The book has a steady flow, a sort of pulse underlying the prose, that makes it delightful reading. The adventures are neither more nor less than average, but they have a plausibility and life that is highly unusual. "Deep Water" has the feel of a book that will live.

**Matto Grosso**  
Grace Thompson Seton is the wife of Ernest Thompson Seton, and a geographer and naturalist in her own right. Not long ago she made a long trip through South America, adventuring several times where no white woman had penetrated before, and seeing things with the eye of a geographer and a woman as well—even in the depths of the Matto Grosso.

Her book—"Magic Waters"—is full of delightful touches—the pages about the little ant eater timidly trying to awaken a response in the dead mother are uniquely touching, for one example. And there is a humanity that manifests itself in an understanding of human frailties as well.

Will James is fifth in the series—although he falls short in the "going somewhere" part, he makes it up in "seeing things." "All in the Day's Riding" is (if memory does not play tricks) Mr. James' ninth book, and in it he tells why the cowboy wears high heels and a wide hat, and a lot about narrow escapes that are "from facts."
