PUSH ACTION AID JOBLESS

Selection of Men For Conservation Camps To Be Made By Department of Labor

Washington, D. C., March 22.—(AP)—Selection of the unemployed for the conservation corps is expected by the Department of Labor.

Representatives of the Pitt county department of health and local nose and throat specialists spent the entire day at the school relieving the children of troublesome adenoids and tonsils. They will go to Bell Arthur Friday to hold a similar clinic.

The total number of children operated upon in the clinics held in six different schools of the county the last month has jumped well above the hundred mark and when the round of all the schools has been completed it was expected several hundred would have received attention.

The clinics are receiving the attention of people of all communities and the health workers are receiving splendid cooperation as they go about their work of trying to improve the general health of the various schools.

The largest number handled so far was at Grimesland where two clinics were necessary to take care of the affected students. This was due largely to the heavy enrollment and the increased number of children suffering from adenoids and bad tonsils.

Dr. R. S. McGeachy, director of the department of health under whose direction the clinics are being conducted expressed himself as gratified with the way things were moving along and expressed the hope they would be able to care for as many children as possible.

New College Museum Drawing Interest Here

East Carolina Teachers College has had many things to be proud of in recent years, but the latest object of pride is the museum setting forth some of the things to be found in North Carolina from the seaside to the mountains.

and catalogued and bear both the common and scientific names.

The museum is located in the front hallway of the science building erected about three years ago before the depression gave everything and everybody the financial cramps and especially the men charged with the responsibility of finding money for the operation of schools.

The museum is a revelation of the many things to be found in the eastern part of the state as well as the mineral resources of the western section. It embraces nearly every kind of marine life from the lowly tadpole and crawfish to the vicious shark and cumbersome whale.

Its director is Dr. R. J. Slay, head of the Department of Science, assisted by Miss Catherine Cassidy and other members of the faculty of the department.

Among the minerals may be found sulphur, china clay, granite, asbestos, mica and other products of the earth mined in western Carolina in addition to pottery from an Indian reservation.

Although not as extensive as they would have it, the faculty members and students hope to add hundreds of new objects to the museum in the future making it necessary to extend cases along the walls in a much longer hallway than that being used at this time.

One of the most interesting exhibits in connection with the collection of Indian relics is a paint box used by warriors when they started out on the warpath and by the squaws when they ventured forth in search of a husband. Of course it doesn't compare with the dainty compact carried around by fair feminity today, but it goes to show the women in the early life of the state were not unaware of the value of a dainty touch of paint to enhance their beauty and charm.

All of the things on display at this time, Dr. Slay said, were collected by students in various parts of the state, who realizing the importance of the museum to the study of science, have set about the task of making it worthy of the fine institution they represent. All displays have been properly classified

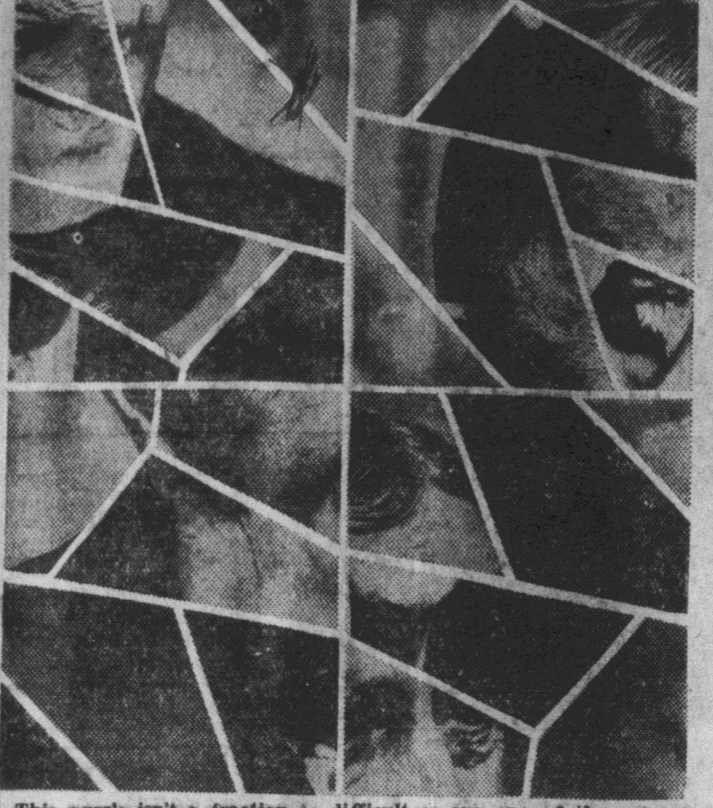

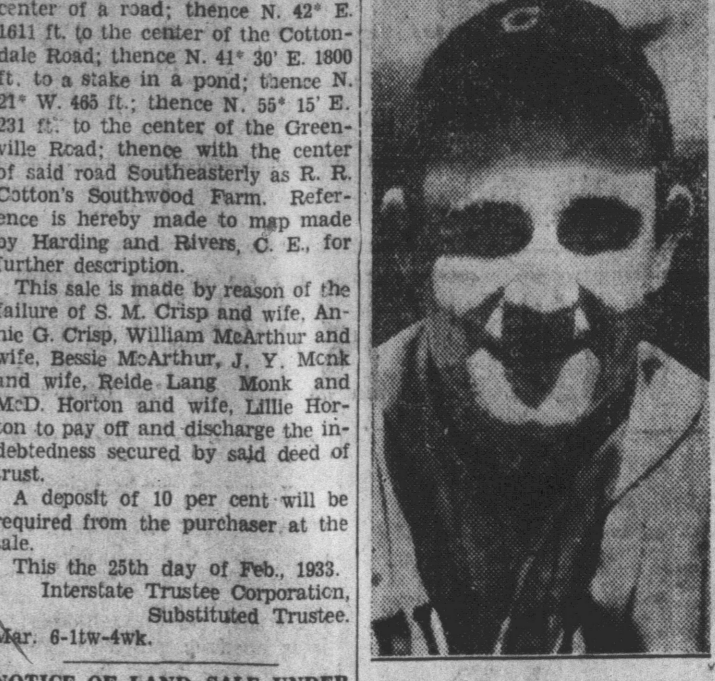

A. A. U. W. HOLDS INTERESTING MEETING

"Novel reading today is no longer one of the three deadly sins," said Miss Mammie Jenkins, in beginning a stimulating talk before the A. A. U. W. Monday night, March 20, on "American Literature in the Last Fifty Years."

The year 1883 classed it with the forbidden card playing and dancing. None of the three today are "sins" much less deadly ones; and novel reading has a wide acceptance in 1933.

Then starting with conditions in 1883, the speaker gave an informational and witty review of the developments in American literature during this period.

"Poetry," she said, "was being called dead in 1883; yet Whitman was alive—his 'Leaves of Grass' had been out for twenty years; and Emily Dickinson was scribbling her priceless verses on odd scraps of paper." What-ifs were then the fashion in furniture, and in poetry the simpering and pretty verses obscured the real things.

Soon, however, according to Miss Jenkins, came the turn of the century, with Mrs. Carman and Richard Hovey, and an awakening in poetry. The magazine "Poetry" gave new writers a chance. Riley came along, in tune with democracy, and left the legacy of his best to Robert Frost; of his worst, to Edgar Guest. The Imagists, Amy Lowell, the Symbolists, the Lyristists all contributed to the change that has come. Today we have the poetry that interprets personality, the Spoon River Anthology, for example.

Miss Jenkins called "The Story of a Country Town," 1883, "the grandfather of 'Main Street,'" and pointed out that our first truly realistic novel was "The Rise of Silas Lapham," published the same year.

She touched most interestingly on the regionalists; "the period of paganism," when American writers turned to history; the various stages in biography—idealistic, gossiping, research, debunking, and showed how the rise of autobiography has affected all forms of literature.

In closing, the speaker said that she thought the Book-of-the-Month Club and the Literary Guild had done much to raise the level of our reading by forcing those who wanted to seem, at least, to keep up with the best thing to do some real reading.

The A. A. U. W. was entertained at the Third street school recreation center by Mrs. E. L. Hillman and Mrs. J. H. Rose. In addition to the members of the club, a number of guests enjoyed the program and the hospitality.—Reported.

THE DOMINATING ELDEST

By Alice Judson Peale

The eldest child in a family often is distinguished by an especially dominating bearing.

He bosses his younger brothers and sisters in a most ruthless manner. Sometimes this attitude extends to high relations with other children. He seeks out younger playmates and tries to treat them as he is able to treat his younger brothers and sisters.

This attitude of the eldest child is to be understood partly as a reaction to the fact that his position of superiority makes it easier for him to dominate—as many persons would like to dominate if they could.

Partly, it may be an expression of the aggressive feelings which spring from his jealousy of the younger children, who one after another (so he feels), supplanted him with his mother.

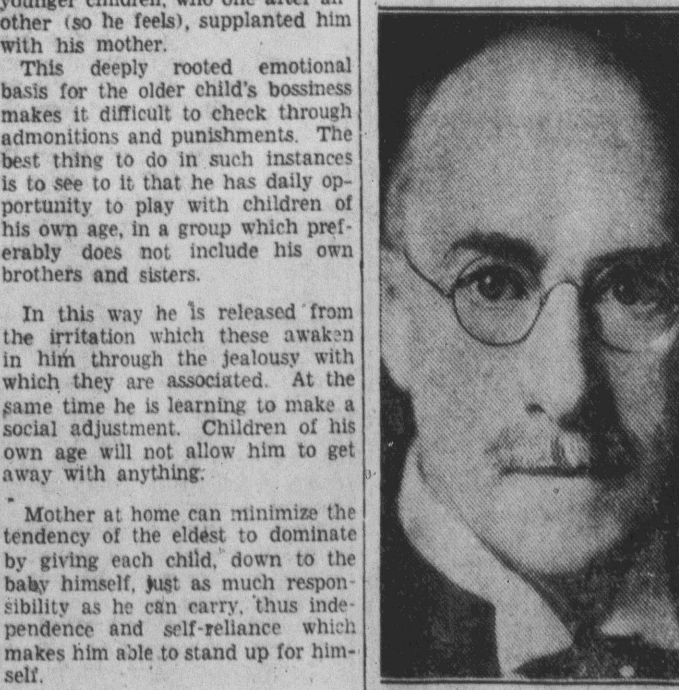
This deeply rooted emotional basis for the older child's bossiness makes it difficult to check through admonitions and punishments. The best thing to do in such instances is to see to it that he has daily opportunity to play with children of his own age, in a group which preferably does not include his own brothers and sisters.

In this way he is released from the irritation which these awaken in him through the jealousy with which they are associated. At the same time he is learning to make a social adjustment. Children of his own age will not allow him to get away with anything.

Mother at home can minimize the tendency of the eldest to dominate by giving each child, down to the baby himself, just as much responsibility as he can carry, thus independence and self-reliance which makes him able to stand up for himself.

Tips on CONTRACT

SUCCESS AT SLAM OVERBIDS

(By Tom O'Neill)

Aces at times go to sleep when they could have set unjustified slam bids.

This is due usually to an adversary's fear of leading a certain suit. He assumes the declarer's side has the ace. The overbidders have tried in the auction to build up that assumption.

Actually the partner of the leader has a setting ace. The moral would seem to be that if the only hope of setting a slam contract is that your partner has a certain ace, give him opportunity to play it.

Presented herewith are hands in which success with slam bids seems foolish at double dummy. But the slams were made against experts who were deceived away from the proper lead to set the contract.

George Dinwiddie sat North in the following deal:

North opened with a heart. East and West kept silent throughout the auction. South leaped to three hearts. North then bid four diamonds. Since he and partner already had agreed on hearts the diamond bid was a slam invitation.

South bid four spades, which proved to be the key bid of the auction and the play. It was unjustified. South should have mentioned four hearts and there the bidding would have stopped.

North replied with four no trump. South said five hearts and North took the contract to six hearts.

One look at all the hands and the novice would see it can be set two right away by a club lead. In fact, many players other than novices would at once open a club on the theory that being the only unbid suit it afforded the best chance of setting the contract.

East, an expert, reasoned that North or South must have the club ace or a void and concluded that the lead of the singleton knave of hearts was the best thing to do until dummy was seen.

The heart lead enabled the declarer's side to take all the tricks but the diamond ace, clubs being discarded on South's spades.

In the eastern pair championships Julian Goldman, donor of the trophy, dealt a hand on which he carried his partner, Chester Munn, to a little slam which could have been set by a lead of a suit that had not been played.

The bidding, with South and North passing, was: East one spade; West two hearts; East four diamonds; West four hearts; East five clubs; West five diamonds (a deceiver which resulted in the contract being made); East six hearts.

North opened a club. The ace of hearts was then led from dummy, followed by the three spot. South's knave was covered by West's queen and North's king. Because West had assisted the diamond bid, North assumed the ace of diamonds was in the West hand. Had he then led a diamond the declarer would have been set, but he chose a club as the least of evils, hoping to shorten dummy's trumps.

A low diamond was discarded from the East hand on West's club king. The nine of spades was then finessed, with a finesse of the 10 following. Upon East's spades two diamonds were discarded from West.

Miss Salaverria was born in Buenos Aires where her father was with La Nacion, one of the most important newspapers in South America. He now is a special writer for ABC, an influential Madrid newspaper.

The daughter was reared in San Sebastian and Madrid. She has traveled widely with her father and speaks German, French and English.

CHANGE PROCEDURE IN HANDLING OF LOANS

At the office of the Regional Agricultural Credit Corporation of Raleigh, North Carolina, this morning John P. Stedman, executive vice-president and manager, announced a complete change of procedure in the matter of the handling of loans by this corporation. Mr. Stedman said that instructions to persons designated to make out applications and attorneys whose certificates of title were acceptable to this Corporation were already in the mail.

"The new plan," Mr. Stedman said, "simplifies the matter and method of making applications for loans, and will tend to expedite the handling of applications, so that when the applications are approved the money will be made available to farmers much more quickly than under previous plans. The present plan provides that only the application and an additional sheet, completely describing the property to be mortgaged, is to be made out and signed by the persons seeking the loan. This paper is then submitted to the county committee, who will pass on the credits involved, then the application in duplicate will be forwarded to the Corporation in Raleigh, N. C.

The things the new Congress did in its opening days were so spectacular that little notice has been taken of the other side of the legislative picture—represented by the things Congress refrained from doing.

In many respects this negative aspect of events at the capitol is quite as notable as any other. It was significant that the administration program was enacted into law. It was significant also that the situation was not complicated by the injection of issues foreign to the administration program.

When it assembled for its first meeting, this Congress was an unknown quantity in far more than the ordinary sense. It had been elected under ordinary circumstances of unrest, and it contained an almost unprecedented percentage of new members.

In the big Democratic majorities of both Senate and House there were a good many rumblings of coming trouble. A rather sharp conservative-liberal division was growing up among the Democratic senators, and the Democratic representatives were painfully conscious of the enmities engendered by one of the bitterest speakership contests in history.

It was no secret that some administration leaders were apprehensive that, while the new Congress might accept Mr. Roosevelt's program, and give him the measures he wanted, it would be unwilling to stop there.

Ordinarily the beginning of a new session is characterized by confusion and temporary stagnation. Old and new members show up with brief cases packed with bills and resolutions, and hardly anyone knows which of these proposals may become, within a few weeks, the chosen vehicles of important legislative action.

This time, everyone seemed to understand from the start that these bills and resolutions—virtually all of them—were worth no more than the paper they were written on.

Bills to pay the bonus, to increase silver coinage, to frankly inflate the currency, to pay a dcl, and to do many other things, were introduced in due order; but to an almost unbelievable degree, the sponsors of these measures sought neither action nor publicity.

A few craftier firecrackers were shot off here and there, but even in the Senate, with its unlimited debate, the delay was not great.

Talks to Parents

A VICIOUS CIRCLE
By Alice Judson Peale
We used to hear a good deal of talk about "inherited fears," "inherited nervousness," "inherited lying," "inherited character weaknesses and faults of all sorts. It was taken for granted that these were passed on in the blood stream from generation to generation.

There is strong evidence that this assumption was false and that character traits are not inherited, but acquired.

According to the evidence, astonishing similarities of character that repeat themselves in one generation after another are the result of the fact that children, identifying themselves with their parents, consciously and unconsciously try to be like them.

Since this tendency to imitate is present from the very beginning of the child's life it is no wonder that he fails to exercise discrimination and copies faults as well as virtues, which, incorporated in his own personality, are in due time copied by his own children.

Self-control can prevent a mother from showing her children irrational fears of thunder or spiders; of being left alone in the dark. The thought of setting a good example should check parents about to indulge in the adult equivalent for a temper tantrum.

A mother who catches herself playing the martyr or dramatizing her grief over some childish wrongdoing may check herself in time when she remembers how much she, as a child, loathed the same trick in her own mother.

A father who has suffered all his life from a timidity which kept him from athletics will encourage his children in their enthusiastic imitation of a camp leader or physical

training director who offers a good example which may offset the force of his own bad one.

We think of children usually as being violently active most of the time.

There are, however, children who do not conform to this picture and who indeed are less active than they should be for their own physical good.

Where such sluggishness is not due to ascertainable physical causes which a physician must deal with, it is necessary to make a real effort to stimulate the child to at least a normal amount of activity.

The most obvious means toward this end is to provide him with the sort of play materials that call for physical exertion. Skates, balls, wheels, sleds, wagons, jump-ropes, and, for little children, see-saws, swings and slides, are examples.

But the phlegmatic child presented with such things often will turn his back on them to return to his reading or sedentary play unless something more is done to arouse his interest.

Boys often are quickly helped by having their fathers not only take a genuine interest in such play but also take part in it. Hikes and games with father and mother are sure to be popular with even the laziest child.

The stimulus of playmates who are active is extremely helpful. Joining an afternoon play group at a nearby playground is often the best way to arouse the child's pleasure in physical activity and keep it going.

Even though he is not enthusiastic at first, his interest gradually develops through contagion from his playmates and through an increasing pride in his own growing skill.
