## BEGIN INVESTIGATION OF CRASH OF AIRSHIP AKRON

### House Committee Plans To Hear Three Survivors Of Greatest Air Tragedy

#### WILL PROBE WRECK FROM ALL ANGLES

**Lieut. Commander Wiley and Two Officers Expected to Repeat Story, Wiley Presented to Secret Session Yesterday; Chairman Vinson Reiterates Determination to Push Probe From Top to Bottom**

Washington, D. C., April 7.—The three survivors of the Akron which plunged into the Atlantic appeared before the House Investigating Committee today to relate their story.

Lieutenant Commander Herbert Wiley, executive officer of the Akron; Richard E. Deal, boatswain's mate, and Mervyn Erwin, metal-smith, were called to repeat publicly the story submitted to the secret session of the committee yesterday by Wiley.

Before the hearing began Chairman Vinson reiterated his promise that "we are going into this thing from top to bottom."

### SCHOOL HEADS MEETING HERE

### State Wide Educational Conference Opens at Teachers College Today

School superintendents, principals, supervisors and teachers from many towns and counties in the State are in Greenville today attending the State-wide Educational Conference in session at East Carolina Teachers College, Goldsboro. More than 100 delegates from 15 counties, including Kinston, Wilmington, High Point, Plymouth, Greensboro, Rocky Mount, Wilson and Pasquotank, Johnston and Northampton counties, are represented in the informal table meetings.

The conference opened with a short general meeting, then was divided into two round table groups, one county and city superintendents, with Ray Armstrong, of Goldsboro, presiding; and one of principals and supervisors, with Dr. W. O. Hampton, of Wilmington, presiding. The two discussion groups have good afternoon's work mapped out for them.

At 9 o'clock tomorrow morning the round table conferences will be resumed with Supt. J. P. Long and James E. Simpson presiding. In one James E. Simpson, supervisor of Johnston County will present the problem, "Should a Teacher Be Employed Without an Official Report of Her Record from the College She Attended?" In the other, Miss Cleo Rainwater will discuss, "What Information Can High School Principals Give the College About the Pupils of the Day, and Give Something that Stimulates Thought."

At 10:30 o'clock tomorrow morning all will assemble in the auditorium for the final session. M. K. Fort will preside. K. R. Curtis will talk on "How May Undesirable Teaching Material Be Eliminated?" The presentation of summaries of the round table conferences will be followed by high spots of the conference. The meeting will close at noon with a business session.

### BOARD NAMES JUDGES FOR CITY ELECTION

### Aldermen Complete Setting up Machinery For Contest First Monday in May

The Board of Aldermen in regular monthly session at the City Hall last night completed setting up machinery for the city election to be held the first Monday in May. Only a few other minor matters were considered in addition to regular routine business.

Registrars of the election were named at a previous meeting and last night the aldermen named the judges and their helpers. The judges will be Jack Foley, and Mrs. Alex Viola and their helpers will be Mrs. Irma Cobb Dunn, Mrs. Louis Gaylord and Mrs. Sugg Fleming.

The election of a mayor and five members of the board will be held at the court-house the first Monday of next month. The contest up to now has been a very mild affair as no competition has developed.

One alderman is to be chosen from each of the five wards, and so far as known, all will be up for reelection with exception of Closs Hearne, alderman of the First Ward, who has moved away from the city.

The board last night also passed a resolution to put a culvert through the ravine of Second Street to permit proper drainage for that section of the city which has been improved during the public works program in recent months.

This was the only business taken up by the Board with exception of paying of bills and reading of month reports from the various department heads.

### LEE COUNTY TO ISSUE UP TO \$25,000 IN SCRIP

Sanford, N. C., April 7.—At a special meeting of the Board of Commissioners held yesterday, details of the plan for issuance of scrip were decided on.

Not more than \$25,000 will be issued at this time. The scrip will bear interest at 6 per cent, redeemable in twelve months. The county will place with a trustee \$65,000 past due tax accounts as collateral for redemption of the scrip.

The commission was decided on a horizontal cut of 25 per cent in assessments of real estate, instead of having a revaluation at this time.

### METHODISTS TO CELEBRATE BIRTHDAY HERE

### Centennial Celebration to be Held at Local Church on May 7.

Sunday, May 7, will be a red letter day for Methodists here as they go about celebrating one hundred years of service to the community.

Plans for the centennial celebration were outlined at a meeting here the first of the week and committees were named to see that the program is put over in a big way.

One of the features of the two services planned for the day will be the presence of all former pastors of the local church now living, in addition to the presiding elder. Some former pastor will deliver the centennial sermon during the morning service. His name had not been announced today but was expected to be made known in the near future.

Following the sermons all fifty and forty year members of the church will be honored in appropriate exercises, and this was expected to be one of the most inspirational features of the morning service.

At night the history and progress of the church will be presented and each of the former pastors will make brief talks dealing largely in reminiscences and congratulations to the congregation for the splendid record of service.

Special musical programs will be rendered by the choir at each of the services.

The church has the largest membership of any other congregation in this immediate section of the state. Its growth has been steady from year to year and the membership is proud of the splendid plant at the corner of Washington street and Dickinson avenue, a monument to their thrift and enterprise.

Rev. E. L. Hillman, who is serving his fifth year as pastor of the local church, said the celebration would be as impressive as it is possible to make it and expected the building to be crowded to capacity at both the services.

### ACCUSED OF MAKING COUNTERFEIT MONEY

Rocky Mount, N. C., April 7.—A two weeks' investigation of counterfeiting in this city had resulted last night in the arrest and arraignment of possessing and passing counterfeit 25 and 50 cent pieces.

Given a hearing before U. S. District Commissioner, George F. Hon here today, Cuthrell was held under a \$1,200 bond for the next term of Federal Court in Wilson. Cuthrell said the bond would be posted.

A number of witnesses testified that Cuthrell passed the counterfeit coins made crudely of lead and tin.

Paul C. Zimmerman, local detective and S. B. Phillips, of Charlotte, secret service detective, conducted the investigation here that led to the arrest of Cuthrell last night.

Cuthrell's arrest last night by Zimmerman and Phillips climaxed a two weeks' intensive investigation by Zimmerman which he inaugurated when this city became flooded with counterfeit quarters and fifty cent pieces about two weeks ago.

### NASH AND EDGEcombe REDUCE VALUATIONS

Rocky Mount, N. C., April 7.—A tentative horizontal reduction of 20 per cent in Nash County property valuations and cuts in Nash salaries ranging from nothing for smaller wage employees to 25 per cent for higher salaried individuals, have been announced.

Horizontal reductions of 25 per cent in Edgecombe County had been previously announced.

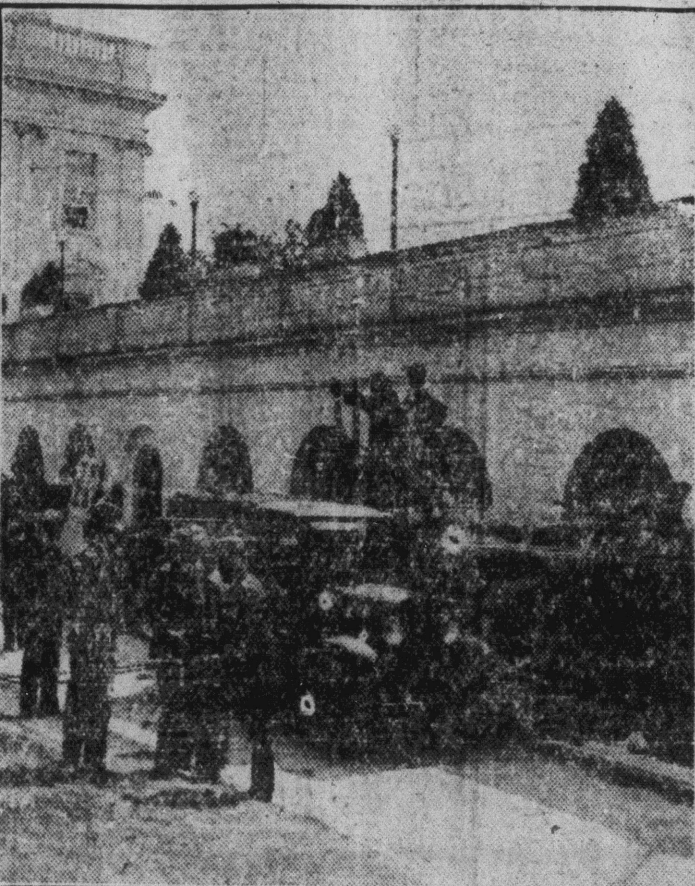

### N.C. UNCERTAIN BEER STATUS

### Attorney General Brumitt Uncertain If Shipments Legal At This Time

Raleigh, N. C., April 7.—(AP)—Whether or not brewers may ship beer into North Carolina legally before midnight of April 30 was undecided today.

Attorney General Dennis G. Brumitt said he could not rule on the matter until he had given the State and Federal legislation closer scrutiny.

Under the Webb-Kenyon act, Brumitt said shipment of the beverage into the State before May 1 would be illegal if the beverage was intoxicating.

With Congressional indication that 32 per cent alcohol was not intoxicating, he did not know what the status would be.

### Late News Flashes

Today in the Legislature. Raleigh, April 7.—(AP)—A general sales tax of three per cent and the possibility that beer may not be legally shipped in North Carolina under the Francis act held legislative interest today.

The House finance committee which finally settled on a three per cent general sales tax in increased corporation franchise tax in the 1933-35 revenue bill notified the House the proposal would be reported tomorrow and secured agreement to debate the measure Monday.

### NEW STADIUM OPENS TODAY

### Appropriate Exercises to Mark Dedication of Third Street Athletic Field

Several hundred people made a pilgrimage to Third Street school this afternoon to attend the dedication exercises in connection with the opening of the new stadium and community building erected during the public work program here the last several months.

The opening was to be marked by a band concert, flag-raising exercises, and the tossing of the first ball onto the turtle back diamond by Mayor R. C. Flanagan. After these preliminaries Greenville high pranced upon the field and attempted to vanquish New Bern who defeated them in the opening game of the season last week.

Mayor Flanagan yesterday issued a proclamation urging the people to leave their places of business from 2:15 to 5:30 o'clock today and attend the opening of the stadium and school athletics. Although it was impossible to say how many would abide by the proclamation it was believed the largest crowd ever to assemble at a high school game would be on hand when the field is officially thrown open to the public.

The stadium is considered the finest in this part of the State and marks the realization of a "great dream" on the part of J. H. Rose, superintendent of city schools, and the student body. In addition to the athletic field, there are lawns and commodious stands capable of seating several hundred people and a club-house with shower baths and rest rooms for the players. The club-house also has certain community building features which makes it of interest to the entire city.

The club-house will meet the demands of the city for years, and the architectural arrangement is such that Elizabeth City has decided to pattern a similar building after it.

Greenville people are proud of the field and will do their bit to help future athletic aggregations to live up to the possibilities which it offers.

### MANY CITIES GREET LEGAL BEER GLADLY

### Celebrations Staged Last Night in New York and Other Large Centers

(By The Associated Press) The thump of gong hammers drummed a long lost coverage back on the American scene today.

Lawful 32 per cent beer gushed in territories populated by about 70,000,000 Americans as nineteen States and the District of Columbia enjoyed beer for the first time in thirteen years.

Jubilee geniality was widespread among friends of the beverage. Its foes voiced criticism and warning. Five minutes after beer became legal, big trucks gay with festoons lumbered to the service entrance of the White House bearing two cases of beer—a brewer's gift to President Roosevelt.

President Roosevelt has indicated he will give the beer to friends. On Broadway New Yorkers paraded behind hearses bearing letterings, "Near Beer is Dead," while bands in bright Bavarian uniforms played dirges and drinking songs.

The brewers of the metropolis had refused to deliver before 6 a. m., but some of the hotels and restaurants had managed to obtain beer from New Jersey and elsewhere.

Thronged celebrations in speakeasies where prices tumbled before previous sums and customers toasted—with needle beer—and greeted the legal beer.

"Surprisingly good," said Chicago connoisseurs as they celebrated "New Beer Day," while 100,000 cases and 200,000 barrels sped to points of delivery there and cheering throngs crowded the downtown district.

German societies in St. Paul where beer flowed freely at midnight, toast-President Roosevelt and "Happy Days."

While H. L. Mencken, author and iconoclast, and beer expert, of Baltimore, was tasting new beer and pronouncing it "pretty good—not bad at all," the head of the W. C. T. U. declared beer violated the Eighteenth Amendment.

### TONSIL CLINIC VISITS AYDEN

### Around Twenty Children Expected To Be Operated on There Today

Representatives of the public Health Department went to Ayden today to conduct one of a series of tonsil and adenoid clinics being held throughout the county in an effort to improve the health of school children.

The Ayden clinic will be the eleventh held since the campaign got under way and it was expected that at least twenty children would undergo operations.

A similar clinic was held at Farmville last Tuesday and the twenty-one children operated on there brought the total to 231.

It was expected the total would go beyond the three hundred mark before the campaign is over. Around twenty children have been operated on in each of the clinics, except Grimesland where over 50 received attention.

Health officers expressed themselves as highly gratified with the spirit of co-operation shown by the people in the various communities so far visited. They said this had been instrumental in speeding up of the work and would result in their reaching more children than they otherwise would be able to reach.

### IMPROVED BUSINESS IS NOTED AT OXFORD

Oxford, N. C., April 7.—Distribution of approximately \$45,000 in crop production funds, the approach of Easter and the desire for a new bonnet and admittance of full banking services here in the immediate future have brought a perceptible improvement in business here.

### SPEED WORK ON THE FARM RELIEF BILL

### Senate Leaders Confident Measure Will Be Passed by Early Next Week

Washington, D. C., April 7.—(AP)—The Senate turned today from the farmers' trouble after having applied a far-reaching measure to speed the initial employment by limiting hours to thirty a week.

The administration farm relief program was set to stay before the Senate until final vote.

Leaders predicted—despite evidence of opposition—that this would come before next week. Then the House must pass on it.

Sponsored by Senator Black, Democrat of Alabama, the bill limiting labor in manufacturing industry to five days a week and six hours a day, was approved by the Senate last night, 53 to 30. It was sent to the House.

Democratic leaders would not predict President Roosevelt's attitude, but expected the measure to be changed in the House to raise the working limit to 35 hours.

Senator Robinson of Arkansas, asserted 36 hours limitation defeated by the Senate in debate would be acceptable to President Roosevelt.

Advocates contended the measure would save jobs to 5,000,000 men and it would be upheld by the Supreme Court.

With some exception the measure would bar from interstate commerce any products manufactured by labor working more than thirty hours.

### THREE FORMER BANKERS ARE PLACED ON TRIAL

Murphy, N. C., April 7.—(AP)—Three officials of the closed Cherokee Bank of Murphy went on trial in Superior Court here today on charges of violating State banking laws.

Defendants are E. A. Davidson, president of the bank; J. W. Davidson, a director; and J. B. Storey, cashier. They are charged in eight bills of indictment with conspiracy, abstraction of funds, making false reports to the banking department on the bank's condition publishing false reports of condition, and accepting deposits after they knew the institution to be insolvent.

### CORPORATION FRANCHISE TAX ALSO BOOSTED

Committee Refuses to Include Four Per Cent Sales Tax With One Per Cent to be Returned to Counties; Franchise Taxes Increased Half Way Between Present Scale and Budget Commission Recommendations

Raleigh, N. C., April 7.—(AP)—The House Finance Committee voted today to report the 1933-1935 revenue bill carrying a 3 per cent general sales tax and increasing corporation franchise taxes.

By a vote of 7 to 6 the committee refused to include a 4 per cent sales tax in its bill with 1 per cent to be returned to the one hundred counties of the State for debt service payments.

Faced with the necessity of providing revenue to meet biennial appropriations of \$83,159,219, the committee voted to write the 3 per cent general sales tax into its bill and then increased franchise taxes to a level half way between the present scale and recommendations made to the Legislature by the Advisory Budget Commission.

The principle of the franchise taxes will be set as follows: Domestic and foreign corporations, \$1.50 per \$1,000 on capital instead of the present rate of \$1.25 and the budget rate of \$1.75.

Public service corporations, 5-1/2 per cent of the gross receipts instead of the present rate of 5 per cent, and the budget suggested rate of 6 per cent.

Railroads 82-1/2 per cent on the \$1,000 valuation instead of the present rate of 75 per cent and the budget scale of 90 cents.

### TELLS HOW N. Y. RECEIVED BEER

### Frank Harrington Returns Home After Failure to Visit Al Smith

Yesterday was a gala day in New York City as millions of thirsty people of the nation's metropolis prepared for the advent of legalized sale of beer this morning at 12:01 o'clock, according to information brought to Greenville today by J. F. Harrington, clerk of superior court, and A. W. Anse, well known business man of Winterville, who spent most of the week in the northern city.

Mr. Harrington said drogstores, smoke shops, cafes and night clubs were gaily decorated for the occasion and that large kegs of beer were on display in thousands of windows as shop keepers attempted to whet the appetites of the thriv-

ing. The advertising campaign, he declared, was the most extensive put on by the great city since the beginning of national prohibition and probably attracted the attention of more people.

Mr. Harrington said he had only regret concerning his visit to New York and that was his inability to see Al Smith. He wanted to talk to Al about the political outlook of the nation, but when he thought about making a visit to see him he found that the New York political chief was comfortably cloistered in his conference room at the top of the Empire State building, the

## THEY SHIPPED BECK TO BUSHES BUT HE REFUSED TO STAY 'PUT'



Three years ago the St. Louis Browns told Walter Beck he could go back to the minor leagues and stay there as far as they, personally, were concerned. But they didn't know Sir Walter. He studied nights, got better and better and now he's back up with Brooklyn, one of the year's greatest pitching prospects. He won 27 games for Memphis last season.

Miami—(AP)—After three fine years with Memphis, Walter Beck, who was unsuccessful in previous major league trials, again is bidding for a hurling job with Brooklyn.

And this time he may make a go of it. In fact, observers of the spring drills have been so impressed with the physique and ability of this 29-year-old "rookie" they think he may be the man to replace "Dizzy" Vance on the Flatbush mound staff.

Last summer Beck became probably the outstanding minor league pitcher in the country by winning 27 games for Memphis in the Southern Association. The year before he won 19.

And, Beck believes, the experience he gained in the Dixie loop in recent seasons will enable him to earn a regular berth on Max Carey's staff.

Four years ago he was shunted back to the "bush" leagues, and Owner Phil Ball didn't re-engage

him to work for the St. Louis Browns. It was a hard blow then, but Beck thinks now it was a good thing.

"There were so many things I couldn't do when the Browns gave me that last chance that I'm really ashamed to tell them. I was over-anxious and thought as long as I could throw a fast ball I was a pitcher. I found myself with Memphis last summer," he says.

Walter, known throughout the Southern circuit as "Sir Walter," believes his last three years in that league have given him the poise he lacked when he was with the Browns.

During those years he worked hard, always with the idea of some time obtaining another major league trial. "I made a study of every batter in the league. They thought I was just a 'thrower,' but never did they imagine me sitting up nights figuring their weaknesses."

An exhibit showing the progress of English journalism from the seventeenth century will open April 24 in New York, in connection with the annual meeting of the Associated Press there. "The Continuation of Our Weekly News," published in 1625 (above) is a forerunner of the modern English newspaper. Later there came a contemporaneous account of the execution of Charles I. The Daily Courant, founded in 1702 was the first English morning paper, and the Daily Post had Daniel Defoe for a contributor, running "Robinson Crusoe" in serial form.

London—(AP)—A complete panorama of the English newspaper, illustrating its evolution through three centuries, will be presented in conjunction with the annual meeting of The Associated Press in New York April 24.

The collection, believed to be the most complete of its kind in private hands, belongs to the London Press Club and begins with an issue that antedates the famous sale of Manhattan island by the Indians by several years.

Exhibition in the United States, the first outside of London, was arranged by Carl W. Ackerman, dean of the Columbia University School of Journalism.

The Associated Press is cooperating with Mr. Ackerman and the university, and the first showing will be April 24, the day of the annual meeting of the press association members. University students and invited guests in attendance at the American Newspaper Publishers Association meeting will have opportunity to study the rare collection April 25 and 26.

The exhibit has been formed during the last five years by Andrew Stewart, honorary librarian of the London Press Club.

It begins with the embryonic stages of the English press in the reign of James I, when the only semblance of a newspaper published in London was a small quarto entirely from the Corantos issued on the continent.

One of these, "The Continuation of Our Weekly News," dated 1625, opens the panorama, which then proceeds to an unbroken sequence of the news pamphlets which in-

formed England of the progress of its civil war.

One of the outstanding exhibits is a complete contemporary record of trial of Charles I and the scene on the scaffold when he was executed January 30, 1648.

It was hunger for news hot from the battlefields of England and of the doings of parliament that led to the establishment of the regular newspaper, and the pamphlets of the time mirror the times in foretelling England.

Weeklies and tri-weeklies gradually developed until 1702, in the reign of Queen Anne, the first daily newspaper appeared. This was The Daily Courant, a two-column paper.

Other important newspapers and journals of a little later in the collection are ones to which S'eele, Addison, DeFoe, Goldsmith and still later, Johnson contributed.

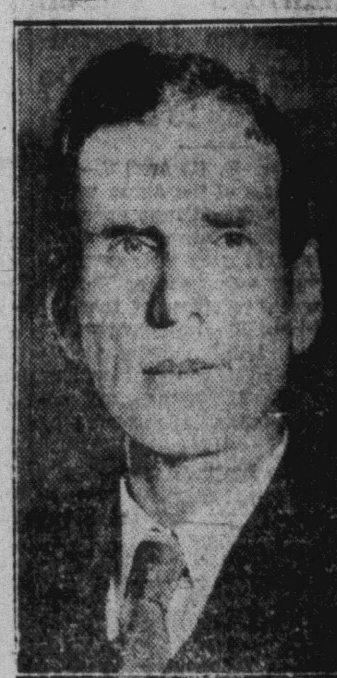

(By The Associated Press) With Hitler's lieutenants announcing flatly in German legislative halls that union with Austria is one of their leaders' aims, France and her allies—Yugoslavia, Czechoslovakia, Rumania and Poland—see a possible fascist barrier across their paths of access to each other.

There are sore spots in post-war Europe, shown on the map in black. Between Rumania and Soviet Russia lies the province of Bessarabia, given to Rumania by the allies but never formally ceded by Russia. On Rumania's other side is the province of Transylvania whose sharing has never been satisfactory to Hungary.

Germany and Poland have the disputed Polish corridor between them. It looks toward the Yugoslavian province of Dalmatia and the blackshirts pray for the day when this shall become their country's "fourth coast."

So Ramsay MacDonald, Great Britain's prime minister, recently called upon Benito Mussolini in Rome to help quiet international nerves. It is reported that the British leader was converted there to Italy's idea that post-war treaties must be revised as a preliminary to effective organization of peace and eventual disarmament. In fact MacDonald told the British commons that "all treaties are sacred but none is eternal."

## HOLLYWOOD SIGHTS & SOUNDS

Hollywood—(AP)—Dimming pages of Los Angeles and New York, theatrical history are due to be turned again as the name of Oliver Morosco returns to the sunlight of activity.

There was a time when the name meant the theater. In New York it enjoyed prominence through hit after hit, and now he is coming back, after several years devoted to reading plays and writing his autobiography.

His plans are two-fold: First, to make pictures as an independent producer; secondly, to form another stock company here for the production of plays, modeled after the company he organized in Los Angeles in 1899 and operated for 25 years.

"I tried out plays here," he reminisced the other day, "and if they fared well I knew they would pass in New York. Los Angeles was better for try-outs than Atlantic City. 'Abie's Irish Rose' played 40 weeks here before it opened in New York, and 'The Bird of Paradise' was approved by Los Angeles before New York saw it."

"I'm going in for new plays—not old ones. I intend to start with an established hit, then follow it with a new play. But first I want to make three or four pictures, and keep in touch with both theatre and screen. I think the time is ripe for my venture."

Morosco, who once had his own film company, will direct and produce his pictures.

A brief survey of his career whets interest in his nearly completed autobiography. He is fully of reminiscences of his more than 35 years association with the stage and its people. He came to Los Angeles in 1899 with \$40 in his pocket, a wife and baby (Walter Morosco, now Fox associate producer and husband of Corinne Griffith), and plunged into the theater.

John Barrymore, Richard Dix, Edmund Lowe, Laurette Taylor, Warner Baxter, Bebe Daniels, Marjorie Rameau, Lewis Stone—these are only a few of the personalities with whom he worked at one time or another, some of whom he "discovered." Leo Carillo was one of his stars; Morosco gave Colleen Moore her first big part in pictures; Harold Lloyd played a bit for him once.

On "Peg O' My Heart" (now being filmed with Marion Davies), a play with one set and nine characters, he netted \$5,500,000.

### AROUND THE WORLD . . . AUSTRALIA TIGHTENS GRIP ON NEW GUINEA MANDATE

Canberra—(AP)—Australia intends to strengthen her grip on New Guinea, the former German section of which is administered here, under mandate from the League of Nations.

The little interest shown so far indicates that next month Greenville may have a city election in which there is not a single contest. If when the time for registrations of candidacies expires without any of the vacancies contested what will be the use of going to the trouble and expense of the election after all? Isn't there some way, in case of no contests, that the candidates can be certified for the respective offices?

At last the legislature has decided in favor of an eight months state supported school term, which is as it should be. The public schools are primarily a state function and it is right that they should be state supported, but it is regrettable that while relieved from ad valorem taxes for schools, the masses under the sales tax plan will still have to bear the brunt of the burden. We know that our people are willing to pay as far as possible in order to retain good schools but we reiterate our contentions that there should be no sales tax except as a supplement after all possible revenues have been derived from other sources that are now escaping their just share of the tax burdens.

The appropriations bill has already been passed but the revenue measure is still pending and it is not too late for the legislature to get the money from the sources most able to pay to carry on the schools. It appears that some form of sales tax is a foregone conclusion but let this come only after every other source of revenue has been tapped.

THE AUTOMOBILE CEMETERIES

(New Bern Sun-Journal) Carrying its spring planting and cleaning campaign a little further than is usually the case, the Greenville Garden Club has undertaken the elimination of automobile cemeteries. It is, the club frankly admits, a stupendous task, and there is need of the co-operation of every filling station and garage operator in and near the city limits.

But the club says, "nothing mars the appearance of the entrance to Greenville so much as do the 'auto cemeteries,' and the garden club hopes to eliminate every one of them."

Many another city could say the same thing as to the effect of the automobile cemeteries upon their appearances, but the task of eliminating them is so great that they hesitate to undertake it.

The Greenville club, however, is apparently not one to be easily discouraged. It has reported the planting of 120 oak in the city of Greenville; 175 rambler roses on the embankments of the Sallis Southall Cotten drive; 50 mimosa trees and 50 crepe myrtles on the Washington road, together with 50 rambler roses on the embankment near a cemetery, and the setting of 50 dogwoods on the Ayder road.

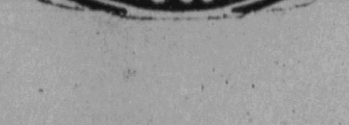

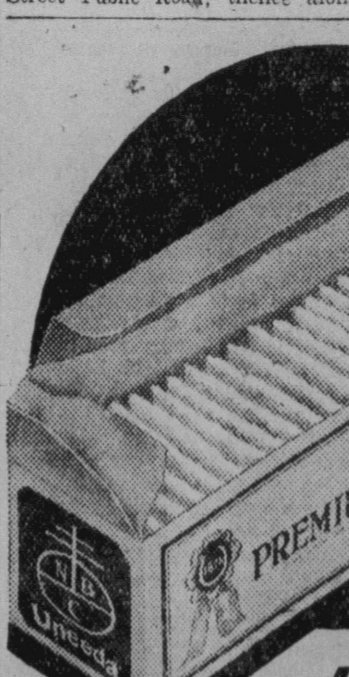

You do not have to dig very deeply into the baseball record book to discover just why so many close observers agree in naming Burton Shotton of the Phillies as one of the most capable and astute managers in the big leagues.

Burt has not had the benefit of any elaborate chain-store system to draw talent from, or been able to call upon a wealthy owner to unfurl his check book for the acquisition of much-needed replacements, but in five years he has effected an improvement of exactly thirty-four games in the winning performances of the Phillies.

That's the difference between the Phils did when Shotton took hold of them and what they accomplished in 1932. They were the "tuttle Phillies" when Burt first called the roll, but they now are one of the most dangerous clubs in the forthcoming National League pennant scramble.

**Peek Points With Pride.** Shotton's record is all the brighter when compared with the achievements of other pilots who have moved into the picture within the same period. Gabby Street, with two pennants in three years, benefited from ready-made material.

The next best records belong to Roger Peckinpaugh, who in five years has made a 26-game improvement in the Cleveland Indians, and Bill McKechnie, who starts his fourth season in charge of the Boston Braves with the satisfaction of having moved his club up twenty-one games in the team standing.

The Yankees in two seasons under Joe McCarthy, improved 12 1-2 games. Bucky Harris has done a much tougher job with the Detroit Tigers, but he can point to a net gain of 7 1-2 games within four years. Bill Killefer, with the Browns, experienced a net loss of one game in the past three seasons, but hopes for better results this year.

## Star Beams Will Feature Fair

By ROBERT H. BAKER (Professor of Astronomy, University of Illinois)

Urbana, Ill.—(AP)—Arcturus, the star of the Chicago World's Fair—and the star whose light will help to open it—rises almost directly in the East at nightfall on April 1.

Later in the evening it will be higher above the horizon and therefore easier to identify. To find this brilliant reddish star follow the curve of the handle of the Great Dipper downward and around to the right.

On the evening of June 1 the light of Arcturus focused by telescopes at four observatories in different parts of the country on photo-electric cells will provide the electrical impulse required to turn on the lights of the Chicago fair.

Forty years ago, while another fair was in progress in Chicago, this light that will arrive on June 1 started toward us from Arcturus. Since that time it has been speeding earthward as fast as 11,000,000 miles a minute. Just now it is less than a million million miles away.

Arcturus is the brightest star of the constellation Boötes.

Here we can see a striking figure formed by the stars of this constellation; it resembles a kite, or perhaps the outline of South America with Arcturus in the position of Cape Horn. This kite figure rises on its side.

There are other interesting sights to be seen in the evening skies of the early spring. Most conspicuous of all are the two planets Mars and Jupiter, which are not far from the familiar sickle of Leo.

Jupiter is the brighter of the two and the farther toward the east. It is a fine object to observe with the telescope.

Mars has been shifting eastward recently away from Jupiter and toward Regulus, the bright star at the end of the handle of the sickle. During April it will turn around and resume its eastward journey among the stars. Mars will overtake Jupiter on June 4, when these two bright objects very close together in the west in the early evening will attract particular attention.

In June also Venus will begin to add its greater luster to the starry scene in the west after sunset. This bright planet will cross behind the sun into the evening sky on April 21.

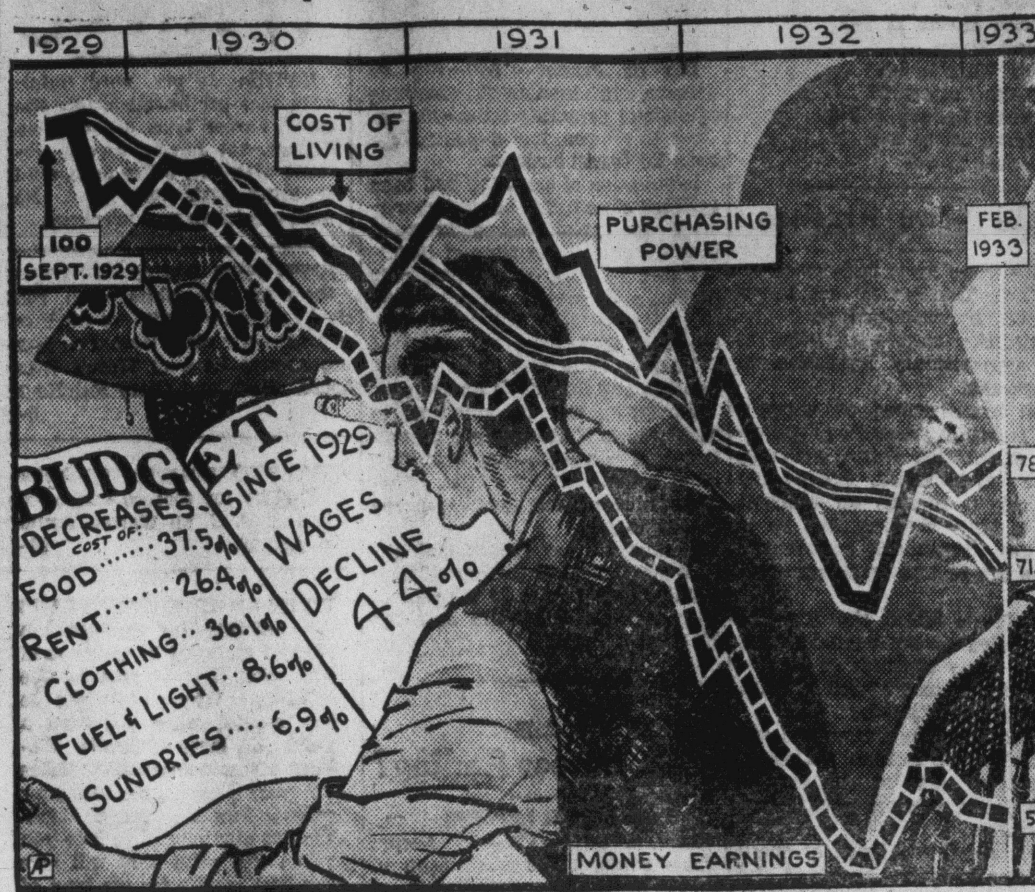
No wonder the World Series scandal of 1919 rubbed out such batting immortals as "Sholess Joe" Jackson, Hap Felsch and "Buck" Weaver have White Sox fans, probably the most rabid in baseball, had much of a chance to go "loco" over a hitter with a real punch. Teddy Lyons, a great pitcher with a tall end club, was and is a great hero, but hardly anything compared to what Simmons can be if he delivers like he did at Philadelphia.

## U. S. Workers' Net Buying Power Lower Despite Four-Year Drop in Living Costs



The line marked "cost of living" in this chart shows the decline since 1929 in the cost of things the average wage-earner buys. The line marked "money earnings" shows that actual dollars received by him have declined more, while the line marked "purchasing power" shows how much less he buys today than in 1929. The budget book gives reductions in various items of the budget, and the total decline in money earnings. Each line covers the period September, 1929, to February, 1933. The budget book items are for the period December, 1929, to December, 1932, as calculated by the National Industrial Conference Board.

**By J. R. BRACKETT** New York—(AP)—Mr. John American Smith's wages have fallen farther than his cost of living.

Which each of his dollars will buy more, he has so many fewer dollars that his total purchasing power was 21.7 per cent less in February this year than in September, 1929, just before the depression began. National Industrial Conference Board statistics disclose.

Mr. Smith (the average small wage and salary receiver) finds that prices of the things he buys have declined 28.3 per cent since September, 1929.

**Big Drop in Pay** He finds also that the number of dollars he receives has fallen 44 per cent, as a result of wage cuts and reduced working time.

Thus, despite his dollar's higher purchasing power, the decline in the number of dollars has brought his total purchasing power 21.7 per cent under 1929.

Mr. Smith finds that living costs declined about 10 per cent in 1932, a smaller decline than in 1931. His budget included food, rent, clothing, fuel and light, and sundries, held to be applicable in a general way to the expenditures of the many who earn around \$2,000 a year.

Mr. Smith's budget does not reveal the status of higher income earners, or those less numerous in the lower income brackets, who are burdened with debt, insurance and other fixed charges which do not decline as do ordinary budget items.

**Fixed Charge Share Grows** In a study of 530 small home owners near New York it was shown that the proportion of the owner's dollar going to fixed charges increased from 22 cents in 1928 to 44 cents in 1933. The fixed charges themselves did not increase, but as income declined they took a larger share of each dollar, reduced the amounts available for ordinary living expenses.

Mr. Smith's budget is based by the conference board on analysis of many budgets showing that about 33 per cent of income is spent for food; 20 per cent for housing; 12 per cent for clothing; 5 per cent for fuel and light, and 30 per cent sundries, such as doctors' bills, recreation and tobacco.

A major portion of the declines in Mr. Smith's living costs in 1932 as compared with 1929 represented food, which cost about 37.5 per cent less; rents, 26.4 per cent less; clothing, 31.1 per cent; fuel and light, 8.6 per cent; and sundries, 6.9 per cent less.

**Mid-West Food Drop Largest** The analysis shows that geographically the Mid-West showed the largest decline in food prices, the Far West the least, with the East and South second and third, respectively. Rents appear to have declined least in large cities, least in the East, and most in the Mid-West.

Prices of food, clothing and rent appear to have fallen least in the East.

FARM NOTES

Two car loads of hogs were sold on the Baltimore market this week, top hogs bringing 4.45. This shipment was made from Bethel growers. F. C. Martin, Jr., J. V. Taylor, Joe Bowers and F. Arnold were on the Baltimore market on day of sale and were very much pleased with the fact that hogs produced in this section were rated among the best hogs on the market that day. The market had for sale hogs from Ohio and other Western States.

Other shipments from the county will be loaded during the month. However, it is expected that the number of hogs shipped this year will be considerably less than last year due to the fact that Pitt County had a very short corn crop.

The old model school has been torn down and moved, the grounds have been clear and plenty of parking space is available for those who care to visit the market on sales days—Tuesdays and Saturdays. The sellers on the market continue to offer a large variety of fresh vegetables, dairy and poultry products and meat.

Those who contemplate making applications for seed loans should do so as early as possible. No applications will be received after April 30 by the Washington office, and since there is a possibility that the appropriation made by the Federal Government may be exhausted before that time, those who desire a loan should get it in to the Washington office as early as possible.

The growing of sweet potatoes for Northern markets has increased considerably in the past two or three years. In order to have the best quality of potatoes, it is necessary to begin with good seed properly treated and to follow the best practices in bedding and handling same. Therefore, we are submitting the following suggestions relative to the securing good plants for growing of crop which are as follows:

Time to Bed: A good general rule is to bed six to seven weeks before the plants are wanted for setting in the field. This means about the first week in April for the main crop in Eastern North Carolina.

Seed to Use: Best results will follow the use of disease-free medium sized potatoes for bedding stock. About eight to ten bushels of average sized potatoes are required to produce enough slips to set an acre from the first pulling. If two or three successive pullings can be made, five bushels should produce enough plants to set an acre.

Seed Treatment: Select for seed purposes potatoes which are free from blemishes and disease, and then treat with a solution of mercuric chloride to kill the spores of surface-borne diseases. If the diseases have already entered the tissues of the potatoes, no treatment will give control. Recent work done by Dr. R. F. Poole of the North Carolina Experiment Station shows that mercury chloride used at the rate of 1 ounce to 24 gallons of water will give best results. Formaldehyde is not satisfactory. The mercury chloride should be dissolved in a small amount of warm water. This is essential since it will not dissolve satisfactorily. Use only wooden or stone containers. A wooden barrel is very satisfactory. After treating fifteen bushels of potatoes, prepare an entirely new solution for each additional fifteen bushels.

The potatoes are more easily treated in bushel hampers or baskets. Clean sacks may be used as a substitute, but they are apt to weaken the solution and to cause greater bruising of the potatoes. The seed potatoes should first be dipped into clean water in order to remove particles of dirt which may weaken the mercuric chloride solution. They should then be placed in the solution for 15 minutes. The potatoes may be bedded as soon as they are moved from the solution, but should not be covered with soil until they are dry.

Bedding: Place the potatoes about three-fourths of an inch apart in the bed in order to avoid crowding of the sprouts. Cover with two to three inches of clean sand. If sand is not available, use sandy soil. Select soil which has not grown potatoes for several years in order to avoid re-infection with disease. If the soil is dry at the time of bedding, it should be given a moderate watering. It should never be allowed to become waterlogged. If it is not possible to locate the bed on high ground, drainage should be provided. Protection: When the potatoes are bedded as late as the first week in April, protection is not absolutely essential, but some protection is desirable. A covering of four to six inches of pine straw will afford protection from cold and at the same time conserve moisture. The straw should be removed as soon as the sprouts begin to come through the soil surface. If protection is needed after the sprouts come up, the straw may be thrown over the bed on cold nights or a covering of tobacco cloth may be provided.

Having been reared in Winterville where one sees only one and two story buildings with plenty of the great open space around them, Mr. Harrington felt a disinclination to go to the top of the Empire building even to see such a remarkable character as Smith. C., April 7.—A group of depositors of the local unit of the North Carolina Bank and Trust Company met here last night and called a meeting of depositors of both the New Bern and Bayboro units of the bank to be held in the court-house here next Monday night at 8 o'clock to consider the taking of steps for their protection. All units of the North Carolina Bank and Trust Company have failed to re-open except on a limited basis following the bank holiday called on March 4.

It is stated here that Bank Commissioner Hood will be invited to meet with the New Bern and Bayboro depositors.

New York Cotton

The initial advance which carried May to 6.59 and October to 6.98, or eight points net higher during the first few minutes attracted realizing and there also appeared to be more Southern selling. The early prices representing an advance of 45 to 49 points from the low level reached in the market here on the reaction of late last month, attracted realizing. May eased to 6.49 and October to 6.86, or about nine to twelve points from the best. The market at midday was barely steady net unchanged to two points lower.

Both houses agreed on compromise measures regarding physicians examination before marriage license may be issued. Instead any man able to present an affidavit from a doctor showing that he is free from tuberculosis or venereal disease will be free from examination.

The Senate tabled the Hinsdale bill to allow county commissioners to help defray expenses of legislators incurred since March 4 when legislation pay expired.

Another Hinsdale measure to authorize the state to issue \$12,502,371 in bonds to care for the current deficit, passed on second reading in the senate.

In an unexpected burst of speed the House yesterday approved the proposal setting up a state wide uniform eight months school and carrying a total of more than \$83,000,000 in allotment for 1933-35.

House Approves Bank Merger

Raleigh, April 7.—(AP)—Reorganization of state banks to form a mammoth state wide commercial bank received House approval today with passage of a bill asked by 56 banks.

Under the proposal banks not now open for unrestricted business under the bank holiday could merge assets for new banks if not more than one-third of depositors or the stockholders protested against the merger in thirty days after publication of the merger notice.

Rep. Taylor offered two amendments which were defeated, to prohibit any reorganized bank from dealing on stocks, bonds and like business and also from serving as trustees or executors.

Other Nations Invited to Confer

Washington, D. C., April 7.—(AP)—The chiefs of the French Italian and German governments as well as the British have been invited to come to Washington to talk more economic recovery with President Roosevelt.

Invitations to Italy and Germany were extended verbally today through the embassies. A similar invitation was extended by President Roosevelt to the French recently.

Each nation has been invited to send the head of its government. In the case of Germany and Italy this presumably would mean the dictators, Adolph Hitler and Benito Mussolini. For France it would be Premier Dolladier. Prime Minister MacDonald already has accepted a formal invitation and will sail April 15.

If the heads of State are unable to come, the three have been advised that members of their governments would be welcome. Failing in that, exchanges of views would take place through diplomatic channels.

Beer to Sell For 20 Cents

Wilmington, N. C., April 7.—(AP)—J. W. Jacobs, wholesale merchant, today said the leading brands of beer would sell for 20 cents for a 12 ounce bottle when the 3.2 per cent brew becomes legal in North Carolina May 1.

He said possibly draught beer would sell for 5 cents for a six-ounce glass. He said he was informed the leading brewers would put out a 15-cent bottle in thirty days.

During 1932 the total length of telephone wire in the London area, for subscribers' lines and interjunctions increased by 347,063 to \$3,572,662 miles.

Gambling Palaces To Lure Tourists Open in Brazil

Rio de Janeiro.—(AP)—Rio de Janeiro, in legalizing gambling again and permitting its seaside casinos to re-open, had a weather eye open for tourist business.

Restoration of gambling had been agitated since it was banned shortly after the provisional government took office in the autumn of 1930.

Under the new regulations, only casinos more than 100 miles from the center of the city may operate, and these must be valued at \$70,000 or more and have dining, dancing and theatricals on the side.

Foreigners will be admitted to such places of chance upon presentation of passports, but Brazilians must present identity cards. Cashiers or other persons handling money will be barred.

Casinos will pay the Federal district government 10 per cent of their profits in addition to 75 per cent of entrance fees, which will be about 70 cents a person.

Chamberlain Career Ending?

By OSCAR LEIDING London, Eng.—(AP)—Sir Austen Chamberlain, who ranks second to David Lloyd George for length of service in the House of Commons, has dropped a hint that he may soon retire from active political life.

He will be 70 years old next October and is now in the forty-first year of continuous membership in the Commons. Lloyd George, "Father of the House," died two years earlier.

There is nothing definite about the contemplated retirement. Sir Austen merely hinted at it in a speech in Birmingham. Political observers promptly jumped to the conclusion that he plans not to seek reelection at the end of the present Parliament.

Sir Austen's departure when it occurs, will remove a picture link with his father, the noted Joseph Chamberlain, who sat in the House for nearly forty years.

There is a visible reminder of the elder Chamberlain in the younger, who often sits now, as his father did, with a monocle screwed to one eye, his hat tipped back, and his legs stretched out.

Always the Monocle Sir Austen and his single eye glass seem never parted, no more so than his father and his monocle. There are other physical resemblances, though politically they often traveled different roads.

But Sir Austen projected departure will not mean, as long as his half-brother Neville is in the political scene, a severance of the last link with his father.

Neville Chamberlain, now Chancellor of Exchequer, a post Sir Austen held on two occasions, is in his prime at 64. It has been an assurance in the last few years that has marked Sir Austen's withdrawal to the political background.

Shared Nobel Prize Outstanding in Sir Austen's career was his promotion of the Locarno conference. For this achievement he was honored by King George with knighthood in the Order of the Garter and, with Charles G. Dawes, shared the Nobel peace prize for 1925.

Retirement may give him more time to spend with his flowers. An amateur gardener of no mean repute, he inherits his father's particular fondness for orchids.
