Big Powers Of World Asked To Attend Roosevelt Confab

PLAN ATTACK ON DEPRESSION EVERYWHERE

Europe, Asia and Western Hemisphere Fall In Line In Response to President's Invitation to Visit Washington; Bids to Other Governments Expected to be Made Soon; Conference Precedes London Meeting

Washington, D. C., April 8.—(AP)—President Roosevelt today shouldered the leadership of the world's first organized effort to attack that lurking common enemy—the depression.

In Europe, Asia and the Western Hemisphere the nations one by one fell into line in response to the President's invitation to come here and join the campaign with him.

Already invited to send the chiefs of government or other high officials were the "Big Four" nations of Europe—Great Britain, France, Germany and Italy; the "Big Three" of South America—Argentina, Brazil and Chile; and the two chief Oriental nations—Japan and China.

Bids to other governments are expected to be made soon.

The first of the visitors, Prime Minister Ramsay MacDonald, of Great Britain, planned to go to Washington from a week today.

In quick succession the bulk of the invitations were dispatched.

From foreign consuls came general expressions of satisfaction and indications of acceptance.

Those who have much to do with international conference know their fate usually is determined in advance and that success depends upon preparation made in the preceding months.

That is why President Roosevelt has chosen to assemble the statement at Washington for individual consultation in advance of the actual convening of the world military conference this summer in London at which an outline of the war against depression will be revealed.

BULLETS FALL IN U. S. CAMP

Fifteenth Infantry of U. S. Army Engaged By Fighting At Chingang-Tao

Peiping, China, April 8.—(AP)—The United States legion was informed today that bullets from fighting about Chinwang-Tao were falling in the summer camp of the Fifteenth Infantry Regiment of the United States Army.

The small detachment at the camp numbered about 800, including members stationed along the railroad to Peiping.

There were no reports of American casualties. Reports of the Rengo Japanese News Agency said that Manchukuoan troops had occupied the seaport and disarmed the Chinese garrison.

On the heels of the report at the legion there came in a British denial by Minister Lampton that British marines had landed Chinwang-Tao, which is ten miles southeast of Chankaiwan yesterday, to protest British interests.

Merchants Talk Sales Tax Here

A large group of merchants met last night at the Chamber of Commerce and discussed the sales tax from every angle. Hon. E. G. Flanagan was present and explained the many phases of the tax.

Representative Flanagan stated that he was going to offer an amendment Monday to recapture part of the tax which the large corporations will be relieved of when the 15-cent ad valorem tax is removed. He estimated that this amendment should raise three and half million dollars.

The merchants are unanimously in favor of passing the tax on to the public and are working out detail plans to see that the purchaser pays the tax.

The merchants went on record favoring the adoption of an amendment secured by Commissioner Maxwell legalizing agreements made by merchants for common action is passing on the sales tax to the consumer. One two Representatives and Senator will be asked to support this amendment.

STILL MAKING FARM LOANS

Regional Bank Attorney Here Denies Rumors Loans No Longer Available

Vigorously branding as false rumors that agricultural loans were no longer being accepted by regional banks, J. C. Lanier, local attorney for region bank loans stated today that they were still accepting loans that all applications would get immediate attention.

He said no restrictions had been placed on the amount of loans to be obtained through this source, and that each application would receive immediate consideration.

Persons in this locality desiring assistance in their agricultural endeavors were urged to get in touch with the local attorney and take advantage of the loan plan.

ALLEGED SLAYERS TO BE TRIED FOR ROBBERY

Tarboro, N. C., April 8.—M. W. Haynes has received a message from the Norfolk detective force stating that Woodrow Whitefield and Herbert Fulsher will be tried in that city on April 17 on a charge of robbing a Standard Oil filling station in Norfolk. These men are under indictment here for the murder of Caswell Suez, late commander of the John W. Wooten Camp of Spanish War veterans.

MOREHEAD TO BE HOST TO FIREMEN

Morehead City, N. C., April 8.—Firemen of this city will have as their guests Tuesday, April 11, the delegates of the Eastern Carolina Firemen's Association, which will meet in this city at that time. It is expected that over one hundred delegates will be in attendance from the fire department of the fourteen counties represented in the association.

Farm Home Robbed

Tarboro, N. C., April 8.—Thieves broke into the residence of Cad Harrell, well-known farmer who lives near Conetoe and stole \$3. Nothing else was reported missing. A bonus key was used of a rear door of the house to effect entrance. Mr. Harrell was in his field when the thieves entered and did not discover they had robbed his home until he returned about night.

Defer Election of Superintendent

RECOVER BODY OF VICTIM OF AKRON WRECK

Remains of Lt. Col. A. F. Masury Found Off the New Jersey Coast

U. S. S. Portland at Sea off the New Jersey Coast, April 8.—(AP)—The body of Lieutenant-Colonel A. F. Masury, U. S. A., ordinance research, who was a guest officer aboard the airship Akron on its last voyage, was recovered from the sea today near the scene of the disaster.

Colonel Masury's body was sighted by the tanker, John E. Archbold, at 9:30 a. m. The Archbold reported having seen the body, and it was picked up by the Coast Guard patrol boat Galatea, eighteen miles off Beach Haven, New Jersey.

Identification was made from papers found in Masury's pockets. The body is being taken to the Brooklyn Navy Yards by the Galatea.

Finding of the body brought the total list of recovered dead in the accident to three.

ONE KILLED ON HIGHWAY

Several Also Injured In This Patrol District During Month Of March

One person was killed and fourteen injured in automobile accidents in this highway patrol district during the month of March, it was made known today in the monthly report of Lester Jones, lieutenant of this highway division.

The death toll was slightly less than several previous months when the total for each month ranged from two to four fatal accidents. The number injured was also considerably less.

Out of 76 arrests made by the patrolmen during the month, 71 defendants were found guilty and six not guilty. Total revenue collected was given as \$4,289.57. Sentences totaled 196 months. The report also showed that 234 persons were warned for parking on the highways, 120 for hogging the roads, 33 for hearse driving on the shoulders of the road, and 26 for passing on curves.

Among those arrested by the patrolmen were sixteen for improper license, nine for no license, eight for driving drunk, seven for being drunk on the highways, eight for speeding, and four for faulty equipment.

REVENUE BILL FIRST VOTE TO COME MONDAY

Measure Placed on House Calendar Today; Misunderstanding Stalls Work

Raleigh, N. C., April 8.—(AP)—The biennial revenue bill containing a three per cent sales tax and estimated to raise enough money to balance the State budget, including operation of the eight months' school term, was placed on the House calendar today.

Representative Doughton of Allamance finance chairman, pointed out that a misunderstanding had arisen and the bill would not be passed on the first reading until the Finance Committee reported is adopted by the House Monday. The test vote will then come on second reading.

A voluminous beverage control act providing regulatory machinery for the sale and manufacture of 3.2 per cent alcoholic beers and wine in the State was introduced in the Senate.

With only local bills to consider the legislative sessions lasted only forty minutes and were attended by 39 of the 170 members of the Legislature. Twelve Senators met twenty-two minutes got two new bills and passed seven measures. The House met eighteen minutes with twenty-seven present to get three new bills, and passed one other proposal.

CITY SUFFERS HECTIC NIGHT

Four Fire Alarms Keep Citizenship in Nervous Condition All Night

The city was suffering today from a severe attack of neurosthenia following a hectic night of fire alarms. Four times the bull-throated whistle atop the City Hall belloyed its warning of fire, and each time two fire trucks, with sirens wide open, dashed from one section of the city to another in search of fire.

Two of the alarms were false, and while the "Larmist" had not been arrested, police today had thrown out a dragnet, in an effort to bring the culprit to justice.

The first alarm sent in about 8 o'clock, sent the truck speeding to Roosevelt Avenue where the house occupied by Lillie Woolard, colored, was ablaze. This was quickly extinguished. Between 9 and 10 o'clock the two false alarms went in and hundreds of people sped along with the fire department to Boxes 71 and 64 to find that somebody had been playing a very dangerous prank on the firemen.

This morning about 5 o'clock the bull-throated whistle again emitted a warning blast. This time there was really a fire, and it totally destroyed the home of Lillie Woolard to which the firemen had been called during the early part of the night. The loss was estimated by firemen at around \$1,000.

Nobody could account for the false alarms. Some attributed it to the excitement accompanying the spirit of celebration in connection with the opening of the new stadium, but others scouted the idea, declaring it absurd. But one thing everybody knows the city was kept in a neurotic condition by the alarms, and many will have to take a sedative before being able to creep into the arms of Morpheus tonight.

MILLER MACHINE SHOP BURNS IN ALBEMARLE

Albemarle, N. C., April 8.—Fire of undetermined origin destroyed the E. C. Miller foundry and machine shop here about 1:30 o'clock this morning, entailing a loss of several thousand dollars, partly covered by insurance. The plant, one of the largest of its kind in this section, covered much floor space and nearby buildings were threatened by the intense heat. Several acetylene tanks exploded during the conflagration, but fortunately no one was injured.

FREED ONE OF ANOTHER HELD FOR ANOTHER

Rocky Mount, N. C., April 8.—Lewis (Conn) Taylor and Fritz Brinkley, local residents, were free of implication today in an attempted robbery at Fayetteville in which a third man, A. W. Bradford, former resident of this city, was fatally shot by officers but were nevertheless being held in connection with another robbery in which an oil company office was looted.

NEW STADIUM DEDICATED ON THIRD STREET

Large Crowd Present At Impressive Exercises at Athletic Field

The new athletic field and community club house recently constructed at Third Street School were formally dedicated and thrown open to the public yesterday afternoon before one of the largest crowds ever to attend an occasion of the kind here.

The exercises, consisting of inspection of the field and building, short talks and flag raising were of inspirational and impressive nature and were followed by a ball game between Greenville High and New Bern, members of the Northeastern Athletic Conference.

The day was ideal for the dedication of the field, considered one of the best in this part of the State, and the grandstand and bleachers were crowded to overflowing. Those who failed to gain seats crowded about the field and craned their necks expectantly awaiting with eager anticipation every part of the program, and especially the hair-raising finale provided by the ball game.

New Bern grabbed a two-run lead at the beginning of the game and held it until the eighth inning when heavy stick work by the locals sent four runners over the rubber. At the end of the game it was announced that New Bern was the victor as a conference agreement called for seven-inning games.

The hundreds of people who had almost split their throats in the thrilling finish provided by the local boys felt like sitting down and weeping, and probably some of the angelic little things who were glorying in the diamond work of their ideals, did do so, but they kept it all to themselves.

The dedication exercises got under way when the High School band headed by J. H. Rose, superintendent of city schools, J. L. Little, chairman of the school board, Mayor R. C. Flanagan, and followed by members of both ball clubs, paraded from the club-house to the front of the grandstand. As the band blared forth a lively tune, the hundreds gathered in the stands cheered enthusiastically.

Mr. Rose spoke briefly, telling of the new plant possible. He then presented the field to Mr. Little, who in turn presented it to Mayor Flanagan, as a gift from the School Board to the city.

Mayor Flanagan spoke of the value of the field to the young of the community, and praised Mr. Rose for his unflinching interest in making it possible.

At this juncture notes of a bugle floated across the field and the Stars and Stripes were raised on the flagpole above the grandstand.

After the flag-raising Mayor Flanagan walked out to the pitchers' mound and tossed the first ball to Martin Swartz, superintendent of the Water and Light Commission who missed the toss and delighted shouts from the grandstand.

The day was a great one for the schools and the public alike, and the interest manifested by the public through attendance was a source of (Continued on Page Four)

PRES. WRIGHT MAKES APPEAL TO EDUCATORS

E. C. T. C. President Welcomes Visiting Teachers From All Sections of State

"Our job is, working under the law as passed to give back to our State the finest type of citizenship our powers, with the funds at our disposal, can produce." President Wright said in his address of welcome last night to the administrators and teachers of the public schools who were assembled at East Carolina Teachers College for the Educational Conference. "The college training teachers and the people out on the firing line must confer with each other and jointly work out problems that confront us," he further said, and closed with the wish that they might find strength in counsel and help in conference.

His speech struck the keynote of the meeting. The group of superintendents, principals, supervisors and teachers and college teachers, worked earnestly through the solution of one practical problem after the other during their two-day meeting, which closed at noon today.

The vote for the continuation of the conference was unanimous and the general feeling of those participating was that the meeting was exceedingly valuable and that much good would result.

FIVE CLASSES LICENSES ARE TO BE ISSUED

Operation of Establishments For Sole Purpose of Selling Beer Barred; Measure Provides Stringent Rules For Sale and Distribution; Many Classes of Business to Be Permitted to Handle Beverages

Raleigh, N. C., April 8.—(AP)—Legislation setting up stringent rules to govern the sale and distribution of beer and light wines and to permit manufacture of 3.2 per cent alcoholic beverages in North Carolina, was introduced in the Senate today by Senator Francis of Haywood.

The measure is a supplementary bill to the Francis law legalizing the sale of 3.2 per cent alcoholic beverages but barring manufacture. Legislators have expressed the opinion that beer cannot be legally sold in the State under the present Federal law unless it is also manufactured in the State.

Under the bill five classes of license will be issued:

A license to allow sale and consumption on the premises of bonafide restaurants, drugstores, groceries, cafeterias, lunch stands, filling stations, cold drink stands, tea rooms and regularly incorporated or chartered clubs and hotels.

Consumption on premises must be at regular tables, but the beverage may be served in hotel rooms.

In original packages, such as bottles, it may be taken from the premises elsewhere.

The licenses would be issued by the Board of County Commissioners at fees they set. Operation of establishments for the sole purpose of selling beer and wines is barred.

Brewers or manufacturers' licenses allow manufacture or sale of legalized alcoholic beverages to be issued by the State Revenue Commissioner with the fees not to exceed \$500 permitted.

Wholesale dealers' licenses to be issued to regularly licensed wholesalers to permit distribution of the beverage with a State fee not to exceed \$150.

Railroad train licenses to permit sale of beverages on railroad trains. State fees not to exceed \$300.

Salesmen's licenses to permit salesmen to offer beverages for sale. State fees not to exceed \$10 per license.

Premises' license may be issued only after the County Commissioners have posted at the court-house the names of the applicants and place where it is proposed to sell the beverages.

No doubt Will Rogers was right in saying that "America didn't want a drink as bad as they wanted the right to take a drink if they did happen to want one." We have previously stated in these columns that it was our belief that as soon as the novelty of being able to purchase beer in this state wears off the beer dealers as well as those who are expecting large revenues from the sale of beer are in for a disappointment.

The Senate continues its efforts on the farm legislation. Let us hope that the matter is pushed to an early conclusion in order that the farmer might be enabled to get a fair return for his labors. Not until the farmers get a living price for their products can the rest of the country know prosperity, and the sooner this fact is realized the better off the entire nation will be.

THEY SHOULD PAY Representative E. G. Flanagan has pledged local merchants that he will introduce an amendment to the revenue bill whereby the state could recapture from the large corporations a portion of their savings under the reduction of the ad valorem tax made possible by the sales tax and it is to be hoped that such an amendment will receive favorable action. The large corporations that are still making huge profits will have to pay no sales tax but will receive great benefits through the reduction of the ad valorem taxes. In view of this it is just that this recapture clause be placed in the revenue measure for these big corporations are amply able and should be made to pay their just share of the tax burdens.

The next few moments are not very clear in my memory. I managed somehow to get the door open and the limp thing dragged through it and into the corridor, and then I could see it in the light from my own room.

I was a man. I did not know who he was. He was dead. I knew that at once. And it was a very ugly death, for he'd been stabbed. I remember saying to myself: "Don't touch anything, this is murder. Don't touch anything."

Then I was in my room. No one was there: Sue was gone. I was pressing the bell with my thumb. I finally released the button, noted that my thumb had stained the white button in a perfect and gruesome thumb mark, and hurried to the bathroom, where I washed my hands. And then I came back to the bell and washed it, too, with a corner of the towel, and rang again.

I was still pushing the bell and wishing the dead man wouldn't stare so, and in the same moment cursing myself for being so shaken, when I heard the door away down at the beginning of the north corridor open. I stepped out into the hall, avoiding a hand which had

Greeley, Colorado.—(AP)—What Mikki Hiri and Felix Kissa say in the comic strips of "The Helsingin Sanomat" of Helsinki, Finland, looks nobody's business to the staff of the Greeley Daily Tribune, or anyone else who can't read their language.

Yet its members, working intently in preparation of the Colorado paper's "world newspaper fair," scheduled for early May, see in these smile-provoking features evidence of the way in which the daily newspaper makes the whole world kin.

Crosswords Everywhere

Crossword puzzles are printed in Arabic and Japanese newspapers and in those of almost every other language. Black-haired maids in gardens at Yokohama and Bagad grope for four-lettered words meaning prehistoric animals, just as their sisters and brothers do the world over.

As for the "world's newspaper fair" idea, it has grown into something bigger than expected when early in February the staff sent more than two hundred letters in several languages to legations in Washington, consuls in various cities and direct to the papers.

Response Astonishing

Response indicating interest in the fair to be held in a small northern Colorado city astonished its originators.

Practically every European country is now represented. The great journals of the British Isles are here. Canada has been completely covered. Letters have brought papers from Trinidad off the coast South America. A daily at Cairo, Egypt, has replied. Papers from Bagdad on the Persian Gulf, Moscow in the U. S. R., Khartoum in the Sudan and Japan have arrived.

Arabic, local news folk have learned in the language that arouses this invariable comment: "Is it written or printed?" for someone always recognizes the handwriting of a relative.

The fair will be held in the paper's community center, divided into their rooms by newspapers suspended from wires. In some cases translations of the most interesting front pages will be hung with them.

Other papers will be bound and placed on reading tables according to geographical divisions, and each section will be provided with maps.

Several newspapers responded with historical material of great interest. These with local offerings of papers with valuable historical events will be featured.

The exhibit will be kept open two weeks and will be re-opened for Teachers College summer session. The May showing will be open to students from some three hundred public schools in the county.

Washington Daybook

A WASHINGTON DAYBOOK BY HERBERT PLUMMER

Washington, D. C.—The tremendous majority that the Democrats enjoy in the House may be unwieldy and a bit troublesome at times, but there are occasions when Joe Byrns, the majority leader, and his aid must breathe a fervent prayer of thanks that they have it.

An outstanding occasion was just the other day when President Roosevelt's reforestation bill was before the House and about to clear the last legislative hurdle.

When final passage of the measure was in sight, from the Republican side, in the person of Mr. Beedy from Maine, came a point of order that struck at the very heart of the bill. Beedy's contention was that the method by which the money to finance the proposed project was to be raised was illegal.

The rules of the House left no choice to the presiding officer. They clearly upheld Beedy and the chair so declared.

The chair's ruling had the effect of rendering the bill useless. Without money the President's plan couldn't possibly be made to operate.

Byrns, however, swung into action. He gathered his aides about him in a hasty consultation and then things began to happen. First he asked and got a recess for 10 minutes.

Out of the chamber scurried members of the rules committee to their regular meeting place one floor above. There a special rule was quickly whipped into shape. This was a 5-42 p. m. At 5:52 p. m. they were back on the floor ready to proceed.

The special rule, which had the effect of abrogating the chair's previous order, required a two-thirds vote to pass. Such action required about two minutes.

At first glance it would appear that the Democratic leaders had been caught napping.

It's hard to believe, however, that such congressional veterans as Byrns and Rainey would have overlooked such a vital thing as that. That such a point of order would be raised they must have foreseen.

roles, Miss Loy, freckle-faced and pretty, is enjoying the departure from the old imprisoning niche—but with reservations. "I've had to much to do," she says. "I'm worn out. I hear there's a part waiting for me after I finish 'When Ladies Meet.' I hope not—it's been more than a year since I've had any time off, and I need a rest."

There was a time when Myrna, stamped as the Chinese, Japanese, Polynesian, Indian or Malayan siren, had enough time to herself, because rarely would any director vision her as she is, an American whose real name is Myrna Williams and a consistent actress. And oriental roles were not frequent.

Myrna's eyes aren't slanted; the reason she makes up so effectively as an oriental is seen in her eyelids. The lids are wide between brows and lashes, and they are smooth rather than indented like most people's; her fondness for bizarre make-up when she was a stage dancer, after leaving school, made it natural that the movies should take her as an oriental type.

"I thought it was fun then," she confesses, "and it was. The characters were interesting, and I seriously studied to make them right. In fact, I think I studied too well. I read oriental philosophy and tried to steep myself in oriental thinking. I didn't know then how difficult it would be to break away from the type I was perfecting!"

But break away she did, however difficult it was. She was a heavy in "The Animal Kingdom" but a subtle, sophisticated sort. Her acting revealed smoothness and sparkle. It was the same in "Topaze" and now in "When Ladies Meet" she has a sympathetic part—as an American.

Her change in screen type has been accompanied by an equally impressive change in her own personality. Four years ago, when she was playing heartless gypsy sirens, Egyptian enchantresses and Indian princesses, she was one of the most timid souls in Hollywood.

"But I got over that," she laughs. "I had to—I was suffering too much."

New Books

By JOHN SELBY New York—Recent days have released two first-rate biographies, one of an average woman whom circumstances forced 'into greatness and martyrdom, the other of a man who overrode his own and others' mistakes and became one of our most interesting Presidents.

Stefan Zweig's "Marie Antoinette's" is quite likely to become the definite biography of that pathetic character. It is more remarkable for the material Zweig has discarded than for the new material he has unearthed, although there is plenty of the latter.

And the problems of Louis XVI's incompetence, and Marie Antoinette's morals are considered with absolute frankness for perhaps the first time in a popular biography.

The reader will miss many pretty little incidents which, Zweig feels, never happened. A large share of the so-called letters of the queen are discarded as forgeries, and most of the fawning biographical data that appeared after the Bourbon restoration is scrapped because Zweig regards it as untrue.

But a vast amount of research has filled in many caps and revealed new material, so that one of the most romantic careers in French history at last may be appreciated.

Andrew Jackson So, too, with Marquis James' "Andrew Jackson." Mr. James neither debunks nor pretties up this intrepid and often mistaken man. He takes no liberties with the facts, which is to say that the book is scholarly in the best sense. But it is also readable for pleasure.

Mr. James finds his subject by no means the expression of a frontier democracy he is popularly labeled, but an aristocrat and a gentleman as those words were understood in his time. His inexorable will, his occasional cruelty, his strange sensitivity and a personal integrity less philosophical than philosophical than instinctive are details of Mr. James' picture.

The book leaves off in 1824, so that a second volume is probable.

"?????" The publishers of "Tunchi," struggling to find a classification into which their book would fit, finally gave up and put down simply "?????"

Their bewilderment is understandable, for the book seems to be the first known ethnological romance.

The head-hunting Shuar Indians of eastern Ecuador, whose knack for shrinking human heads to the size of an orange was developing into a thriving souvenir business when Ecuadorian authorities stopped it, are the subject of the ethnological study.

And a love affair between a girl of the tribe and the New Yorker emissary of a chemical fertilizer company provides the romance. This material, lived by Carl Liddle and put into words by David Thibault, makes a book sometimes unexpectedly touching.

Less vivid and more pathetic is "White Man, Brown Woman," by T. L. Richards and T. Stuart Gurr, in which a white man who loved the women of the South Seas tells all about it. And gargantuan is the word for Evelyn Scott's latest—799 pages of rambling philosophical novel.

ing that more than the score was essential in giving these. The chief dangers in these, he pointed out, are over-emphasis and under-emphasis; their chief use is for diagnostic purposes and for pointing out where difficulties lay.

Miss Jeanette Sesoms, classroom teacher from High Point, in discussing "Some of the Ways in Which the College Can Help Teachers Who Are Teaching for the First Time," pointed out the benefits of having supervisors follow up on the young teachers and observe them for a day, of teachers coming into closer contact with the working area before entering as a teacher, of writing back to critic teachers for advice, and of an exchange of student teachers in the field for a few days.

Miss Cleo Rainwater, critic teacher, read a most valuable paper on "What Information Can High School Principals Give the College About the Graduates They Send to College That Would Enable the College to Make the Most of the Material?" The speaker stressed the importance of personality, citizenship and emotional attitude toward success.

The groups discussed separate the question as to the advisability of the offering of extension courses by the teachers colleges. Both reached the conclusion that these courses were desirable, if the right kinds of courses were offered and plans could be made to reach the group centers needing these. Other topics were suggested from the floor in both groups and were discussed, but most of them grew out of the set problems or reached back to them.

Supt. K. R. Curtis, of Wilson, made an excellent summary of the desirable and undesirable qualities of a teacher, following the method that others had used of quoting directly from letters from superintendents themselves. In answering the question, "How May Undesirable Teaching Mater Material Be Eliminated?" he showed that the poor teaching could be eliminated without eliminating the teacher by careful supervision and criticism.

Supt. J. O. Bowman—of Duplin County, summed up the work of the conference, and voiced the spirit of the whole group when he said that the school people of the State were determined to go on in spite of depression and do all that could be done to meet conditions as they found them. He referred to President Wright's address as a great challenge to those training for citizenship.

The following paragraph from his speech sums up President Wright's attitude toward the task ahead: "Because the State is taking over the schools and many things we have done in the past we cannot do today, is no reason why we cannot build into the lives of our children the truths they must live by. The State will make a fatal mistake if it so circumscribes the schools that the teachers cannot build into the lives of the children of today these great fundamental principles of life. The State should supply the money to operate the schools, and then let the right-minded teachers, supervisors, and superintendents do the rest. If the State attempts to do more for the schools may become the cause for the destruction of the State. I know this is strong language, but it is the truth and some one should say it. To warp the mental growth of the child may destroy him as a good citizen. The only function of the State outside of furnishing the financial support for public education is to lay down the fundamental principles of an education, such as the development of right-minded citizens. The details of the curricula, and of the administration of the schools must be worked out by men and women trained in this field of public service. These things cannot be worked out in sixty days by any body of men. A board by any name, that tries to make all children equal is of necessity a board of destruction, and not a board of construction."

"Unquestionably we are facing a new era in our civilization. Many old things must give away to new and untried ones. The government of our fathers will not be the gov-

ernment of our children. It is the duty of the schools of today to train the children to meet the requirements of good citizens of tomorrow. If we do not know, and we do not just what that government is to be, then we must so educate that the child of today will know how to make his adjustments to the needs of tomorrow. We must be willing to give up tradition and adjust himself to known facts. He must be able to weigh facts and find the truth; for after all it is said it is the truth that makes men free."

Almost as soon as the governor announced he had ordered the continuance of the wage scale temporarily rumors spread over capital hill that Ehringhaus and Henry Burke had come to a definite parting of the ways over the wage question.

Two Held For Counterfeiting

Rocky Mount, April 8.—(AP)—M. Von Milgrom, once prominent jeweler here, and his son Robert, were held by police today on a charge of making and passing counterfeit currency. H. G. Cuthrell, bound to federal court on charges of counterfeiting earlier this week implicated the Von Milgroms when questioned by the police. Officers found a mold in Von Milgrom's home and a counterfeit quarter in the gas meter. He denied the mold was used to make counterfeit money and said it was a ring mold.

ASKS RUN-OFF PRIMARY IN MAJORITY FIGHT

Kinston, N. C., April 8.—Judge Guy Elliott has notified the city Democratic executive committee here that he will demand a run-off primary to determine the nominee for mayor. Elliott, a former judge of the police court, was runner-up to Dal F. Wooten in last Tuesday's biennial primary, in which Mayor James C. Dall and Robert L. Crisp were eliminated. Wooten led him by about 300 votes. Eight candidates for the five seats on the board of aldermen are expected to go into the second primary.

ALBEMARLE PREPARING FOR HANDLING OF BEER

Albemarle, N. C., April 8.—A survey of the town made this week among restaurants, filling stations, garages and drug stores reveals the fact that no one will suffer the pangs of thirst after May 1, insofar as beer is concerned. Practically every place approached on the question is now making preparations to handle the beverage.

A Washington Day Book

By HERBERT PLUMMER Washington.—(AP)—As a general thing, the wife of the President, isn't usually a source of what newspaper folk call "spot" news.

That doesn't mean, however, that they haven't at times been in the day's interesting stories. Mrs. Hoover, for example, stirred up a controversy while she was mistress of the White House by dismissing her secret service attendant and driving her own car around Washington.

So-called arbiters of etiquette protested to be shocked that the President's wife should do such a thing. And that celebrated incident of the time Mrs. Coolidge was late to luncheon in the Black Hills and kept the President cooling his heels also was news.

But the point is, First Ladies never have been considered of sufficient news importance for the Senate and press gallery correspondents in Washington to worry about them very much.

Twice a week most of them drop everything and go to the White House to attend the President's regular press conferences. They would not think of missing one of those

Wednesday morning or Friday afternoon sessions with the chief executive. But it now appears that there are other news sources at the White House than merely Mr. Roosevelt. Mrs. Roosevelt has emerged as a news-maker who will bear watching.

Once a week Mrs. Roosevelt gives a press conference of her own which is attended only by the newspaper women of the capital. The men of the craft had thought little of these weekly meetings and had ignored them. Then the other day they had their eyes opened.

It seems that Mrs. Roosevelt told the young women who had gone to the White House that day that while she was a teetotaler herself, she was legal to serve beer, then guests at the mansion may have it for the asking. And then she switched to the subject of Easter clothing and voiced objection to the purchase of gowns which in price and manner of manufacture would proclaim they must be sweat shop work. Since the secretary of labor is waging a crusade on this subject at the present time the announcement was regarded as highly significant.

The men correspondents in the capital were jarred considerably when they read these stories in the paper and realized they had been scooped. What they'll do about it is not yet clear. But the general attitude seems to have been expressed by a columnist on one of the Washington papers. "If the girls think we men" he wrote, "are going to miss out on such economic stories they are as crazy as galeots."

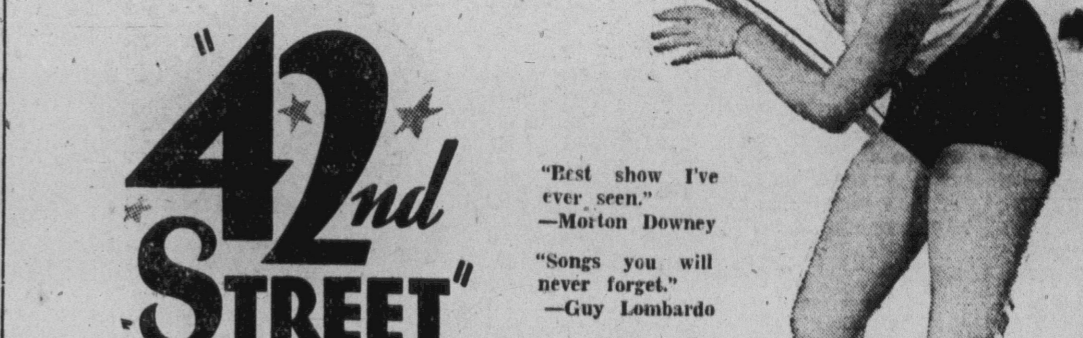
