One Killed And Several Injured By Bomb Blast In Political Disturbance

17 EXPLOSIONS SHAKE CITY IN A SHORT TIME

Police Warned of "Red Week End" by Anonymous Letters; Mounted Troops Patrol Principal Streets Automobiles Stopped and Searched as Police Attempt to Round up Terrorists; Score of Students Seized

Havana, Cuba, April 14.—(AP)—Troops were called today to stamp out "terrorism" after seventeen bomb explosions which killed one and injured three or four others.

The blast came on the heels of several anonymous letters to police headquarters warning that yesterday would start "Red week-end in Havana."

Cavalry was called out after police had started a round-up of persons suspected of terrorism and who showed opposition to President Machado.

The mounted troops patrolled principal streets of the city while automobiles were stopped and searched.

Police seized a score of youths, three of whom were taken to the police station for questioning. Police patrols armed with machine guns guarded against further outbreaks.

The shooting started when police said they arrested Marcel Garcia, 19, for carrying a bomb at a street corner. He was probably fatally wounded.

The bombs were attributed by police to political terrorists, and so quickly did they follow one another that police and newspapermen could hardly keep up with them.

REDRYING PLANT HAS SUCCESSFUL SEASON

Lumberton, N. C., April 14.—The Lumberton tobacco redrying plant operated by the firm of Whitehead and Anderson of Wilson, J. W. Priddy, manager, closed down for the season Thursday, April 13, after nine months' operation, during which the average of tobacco handled was about twice that of the preceding season.

This plant has shown substantial growth each of the three years it has been operating. The first year it closed the middle of November. Last year it went until the end of the first week in February. This time it has operated continuously since the middle of last July. Since October it has employed an average of from 135 to 140 people daily.

LARGE FISH CATCHES IN THE ROANOKE RIVER

Williamston, N. C., April 14.—Fishing activities on the Roanoke took on much added interest early Tuesday when the catches were increased two, three and even four times in size over the catches of a few days before.

At Camp Point, a few miles below Jamesville, one report stated that from 12,000 to 15,000 herring were taken at the first dip Tuesday. The Fleming Fishery at Jamesville reported around 10,000 caught in the first dip there Tuesday morning, the catches averaging from 5,000 to 7,000.

NEW CHARGE ENTERS INTO MOSCOW CASE

Soviet Employee Says Briton Attempted To Bribe Him Last Year

Moscow, April 14.—(AP)—A charge of bribery was flung today from the witness stand in the trial of six British engineers and eleven of their Russian associates on charges of espionage against the Soviet Union.

A key Dolgov, chief of the Soviet Department of Imports, said a bribe of 3,000 rubles, about \$1,500, was given him by L. C. Thornton, one of the defendants.

Dolgov said he considered this a bribe to influence him to conceal defective machinery installed by the Metropolitan-Vickers Company of England, which employed the defendant.

"The money was given to him in Thornton's office in June, 1932," Dolgov said.

Thornton then was called upon to stand in the prisoner's box. He admitted giving the money to the man, but said it was a loan. He said Dolgov requested it in order to buy an apartment for himself and promised to return the money.

GUARD TRAIN FOR DANIELS

Detectives and Soldiers on Train Bearing Ambassador to Mexico City

Mexico City, April 14.—(AP)—A train carrying a special guard of Texas Laredo detectives bore Joseph Daniels toward the capital today for his new duties as Ambassador from the United States.

Railroad circles here issued a report which was not confirmed, that an armored car had been added to the train at the border as a further protection to the Washington envoy.

Half a company of Federal soldiers were reported riding in the car as the train escort.

Armored cars were removed from Mexican trains several years ago. Ordinary trains today carry from ten to fifteen soldiers as passengers. A dozen Mexican detectives were assigned to accompany the train from the border as far as the Rio Grande.

Daniels was asleep when the train entered Nuevo Laredo, the Mexican town across the Rio Grande.

A special car was waiting there and it was hooked onto the train. Railway officials said Mr. Daniels would occupy it when he awakened.

Funeral services for J. L. Hassell, 63, well known railroad man and member of the Board of Aldermen, were held from his late home on Pitt street this afternoon at 4 o'clock. ORDER PROBE OF SURCHARGE BY RAILROADS

Action of Four States To Receive Attention of I. C. Commission

Washington, D. C., April 14.—(AP)—Investigation into the refusal of North Carolina, Georgia, Alabama and South Carolina to permit railroads to continue surcharges on freight bills was ordered today by the Interstate Commerce Commission.

The commission set the probe for the hearing on May 1 to May 4, inclusive, with North Carolina appearing May 1, South Carolina May 2, Georgia May 3, and Alabama May 4.

The four States' railroad commissions refused to go along with the Interstate Commerce Commission when it recently authorized railroads to continue surcharges for six months from March 31. They declared the surcharges which had been in effect fifteen months would be discontinued on freight in the States.

The railroads operating in the State appealed to the Commission and the investigation was ordered.

BEER IS MADE LEGAL IN S. C.

Legislature Passes Measure For Immediate Sale of Wines And Beer

Columbia, S. C., April 14.—Governor Blackwood today signed the beer act legalizing the sale of 3.2 per cent beer and wine in South Carolina for the first time in sixteen years.

The stroke of the chief executive's pen was the signal for dispensers in all parts of the State to get ready to pass the foamy liquid to the thirsty of the Palmetto State.

The measure was ratified by the Legislature last night after the House with a roar of "ayes" concurred in Senate amendments to the measure.

It authorized immediate sales anywhere and any time, placing no restrictions except the payment of 15 cents a gallon tax, or 2 cents on 12 ounce bottles, with one cent being added for additional six ounces.

SHIP CHICKS TO NEW YORK

Car Load of Poultry Being Loaded at Bethel Today For Northern Markets

The fourth carload of chickens to be shipped from this county this year was being loaded at Bethel today in preparation for shipment to the New York market tonight.

The chickens were being loaded at the A. C. depot and were expected to bring ten cents a pound when they reached market.

The second carload of the year was loaded at Ayden Wednesday and the third at Greenville Thursday.

The total shipment for the season should bring the growers around \$6,400, and this isn't anything to be sneered at during these times when dollars are as scarce as the proverbial hen's teeth.

Several cars of hogs have also been shipped from the county in recent weeks, and while figures were not available it was a known fact they brought additional thousands of dollars to producers in this city.

TWO SOLONS FILE MEASURE THIS MORNING

Burgwyn and Blackstock Would Create A Hydro-Electric Commission of Five Members Empowered to Issue Bonds And Buy Land For Establishment of State-Owned Power Plant; Along Same Lines of Muscle Shoals Measure Now In Congress

Raleigh, N. C., April 14.—(AP)—A proposal to place the State of North Carolina in the hydro-electric business was made in the Senate today by Senator Burgwyn, of Davidson, and Senator Blackstock, of Buncombe. They introduced the bill to create a hydro-electric commission of five members who would be empowered to issue bonds and buy land by condemnation or other proceedings for establishment of a State-owned power plant.

Burgwyn said the measure was based on the Muscle Shoals bill now before Congress. He said it would do what New York is attempting to accomplish with the St. Lawrence River project.

"The power industry is as much a public enterprise as highway and schools," declared the Davidson Senator.

The commission proposed would be appointed by the governor and approved by the Senate. The tenure of office would be five years with the first five members named for terms of one, two, three, four and five years to provide for overlapping terms in the future.

GOOD WORK, WELL DONE.

It might appear that it is becoming a daily habit with us to congratulate our two representatives in the lower house of the legislature but during the past few days their action on the revenue bill has so coincided with our ideas in the matter, and as we believe, the wishes of the people of this county, we feel that whatever amount of praise we give them is well deserved and we are glad for our readers to know the efforts that are being made by our representatives in their behalf.

We repeat our contention that the bulk of the needed revenues should be derived from the power companies, foreign stocks and large corporations that are making millions in net profits and can stand an increase, before any more tax is passed on to the little man and each of these issues during the past three days has had the vote and support of Messrs. Flanagan and Edwards. Our contention has been that after these other sources were taxed and there still remained a deficiency to necessitate any kind of sales tax that it should be a selected commodity tax rather than one upon the bare necessities of life and despite the majority vote against this plan in the House last night our two Representatives still stood true to their course by voting for the measure.

It appears now that in the end the opponents of a general sales tax may have to accept a compromise on the general sales tax plan with the bare necessities of life exempted from the tax but such a tax in its last analysis, provided the real necessities are exempted is a selected commodity tax after all, and if forced to accept such a compromise our representatives will be justified in so doing.

Again we say that they have so far run a true course in their efforts to keep the burdens off the backs of the poor and we congratulate them on this stand and urge them, in accepting any compromise whatever to see to it that the burden is placed as far as possible upon those most able to pay.

It develops that the only item now causing any hesitation about promotion of the Max Schmelling-Max Baer fight in the Yankee Stadium, June 1, under the auspices of Promoter Jack Dempsey concerns the willingness of the Yankees to consider transferring a scheduled ball game with the Athletics from June 2 to some other date.

The idea, of course, is that the fight interests want to have at least one day's leeway so that in the event of rain preventing their holding the bout on Thursday night, they would not be obliged to go to all the bother and expense of removing their ringside seats and other equipment to make way for a ball game on Friday. Moreover, with tickets sold in advance and the ballyhoo steam up, a week's postponement or more of the fight might cause a serious reaction among the cash customers.

The Yankees could oblige Dempsey, since they have an open date on the following Monday, but the A's unfortunately are billed on that date with Washington in Philadelphia.

The Polo Grounds is available, as an alternative, if Dempsey sticks to June 1 as the date for the fight, but

fight promoters have steered clear of the Giants' Park ever since the difficulties that marked the ringside seating arrangements for the famous Dempsey-Firpo fight there ten years ago. Besides, the Polo Grounds offers only 3,500 bleacher seats, poorly located for fight customers of the one dollar variety, whereas the Yankee Stadium can accommodate 22,000 bleacher customers, with a good view for all.

Rowing Interest Keen The under-current of regret over the cancellation of the Poughkeepsie Regatta this year has grown since the students at most of the big Eastern colleges have demonstrated their willingness to make sacrifices, in the interests of economy, as well as their ability to sustain or develop athletic activities on the "cash and carry" plan.

## Would Not Scrap N. C. Game Laws

Washington, D. C., April 14.—"It looks as though North Carolina is about to do the 'crab act' and slip down the long hill of despair and regret in attempting to return twenty-eight counties to the failure-proven system of county administration of game fish," Seth Gordon, president of the American Game Association, said in a bulletin issued here today in protest against the Ingram bill designed to remove twenty-eight counties from the operation of the State-wide game and fish laws of that State. The bill passed the Senate last week.

"If this bill goes through the House and becomes law, it will utterly ruin the work of the last six years," Mr. Gordon declared emphatically. He also pointed out the unfairness of placing the entire burden of State-wide administration on the remainder of the one hundred counties of the State.

"Six years ago North Carolina shook off the shackles of county game and fish administration, and immediately took her place at the top of the ladder with other progressive game and fish States," Mr. Gordon's statement continues.

"This movement to eliminate the obsolete county game and fish systems was unanimously victorious throughout the nation when Washington changed its leopard's spots—some counties good, others black—and established the State-wide system of game and fish administration last January.

"North Carolina's progress during the past six years has been decidedly good. At last North Carolinians are beginning to appreciate what can be done through State-wide administration. They are awaking to the great economic and recreational values of game and fish resources.

"The American Game Association has studied game and fish administration in every State of the Union for the past two decades, and we know that the proposed plan will wreck the game and fish activities of the Department of Conservation and Development.

"Surely the thousands of outdoor

residents of North Carolina will not permit such a catastrophe to happen. No county in North Carolina should be permitted to get up the old wasteful county system of handling game and fish affairs.

"The only way to head off this disastrous proposal is to let your members of the General Assembly know your views at once. Telephone or wire, or better still, go see your member now! Don't allow North Carolina to ditch a system that produces results," Mr. Gordon concluded.

## Would Not Scrap N. C. Game Laws

Washington, D. C., April 14.—"It looks as though North Carolina is about to do the 'crab act' and slip down the long hill of despair and regret in attempting to return twenty-eight counties to the failure-proven system of county administration of game fish," Seth Gordon, president of the American Game Association, said in a bulletin issued here today in protest against the Ingram bill designed to remove twenty-eight counties from the operation of the State-wide game and fish laws of that State. The bill passed the Senate last week.

"If this bill goes through the House and becomes law, it will utterly ruin the work of the last six years," Mr. Gordon declared emphatically. He also pointed out the unfairness of placing the entire burden of State-wide administration on the remainder of the one hundred counties of the State.

"Six years ago North Carolina shook off the shackles of county game and fish administration, and immediately took her place at the top of the ladder with other progressive game and fish States," Mr. Gordon's statement continues.

"This movement to eliminate the obsolete county game and fish systems was unanimously victorious throughout the nation when Washington changed its leopard's spots—some counties good, others black—and established the State-wide system of game and fish administration last January.

"North Carolina's progress during the past six years has been decidedly good. At last North Carolinians are beginning to appreciate what can be done through State-wide administration. They are awaking to the great economic and recreational values of game and fish resources.

"The American Game Association has studied game and fish administration in every State of the Union for the past two decades, and we know that the proposed plan will wreck the game and fish activities of the Department of Conservation and Development.

"Surely the thousands of outdoor

residents of North Carolina will not permit such a catastrophe to happen. No county in North Carolina should be permitted to get up the old wasteful county system of handling game and fish affairs.

"The only way to head off this disastrous proposal is to let your members of the General Assembly know your views at once. Telephone or wire, or better still, go see your member now! Don't allow North Carolina to ditch a system that produces results," Mr. Gordon concluded.

American Motors Carry Japanese In Jehol Invasion

By JAMES A. MILLS (Associated Press Writer With Japanese Army)

Jehol City—(AP)—American motors, in trucks, automobiles, motorcycles, ambulances and airplanes, played a leading role in Japan's conquest of Jehol.

When the campaign plans were drawn it was decided that the 65,000 square miles of territory could be most expeditiously added to the Japanese-ruled state of Manchukuo by the use of a motorized force.

Trucks Pursue Chinese All except a few of these vehicles bore American trade marks. The exceptions were made in Japan.

Caravans of trucks, sometimes three miles long, loaded with Japanese warriors, pursued the poorly organized Chinese over frozen roads and mountain passes, going day and night.

All of the Japanese officers were loud in their praise of these American machines which stood the most terrible abuse and stresses on some of the worst roads in the world.

Another score for American industry was chalked up by the motorcycles. Thousands of these sturdy little vehicles carried officers' machine gun units, medical supplies, dispatches and even the wounded.

They, too, stood the grueling tests with few breakdowns. Wounded Ride in Comfort The hospital service used American ambulances almost exclusively. I saw scores of these comfortable, six-wheeled vehicles, none of which failed at a critical moment.

American-made airplanes also contributed largely to the Japanese success. Some of the ships had only American motors in them, but there were a considerable number of entirely United States manufacture.

To complete the American transport monopoly, virtually all the Japanese generals and other high officers traveled in powerful American passenger cars, equipped with over-size tires.
