

INFLATIONISTS STAGE NEW ASSAULT IN THE SENATE

Hope For Final Vote On Bill Tomorrow Night; New Strength Is Shown

ROOSEVELT IS AGAINST PLAN FOR FARM BILL

President's Opposition to Inflation as Expressed Through Senator Robinson Believed Cause For Defeat in Skirmish Yesterday; Democratic Leaders Eager to Speed Farm Bill to Completion

Washington, D. C., April 18.—(AP)—The city of monetary inflation was heard in the Senate once again today as the defeated inflationists formed lines for a second vote in as many days.

The first efforts ended yesterday in a 43 to 33 defeat of the proposal for free coinage of silver in ratio of 16 to 1 in gold, but despite the setback, advocates of inflation were expected to gain strength over last January's test.

Democratic leaders were anxious to speed the administration farm relief program to which inflationary moves are being offered as an amendment clause. They hoped for final vote on the relief program by tomorrow night.

ROTES HEAR ENTERTAINER

Lebron Spence Shows Clubmen How to Make Depression Evaporate

Lebron Spence public speaker and entertainer, held the spotlight at the regular meeting of the Rotary Club last night making the principal address and pulling off a few stunts that helped President Roosevelt put depression on the run.

He said he hoped the local club would be well represented.

TRAIN WRECKS IN MOUNTAIN CUT IN GEORGIA

Two Killed as Louisville Passenger Train Piles up Near Cartersville

Emerson, Ga., April 18.—(AP)—The northbound Louisville passenger train piled up in a cut in the Alton Mountain three miles south of Cartersville last night, killed two of the crew and another man and injured three persons.

Engineer, B. W. Evans, 52 of Atlanta, Ga., and a fireman, B. A. Giles, 45, of Etowah, Tenn., were scalded to death as the cab of the locomotive overturned, while A. H. Perry, catching a ride on the train, was crushed fatally between the tender and mail car.

Trainmen said they were unable to assign a reason for the wreck.

CHINESE IN FULL RETREAT

Forces Along Coast To Peiping Fall Back in Face of New Jap Offensive

Tientsin, April 18.—(AP)—Chinese forces continued to retreat along the railroad leading from the coast to Peiping today before the Japanese offensive. They established a defense line far south as Tientsin, eighty miles northeast of Tientsin.

Japanese and Manchukuan troops have not attempted to cross the Luan River in the vicinity of Wan-shan, but they are reported as attempting to cross in the vicinity of Tientsin.

The deceased was a member of the Free Will Baptist Church and was well liked in the community where she spent the major part of her life.

STEVENS IS NAMED FOR MAYOR OF SMITHFIELD

MINOR CASES MARK FIRST DAY OF COURT

Grand Jury Returns Number of True Bills At Opening of Criminal Session

The two-week term of criminal Superior court got down to work in real earnest yesterday afternoon after organizing in the morning hours and disposed of several minor actions. The grand jury also went into action at the same time and reported a number of true bills during the late afternoon.

The court is faced with a backlog of over a hundred cases and if the first afternoon's work is to be taken as an index to the two week term, then the bulk of cases will be disposed of before work is completed.

Judge Henry A. Grady, of Clinton who possesses the happy faculty of being able to speed court work, is presiding over the term and Solicitor D. M. Clark is prosecuting the docket.

Bennie James, charged with assault on his wife, was sentenced to eight months on the roads. Thad Moore was fined \$50 and cost for driving a car while drunk.

J. D. McLawhorn, charged with moving a fence and letting out hogs, was adjudged not guilty.

Ernie James, Lula James, Minnie James, Jesse Smith, Lorenz Smith, charged with trespassing on tobacco plants, were found not guilty. Henry Tyndall was found not guilty of jumping a board bill here.

Judgment was suspended in the case of L. E. Eiks, charged with giving worthless checks, providing he pays the checks and cost of action.

Scrap Proctor was adjudged not guilty of driving an automobile without proper license.

Jack Mazingo and W. D. Whitley of Farmville, charged with arson over a year ago, were found not guilty. They were charged with burning an automobile.

NO INTEREST IN ELECTION

Lethargic Condition Prevails in Forthcoming Aldermanic Contest Here

An apathetic condition apparently gripped the city today as it pertains to the mayoralty and aldermanic election set for the first Monday in May.

Records in the office of the city clerk where candidates for public office are supposed to register for participation, indicated that not a single candidate has put his name on the dotted line. This includes members of the present board of aldermen who also seem to be suffering from a severe attack of lethargy, although they were expected to show activity within the next week or so.

The filing period for mayoralty candidates will expire ten days prior to May 1 and for aldermen five days. With the first half of April already history, it is going to be necessary for somebody to put on steam and get the old political pot sizzling merrily within the next several days.

Owing to the death of J. L. Hassell, the seat in the second ward must be filled during the election, as well as that in the first ward, caused by the resignation of Closs W. Hearne, who moved to another section of the state.

It is the first time in years probably that not a single candidate had filed for office prior to this date, and if the present condition indicates the future status of the situation, it is going to be a dull election with the present incumbents winning in a walk.

While the incumbents are holding their peace concerning their intentions in the battle of ballots, they were expected to put on full steam ahead in the next few days and let it be known that there is to be an election after all.

Only two dozen registrations have been recorded since registration books were opened sometime ago. These consisted of people moving from one ward to another and new residents. It isn't necessary for persons who have not moved since the last election to register again.

HELEN VASCO HOME AGAIN

Immigrant Leaves Home Because of Curiosity of Hordes Of People

Hastings, N. Y., April 18.—(AP)—Little Helen Vasco, the two-year-old girl whom doctors have called doomed unless she undergoes an eye operation, was found today after being hidden away in the home of a relative since last Saturday. Her mother declaring against operations, fought attempt of physicians to have it performed.

Last Saturday while the Appellate Division of the Supreme Court considered its phase of the legal order to force the operation the Vasco family disappeared from home.

John Vasco, immigrant laborer and father of the child, revealed her whereabouts today when he called at the police station and asked protection against the hordes of curious people who had gathered around his home since publication of the story.

He said he and the remainder of his family had been in seclusion at the house of a cousin. They will go home today if the police will keep the crowd away.

BRITON AGAIN ASSERTS HIS GUILT IN COURT

William McDonald Pleads Guilty at Moscow; Russians Ask Mercy of Court

Moscow, April 18.—(AP)—Just before the court retired today to consider its verdict in the Metropolitan-Vickers sabotage case, William McDonald reiterated his guilt as other Britons asserted their innocence and the Russians threw themselves on the mercy of the court.

The Russians admitted all charges against them these varying in statements made individually to the court by each of the defendants before the judge retired to make his decision.

Stepping to the front of the judge's stand, his face unusually pale, McDonald, the first of the British defendants called on, stood with hands in his trousers' pockets, looked Judge Ulrich squarely in the face and declared:

"I am confessing and I have nothing to say." The remainder of the Englishmen spoke in English.

He was a member of the Free Will Baptist Church and was interested in work of the denomination in his community. WARN AGAINST MEASLES HERE

Spread of Sickness Causes Health Office to Stress Quarantine

With measles and whooping cough on an increase in this community the last few days, health authorities today warned parents to report such cases to the health department immediately.

Where school children are involved, parents are asked to reports to the teachers or to the health department.

The prevalence of whooping cough and measles became more pronounced today with a report from one school district that thirty children were out on account of illness.

While the health department has been issuing quarantine signs the last several days, it was said that numbers of cases had not been reported. This caused health authorities to ask for public cooperation in reporting such sickness to prevent an epidemic in the public school system.

Although prevalence of both measles and whooping cough has been reported from many parts of the county Chocod township probably suffered the greatest from measles alone. So severe was the epidemic in the schools there that the tensil and adenoid clinic had to be postponed until last week when the situation cleared up sufficiently to permit workers to hold the clinic.

The health department is doing everything possible to cope with the situation, it was said, but this will be impossible without the assistance of parents who will become a great factor in preventing an epidemic by promptly reporting such cases.

TO MARKET MELONS ACCORDING TO GRADE

Raeform, N. C., April 18.—Watermelon growers of Hoke County will set according to grade this year and will attach a label to each melon giving the variety, name of grower and other desired information. Reports County Agent S. C. Oliver, Jr. A total of 375 acres of melons have been signed to be marketed through the local mutual exchange.

Instructions as to time of picking, grading and other market conditions will be given by the exchange.

NEW BUYERS ARRIVE FOR BERRY PURCHASES

Chadbourn, N. C., April 18.—Prices on the Chadbourn strawberry market today ranged from \$2.25 to \$3.50 per crate of 32 quarts. Deliveries today were sandy and pale of color. A number of new buyers arrived today for the first of the season and large numbers of motors are arriving and going out daily.

Yes, we are still talking sales tax and it is the same thing we have said many times before. The matter will come up for discussion in the legislature at its regular session tonight and again we say we do not consider that a general sales tax in North Carolina is necessary to balance the budget if the legislators were of a mind and had the courage to get the money "where the money is."

THE ARMS EMBARGO Congress did well to empower the President to establish embargoes against shipments of arms to warring nations. If we believe in peace, as we profess to do, certainly we should aid the movement in every way possible and the refusal to sell arms to nations in conflict is one way that we can do our bit in helping to prevent such catastrophes. There are those, of course, who object to the action because the embargo would cause them to lose sales of large quantities of arms with the resulting profits, but as we see it, this objection should count for nothing. But for the great profits to be made on the outside wars would be even more unpopular than they are, and the sooner all the nations realize this the sooner permanent peace may be assured.

A MOST SERIOUS SITUATION The statement made by Dr. R. S. McGeachy, before the meeting of the State Medical Association yesterday, with regard to the tuberculosis situation in this county should bring horror to our people and a determination on their part to go the limit to help better this condition. Dr. McGeachy's statement was to the effect that one out of every four Pitt County children tested was found to be infected, while a test of the cattle showed only four out of every thousand. This is a serious situation that should have attention and yet there are some in this county who have expressed a desire to do away with our health department or cut it to the point of uselessness for the sake of economy. Of course, we all want economy, but any economy that would endanger the lives of our children is false economy indeed. We take this opportunity to urge that our county authorities as well as every citizen in the county lend their every co-operation to fight this dread disease in our county.

For some reason the "gay nineties" never have been popular as a period against which to plant screen romance, until now. A few pictures laid in the setting of the mauve decade were attempted from time to time.

Now there is a veritable epidemic of films whose characters know the delights of a bicycle-built-for-two, the picturesqueness of quaint puffed sleeves, wasp-waisted costumes, the atmosphere of bric-a-brac and ornately adorned parlors, the gaiety of beer gardens and simpler living.

The success of good pictures, no matter what their setting or period is sufficient reason for the sudden popularity of the "gay nineties," but in the life of today producers may see a decided parallel to the life of that period, thus making it as "up-to-date" as the 1933s. For one thing, the styles worn by women then were not far different from those which are the mode today. Roosevelt's Technique With Congress Suggests Wilson's Handling Of It

By HERBERT PLUMMER

Washington, D. C.—With Congress clicking along as it is, approving the President's legislative proposals in a fashion that has almost everybody gasping in amazement, the Roosevelt strategy is a chief topic of conversation "on the hill" among veteran political observers.

The President's method in dealing with Congress seems to many of them strikingly similar to that followed by Woodrow Wilson when he was in the White House.

Wilson, like Roosevelt, had an overwhelming Democratic majority in the House. In 1913, the year he became President, there were 290 Democrats in that body and 127 Republicans.

Wilson centered his attention on the House. When he submitted his legislative proposals to Congress, with the aid of a strong and powerful Democratic leadership, they were rushed through there with a minimum loss of time. The rules of that body were invoked to their limit.

As a Starter The theory was that the House should provide the Senate with something on which it could work. Wilson knew that the Senate would tear things to pieces anyway. His idea was to get the administration's ideas before that body in the form of a bill approved by the House and let the tearing begin.

The psychological effect was good too. For the House to approve an administration proposal almost immediately it was presented to it, gave the impression that the Senate would be in the same position.

In any event the President had got off to a running start, and the force of public opinion could be relied upon to help in influencing the Senate to speed up things if it showed a disposition for undue delay.

A Trail Blazer That seems to be pretty much what President Roosevelt has done so far. Aside from the emergency banking bill, which was passed by both Houses on the first day of the session, it has been the House that has blazed the trail for the administration.

The drastic economy measure was passed by the House in one sitting. The Senate wrangled for three days and nights before giving its approval. The beer bill was passed in the House in three hours, while the Senate took twice as much time.

Each of these measures might have tied the Senate up indefinitely at other times. But with the President urging speed, and the House compelling with his demand, the Senate fell in step, as far as it was able.

By QUINTIN JAMES One of the most colorful and attractively designed sets of the year comes from Tripoli, Italian colony in North Africa.

Those who make a specialty of wild life pictures are almost certain to like the 10 centesimal, purple with an ostrich; the 1.25 lire, blue, with an eagle poised on a wall; and the 5 1/2 plus 11, brown, with a stalking cheetah.

Other values: 25c, green, small tree growing from urn; 30c, light brown, hooded native with drum; 50c, purple, archway, with flags of a procession under it; 101 plus 2.501, red, the symbolical fasces rising above an African city.

Airmail stamps show planes flying over various sections of the territory. The values are: 50c, green; 75c, red; 11, blue; 21 plus 50c, purple; 51 plus 11, light brown; 101 plus 2.501, dark gray.

The set is issued in connection with Tripoli's seventh agricultural fair. Proceeds from the overcharges on some of the values are used to help meet expenses of the fair.

Few Commemoratives In contrast with many countries, the United States has issued few commemorative stamps, and those issued have been confined to a few values.

The revised "Description of United States Postage Stamps," just published by the Postoffice Department lists only 42 special issues up until the end of 1932. Twenty-two of these, however have come within the past five years.

United States stamps, the publication says, have carried the portraits of seventeen Presidents and of twenty-four other persons prominent in American history.

The pamphlet, which describes all this country's stamps from the first issue of 1847 to the Daniel Webster commemorative of 1932, may be bought for ten cents from the Superintendent of Documents, Washington, D. C.
