PRESIDENT ORDERS GOLD EMBARGO RESTORATION

Britain Declares Partial Embargo On Soviet Goods

RETALIATION FOR TRIAL OF ENGINEERS

Russian Imports to United Kingdom Expected to be Cut at Least 80 Percent; Proclamation Signed by King George At Windsor Castle; Parliament Acted Last Week

London, April 19.—(AP)—Great Britain answered the conviction of British engineers in Moscow by declaring today a partial embargo against Soviet goods which will cut out 8 per cent of Russian imports in the United Kingdom.

On the basis of currency trade figures the embargo which before April 26 will bar imports aggregating 9,600,000 pounds, which in currency is \$33,600,000 annually.

The proclamation was signed by King George at Windsor Castle and published in the London Gazette.

It prevented all importation of Soviet wheat, barley oats and other grains, in addition to poultry, raw cotton, petroleum oil, wood and timber, dressed, or articles manufactured wholly or partly of wood and timber.

Parliament authorized the action last week as a measure of retaliation against the prosecution of five British engineers in the Moscow espionage trial.

J. T. HODGES KILLED BY CAR

Belvoir Man Dies Shortly After Being Struck on Bethel-Conetoe Highway

J. T. Hodges, 81, farmer of the Belvoir community, was fatally injured this morning when his horse and buggy were hit by an automobile in the Bethel-Conetoe highway, near Blount's saw-mill, and died an hour and a half later.

R. L. Yelverton, of Rocky Mount, driver of the car, which was also occupied by his brother, B. O. Yelverton, was exonerated by a coroner's jury under the direction of Coroner A. A. Elwanger, when it was found that the accident was unavoidable.

Hodges had spent the night at the home of his daughter Mrs. Joe Barnhill, near Bethel, and was returning to his home in Belvoir when the accident occurred.

The crash occurred on a curve during a rain. Hodges was said to have had an umbrella over him and was believed to have been unable to see that his horse had carried him to the middle of the road.

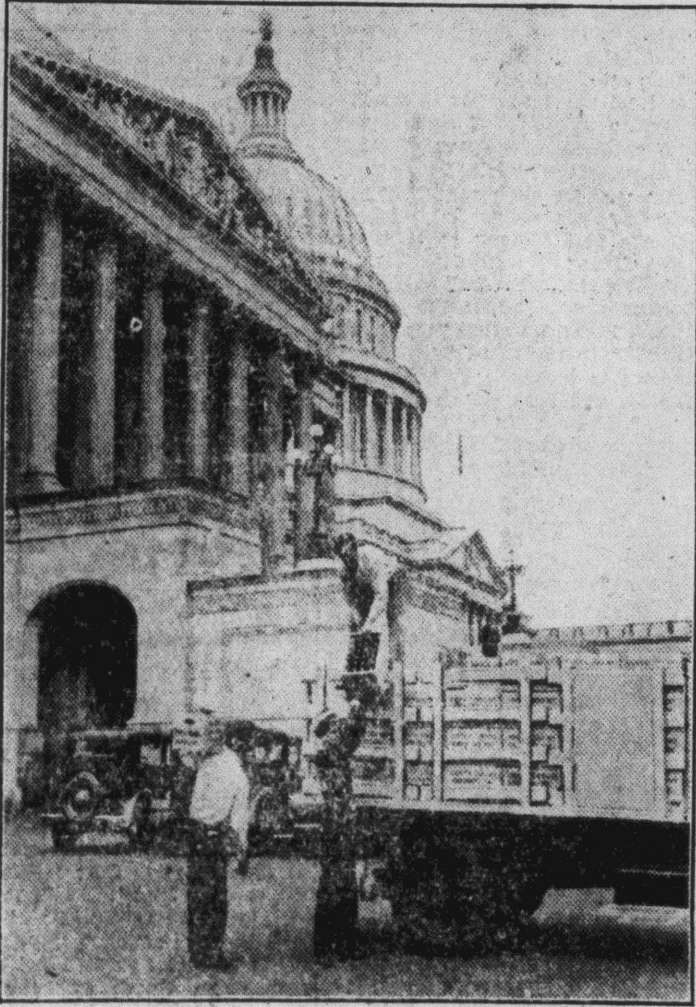
Coming around the sharp curve Yelverton said he was unable to see the approaching vehicle until it was too late to stop. The horse was injured so badly that it was found advisable to kill him.

After rendering all possible aid to the injured man, the Yelvertons went to Bethel and obtained the assistance of Dr. Garrenton. Hodges was returned to the home of his daughter where he died an hour and a half later.

Funeral services will be conducted from his late home tomorrow afternoon at 3:30 o'clock by Rev. Warren Davis, of Washington, N. C., pastor of the Mount Pleasant Church, of which Mr. Hodges was a member which Mr. Hodges will be made in the family burying ground. He is survived by three sons, N. O., T. H. and J. H. Hodges; three daughters, Mrs. Joe Barnhill, Mrs. M. H. Whichard, and Miss Ella Hodges, of this county, and a brother, Joe Hodges, of Beaufort County.

NEGRO KILLER SENT TO PEN

Perry Little Given From 10 to 15 Years In Prison For Murder Sweetheart

Perry Little, colored, charged with the slaying of his sweetheart, Lucy Surg, while in a fit of jealousy over another man, was sentenced to not less than ten nor more than fifteen years in state's prison by Judge Henry A. Grady of Clinton, who is presiding over the two-week term of criminal Superior court here.

Hearing of the case consumed only a small portion of the second day's session and the jury was out only a short time.

Little was jailed by police here several months ago after he quarreled with the woman, followed her to the home of a neighbor and shot her to death.

Several other cases were disposed of during the day, and numbers of the defendants were either given road or prison sentences.

Elmer Whitley, young Greenville man, who figured prominently in the Ballard highway robbery case here about two years ago, was found guilty of stealing three gallons of gasoline from an automobile in the western section of the city, but sentence was not pronounced.

Horace McLawhorn and Bill Manning, charged with breaking in a filling station in the Ayden community were sentenced to three and one years, respectively, in state's prison.

McKinley Faircloth and Otis Watson, colored, charged with robbing an aged colored woman of \$94 here several weeks ago, were each sentenced to 18 months on the roads. Minnie Johnson, an accomplice, was given eight months in jail, while Gertrude Carr, an accomplice, was given eight months in jail. (Continued on Page Four)

GOVERNMENT OPERATES AT GAIN IN MARCH

Slight Balance Shown In Classified Report Issued by The Treasury

Washington, D. C., April 19.—(AP)—The United States Government operated at a profit during March for the first time since the beginning of the present year, the Treasury's current statement showing classified reports operating expense revealed.

Thanks to income tax receipts of \$180,712,321 during the period the government closed its books for the month with a balance of \$817,909 on the right side of the ledger after taking into consideration all items of receipts and expenditures, including those on account of general special funds.

Total general funds during the month amounted to \$289,914,029 to which was added receipts of \$2,122,267 as special funds and \$11,149,477 of trust funds, bring the total to \$293,185,773.

General fund expenditures amounted today to \$272,412,242 during the month to which was added \$957,104 for special funds and \$8,997,519 of trust funds, making a total of \$282,367,864.

BRITONS FILE APPEAL FROM PRISON TERM

Thornton and McDonald Held in Jail After Trial in Russian Court

Moscow, April 19.—(AP)—An appeal will be made against the prison sentences imposed early today on L. C. Thornton and William McDonald, British engineers convicted of espionage sabotage and bribery. They were held incommunicado in prison.

Four other Britons who were tried on the same charges are leaving Russia presumably never to return.

Thornton, chief engineer in the Russian Metropolitan-Cickers Company was given a three-year term, and his assistant, McDonald, two years. Immediately afterwards they were hustled off to jail.

Eleven Russian red-fisted agents were given prison sentences up to ten years and one was acquitted.

CONTROL OF PRICE LEVEL BEING SOUGHT

Chief Executive Awaits Effect on Today's Move on Gold Before Taking Next Step to Boost Economic Recovery; Federal Reserve Governors Meeting in Washington Expected to be Significant in Further Action

Washington, D. C., April 19.—(AP)—President Roosevelt announced today a restoration of the gold embargo as a move to improve important domestic commodity prices. This is the first step to be undertaken to establish a control price level—and a control of credit to counteract deflation. The word "inflation" is not particularly in the vocabulary of the President as he mapped his campaign to improve the domestic situation. Rather he apparently preferred to speak of control of new price levels. Additional steps are in prospect.

The President is awaiting the effect of today's move on gold, however, to determine the extent of his next step.

Today he was awaiting hopefully a meeting across from the White House of twelve Federal Reserve governors called to outline plans for the use of existing idle currency and for freeing billions in deposits in closed banks.

107 PITT MEN TO BE USED ON FOREST JOBS

Unemployed to Participate in Reforestation of Federal Government

One hundred and seven Pitt county men will be eligible for jobs in the giant reforestation program set in motion recently by President Roosevelt with congressional approval.

These men will be picked from the ranks of unemployed and must have dependants, it was said.

K. T. Futrell, director of the Pitt County Welfare Department, will attend a regular conference in Washington next Friday to discuss the reforestation scheme and its work believed that all phases of the program would be worked out at that time.

The men picked for the reforestation camps will be from 13 to 25 years of age, but it was expected the age limit would be increased in the near future owing to the fact that a large part of the unemployed is made up of men beyond that age.

These workmen will be paid \$1.00 a day and will receive clothing, food and housing in addition. It is not a military project but a tremendous attempt to relieve the unemployment situation which has proved distressing to all communities the last several years.

The reforestation movement in this state will be conducted in the national park in the western section and was expected to play a big part in clearing up inaccessible regions in the rough mountain territory.

BEAMAN ARSON TRIAL BEGINS

Former U. S. Commissioner Charged With Firing His Home in This City

Thomas E. Beaman, former U. S. Commissioner here, went on trial in criminal court this morning on a charge of arson the case growing out of the alleged burning of the house in which he lived in the southern part of the city the early part of the year.

Hearing was begun after the opening of court this morning, and it was believed the case would go to the jury either late this afternoon or early tomorrow morning. The taking of evidence was resumed after court returned from its noon recess.

After the fire which partially wrecked the house occupied by Beaman and owned by Mrs. Hortense Meye, the former commissioner was arrested and charged with incendiary.

Firemen said they found burlap bags saturated with kerosene in the roof of the building. These were being offered as part of the evidence today.

The new charge was preferred against Beaman after he was already facing court action for alleged acceptance of bribes from bootleggers and embezzlement. A mistrial resulted in the bribery charge in Federal Court and the embezzlement case probably will be aired in this term of court.

ORDER GUARDS PATROL DYKES

Soldiers Ordered to Glendora, Mississippi, After Destruction of Dam

Clarksdale, Miss., April 19.—(AP)—A national guard unit of fifty men was rushed by train to the Mississippi delta today to patrol levees of swollen streams there following the dynamiting of dykes by a band of 200 or 300 men yesterday.

The guardsmen were ordered to report to Glendora by Adjutant General Thomas Gregson after Tallahasse County authorities had asked the governor to provide military protection in the areas.

WOMBLE WINS HOG CONTEST

LaGrange Vocational Student Captures First Place in Stock Judging Here

Representatives of thirty-four vocational schools of District Two, comprising northeastern Carolina, took part in the livestock judging contest held at Oakhurst farm, several miles east of Greenville yesterday afternoon.

Sixty-four contestants, each judging individually, specimens from the Duroc Jersey registered hogs, participated in the elimination contest in which three winners and one alternate were chosen to represent the district at a similar contest to be held at State College at which a North Carolina team will be chosen for the contest at the National Live Stock show in Kansas City next November.

Herbert Womble of LaGrange, emerged winner in the Oakhurst contest, scoring 365 points out of a possible 400. His vocational teacher is E. J. Morgan.

Second and third places were taken by Judson Whitehurst of Stokes, and Harvey Grant of Woodland, who tied with a score of 368. G. N. Britt is the vocational teacher at Stokes and H. N. Cherry at Woodland.

Winner of fourth position, or alternate, was Alvin Bone of West Edgecombe school, whose score was 361. His vocational teacher is P. H. Gaston.

The contest was well attended and much interest was shown in the actual judging of the fine hogs for which the farm has long been noted. At the noon hour, J. H. Boyd, owner of Oakhurst, was host to the visitors at a barbecue dinner.

Reversing its previous stand on the sales tax issue, the House last night voted 51 to 49 in favor of a two per cent general sales tax. The close vote still makes uncertain the final outcome but surely it is to be hoped that the House will again reverse itself and not place this burden upon the backs of the poor people of our state. We have contended all along that a sales tax in North Carolina is not necessary at this time to balance the budget, but no doubt it appears the easiest way out for the legislature because it is far easier to pass this burden on to the masses than to place it upon the powerful privileged classes where it belongs, in the face of strong lobbies present in Raleigh.

If every other source of revenue had been taxed to the limit and this did not furnish the necessary revenues, then the people of the state, we believe, would be willing to make up the deficit by a sales tax, but so long as any of these other sources enjoy special privileges a sales tax upon the necessities of life is unjust and should not be tolerated.

Announcement from some sections of the state to the effect that typhoid fever is more prevalent than in many years should be a warning to those persons in every community that have not been inoculated against this disease. During the past several years typhoid fever in Pitt County has been greatly decreased as a result of this preventative treatment and we urge our people who have not been inoculated within the past three years to take the treatment just as soon as possible. You can have your regular family physician give you this treatment or you can get it free of charge at the county health office and there is no good reason why we should not continue our efforts to prevent this disease in our county.

Now that the tobacco setting season is at hand reports are coming in from over this section that indications are that there will be an increased crop this year. Again we urge our farmers not to increase their crop this year. It is a foregone conclusion that a large crop this year will mean lower prices which will spell disaster for the growers. We urge you not to plant more than you can properly take care of in order that you might produce the best possible quality. A small crop this year of good quality will

France Sends Political Ace To United States

By M. K. WHITELEATHER Paris—(AP)—France is sending her outstanding political figure to President Roosevelt's White House conversations.

Eduard Herriot, the nomad of French politicians, veteran of European diplomatic battles and ardent advocate of payment of the defaulted French debt, will arrive in America April 23 as spokesman of the Daladier government.

Herriot at 61 is equipped to speak with authority. He has been thrice premier, is at present chairman of the foreign affairs committee of the chamber of deputies and for long has been leader of liberal forces of the country.

Such a trip fits perfectly into Herriot's scheme of life. He is always on the go. He visited the United States in 1924 as a private citizen and he often recalls this voyage, specially the time he spent in and around Boston.

low tail coat and a stiff shirt—that's all he cares about. Apparently he never heard of Beau Brummel. Left a penniless orphan at the age of 17, he has made a living by his pen and his tongue. He is a prolific writer. Contributions appear in newspapers and magazines all over the country. It is not uncommon for him to lecture in Marseilles one night on Beethoven and two nights later in Brussels on Greek literature.

He also finds time to write books on various topics. This means that Herriot's candle burns well into the night.

The man President Roosevelt will face is in many ways a typical provincial Frenchman. The time he has spent in cosmopolitan centers has not effaced his jovial, wisecracking provincial bourgeois manner.

The Herriot heart beats with contentment when he climbs into the tribune of the chamber of deputies. Here, a commentator has said, "he appears like Samson carrying the columns of the temple before pulling them down."

Audacity has been the leit-motif of his political career. Where conservatives dared not enter, the mayor of Lyons went in. When he came to power last June, he completely reversed French foreign policy. He did the same thing when he first became premier in 1924.

"It is as well," he said in my ear, "for us not to be seen together. It is not wise at the moment. Will you precede me into the hotel?"

"But I want to see you at once. Why did they let me out? Were you right? There are things—to be done."

"Yes and no; it's a longish story. I'll come to your room tonight," he said. "Go on. I'll come later."

He turned away to let me enter the hotel ahead of him, but I seized his arm.

"Wait," I said. "What do you mean, 'yes and no'?"

"I was obliged to shriek against a furious gust of wind, and he looked at me in sharp disapproval. 'Wind is tricky,' he said. 'We may be overheard.'"

"I don't care who hears. What killed him?"

"He was poisoned," he said. "If I am to help you, Mr. Sundean, you must let me do it my own way. I shall come to your room after I've had dinner. We can talk then. Not here." He vanished into the darkness.

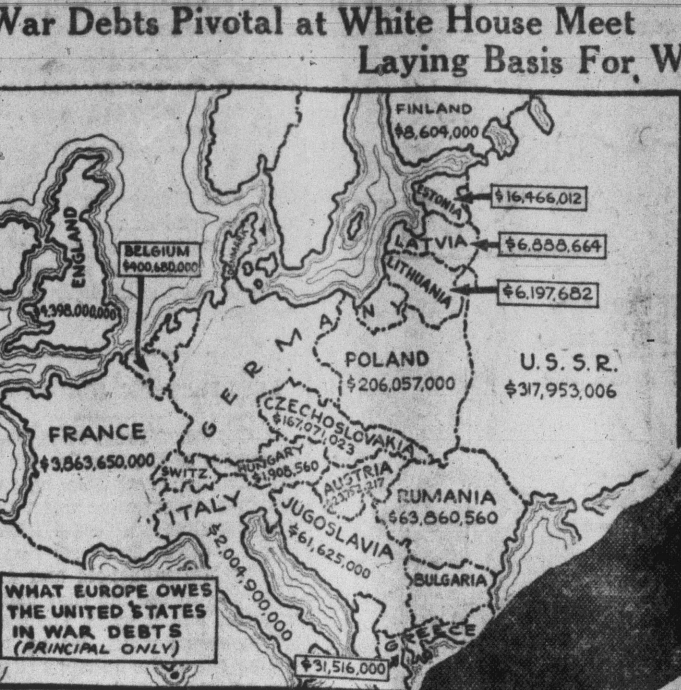

Washington, D. C.—(AP)—Readjustment of the war debt situation may be done of the outstanding American contributions to success of the world economic conference.

The subject promises to be brought into the discussions here participated in by President Roosevelt, Ramsay MacDonald of Great Britain, Edouard Herriot of France and the representatives of other powers which have been asked to take part in the talks designed to insure success of this summer's big gathering at London.

## Eleven Billions Unpaid

Down to date, including payments prior to the funding agreements, debtor nations have paid a total of \$2,267,680,897, of which \$433,310,743 was principal and \$1,230,925,551 interest. The principal still owing totals \$11,598,501,453.

Most of these payments came from loans which American interests made to Germany so that country could meet its reparations payments to the former allies. When these loans were halted, the Lausanne conference of last summer agreed to cut German reparations about 90 per cent, subject to success of debt negotiations with the United States.

## Debtors "Key Nations"

There would be no contractual relation between debt readjustment and such world economic problems as tariffs, import quota restrictions, money and exchange limitations and similar puzzles. More than sixty nations will be represented at the world conference, however, including key nations in the economic log jam and it appears to be the thought of the Roosevelt administration that new accords on debts might be bartered for new policies on trade. For example, Secretary of State Hull in all his statements on the subject consistently has linked war debts with tariffs.

The administration is eager for the success of the world economic conference, particularly in destroying trade barriers. Secretary Hull has indicated that if a new policy is to be adopted on debts, the debtor nations must agree in principle on questions to come before the London gathering. That implies to some observers that debt negotiations might be held with any of the interested nations which would agree to trade reciprocity.

## Commerce Hearing of Alleged Slayers

Hertford, N. C., April 19.—The death penalty will be asked by Solicitor Herbert Leary for George Lane and his wife, Betty Hines Lane, charged with the murder of Woodrow Wilson Lane, 17, on July 27, 1932.

Lane and his wife are being tried jointly for the murder of the boy stepson of Mrs. Lane. Mrs. Lane was freed under \$2,500 bond after she had been implicated by an affidavit signed by her husband after he was lodged in jail on the charge. Lane said his wife killed the boy with an axe while he was tying his shoe. Yesterday Mrs. Lane was re-arrested after the grand jury returned an indictment consolidating the charges against the two.

Selection of a jury went forward slowly today with only five jurors selected out of a venire of seventy-four men. Another venire was called.

Knee length coats which reveal the frock below and dresses designed with tunics six inches shorter than the skirt are foremost evidences of the trend.

A black wool frock appears with a three-quarter length coat of white cotton; a morning frock is designed with a brown crepe skirt and a long tunic blouse of brown and white checked crepe and an afternoon gown has a black crepe skirt and a three-quarter length tunic of black and white printed crepe.

Pert taffeta frocks as crisp as a sheet of tissue paper are among new offerings for formal afternoon wear. Most of them are designed with short sleeves or sleeveless cape shoulder lines and fairly full skirts which rustle as the mannequins parade through the salons.

Washington—(AP)—Back in the days when the Republicans were in control of the House the favorite target of the Democrats was the famed triumvirate of "Longworth, Tilson and Snell."

These three leaders—Longworth, the speaker; Tilson, the floor leader; and Snell, the chairman of the rules committee—were variously dubbed "The Three Horsemen," "The Three Musketeers," and sometimes were accused by their opponents of riding rough shod over the will of the majority of the House.

The cry of "gag rule" was raised frequently and strong then. Demands for liberalization were heard on all sides by the Democrats. And they promised themselves if they ever were returned to power in the House things would be different.

Longworth is dead. Tilson no longer is a member of Congress. The third of the trio, Bert Snell, is now the Republican floor leader.

And how he is enjoying himself these days reminding his Democratic friends of the times they denounced him!

For the Democratic leaders in the House, in their zeal and eagerness to rush through President Roosevelt's emergency legislative program, have been pushing the members along at top speed.

They have brooked little delay. Once a proposal of the President is sent to "the hill" it has been quickly dispatched through the committee, a special rule for the legislation possibly being framed in the rules committee, and it is brought out on the floor.

A special rule for a piece of legislation is a powerful weapon. Usually it curtails debate to the minimum, often precludes the right of members to offer amendments in which they are interested, and shuts down generally on the proposition.

That's why the House has been able to move so quickly in the disposition of the President's program so far. Such a thing is impossible in the Senate.

"Do you think Schoolboy Rowe has any prospect of becoming the next Babe Ruth?" I asked Bucky Harris, who happened to be shaving at the moment and exhibited remarkable control in not cutting himself or taking a slash at his inquisitor.

We were discussing the baseball situation in general, the Tiger prospects in particular. I detected a gleam in Mr. Harris' youthful countenance upon mention of his sensational young pitcher 21-year-old Lynnwood T. Rowe of Waco, Texas, up for his first peek at the big league proceedings.

"Well," replied Bucky, after a meditative moment in which he applied more soap and rinsed the razor. "I don't mind telling you this: Rowe is the best young pitcher I have ever seen, in addition to which he has color, physical resources and he can hit that apple."

"He pitches and bats right handed, so that he can't qualify as another Ruth, in addition to which my hunch is he will stick to pitching and become a real star. Of course when he is in the lineup, he won't be a soft spot for the opposing pitcher."

As most everyone knows by now, Lynnwood (Schoolboy) Rowe is the son of a trapeze artist, with a circus background.

Unlike his father, a small, wiry man, Lynnwood kept right on growing and now stands a modest six feet four inches and weighs 210 pounds. His home is in El Dorado, Ark.

Before he was through high school, Tiger scouts put their eagle eye on him and obtained an option on his services. He was given his first professional job last year, pitching for Beaumont in the Texas League. He won 19 games and lost 7 with a pennant-winner, yielding only 2.34 runs per nine innings.

"For a youngster up for the first time, he has remarkable control and poise," says Harris.

The Detroit manager, who still holds the distinction of being the only pilot of a pennant-winner in Washington (1924-25), thinks his Tigers will do their share toward tightening up the American League race and reducing the gap which separated the Yankees from the rest of the clubs last year.

"It will be tough to beat the Yankees, under any circumstances," Harris admitted, "especially if they get the same kind of pitching they had last year. But Detroit, Cleveland, Washington, Philadelphia and Chicago all should make a better showing against the champions, Bill Killefer's club in St. Louis will be far from a setup."

"I have four new men—Marberry, Rowe, Fox and Owen—who figure to make Detroit stronger than at any time since I became manager."

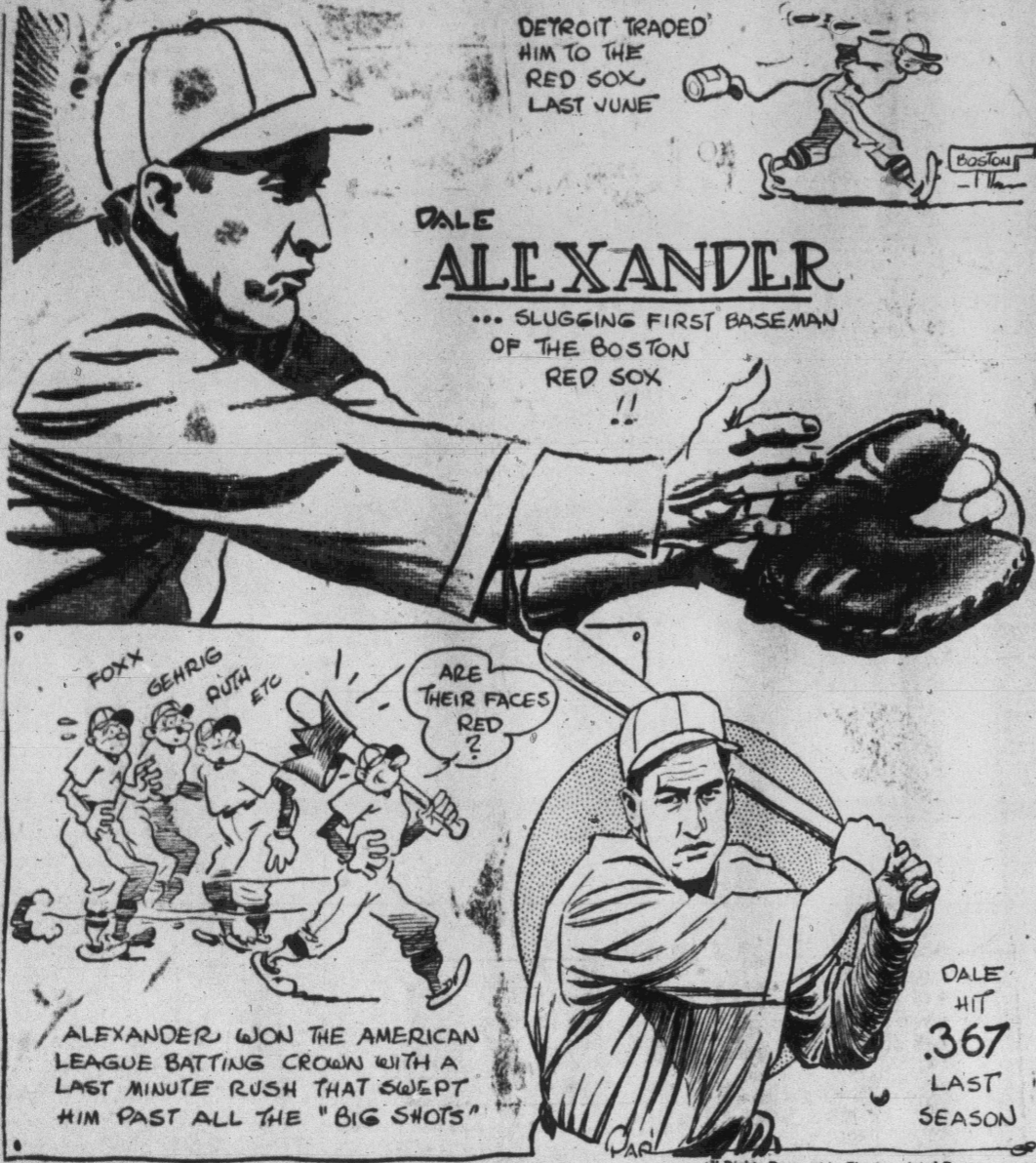

The War Debts—What's The Answer?

(By The Associated Press) War debt, while considered officially as but one factor in the situation which confronts this summer's world economic conference, are recognized as one of the chief sources of world worry.

Other possible arrangements include concessions to American commerce and tariff agreements. Neville Chamberlain Chancellor of the Exchequer, takes the position, that the debt payments simply can not be made under existing world conditions, since in the long run international debts can be paid only in the form of goods or services.

So Britain hopes for a speedy and final settlement of the vexatious question. Speedy because she faces another payment of \$75,950,000 on June 15. Final because she considers this a final would aid recovery.

To support this latter view, British point to the balance sheets. These indicate that John Bull's share of what is due Uncle Sam includes, in round numbers, a funded principal of \$4,600,000,000 and \$2 annual payments of \$170,000,000.

These would bring the British total to better than \$11,000,000,000, which is more than "the original American loans to all the debtor nations."

Paris.—(AP)—A lump sum final payment is the French government's idea of how best to dispose of its war debt to the United States.

The debt, as reckoned here stands at \$3,921,547,000, with \$19,261,000 in default.

Indications are that Andre Lefebvre de Laboulaye, newly appointed ambassador to Washington, and his advisers, will ask the Roosevelt administration to consider a lump sum payment on the basis of the Lausanne agreement of last July.

This agreement reduced Germany's reparations debt to the allies by ninety per cent.

Edouard Herriot, as Premier, consented at Lausanne to scale down Germany's reparations debt, but insisted that the Reich should pay something so that America's debtors would have a substantial amount to hand over to the United States in settlement of their war debts.

Germans were asked to pay three billion gold marks. A strong movement is developing in this country for payment of the defaulted interest installment which the Chamber of Deputies passed over last December.

Members of the government are fervent. They quietly are fanning the pay-up idea in belief that it would be a good gesture now that President Roosevelt has extended the right hand of fellowship to France in spite of the default.

They also foresee the need of keeping close relations with America in the face of a seething continental Europe which presents many uncertainties to the French.

Italy Rome.—(AP)—Italy's "ability to pay" will govern her debt negotiations in Washington just as her "ability to pay" in 1925 brought her the lightest debt settlement of the big power.
