WILL SPEED LOANS TO DEBT BURDENED FARMERS

Plans For Pushing Farm Mortgage Bill Provisions Under Way At Capitol

FARM BOARD HEAD WORKS ON PROGRAM

Henry Morgenthau Hopes to Give Growers Relief as Soon As Congress Completes Action on Roosevelt Bill; Will Attempt to Save Farmers From Losing Their Homes

Washington, D. C., May 3.—(AP)—Provisions for speeding loans to debt burdened farmers faced with the possible loss of their homes will be the first portion of the farm mortgage bill to be administered when Congressional action on the Roosevelt farm program is completed.

It was learned today that Henry Morgenthau, Jr., Farm Board chairman and governor designate of the farm credit administration which will begin functioning May 27, has completed arrangements for giving quick aid under this portion. It is separate from the bill authorizing refinancing up to \$2,000,000 in farm mortgages of issuance of Federal Land Bank bonds whose interest will be guaranteed by the government.

USED BLOODHOUNDS TO TRAIL MEAT THIEVES

Kinston, May 3.—Bloodhounds were used to trail meat thieves in Greene county, according to a report had here today. The smokehouse of Charles Wheeler was robbed. Bloodhounds from the prison camp near Snow Hill were taken to the Wheeler farm. They trailed down Walter Newkirk, Columbus Duncan and Tom A. Ward, negroes and six pieces of meat were recovered. Newkirk confessed theft of a pair of bolt cutters in Pitt county. He was sent to that county for trial. More than 1,500 pounds of meat have been stolen from barns in the community in which Wheeler lives during the past few weeks.

STANLY MAN BELIEVED VICTIM OF ACCIDENT

Albemarle, N. C., May 3.—Sidney Howard, 22-year-old white man of the Silver Springs community, died in a hospital here at 1 o'clock yesterday two hours after a charge from a shotgun had been fired into his left breast.

From all reports, young Howard and another man were riding in a road cart and Howard was handling a shotgun. In some manner it was fired, the entire load entering the region of his heart.

An inquest will be held today. Howard was a member of a prominent Stanly family.

TOBACCO INDUSTRY SHOWING A REVIVAL

Richmond, Va., May 3.—(AP)—Speeding up the wheels of the tobacco industry here was indicated today, as one company reported adding between 75 and 100 workers and another called back thirty during the last week. Others have increased working hours and are running close to capacity on their present work basis. Increased demand particularly for cigarettes, was credited with bringing about the improvement.

LIGHT DOCKET BEFORE COURT

About Fifteen Cases Disposed of In Weekly Session of County Court

Sitting for the first time in two weeks, due to the Superior court term which was concluded last Friday, County court disposed of a docket of fifteen or more cases yesterday.

The major part of the docket consisted largely of larceny and prohibition violation charges, but only a few defendants found their way to the roads, although several were given their freedom with suspended sentences hanging over their heads.

Jesse Hopkins, colored, charged with assault with a deadly weapon, was sentenced to four months in jail.

Permit Fishing In Pitt During Closed Season

The State Department of Conservation and Development announced today that fishing would be permitted in Pitt county three days each week during the closed season.

The closed season extends from May 1 to June 10 and the days on which fishing will be allowed are Monday, Friday and Saturday. The department announced last Saturday that the season for taking shad in inland waters had been extended fifteen days.

Announcement of three day fishing during the closed season was received with considerable interest by fishermen in this section, whose catches have been rather small at times on account of unfavorable weather conditions.

N. Y. Mayor HAS RESIGNED

Joseph McKee Gives Up Post Formerly Held by Walker to Enter Banking

New York, May 3.—(AP)—Joseph McKee, who succeeded James J. Walker a brief period as mayor of New York City and was the chief hope of the anti-Tammany forces in the November election, renounced his political career today.

He accepted the presidency of the Title and Trust Company. A statement issued by the bank in behalf of McKee in which he emphasized the "complete elimination of myself from political and public office."

He added that he felt that his new position would give him greater opportunity for public service in view of the plight of the small home owner under existing economic conditions.

EARLY CHURCH SCANDAL TOLD

Rev. Charles Gable Delivers Last of Series of Lectures on Christianity

For the closing lecture on the first century of Christianity the Rev. Charles Gable gave a detailed account of the origin and development of the opposing religious forces, in the early church. According to the speaker they were a natural outgrowth that followed Jewish as well as Gentile speculation of the doctrine of Christ. Even before the coming of Christ there were a number of divergent schools of thought among the Jews. And the principal systems of Greek philosophers had already had their day. When the first Christians were familiar with the simple statements of Christ's teachings and their relationship with Judaism they began asking questions and seeking solutions of the hidden mysteries. For instance where was Jesus before His birth and what was He? What was His place among celestial beings? What was the binding power of the Mosaic law? These and a hundred questions were agitated. Instead of seeking a solution from their teachers and accepting them in faith the individuals sought to reconcile them with their previous religious convictions. As a result there was hardly a community in the days of the apostles that did not contend with some exaggerated view of Christian tenets. In one place it was the over-emphasis of the Jewish law; in another a complete relaxation of all the Mosaic practices. Elsewhere they were clothing the teaching of Jesus with some plausible process of reasoning that was destructive of faith. To combat these aberrations the Apostles St. Peter, St. Paul and St. John wrote their epistles. In some instances these writings were effective and set aright the erring flocks.

But in other cases pride and self-will were resentful, and as a consequence there were many schools of heresy at the close of the apostolic age. While everyone in turn was destructive in its own way, yet the effort was constructive upon the young faith. Above all it produced that unity which was in the prayer of the Master. ASSOCIATION HOLDS MEET

Shareholders of Home Building and Loan Hear Fine Report in Annual Meeting

The shareholders of the Home Building and Loan Association held their regular annual meeting last night at the Sheppard Memorial Library over \$700,000 of stock was represented in person and by proxy.

The meeting was called to order by Dr. L. C. Skinner, president, who made a short talk on the progress of the association for the past twelve months. J. J. White, secretary, was called on to make a financial report which revealed that the association had paid to shareholders during the last twelve months through matured stock \$138,600. He also reported that \$38,442 had been paid in dividends. The report also showed that the earnings for 1932 were approximately 6.90 per cent, which is the largest earnings for any year during the last five years.

The following directors were re-elected: Dr. R. H. Wright, C. W. Harvey, J. B. James, H. L. Hodges, C. Heber Forbes, B. S. Warren, C. T. Mumford, Dr. J. C. Greene, G. B. W. Hadley, Dr. L. C. Skinner, E. B. Allsbrook, and J. J. White.

The following officers were then elected for the ensuing year: Dr. L. C. Skinner, president; Dr. J. C. Greene, vice-president; J. J. White, secretary and treasurer; J. B. James, attorney.

Today In The Legislature—Raleigh, May 3.—(AP)—Prohibition, revenue, schools, horse racing with pari-mutuel betting and revision of the state constitution all voted for center of the legislative interest today.

The House passed and sent to the Senate the Murphy bill to call a general election on November 7 to determine whether the state shall hold a convention to consider the Blaine resolution to repeal the 18th amendment. Delegates will be elected at the same time.

HALT MERGER OF BIG BANKS

Court Order Temporarily Stalls Proposed Action of N. C. Bank Trust Co.

Raleigh, N. C., May 3.—Gurney P. Hood, State Bank Examiner, and the North Carolina Banking and Trust Company today were temporarily restrained by Judge Henry A. Grady from taking immediate and further steps in the proposed reorganization and possible merger of the bank with other banking houses.

A hearing on the temporary injunction will be held at New Bern at noon, May 16.

C. W. Lewis, as president of Lucas & White, Inc., secured the order from Judge Grady yesterday.

It was served on Commissioner Hood this morning by Deputy Sheriff W. C. Maddrey of Wake County.

The order especially deals with New Bern and Bayboro units of the bank, but restrains the entire merger proposal temporarily, bank commission attaches said.

Hood left the office immediately after accepting the summons and could not be located for comment.

Lucas & White, Inc., asked in its own behalf for all depositors similarly affected who care to join in the litigation and share in its cost.

That it being given deposits on credit in the New Bern bank of the N. C. Bank and Trust Company on March 3.

That the proposed re-organization and merger of the bank be restrained to save property of the plaintiff and that the assets of the New Bern and Bayboro branches of the bank be segregated and set apart and that after deduction of actual operating expenses of the units, that the remainder be distributed among the depositors in the two branches, including the plaintiffs and depositors similarly affected.

SCHOOL GIRL KIDNAPPED

Police Push Search in Wooded Areas For Margaret McNath, 10 Year Old

Hartwichport, Mass., May 3.—(AP)—Police plowed into heavy wooded areas of the East Hole section today for a clue in the kidnaping of 10-year-old Margaret McNath from a school yesterday.

A report that muffled screams has been heard from an automobile answering the description of that used by the kidnapers while speeding in the direction of Hartford, Conn., also was being investigated in central Massachusetts.

The child, daughter of Mr. and Mrs. Neil McNath, members of a wealthy and socially prominent Detroit family, was spirited away yesterday by a negro wearing the uniform of a chauffeur.

In a telephone call ostensibly from the father, school authorities previously had been instructed to release the child.

A description of the negro and the automobile he used and of two white men seen in his company prior to the kidnaping, were the only tangible clues hied on which police had to work.

SLOAN ESTATE IS SOLD AT AUCTION FOR \$25,000

New Bern, May 3.—At public auction here Monday at noon, the Sloan estate on the Country Club road was sold by Commissioner R. E. Whitehurst, the highest bidder being for \$25,000 by Mrs. Anna M. Glenn, wife of ex-Senator Otis F. Glenn of Chicago. The sale is subject to confirmation by court, but this is expected.

The Glens bought the property from N. E. Mohn and C. T. Hellinger of New Bern, but there was an argument over the price. They had a mortgage on the land, and they obtained another mortgage previously owned by Mrs. Earl S. Sloan of Boston. In an effort to bring suit under mortgage foreclosure, their attorneys arranged the compromise public resale. Now that it has been bid in by Mrs. Glenn, this seems to settle the matter.

Previously, the Glens had invested around \$50,000 in the property.

REVIVAL TO END FRIDAY

Memorial Baptist Church Services Continue to Draw Large Crowds

The largest crowd attending a morning service in the revival at Memorial Baptist Church was on hand this morning to hear Rev. Louis S. Gaines, of Raleigh, speak on the subject, "Burden and How to Bear Them."

The message was one of the most effective of the series of services which opened the first of last week and showed conclusively that burdens came into human experience with the coming of sin. The message was a powerful exposition of the power of God to lift burdens from the shoulders of finite man and to lead him into new fields of spiritual achievement.

Last night Mr. Gaines spoke on "The Three Appearings of Jesus." Tonight his subject will be "Repentance," and tomorrow morning "Grace."

Constitutional singing has been inspirational and impressive throughout the revival. Last night a special number was rendered by Mr. Gaines and Mr. Fleischman.

The services will close Friday evening. The church, which has been well filled each day, and packed to overflowing at times, was expected to be crowded to capacity during the remaining three days. The service tonight is being sponsored by the T. E. L. and Fidelity Classes. The C. J. Ellen Bible Class sponsored the service last night.

This morning Mr. Gaines' text was Psalms 55:22.

In part, he said:

"We observe that burdens came into human experience through the coming of sin. When man was still in his condition of innocence he had no burdens. He was happily occupied. But with the appearance of sin conditions changed. The matter of burdens may be considered in three ways: First, physical burdens, such as toil, sin, and the climax in death. Second, intellectual burdens, like fear, ignorance, superstition; and third, spiritual burdens, doubt, materialism, and the sense of guilt. Considering this subject we do so by looking at it in the form of a triangle, and taking into account of definite truth at each angle. The first is: 'For every man shall bear his burdens.' (Gal 6:5.) Individual responsibility is revealed here. It is a challenge against self-pity, and feeling that we suffer in the world above all others. We are not to grovel in the dust of circumstances, but to rise up like kings, in the power of God." (Continued on Page Four)

PLEASED WITH GOODWILL AT WASHINGTON

British Leader Says Good Results Should Come From His Conversations With President Roosevelt; Denies Inviting American President To Attend London Conference

South Hampton, May 3.—(AP)—A cheering crowd on the dock greeted Prime Minister Ramsay MacDonald when he returned today from his economic discussion with President Roosevelt in Washington.

MacDonald, upon landing, said it was worth while going ahead and attacking world problems which were bound to yield to corporation and good-will.

It was such good will he found in a striking way in Washington, he said.

He denied inviting President Roosevelt to London to come to the London conference from the World Economic Conference which opens in London June 12 and said the matter was not mentioned.

GREENS IN FIELDS AND ROADSIDE GIVE MENU VARIETY

Washington (AP) - "Garden ease" is just about ready in the fields for those who want to vary the family fare and save on the budget.

They are the greens that country aunts know most about. The city dweller usually has a green dandelion salad in the spring. And if he finds a well-hidden creek he usually brings home some water cress. But there the general knowledge of greens ends.

Actually there are many more. The list includes mustard, poke shoots, lamb's quarters, sorrel, young tops of beets and turnips, cabbage sprouts, celery leaves, curly endive and alfalfa shoots.

Look for them in the fields, along the roads and in thin woods. Cook greens in a small quantity of boiling water with a pinch of salt, says the Bureau of Home Economics. Cook them without a pot cover and only until they are tender. Some, such as spinach and dandelion greens, only need the water that clings to the leaves after washing.

Across the shadowy court the window and glass-paned door of the lobby made bright rectangles of light, and I could see two policemen; they sat at a small table directly under the light and were placidly playing some kind of card game.

The men were not smoking, although, if they had been, the odor would never have reached my room. But behind me the whole north wing was deserted and silent. I walked carefully along its length. I even opened, very cautiously, a door or two near my own room. But the rooms were black cavities, and the air that rushed to meet me was cold and stale and had that peculiarly musty, dank smell of rooms that are very old and have been empty for a long time.

Moreover, the smell of tobacco smoke was much fainter here—was indeed so faint that I was not sure it was there at all. It was only when I returned to my room that it was definite and strong again. I closed the door, puzzled, and snapped on the light.

It puzzled me so much that I examined the room and adjoining bathroom. There was no one there, of course, and no evidence that anyone had been there. I even looked for hidden entrances to my room, feeling a little silly and melodramatic about it, but thinking still that there might be some such thing in that old place, built in the days when secret doors were the most matter-of-fact of arrangements.

But there was nothing; indeed there was no place for anything except behind the enormous wardrobe, and if I moved that I should rouse the whole hotel in the process, for it was very heavy and large.

However, I did drift into uneasy dreams again, and by morning the odor of tobacco smoke—a silly and trivial thing at its clearest—had merged into these dreams and no longer seemed important, although I told Lorn about it when I saw him.

That was when we met in the lounge after breakfast. Mariame, red-eyed and dark and somehow sullen, had brought in the breakfast tray and bounced out again. All her giggles were gone, poor child. I wondered what little Marcel had been to her.

Lorn listened politely, but without much interest, to my story of the tobacco smoke—which did, in fact, sound extremely trivial and fanciful by the light of day—said in a listless way that it was probably a policeman somewhere, but that he would try to make sure; asked how my shoulder was and said he was off to try to discover what the police were doing.

Fewer Bank Robberies Oklahoma City.—(AP)—Nineteen thirty-three started out to be a light year for Oklahoma bank robbers. In the first three months there were but two hold-ups, one burglary and one attempted burglary compared with sixteen robberies during the same period of 1932.

Georgia building and loan associations lent \$1,119,241 for construction of 93 new homes and refinancing of 639 others during 1932.

Deposits of South Dakota banks at the end of 1932 amounted to \$68,754,000 as compared with \$92,347,000 the year before.

Work or Lose Your Gains Cheyenne, Wyo.—(AP)—There's material for a typically American success story in the career of Nellie Taylor Ross, President Roosevelt's appointee as director of the nation's mint.

For the woman who is to sit at Washington in charge of all the gold, silver and copper coins in the country and of the assay office where gold is brought for conversion into money is something of a pioneer—political speaking—with two "firsts" to her credit.

When in 1924 she was drafted to succeed her husband, Gov. William Bradford Ross of Wyoming, after his sudden death, never before had a woman served in the governor's chair. And now again she is to fill a job heretofore reserved for men.

After two years as governor—her first political reversal came in her defeat by the late Frank Emerson at the end of her husband's term—she sat back to watch the political scene. But not for long. Soon she was doing an energetic job for the Democrats in the 1928 national campaign.

Then came the 1932 fight when she told the captains of her party: "Now is the time to talk to women. They are alive to government. The crisis has awakened them, and they have always been liberals."

"Yes, and you're going to organize them," the captains agreed. She went to work and when she had finished she had seen 36 states and 200 cities.

All had heard this dainty little woman step to the footlights and make government routine seem like any housewife's job. She had become an outstanding campaigner.

And it all had started in a little Wyoming home where a young attorney and his Missouri-born wife had read together every night after their little boys were tucked into bed.

Before she got into politics it always had irritated her to see women paying taxes and not knowing how the money was spent. She saw the need for women in politics.

"This administration has given women more than they have ever had. They must deserve the advance, to hold it. That means giving of yourself and time. But it is a delight."

HOLLYWOOD SIGHTS & SOUNDS

By ROBBIN COONS Hollywood.—(AP)—There's been much talk in Hollywood about the ills of the industry, and now "sick pictures" themselves are about to be doctored.

Music and sound effects are the chief "medicines" in the proposed treatment of "ailing" films. And there are others—sometimes a major operation, with scissors to do the necessary amputating.

"Many producers have made pictures, only to learn too late that something was wrong with them from the beginning," explains Abe Meyer, who, with Dan Milner, is planning a venture into film doctoring.

"The result is that the picture goes on the shelf—a repeated process that represents fortunes wasted. So we propose to do things."

How? That's simple. By looking over the sickly product, diagnosing its malady, taking it apart and putting it to gether again—with a new dressing of continuity, some salvage of music, perhaps a bolstering splint of sound effects in the midriff of the drama. Going out on their own if need be, to shoot additional scenes which would make a fair picture from a poor one, or a good one from a fair.

The idea goes farther than that, however, including advice on the "ounce of prevention"—that is consultations with the producer before shooting begins, so that incipient cinema "diseases" can be nipped, at their source.

Leatrice Joy, once a big name in pictures, was at lunch in a studio restaurant the other day, and conjecture as to her possible return to the films arose at once. But Leatrice said no. She had come with her step-daughter to rent a costume from the studio wardrobe for a party.

She retired from the screen when she married, and—"I've gone domestic with a vengeance," she said. "But it is exciting to come back, even for a day, isn't it?—something fascinating in the atmosphere," she added with a laugh.

Hollywood.—(AP)—Mae West's screen character—hard, dazzling and spectacular—is no lily, yet it requires some expert gliding.

All writers who work on Mae's pictures—for her next they're Claude Binyon and Frank Butler—something of Miss West's shrewd showmanship.

No star likes to be heavy, not even Mae, and her first requirement is that if she is to portray a not too spotless flower she shall be surrounded in the cast by others less savory. Deft contrast, you see, making for audience sympathy.

The second is that Mae, whatever else she may do, must not hurt anybody. Men can ruin themselves for her, but Mae won't have a hand

in the business,

Darryl Zanuck's retirement from the Warner organization was something of a Hollywood sensation. Another followed it when the young production general shortly after announced his affiliation with Joseph Schenck in a producing arrangement.

From the start Zanuck's been a showman. He used showmanship in his movie crashing. He wanted to be a writer. Broke, he trudged around Hollywood making the studios, got nowhere until he took a cue from one refusal. "We're using only established writers." An established writer, he learned, was one who had a book published; so Zanuck had a book published locally and became an "established writer."

It was as a writer that he joined Warner Bros., the studio where he was to become production chief.

He is hard-driving, tirelessly energetic, shrewd, loud-talking. He doesn't spout about art, and yet some of his pictures have had a claim to it. He has no working hours, and ye almost any hour he can be found at work—except when he's playing polo, which he manages to do often.

He has a reputation for giving younger writers a chance. Carl Erickson, a lad who came to his office seeking a job, is on the studio staff now and doing well. The executive—all executives are supposed to be stony-hearted—probably remembered his own weary attempts to connect with a studio.

Horses Hitched To This Farm Aid Plan

Urbana, Ill.—(AP)—That joke about the old gray mare isn't what it used to be. It has assumed a serious complexion—involving the whole problem of farm prices.

Prosperity Via Horses The decline of the horse has continued to such an extent, according to studies made by C. W. Crawford, horse husbandry expert at the University of Illinois, that his conclusion is this:

Restoration of the 8,500,000 horses which have disappeared off American farms in the last seventeen years would do "more than anything else" to wipe out underconsumption of grains and bring back the 68-cent corn and 43-cent oats of 1915.

If there were 21,195,000 horses on United States farms—as there were in 1915—Crawford says:

"They would eat more oats than are now marketed and 85 per cent of the corn which was shipped out of producing counties in 1932."

Minimizes Production as Cause Crawford discounts the idea that low grain prices are results of increased production.

"Quite the contrary," he contends. "We have been producing about the same amount of corn and oats in recent years as we did before the war."

"The 1932 corn crop was larger than usual, but it had been exceeded four times in the past twenty years and has been equaled three different years in the same period."

"Combined production of corn and oats for the ten-year period 1905-1914 averaged 3,756,000,000 bushels. For the five-year period 1928-1932 it was averaged 3,803,000,000 bushels—an increase of only 1.4 per cent."

Population is Partial Offset "To balance this slight increase, we have had a steady rise in population. The 1930 census showed a 16 per cent increase over 1920. Therefore it seems we do not have a surplus as far as potential consumers are concerned."

Corn and oats, however, are not eaten directly by people to any great extent. Crawford explains, with 85 per cent of the nation's corn and 80 per cent of its oats being fed to livestock.

"Consequently," he contends, "coarse grain prices are vitally influenced by livestock production, and the latter industry is directly dependent on meat consumption for the most part."

Meat, Lard Consumption Off Per capita consumption of meat and lard in the United States has dropped less than 2 per cent, Crawford says, while receipts of dressed poultry at major markets have gained 85 per cent in eleven years.

"Therefore our decrease in consumption of coarse grains," he argues, "must be in other classes of livestock than meat animals."

"Numbers of dairy cows have increased steadily for years and must be consuming as much or more grain than formerly. This leaves only one class of livestock which may answer the problem."
