THIS COUNTY HIT BY STORM LAST NIGHT

Buildings, Trees and Crops in Various Sections of County Damaged

Wind, lightning, hail and a down-pour of rain was the weather bill of fare for this community last night. While residents of this city believed from the intensity of the wind here that great damage was being done, a check-up of the city this morning revealed a few broken trees blown down...

While the Bethel section had a good rain, reports from that section indicate that the storm was slight, while the Ayden section at the other end of the county report much damage to the crops from the large rain that overflowed fields and ditches...

Probably the greatest damage was that on the Travis Hooker farm between this city and the Country Club where several large trees were broken off by the storm and did considerable damage by falling upon sections of the dwelling house and the barn nearby...

The reports received here today were meagre, and it is expected that when the full extent of last night's storm is made known the damage will be far greater than it now appears from the reports received.

Funeral Services Civil War Veteran Held Yesterday

Funeral services for Ezekiel Thomas Trotman 63 who died Thursday evening at the home of his daughter, Mrs. M. H. James, at Whitehurst Station, were conducted from the home yesterday afternoon by Elder J. B. Roberts of the Primitive Baptist Church, followed by burial at the family burying ground. The services were largely attended, attesting the high esteem in which the deceased was held.

Mr. Trotman was a native of Gates County. During the Civil War he served in the Confederate Navy, and following the close of the war he entered the U. S. Navy where he served 25 years, being stationed the major portion of that time at Portsmouth, Virginia.

Funeral services were held at the home of Mrs. M. H. James, at Whitehurst Station, yesterday afternoon.

W. J. SWAN MAKES BOND FOR APPEARANCE

New Bern, May 6.—Capias instanter was to have been issued for W. J. Swan, indicted by the Pamlico county grand jury Thursday for receiving deposits when he knew the bank was insolvent, but it was not served as he gave himself up voluntarily and agreed to fix bond, set at \$5,000 by Judge Henry Grady of Clinton, presiding over the week's term of criminal court. He will be tried at Bayboro next October. No indictments were brought against other bank officers.

Mr. Swan was for some years president of the Eastern Bank and Trust Company, now defunct. The bank operated a home office here and several branches in this section for some years. It was closed after a run following the close of the local Citizens' Bank on August 7, 1930, but was permitted to reopen under restrictions, upon depositors' agreements, within a few months. On December 20, 1932, its new assets were taken over by the North Carolina Bank & Trust Company, while its old business was continued in liquidation by State banking department officials.

Late News Flashes

More Banks Reopen. New York, May 6.—(AP)—During the past week 117 banks reopened on an unrestricted basis, the American Banker reported today. This is by far the largest weekly resumption since the end of March.

"The large number reopening," says the publication, "indicates rapid strides in the bank reconstruction program under way for the rehabilitation of the 3,000 banks still in the hands of conservators or otherwise unopened since the March holiday."

More Cuban Bombings. Havana, Cuba, May 6.—(AP)—Terrorists bombers struck again today killing one policeman and injuring a civilian. LEGISLATURE MAY ADJOURN ON THURSDAY

House Expects to Complete Passage Revenue Bill Monday Night

Raleigh N. C., May 6.—(AP)—The House of the North Carolina General Assembly passage on Monday night of the revenue bill, it is expected to adjourn next Thursday. The measure was accepted by the House in first reading yesterday and the body reconvened shortly before midnight so that a vote could be obtained early this morning and the measure prepared for final passage Monday night.

It will then go to the Senate where as it embodies most of the recommendations of that body when it reviewed the original House bill, it is expected to pass in the minimum of three days. The House vote on first and second readings were 45 to 40 and 39 to 21 exclusive of eighteen pairs.

The measure embodies the Senate 3 per cent sales tax with certain exemptions estimated to reduce the actual levy to two and one-half per cent. Meat, milk, flour, meal, molasses, salt, sugar and coffee are exempted. The kilowatt power tax included in the House measure was eliminated and was the original House proposal to tax stocks of foreign corporations.

PAYING GUESTS INVADE SCOTCH DUKES CASTLE

Glasgow, Scotland.—(AP)—Another famous Scottish estate "rent commercial" when Buchanan Castle, seat of the Duke of Montrose, head of the house of Graham, was vacated by the family to receive its first "paying guests" for the Easter holiday.

The duke and family took up residence in a house on the grounds beside Loch Lomond. In the castle the sumptuous dining room was fitted with small tables and a number of bathrooms have been installed.

Heavy taxes have struck the fortunes of the Montrose family, and on more than one occasion the duke has sold tracts of his estate.

ROWLAND RENOMINATED FOR MAYOR OF RAEFORD

Raeftodd, N. C., May 6.—In a three-cornered contest here today, G. B. Rowland was renomiated for mayor. The vote was as follows: G. B. Rowland incumbent, 182; J. H. Austin, 19; W. M. Blue, 84. Four of the old board of aldermen were unopposed, and T. B. Upchurch, Jr., was nominated without opposition. The vote was very light and little interest was manifested.

MEETING AT LOCAL CHURCH COMES TO END

Series of Services at Memorial Baptist Church Ended Last Night

The revival meeting at Memorial Baptist Church which began April 24 came to a close last night with a strong sermon by Rev. Louis S. Gaines, pastor of Hayes-Barton Baptist Church, Raleigh, guest preacher. This closing service was well attended. Special musical features of last night's service included a solo by Mrs. W. Z. Morton and Mrs. E. S. Hamrick and a duet by Mr. Gaines and Mr. Fleischmann. The revival meeting resulted in many additions to the church membership.

Last night Mr. Gaines spoke on the subject, "Gethsemane Gabbatha, Gethatha." In part, he said: "Great events of peculiar significance to the Christian are connected with these places. The Bible teaches us that as we journey toward the new Jerusalem we are beset by a triumvirate of evil, namely, the world, the flesh, and the devil. It is of added significance that after Jesus had offered himself at his baptism he was led forth to a series of temptations. He passed through them victoriously. In them was epitomized the struggle with this trinity, the world, the flesh, and the devil. In the first contest, that of the flesh, he won the struggle by unsheathing the Sword of the Spirit, the Word of God, against the adversary. In this same manner the Christian may fight and attain victory. Second, he faced the allurements of the world, the supposed course to attain the expected goal by a short cut. His ways were those of obedience, love, sacrifice, and self-giving. He had come to drink the cup to the dregs and would do so. Once more, he faced the devil in the direct bid for worship. By the Sword of the Spirit he vanquished this foe again, and in this matter we may appropriate his victories by faith."

"At the close of his ministry, at these historic places, he faced these same temptations, and attained his victory to the glory of God, and also for our encouragement. Gethsemane, the victory over the flesh as God answered His prayer, having given himself unreservedly to His will. At Gabbatha He stood and received the judgment of an unbelieving world, and at Golgotha he died, the Savior of the world, as he conquered sin, death and the devil by the one method, that of submission. In all this we may follow as we are in Him by faith."

APPROVE ACCEPTING OF BONDS FOR TAXES

Goldsboro, May 6.—The new board of Goldsboro city aldermen at their meeting Wednesday night, approved for passage in the present session of the Legislature, a petition presented by Co. George K. Freeman, relative to acceptance of city bonds for obligations due the city.

The proposed bill provides that bonds accepted in payment of taxes and assessments for the year 1931 and prior years may be accepted on the basis of not more than 20 per cent in excess of the cost to the taxpayer offering them as payment of his taxes or assessments.

Bonds maturing prior to January 1, 1932, may be accepted for payments of taxes and assessments for 1932 and prior years at their actual cost to the taxpayer.

Colonel Freeman said that the bill would safeguard a law recently enacted allowing Goldsboro to accept its own bonds for payment of taxes, street and sidewalk and sewer assessments.

HEALTH REACTION TO DEPRESSION DUE SOON

Sanatorium, May 6.—There are numerous evidences from several sources that the long-forever delayed reaction of the country's death and disease rates to the economic depression is about to manifest itself, according to an editorial in the May issue of The Sanatorium Sun, publication of the North Carolina Sanatorium, which refers to a statement by Health Commissioner Wynne of New York, who pointed out that the low death rate of the past few years of economic stress could not be expected to continue indefinitely.

SEEK BRITISH ATTITUDE TO TARIFF TRUCE

Norman Davis Ordered to Remain in England and Urge Immediate Statement

London, May 6.—(AP)—Norman Davis, special ambassador of President Roosevelt has received instructions to remain in London and press the British government adherence immediately to the tariff truce, or at least force a declaration of the British position.

Davis was preparing to depart for the Dismantment Conference at Geneva, but was retained here for the effort to get acceptance of the American proposed truce. Although his presence is needed at Geneva, the American government insisted that the matter of the tariff truce be ironed out immediately. It is understood that other nations are prepared to follow Great Britain's lead and are awaiting her decision. The difficulty is that the British government thus far has given no reply as to its real attitude toward the truce proposed for the duration of the World Economic Conference, and it is expected that she will not agree unless Great Britain's tariff position is protected by sea quarries.

Tokyo, May 6.—(AP)—The Japanese government today decided to agree to the American tariff truce proposal with reservations.

FOUNTAIN MAN PASSES AWAY

Ollen Gardner Dies Early This Morning Following Illness of Two Months

Ollen Gardner, age 81, died this morning at 7:30 o'clock at his home in Fountain following an illness of the past two months, resulting from a stroke of paralysis. Funeral services will be held from his late home Sunday afternoon at 2 o'clock. Burial will follow in the Rogers' burial ground near Fountain. Services will be conducted by Elder Hart, of Snow Hill.

Mr. Gardner was born and reared in Fountain, and is well-known in his community. He was a member of the Aspen Free Will Baptist Church.

Surviving are his wife, Mrs. Addie Bell Gardner, and three sons, Herman, William and John Gardner, all of Pitt County.

PERMIT THREE FISHING DAYS DURING WEEK

County Game Warden Marvin Horton today announced that he was in receipt of information from the State Game Commission to the effect that during the closing fishing season from May 1 to June 10, fishing was permissible in most of the eastern counties. Craven, Jones, Onslow and Pamlico being exceptions to the provision, having so far not been granted the three days' privilege.

There are practically no other changes in the fishing laws, he says, except that fishing with trot lines has also been permitted.

BRITISH AIR LINE TRIES SPECIAL CRUISE PLAN

Cairo.—(AP)—Ocean liners which vary, scheduled sailings with special cruises have their counterpart in the air.

A 38-passenger Imperial Airways plane will be seen in a cruising role May 8 when it leaves Egypt for England via Bengal, Malta, Rome, Lyons and Paris.

The cruise will last five days.

Tornadoes In South Carolina Take Toll Of Sixteen Lives

More Than Hundred Injured and Hundreds Are Homeless Damage Over Million Dollars

(By The Associated Press) The death toll of yesterday's tornado that roared through upper South Carolina striking striking destruction to Anderson, Greenville and Laurens Counties, stood at sixteen today. The list of injured ran up to more than one hundred, while property damage was estimated in excess of a million dollars. Hundreds were homeless.

Meanwhile the Red Cross, Reconstruction Finance Corporation and other relief agencies were pressing forward in their relief work. The Red Cross at Laurens issued an appeal for clothing, furnishings and food for many families whose homes were wrecked.

Balton, a little industrial community ten miles from Anderson was hardest hit. Here the storm took ten lives, injured scores, demolished thirty-one houses, unroofed others and wrecked the Blair Mill. The damage to the mill alone was estimated at \$150,000.

Authorities estimated that sixty families were homeless. Greenville reported four dead, Laurens one and the force of the storm was also felt in Union and other counties.

GIRL IS FREED BY KIDNAPERS

Peggy McGrath's Parents Paid \$60,000 Ransom For Return Of Child

Harwichport, Mass., May 6.—(AP)—Cyril Buck, the man who returned kidnapped Peggy McGrath to her parents yesterday, and his brother Kenneth Buck, were arrested as participating with two unidentified men in the abduction of the child and the extortion of approximately \$60,000 ransom. Daniel Needham, Massachusetts Commissioner of Public Safety, announced the arrest and stated that he had a full statement from Kenneth Buck, unemployed, chauffeur, admitting his part in the crime. He said Cyril Buck had admitted connection with the affair in bringing about the return of the girl but maintained that his part was innocent. Needham at first had said he had confessions from both the men but later modified his statement as to Cyril.

The two were arrested a short time after Cyril had been brought back to Harwichport from Woods Hole where with the father of the stolen child and William Lee, his business associate, he had undergone an all night questioning by the police. Needham announced the arrest of the McGrath family from any connection with the kidnaping. He quoted Cyril Buck as saying: "I brought the child back myself. McGath will verify that. I did a big job, and now I suppose I'll have to pay for it." Cyril claimed he knew nothing of the affair until Wednesday night when he is understood to have acted as contact man between the kidnapers and the child's parents.

Woods Hole, Mass., May 6.—(AP)—Neil C. McGrath whose ten-year-old daughter was restored to him upped rigid questioning by State authorities today. The process had continued without interruption since early last night. With him also under questioning by State police aboard the coast guard base ship here were William Lee McGrath's business associate; Cyril Buck, garage man, and Harold Sawyer, also a resident of Harwichport.

Daniel Needham, State Commissioner of Public Safety, and District Attorney William Crooksley, sought through the questioning to determine what they might know concerning the identity of the kidnapers who enticed the little girl from in front of her school Tuesday afternoon and who restored her to her parents after the payment of approximately \$60,000 Friday morning. They sought also to determine the exact locality of the shack in which the child had been kept prisoner and the source of the ransom money. There was no indication from aboard the coast guard cutter about when the questioning would be completed.

It was learned from an authoritative source today that the total sum paid in ransom for the return of the child was approximately \$60,000. Last night the amount was estimated between \$70,000 and \$80,000.

So important a little Napoleon of production as Darryl Zanuck, who resigned from his Warner Bros. post after that company failed to return to the full salary schedule, works on the principle that story is the first essential of a successful picture, and this principle finds concurrence among other movie executives.

That is why the writers who have joined the newly vitalized Screen Writers' Guild more than 250 strong, regard themselves in a peculiarly healthy position to present demands to the studios.

This they will do in the form of a code, now being drafted, which will embody not only the writers' stand on current questions in the industry affecting them, but the accumulated grievances of their craft since screen writing became a profession.

These views, obtained by a canvass of the membership, include protest against mass salary reductions and against the proposed "Artists' Service Bureau"—and, in addition, a host of more or less

vital matters pertaining to working conditions.

Screen credits may be ignored by the fans who see the picture, but they're dearly prized by the men who get them, and they don't like to see their work credited to, say, an associate producer who happened to sit in on one or two story conferences with them.

Since talkies made dialog important, writers have been more prone to resentment than before at the old movie custom of changing stories on the set. Dialog has to hold together, and when a director or a supervisor, who hasn't worked on the story, undertakes to "improve" it, the original writer often feels he has cause to squirm.

Airship Shopping? Check Its Curves

Akron, Ohio.—(AP)—Curves are just as much the concern of the United States Navy before it accepts a new airship such as the Macon as they are to a woman buying a new dress.

It is important to know the kind of curve the airship can describe against the sky when turning a corner or when turning completely about, as these points have to do with her maneuvering and ease of handling.

A part of the test flights he to do with these turns. Before accepting the Akron, the navy demanded that she be able to turn about in a diameter of 3,500 feet. The same demand holds in the case of the Macon.

Because an airship leaves no tracks, it is hard to measure the curves, so instruments with such names as theodolite, camera obscura and yacometer are used.

The camera obscura takes a series of pictures of the airship while describing a turn. Pictures taken at intervals of 10 seconds on a sheet of paper form a curve and thus show the path that has been taken.

The theodolite is a surveyor's telescope with the eyepiece at the side rather than at the end. An observer measures the angle between the line drawn to a certain point on the airship and another line perpendicular to the ship's original course.

These angles are measured at 10-second intervals. Two of the instruments are used, one on top of the ship's dock, another on the roof of a factory three miles away. Measurements are made at the same instant by means of synchronized clocks.

From the angles the radius of the ship's path is determined.
