America Will Seek Quick Action At London 'Confab'

METHODS OF PROCEDURE ARE STUDIED

Views on Subject Are Being Exchanged Between President And Dr. Hjalmar Schat, German Representative; Stabilization of Pound and Dollar Form Most Important Topic of Conversations

Washington, D. C., May 11.—(AP)—American preparations for the World Economic Conference are now centered on the definite decision of the best way of procedure at London to secure the quickest action and prevent a long drawn-out gathering.

Views on this subject were being exchanged with Dr. Hjalmar Schat, representative of the German government and other statesmen, sent here for conversations with President Roosevelt.

In official circles the opposition has been formed that stabilization of the pound and the dollar at about their present ratio would be the soundest basis for action at the London conference.

Effort to hit upon a specific ratio during the visit of the Prime Minister Ramsay MacDonald and his British colleagues were unsuccessful but they have not been abandoned.

Mrs. Harris Dies In This County; Funeral Friday

Mrs. Robert Ann Harris, 75, died this morning at 9 o'clock at her home near King's Cross Roads after an illness of five years. She had been confined to her bed since last Thanksgiving when her condition took a turn for the worse.

Funeral services will be conducted from her late home Friday afternoon at 3 o'clock by Rev. B. L. Manning and burial will be made in the Nobles graveyard in the Reedy Branch community.

The deceased had been a member of the King's Cross Roads Free Will Baptist Church since twelve years ago. She was a devout Christian and manifested much interest in the work of the church.

She was the widow of the late Alex Harris, who died about sixteen years ago. Surviving are two sons, Alex Harris, King's Cross Roads; Robert Harris Ayden; two daughters, Mrs. Will Jones, Greenville; Mrs. Reba Hinson, Ayden; two sisters, Mrs. Jane Smith, Winterville, and Mrs. Gertrude Tyson, Frog Level community.

TOBACCO FARMER IS SHOT BY NEIGHBOR

Selma, N. C., May 11.—Moulton Jones, aged about 30, was shot and seriously wounded about 3 o'clock this afternoon. The shooting took place at the home of Leroy Lynch, five miles northwest of Selma, on the Selma-Wendell road. Lynch, who did the shooting used a double-barrel shotgun. The wounded man's skin was perforated from the knees to the shoulder. Fifty-three shot were picked out of his body. He was rushed to the offices of Drs. Vick and Person in Selma for treatment.

He was later removed to his home, which was arrested soon after the shooting by Deputy Sheriffs Massey and Harbour and brought to Selma, where he gave bond in the sum of \$1,000 for his appearance in Recorder's Court next Wednesday. It is said the trouble occurred over some tobacco plants. Both men are well-known farmers.

STOCKS TAKE QUICK JUMP

New York, May 11.—(AP)—Stocks and leading commodities moved higher on heavier trading today. Shares swung up a few points to more than a half in extremely active opening, while cotton rose \$1 a bale and grains were buoyant at Chicago with wheat up two cents a bushel.

On the stock exchange, blocks of 1,000 to 15,000 shares came and the opening and activity continued at so fast a pace that the ticker fell ten minutes behind time during the first half hour.

Today In The Legislature. Raleigh, May 11.—(AP)—The biennial revenue bill with its modified three per cent sales tax today received final legislative approval.

The Senate Merchants Association through Willard Dowell, its secretary had served notice on the legislature that the constitutionality of the tax will be tested.

PEIPING GETS WAR WARNING

Peiping, May 11.—(AP)—A Japanese bombing plane roared over this "forbidden" city today and from it rained handbills warning of war. Chinese machine gunners opened fire, but the plane, at a safe height, completed its mission and then vanished.

"Our army," said the handbill, "takes pity on your ignorant soldiers." Peiping and Tientsin are the gate cities of North China under the Chinese treaty.

Japanese planes dropped bombs during the morning, and reports said that Chigisa, only forty miles away, and Myrun, 35 miles on the north, also were bombed.

BRITISH SHIP BRINGS CLOTH FROM INDIA

Norfolk, Va., May 11.—Besides Hessian cloth and bagging, the British steamer ship Mabout brought in 250 bales of cotton cloth from India and is now bunkering prior to loading cargo for London. This cargo is largely tobacco, lumber, mica and general freight.

The Mabout, a Brockbank-Cunard liner, arrived early Tuesday, according to government observers at Cape Henry.

POLICE GUARD IS RUSHED TO CAPITOL HILL

Effort to Prevent Trouble in Bonus Army Started by Authorities

Washington, D. C., May 11.—(AP)—A detail of twenty-five police from Washington was sent to Capitol Hill today to do guard duty.

Although they apparently were being posted in case bonus-seeking veterans become troublesome officials declined to explain the presence of the troops.

No veterans were visible on the grounds or in the vicinity of the building at the time.

A body of marchers camped on an adjoining lot today decided to obey a police order to move. Leaders told their followers they must give way to the law.

The ranks of the bonus-seeking army was swelled rapidly today, but they were split into antagonistic camps.

NOTE SUITS MOVE QUICKLY

Over Half Dozen Cases Completed in Yesterday's Session Of Civil Court

A half dozen or more suits on accounts and notes were disposed of in yesterday's session of civil court. All of the cases involved small amounts and only minor time was required in consideration.

Quite a number of actions have been disposed of since the opening of court here the first of the week, and it was expected the bulk of the calendar of nearly a hundred cases would be disposed of by the end of the week.

State Bank and Trust Company obtained judgment on a note against John F. Crawford here yesterday, the amount being under \$200. The same institution also obtained judgment on a note against B. S. Sumrell.

GENEVA HEARS TALK OF WAR

Paraguyan - Bolivian Dispute Receives Attention of League of Nations

Geneva, May 11.—(AP)—The League of Nations invoked a special session of the council today to consider the Paraguyan declaration of war against Bolivia, the first declaration since establishment of the League of Nations.

The action was taken at a meeting of the council committee on disputes and had been convoked as result of official notification of Paraguya's declaration.

PARROTT FILES ANSWER TO ACTION FOR DAMAGES

Kinston, N. C., May 11.—Dr. James M. Parrott, executive secretary of the State Board of Health, has filed answer in Superior Court here to a suit brought against him by Mrs. Laura Hines who asks \$3,000 because the dog was bitten by a dog. She was bitten by "Stubby," a terrier, and asserts she was made ill.

Mrs. Hines first sued Miss May Harvey, neighbor of Dr. Parrott. Miss Harvey won the suit. She denied the dog was her property. "Stubby," a canine character known to many was owned by Dr. Parrott, she stated.

Then Mrs. Hines filed suit against Dr. Parrott. But she declined to relinquish Miss Harvey from partial responsibility. Appealing from the verdict in the Harvey suit, she asserted the defendant petted and pampered and harbored the dog.

Dr. Parrott's answer contends Mrs. Hines is "due, no amount whatever."

AGREE TO INAUGURATE A FORTY-HOUR WEEK

Gastonia, N. C., May 11.—(AP)—Textile executives representing 1,400,000 combed yarn spindles agreed to the inauguration of a forty-hour week in their plants at a meeting here today.

After the meeting it was announced there had been no consideration of a minimum wage agreement.

The mills concerned are situated in an area embracing Gastonia, Thomasville, Statesville and Albemarle.

TWO NABBED FOR LARCENY

Heads of Chicken Stealing Ring Rounded up by Officers Here Yesterday

Robert Tyson and James Evans, colored, were arrested here yesterday and charged with wholesale chicken thefts in the Winterville community.

Given preliminary hearing the couple was bound over to the next term of county court. They were unable to furnish bond and were remanded to jail.

The two men were nabbed by local officers as they were attempting to dispose of a coop of chickens on the streets of Greenville.

They admitted taking the chickens from the homes of Mrs. Nines and Miss May, between Greenville and Winterville, and also confessed complicity in a number of chicken house robberies in recent weeks.

Officers expressed belief the arrest had virtually cleared up the epidemic of thefts reported in the Winterville community the last month or so as the two prisoners were believed to be the heads of a ring specializing in the stealing of chickens.

PARIS TRUCE GETS SETBACK

Germany's Disinclination to Give Assent Stalls Consideration

London, May 11.—(AP)—Germany's unwillingness to give prompt assent to the draft of the Paris truce has indefinitely delayed formal acceptance and the passing on to other governments of world conferences on armistice projects.

Germany's action had been expected last night and again today, but when the government's reply was finally received at the afternoon meeting of the cabinet in Berlin it was to the effect that the German government would need more time to study the proposals.

An effort will be made to impress upon Germany the necessity for action, and it was understood similar action would be brought to bear at Washington.

In absence of American queries it was understood that a formal reply had not been received, and it was being held in abeyance pending action of the Reich.

Washington.—(AP)—"Big Shots" of the reptile family will bask luxuriously under the rays of infrared and violet lights when they are taken to the World's Fair at Chicago by the Smithsonian Institution in June.

One proud sand lizard from each continent of the world will be displayed as a part of the Smithsonian exhibit, illustrating the last word in the care of live animals.

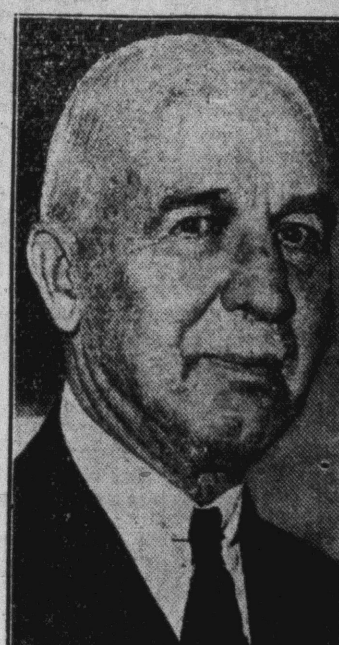
YOUNG NEGRO GIVEN SENTENCE TO PRISON

Windsor, N. C., May 11.—In Superior Court in session here Monday, with Judge F. A. Daniels of Goldsboro, presiding, Stark Sutton was sentenced to two and one-half years at hard labor at the State Prison.

REVENUE BILL FACES FINAL ACTION TODAY

House Committee on Public Utilities Unfavorably Report Bill on Power Company Valuations; Action Death Knell For Measure; Father Of Bill Expected To Be Approved by Minority Report

Raleigh, N. C., May 11.—(AP)—A three per cent modified general sales tax for North Carolina received final legislative approval today as the revenue bill conference report was finally passed by the Senate. After the mere formality of ratification of the biennial money raising act today or tomorrow the sales tax will be a part of the State statute.

Usually an unfavorable committee report means the death of a bill.

James A. Pou, of Raleigh, and Wilbur Doshner, representative from New Hanover, led the fight for the utilities companies before the committee. Ewing said a minority favorable report might be made.

TWO ARE SENTENCED TO 30 YEARS IN PRISON

Clinton, N. C., May 11.—Dallas Bradshaw, white, and Roy Jones, negro, were each sentenced to twenty years in the State's Prison at hard labor by Judge W. C. Harris in Superior Court here today. The two defendants entered a plea of guilty to assault with a deadly weapon with intent to kill and conspiracy to commit murder when arraigned for trial here Wednesday of last week.

The charges were brought as the result of a murderous attack made upon Stacy Holland, young white man, who, according to his testimony, was severely beaten by the two defendants, tied to a tree, given a short time to pray, and then shot in the forehead. Bradshaw was charged with firing the shot, which almost claimed the life of the victim.

NEGROES CONDUCT CLEAN-UP CAMPAIGN

Spring Hope, May 11.—The Better Home, Garden and Corn Society, organized under direction of the Negro Vocational Agriculture Department, conducted a clean-up week from May 1 to 6.

According to the judges' report, the homes of the twenty-two members had been improved greatly. Besides re-arranging old shrubbery, the members had cleaned their yards, planted new shrubbery, cut the lawns, planted flower beds, and around some homes had sown lawn grass and planted trees.

W. T. Johnson, vocational instructor, was greatly pleased with the improvement that had been made. He expressed his belief that the continuation of a similar contest will cause the negroes of Spring Hope to forget the depression and live at home.

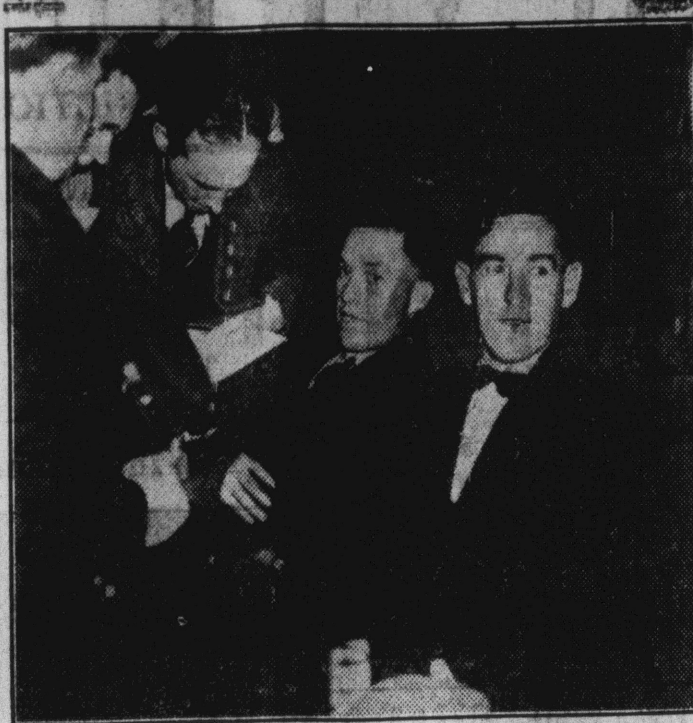

INFLATION—AND YOUR DOLLAR

By J. E. BRACKETT
New York. (AP)—Inflation and deflation accomplish the same result if carried through to the theoretical ultimate—the destruction of values. Therein lies the danger.

But seldom has either gone to this extreme. The course of the depression has illustrated deflation, as, in the case of the farmer who has lost his farm through foreclosure.

How the Opposites Work
Deflation destroys money, while inflation creates it. Deflation increases the purchasing power of those who have money, but reduces the number of people who have money; inflation lowers the purchasing power of money but gives it to more people.

Complete deflation would turn all credit into hard cash. Since there is about \$4,250,000,000 of gold in the country, this would mean, if carried to the theoretical extreme, that all of the \$35,000,000,000 bank deposits and the billions in securities would be reduced to gold, the basic money.

Inflation attempts to turn hard cash into credit and credit into more credit. Carried to the theoretical extreme, this would make all money valueless because there would be too much of it.

Germany's inflation represents such an extreme case; billions of marks literally came worth less than the paper they were printed on. In 1929 America inflated credit in a similar way, but not to such an extreme.

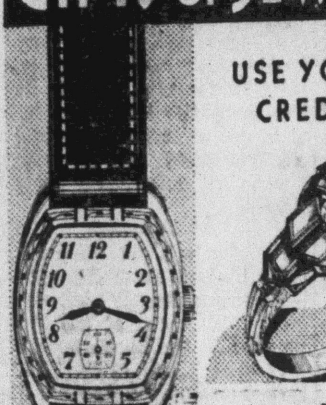

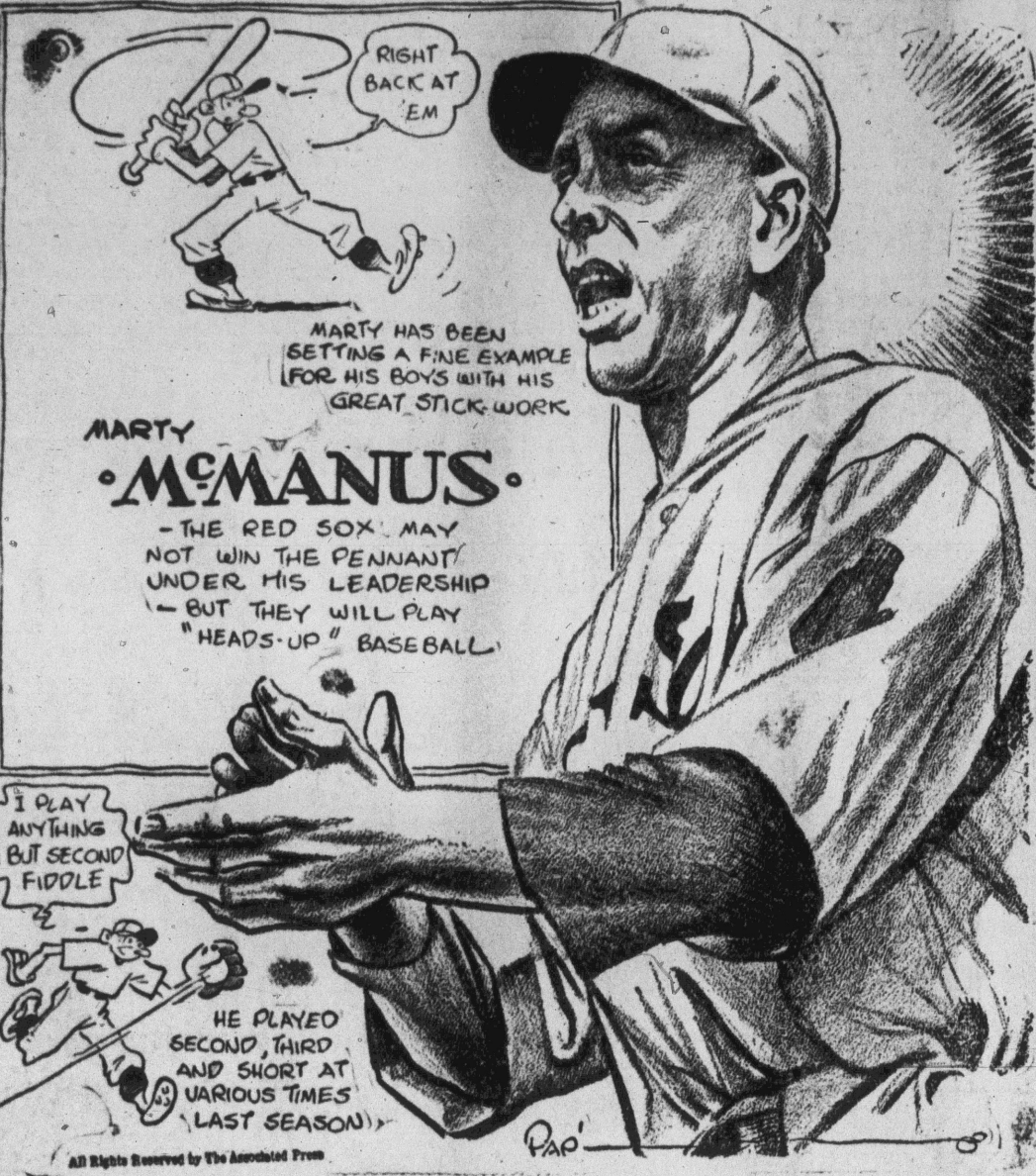

President's Own Pool Ready Soon

Washington, D. C.—(AP)—Early some morning around June 1 President Roosevelt will take his first plunge in the new swimming pool being built in the west wing of the White House.

As he swims the length of the 52-foot pool in his powerful crawl stroke he will be taking the first genuine exercise he has had since he has been in the Executive Mansion.

Overlooked Lawns.
Through the arched windows on either side he will be able to see the sunny expanses of the White House lawns. He can slip into his swimming suit in one of the two dressing-rooms that have been built at the east end of the pool, adjoining the White House porch.

Swimming, which played a major part in his battle to overcome the effects of infantile paralysis, has remained a delightful pastime for him. Visitors to his cottage at Warm Springs, Ga., saw him daily laughing, splashing and playing ball in the water with the young patients at the foundation he sponsors.

When he arrived at the White House it seemed as though he would have to give up this sport which keeps him fit for his long working hours.

First White House Pool

No other President had had a swimming pool. President Coolidge took his exercise on an electric "horse." President Harding preferred a foursome at golf. President Taft liked to walk so well that a bridge he admired on his favorite stroll through the city has been named for him. President Hoover's "medicine ball cabinet" met for games on the White House lawn.

Then a New York newspaper publisher opened a campaign for funds to build a pool for President Roosevelt. Some forty other papers took it up, and in a short time the necessary funds were subscribed. Checks kept pouring into the White House and secretaries were kept busy returning those that arrived too late.

Now work is being rushed on the pool under the direction of Major D. T. Gillette, of the public building and grounds department.

The pool will be simple but beautiful, not only in construction but because of the setting. Glazed terra cotta in aquamarine will line the pool and pale green terra cotta will be used for a six foot watercut. The arched ceiling will be finished with an ivory-colored, moisture-proof plaster.

Water May Be Heated.

Washington, May 11.—(AP)—Coston, B. Means, testifying in his own defense in the ransom conspiracy trial today, said in District of Columbia Supreme Court that he knew who kidnapped the Lindbergh baby, how child was killed and who got \$50,000 John F. Condon paid the ransom for the infant.

Means, former justice department agent on trial with Norman Whitaker on a charge of attempting to defraud Mrs. Evelyn McLean of \$25,000, to use as ransom.

Means said he believed a man named Irving Fenton and possibly another named Wellington Henderson had an important part in abducting the child of Col. Lindbergh.

He testified after Justice O'Donoghue had overruled the defense motion seeking a directed verdict in favor of the defendant, and to strike out testimony of various prosecution witnesses.

Means said Henderson head of the Third International in this country and president of communism in Detroit. He said he met him when the latter met a friend of Means at Atlanta. He said Fenton had asked him to go in with him on the kidnapping but he declined.

Rush Relief Program
Washington, D. C., May 11.—(AP)—House and Senate hurried forward today with more of the Roosevelt program so the big farm relief and inflation bill had to await the return tomorrow of Speaker Rainey before it could be sent to the White House. For the second day Representative Bulwinkle, of North Carolina was designated acting Speaker during the absence of Rainey, who is in Columbia waiting good weather to come to Washington.

SPORT SLANTS

After reading a particularly juicy account of the stop-off of Big Bill Tilden's tennis troupe in Sioux Falls, South Dakota, where the veteran was handed a three-set trimming by the youthful Texan, Bruce Barnes, I am inclined to agree with Jay Vesels, who relays the yarn, that Big Bill still is the master showman of the courts.

I do not suspect that Tilden would "throw" a match for the sake of the "rate" or any other consideration. He is too much the tennis artist and has the winning spirit too firmly imbedded to let himself down in that fashion.

He has dominated his own troupe by sheer ability, not by methods well known to the traveling wrestlers; yet if he happened to have an off night or found himself losing control of a situation on the courts, it would be well within his dramatic powers to make the most of it.

Next Week "East Lynne"
Whether or not this supposition is correct—and who can say as to that, except Big Bill himself?—here is Jim Ashley's interesting eye-witness account, written for the Sioux Falls Argus Leader:

"Barnes, substituting in the feature singles match for Hans Nusslein, gave his superior a whipping and Tilden, irked to unrestrained peevishness by line decisions and other incidents, didn't like it. The crowd most plainly did like it.

"At the finish Tilden was in his stocking feet and the fans were yelling for Barnes to beat the socks off him. Why Barnes could beat his tennis master on this occasion is of no more importance than the result, although some observers may have wondered if it wasn't because a pretty girl was holding his spare racket on the side-lines.

"The memorable point is that Sioux Falls saw Tilden striving desperately to avert defeat; witnessed a real tennis battle instead of a sham and was treated to spectacular and thrilling play, albeit the star performer was not at his best.

"Big Bill has earned something of a reputation on the stage as well as playing the hero role in many ten-act dramas, but none in attendance suspect that he was calling upon his Thespian talents to put on a show last night.

"Tilden's role was not one he would choose. He complained of poor decisions by linesmen; protested loudly to Barnes for not giving him time to get set for his second service ball; once lost such control of himself that his precise diction became en-
