## AMERICANS ADVISED TO EVACUATE TUNGCHOW

### HIGH SCHOOL WILL CLOSE HERE TONIGHT

**Dr. Elbert Russell of Duke Delivers Sermon to Graduating Class**

Making a tremendous appeal for the application of truth in human relations, Dr. Elbert Russell, of Durham, dean of the School of Religion at Duke University, delivered the commencement sermon to the graduating class of Greenville High School last night in the High School auditorium.

The speaker asserted "international lying" had produced a world of anarchy throughout the world and that the only remedy for the situation was the building up of public confidence through a clearer understanding of the spiritual values of life as enunciated by Christ during His momentous visit to the earth nearly two thousand years ago.

The sermon was heard by a congregation that taxed the building almost to capacity. All churches of the city abandoned their usual Sunday evening services to permit worshippers to hear the final sermon, and this boosted attendance to no little extent.

High School commencement will close tonight with graduating exercises in the campus building of East Carolina Teachers College when 60-odd young people will receive diplomas signifying their completion of the prescribed course of study of the public school system. The class this year is somewhat smaller than the past four or five years due largely to the shortened school term but it compares favorably with some of the larger schools of the State with greater facilities than those here.

There will be no commencement speaker. The exercises will be marked by a program by the department of music showing what has been achieved in this field of endeavor during the last year. Some of the youngsters who won high honors at the State-wide music contest at Greensboro several weeks ago will have a part in the program which is expected to be one of the most impressive ever put on by the school.

Class Day exercises were held at Third Street School club-house this morning at 11 o'clock. This was followed by a picnic on the athletic field described recently as one of the best of the kind in this part of the State.

Finals season opened last Friday with awarding of certificates of graduation to pupils of intermediate schools and the High School senior play that night.

The service last night consisted of the professional by the High School orchestra; hymn, "Onward Christian Soldiers"; invocation by Rev. W. S. Harden, pastor of the Presbyterian Church; responsive reading conducted by J. H. Rose, superintendent of schools; solo, "Out of the Deep," by James Savage; Scripture reading, Rev. W. S. Harden; musical number, "Faith, Hope and Love," by Misses Carolyn Hamric, Martha Scoville and Helen Sawyer.

After the sermon the High School mixed chorus, directed by Miss Ona Shindler, director of public school music, and accompanied by Miss Eva Hodges, of the music department, rendered "The Singers." The presentation gave the large crowd some idea of the development of mass singing in the public schools.

Dr. Russell took his text from the 32nd verse of the 8th chapter of John: "Ye shall know the truth and the truth shall make you free."

He said the physical freedom sought by the Jews was not what Jesus meant when he spoke the great truth concerning human freedom. He said no man is free that is a slave of sin, superstition, fear and unbelief. The Jews had sold their independence to the Romans and had forfeited their national unity.

Dr. Russell said Jesus really meant the truth by which men must live.

### MRS. SPILMAN WILL RUN FOR STATE SENATE

**First Woman to Seek Legislative Post In Pitt To Be Candidate Next Year**

With the State Legislature closing today, the political pot for the next State primary commenced putting on steam with news that for the first time in history a woman would be a candidate for the State Senate from Pitt County.

She is Mrs. J. B. Spilman, who for years has been prominent in activities of the Democratic party in this county.

It had been rumored for some time that Mrs. Spilman would be a candidate for the important legislative post in the election next year, and she verified the rumor today when asked if the reports were true.

She stated it was her present intention to seek the senatorial post and that official announcement of the fact would be made in due time.

Mrs. Spilman has been connected with East Carolina Teachers College here for a number of years. She has been active among women in the political life of the county and State for some time. During the last campaign in this county she headed the women's organization, and it was largely through her untiring effort that the women helped the county pile up the greatest Democratic majority in history.

In addition to her political activities, Mrs. Spilman is active in church and civic organization work throughout the county. Hardly a week passes that she is not called upon to speak before some woman's organization in some part of the county.

Although the election is too far away to predict its outcome, the hundreds of friends and admirers of Mrs. Spilman displayed much interest in news of her intention to seek the senatorial seat and predicted she would be the recipient of a tremendous vote.

### MOTHER'S DAY IS OBSERVED

**City Joins Remainder Of Nation in Paying Tribute to Its Mothers**

The tremendous influence which mothers play in the life of the world was acclaimed from thousands of pulpits of the nation yesterday, it being the annual observance of Mothers' Day.

Greenville joined the remainder of the country in celebrating the occasion and all churches of the city turned their morning services over to the paying of tributes to the sublimated creature of every household.

In song and sermon mothers, living and dead, were lauded for what they have accomplished and are still accomplishing to keep the world on an even keel.

Special musical programs tending to show the depths of a mother's love and devotion to her children, her sacrifices and unremitting toil in behalf of humanity, were provided by virtually all of the churches of the city and these formed a fitting prelude to the special sermons prepared by the ministers.

Christian motherhood was the theme of the majority of speakers as they attempted to impress upon living mothers the paramount importance of living close to God and the implanting of His teachings in the hearts of their children.

### PUBLIC ENEMY PUT TO DEATH

**Rocco Belcastro Slain By Gunmen In the Loop Area Last Night**

Chicago, Ill., May 15.—(AP)—Rocco Belcastro, "public enemy" and brother of Chicago's "king of bombers," was found slain today in an automobile with a bullet sack tied over his head and shoulders.

The automobile, a new sedan, without a license plate, was parked on Carroll Street near the Loop. The body was sunk in the tonneau.

Police said it might have been there for hours without being noticed. Police officials said they identified the victim as a brother of James Belcastro, reputed "boss bomber" of gangsters. James Belcastro has long been on record as a public enemy.

The body in the automobile had been found partly wrapped in a burlap bag and covered with a blanket. Medical investigators said Belcastro apparently was killed by gunmen enemies while bound.

### NEW RACING BILL PASSED

**Pari-mutuel Measure Rushed Through Final Legislature Session Today**

Raleigh, N. C., May 15.—(AP)—Under suspension of rules, the Senate today passed and rushed to the House in the closing minutes of the 933 session bill to allow voters in New Hanover and Haywood counties to decide whether or not pari-mutuel betting on horse racing would be legalized in those localities.

Today in the Legislature, Raleigh, May 15.—(AP)—North Carolina's 1933 General Assembly worked on the afternoon to try and adjourn sine die in late hours of the day but the legislative clocks recorded the hour as 12 noon, May 15th.

A last minute rush of new bills and disagreement over supplementary measures held the lawmakers in session long after the agreed hour of adjournment at noon.

Under legislative custom, however, the clocks in both halls came to a stop at exactly noon and the journals will record that the 132-day session closed at noon today.

The 1933 legislature sat for a longer period than any other in the state's history except the 147 day meeting of 1931.

The Senate this morning completed action on the biennial school machinery act and ordered it enrolled for ratification. Final vote on the compromise which allows certain local units to vote supplements to add a ninth month to the state eight months term was 37-0.

Both divisions got numerous new local bills and passed them under suspension of rules. The flood tied up the enrolling office and it took several hours to prepare them for ratification.

### COURT RULES CASE AGAINST CANNON VALID

**Court of Appeals Upholds Indictment Against Churchman And Secretary**

Washington, D. C., May 15.—(AP)—Trial of Bishop James Cannon on a charge of violation of the corrupt practices act in 1928 seemed certain today with a ruling by the District of Columbia Court of Appeals that the indictment against the churchman was valid.

The Court of Appeals also upheld the indictment against Miss Ada Burroughs, Bishop Cannon's former secretary.

The churchman was indicted by a grand jury but later the District of Columbia Supreme Court sustained a demurrer. The ruling today reversed the decision.

The case previously had gone to the high court on the claim that the Court of Appeals lacked jurisdiction to hear the government appeal from the District of Columbia Supreme Court.

The decision quashed the indictment. The Supreme Court, however, upheld the Court of Appeals.

The case against the churchman grew out of his activities against Alfred E. Smith during the 1928 election.

### LONDON UPSET OVER GERMANY

**Claim of Pending War Clouds Causes Sensation In the British Area**

London, May 15.—(AP)—Efforts were made in Downing Street today to calm the sensation created by press reports over the week-end concerning a general European crisis.

It was stated that no anxiety was felt in official circles regarding week-end developments.

Several morning newspapers spoke of the increased tension in Europe and discussed what they interpreted as gathering war clouds in Germany.

The Daily Times commented on what it termed "inculcation of hatred of foreigners and of militarism in the Hitler regime" and called upon any to disprove, if possible, to disprove that one of the main objects of Hitlerism is to prepare for a war of revenge.

### REDFERN BODY FOUND IN RIVER

**Aviator Lost On Brazil Non-stop Flight Suicide In New York**

Rochester, N. C., May 15.—(AP)—Discovered floating downstream by fishermen, the body of Richard Redfern, aviator who was lost in an American-Brazil non-stop flight in 1927, was recovered from the Venness River today.

His body had been sought since April 24, when a man was seen to have plunged from the Veterans' Memorial Bridge. Redfern's car was found parked near the bridge, and when his brother, Edwin Redfern, received a note, he said there was no doubt as to the suicide's identity.

Identification was made by personal articles on the body and a note addressed to Edwin, which read: "Dear Ed—Take care."

His brother ascribed the suicide to financial worries.

New York, May 15.—Ernest Torrence, veteran screen actor, died today at the age of 54 years.

The noted portrayer of character roles succumbed at dawn at the Lenox Hill Hospital when he failed to rally after an operation for gall bladder trouble. For hours physicians had known that death was inevitable.

### DEFER PHONE RATE HEARING

**Illness of Counsel Causes Commission To Delay Hearing In This State**

Raleigh, N. C., May 15.—(AP)—The State Corporation Commission today granted the Southern Bell Telephone and Telegraph Company a "temporarily indefinite" postponement of its hearing when the serious illness of his brother made it impossible for E. B. Smith, of Atlanta, general counsel of the company, to complete plans for the hearing.

The Southern Bell Company and all other companies operating in North Carolina are to appear before the commission for conferences in regard to possible rate reduction for the State.

### TAKES CRACK AT SALES TAX

**Judson Blount Declares He Is Unalterably Opposed To Legislation**

The sales tax passed by the North Carolina Legislature was described today as "an increased burden to the little man" by Judson Blount, former president of the North Carolina Merchants Association, and long opponent of this form of taxation.

In a statement handed The Reflector today Mr. Blount praised the paper's opposition to the tax and declared it had rendered an outstanding service to the people.

The statement follows: "Although the sales tax has finally been enacted and is now written on our statute books, I want to say once more that I still feel as I have always felt about it, and that I am eternally opposed to it, because I believe in all sincerity that it is wrong in principle. As you know, it contrasts, when finally it was passed by both branches of the Legislature, a mandatory clause, whereby the merchant is compelled to pass it on to the consumer. This, as has been said thousands of times, but is as true today as when first it was said, puts the burden of the tax on the class of people in our State who are least able to bear it. It is a great tragedy that our State Legislature should have been in session nearly five months, and that one of the major pieces of legislation enacted should be one that increases the burden of the little man, and makes life a little more difficult for him. But it is now a law of our State and however, we may have felt in the past, we are loyal and law-abiding citizens of our State and I feel sure that if we will co-operate, we shall yet be able to find a way out.

"I have wanted a long time to commend the editor of the paper for the splendid stand which he has taken on the sales tax, and I am glad through this session of the Legislature, he has consistently and courageously defended the best interests of the people of this community. He has endeavored to know the mind of his people and then he has used every resource at his command to further their interest, keeping ever before our Representatives in Raleigh the wishes and needs of the folks back home. He has rendered the people of this section of the State a very real service and I am confident that they deeply appreciate it.

"I think we may be justly proud likewise of the record of our Representatives while in Raleigh. However things may have turned out, the Representatives from Pitt County tried always to let their voices be heard on the right side.

"Again let me say that though we fought it and still believe it to be an iniquitous act, it is nevertheless, in spite of all our efforts, a law of our State and we shall with your help and co-operation handle it to the very best of our ability."

### CHINESE ARE MOVING OUT OF TANGSHAN

**Japanese Fliers Bomb British Center As Chinese Troops Attempt to Scramble Out of Trenches; Japanese Ultimatum Demands Evacuation of Tientsin and Other Important Centers of District**

Peiping, May 15.—(AP)—The United States legation advised Americans today to evacuate Tungchow, thirteen miles east of Peiping, because of a rumor that Japanese would occupy that town.

The American community at Chintung consists of 30 missionaries belong to the American Board of Missions.

Tientsin, May 15.—(AP)—Evacuation of Tangshan, headquarters of the British Kailan Mountain interests, was begun today by Chinese forces after Japanese fliers had attacked the town and bombed the Chinese cement works and cotton mills.

Anti-aircraft guns went into action, but fliers maintained sufficient altitude to prevent being hit. It was believed there had been few casualties by property damage was heavy. The bombers returned for a second raid and re-opened on a line on Chinese forces scrambling out of trenches a mile outside the city.

Two bombs were dropped in the garden at the residence of the British chief engineer at the Kailan Mountain administration. Previously the Chinese had evacuated Lwanchow, chief city on the right bank of the Ling River east of the mining center.

Meanwhile, there was an unconfirmed report that Japanese authorities had issued an ultimatum demanding the evacuation of the Tientsin area, but also of Tangku at the mouth of the Pai River on the seacoast 35 miles east of here.

### Macon Off On New Test Trip

Akron, O., May 15.—(AP)—The United States Macon, the new navy Zeppelin, started on her third test flight today.

She was to fly twelve hours, but as usual, Capt. A. H. Drexel withheld information as to her itinerary.

## FARM NOTES

Hog Cholera Control Campaign. The hog cholera control campaign will be completed this week. Last week 736 hogs were vaccinated for \$5 farmers. Practically all of the breeding stock of the county has been immunized against cholera, thereby eliminating the necessity of re-vaccinating annually.

Market House. Special prices will be offered this week on carrots, radishes, beets, strawberries and cream at the market house.

The sellers on the market regret very much that the rain last Friday added to the inconvenience of the customers on the market due to the delay that recent work on the driveway and walk had not been completed. This work will be completed this week and, it is hoped, will add greatly to the convenience of those who trade at the market.

## Market Gardens.

Frequent plantings in the market gardens are necessary in order that the growers may have young, tender vegetables to offer at all times to the buyers of the market. Such crops as snap beans, butter beans and tomatoes should be planted at least every two weeks and in some instances, every week. The amount that is planted each time depends somewhat on the amount needed by the farm family and the surplus they are able to sell on market days.

## Poultry

Both laying hens and growing chicks should have plenty of green stuff and at this season of the year some animal protein. Chicks that are allowed the range of the farm do not need as much animal protein as those that are kept confined and the protein needed may be supplied by scrap meat from the kitchen or from fish meal. At least 20 per cent of the rations should be from some source of animal protein.

## FARM NOTES

Hog Cholera Control Campaign. The hog cholera control campaign will be completed this week. Last week 736 hogs were vaccinated for \$5 farmers. Practically all of the breeding stock of the county has been immunized against cholera, thereby eliminating the necessity of re-vaccinating annually.

Market House. Special prices will be offered this week on carrots, radishes, beets, strawberries and cream at the market house.

The sellers on the market regret very much that the rain last Friday added to the inconvenience of the customers on the market due to the delay that recent work on the driveway and walk had not been completed. This work will be completed this week and, it is hoped, will add greatly to the convenience of those who trade at the market.

## Market Gardens.

Frequent plantings in the market gardens are necessary in order that the growers may have young, tender vegetables to offer at all times to the buyers of the market. Such crops as snap beans, butter beans and tomatoes should be planted at least every two weeks and in some instances, every week. The amount that is planted each time depends somewhat on the amount needed by the farm family and the surplus they are able to sell on market days.

## Poultry

Both laying hens and growing chicks should have plenty of green stuff and at this season of the year some animal protein. Chicks that are allowed the range of the farm do not need as much animal protein as those that are kept confined and the protein needed may be supplied by scrap meat from the kitchen or from fish meal. At least 20 per cent of the rations should be from some source of animal protein.

The film shows depression hitting high and low in the ranks of an honored and long-lived department store headed by Lewis Stone. ence is an excellent example of the "system" on capitol hill.

The Mississippi has risen to the heights in the House before a quiver twist in the politics of his state deprived him of his seat last year. He had become chairman of the most powerful committee in the House, that of ways and means, before going out.

Yet, when he visited the capitol for the first time in 1929, as a member of Congress, a doorman refused to let him in because he didn't know him.

Collier's climb to the pinnacle of House committee assignments is an interesting story. He became a member of Congress in the days when "Uncle Joe" Cannon ruled the House as a czar.

Young and ambitious, committed, as he says, to many reforms promised in his pre-election speeches, Collier wanted a place on just two committees—agriculture and rivers and harbors.

"Uncle Joe" gave him a berth on accounts and mileage.

"A more empty honor couldn't have been conferred on a member," he says. "It was perhaps the least important committee in the House; it was rarely, if ever, called in session, and has since been abolished."

But he took it, sure that "Uncle Joe" would remember him with a better assignment later on.

"Uncle Joe" did remember him later on. At the next session, he was promoted to the committee on industrial arts and exhibitions.

"This," says Collier, "was a step above the first by virtue of the fact that its sonorous and high-sounding title was absolutely second to none."

"It, too, was seldom called in session and was since been abolished. I was downhearted."

But he kept plugging. A fortunate incident gave him opportunity to make a name for himself as a member of industrial arts and exhibitions. He attracted attention.

Then came a place on ways and means that led him finally to the chairmanship of that powerful committee and subsequently played an important part in landing him on the tariff commission when the vicissitudes of politics left him without a job.
