U. S. MAKES KNOWN ITS STAND ON DISARMAMENT

Four Nations Favor Peace Plan

Mussolini's Ten Year Proposal Endorsed By Three Other Countries

COVENANT OF THE LEAGUE IS FOLLOWED

Preamble to Pact Endorsed by Britain, France, Germany and Italy Based on League of Nations; Solution of Problem Not to be Imposed on Any Smaller Nation

Rome, May 22—(AP)—Britain, France, Germany and Italy have joined into line in support of Benito Mussolini's plan for maintenance of European peace for ten years untrammelled by desires of any other nation.

Informal agreement to a revision of the pre-war pact proposed by the premier in March was given yesterday by the four nations.

Its main points: Collaboration among the four powers to preserve peace for ten years without intention to impose any solution upon any smaller nation.

The statement that post-war treaties revision is a possibility but only under Article 16 of the covenant of the League of Nations.

The mention of disarmament as a desirable necessity without specific recommendations.

Agreement to abide by articles of the past protection territorial integrity and independent collective members against external revision.

The preamble to the pact is based on the League of Nations covenant which granted Germany arms equality after serious misunderstanding in the disarmament conference. The league covenant was mentioned in the form of the original pact.

MAKE HEALTH SURVEY OF INDIANS

Sanatorium, May 22—The extension department of the North Carolina Sanatorium will co-operate with the United States Public Health Service and the State Board of Health in a health survey of the 2,300 Indians living in several western North Carolina counties according to plans announced here by Dr. P. P. McCain, superintendent of the sanatorium and director of the extension department, who has just returned from a visit to that section of the State, where he conferred with representatives of the other two groups.

Dr. Charles D. Thomas, of the sanatorium clinic staff, will leave this week to administer the tuberculin skin test to the Indians of Swain, Jackson, Cherokee and Graham counties.

YEARLY LEGISLATIVE SESSIONS PREDICTED

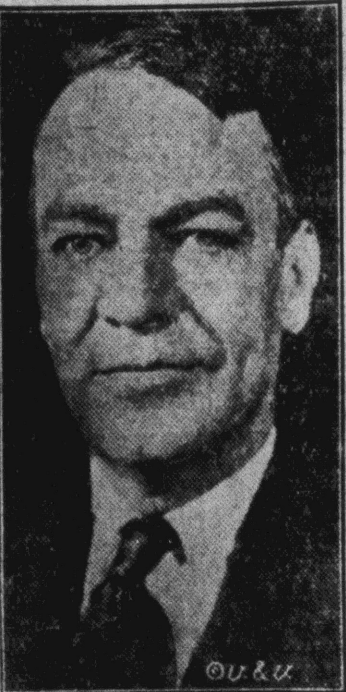
Durham, May 22—(AP)—The increased duties which face each biennial meeting of the North Carolina General Assembly probably will lead to annual meetings within a few years, says R. O. Everett, Durham attorney and a member of the 1933 House of Representatives.

Mr. Everett points to the 132-day session as evidence of the fact that yearly terms will be needed to keep up with the State's business. He said press of business caused the past session to extend to far beyond the 60-day required term.

WILL ASSIST IN DEBT PLAN

Farm Department to Aid Farmers in Government Refinancing Legislation

(By E. F. ARNOLD, County Agent)

As announced through the press sometime ago, I plan to be in my office on Saturdays and Mondays for the purpose of assisting farmers in taking advantage of the Farm Debt Refinancing Program, which was enacted by the passage of the Farm Relief Bill. The act provides for relief to farmers whose mortgages are held by the Federal Land Bank, Joint Stock Land Banks, Insurance Companies and private individuals.

According to press reports more than four thousand farmers have already applied for relief through this office.

Due to the large number of applications flowing in, those who have already been foreclosed or who are subject to foreclosure should get their applications in as soon as possible. I am advised by the department that this class of loans will receive first consideration.

The declared purpose of the new Farm Relief Act is to increase the purchasing power of the farmers. The act provides several means by which this may be accomplished.

First, the Secretary of Agriculture may arrange with individual farmers to reduce their acreage or production by a specific amount and to compensate them either by paying rentals or by making direct benefit payments. This would be immediate relief with only participating farmers receiving benefits.

Second, he may secure the desired results by entering into marketing agreements with processors and others to reduce wasteful and price-depressing competition, excessive handling charges, and so on, thereby bringing better prices to the farmers.

Third, cotton growers who reduce their acreage at least 30 percent can be given an option contract for an equivalent amount of cotton from stocks now owned by the federal government. If a rise in cotton prices should result from this the grower may have his option cotton sold and take the proceeds and in no case would the grower be liable. (Continued on page five)

FOUR GUESTS FILL PULPITS CITY CHURCHES

Impressive Services Held in Various Churches of Greenville Sunday

Four guest speakers occupied the pulpits of Greenville churches yesterday and services were of an unusually impressive and inspirational nature.

Nathan C. Brooks, Jr., ministerial student at Louisville, Ky., delivered two sermons before the congregation of Memorial Baptist Church yesterday morning and last night, taking the place of Rev. A. W. Fleischmann, who is attending the Southern Baptist Convention at Washington City.

Mr. Brooks, who filled the local pulpit for two months last summer while Mr. Fleischmann was in a California hospital for treatment, spoke on the subject of "Opportunities," taking his text from the 11th verse of the 28th chapter of Samuel, "Bring me up Samuel."

He used the despairing words of King Saul after he had forsaken Samuel, the "tower of God, and who in extremity at last appealed to a witch to help restore some of the security which he felt when Samuel was at his side.

The speaker referred to the disarmament conference now in progress at Geneva and expressed the hope that America would take some action to blot out war forever, despite the fact that the nation held aloof in the first conference year ago looking to peace for all nations.

He referred to the present attempt to repeal the national prohibition law, warning his hearers not to lose the opportunity of supporting this moral issue for which the church had been battling for many years.

He concluded by calling attention of the congregation to the opportunity for serving God in a local way as well as in a national and international way, and urged that the teachings of Christ be given due attention during one of the most complex eras the world has ever known.

Rev. Ford Burns of Farmville, speaking at Immanuel Baptist Church yesterday morning, urged his congregation to look forward and to stop giving so much time to consideration of things of the past. He urged them to put God first and to see that He is placed ahead of everything else.

At St. Paul's Episcopal Church, Rev. J. Q. Beckwith, Jr., of Farmville, spoke on the subject of "Prayer." He told of the tremendous influence of prayer in the life of Christian men and women and appealed to his hearers to give more attention to this important matter if they would reach that height of Christian achievement sought by every earnest heart.

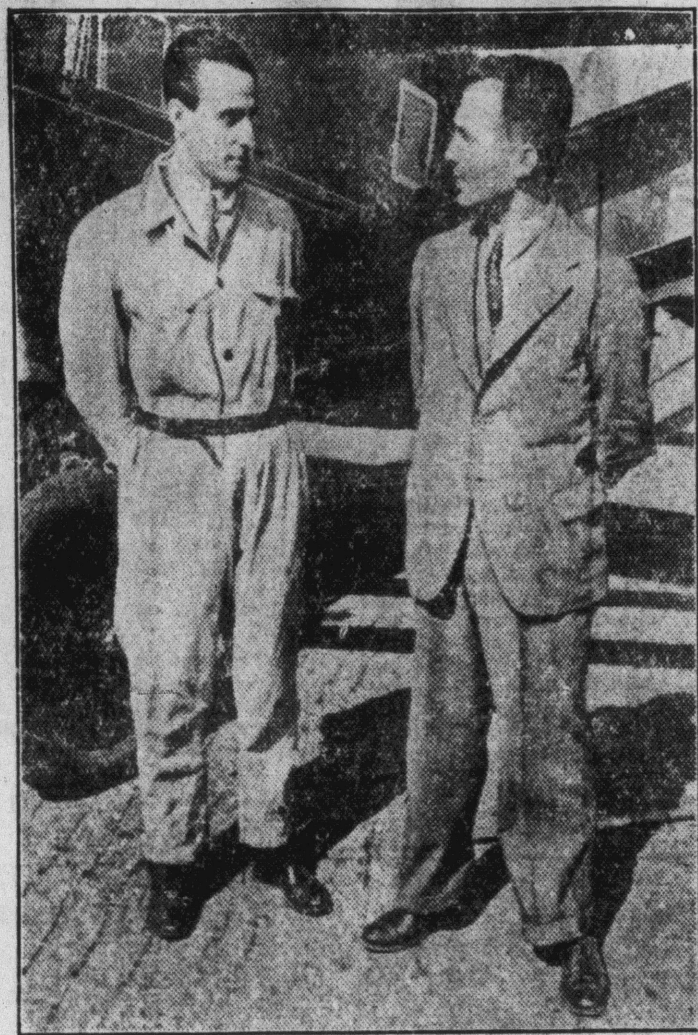

THREE HELD FOR LARCENY

White Youths Remanded to Jail in Hearing on Bicycle Theft Here

Late News Flashes

Approve Higher Taxes. Washington, May 22—(AP)—On a quick 13 to 9 vote the House ways and means committee today approved a program increasing income and gas taxes and making corporate dividends subject to income rates. Revised to finance the \$3,300,000,000 public works-employment bond issue it would lift the normal income rate from 4 to 6 percent on incomes of \$4,000 not and less, and from 8 to 10 percent on all above \$4,000—estimated to yield \$46,000,000; subject dividends from corporate stocks to income tax rate estimated to yield \$83,000,000, and levy an additional tax of 3-4 of one cent on a gallon of gas to bring in a \$92,000,000 for a total of \$221,000,000.

CHILD DROWNS AT RIVER CAMP

Nine-Year Old Child Of Sterling Gates, of Farmville, Drowns In Neuse

Lee Sanders, 9-year-old daughter of Mrs. and Mrs. Sterling Gates, of Farmville, was drowned yesterday while swimming in the Neuse river at Cherry Point camp, according to information reaching the city today.

Funeral services were conducted from her parents' home in Farmville this afternoon at 4 o'clock, by Rev. L. R. Ennis, pastor Farmville Baptist Church, and burial was made in the cemetery there. Surviving are the parents and two other children.

The child was reported to have been playing around in shallow water when she suddenly stepped into a deep hole and was drowned before aid could reach her. The body was recovered shortly afterward.

The family had been spending a week at the camp when the accident occurred. Cherry Point is about half way between New Bern and Morehead City.

First Sawmill Built in 1625

Raleigh, N. C.—(AP)—Extension Professor H. W. Graeber of North Carolina State College says the first sawmill operated in the United States was built at South Berwick, Maine, in 1625.

In deciding upon the program the committee rejected the proposed general manufacturers' excise tax which was estimated to net \$228,000,000.

FLOOD SWEEPS TWO STATES

Crumbling Levees in Arkansas and Missouri Cause Grave Concern Today

Memphis, May 22—(AP)—A sea of muddy water swept over flood-stricken northeast Arkansas and the southeast Missouri border today driving farm families and animals before it and drowning out crops that were planted behind the perilous protection of soggy levees.

The water came down in a sheet from a collapse of the St. Francis levy system near Berk, Arkansas, yesterday and covered about 50,000 acres.

Late yesterday there were at least 14 places through which the river cut widening gaps. Some of the holes were 250 feet wide. The Big Slough ditch levy at Paragould also broke in several places.

WATCH EFFECT DAVIS SPEECH

President Roosevelt And Associates Await Reaction At Arms Conference

Washington, May 22—(AP)—President Roosevelt and his associates on the vital arms question awaited with eagerness today the international reaction to the American position made known by Norman H. Davis in an address today before the arms conference at Geneva.

A copy of his address setting forth the American agreement not only to consult with other states upon a threat of war but also to refrain from any action tending to defeat collective effort against violators of peace provided the United States agrees to such a recourse was made public today by the State Department when Davis began to speak at Geneva.

DR. CURRAN SPEAKS HERE

President of International Truth Society Addresses Gathering Here

Dr. Edward Lodge Curran, member of the New York Bar and president of the International Catholic Truth Society, spoke at the court house here last night. He will speak here again tonight and tomorrow night at 8 o'clock.

His subject last night was "God and Myself." He said in part: "For the past fifteen years the world has been breaking the first commandment of Almighty God. It has refused to listen to the voice of God. It has listened eagerly and enthusiastically to the voice of false economic prophets. Until recently economics had become a veritable religion in America. The worship of gold instead of God the Father, the worship of credit instead of God the Son, and the worship of success instead of God the Holy Ghost, alone, so the economists told us, would bring unbounded happiness to America.

"Today we know after sad experience that our economic and political gods have duped us. The great economists, who refused to consider God in their prophecies of American prosperity, either foresaw our present economic failure or not. If they foresaw it and failed to warn us, then every one of them should be incarcerated in our Federal prison. (Continued on page five)

CIVIL COURT SITTING HERE

Two-Week Term Convened Today With Judge Grady Presiding

A two-week term of civil Superior court convened in Greenville this morning with Judge Henry A. Grady, of Clinton, presiding. The calendar completed the first of last week contains about forty cases for each week and it was hoped the majority would be disposed of.

Two dozen or more cases were cleared from the docket week before last and several times that number at a previous session, but the present session had plenty of work ahead and the week was expected to be a very busy one.

This will be the last sitting of Superior court until the criminal term in August the scores of important cases were expected to receive consideration.

Because of the disinclination of litigants to push their cases, Judge Grady at a previous session ordered that numbers of actions be not proceed.

Last year nearly two hundred cases were taken from the calendar for the same cause.

TARIFF BILL ABOUT READY

Sec. Hull Expects New Administration Measure to Get Rapid Action

Washington, May 22—(AP)—The Roosevelt bill authorizing reciprocal tariff concessions was practically ready today for submission to congress and Secretary Hull expects it to go forward before long.

Coinciding with this country's latest effort toward world disarmament and economic harmony as represented in the speech of Norman H. Davis at Geneva, the secretary of state prepared to go into a final conference with the president on the tariff legislation. Meanwhile, it appeared definite that Rep. M. Reynolds of Tennessee—chairman of the foreign affairs committee, will be named to the London economic conference delegation with J. Hull, James Cox, of Ohio and Chairman Pittman, of the foreign relations committee.

WILL CONSULT OTHER POWERS IF WAR LOOMS

Doctrine Viewed By League as Meaning That America Has Abandoned Traditional Policy of Isolation; Also Advocates System of Control Of Armaments; Urges Maintenance of Territory Status Quo

Geneva, May 22—(AP)—The United States through Norman H. Davis told the nations of the world today that she would consult them when peace is menaced and if she agrees with them as to the identity of the aggressors she will refrain from any action of a nature to hinder collective efforts to restore peace.

This doctrine, considered by League of Nations circles as an abandonment of America's traditional policy of isolation, was announced by Davis to the disarmament conference in an eagerly awaited message this afternoon.

The doctrine was taken to mean that when the nations take punitive measures against an aggressor that the United States if it agrees to the identity of the aggressor will not insist upon rights of neutrality.

Davis also announced that the United States advocated a system of control and supervision of armaments and said that American readiness to participate in a measure for this control would be effective automatically.

Intentionally opposing a brisk revision of the treaties the American ambassador at large urged the maintenance of the territory status quo.

He revealed that his country defines an aggressor as one whose armed forces are found upon foreign territory in violation of treaties.

He also announced that the United States is opposed to the rearmament of any nation and declared in favor of the abolition of arms. He reiterated American acceptance of Premier MacDonald's disarmament proposal.

Turning to the Versailles treaty, Davis expressed the conviction that there is a continual obligation for armed nations to reduce armaments to a defensive level which would be comparable to the level which the vanquished powers were obligated to reduce armaments by the peace treaties.

He offered President Roosevelt's proposal for an international agreement to prevent sending armed forces outside national territory and then gave the definition of an aggressor agent as in line with the proposal.

LUMBER COMPANY IS NAMED IN \$15,000 SUIT

Kinston, May 22—The Hines Bros. Lumber Company and the city of Kinston are defendants in a \$15,000 suit to be tried in Superior Court here tomorrow. George Jones, plaintiff, asserts his four-year-old son, Julian, was fatally injured by a falling sill on the Hines company's yard in 1931. He alleges the municipality was negligent in having allowed a walkway through the yard to be blocked.

TO RECEIVE CHECKS FROM CLOSED BANKS

High Point, May 22—Dividend checks totaling \$807,832, covering a dividend of 15 percent to depositors, will be distributed within the next few days by John D. Biggs, receiver of the Commercial National Bank, which closed here 16 months ago. It is the first dividend that has been paid and is made possible through the Reconstruction Finance Corporation which a month ago approved a loan of \$517,000 for the bank here.

LOOKING UP

If the sale of new automobiles is any barometer of the business trend, things must be looking up in Greenville. According to a survey seventeen new automobiles were sold here during the past week, with a number of them being sold for spot cash. While the number may not sound large to some it is a great improvement over the past few months, and with the approach of the summer season no doubt last week was just the beginning of a definite trend upward for the automobile business here.

STOP CHILDREN FROM DRIVING CARS

With the vacation season at hand, the number of children driving automobiles here apparently is on the increase and certainly presents a problem that should have attention. To begin with, it is against the law for a child under sixteen years of age to be permitted to drive an automobile, but there are many below this age who may be seen driving on our streets almost any day. Despite the apparent capabilities of the child, the records show that in emergencies they do not think and act fast enough to avoid accidents that could be avoided by one of more mature judgment, and this is one of the reasons for our present state-law against the children drivers.

Everyone knows that it is against the law for children to drive automobiles and the parent who permits the child to drive is not only endangering the lives of others but is breeding within the child a spirit of disrespect for the law. Regardless of how capable you think your child is, we urge you as a parent not to let your child drive your automobile. If you do you are not only placing yourself liable for damages but you are aiding the child in breaking the law. The matter is a serious one and if the parents do not put a stop to it we urge the officers to do their duty by arresting every child under 16 years of age, regardless of whose child it is, who is seen driving an automobile on our city streets or the public highways.

POLITICS

By BYRON PRICE

The general feeling in Washington is that a strikingly favorable atmosphere for the London economic conference has been created by the White House conversations between President Roosevelt and the foreign statesmen who have been visiting him.

This opinion pervades not only the State Department, but many foreign officials in the diplomatic corps. A widespread belief is apparent that the United States at least has made a strong bid to regain the world leadership it exercised during the world war and lost after the peace negotiations began at Versailles.

It would be hard to overstate the degree of optimism of some of those closest to the President. They express privately a conviction that he will be able to get his international program through the London conference with the same facility which has marked enactment of his domestic program by Congress.

That, of course, remains to be seen. International diplomacy is full of pitfalls and the London conference in particular is beset by many difficulties. The important news fact just now is the confidence which has been built up beforehand by the talks taking place at the American capital.

On the basis of what the visitors from abroad have said privately to their own fellow-countrymen, there seems no question Mr. Roosevelt has made a good impression on his conferees.

One of the most distinguished Europeans was struck particularly by the President's freedom from the ordinary restraints of diplomacy. He has been speaking very plainly several very delicate subjects,

and he has surrounded the whole of the President, were made with discussion with an air of informality not seen in many years at the White House.

The hope in Washington is that this all will be reflected in an increased disposition at London to act, without too much debate or red tape.

There is the added hope that during their visit to the United States the foreign leaders may have got into their veins some of the germs of the changing American order, and from their first-hand contact may have carried home with them a conviction that the day has arrived for equally important changes in the world order.

Whether Mr. Roosevelt himself will go to London at some stage of the conference must remain for the present a matter of speculation.

It can be said authoritatively that he has no present plan for going, and that he made no promise on that subject to his foreign visitors. Plans for decking a fast cruiser at Annapolis near the capital, for use

of the President, were made with an entirely different purpose in mind.

It can be said also, however, that Mr. Roosevelt is a man accustomed to figuring his course as he goes along. He likes to base his next move on the other fellow's last move. It is not at all inconceivable that he might decide to go, should negotiations become deadlocked.

Whether he actually crosses the Atlantic or not, the President may be counted on to rank as the chief American negotiator at London. He means to keep the threads of the conference very closely in his own hands, and make every major decision himself.
