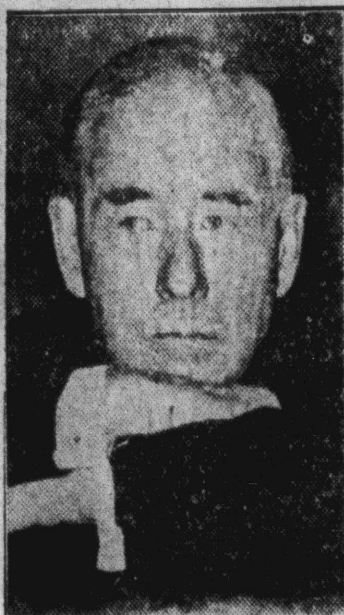
MAHATMA GANDHI ENDS THREE WEEKS OF FASTING

Indian Leader Takes A Sip Of Orange Juice And Sings Praise of God

CROWD VISITS HOUSE TO SEE FAST ENDED

Representatives of Many Castes Present As Leader of Untouchables is Removed From His Room and Placed in Hall; Says His Fate is Not Less But Greater as Result of Fasting; Sings Glory of God.

Poons, India, May 29—(AP)—"In God's name I began this fast and in God's name I end it," said Mahatma Gandhi today as he broke the three week voluntary abstinence from food in the untouchable's cause by sipping a glass of orange juice.

He began the fast at noon May 8. The end of the fast was as impressive as its beginning.

The Mahatma concluded his period of abstinence at 12:40 and thus he was wholly without food for three weeks and forty minutes.

Long before he broke the fast the relatives of Madame Saragani Naidu poet and lecturer, where he was cared for, was besieged by his friends of all castes—Hindoo, Mohammedans, Parsis and Europeans.

Madame Naidu stood at the top of the stairs reluctantly selecting those to be admitted.

None of the money could get them in the circle. Finally 150 men and women residents and a score of newspapermen were admitted into the big white hall.

Banks and Postoffice to Close Tomorrow; Graves of Dead Decorated

Memorial Day will be observed here tomorrow by the closing of banks and the post office, although no formal exercises had been planned for the day.

It was announced at the postoffice this morning that regular holiday hours would be observed but with the usual dispatch of mail to all sections of the country.

Members of the Pitt county post of the American Legion and its Auxiliary honored the World War dead yesterday by placing flowers on the graves of dead veterans buried in various sections of the county.

Not a single one was forgotten as the Legion went about paying tribute to the men who sacrificed their all in the mighty conflict overseas fifteen years ago.

Saturday the Auxiliary of the Legion conducted the annual sale of poppies, emblematic of Flanders Fields, and hundreds of people wore the tiny red flowers in honor of the men who fell during the terrific fighting with the German foe.

The poppies were made by disabled veterans in the various hospitals of the country and the money derived from the sales goes to making life just a little bit easier and more comfortable for them as they lie in hospital beds.

Prayers were offered for the dead in various public assemblies of the city yesterday, and the entire county was caused to remember the sacrifices made by American soldiers while defending civilization from a common enemy.

Late News Flashes

Spends \$6,500 For Lobbying. Raleigh, May 29—(AP)—The American Tobacco Company, one of North Carolina's largest industries, spent \$6,500 for lobbying activities during the session of the 1933 legislature, its New York office reported to Secretary of State Wade today. Of this amount \$6,000 went to the law firm of Brooks, Parker and Holderness of Greensboro, legislative representatives of the company, the balance representing hotel and other expenses here at Raleigh.

The North Carolina Bottlers' Association reported it had paid J. E. Long of Durham for representing it during the legislature. In addition to this amount \$128 was paid to Frank Johnson of Statesville, for expenses.

Expenses of \$1,128 was reported by the Duke Power Company of Charlotte, for legislative representation. W. L. Long of Roanoke Rapids, received \$750, the report showed, and \$376.80 was for expense of Norman Cooke of Charlotte, an official of the power company.

GOLD MEASURE SPEEDED UP IN BOTH HOUSES

Members of House Plan to Ride Down Small Band of Opposition; More Opposition Expected in Senate; Senate Committee Continues Hearing on Industrial Control and Taxation Measures

Washington, May 29—(AP)—Cancellation of obligations to pay in gold and legislation for economy engaged both houses of congress today.

The legislators went out at their task buoyantly, the majority determined to ride down all opposition in its order so the week can bring a clean up of pending legislation and open the road to adjournment June 10.

This date is President Roosevelt's aim. Many in congress talk of June 17 as more likely. Past performance would indicate adjournment July 4 but this session has not gone according to past performance any time.

The gold legislation void gold clause in government and private contracts, past and due; was taken up in the house and assured of overwhelming support.

Against it was arrayed a small band, mostly Republicans, which held fast against what they called repudiation by the government. Passage was not looked for until tomorrow as house leaders had decided to leave the bill open to amendments.

More opposition was waiting for it when it got to the senate. The senators selected to pass today the \$543,000,000 appropriations bill for independent offices with its veterans fund cut in half from the budget estimate and with great economy power for President Roosevelt. The usual amount of oratory against the measure was expected but was not credited with a chance to tie up proceedings.

The biggest bill now in congress the public works industrial control or taxation measure remains before the senate finance committee with more witnesses, commercial and industrial, given the floor to speak pro and con.

This will be the last sitting of court until next August when the regular term of criminal court will be held.

A new six-months grand jury will be selected at that time to take the place of the present jury which produced the most comprehensive reports on county affairs ever issued by a jury. The report covered virtually every phase of public life, and especially county finances and recommendations for improvement of school transportation service by replacement of many worn-out buses.

CHURCH BODY ENDS SESSION

Presbyterians at Montreat Adopt Resolutions in Final Session

Montreat, May 29.—(AP)—The Assembly of the Presbyterian church in the United States adopted several resolutions, most of them without discussion before adjourning its 73 session during the mid-morning. Dr. E. N. Thomson, of West Virginia, the moderator, overruled out of order a proposal to create a prominent committee on so-called moral problems. The assembly earlier in the session adopted a resolution to create such a committee but later reconsidered and rejected the proposal.

A resolution was adopted commending secretaries and employees of the denomination's executive committee for their action on voluntarily cutting their own salaries. Without opposition the assembly adopted a resolution setting forth the salary cuts voted last week and made a basis of the 1932 scale. Dr. Charles Clark, of Comanche Texas, offered a resolution calling for greater prayer for a general revival. It was adopted. Stronger churches were requested to assume support of home missionaries in another resolution adopted.

MUNICIPAL WOOD YARD SET AFIRE

Elizabeth City, May 29.—The last two Saturday's the municipal woodpile, where the fuel supplies of the needy of the city are furnished, has been found mysteriously afire. Mayor Jerome B. Flora has sent fire fighters to the scene each time, but thinks the fire is of incendiary origin. Many requests received by the mayor asking that free wood be supplied have been denied for reasons which he considers good. It is advanced as a theory that someone set the pile afire for revenge upon the mayor.

# SPORT SEANTS

No doubt our social, industrial and financial structure still is in need of considerable re-adjustment and repairs, but the signs of normalcy again along the sporting highways and by ways, already are becoming conspicuous if not exactly numerous. One of the most welcome is the come-back of your old favorite, John Leonard (Pepper) Martin.

It's good to see the Pepper romping around again with the same sort of spirit and activity that made him the one-man show of the 1931 world series and a national hero overnight. The remarkable feature of his come-back is not so much that he is again flogging all kinds of pitching, but that he has taken over a brand new job at third base with such gusto that he is already being compared to the best in the league in that difficult position.

Pepper broke loose against the Phillies one afternoon, reminiscent to the day he put the Athletics to rout single-handedly. Subsequently he has hammered his way to the top flight of National league hitters.

**Greasing The Chutes**  
It has taken the effervescent Martin exactly a year to shake off the reaction of misfortune that pursued him after his dramatic performance against the Athletics.

In fact, I have a distinct recollection of the way this re-action set in, following the fifth game of the 1931 series and Martin's return to St. Louis as a conquering hero. The Cards were leading 3 games to 2. The night before the sixth game Martin was dined and feted. I can see the "Wild Horse" yet, embarrassed, dazed, chewing a big cigar from which he had neglected to remove the wrapper. The chute were being greased in the customary manner for a new sporting idol.

The next day, at the park, admirers flocked around to present flowers, cactus buds and shotguns to the little outfielder. When he faced Lefty Grove and George Earnshaw in the remaining two games Pepper was still in a daze. He went hitless but the Cards won the final game, anyway, and the glorious reflection of his exploits was still bright.

**Trying To Hard**  
Only Martin's rugged constitution enabled him to withstand, as well as he did, the off-season round of luncheons and dinners, speech-making and hero-worship.

The enormous responsibility of it all was beginning to tell, nevertheless. He roared into camp in the spring in a high-powered new car. He worked desperately to get into condition. Too desperately, in fact for even in the exhibition games in Florida spectators flocked to see Martin run wild again.

The widest running Martin did was chasing home runs off the bats of the Athletic's sluggers at Miami. Naturally high-spirited, it soon became evident to one and all that Pepper was over-anxious and trying too hard. Then he dislocated a shoulder sliding before the end of April. He wound up by playing in only about half the games and batting .238.

Pepper Martin wasn't and never will be another Ty Cobb, but he isn't through. He's as game as they come. He has the spark of greatness, rare fighting spirit and he figures to have a big 1933 season by the simple expedient of attending strictly to the business of playing baseball.

## New York Cotton

New York, May 29—(AP)—Cotton futures opened steady three to seven cent decline in response to lower Liverpool cables partially offset by good commission house and trade demands.

While initial selling was absorbed by trade and commission house offerings increased after the lull with July selling off to 8.95 and December to 9.35 or about 14 to 18 points lower on the more active positions.

The buying was encouraged by over Sunday reports of a very firm tone in the cotton goods market and offerings were taken by buying on scale down orders with prices showing rallies of 3 to 4 points from the lowest at the end of the first half hour.

After showing losses of about 12 to 18 points under the early pressure cotton turned steadier on the renewed trade and commission house buying.

July sold up from 8.95 to 9.15 and December from 9.33 to 9.55 or about five to six net higher and the market was within a point or two of these figures at midday.

Futures closed four to nine higher; middling 9.20.

New Cotton Plan  
Washington, May 29—(AP)—Secretary Wallace revealed today that consideration is being given a plan for leasing sections of land now planted to cotton and expressed the opinion that expenditures of about \$150,000,000 for this purpose in payments to growers would have

the effect of maintaining cotton prices at from 10 to 12 cents per pound.

He said that cotton program under the new law will be drafted as soon as C. A. Cobb of Atlanta cotton production director returned this week after survey of the south and interviews with growers and their representatives.

Wallace also announced that the first public hearing under the new farm law has been set tentatively for Monday and will be on the proposed trade agreement covering the Chicago fluid milk market under which prices to producers and customers would be fixed.

Hearing will be held either at Chicago or Washington.

# A Washington Daybook

By HERBERT PLUMMER

Washington, D. C.—Clarence Cannon is disturbed about the size and cost of the Congressional Record and proposes to do something about it.

That young and energetic Representative from Milwaukee has estimated that it costs the government on the average of \$5,000 a day to print The Record, and hints have come to him of members given permission "to revise and extend their remarks" who employed ghost writers to compose their speeches.

But he's not having much success with his proposed reform.

Individual members of the House have a firm conviction that about the only thing left to them these days is the privilege of The Record. They don't get much opportunity to speak on the floor. During this special session legislation has been jammed through with such speed as to limit debate.

With Representatives lacking the right to express their views in The Record, the folks back home might never know how they stood on important legislation.

**Victims of Speed**  
There have been drawn for example, some 39 or 40 special rules since President Roosevelt called Congress in session shortly after March 4. These special rules sweep everything else aside until the bill is either passed or defeated.

Debate is shut off or limited to a minimum. The farm bill, for instance, was passed with only four hour's debate. The Muscle Shoals bill was rushed through in six hours and the securities bill was open for discussion only five hours before a vote was ordered.

Each of these bills, to say nothing of the others, is of vast importance. A member's political future may depend on how he voted or how well he can explain his vote to the people back home. The Record is his hope.

## Escape Up Sometimes

The leaders of the House realize this and at times, when there is no business before the house, they let down the bars for general debate. A flood of oratory rushes in.

It doesn't matter particularly to the speaker if only a handful of his colleagues are in their seats and listening. He's speaking for the Record. Once his remarks are incorporated in the Record, then he is free to frank copies of it to all his constituents if he chooses.
