

JAMES MATTERN MAKES SAFE LANDING AT OMSK

American Flier Will Resume His Flight Tomorrow

LOSES GROUND IN EFFORT TO BEAT RECORD

Lone Texan Loses Advantage Over Post-Gatty Record in Landing at Omsk; Reason for Flier's Decision to Remain in Omsk Not Determined; Encounters Bad Weather Between Moscow and Omsk

Moscow, June 6—(AP)—James Mattern, American round the world flier, planned to remain in Omsk until tomorrow, dispatches received here today said.

The reason for the decision had not been explained. Effort was being made to ascertain whether the flier had encountered any mechanical difficulty with his plane or whether he was taking the opportunity to rest.

Omsk, Siberia, June 6—(AP)—Jimmie Mattern landed here at 11:35 P. M. today (Moscow time) or 9:35 (E. S. T.) from Moscow.

Mattern thus required 12 hours and 21 minutes in which to fly from Moscow to Omsk, a distance of 1,400 miles which he made with an average speed of almost 120 miles an hour.

Head winds were strong between Moscow and Omsk slowing up his speed but he knew about them before he left the Soviet capital.

Beyond Omsk he will have slight winds and clear weather and good visibility, according to the weather bureau reports here.

New York, June 6—(AP)—Jim Mattern reached Omsk today with a 54-minute lead on the Post-Gatty record up to that point but lost this advantage when he landed for the record holders flew over Omsk without stopping.

The lone Texan who is seeking to wrest the round the world flight record from the Post and Gatty was 73 hours and 15 minutes out of Floyd Bennett airport when he landed at Omsk.

BILL BADHAM VICTIM OF AN AUTO ACCIDENT

New Bern, June 6—William Badham, popular young man of Kinston, son of Mr. and Mrs. Louis M. Badham of New Bern, was instantly killed about 9:30 Sunday night in an automobile accident on the Central highway just on this side of Morehead Bluffs, as he was returning home in his Chevrolet coupe after an afternoon visit to the coast.

Lights on an approaching car from Bogie sound highway toward the Central highway blinded him as he drew near the forks, and he sideswiped another automobile, coming sailing several times and the driver was thrown to the ground, his skull being crushed.

The body was viewed by George Dill of Morehead City, Carteret county coroner, and was then brought to New Bern.

A companion, a Newport young man, who had requested a ride, was not injured but was badly shaken up. The occupants of the sideswiped car were not hurt.

STORES BEGIN HALF HOLIDAY ON WEDNESDAY

Public Buildings Also to Observe Summer Closing Period Tomorrow

Half Wednesday holidays will get under way in Greenville tomorrow with the closing of the majority of public buildings and business houses.

A closing petition recently issued through the Chamber of Commerce showed that virtually all merchants were in favor of observing the half holidays and the closing was expected to be more general than any time in years.

Because they did not have time to make proper arrangements, a few grocery stores indicated they would not be able to close tomorrow but the managers said they would be in shape to carry out the closing plan the remainder of the summer.

The post office, which has been observing a half holiday on Saturday, in accordance with federal regulations providing for a half day closing, will close at 1 o'clock on Wednesday while the summer closing movement is in progress.

The court house will also join the movement as will some of the other public buildings wishing to keep pace with the step to give employees an opportunity to take advantage of some of the recreations afforded during the summer months.

The closing tomorrow will give everybody a chance to attend the opening game of the Coastal Plain League here in which Greenville will vie for honors with Ayden.

The seating accommodations at the ball grounds were expected to be exhausted by the crowds from the two towns.

ILLINOIS IS FOR 'REPEAL'

State Joins Eight Others in Seeking to do Away With Prohibition

(By The Associated Press) The movement for repeal of the 18th amendment is one quarter of the way toward the goal today with Illinois added to the eight states which previously voted to take the 18th amendment from the constitution.

Thirty-six states are needed for repeal. Today Indiana made its decision at the polls, the state legislature having liberalized its dry laws earlier this year.

"If we can win in Indiana we can prevent repeal." An Anti-Saloon League superintendent for that state expressed the opinion that prohibition defenders had a 50-50 chance.

The vote in Illinois yesterday was approximately four to one for repeal.

This was the third test of the middle west, Michigan and Wisconsin having blazed the repeal trail.

Four eastern states, New York, New Jersey, Delaware and Rhode Island and the western state of Wyoming and Nevada having voted for the repeal amendment.

THWART PLAN OF CONVICTS TO LOOT TOWN

Citizens of Arkansas Town Arm Themselves in Face of Raid Threat

Rison, Ark., June 6—(AP)—A band of between five and seven armed men who Sheriff Roy Morrison said he believed were fleeing Kansas convicts were thwarted in an attempt to loot this town today after the early morning kidnaping of the night watchman.

Lights were turned on and armed guards patrolled the streets after information that Deputy Sheriff W. A. Fore, night watchman, and J. R. Perkins and Sam Rogers, negro, had been kidnaped by three armed men from in front of Harry Thompson's merchandise store about 1 a. m.

Thompson, who had come to deliver a load of hay, witnessed the kidnaping when he got up to meet Perkins and the negro and heard them tell Fore they would return to loot five or six safes.

Their car bore an Oklahoma license. Thompson notified Sheriff Morrison who turned on the town lights and assembled a citizen patrol.

Fore Perkins and the negro were released on the Rison-Pine Bluff highway about two hours later when the gang traveling in two cars spotted the officers and released the captives.

The Pine Bluff officers picked up Fore and his companions and gave chase. Fore said the men who had kidnaped him and the other two captives drove them to a wooded spot three miles from Rison where they met another car in which three or four men armed with sawed-off shotguns sat.

Leaving the trio under guard of one man the five or six other members of the gang piled into two cars and headed back to Rison. In about half an hour they returned, their looting plans evidently thwarted by the presence of the armed guards.

GREENSBORO REPORTS GOOD BUSINESS GAINS

Greensboro, June 6—(AP)—Business percentages here during the past several months have skyrocketed.

The Carolina Steel and Iron Company reported gains of 110 to 115 per cent. During the past months, merchants reported that business during the last several weeks, has been the best in two or three years; textile mill officials said operations have been on the upgrade for several months.

NEW LEAGUE SWINGS OPEN WEDNESDAY

Ayden and Greenville to Engage in Opening Contest Here Tomorrow

Preparations had virtually been completed here today for the opening of the Coastal Plain League tomorrow with Ayden and Greenville meeting at Third street school athletic field.

Mayor R. C. Flanagan will toss the ball that sets the game in motion and the high school band will provide the music for the afternoon.

The name of each player will be announced as he goes to bat so that the hundreds of fans expected to be in attendance may acquaint themselves with members of the local club as well as the visiting organization.

The league is composed of Kinston, Ayden, Greenville and Snow Hill. Three games will be played each week and extra games have been arranged from time to time to keep the players in trim while making time for scheduled games.

Virtually all business houses will close to give employees an opportunity to see the opening game, and many remembering the competition which Ayden furnished back in the first East Carolina League, will be looking for a team representative of the thriving Pitt county town.

Players have already been chosen in each of the towns, according to information reaching the city, and when the umpire shouts "play ball" each club will be ready to do its best to bring honors to the town it represents.

The Greenville club started actual practice Monday a week ago and yesterday vanquished Grimesland in an exhibition game here.

The game provided fans with some idea of how the locals will stack up against other clubs of the league in view of the fact that many of the Grimesland players yesterday will be members of the Snow Hill club to play here at an early date.

With seating accommodations surpassing all other ball grounds here, club officials were expecting a big crowd from Ayden to augment the large attendance looked for here.

The success of the league, officials said recently, will depend largely upon the kind of support given by fans at home, and in view of this declaration, supporters will do everything possible to have large crowds present throughout the summer.

Roosevelt Policies Are Studied By Republicans

By BYRON PRICE What do the new Roosevelt policies at Washington mean in terms of party politics?

The answer must be qualified, because there is no certainty now what course the republican party will follow. If the Roosevelt experiments turn out well, the opposition may be expected to look for entirely new ground in 1936.

Subject to this qualification to the future, the only logical means of comparing the present position of the two parties is to measure what the democrats have done against what the republicans promised to do if retained in power.

The outline of these promises is to be found in the campaign speeches of Mr. Hoover. By tradition he remains the leader of his party until a new leader is chosen.

The national party officers at the moment are men selected by him. His most recent utterances are the latest extant pronouncements of party policy.

Seen in that light, several direct lines of division at once become apparent. For since March 4 most of the things so strenuously objected to by Mr. Hoover last summer have come to pass.

Where They Differ To enumerate only a few: Money—the gold standard, a rallying point of republican defense is gone. Inflation, a word of deepest republican abhorrence, has been accepted openly into the democratic vocabulary.

Industrial Control—Mr. Hoover's "rugged individualism" is melting before a democratic program of extra-strict governmental regulation, running to special lengths for such industries as agriculture, culture and railroads.

Power—The government, at Muscle Shoals, is embarking on the manufacture and distribution of power in the exact manner bitterly opposed by both the Coolidge and Hoover regimes.

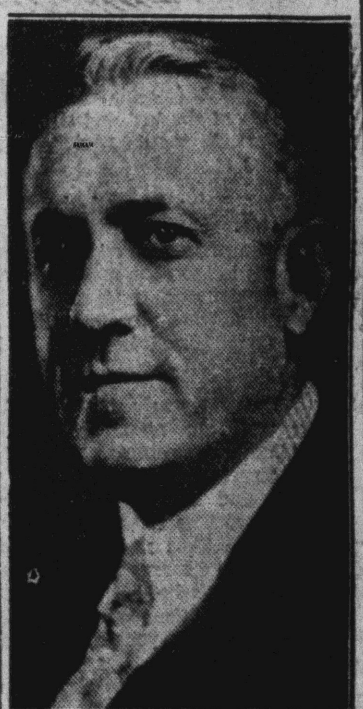
Economy—The democratic administration has defied organized minorities, ripping out of the federal budget veteran and other expenditures looked upon by Mr. Hoover as fixed charges permitting of only limited reduction.

Spilling on Prohibition Having already legalized beer, the Roosevelt regime is throwing its full strength in the balance for outright repeal, against the expressly stated republican modification policy outlined in 1928.

Public Work—Democratic plans encompass expenditures at which the republicans would have held up their hands in horror, and did in 1932, particularly with respect to that they called the Garner "pork barrel" bill for new post offices.

Tariffs—The Democratic administration is moving steadily toward an era of "negotiated tariffs," generally opposed to republican doctrine for a generation and specifically opposed to the Hoover utterances (Continued on Page Four)

WORD GIVEN AT MEETING OF LEAGUE

Germany - Will Respect Findings of League of Nations Council in Bernheim Case, Finding of League Council Has Far-reaching Effect in Individual Intervention

Geneva, June 6—(AP)—A representative of Chancellor Adolph Hitler's government pledged his word before the public League of Nations council today that Germany will give back to German Jews the position they lost in Germany's Upper Silesia.

The question of Germany's treatment of the Jews brought before the league council on May 10 when Franz Franz Bernheim, a German Jew, presented a petition charging that barring of Jews from professions in that area contravened the Polish-German convention guaranteeing certain rights regardless of race or religion.

Caustic words passed between Frederick Von Keller, German representative, Stephana Osuski, of Czechoslovakia, and the Norwegian representative, Christian Lange, at the meeting today.

Her Von Keller charged Lange with having challenged the good word of Germany when the Norwegian referred to the necessity of preventing local officials from misunderstanding the purport of the general laws and insisted that Osuski went beyond the agency when he hinted that the entire system of minorities should be handled by the league assembly.

Berlin, June 6—(AP)—Germany will respect the findings of the judicial committee of League of Nations of National Council in the Bernheim case, it was authoritatively stated today.

In German opinion the committee report had no significance for settling the Bernheim case, it was explained, but has a far-reaching juridical significance in that uninvolved individuals can intervene in behalf of someone directly affected.

"Germany will naturally in later cases if this should be deemed advisable revert to the judicial committee opinion a spokesman said.

Judges Still Stick To The Senate

By HERBERT FLUMMER Washington—(AP)—Decision of Senator Bratton—New Mexico, red-haired and scholarly, to leave the Senate for a seat on the federal bench rather than reverse the usual thing in this respect.

Judges in the past have shown a keen liking for getting into the Senate. And Bratton's decision to leave, when his present term is up until 1937 is rather strange.

Glance down the list of a few of those now in the Senate who left high places on the bench for the Senate.

Wagner of New York is an outstanding example. He was a justice in the appellate division of the Supreme Court of his state when opportunity to run for the Senate presented itself. He took it, and has been enthusiastic in his new job ever since. There have been reports that an effort was made to persuade him not to run for reelection last November and that he turned the suggestion down cold.

There's Logan of Kentucky, who was chief justice of the highest court in his state when elected to the Senate. Logan has indicated that he is not particularly happy in the Senate, but he is sticking on just the same.

George of Georgia was sitting on the Georgia Supreme bench when he resigned to run for a seat in the Senate. (Continued on Page Four)

In so enormous an undertaking, one might expect curious perceptions as well as lengthy ones. 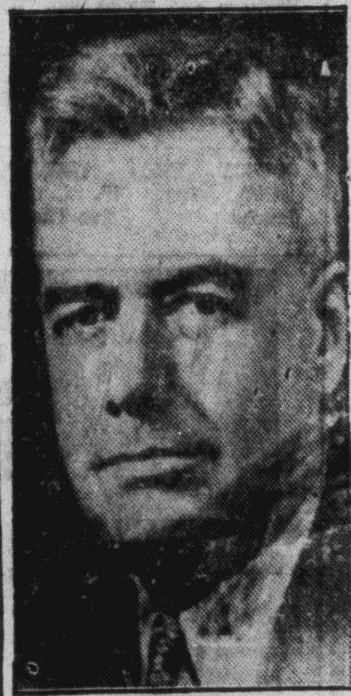

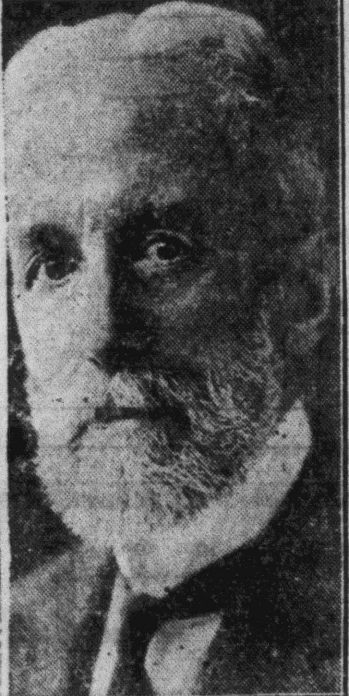

Local Leaguers Trim Grimesland In First Exhibition Game Here

Displaying speed and stamina unusual for an exhibition game, the Greenville club of the Coastal Plain league defeated the strong Grimesland aggregation at Third Street School athletic field here yesterday afternoon by the score of 6 to 4.

It was the first exhibition game played by the local club since practice got under way here the first of last week, and incidentally the last before the opening of the new circuit tomorrow afternoon with Ayden playing here.

Quite a number of fans were on hand yesterday to see how the locals would stack up against Grimesland, which had obtained a number of Snow Hill players for the contest, and they were satisfied with the showing.

It has been many years since Greenville has witnessed such a demonstration of pitching as was in evidence yesterday. The hurling feat was of far greater interest to the community in view of the fact that two local boys, Roger Taylor and Bob Forbes were given an opportunity to "show their stuff" and the way they made the visitors whiff the air in a vain attempt to connect for safeties caused much elation among their supporters.

Then there was a giant moundman used by the locals who came in for considerable praise. He was no other than "Big Boy" Winstead, of Raleigh, former fireman and Piedmont league player whose baffling speed and curves only tended to add to the fulfillment of the visitors' efforts to connect.

Manager Milton Harrington gave all his pitchers a chance to display their wares. Taylor pitched the first three innings, yielding three hits which combined with a couple of errors by his teammates enabled the visitors to send three runners over the plate in the first frame. Forbes took the mound in the fourth and with slight support let the visitors down without a single tally or hit.

Winston was less fortunate than Forbes, although he probably had more strikeouts to his credit than any of the rest. One three base drive by Mewborn enabled Grimesland to send their final runner racing home in the seventh.

Greenville boys also came in for the major part of honor in the offensive at the bat. Harrington, Brown, and Hicks chalked up two safeties each, with Hicks getting an extra base drive. Bostic was credited with one hit that being for an extra base. Poole, playing second obtained two hits that figured in the scoring.

Grimesland used to pitchers, Hardison going as far as the seventh frame when the batting attack unleashed by the Greenville club caused him to be jerked out in favor of page of Elm City, who allowed two more tallies during the remainder of the game.

Grimesland was credited with the only double play of the game, that coming in the eighth inning from V. Peele to Baker to Webb, Mewborn tripled in the ninth frame to give the visitors their fourth tally, and incidentally increased the hits to four. He was the only extra base drive made by his team.

ARMY TO SUFFER HEAVIEST LOSS BY GRADUATION

West Point, N. Y.—(AP)—While graduation annually takes its toll of college athletes, authorities at the U. S. Military Academy declare that this June the largest number of outstanding stars ever to change their uniforms from cadet grey to the olive drab of the regular Army will leave West Point. Included in the group of 97 varsity squad men are three members of "All-America" teams. They are Milton Summerfelt, Benton Harbor, Mich., football and lacrosse; Dick King, Georgetown, S. C., football; and Charles Pottenger, Oklahoma City, Okla., lacrosse. Another prominent athlete finishing his college career is Felix Vidal, Madison, S. D., who led the attack of the Army football team last season.

Kenneth Fields, Elkhart, Ind., who has won six major A's in football and baseball, together with scholastic honors, also will leave the "Point." Fields has won the gold star of a Distinguished Cadet, indicating that his marks in every subject were 92 per cent or better since his plebe year. He stood number one in his class for the past two years. Last June, Vidal was appointed First Captain or Regimental Commander of the Corps of Cadets by Major W. D. Connor, superintendent of the Military Academy. Other outstanding athletes include Joe Remus, Shenandoah, Pa., captain of the boxing team and intercollegiate heavyweight champion in 1932; Maurice E. Kaiser, Sacramento, Calif., captain of fencing and winner in 1932 of the individual intercollegiate sabre championship; Bruce Scott, Beverly Hills, Calif., captain of polo and member of the Army quartet winning the outdoor intercollegiate polo championship in 1931.

Others in the list are: David Wagstaff, Jr., Tuxedo Park, N. Y., hockey captain; Chalmers K. McClelland, Jr., Fayetteville, Ark., swimming captain; Alfred D. Starbird, Burlington, Vt., cross country captain; Stephen O. Fugus, Jr., Washington, D. C., baseball captain; William V. Thompson, Pearisburg, Va., wrestling captain; Winston S.
