FRANCE PLEDGES FULL AID AT LONDON CONFERENCE

Drive Of Gold Bloc For Adjournment Believed To Be Gradually Weakening

BONNET MAKES FIERY SPEECH TO DELEGATES

French Foreign Minister Declares His Country Willing to Render Best Efforts For Success of Conference; Demands Concrete Decision On Stabilization Proposal

London, June 21.—(AP)—What was taken by many delegates to be indication of weakening in the gold bloc drive for adjournment of the world economic conference pending stabilization of the American dollar came dramatically today in an impassioned speech by Finance Minister George Bonnet of France.

The French foreign minister took the floor in the sub-committee on important monetary affairs and while again demanding stabilization, he pledged "France's full aid toward success of the conference."

M. Bonnet's speech, in which he painted a picture of the danger of inflation and currency depreciation with a broad thrust, was one of the most eloquent delivered in the conference.

He put his whole driving force into the address and held the closest attention of the members of the committee.

"We demand concrete decision and not simply signatures on a book of paper which will be carried away," he declared.

"To arrive at this end we bring you our entire aid."

Later he emphasized this with "I repeat that the French delegation brings here France's full aid to the success of the conference."

Despite official hearing earlier in the morning, Bonnet had raised the question of the conference's future if stabilization is not achieved immediately.

WILL LIMIT 'TOP' WAGES

National Recovery Act to Spike Changes in Minimum and Maximum Rate

Washington, June 21.—(AP)—The government is going to do everything possible to prevent trade agreements made under the national recovery act from limiting top wages.

Hugh Johnson, administrator of the law, is anxious to have all industry accept codes of their competition fixing minimum wages.

But if he can help it, organized labor's returning contention that minimum wages become maximum will not be borne out this time.

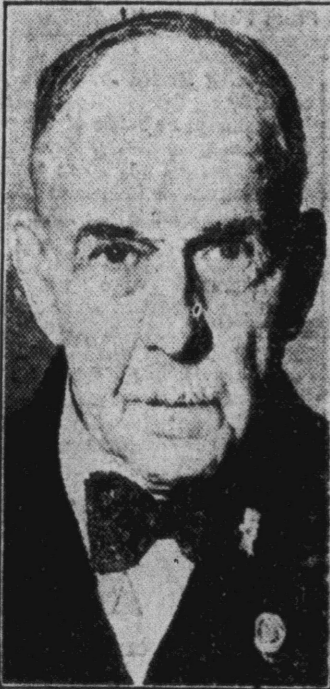
He summed up his reaction to that argument in this sentence:

"There was a minimum wage during the war that became maximum and farmers haven't yet gotten over it."

And he added that he would fight any attempt to repeat the war time wheat price mistake.

He is willing for other industries to follow the cotton textile trade and for minimum wages that vary with localities.

'WETS' TAKE THREE STATES

Fourteen States Have Now Joined the Parade Seeking Prohibition Repeal

Long, dry Iowa with Connecticut and New Hampshire today brought to 14 the states which in unbroken succession have voted to knock the 18th amendment out of the constitution.

The Hawkeye state's swing away from the position she has maintained for nearly two decades, left drys fixing their hope for hauling the parade on Alabama and Arkansas, both voting July 18.

In the doubtful column when the balloting began, Iowa brought in a majority for the repeal amendment even though it was not as big as that in Connecticut and New Hampshire.

But with 611,000 votes and only 30 precincts missing the count was 368,691 for repeal and 242,612 against. That means she has instructed all 99 delegates to the state convention July 10 to vote for repeal.

From the start there had been no question about what New Hampshire and Connecticut would do.

The former with a light ballot and only a small town missing, voted 75,969 for and 30,337 against. In like fashion, Connecticut registered a 6 to 1 majority to the 21st amendment, which repeals the 18th.

Her unofficial total was 236,915 for repeal and 35,340 against.

WOULD GIVE SUPPORT TO REPEAL RESOLVE

Washington, June 21.—(AP)—Ed Howard, president of the Washington Young Democrats Club, says his organization will support a resolution demanding repeal of the 18th amendment when the State Young Democratic Convention is held at Wrightsville Beach July 8.

Howard said so far as he had been able to ascertain the entire membership of the local club is "in favor of backing the national Democratic platform to the fullest."

Late News Flashes

Convicted Of Opening Graves. High Point, June 21.—(AP)—Four high school students who opened graves here to take pictures to further scientific study of the school club, pleaded guilty today to disturbing a graveyard and each was sentenced to spend five nights from 1:30 to 4:30 alone in the cemetery. Each also was taxed with the costs.

The charge against the four previously was grave robbing but it was explained the youths had taken nothing from the graves and since the charge was a felony it was reduced to disturbing a graveyard. (Continued On Page Three)

PLAN SIGN-UP IN COTTON CUT DRIVE IN PITT

Meeting To Be Held In Townships Next Week To Determine Pitt Reduction

A series of township meetings will be held in various townships of the county next week to determine how many farmers are going to take part in the government cotton destruction program to boost prices of the staple.

The meetings have been called for Monday and Tuesday and will be conducted by members of the committees to attend a meeting at the courthouse here Friday for the purpose of being informed concerning the crop reduction program.

On Wednesday a meeting of the committees will be held at the courthouse here to receive reports from the crop production control committees from the various communities. The meeting will be held at 8 o'clock and it will be determined how many farmers have agreed to plow up their crops in the federal program to relieve market congestion.

COTTON MILLS HIT FAST PACE

Revival of Buying And Demands For Textile Products Reviving Industry

Washington, June 21.—(AP)—Cotton spinning operations during May struck their fastest pace since October, 1929, reflecting a revival of buying and increased demand for their products.

The census bureau announced today that during the month United States mills operated an aggregate of 8,309,565,722 spindle hours.

In October, 1929, the number of hours was 9,005,849,000. Since 1929 the number of spindle in place has dropped from 34,000,000 to 30,959,216 as of May 31.

Partly as a result of that operations were carried on at a higher percent of capacity on a single shift basis than at any time since the bureau began keeping records in August, 1921.

Mills operated at 112.3 percent of capacity during May based on an activity of 8.96 hours per hour day. The average number of spindles operated during the month on a single shift basis was 34,778,658.

North Carolina reported 1,846,343, 126 active spindle hours an average of 301 per spindle in place.

Has Increased Payrolls

Lincolnton, June 21.—Lincolnton county last week had the largest pay roll of any year in the past three, according to estimates made here by those in the "know." Fourteen major business, 13 cotton mills and a furniture factory, paid out to employees last week over \$15,000. This represents lower wages, it was pointed out but it also represents full time, part of the businesses having run day and night to keep up with rush orders.

JUNIUS ROSE CHOSEN HEAD LEGION POST

Other Officers Selected At Open Air Meeting At Third Street School

Junius H. Rose, Superintendent of City Schools, was elected Commander of the Pitt County Post of the American Legion at an open air meeting at Third Street school athletic field last night.

He succeeds Capt. J. Con Lanier, who served for the usual term of one year. The term of the new commander will begin in September. In addition to the selection of a post head, the legionnaires also elected or re-elected a full staff of officers to serve under the new administration.

At the suggestion of S. L. Bridgers, it was decided to divide the county into three districts with exception of Farmville which has its own post, with one vice-commander from each district.

The officers elected were: John Rook, Bethel, first vice-commander; A. T. Rowe-Ayden, second vice-commander; Ray Harrison Stokes, third vice-commander; S. M. Woolfolk, adjutant and finance officer; S. L. Bridgers, chaplain; Dr. R. S. McGeachy, service officer; Carl Langley, sergeant-at-arms; Dave Moore, athletic officer; D. J. Whitchard, publicity officer; Dr. S. M. Schultz, historian.

All officers were elected without contest except S. M. Woolfolk Carl Adams was offered as a contestant for the office, but he declined the honor in a brief speech. His declination was not accepted and the question was put to vote. Woolfolk won by a good majority.

The name of Mr. Rose was presented by State Senator A. B. Corey, who said his candidate had rendered the post excellent service and deserved recognition of his comrades. The election was made unanimous.

REPEAL VOTE LEADING DRYS

The total vote so far including the latest returns from New Hampshire, Connecticut and Iowa is 6,981,498 for repeal and 1,899,724 against.

RAIDS MADE ON QUARTERS NATIONALISTS

One Killed in Fight As Nazi Troops Attempt to Carry Out Orders of Their Leader; Expulsion From Cabinet of Dr. Alfred Hugenberg Pending; Cleanup Expected

Berlin, June 21.—(AP)—Chancellor Adolph Hitler's new administration moved against Dr. Alfred Hugenberg's nationalist party today with a series of raids upon various party headquarters in which one was killed and with orders dissolving the nationalist auxiliary organization.

The fatality occurred at Frankfurt-on-the-Oder where a man was shot during a raid on party headquarters.

Dr. Hugenberg, who recently returned from London after he had been repudiated by the German delegation to the world economic conference, was remaining in Bonn, Germany.

Some quarters said today that events would result in his expulsion from the cabinet in which he is minister of economics and agriculture.

Before Hitler gained control in Germany the national stns were his aids. He no longer needs them now he has a majority in the Reichstag without them and he has effectively minister of economic and agriculture anyway.

BUILD TENNIS COURTS HERE

Three Courts To Be Built Into Hillside Back of Third Street School

Along with the building of the athletic field at Third Street school ground it was announced today that three tennis courts would be built in the back of the field.

In fact, construction work has already been started and will be completed within the next few weeks.

The courts, it was said, will be for public use, and anybody desiring to enjoy this pastime will be allowed to do so.

Announcement of construction of the courts was made yesterday afternoon following an editorial in the Daily Reflector asking that some of the funds being spent for public work in this community be expended in public tennis courts. It was pointed out in the editorial that this is one of the most popular forms of recreation enjoyed at this time and was receiving increased attention from people in this city.

The building of the courts, it was understood, followed considerable agitation of the question by tennis players of the city, the majority of whom have no place to play. Virtually all courts here are privately owned, and in view of the improvements made in athletic fields at the high school and college, opinion was expressed by tennis exponents that they should also be given a show.

Although decision to build the courts at Third Street school was decided on several days ago, no public announcement was made until yesterday.

Construction forces were busy today cutting into a hill overlooking Tar river and into the hillside will be built three courts which are expected to be numbered among the best in this part of the state. The Third Street stadium is already famed as one of the finest athletic fields in this part of the country, and with the addition of the tennis courts and other improvements to be made from time to time, its prestige will be given still a greater boost.

Rehabilitating The Farmer And His Job

Washington.—(AP)—Rehabilitation of agriculture is rated a social as well as an economic job in the program for a new national economy.

Advocates of the program which Congress has approved for the farmer see it translating higher prices for farm commodities into a weapon against debt, lost purchasing power and wasteful production.

In effect, Congress says to the farmer: "The government will help you to keep your home and your business and even up commodity and dollar values, but you must reduce your production to a profitable relation with consumption so you can purchase the products and services which the rest of the population makes a living."

The instruments of the program and their resources are: 1. Farm Credit Administration \$2,542,000,000.

2. Agricultural Readjustment Administration \$100,000,000.

The 12 federal land banks are authorized to issue an aggregate of \$2,000,000,000 of 4 per cent bonds for the purpose of making new loans to farmers at 4 1/2 per cent interest, purchasing mortgages to prevent foreclosures, and may exchange bonds for mortgages not in excess of the reappraised property value.

To compensate the federal land banks for lowering interest rates to farmers and deferring installments on the principal, the federal treasury is to make \$15,000,000 available to them as losses accrue.

Striking at the root of the farmer's second mortgage difficulties the farm loan commissioner is authorized to use \$200,000,000 to refinance any indebtedness wherein creditors scale down their claims in proportion to the decline in the capital value and earning power of the property involved; to provide working capital for farm operations (Continued On Page Four)

FARMERS SHOULD TAKE UP COTTON PLAN

The new government plan for reduction of the cotton acreage together with the equivalent option privilege for all farmers who cut their crop is, we believe, a movement that our farmers would do well to join at once.

As we understand the new plan, the farmer who will now plow up a part of his acreage ranging from 25 to 40 per cent he will receive payment from the government of \$8 to \$10 per acre on all acreage so destroyed and he can then derive the benefit of the fertilizer now in the ground by planting that acreage in food or feed crops for home consumption. In addition to being paid for the number of acres destroyed he likewise will be given, without cost, an option upon the number of bales that would have been produced upon those acres destroyed on the basis of six cents per pound and the farmer may sell this optional cotton at any time between the time of issuance of the option and January first, making for himself whatever profit the cotton brings above the six cents price. In addition to the benefits to be derived from the above it is believed that this shortening of the crop will also make the price of cotton higher with the result that the farmer would likewise receive more for that cotton raised upon the balance of his acreage.

It seems to us that here is a plan that is really intended for the sole purpose of helping the farmer and it is our belief that our farmers would do well to take up with it just as soon as the opportunity is offered them. Already reports have come from some sections of the county that the farmers are enthusiastic about the prop-

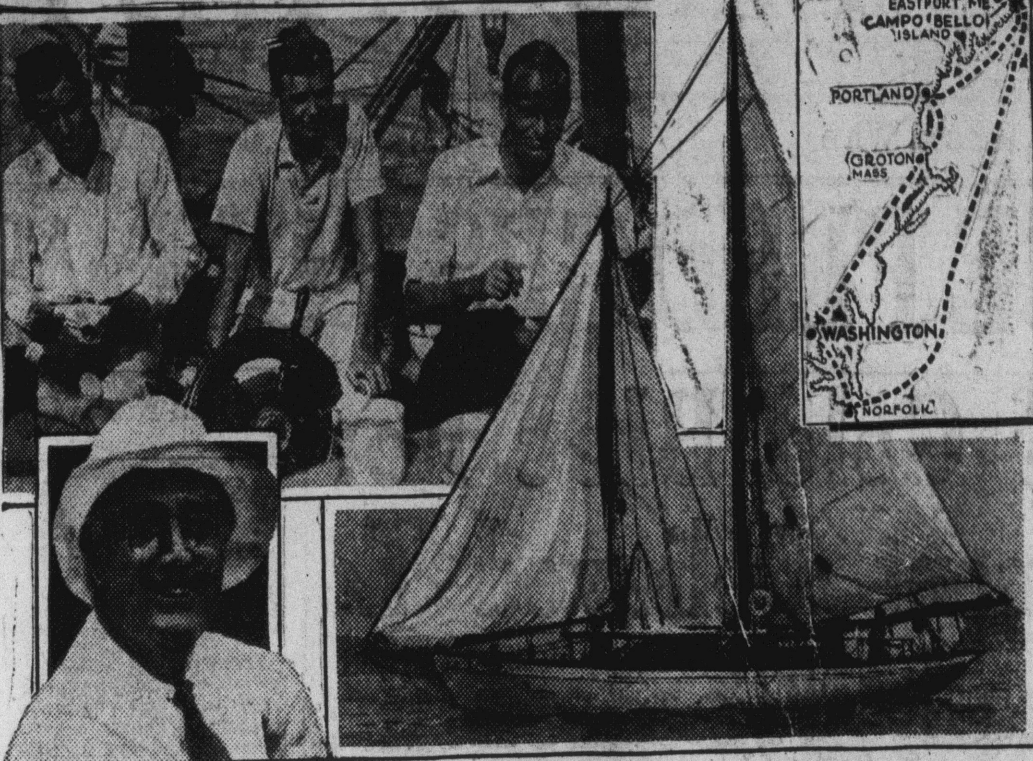
A Washington Daybook

Washington — When James W. Wadsworth of New York, one-time senator and a recognized power in republican politics of his state, came back into the national political picture as a member of the present house of representatives, Washington observers immediately began to speculate.

It wasn't very long before politi-

cal analysis put him down as one of the real contenders for the republican presidential nomination in 1934.

Wadsworth didn't do much to substantiate such a belief on their part. He was rather reticent about the whole thing. As a matter of fact, he scotched rumors that his reappearance in the national spotlight had any significance.

It was his belief, he said that the house afforded him excellent opportunity to serve his country. As for trying to contest the leadership of the republican forces, there was simply nothing to it.

Bert Snell, his friend from New York, was the titular leader of his party in the house, and as far as he

was concerned he intended to be a loamy man in the ranks.

Silence His Policy

He held to his word. Rarely did he make a speech. If he had any plans for the future, he kept them to himself. So far as is known, his most intimate friends have never heard him express himself on such things.

but the fact remains that he does occupy an important place in the republican party's hopes and plans to stage a comeback either in the by-elections of 1934 or in the still greater push of 1936.

Campaign material was rather slow in the making during the first part of the special session of the seventy-third congress, but along toward the end it was apparent to ev-

erbody that definite lines of battle were being formed for future party conflicts.

In perhaps no battle of the session was this more clearly shown than when the fight was on to write the administration's industrial recovery bill into the law of the land.

Looking To 1936

Wadsworth's voice was heard while this legislation was before the house. What he said was brief, but to the point, and in the opinion of many was one of the most politically significant expressions made on the bill.

"This is the beginning of one of the greatest political battles in our history," he declared.

"If this shall be the policy adopt-

ed here and continued hereafter, then I am sorry for my sons and their sons. They will live in a country whose people shall be regimented, controlled, guided and finally, compelled to adopt whatever methods of live government imposes upon them."

This statement from a man mentioned as a possible leader of protest forces in 1936 is not the sort that politically minded observers look.

CHECKING UP ON why, and to assist farmers in redeeming foreclosed property.

The third major credit provision is a \$10,000,000 revolving fund authorized by the farm credit act of 1933 for the federal purchase of capital stock in production credit associations and corporations.

The associations, one to each federal land bank district, provide loans to individual farmers for crop and livestock production, and the corporations or banks similarly distributed substitute for the dismantled farm board in financing cooperative marketing agencies.

Simultaneously the agricultural readjustment administration moves to life the surplus pressure from wheat, cotton, corn, hogs, tobacco, milk and milk products.

The act provides that compensation to farmers for reductive acreage or production be financed out of a processors' tax on the domestically consumed portion of the commodity served.

In addition, the processors' tax may be used to pay producers the difference between the open market price of a commodity and the price at which it would have to sell to restore its pre-war purchasing power.

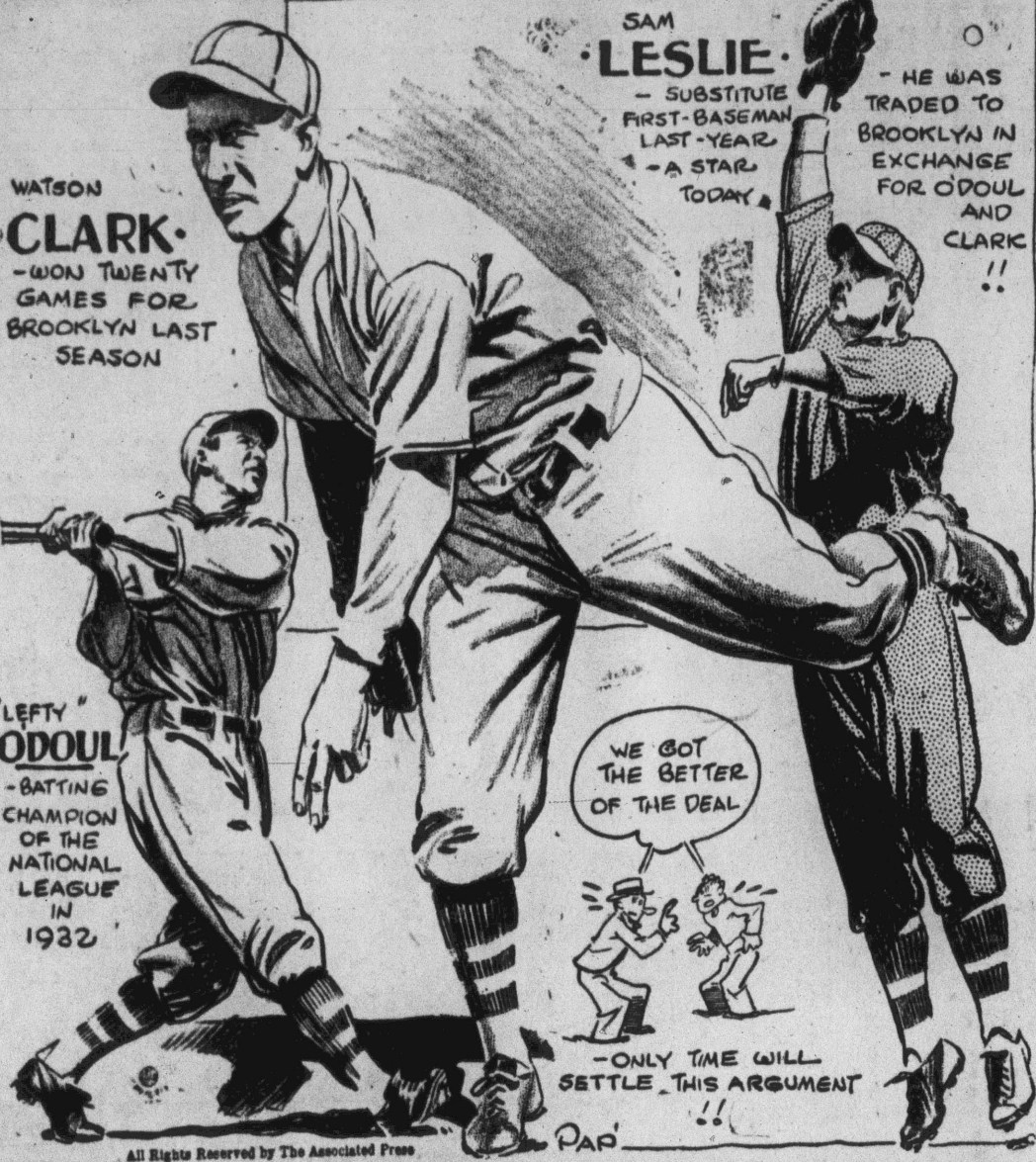

Lawyers-Judges To Discuss N. C. Constitution

Chapel Hill, June 21.—The members of the Constitutional Commission, together with Attorney General Dehins G. Brummitt and Senator A. McLean, have been invited to discuss the provisions of the State's proposed new Constitution at the group meeting which the judges, solicitors, and bar officials will hold in connection with the opening of the Institute of Government here Friday again on Saturday morning.

Capus M. Wainick of High Point who was chairman of the Senate Committee on Constitutional Amendments, is in charge of the instruction for this group. Leading the discussion with him will be Walter Murphy, who headed the House committee on amendments.

Among those who have been invited to participate are Chief Justice W. P. Stacy, Federal Judge John J. Parker, Representative Lindsay Warren, Burton Craig, J. O. Carr, George E. Butler, Clarence P. and Commissioner of Revenue A. J. Maxwell.

The vital changes which the new Constitution would make in the laws and the government of the State will be taken up in detail so that this gathering promises to be one of the highlights of the two-day program.

Included among the subjects for discussion and evaluation are the flexible provisions for the legislative exercise to the taxing power, the election of judges by district instead of statewide vote, the principle and policy of the executive budget, the veto power of the government, and the organization of counties, cities and towns under general laws only.

Washington, June 21.—(AP)—The acting secretary of the navy, Henry L. Roosevelt, said today the navy planned to spend \$86,000,000 worth of shipbuilding in 1934 fiscal year which begins July 1.

The navy has just allotted two submarines of 1,400 tons each, for construction, N. H. navy yards, one of them in New York and the other at the Charleston, S. C. navy yard.

Roosevelt explained that \$40,000,000 would be spent on ships already under construction and at least \$46,000,000 starting new 32 ships program for which the President has approved \$328,000,000 allotment out of the public works funds.

Secretary Swanson previously had said that 85 per cent of naval construction goes to labor.

Mitchell Case Goes to Jury

New York, June 21.—(AP)—The case of Charles Mitchell until recently a powerful figure in banking world, who is charged with defrauding the government of over \$850,000 in income taxes was given to a federal court jury today.

At 11:25 a. m. federal judge Henry Goodard concluded his charge and the case which has been in trial since May 11 was turned over to the 12 men.

The maximum sentence should Mitchell be convicted would be ten years and a fine of \$20,000.
