## ITALIAN FLIERS LEAVE CHICAGO FOR NEW YORK

### LEGION NAMES DELEGATES TO STATE CONFAB

Other Matters Taken Up at Monthly Meeting of Organization Last Night

Meeting in regular monthly session last night, Pitt County Post of the American Legion elected delegates to the State convention at Wrightsville Beach, July 17-18-19. The delegates are: J. H. Rose, S. M. Woolfolk, Dr. Grady Dixon and Dr. Tom Watson. Alternates are: A. B. Corey, Dr. S. M. Schultz, Walter Cherry and Dr. R. S. McGeachy. At the suggestion of Dr. S. M. Schultz, the post adopted a resolution asking that Reconstruction Finance Corporation funds in this state be applied to indigent hospital cases. The movement is state wide. In the absence of Commander J. C. Lanier, who recently left for Washington to take charge of a government position, A. B. Corey opened the meeting and entertained a motion that J. H. Rose, newly elected commander, fill the unexpired term of Mr. Lanier. It was adopted. Mr. Rose will be inducted for his full term of office in September and will actually take over the duties in October. The meeting was held at Third School athletic field house which has been selected as permanent meeting place of the organization in the future. A delightful chicken supper was served and the way the meat disappeared under the impact of the attack of the former soldiers caused joy to the culinary department.

The interest manifested by the membership indicated the new year will be one of the best in years with marked increase in membership.

### BROWNS GET NEW LEADER

Coach Named Temporary Manager Following Killefer's Resignation

St. Louis, July 19.—(AP)—Bill Killefer, manager of the St. Louis Browns, today telegraphed his resignation from Washington.

President Phil Ball announced Al Southerton, who had been coach, would be the manager temporarily. President Ball, who is confined in a hospital, said he would take steps to obtain a new manager when he is released in a few days.

He had no comment to make on Killefer's resignation but it has been no secret that he was displeased with playing of the Browns who are in last place in the American League.

### STORE AT WADESBORO IS DAMAGED BY FIRE

Wadesboro, July 19.—Fire discovered about 11:30 yesterday morning damaged to the amount of several thousand dollars an A. and P. store in the main business section of Wadesboro. The roof and second story ceiling were burned out and the stock of goods on the first floor was ruined by water. The damage to the building, owned by Mrs. R. L. Harrison, is estimated at three to four thousand dollars. The A. and P. stock was almost a total loss, but the value has not been estimated. Belk's department store and Dockery and Moore's grocery were damaged to some extent by smoke and water. The origin of the fire which was confined to the A. and P. building is unknown. The loss is covered by insurance.

### TAG DAY IN CITY TODAY

### Young Women Sell Tags to Boost Financial Standing of Ball Club

Today was a banner day for the Greenville baseball club with young women representing the Junior Woman's club selling tags to help boost the club's financial position and the business section taking a half holiday this afternoon to witness the clash with Ayden here.

Persons buying tags will be admitted to the ball game today, and in addition to helping the club in a financial way, they will receive returns from their money. With this afternoon being the half holiday enjoyed by the business district during the summer months, it was expected hundreds would be on hand this afternoon to see the local club cross bats with Ayden. With Greenville tied with Snow Hill for the top, all battles of the league will among the most spectacular of the season.

This is the first time a public effort has been made to raise funds for the club since the canvass of the beginning of the season, and it was expected the public would buy liberally of the tags and then be on hand to see the effort to trounce Ayden for the second time in less than a week.

### MOST OF GREENSBORO'S STRIKERS WORKING AGAIN

Greensboro, July 19.—More than 100 relief workers, paid with funds distributed through the city's family service agency, remained on strike today, but around 300 of those who quit work last week on the battleground returned to work yesterday without further trouble. The strikers were asking a minimum wage scale.

### Balbo Reaches New York.

New York, July 19.—(AP)—General Balbo's flying fleet passed over New York at 2:39 p. m. today and landed in Jamaica Bay.

### McNinch Heads Power Commission

Washington, July 19.—(AP)—Di-George Otis Smith today resigned as chairman of the Federal Power Commission at the request of President Roosevelt, who designated Commissioner Frank McNinch of North Carolina, as his successor. Smith's resignation today was only from the chairmanship of the commission, but it was understood his resignation as a member of the agency would be forthcoming in the next 90 days.

In ratifying the designation of McNinch as chairman of the commission, Basil Manly of Washington, was made a new appointive as vice-chairman. McNinch, a Democrat, was named a commission member in 1931 by President Hoover. Although the power commission could have elected McNinch as chairman, President Roosevelt paid him the compliment of designating him as chairman.

### Headed Anti-Smith Fight.

Charlotte, July 19.—(AP)—Frank McNinch, Charlotte attorney, who was named chairman of the Federal Power Commission by President Roosevelt today, was leader of the anti-Smith group in North Carolina in the 1928 campaign.

He conducted a victorious campaign for President Hoover, and his efforts were rewarded by this state casting its electoral votes for a Republican President for the first time in 30 years.

### Concerned About Post.

Novosibirsk, Siberia, July 19.—(AP)—The Irkutsk airport became concerned today over the lack of word about Wiley Post, American aviator flying round the world, and urgent inquiries were broadcast along his course as far as Khabarovsk.

Post was last reported at 11:29 a. m. (Moscow time) flying over Kosnyan enroute from Irkutsk to Blagoceschensk. The Irkutsk wireless station reported directing at Novosibirsk each hour. (Continued On Page Four)

### COUNTY COURT TAKES RECESS

### Work to be Resumed August 8; Light Docket Completed Yesterday

County court officials today were taking their annual summer recess which will extend to August 8. The decision to recess was decided upon following the disposition of the regular weekly docket yesterday.

Owing to the inability of farmers to attend court because of the harvesting of their crops, court always takes times off this season of the year so that the growers will not be interrupted at their work. Seven or eight cases were disposed of yesterday. All were of a minor nature and required only minor time in completing.

Jasper House, charged with selling liquor, was sentenced to four months on the roads. He filed notice of appeal to Superior court under bond of \$200. He was taken in custody by sheriff's officers during a raid on a filling station on the Vanceboro road near Greenville. Sentence was suspended for three years in the case of Walter Coward charged with possession of whiskey. He was required to pay cost.

Richard Leary, colored, was fined \$50 and cost on a charge of possessing liquor for sale. Fined \$10 and cost on a charge of Larceny, Lonnie Mills filed notice of appeal to Superior court under bond of \$100. Judgment was suspended for three years on good behavior in the case of Frank Nobles, colored charged with assault with a deadly weapon.

### JUST THREE HOURS AHEAD OF OLD TIME

### Bad Weather Causes American Flier to Lose Precious Hours In Hop From Moscow to Novosibirsk; Takes off From Irkutsk for Sixth Lap of Record-Making Flight

Irkutsk, Siberia, July 19.—(AP)—His lead over his 1931 record having been cut sharply to three hours and 21 minutes, Wiley Post zoomed out of Irkutsk today toward Blagoceschensk, nearly 1,000 miles eastward on the sixth lap of his flight around the world.

The American aviator hopped off at 7 a. m. 11 p. m. (EST) after remaining here since 5:35 a. m. (EST) while his advantage over the former record by him and Gatté two years ago was whittled to a slim margin.

Bad weather which caused him to lose precious hours on the jaunt from Moscow to Novosibirsk again dogged him and forced him to stay here longer than he wanted to.

### GOVERNOR TO FLY TO CAMP

### Ehringhaus to Inspect Review of National Guards at Camp Glenn Tomorrow

Raleigh, July 19.—(AP)—Governor Ehringhaus will fly by army airplane to Camp Glenn tomorrow, weather permitting, to inspect the something like 1,000 members of the National Guard now in camp there.

The governor has been tendered the use of the army plane by General Manus McCloskey, commander of Fort Bragg.

A special review will be staged for the governor.

### TWO CASES OF SPOTTED FEVER IN DAVIDSON

Lexington, July 19.—Definite diagnosis of two cases of Rocky Mountain spotted fever in Davidson county was reported yesterday afternoon to Dr. G. C. Campbell, county health officer, by Dr. Milan epidemiologist of the U. S. Public Health Service, who recently came to the state to investigate reports of this disease in North Carolina. The victims are Mr. and Mrs. U. G. Pope, who live near High Point.

### SEEDLESS TOMATO GROWN BY TEXAN IN HOthouse

Amarillo, Tex., July 19.—(AP)—After long experiment, winter and summer, in a hothouse W. J. Beechler, Amarillo florist, has grown a "seedless tomato." Each year Beechler took cuttings from the plants producing tomatoes with the fewest seeds and started new plants. He now has groups of plants showing the various stages of seed elimination.

Only an occasional seed is found in the fruit of the more advanced of these. Beechler expressed the opinion that the flavor was improved with the disappearance of the seeds. "I believe seedless tomatoes can be grown on a commercial scale," Beechler said, "although so far as I know it has never been done. The plants are perpetuated by cuttings and are still bearing as well as those grown from selected seed."

### TWO STATES FOR REPEAL OF DRY LAW

### Arkansas and Alabama Join Ranks of Wets in Voting Contest Yesterday

(By The Associated Press) Arkansas and Alabama, the first states of the "solid south" to speak on the prohibition amendment, have voted for its repeal.

Approximate and incomplete returns showed today that Alabama favored repeal by about two to one. The vote for repeal in Arkansas was three to two.

Yesterday's vote brought states on record for repeal to 18 with prohibitionists yet to show their first victory.

Tennessee voters will register their decision tomorrow with Oregon Friday. Thirty-six states must vote for repeal if the amendment is to be nullified.

In addition to Tennessee and Oregon, 15 states have definitely fixed dates before early November to vote on repeal amendment.

### DEATH CLAIMS RESCUE HEAD

### Captain Anton Nilsson Succumbs to Exposure Saving Crew Of Cities Petrol

Fort Lauderdale, Fla., July 19.—(AP)—Captain Anton Nilsson, master of the tanker Gulf M, died last night in a hospital here and physicians attributed the primary cause of his death to exhaustion incurred during the rescue of the crew members of the Cities Service Petrol when that vessel sank after two explosions last Friday off the North Carolina coast.

Nilsson was on the bridge of his ship more than 36 hours directing connections with the oil tanker after being attracted by the explosions.

### PREDICTS N. C. WILL VOTE WET

### Head of State Repeal Council Says State Will Outdo Arkansas and Alabama

Raleigh, July 19.—(AP)—Walter Murphy, executive secretary of the North Carolina United Council for repeal of national prohibition, said today that North Carolina should roll up an even larger majority in favor of repeal than was recorded for the wets in Alabama and Arkansas yesterday.

Professing to see a connection between the campaign for repeal in the south and the industrial status of the section, Murphy said returns from Alabama and Arkansas proved that no section need look any longer on the south as a backward region.

### BANDITS ROB, BIND AND GAG 3 MEN AT STATION

Windsor, July 19.—(AP)—Two bandits Monday night held up, bound, gagged and robbed three men at a filling station three miles from here and then escaped.

The bandits entered with drawn guns and held up Jordan Castello, the proprietor, his brother, Richard and Hayes Dempsey. They fled with \$20, cigarettes and merchandise.

### DRYS ARE CONFIDENT STATE MRS. LINDSAY

Charlotte, July 19.—(AP)—Drys in North Carolina feel confident that the state will not vote for prohibition repeal November 7, Mrs. W. B. Lindsay, of Charlotte, state president of the Woman's Christian Temperance Union said Monday on her return from the national W. C. T. U. convention.

Definite plans are being outlined for an active state campaign, she said. Progress thus far, she added, "has been splendid."

### The 'Super-Cabinet' Drama Changing Time

#### By BYRON PRICE

President Roosevelt creation of a "super-cabinet" dramatizes better than anything else how times have changed in Washington. Every congress bill are introduced to enlarge the cabinet. Not since the last change was made 20 years ago has such a bill been considered seriously. Congressmen argued there were too many cabinet members already.

Overnight, Mr. Roosevelt in effect doubled the size of the cabinet simply by calling into cabinet meetings the new "administrators" set up by the Roosevelt legislation. He names the bigger group a "Recovery Council." No member of Congress criticizes.

This was no new idea. Months before inauguration some of Mr. Roosevelt's callers came away talking mysteriously of a bigger cabinet which would include members "without portfolio," each spokesman for some important element of the nation.

It didn't quite work out according to the original specifications. For one thing, it had been hoped to have a duly authorized representative of organized labor in the "super-cabinet." Some think that may happen yet.

Stirring Up The Republicans The regional republican conferences evoked by National Chairman Everett Sanders have some unexpected reactions:

One republican leader (still in public office) has been deluged with inquiries. One of those who telephoned to ask what it was all about was no less a party personage than Charles C. Dawes. The leader interrogated replied he didn't know what it was about didn't see any chance to do republican planning so far ahead, and hoped nothing would be done now to commit the party to any candidate or any policies.

The Sanders reorganization corps is made up almost entirely of former Hoover men. That accounts for most of the inquiries.

Incidentally, word has reached Washington that Mr. Hoover is receiving in California comprehensive reports how the wind is blowing, and that shortly there will be a gathering of the faithful at Palo Alto.

A Matter of Misunderstanding. President Roosevelt took a long time appointing his public works administrator; and there was an interesting story behind it.

Gen. Hugh Johnson was so surprised when he found he was not to have charge of public works as well as industrial recovery that one of his most influential friends was called in to tell him it was alright.

Then Col. George R. Spalding appeared so definitely in line for the place that newspapermen were not expected at first they telephoned. (Continued On Page Two)

### STROKE KILLS MAJOR PRICE

### Head of State College Music Department Succumbs to Apoplexy Today

Raleigh, July 18.—(AP)—Major Percy W. (Daddy) Price, director of music at North Carolina State college here for many years, died at 2:15 this morning at Rex hospital after suffering a stroke of apoplexy an hour earlier at his residence.

Major Price was known throughout the state and over the southeast as a band leader and his musical aggregation at the college here ranks high among collegiate organizations.

Major Price was 46 years of age. He is survived by his widow and three children.

The body will be taken to Chickadee, Mass., today, the former home of his widow, and burial with Masonic rites will take place tomorrow. Ben Mays of San Angelo, Tex., former cow hand, finds a ready market for all the hand-made quilts he can turn out.

### REFUSE S. C. 'BEER' FUNDS

### Cornwell Orphanage Trustees Decline Further State Aid in S. C.

Clinton, S. C., July 19.—(AP)—Dr. L. Ross Lynn, president of Cornwell Orphanage here, announced today the school will in the future refuse all state public school fund aid because part of the fund is derived from the sale of beer. Dr. Lynn said trustees of the orphanage endorsed this stand after a meeting.

The orphanage, housing 375 children most of whom are of school age, is supported in the main by the Presbyterian Synod of South Carolina, Georgia and Florida. At the same time, however, a portion of state school funds go to the orphanage to aid in supporting it.

Dr. Lynn said it would be inconsistent for the school to accept the money, part of which accumulates from the sale of beer in South Carolina.

### ARMADA OFF ON FIRST LEG OF TRIP HOME

### New Yorkers Plan Big Celebration for Fliers During Three Day Stay There; Crowds Gather at Field at Same Time Armada Leaves Chicago; Balbo to Follow New Route Back Home

Chicago, July 19.—(AP)—Italy's armada of 24 seaplanes begun taking the air at 6:42 a. m. (CST) today enroute to New York on the first leg of their long journey to their homeland.

The weather was clear as the first of the twin-motored flying boats piloted by General Italo Balbo lifted itself from the water of Lake Michigan and headed southeast in the general direction of South Bend, Ind. Two others left at almost the same time.

The route as planned by General Balbo lay along the southern end of Lake Michigan and then over Toledo, Cleveland, Erie, Penna., Buffalo and Albany to New York with a landing in Jamaica Bay off Floyd Bennett air field.

Prior to his departure, General Balbo announced that if weather conditions are favorable he would undertake a trans-Atlantic journey in the most ambitious attempt of an east to west crossing.

The proposed route would be by the way of Newfoundland to Ireland and would keep the fliers over the water little less than 2,000 miles.

Within a few hours he expected to be in New York where they plan to remain three or four days. Meanwhile, General Balbo and his 24 officers will fly American planes to Washington where they will be greeted by President Roosevelt.

New York, July 19.—(AP)—The Italian fliers took off at Chicago this morning and crowds were gathering at Floyd Bennett air field to greet them this afternoon. More than 600 police were assigned to the field for duty from early morning.

### Kiwanians to Attend Sectional Meeting of Eastern Chamber Here

Members of the Kiwanis club have accepted an invitation of the Eastern Carolina Chamber of Commerce to be guests of the organization at a sectional business conference at the Friendly Dining Room, here Thursday evening at 7:30 o'clock.

The theme of the meeting will be "The New Deal" and state officials congressmen and senators have been invited to attend and give their slant on the effort of the Roosevelt administration to lift the nation out of the slough of depression.

The conference has been extensively advertised in this immediate part of the state and scores of prominent in the business and professional life of the section were expected to be in attendance.

Although announcement of same had not been made, it was expected other organizations, like the Kiwanis, would attend the conference as a unit to help boost interest in the administration's effort to bring a return of the prosperity which Herbert Hoover saw around the corner through his administration, but was never able to induce it to round the bend.

### YOUNG LAWYERS SET FAIR MINIMUM FEE

Chicago, July 19.—(AP)—Young lawyers of the Junior bar association of the United States today agreed to establish a minimum fee of \$2 for consultation, and an hourly fee of the same amount if consultations are prolonged. For secretaries, stenographers and clerks who have not been admitted to the bar, a minimum weekly wage of \$14 and a maximum of \$30 was decided upon.

With Ickes holding the title of administrator, the President has preserved a situation where he personally can decide how the argument is to be settled.

Washington—There wasn't much advance notice of President Roosevelt's creation of a council to speed recovery plans.

When the announcement was made, press and public were quick to dub the new organization a "super cabinet" and although some observers maintained there is no justification for such a title, names of this type have a tendency to stick regardless.

Apparently what the President did was to create a temporary "two-house" cabinet. According to this classification, the first is a purely representative body composed of all those who have a finger in the effort to restore the nation's equilibrium. The second is strictly representative of those concerned with the normal process of government.

Liaison. Members of the President's cabinet sit on the new recovery council apparently because they are the directing heads of various parts of the recovery plan assigned to them.

Secretary Wallace, for example, has the duty of supervising the far-reaching farm relief act. Secretary Perkins is assigned the task of re-employment. Secretary Ickes has charge of the gigantic public works plan.

When President Roosevelt selected members of his cabinet, probably along with gauging their fitness to administer their articular departments, political considerations were not overlooked.

When congress returns in January and the political aspects of the legislative program have to be weighed, the pros and cons of the recovery administration and the regular affairs of the government must be considered in the light of the elections of next year.

For Example—It is to be expected that the cabinet itself and not the newly created recovery council will be the place where these phases will come to light.

As an illustration, suppose the set-up of a particular state organization comes up at a meeting of the recovery council. In all probability discussion and recommendations on the subject will be made with the idea of obtaining the greatest degree of efficiency.

But it is likely that any political consideration arising in connection will be dealt with in the cabinet.

# 'LEFTY' DEAN SETS UNIQUE MOUND RECORD

That boy "Lefty" Dean is a pitching fool.

The reason we know it is because he has pitched 45 1-3 innings, during his stay with the local club of the Coastal Plain League and has struck out 45 batsmen.

That's at the rate of nearly one man an inning.

In addition to this, he allowed a total of forty hits, made two wild pitches, hit one batsman, issued a dozen free passes, won three games and lost two.

The youngster is not only pitching at a lively clip, but the way he raps the old apple to the outer garden when at bat has brought inexpressible joy to the hearts of local fans from time to time. He plays outfield and first base in addition to his work on the mound.

Although Dean had the most unique pitching record, Bob Forber who has been with the club since it was organized about two months ago, led the pitching staff with four victories to his credit against one loss. He has pitched a total of 53 innings and had 31 strikeouts to his credit. He allowed 12 bases on balls, hit one batsman, made two wild pitches and yielded up 43 hits.

Roger Taylor, another former local high pitcher, takes second place. He too, has been with the club since the beginning of the season and has participated largely in exhibition games. His work has been exceptionally fine at times. He is credited with one victory and two losses. This includes only the regular league schedule. Also he made 10 batters whiff the breeze, issued 6 free passes, hit four batsmen, made three wild pitches and gave up 21 hits in a total of 131 1-3 innings.

Sigmon, like Dean, is a newcomer to the league and has not had much of an opportunity to show his stuff, but so far he has two wins and one loss to his credit. Out of a total of 37 1-3 innings, he struck out 18 batsmen, issued 10 bases on balls, hit three batters, made three wild pitches and allowed 28 hits.

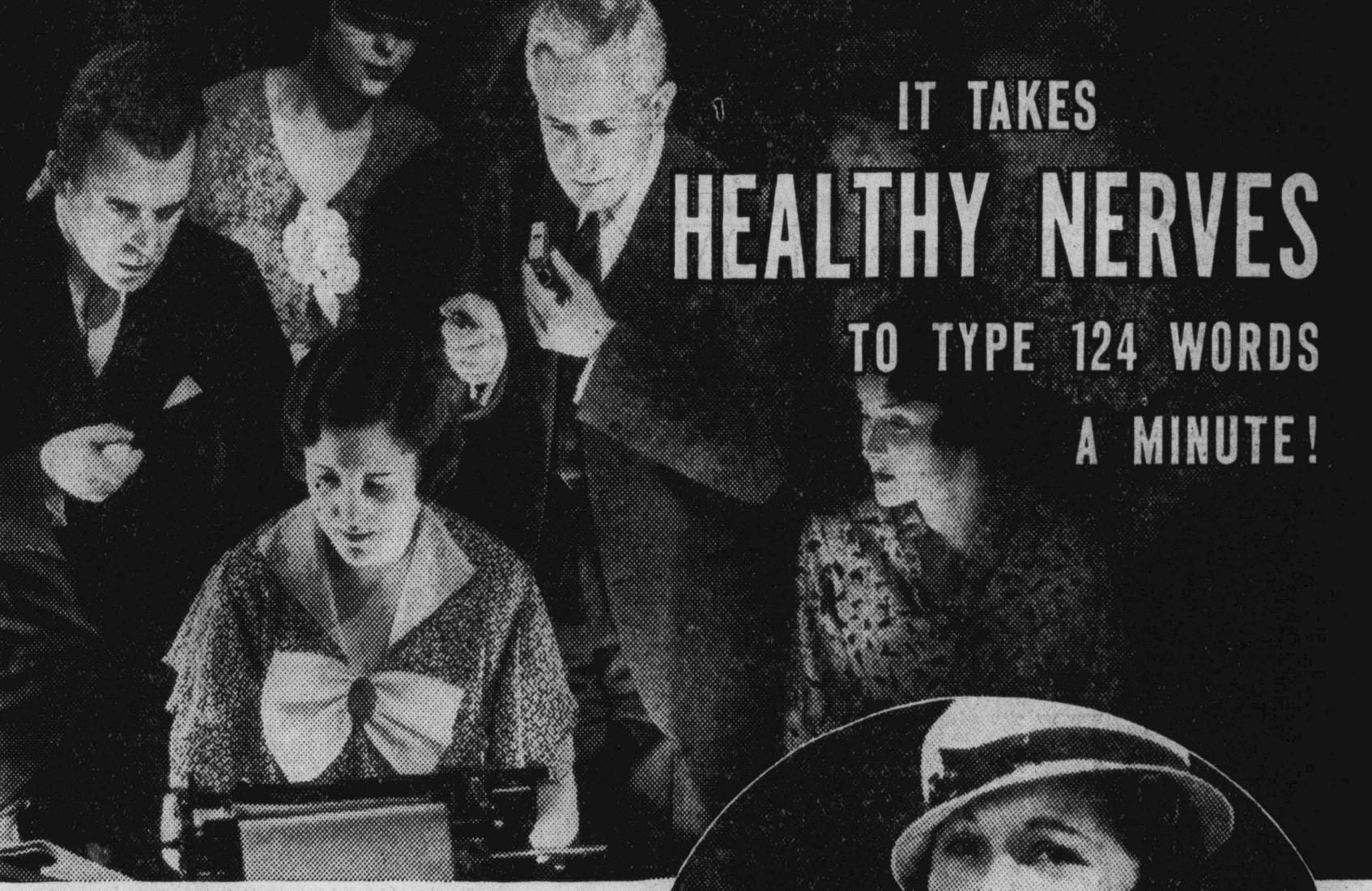
