FORTY-HOUR WEEK APPROVED FOR TOBACCO TRADE

About 16,000 More Employees To Receive Jobs

EIGHT HOUR DAY WILL BE IN FULL FORCE

Minimum Wage Fixed 40 Cents an Hour; Peace Workers to Receive 25 Cents; New Agreement Submitted by S. Clay Williams, Head of Tobacco Code Committee in America

Washington, Aug. 16.—(AP)—A forty-hour work week is provided in a modified president's re-employment agreement approved today by the National Recovery Administration for cigarette, chewing, smoking tobacco and snuff industries.

S. Clay Williams, chairman of the code committee of the industries, in a telegram today to Administrator Sator estimated that inclusive of seasonal employees, 16,000 additional workers will find jobs in the next sixty days in the industry.

Under the terms of the agreement the maximum work week is fixed at 40 hours for more than 400,000 workers in the industry. The rate for peace workers was to be placed on an average of four weeks of June, 1933 and to yield an average return of not less than 25 cents an hour.

TAX RATE OF 92 CENTS FIXED FOR BEAUFORT

Washington, N. C., Aug. 16.—Beaufort county commissioners' meeting in the city yesterday late in the day fixed a county-wide tax rate of 92 cents on an approximate \$20,000,000 valuation.

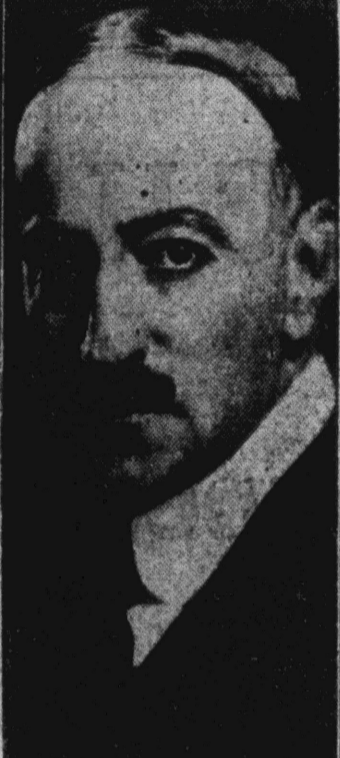
CHARLOTTE VOTERS REJECT BY A VERY NARROW MARGIN

SEEK CODES FOR TITANS OF U. S. INDUSTRY

Steel, Oils, Coal and Automobiles Receive Attention of Administration

Washington, August 16.—(AP)—Vexing difficulties in formulating trade codes for the four Titans of American industry—steel, oil, coal, and automobiles—today were shortening the present drive of the NRA toward its goal of enfolded all business under the yoke-spreading regulatory agreement.

To complicate the issues affecting the administration, Hugh Johnson and his aids were told by organized labor that steel was flaunting the recovery machinery effort to compose difference.

Johnson in bringing all NRA facilities to bear on the four major industries, sent word to them that codes must be agreed upon immediately as to production, wages and hours.

INCREASE TAX RATE, DECREASE VALUATION

Elizabeth City, Aug. 16.—A tax levy of \$1.41 for Pasquotank county was approved by the board of commissioners in meeting Monday. This rate is higher than last year but a saving of \$7,500 for taxpayers is expected as a result of a one-third reduction in real estate, authorized a few months ago.

Police said they found a letter from Shank in the clothing of one of his victims, Mrs. Ethel Colley, advising her and her husband, Alvin to "keep eyes open and mouth shut" and he would soon join the "and you will all be rich."

RENOVIZE THE UNITED STATES

Eighty-five per cent of Americans are inadequately housed. Seventy-five per cent live in hand-me-down quarters bare of modern comforts and conveniences. Where our annual building expenditure in 1928 was \$6,500,000,000, it was only \$1 billion last year.

These facts appear in an editorial in the St. Clairsville, Ohio, Chronicle. And, as the editorial further points out, there are sound indications that a major building revival is on its way. Every American desires better living conditions; millions of American have been prevented from achieving them the past few years either because of financial stress or fear of the future.

That fear is now being allayed—recovery has started, and it can be seen in all parts of the country. Men are going back to work, factory chimneys are smoking—and dollars are finding their way into pockets from where they will go to buy the necessities of life. A good part of those dollars will either be used to build new homes, or rebuild and modernize old ones.

It's time for a national campaign to "Renovize the United States." That would speed recovery and be the most potent influence that could be brought to play in stabilizing price levels and providing employment.

Remember that employment and investment are better and cheaper than charity. Remember, too, that in a few months, when the building boom gets underway, prices are going up and are going to stay up. Get in on the "building bargains" while they are still being offered.

He is stern and he glowers as he mentions the name of Hollywood. Come October, when he will be free of his contract, and he will be gone to New York in the winter.

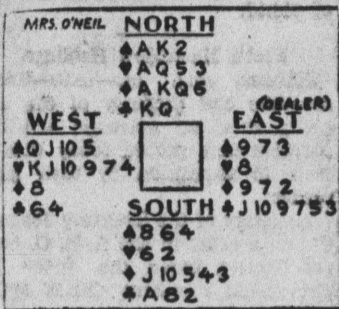

PSYCHICS FOILED

After the dealer and second hand have passed scum players are prone to open light third hand on a distributional holding, having no quick tricks. The purpose is either to protect the dealer's pass of a strong hand or to deter fourth hand from making the most of a strong holding.

A double by a strong fourth hand ordinarily will expose a light third hand opening, but there comes from Freeport, N. Y., a hand in which another method occurred to fourth hand. These were the cards:



East and South passed, J. Randall Youatt, West, thought a semi-psychic of one heart would do no harm and possibly would prevent North going somewhere. Mrs. Dolly O'Neil in the North feared that a mere double would fail to picture things to South, especially if his hand should be nearly worthless.

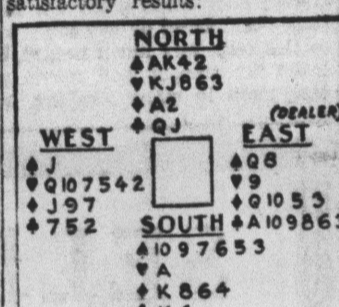
Because of West's heart bid she had reason to believe she could be certain of at least eight tricks at no trump. Her hand was worth an original two forcing bid and so she bid two no trump.

East passed, South having a five card suit and a side ace, bid three diamonds. West was silent and North took the diamonds to five.

South, noting the strong two no trump overall followed by the leap to five diamonds, bid little slam in diamonds, which was made easily.

A double of the one heart bid by North might have worked out the same but North after a two-diamond bid by South probably would have proceeded more cautiously as the diamond offering might be a minimum. South's three diamond bid over two no trump obviously inferred a certain measure of strength.

Here is a hand from Provincetown, Mass., where a double of a third hand semi-psychic produced satisfactory results:



Two passes and West bid a heart which North doubled. East feared there might be a strength pass South and bid two clubs. Ernest H. Morris, South, bid two spades, determined to show strength by a voluntary bid and confident that North's double of hearts was based on strength in spades.

After a pass West, North went to four spades. East passed and South bid five hearts to show no losers in that suit. North took the contract to six spades. The only loser was the ace of clubs.

New Books

of the week has almost no text in it. This large tome is entitled "The First World War," and its content is almost entirely photographs.

There are 513 photographs, chosen from uncounted thousands by Otto Kurth with what must seem to most "readers" uncommon perspicacity. The photographs are prefaced by a short introduction by M. Lincoln Schuster, and a similar bit of prose by Lawrence Stallings, to whom the book is credited on the title page.

And they are an astonishing argument against war, those photographs, as well as a panoramic view of the last great war. Perhaps the most subtle thing about the work is its title—with its unavailing emphasis on the word first. Impressive is the strange restraint by means of which the horror of war is brought home to the reader.

There is something peculiarly heart wrenching about the sight of those thousands of marching boys when two or three "shots" of rotting corpses are dropped into the midst of them.

Mr. Stallings has furnished very brief captions for the pictures.

Success Story. It is nothing new, F. W. Bronson's idea that honesty is not al-

ways the best policy, and that bluffs often are not called after all. But he expresses his truism well enough in "An American Hero" that his reader's interest need not flag even in August weather.

His American hero was a boy whose chief virtue seems to have been an ability to play first rate football. He was the son of an alcoholic father and a washerwoman; his minor assets were an infectious manner and the gift of "getting on" with people.

His way was paid through college because of his football prowess; his way was paid through life by less tangible but not more important coin. He drove one woman to suicide, and deceived another. He made and lost a fortune, and made a second, not without cheating. Altogether, he is a man we all know and somehow don't dislike as much as we perhaps should.

Mr. Bronson's book is written in clean and spare prose and with a very keen eye for contrast and clarity. There are some vaguenesses, but they are in characterization, not in expression.

SPORT SLANTS

The Giants are rooting for the Yankees to come through to the world series again in order to enjoy the benefits of another "subway series", but the Washington Senators, now in a more authoritative position so far as the American League is concerned, are pulling for the Giants.

Capital memories not only are still keen as regards the celebrated series of 1924 but the Senators feel that this season's "natural" is a battle of wits for baseball supremacy between Bill Terry of the Giants and Joe Cronin of the Senators, two of the youngest major league pilots.

They are not alone, of course, in Washington in fancying this idea for a world series duel. The fortunes of Terry, as McGraw's successor, and Cronin, as another of Clark Griffith's experiments, have attracted the interest of baseball fandom generally. I have talked with both pilots within recent weeks and if the burdens of a close race and their heavier responsibilities weight upon them, they do not manifest it. Terry and Cronin both have been settling most of the batting pace for their clubs. Each is a marvel on defense. Each has a buoyancy of spirit and confidence that has unquestionably proved infectious. Without wasting any time patting themselves on the back, Terry and Cronin both feel sure they are going to finish on top.

"Why, sure," says Cronin with that slow smile, seeming to say that the question is almost superfluous. The Senators have at no stage made the mistake of the Yankees in under-estimating their opposition. This may well explain the more consistent work of the capital crew, its ability to "take it" and come right back to win.

Of course when Babe Ruth and Lou Gehrig are not getting the range the Yankees do not look so impressive nor do they feel so good themselves. There is nothing strange in that. Any outfit would feel the handicap of having one of its big guns getting worn and the other misfiring. They may snap out of it and deliver the winning blows with a come-back charge but when they left for the great open space the Yankees looked exactly like this year's runners-up.

Secret Society, began the probe as Provisional President Carlos Manuel Des Céspedes' administration weeded out persons suspected of profiting by the Machado regime. It was reported that an embargo was planned on fortunes of the party of the Machadistas.

Police Seek Desperados
Chicago, Aug. 16.—(AP)—Fifty police with machine guns and rifles were rushed from Chicago into southern Wisconsin today in an attempt to corral a suspected band of kidnapers.

Police said the desperados sought probably were members of the same gang as the two fugitives who eluded 300 officers after a gun battle on Chicago western outskirts today. The exact destination of the mobilization of police was a secret but it was rumored to be in the Wisconsin summer resort region.

The notorious Tooley gang, four members of which have been named as the \$100,000 kidnapers of William Hamm, Jr., St. Paul brewer, was known to make headquarters in the region.

LATE CORN DAMAGED BY SEVERE DROUGHT
Raeford, Aug. 16.—Corn planted where cotton had been plowed up in compliance with the government reduction plan and that planted on stubble after small grain has been 90 per cent killed by budworms and so this crop, very much needed, because the drought had ruined the early corn in many localities, will

be a failure. The oldest inhabitant never saw corn die as it does this summer. Late garden truck is dying also, and many families will not have well-stocked pantries of canned vegetables next winter because we can't grow them this year.
