SET DEADLINE IN COTTON CUT

Growers Must Have Staple Out of Production By August 23

August 23 has been set as a deadline by the federal government for taking cotton out of cultivation. It was announced today by E. F. Arnold, director of the local farm department, and head of the cotton reduction drive in this country.

Mr. Arnold said he received a telegram from the Agricultural department this morning advising him of the deadline and urging him to impress upon growers the necessity of taking their cotton out of cultivation by that date.

Committeemen are already busy making their rounds of farmers at this time, and growers were urged by the farm director to make a complete measurement of the acreage taken out of production and be ready to check with the committeemen upon arrival.

The Greenville firemen captured three first honors, one second and a third place in the series of contests staged during the three days of activity.

SEN. COUZENS TESTIFIES IN BANK INQUIRY

Charges Lack of Law Enforcement Responsible For Detroit Situation

Detroit, Michigan, Aug. 18.—(AP)—Senator James Couzens resumed his testimony today with a declaration that "while the depression had much to do with the bad condition of the two local national banks, I am still ready to admit that much of it was due to lack of law enforcement by the federal authorities at Washington."

The Michigan Republican made this statement before Judge Harry B. Keldan, who is sitting as a grand jury to probe causes of the Michigan bank holiday which marked the beginning of the national crisis.

The statement came as a result of questioning by Prosecutor Harry Toy, who sought to show that the condition of the bank—the First National Bank of Detroit and the Guardian National Bank of Commerce—both closed by a state holiday—was the result of general supervision.

J. H. HARDEN BURIED HERE

Final Rites For Lineman Electrocuted Here Yesterday Held This Afternoon

Funeral services for Jimmie H. Harden, 32, lineman of the local Water and Light Commission, who was killed when he came in contact with a high tension wire seven miles west of Greenville yesterday shortly before noon, were conducted from his late home, 207 Second street, this afternoon at 4 o'clock.

Harden, who came to Greenville from Robeson county four years ago, met death while assisting a construction crew in rebuilding the power line between this city and Ballard's Cross Roads. He was up a pole at work with his foot on a ground wire when his arm struck one of the high tension wires, causing 6,600 volts of electricity to course through his body, producing instant death.

Harden, 32 years of age, had been in the employ of the power company since coming to Greenville four years ago. He was a member of the Greenville fire department.

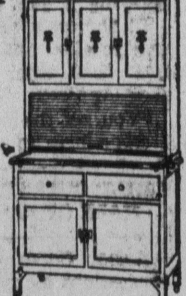

Dutch Communist Faces Trial For Reichstag Fire

Berlin, Aug. 18.—(AP)—Germany's interest is beginning to center on mid-September when the Dutch communist, Marinus van der Lubbe, will be sent to trial at Leipzig charged with setting fire to the Reichstag building February 27, a week before the elections which put Hitler in power.

Along with van der Lubbe, the government says, a number of German communists also will be tried. Although the names have not been announced officially, it is expected that Ernst Torgler, communist whip in the Reichstag, will be among the defendants.

Van der Lubbe, a chunky, beetle-browed man, was found, officials charge, in the Reichstag building the night of the fire. He was bare to the waist and the government charges he was firing the building.

Examinations indicated the building had been fired in 14 places. Torgler's connection with the case so far as it has been publicly announced, rests on the fact that he left the building about 20 minutes before the fires broke out.

BARBERING WHEAT FOR FLOUR SAVES MONEY ON TAXES

Flankington, S. D.—(AP)—The old mill wheel is steadily churning wheat processors back to a new prosperity in South Dakota.

Despite climbing wheat prices, farmers are bartering much of their wheat for flour direct from the mill. This trade saves the farmer one per cent gross income tax, and the miller doesn't have to pay the 30-cents a bushel processing tax affixed under the wheat allotment act.

With flour prices on the upswing, these tax exemptions save the wheat grower 70 to 80 cents for every 100 pounds of flour used, wheat growers say.

With this influx of new business, mills that for 50 years struggled through a precarious existence have started extra shifts.

NEW LEGATIONS TO SEAL JAPAN-AFGHANISTAN PACT

Tokyo, Aug. 18.—(AP)—Diplomatic relations between two widely separated Asiatic powers are to be established shortly.

Afghanistan has received Japanese approval for the dispatch of an Afghan minister to Tokyo. The Tokyo foreign office will ask the next diet to vote funds for a Japanese legation at Kabul.

A treaty of commerce and amity was concluded two years ago between the island empire and the mountain nation on India's northwestern frontier.

NOTE FOR IMMEDIATE PROGRAM OF BUILDING

Henderson, Aug. 18.—By unanimous vote, the board of trustees of the Henderson city schools went on record at a meeting Wednesday evening in the office of Supt. E. M. Rollins as favoring an immediate high school building program for the city on condition that adequate funds for the purpose can be obtained on favorable terms from the public works building funds of the federal government. The members were assured that there was every likelihood that the money could be obtained.

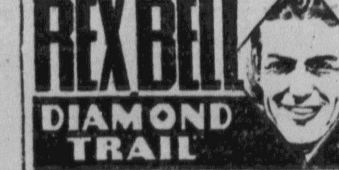

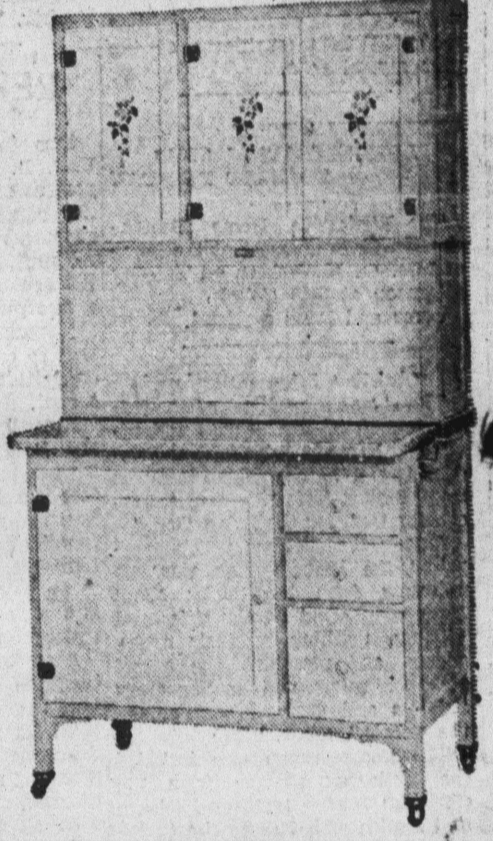

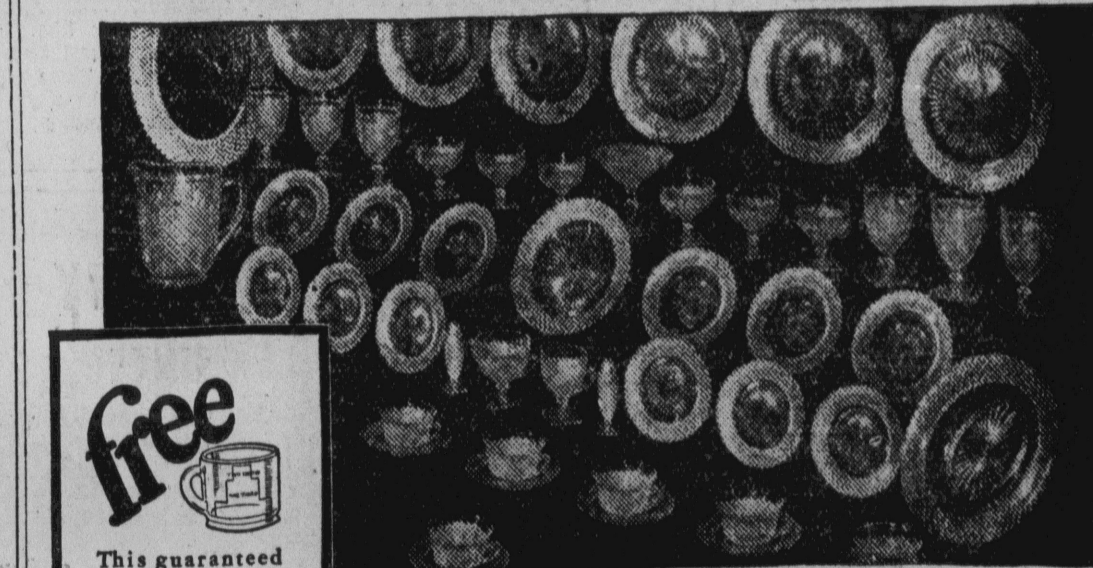

STEEL INDUSTRY RALLIES TO THE BLUE EAGLE

Code A Waits Signature Of The President

COAL AND OIL EXPECTED TO JOIN PARADE

Terms of Code Given To Roosevelt Over The Telephone Last Night; His Approval Of Agreement Considered Certain; Hugh Johnson Announces Terms of The Agreement

Washington, Aug. 19.—(AP)—Steel today led America's four biggest industries toward Blue Eagle membership.

On President Roosevelt's desk today is a document which will be a dramatic step toward the steel code and speed pending the plans for automobile makers.

Presidential approval and the proclamation on the steel agreement was virtually certain.

Then Hugh S. Johnson, National Recovery Administrator, announced the agreement reached on the steel code involved.

Hours: Average of 40 hour week over a three month period with maximum per employe of 48 hours and a six day week.

On or after November 1, 1933, or as soon as production reaches 80 per cent capacity, the eight hour day for all employes except supervisory and technical and emergency employes.

Wages: A general increase of 15 per cent has been made since July 1. The minimum wages fixed in the code are estimated by steel companies to exceed the average of 40 cents an hour.

The arrivals were Oscar B. Sintas, Cuban ambassador to Washington under Machado, and Ramiro Gujara, former secretary of the deposed Cuban president.

They landed from the liner Morro Castle on which the Anti-Machado party is booked to sail.

TRUCK CODE TALKED HERE

Bailey Groome, of Charlotte, Addresses District Truckers Here Last Night

Bailey T. Quick Naturalization Of Einstein Being Sought

London, Aug. 19.—(AP)—Steps are being taken here to obtain for Prof. Albert Einstein—citizen of the world but of no country—rapid naturalization as a British subject.

The champion of the famous German Jewish savant who lodged notice at the German embassy in Brussels renouncing his German nationality, is Commander Oliver Locker-Lampson, a member of parliament.

Search For Short Cut Commander Locker-Lampson, who was Prof. Einstein's host on his recent visit here, introduced a bill in parliament just before it adjourned which was designed to permit citizenship in Palestine for Jews deprived of citizenship elsewhere.

But for the scientist, the commander believes, this would be neither adequate nor sufficiently prompt. So he is seeking, through the home secretary a more rapid naturalization process.

Prof. Einstein himself sat in the distinguished strangers' gallery in the house of commons just before adjournment and listened to his host plead for the extension of opportunities of citizenship for Jews resident outside of the British empire.

MAP TRUCK ROUTES HERE

New Transportation Set-up Must be Submitted to State School Commission

A map of truck routes of Pitt county school districts was being prepared by W. S. Stafford, director of transportation of Pitt schools for submission to the State School Commission at Raleigh.

The map, giving every truck route in the county, must be passed on by the commission before the transportation set-up of the county for the coming fall term become and actuality.

Assisting Mr. Stafford in arranging the new routes was T. A. Atmore, of Washington, member of the commission, who is rendering similar services to other sections of the state attempting to solve transportation problems.

The re-routing of the districts is being conducted according to legislation passed by the last General Assembly. Appropriations for this purpose have been cut sharply the last year, causing the taking off of at least six trucks in this county.

Approximately 250 children who rode to school last year will either have to walk this year or provide their own means of transportation.

Mr. Stafford made known sometime ago that children living within a radius of two miles of a school district would have to walk this year or ride a bicycle or mule. The 100 trucks operated by the system last year will be reduced to 94 this year.

County school authorities said they were doing everything possible to make transportation facilities reach as far as possible but they can go so far and no further because of the low providing specific transportation rulings.

All double truck trips will be eliminated this year and trucks will be required to operate direct to the schools.

THORNE TELLS OF LEAF PLAN

State Committeeman Says Federal Government Will Curtail Acreage Next Year

Plans of the federal government for curtailing production of the bright leaf tobacco crop next year were outlined to the Pitt County Board of Agriculture this morning by John T. Thorne of Farmville, North Carolina committeeman in the federal reduction drive.

Mr. Thorne, who recently attended a conference of representatives of growers and the federal government at Washington, told the department members the meeting was favorable toward tobacco control in a similar plan as that applied to cotton and wheat.

This provides for a processing tax on the manufacturer of domestic tobacco with the farmer being paid to take a part of his crop out of cultivation.

Mr. Thorne said the plan would be fully worked out and presented to growers in time to take care of next year's crop. The reduction movement is an effort on the part of the government to relieve the congested world market and cause a rise in the price of tobacco.

After hearing Mr. Thorne the board passed a resolution expressing appreciation to the Board of County Commissioners for cutting a door through the attorney's room on the second floor of the courthouse to increase facilities for the handling of acreage reduction movements.

DEAD PERSONS COMING BACK FROM CHICAGO

Ten Others Injured As Truck Collides With Bus Carrying Sightseers to World Fair; All of Dead From Waker, Indiana, Except One From Leesburg

South Bend, Ind., Aug. 19.—(AP)—Six residents of Waker, Indiana, were killed and ten others injured, several perhaps fatally, today when a truck converted into a motor bus in which they were returning from an outing at the Chicago World Fair, was sideswiped and wrecked by another truck near here.

One side was torn off the makeshift bus which careened wildly down the road strewing its passengers, dead and injured, for a distance of several hundred feet before it went into a ditch.

All of the dead were from Waker except one whose home was in Leesburg, Ind.

Twenty-eight young people had spent Friday at the Century of Progress Exposition and were laughing and singing when the heavy truck lumbering along from an opposite direction sideswiped the bus.

TEACHER-PAY SCALE GIVEN

Salaries From \$45 to \$90 a Month Would Be Paid in This State

Raleigh, Aug. 19.—(AP)—North Carolina school teachers would be paid salaries ranging from \$45 to \$90 a month the coming year under a scale to be submitted to the State Board of Education by a special committee.

A maximum salary of \$115 per month was provided for principals in seven teacher schools with a minimum of \$65. Principals of city units could not get more than \$2,500 a year.

The scale has been approved by the State School Commission and likely will be acted upon within a few days by the Education Board.

 Washington, Aug. 19.—(AP)—There's a great deal more than the plight of the Cuban people that is worrying President Roosevelt and his advisers as the little island republic continues in a state of political uncertainty.

Our relations with the Latin-American countries at the present show great promise. The marines have left Nicaragua. Haiti is due to be evacuated long before the treaty requirements.

The accusation so often leveled at the United States in these countries that American capital is inevitably followed by American marines and American warships seems to be losing much of its force.

A better feeling prevails, too because President Roosevelt appears desirous of bringing about an understanding between the two continents during his administration.

His announced policy of "good neighbors" with the Latin American countries is expected to bring results.

Enter, A Menace.

The approaching Pan-American conference at Montevideo in December has a large place in his scheme of promoting this feeling of good will.

He thinks it so important and is so hopeful that it will bring important economic results to all concerned that Secretary Hull of the State Department may attend.

The Cuban situation threatens the President's whole plan.

Were American marines and blue-jackets ordered to the island, there is indication the campaign of anti-American propaganda that has caused such concern in the past might be revived.

Again there might be heard the warning to beware of the greed of the United States.

Seeing Through My Windshield

(By ETHEL NICE, E. D. A.)
The following are some recipes used by Miss Martha Ross Temple at the State Short Course:
Hot Water Pastry
1-4 cup shortening; 1 cup sifted bread flour; 1-2 tsp. phosphate baking powder; 1-4 cup boiling water; 1-2 tsp. salt.
Beat the shortening and hot water together with a fork until the shortening is almost melted. Quickly sift the flour, salt, baking powder into the water. Mix lightly, then form into a ball and chill for about 15 minutes. Roll thin, fit into a pie pan, prick and bake in a hot oven (450 F.) for about 12 minutes. For a pie crust, pie, use one and one-half times this recipe.

Marshmallow Filling
1 cup dried marshmallows; 1 cup granulated sugar; 1-4 cup water; dash salt; 1 egg white; 1-2 tsp. vanilla.
Melt the marshmallows over hot water. Combine the sugar, water and salt and cook to the firm stage (280 F.). Pour onto the egg white beaten until stiff. Add the vanilla and the melted marshmallows and beat until the filling holds its shape.

Applesauce Spice Cake
1-2 cup shortening; 1 cup granulated sugar; 1 egg beaten light; 1 tsp. cinnamon; 1-2 tsp. cloves; 1-2 tsp. soda; 1-4 tsp. salt; 1-1/2 tsp. phosphate baking powder. 1 cup applesauce (strained and sweetened); 1-3/4 cups pastry flour; 1 tsp. vanilla; 1 cup raisins, dates and nuts mixed.
Cream shortening, add sugar and beat. Add the eggs and mix well. Sift the dry ingredients saying 1-4 cup to dredge the nuts and fruit and add alternately with the applesauce and the vanilla. Add the flour and nuts and fruit. Turn into a loaf pan and bake in a moderate oven (350 F.) 40-45 minutes.

Molasses Cookies
1-2 cup lard; 1 cup molasses; 2 tbs. warm water; 1 egg (beaten); 3 cups bread flour; 1-4 tsp. salt; 1-4 tsp. soda; 1-2 tsp. ginger; 1-2 tsp. cinnamon; 1 tsp. phosphate baking powder.
Mix together shortening, molasses and warm water; add beaten egg. Sift together dry ingredients and add to first mixture; mix thoroughly and let stand ten minutes. Roll out on floured board to 1-3 inch thick; cut with round cutter and bake in hot oven at 400 F. about 10-12 minutes.

Cocconut Peanut Loaf
2-3 cup butter; 1 cup granulated sugar; 3 eggs; 2 cups pastry flour; 1-1/2 tsp. phosphate baking powder; 1-4 tsp. salt; 1-2 cup cocoanut; 1-3 cup nut meats (broken); 3-4 cup milk; 1 tsp. vanilla.
Cream the butter and add the sugar slowly. Add the egg yolks and beat well. Sift the dry ingredients and add a small portion to the cocoanut and nuts. Add the remainder alternately with the milk and vanilla extract. Add the flour and nuts and coconut and fold in the egg whites, beaten until stiff. Bake as a loaf cake in a moderate oven (350 F.) for 45-50 minutes. Ice with double boiler icing and cover with cocoanut and pecans.

3 green peppers; 3 red peppers; 3 large onions; 3 large cucumbers; 2 medium heads cabbage; 2 quarts green tomatoes; 2 quarts red tomatoes; 4 cups vinegar; 2 cups brown sugar; 1-2 tsp. tumeric; 2 lbs. mixed pickle spices (dried in a small bag).

Things about which some furor may be made in the prints or the record books or among the fans do not seem to register any lasting memories with the performers themselves.

Ninety-nine out of every 100 boxing fanatics who recall the Dempsey-Firpo fight, either by hearsay or as an eye-witness, dwell at much length on the "mighty blow" by which the Wild Bull flung our champion right out of the ring into the lap of Mr. Jack Lawrence, then on the staff of the New York Tribune.

But Dempsey will tell you, as he has told me, that the hardest blow he took in that fight was the very first punch that Firpo landed, a right to the jaw delivered as they rushed from their corners. In fact Dempsey says he saw at least three Firpos for the remainder of that hectic first round and on that basis he floored each of them 2 1/3 times.

Ruth's Memory Fails
Most any small American addict of the national sport of baseball know more about the details of the great G. Herman Ruth's clouting records than the genial Babe himself.

I put to him the same query that had been handed me: Do you know how many homers you have hit off Lefty Grove or when pitcher you hit for the most homers altogether?

He couldn't even make a guess. I told him the count was nine off Grove and so far as I could locate 14 each off George Daus and Howard Ehmke, for the high mark off any flinger.

"What about that Walburg?" he countered. "I musta hit plenty off him. Why I nicked him for seven

one year, 1927, when I made the record."

At the moment we were in the Yankee dugout. Although skeptical I could not dispute the great man until I took another dive into the record books, finding that unless the official scorers had astigmatism Ruth collected only four homers off Walburg in 1927.

The Babe 'Fixed Him'
There's a classic story told about the days when Ruth was a great left-handed pitcher for the Red Sox moving the enemy down with speed and rare control.

The Babe had instructions between innings to "dust off" one of the opposing batsmen expected to come up in the next inning. He was given the name and nodded in complete agreement and understanding.

As it happened this particular batsman was replaced but it didn't mean anything to Ruth. He followed orders anyway, "got his man" and then came in to the bench chuckling.

"Well, I guess I fixed so-and-so the way you told me, didn't I?"

Push For Coal Code

Washington, Aug. 19.—(AP)—Getting final drafts of NRA codes for steel and oil on President Roosevelt's desk today was Hugh Johnson's chief concern, but he found time also to press for an agreement among bituminous coal operators.

While the agreement on steel was reached in the early morning hours it was being polished for the President's consideration. Johnson met oil men conferring with the industry who favored a more rigid price supervision than contained in the administration code.

Then he went into conference with his own oil advisers.

Although speedy completion of the coal agreement was another NRA intention it was conceded by officials that the final code could not be placed on President Roosevelt's desk before he leaves tonight for Hyde Park.

Johnson acted to prevent evasion of the modified re-employment signed by the restaurant industry. He ruled that owners could not nullify the minimum wage provis-

ions by charging employees for meals unless that had already been the practice in a particular restaurant prior to June 15.
