# HOLD UP MEN BREAK JAIL

## KIDNAPPER GETS OUT OF TEXAS JAIL

### Harvey Bailey Leader of Outlaw Gang Makes Daring Escape Early Today

Dallas, Texas, Sept. 4.—(AP)—Harvey Bailey, charged with kidnaping Charles E. Uchel, Oklahoma City oil millionaire and shooting four officers and their prisoner, escaped from Dallas County jail about seven o'clock this morning. The notorious outlaw leader escaped as he was being taken breakfast. He escaped in a prison car and carried Nick Trest, one of the jailers, with him. Bailey was a leader in the break at Kansas City last Memorial Day. He had been held in Dallas County jail since his capture several weeks ago on a farm near Paradise, Texas. He was indicted with a number of others in the Uchel kidnaping and was to have been transferred to Oklahoma City for trial on that charge.

When Charlie Young, deputy jailer, took Bailey's breakfast up to him this morning he found the prisoner with a pistol in his hand. Young walked up the flight of stairs to the death cell above where Bailey was confined and when he unlocked the run-around he found that Bailey was not in his individual cell but in the run-around. "I ought to kill you, but I won't, you've been so nice to me," Bailey told Young. "Now give me those keys. Hurry and be quiet." He took the keys, locked Young in the death cell and then walked down to the sixth floor where he met Ed Morrow, jailer, on duty. He covered Morrow and asked about the elevator. While he was quizzing Morrow about the elevator a negro trusty brought the elevator to a stop at the sixth floor, accompanied by the prison chef. Bailey locked Morrow and the chef in a cell and ordered the trusty on the elevator to carry him to safety below.

## RHOADES IS APPOINTED TO FEDERAL OFFICE

Asheville, Sept. 4.—Berne Rhoades former executive secretary of the North Carolina Park Commission, has resigned his position with the real estate department of the Wachovia Bank and Trust Company to accept a position with the emergency administration of the federal public works program at Washington. He received notice yesterday of his appointment to the government service and expects to leave Asheville about September 12, to assume his new duties. He was secretary of the Park Commission for five years after it was first organized and resigned that place to go with the bank before going with the park board, he was supervisor of the Pisgah National Forest.

## Ford's Lone Battles Set Precedent For His Controversy With NRA

Detroit, Mich.—(AP)—The controversy that began to simmer in the first uncertainty at to Henry Ford's reception of the NRA code centered about an industrialist accustomed to "going it alone."

For it was Ford who years ago fought through to a finish the court battle over the "Selden patents," and won freedom from payment of fees on the patents.

Again he played a lone hand in his battle with New York interests. Rejected Wall Street Terms

In 1921, it was Ford who turned down the terms of "Wall Street" To realize on funds tied up in inventory, he started his factory at top speed and notified his dealers to dispose of the flow of trucks, tractors and automobiles or surrender their agencies.

He did not stop until he had built his own system of steel mills, glass factories, steamships, a railroad and other enterprises to supply his raw materials and distribute his product.

## FIND LIMBS OF WOMAN AT DETROIT

### Officers Begin Effort to Unravel Detail of Gruesome Tragedy

Detroit, Sept. 4.—(AP)—The arms and legs of a woman hacked roughly from the body were found in the bushes in a field on the northwestern outskirts of this city today. The limbs were identified by the finger prints of those of Lourier Jobb whose fingerprints were on file with federal immigration officers. Search began immediately for the rest of the body.

Dr. Edmund Knobloch, coroner, said the limbs were hacked off the body shortly after death.

Miss Jobb was arrested in connection with an immigration case in 1932 and she was 19 years old.

Police barred all persons from the field where the limbs were found for other parts of the body. Detectives of the homicide squad expressed belief that the slayer had probably hidden the head and torso in other parts of the city and a widespread search there for the other parts of the body was begun. The arms were cut off at the shoulders and the legs at the knees.

The hands showed signs of excellent care and the nails had recently been manicured. Dr. Knobloch believed the woman had been dead not more than 48 hours when the limbs were found and that amputation had been made within 24 hours of death.

## Ask Government To Buy Tobacco In Order To Assure Increase Prices

Washington, Sept. 4.—(AP)—Delegations of tobacco growers and warrentsmen met here today with representatives of the Farm Adjustment Administration to present plans for increasing the price of cured tobacco prices in North Carolina and South Carolina and other states.

The delegations included Gov. J. C. B. Ehringhaus and other representatives of North Carolina, South Carolina and Virginia.

After the morning session had assembled the committee drew plans for presentation to J. E. Hutson, chief farm administrator of the tobacco section, and

Chester C. Davis, director of production.

Tobacco markets are now closed in North and South Carolina because of low prices and Gov. Ehringhaus indicated that they would not re-open in his state until there was assurance of better prices.

Governor Blackwood of South Carolina, was represented by Ashton H. Williams, and Governor John G. Pollard of Virginia, by George W. Kolner, state commissioner of agriculture.

Delegation members said they planned to see President Roosevelt, if necessary, in their effort to bring action to raise the (Continued on page four)

## COLLISION FATAL TO POMONA MAN

Greensboro, Sept. 4.—(AP)—Lairron Hobson Kohn, 31, of Pomona, a suburb of Greensboro, died in a local hospital yesterday as a result of injuries inflicted in an automobile collision on West Market street Saturday night.

Following Kohn's death a warrant charging manslaughter was served on R. E. Rackley of this city, who was driving the automobile with which Kohn's car collided. Bond for Rackley's appearance in city court September 15 was posted. Police stated Kohn was driving on the wrong side of the street at the time of the collision.

Mrs. R. E. Rackley, who was in the car with her husband, sustained a broken arm and a knee injury. She is improving in a local hospital. Only minor injuries were inflicted upon Rackley.

## SIX DEATHS OVER WEEK END IN THIS STATE

### Automobile Accidents Continue to Add to List of Killed and Injured

(By The Associated Press)  
The week-end harvest of deaths from traffic accidents and violence in North Carolina stood at six today and at least three men faced charges as a result of the fatalities.

An early Sunday morning ride ended in instant death for Mrs. Jackie Lineberry, 26, of Greensboro, near Lexington. The roadster in which she was riding with two men and another woman struck the rear of a truck which they were attempting to pass and officers believed Mrs. Lineberry's head came into contact with the truck. Ernest Smith, driver of the car, was held under \$500 bond pending investigation of the accident.

Ralph Roberson, of Asheville, died in a hospital following injuries received when his car left the road and smashed. Suncombe deputies arrested John Dryman, alleged driver of the car, and lodged him in jail.

A Saturday night collision at Greensboro resulted in the death of Lairron Hobson Kohn 31, of Pomona, Greensboro suburb, and the placing of manslaughter charges against R. E. Rackley, Greensboro, man said to have been driving the car that collided with Kohn's car.

Noah Shehan, 26, mill worker, was killed when he was struck by a train near China Grove. Miss Farness Homewood, 18, of Burlington; Howard Barber and J. M. Stensen, of Belmont, were injured when their car crashed near Burlington, while D. E. Lawson, of Florence, S. C., was seriously injured when his machine skidded off the road and crashed near Four Oaks.

Ney Dayton, 65, was shot near Southern Pines by Jack Elliot, 26, who claimed that Dayton attacked him and he shot in self-defense.

At Elk Park Ira Dugger, ice company electrician, was electrocuted when he came into contact with an electric wire.

An inquest into the accident will be held tomorrow morning by Dr. John L. Carroll, coroner.

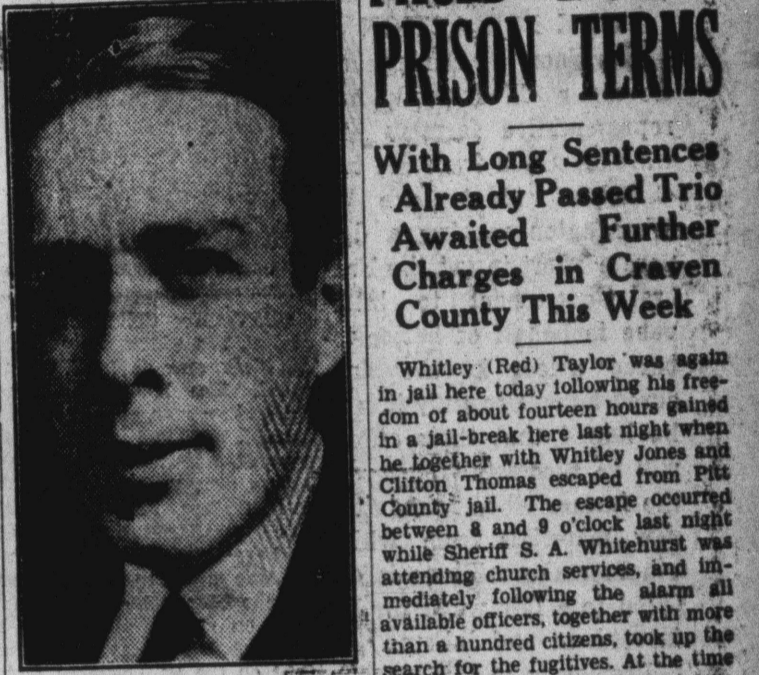

## STORMS STRIKE FLORIDA COAST

### Heavy Property Damage But no Casualties Are Reported Today

Fort Pierce, Fla., Sept. 4.—(By Radio to Associated Press)—Considerable property damage was done here by the tropical storm that struck last night, but no casualties have been reported. Loss to citrus was heavy.

Zero Beach, 16 miles north of here, experienced about the same effects from the storm winds as Fort Pierce. Mayor Alex McWilliams, of Zero Beach, said while property damage was considerable, no estimate had been made. A hurried survey of the territory revealed the usual storm debris, overturned sheds, garages and one large packing house at Zero Beach partially unroofed.

Losses to the citrus crop were estimated from three-fourths to the entire crop in sections. Trees blown down on the highway north of Zero Beach impeded traffic.

## Domestic Plans Curb Roosevelt Hand Abroad

There will be a great deal of talk but no one in Washington really appears to expect much out of the current reciprocal trade negotiations or the coming war debt discussions.

The reason for this is the President Roosevelt is launched on a very definite program of national rehabilitation, and he can not go very far on the international tack just now without running into complications which might weaken what he is doing at home.

Long before he came to Washington, Mr. Roosevelt had an idea of making up some sort of "consolidated ledger" account with other nations, figuring in the debts and trade considerations. The suggestion was that we agree to take certain goods, in certain amounts possibly in part payment of war debts, and to export certain other goods.

He discussed this idea with at least one foreign statesman when he was in Europe two years ago. But the trouble was that to agree to take a certain amount of imports would almost inevitably lead

to some dislocation and unemployment at home. That can not be risked now. Perhaps a year or two hence, if conditions here are brought to normal by the Roosevelt domestic program, these negotiations may be revived with a real prospect of action.

It's Not All Rosy  
Viewing the concessions made to labor under the NRA codes, it might be supposed that William Green, president of the American Federation of Labor, is one of the happiest men in the country today. Then we realize means a promise of higher wages, shorter hours, no more child labor, union recognition in fields such as the soft coal industry, where there has been nothing but antagonism to unions heretofore.

TIME FOR ACTION

Governor Ehringhaus, Governor Blackwood and representative farmers and warehousemen from the two Carolinas today are in Washington making a desperate effort to get the Federal Government to intervene in behalf of better tobacco prices in the flue-cured belts. Certainly it is to be hoped that their efforts will be successful for surely the farmer who raises the raw materials from which others make millions is entitled to a fair wage for his investment and labor.

Previously in this column we have referred to the fact that most everybody who touches tobacco makes a profit out of it except the grower and that in some instances a single tobacco manufacturing company makes more net profit in a year than the entire crop brings.

Recent figures made public on the 1931 crop reveal the fact that after leaving the farmer's hands every acre of tobacco multiplied in value several times bringing great profits to others all along the line, the farmer at one end and the consumer at the other being the goats of the transaction.

Based upon government figures the farmer received an average price of \$77.93 per acre that was raised at an average cost of \$101.00. After leaving the farmer's hands the tobacco yielded a toll to the warehouses, freight carriers and other handlers finally coming into the hands of the manufacturers.

Then here's what came from that same \$77.33 worth of tobacco:

The job of Buck O'Mara's mob had nothing to do with the disposal of the cargo—their job was merely to put Dollaire and all his crew on the spot and then return to shore. Hideous—even if it were by way of retaliation!

Dollaire, suspecting nothing, would be taken by surprise, and he and his men mowed down. And he, Colin, must appear to take an active part in the killings. There was no way out of that. No bullet of his, of course, would find its mark anywhere; but if he were caught at that sort of thing, or the slightest suspicion was aroused that he was playing a passive role, his life would not be worth a second's purchase. A Washington Daybook

By HERBERT PLUMMER WASHINGTON—Now that the "new deal" has emerged victorious in its first court test, one of the most important and significant phases of the new administration's program has been reached.



It was something worth watching when the oil refiners of Texas came into the District of Columbia supreme court attacking the industrial recovery act and asking that it be set aside. Here was a test of one of the most weighty problems that have arisen since adoption of the constitution itself.

The refiners complained that the President is, exercising powers which must be exercised by congress alone. And when their counsel was asked by the presiding justice whether he thought the act was based on federal powers over interstate commerce or power given to the federal government to meet emergency conditions, he answered flatly: "The act can't be sustained on any grounds."

Then The Court Spoke But the court, it has developed, indicated that it holds a contrary

view, by deciding that all laws, "including the constitution, should be read in emergencies in the light of the law of necessity." The final decision, of course—and one which might mean that the program of the "new deal" will either stand or fall—rests with the supreme court of the nation.

IT IS highly doubtful whether the supreme court will make a decision on the new laws any time soon. It's almost physically impossible. The court has adjourned until October. With the facilities the justices have at their disposal it would seem almost impossible for decisions affecting the "new deal" to be handed down during the next session which comes to a close in May, 1934.

Necessity Or Precedent

THE philosophy of the court as it is now constituted and as it has been revealed in decisions seems to many observers to be liberal. Even without the presence of Oliver Wendell Holmes on the bench this appears true.

While no one can predict what will happen to the new laws when they do reach the court, some believe this will play a prominent part. Meanwhile, speculation continues as to whether the important governmental changes made by the new administration are to be passed upon finally by justices having their eye on present conditions and not wholly on precedents. In this connection the District of Columbia decision is certain to be pointed to as significant.

There has been altogether too much sickness due to lack of food and the wrong kind of food. When the days of unemployment are over those folks who are unemployed because of poor health are going to feel very conspicuous. A big responsibility for the health of the family rests upon the mothers. Club members are realizing this and are continually improving the standards in meal planning. Practically all club members I have seen have helped some other homemaker with her canning.

Relief canning from the community gardens at Farmville, Ayden, and Greenville at this time amounts to 36,366 quarts. Considerable home canning has been done for relief gardens which does not show in this report.

## HOLLYWOOD SIGHTS AND SOUNDS

Hollywood.—A philosophical elow is E. Wynn, who confines the job of being "the perfect fool" to his career as a comedian.

On the stage 31 years, a star for 17, Wynn is out here to make his second talking picture. In Hollywood as in New York, however, he is continuing his hermit-like existence.

"I like to stay home," he says. "That's the main reason I don't go around much. A contributing cause, however, is the fact that I don't like to work at being funny all the time. Twenty-two hours a week is enough time to spend at that, and after I quit work I don't like to take my job with me."

**Doffing His Cap and Bells**  
In common with other comedians, Wynn has had the experience of finding himself called upon, on any and all occasions, to be amusing. But E. Wynn likes to let the actor rest off-stage.

For seventeen years he has made it a rule to appear in public, except professionally, as seldom as possible. Twice he has deviated from that rule here—once to attend a night club (the wished he'd stayed home) and then to attend a breakfast for the visiting governors.

Mid-mannered and genial, Wynn preaches laughter as a panacea. He thinks laughter could do away with war, and advocates a secretary of humor in the national government, courses in humor in the educational curricula.

**Saving Humor**  
"In the crash four years ago," he recalls, "I lost a fortune that represented my life savings. I cried around for three or four days, and then—suddenly I got a funny twist on it. What I lost was money I'd never seen, a couple of theaters I seldom saw. What good were they to me, after all? You can't go around carrying an armload of dollars; so what's the difference? I snapped out of it."

In 1919 Wynn was a leader in the actors' strike that resulted in formation of Actors' Equity Association. After that, because managers would have nothing more to do with him, he says, he formed his own company. He must have made money.

**McBRIDE OR 'OUSTER'— YOU TAKE YOUR CHOICE**  
McBride, Mich., Sept. 4.—(AP)—McBride—or Ouster—is a town divided against itself.

Though the town uses the same city hall, the same fire department and to all outward appearances is one municipality, it has two names. On one side of Division street is McBride. On the other is Ouster.

The mix-up developed in 1878 when two persons laid out towns on opposite sides of the road.

## Hitler-Wagner Romance Dies

Bayreuth, Germany.—(AP)—The rumored romance between Adolf Hitler and Winifred Wagner, gossiped about for years, apparently is off. Intimates of each say that only friendship survives.

Hitler is so busy with his chancellorship and his Nazi party that marriage is said to be further from his thoughts than ever.

Also, Frau Wagner is one of the few Germans who have refused to bow to a Nazi decree. The moment she heard of a radio order which barred Toscanini and some other distinguished American conductors from German air waves, she posted to Berlin and bearded Hitler in his den.

She told him the radio ban was a big mistake. Also she insisted that her star Jewish singer, among them Emanuel List and Alexander Kipnis, must be retained.

She had her way about the soloists. But the broadcast decree held and Toscanini refused to come to Bayreuth.

Outwardly relations continued cordial. Hitler came to the festival here and Frau Wagner gave a reception in his honor.

But she paid such a superlative tribute to Heinz Tietjen, manager of her festival operas, that gossip switched from Adolf to Heinz.

**SWIMMERS PLAN TO "FLOAT" TENNESSEE RIVER'S COURSE**  
Memphis, Tenn. (AP)—Louis Lundy, 20, of Memphis and L. E. Bruce, 17, Paris, Tenn., hope to make a "floating trip" over the entire course of the Tennessee river soon.

Lundy, back home in Memphis, told of their test trip about the middle of August.

"We spent 48 hours in the water, without food, while we floated 77 1/2 miles down the river from Danville, Tenn., to Baccuch, Ky.," Lundy said. "We floated by means of rubber inner tubes. For some years now there has been a movement to allow children to follow the line of least resistance in their choice of occupation both at home and in school. The child selects for himself what he wishes to study or play and is as far as possible allowed to guide his own pursuits.

Of course, it is all a reaction from an older notion that what was pleasant was necessarily wrong and that training lay in forcing a child to do what he disliked.

I am not sure which school of thought is the more harmful, and feel convinced that there is a middle ground so far overlooked, but which, if found, might avoid the weaknesses of both systems.

Certainly the child who works only from a sense of duty is unfitted for a happy life, but so is the one who works only at what he likes. Some things must be done because, for reasons not yet clear to the child, they are essential to his development both as a useful citizen and as a happy and contented individual.

Into every life there come times when duty—old-fashioned though the word sound—blocks the road. Today, more than ever, the world is full of men who, never having learned to use their hands must yet earn a living by manual labor, of women who, loving domesticity, must yet go out and find a job to support the family.

"The child is father of the man," and the best preparation for the exigencies of life probably would include a certain proportion of lessons in doing what one least likes to do; willingly, if possible, but if it is not possible, then because it is obligatory. His whole future may depend upon it.

Former Page Now Occupies Large Suite of Offices Opposite Old Job

By HERBERT PLUMMER Washington, Sept. 4.—(AP)—When the Democrats came into control of the Senate at the beginning of the present Congress, the choicest plum within the power of that body to bestow to an outsider fell to a man who had served the party long and faithfully.

In the old days, often it depended on how fast the colonel's legs flew as to whether the Democrats in the Senate suffered defeat or won a victory on various pieces of legislation. It was one of his duties to see that they were all on deck at voting time.

It's not necessary for him to do things like that these days. "Leggin' it" has been turned over to a young man especially trained for the job by the colonel.

But old habits are not easily forgotten—especially in so far as the colonel is concerned. He may have been assigned to the tall-ceilinged handsome suite with red and plush curtains and ferns, but the old urge to be where the battle is the thickest is still there.

When the Senate is in session, he may be seen almost any day on the floor conferring with senators on the Democratic side. When he was secretary to the Democrats, he held on to an old job that he had before as the party's par clerk. During the recent special session, many suspected that his presence on the floor at crucial moments, was to make sure that all of the Democratic senators not voting were properly safeguarded.

The colonel had another job, too, before his elevation from which he finds it difficult to tear himself.

For years, and under successive chairmen, he has been secretary of the Democratic Senatorial Elections Committee—the Senate body charged with not only keeping Democrats in their seats but also putting new ones where Republicans sit.

The senatorial elections of 1934 are the greatest political events next on the calendar. There are 16 Democrats who must face the electorate next year. There are 17 Republican seats to be targets for Democratic guns.

The colonel is already at work. The office of secretary of the Senate is administered by the colonel in impartial fashion. But, apart from that, there are many opportunities for him to labor in the Democratic political vineyard.

In the meantime a report reached this city from Pinetops officers that two white men, shortly after daylight had stolen a Ford roadster and robbed a filling station near Sparta and this lead was being followed to ascertain whether or not it had anything to do with the criminals wanted here.

Taylor, Jones and Thomas, together with D. G. Traylor, were convicted in criminal court here last week on charges of secret assault with intent to kill and robbery with force of arms, in connection with the holdup of Raymond Collins filling station near Ayden in which Collins and his wife were both injured in their efforts to protect their property. Immediately following the trial here the four men were taken to Bertie county where they were convicted of house and store breaking and received additional prison sentences of 13 to 15 years each. They were then returned to jail here to await transfer to New Bern where they were to again face Judge Frizzelle this week for staging a holdup of Paramore's Filling Station near Vanceboro and inflicting serious injuries upon Paramore and his wife.

SPORT SLANTS

By ALAN GOULD

Spurred by Federal action, following the wholesale indictments for "doping" race horses at the Chicago tracks, Eastern turf leaders have promptly begun a "clean-up" of conditions at the famous Saratoga course.

Conditions on the various New York tracks have been subject to criticism for years. State control has been lacking under the existing racing laws but Department of Justice agents have lately exerted so strong a hand that horsemen now have no alternative other than to eliminate questionable practices.

"Never in the history of thoroughbred racing in this country has the use of 'hop' been dropped so suddenly from the regular menu of the racing stables," comments a veteran observer. "Hardly a horse now is stimulated for a race at Saratoga. This is particularly noticeable in the paddock when the horses are led in. In the races, too, it is plain nothing has been administered to a horse that comes charging down, mouth open and eyes ready to flitter away, instead of with nostrils distended and eyes 'oping'."

"It was only recently that two horses in the first race were under surveillance in the paddock. The Federal agents were active during the saddling and these two thoroughbreds came in for an unusual amount of scrutiny. They belong to two very prominent horsemen. One of these horses ran second in the race while the other failed to show."

"The stables at Saratoga are fairly alive with agents. Not one stable has escaped surveillance. Disguises as groomers or stable boys are used. The racing associations all are co-operating in the clean-up campaign and helping the Federal men in every way to stamp out the use of narcotics."

Nats Prove Superiority

Looking back over the American League race, it is interesting to note that within practically one month, from June 22 to July 24, the Washington Senators waged a nip-and-tuck struggle with the world champion Yankees for the leadership, the upset of which was that the Nats proved the better club and moved on to a commanding margin.

Up to the end of July the Yankees were more often in front than their rivals. In fact until June 22, when Washington first gained a tie for the lead, the New Yorkers were out of first place only three days, yielding in these instances to Cleveland.

From June 22 to July 21, the Yankees and Senators were deadlocked at the top no less than seven times, the lead shifting otherwise by a small margin.

The last rally by the Yankees pulled them up to within one game of the Senators on August 7, when they won a double-header from the Senators, but within the next ten days the world champions dropped seven and one-half games behind the pace-setters.

Yanks Look Ahead

While the Senatorial parade is still on, the Yankees have begun to experiment with what they have and buy or recall what they think they need for 1934.

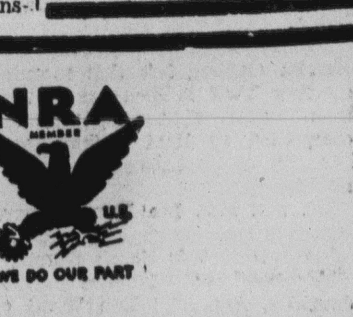
