WARSHIPS ORDERED TO CUBA

Government To Take Action On Tobacco Price Situation

Cruiser And Three Destroyers Sent To Protect Americans

EXPECT STRIFE BEFORE NIGHT JAIL BREAKERS STILL AT LARGE

Army Revolts Against New Provisional Government of Southern Republic. President and Cabinet Resign

Washington, Sept. 5.—(AP)—Warships were ordered to Cuba today because of a coup d'etat there. A cruiser and three destroyers were dispatched to protect American lives and property from danger in threatened strife precipitated by a revolt of the army against the new provisional government there.

This was the second time in a matter of weeks that war vessels have been sent to the republic to the south, the first time being during the disturbances in connection with the overthrow of the Machado government. Today's action was taken promptly after Secretary Hull had been apprised of the swift developing situation by two long distance telephone calls from Ambassador Sumner Welles at Havana. The secretary bravely faced reporters and told them the cruiser Richmond had been ordered from the Canal Zone, the destroyers MacFarland and Bainbridge had been ordered to the Cuban capital from Key West and Norfolk, and the destroyer Studebaker had been ordered from the naval base at Guantanamo to Santiago.

Already their sharp prows are cutting the water while President Roosevelt made his way toward Washington on the Astor yacht, returning from a vacation, to take a personal hand. Forces of Marines and Blue Jackets capable of a respectable landing force, are aboard the war craft. It was emphasized that intervention in Cuban affairs was not desired by the forces being sent expressly to protect foreign life and property. Secretary Hull believed the Richmond carried 75 to 100 Marines.

As to any danger of bloodshed, the American officials could make no prediction. Even Ambassador Welles, on the ground at Havana, was unable to precisely estimate the danger with conditions changing from moment to moment.

Havana, Sept. 5.—(Copyright by Associated Press)—Cuba's revolutionary government less than a month old prepared to resign today in favor of a commission of five men selected by leaders of soldiers, sailors and national police who seized power in a bloodless coup d'etat last night.

Provisional President Carlos Manuel de Cespedes, who succeeded the deposed Machado August 12, today hurried back to Havana from Santa Clara, where he had gone to lock over the damage caused by the hurricane. On his return to the capital, the President expected to call a cabinet meeting at which his government will resign. The coup d'etat placed the power in the hands of the extreme radical and socialist representatives of student groups, the A. B. C. revolutionary society which was largely instrumental in the overthrow of Machado, and certain university professors. Although the shift of power was accomplished without fighting, there were a number of disorders. A. B. C. headquarters was in an uproar. Automobiles loaded with young men armed with pistols and rifles, dashed through the streets. Fears were expressed that there would be bloodshed before nightfall.

Members of the new regime commission asserted that they did not want to hold office permanently but would govern only until the constitutional assembly could select their successors.

Officers Continue Search For Men Who Broke Jail Here Sunday Night

Whitley Jones and Clifton Thomas two of the trio of highway robbers, who escaped jail here Sunday night, continued at large today while officers continued their search for the fugitives. Whitley Taylor, the other member of the party, was recaptured yesterday morning and returned to jail here.

The men had been sentenced to serve 18 to 20 years in state prison after being convicted here last week along with D. G. Traylor on a charge of holding up Raymond Collins' Filling Station and wounding Collins and his wife. Traylor, who was confined in a separate part of the jail, did not escape. Shortly after their escape Sunday night the trio separated, Taylor traveling alone and Thomas and Jones making their escape down the river in a stolen boat. The boat was found abandoned at Red Banks, three miles below this city, and officers believe that the two men are still in hiding in the swamp adjacent to the river shore. All day long yesterday officers and posses kept the section surrounded and the search continued today. Since the search started very soon after the escape, it is believed that the two men have had no opportunity to make their way to the highway to get away from this territory. Despite the fact that the men have been at large nearly 48 hours, officers still expressed belief that they would be recaptured.

The four men, after being sentenced in court here by Judge Prizzelle, were carried to Windsor where they received additional sentences for their crimes in Bertie county and were then returned to this city to be held for Craven county officers. They were to have been tried in New Bern this week for holding up Paramore's filling station near Vanceboro.

Tropical Hurricane Still Lashing Points Along North Gulf Shore

Corpus Christi, Texas, Sept. 5.—(AP)—Surging waves from a high tide swept through the business district today and J. C. McCauliff, government forecaster, predicted that the worst was yet to come from the tropical hurricane that lashed the city throughout the night.

"The water is four deep over North Beach peninsula and is running waist deep in Chapparel Street, a block from the waterfront," McCauliff said. He predicted the water would be several feet deep in the entire business district by noon. A section 250 feet long had been washed out of the causeway connecting Corpus Christi with the San Antonio and Houston Highway across the arm of Corpus Christi Bay. The only road from the peninsula is by Alice. "The wind is steady now in the east, but if it shifts into the southeast I'm afraid the worst is yet to come from Corpus Christi and the water will come higher," McCauliff declared.

The gale maintained a steady blow of 48 miles an hour during most of the night, although gusts at times reached a velocity of 60 miles per hour. From a low of 29.64 at midnight the barometer had risen to 29.72 at 7 o'clock this morning. Early surveys of the havoc revealed

LARGE CROWD NRA MEETING LAST NIGHT

Mrs. W. B. Murphy Of Snow Hill, Was Principal Speaker to Gathering

Addressing more than 200 persons gathered at the court house here last night, Mrs. W. B. Murphy, of Snow Hill, State Lieutenant of the Women's Division National Recovery Administration, declared that President Roosevelt is depending upon the rank and file of America for the success of his efforts to restore prosperity and that the plan cannot fail. The meeting was in charge of Mrs. J. B. Spillman, Pitt county chairman, and the speaker of the evening was introduced by Mrs. H. S. Ragsdale.

In setting forth the purposes of the meeting, Mrs. Spillman stated that already the consumers sign-up was in progress in other sections of county and that as soon as adequate supplies were received, the drive would get under way here probably the last of the week.

While last night's meeting was primarily in preparation for the consumers sign-up campaign, R. L. Powell, secretary of the local Chamber of Commerce, in a brief talk explained the NRA codes for the benefit of those business men present who had not already signed a code.

Mrs. Murphy, addressing her audience in her usual delightful manner, said:

"President Roosevelt has given new meaning to two simple English words. The first he enunciated in the remark made to Premier Ramsay MacDonald soon after his inauguration when he said: 'It isn't enough merely to hope for better days. We've got to have better days.' And the second is the word which stands for the thing that will make possible better days. The co-operation of every man, woman and child in America. It's up to us, the most important citizen of Pitt and Greene Counties as well as the towering giants of the finance and industry.

"Let us stand by our President. Alone he cannot do anything but make plans. With the nation's backing he can start the currents of industry.

"We can sign his re-employment program and bring to pass a nation whose people are happy in work, at peace among themselves with other nations who find their joy in what they can contribute to the general happiness of all.

Jacksonville, Fla., Sept. 5.—(AP)—A trail of ravaged homes, business houses and citrus groves today marked the wake of the tropical storm that struck Florida on the east, swept the south central part and blew into the Gulf of Mexico north of Tampa. Damage was estimated at a million dollars.

Communication with the southern portion of the state was still difficult today but meagre reports disseminated refused to leave his home at Palm Beach as the storm approached and was killed as the building collapsed. An amateur radio message told of the death between Sebring and Lake Placid of a flagman when 11 cars of a Seaboard Air Line train was derailed because of the undermining of the tracks by rain water.

The Eastern Carolina Chamber of Commerce has memberships in more than one hundred towns in the East, and it is hoped through this two-day drive to add materially to the number of members already on the roll.

URGE REFUND OF PART OF TOBACCO TAX

Tax Relief Association Suggests Plan To Farm Administration

Urging the turning over to the farmer of a portion of the huge tobacco tax now collected by the federal government the Pitt County Tax Relief Association late yesterday wired Governor Ehringhaus at Washington suggesting the presentation of such a plan to federal officials.

The telegram was as follows: Gov. J. C. B. Ehringhaus, care of Hon. J. B. Hutson, Washington, D. C.

Respectfully assert growers, manufacturers, and government do not share equitably income from our type tobacco. Urge government compensate growers twenty cents pound out of the dollar and six cents tax pound on thirty-three crop on growers signing acreage control contract. Such would leave tobacco business undisturbed and eighty-six cents tax on pound to government. Present inequitable relations impossible for continuance.

PITT COUNTY SCHOOLS OPEN SEPTEMBER 18

Schools This Year to Be Under New System of State Operation

The Pitt county schools, other than Greenville, will open for the 1933-34 term, September 18. The expense of operating the schools this year will be born by the State of North Carolina. The maintenance of buildings and grounds will have to be paid from county funds. The State School Commission, represented by T. B. Atmore of Washington, has full control of the schools during the eight-month term. This authority extends to the operation of school transportation, purchase of fuel, and to all other items pertaining to the operation of school plants. Any citizen who may feel that he has just cause to protest a decision made by the School Commission may file his complaint with the county superintendent who will send same to the local commissioner at Washington, and also to the executive secretary at Raleigh. If sufficient cause is shown, a hearing will be granted before the School Commission and such rulings as it may make of the case at hand will be carried out locally.

Attention is hereby called to Section 28 of the new school code which reads as follows:

"After a careful study of the schools operated and the transportation needs in the county, giving due consideration to road facilities and availability of drivers, the county board of education shall determine the routes to be followed by all busses used in transporting children to and from school. In all districts where transportation is provided, provision shall be made for transporting all children living more than two miles from the school building by way of the nearest traveled route; and unless road conditions or other reasons make it inadvisable busses shall be routed so as to get within one and one-half miles of all children entitled to transportation in said districts."

The attention of the patrons is further called to the new regulations concerning children who will enter school for the first time this year. Admission will be granted to all children who will be six years of age before November 15. The County Board of Education has (Continued on Page Two)

Washington, Sept. 5.—(AP)—Pleased with his success for higher tobacco prices, Governor J. C. B. Ehringhaus of North Carolina today started a campaign for better peanut prices in the southern states. At the invitation of the North Carolina executive a number of persons from North Carolina, South Carolina and Virginia here to attend the tobacco conference, met and mapped preliminary plans for a drive for higher peanut prices. Nothing definite was announced but a conference will be held possibly at Raleigh at a later date.

MAY PURCHASE CROP SURPLUS

Farm Administration Officials to Meet Representatives of Growers at Raleigh Tomorrow

Expressing satisfaction at results of conferences with the Farm Administration regarding the tobacco price situation, W. Z. Morton and B. B. Sugg, of this city, members of the warehousemen's committee sent to Washington, sent the following telegram to The Reflector: "Government will declare acreage reduction for nineteen thirty-four and thirty-five maximum thirty per cent. Signatures of growers to be secured before markets reopen. Contracts being rushed. Probably delivered Thursday. Entire warehouse committee greatly pleased with results of conference. Full details of government program be announced tomorrow's meeting in Raleigh. "B. B. Sugg, W. Z. Morton."

Washington, Sept. 5.—(AP)—Governor J. C. B. Ehringhaus, of North Carolina, speaking for representatives of southern tobacco growers said he was entirely satisfied with plans of the farm administration for attempting to secure higher prices for this year's crop and reduce next year's acreage.

The plan was not made public but J. C. Lanier, tobacco expert in the department said preliminary individual contracts in the proposed crop reduction program would be mailed to county agents Thursday. The 400,000 contracts will be mailed to North Carolina, South Carolina and Virginia but Governor Ehringhaus said an effort would be made to make the plan retroactive so that Georgia and South Carolina growers who had already sold their leaf might be benefited.

A delegation headed by Governor Ehringhaus and Ashton Williams, representing Governor Blackwood of South Carolina, and George W. Kolmer, Virginia Commissioner of Agriculture, was to call on President Roosevelt this afternoon to ask that a proclamation be issued urging growers to sign the contract. Governor Ehringhaus, who presided over the meetings of growers, warehousemen and state officials, said he believed it would be possible to re-open the warehouses within a week or ten days.

On motion of Col. D. A. Spivey of Conway, it was agreed to ask the United States Tobacco Association for the South Carolina and border markets to be allowed to remain open after their regular closing dates for as many days as are lost by the holiday.

Washington, D. C., Sept. 5.—(AP)—After another meeting today with representatives of fine-cured tobacco growers Farm Administration officials said it had been decided to offer the growers preliminary individual contracts in the proposed crop reduction campaign for tobacco.

At a conference yesterday in which Governor Ehringhaus of North Carolina participated it was decided tentatively to have a blanket agreement offered to growers. After further consideration it was agreed that each grower sign a preliminary reduction contract stipulating only to reduce the amount desired by the government in return for benefit payments for taking acreage out of production.

The Farm Administration already had announced it intended to levy a processing tax on fine-cured tobacco to raise funds to pay the farmers who promise to reduce their crop in 1934, but growers and officials of North Carolina, South Carolina and Virginia asserted this program might not raise prices for the 1933 crop and they came to Washington for (Continued on Page Four)

A GOOD PLAN

The plan presented by warehousemen yesterday to federal farm officials suggesting that a government corporation be organized to come onto the markets and purchase such tobacco as does not bring a parity price is, we believe, a solution to the problem of this year's prices and unless there is some better plan suggested we hope the government will accept this plan immediately.

Establishment of parity prices for the farmer based upon today's commodity prices and backed up by government buyers who would purchase every pile of tobacco that does not come up to the parity price is one sure way to assure the farmer of a living wage for his investment and labors and in the long run the government would lose nothing. In the face of proposed crop reduction next year and the years to come there would be created a shortage that would necessitate the purchase of government stocks by the tobacco companies and at such prices as the government considered fair.

We reiterate that we believe the plan not only workable but fair, and if the plan goes through the warehousemen and others who had a part in putting over this good piece of work in behalf of the farmers are to be congratulated.

"Bankers and industrialists and thinking business men are supporting the NRA program because they know the only alternative is chaos."

"The workers are supporting NRA because it means a decent living wage. They know, too, that shorter hours will put more of their fellow-workers back to work."

"The man in the street, the average citizen, is supporting this great movement because he knows that a return of prosperity can be achieved only by unified action, leadership and universal co-operation."

"The women of the nation will contribute tremendously to the return of prosperous conditions to the restoration of buying power. The women do 85 per cent of the buying. General Johnson says the success of the NRA depends upon the co-operation of the people in each town and in the last analysis upon the women."

"A very definite task has been assigned the women, viz., to get every man, woman and child in America to sign the consumers' pledge and then live up to the contract of co-operation with the President which it involves."

"I trust that within a few days now every home and every car in North Carolina will bear the seal, 'N. R. A.—We Do Our Part.'"

When Andrew Jackson (Old Hickory) died, some one asked, 'Will he go to heaven?' and the answer was, 'He will if he wants to.'"

"I think that the President may count on North Carolina because I think every citizen of the State

to do his part. Some object to the President's program because it savors too strongly, they think, of the high pressure methods of Hitler, Mussolini and Stalin. Personally my observation leads me to the conclusion that high pressure methods are the only one that get results.

I'm in favor of giving the President's program a two-year trial, which is the time limit of the National Recovery Act. We've been running our own business the past 150 years in America as we pleased and we're worse off financially speaking than when we started.

The most pleasing personal reason I have for supporting the N. R. A. is that it makes buying all the things the women of this country have been doing without the past few years, the paramount test of patriotism, and really I'm having the best time I've had in years. Dr. Murphy is a good sport, generally speaking, but there are times when he thinks I overwork that provision.

## Recipe For Spiced Pears

A Dinner Menu  
Sliced Cold Ham Buttered Potatoes  
Fried Tomatoes  
Bread Butter  
Blueberry Cobbler Cream  
Coffee

Fried Tomatoes  
3 firm ripe tomatoes 1/4 teaspoon salt  
1 egg yolk 1/4 teaspoon paprika  
2 tablespoons cold water 6 tablespoons bacon fat  
1/2 cup rolled crumbs

Wash and peel tomatoes, cut into three crosswise slices. Beat yolk and add water. Dip slices in egg mixture and then in crumbs. Sprinkle with salt and paprika. Heat fat in frying pan and add brown tomatoes. Cover and cook slowly 10 minutes.

Blueberry Cobbler (Serving three)  
1 1/2 cups flour 1/2 teaspoon salt  
2 teaspoons baking powder 1/2 cup milk  
1/2 cup sugar 1/2 cup water  
1/2 teaspoon cinnamon 2 tablespoons butter  
1/2 teaspoon cloves

Mix flour, baking powder and salt. Cut in fat and add milk. Spread this soft dough over berries.

Berries  
2 cups berries 1 tablespoon lemon juice  
1/2 cup sugar 1/2 cup water  
1/2 teaspoon cinnamon 2 tablespoons butter  
1/2 teaspoon cloves

Blend berries, sugar, cinnamon and cloves. Add rest of ingredients. Cover with crust, make 3 holes in top. Bake 25 minutes in moderate oven.

Spiced Pears  
2 pounds pears 1/2 cup broken cinnamon bark  
1 cup sugar 1/2 cup whole cloves  
4 cups vinegar

Wash pears, peel carefully, cut in halves, remove cores. Boll sugar and vinegar 4 minutes, add spices which have been loosely tied in a white cloth bag. Boll 5 minutes. Add pears and cook slowly until very tender and well glazed, pour into jar and when cool, cover and store in dry, cool place.

Allow spice bag to remain in jar with the pears.

Since the world began paying attention to airmail through specially designated stamps—the first country to do so was Italy 16 years ago—there have appeared approximately 2,100 such stamps. More than half of these have come in the last three years.

It was on May 22, 1917, that the first "airmail" put in its appearance. It was intended for the flight between Turin and Rome and was a regular 25-cent Italian special delivery surcharged (translated) (Experimental air post, May, 1917, Turin-Rome-Rome-Turin).

Although the first airmail stamp it does not have as high a catalog rating today as some others that have followed it. It is listed at 15 cents unused and 25 cents used. Approximately 200,000 were printed.

First Transatlantic. The reverse is the case with the first Transatlantic airmail stamp, issued by Newfoundland in 1919, for the attempted crossing of the Atlantic by H. G. Hawker and K. M. Grieve, whose plane came down at sea 1,100 miles out. The fliers were rescued, and later the mail bag they carried was salvaged.

Valued in the catalog at \$1,500 unused and \$1,000 used, the stamp

was a regular three-cent surcharged "First Trans-Atlantic Air Post, April, 1919." Only 200 were printed of which but 95 were used for postage, and 18 defective copies were destroyed.

Topsy-Turvy Value. However, the most valuable airmail stamp is the 24-cent, with center inverted, of the first United States issue, put out May 13, 1918, for the first official flights between Washington, New York and return, and Philadelphia, Washington and return.

Only 100 of these inverts are known to exist, contained on a sheet sold over the counter at the Washington post office. The rating in the catalog is \$3,300. Stamps of this issue without this error are listed at \$1.25 unused and \$1 used. The central design is an airplane.

Of the major countries which use airplanes for mail, only Great Britain has no special air stamps.

UNDERGOES OPERATION FOR REMOVING BULLET. Lumberton Sept. 5.—(AP)—Conrad Donnell, 32, of Sanford, brought here Saturday from Whiteville suffering from two apparently self-inflicted gunshot wounds, underwent an operation today for removal of a bullet from his head.

Dr. R. S. Beam who performed the operation at Thomason Memorial hospital, said Donnell withstood the operation well and that his condition was satisfactory.

Besides the wound in the head, he was shot just below the heart.

Donnell, who was Scoutmaster for a Boy Scout troop at Sanford, was at White Lake in camp with the boys. He has made no statement with regard to the shooting.

PRESBYTERIAN SYNOD WILL CONVENE TONIGHT. Greensboro, Sept. 5.—(AP)—The 120th session of the Presbyterian Synod of North Carolina will open Tuesday night at the Church of the Covenant with the annual sermon by Dr. R. A. White, Mooresville, retiring moderator, and an address by Dr. Frank P. Graham, president of the University of North Carolina.

Registration will begin Tuesday afternoon and an attendance of approximately 300 is anticipated. The visitors will be accommodated at Woman's College in a manner similar to the entertainment inaugurated two years ago at Queens-Chicora College, Charlotte.

The Synod will be in session through Thursday. The moderator will be elected at the opening meeting.

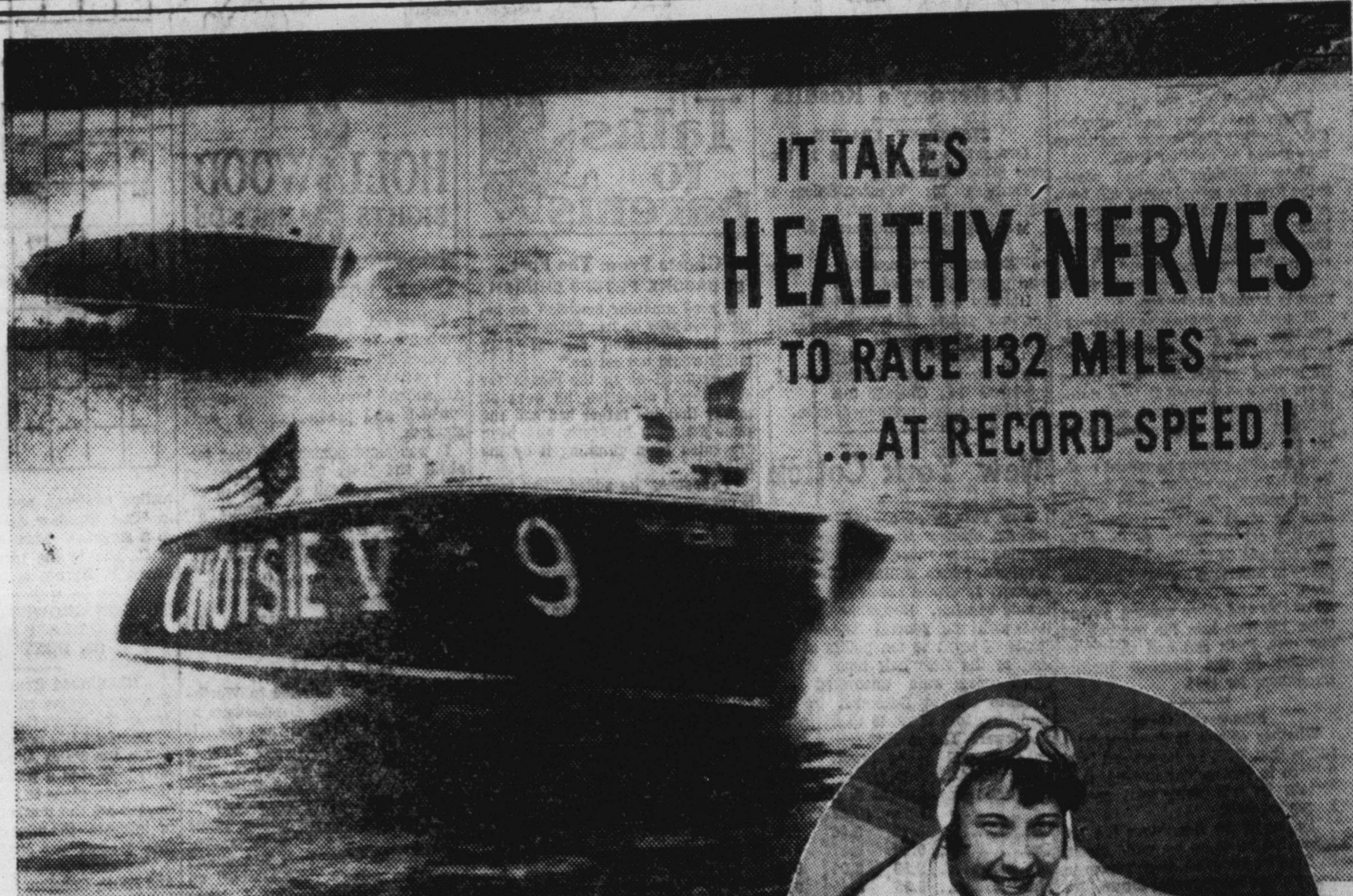

An Act to Regulate the Practice of Cosmetic Art in the State of North Carolina, passed by the last Legislature, provides:

"Sec. 7. 'Itinerant Cosmetologist' is any person who practices cosmetic art outside of a cosmetic art shop, beauty parlor, or hair-dressing establishment, either in going from house to house or from place to place at regular or irregular intervals."

"Sec. 10. No person shall be issued a Certificate of Registration as a Registered Apprentice by the State Board of Cosmetic Art Examiners hereinafter established—

"(a) Unless such person is at least eighteen years of age.

"(b) Unless such person passes a satisfactory PHYSICAL EXAMINATION prescribed by the said Board of Cosmetic Art Examiners.

"(c) Unless such person passes the examination prescribed by the Board of Cosmetic Art Examiners and pay the required fees."

Sec. 28. The penalty for violation of this law provides a fine of not less than \$10.00 nor more than \$50.00, or imprisonment for not less than ten nor more than thirty days for EACH AND EVERY VIOLATION.
