N. C. Coast Isolated By Storm

Heavy Property Loss Is Reported Along Seaboard

TWO LIVES CLAIMED BY HEAVY SEAS LIGHT DAMAGE FROM STORM IN THIS AREA

Elizabeth City, Beaufort and Morehead City Isolated; Heavy Loss Reported; Full Picture of Storm Hidden by Disrupted Communications with Outside World. Indescribable Confusion at New Bern.

Wilmington, N. C., Sept. 16.—(AP)—Roaring up from the tropics, a hurricane lashed the northeast section of the North Carolina coast early today spreading destruction over a wide area and claiming two lives.

The battering, smashing wind of full hurricane force destroyed communications and hid the full picture of the storm damage from the outside world, but dispatches coming by wireless told of widespread loss.

Elizabeth City, Beaufort and Morehead City, three of the large communities on the coast were isolated. The coast guard cutter Pamlico wireless that New Bern, city of 12,000, was hard hit and that property damage was heavy, but no loss of life was reported.

Destruction of the Neuse River bridge, lighting facilities, waterfront property destroyed and six feet of water in the business district were related by the coast guard. Red Cross aid was asked.

Indescribable confusion was the description of conditions given by E. H. Dixon, manager of the Carolina Telephone and Telegraph Company at New Bern who made his way from the storm-torn city to Kinston.

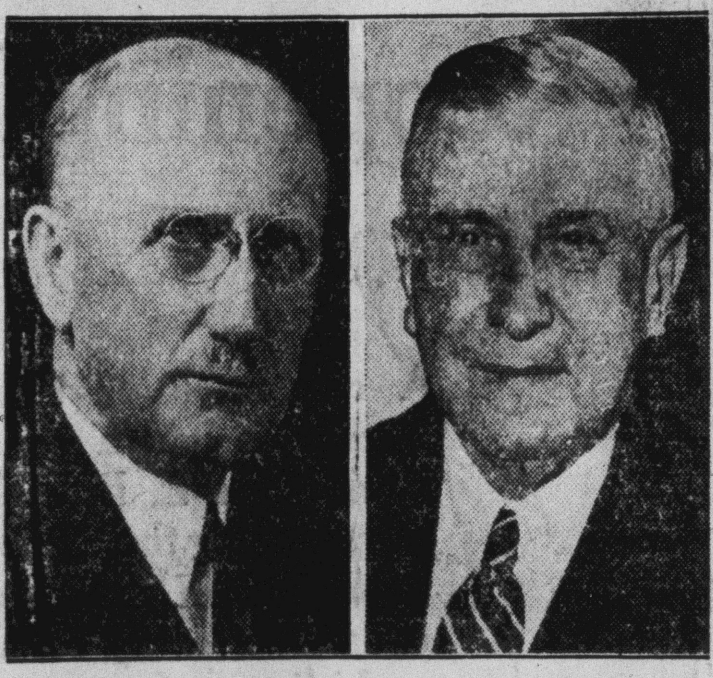
"New Bern is a tangled mass of trees and wires," Dixon said. "The tide spread over the business district, trees were blown down on nearly every street and telephone wires were tangled everywhere."

Dixon said there had been no loss of lives so far as he knew. He said the storm reached its height at 2 p. m.

The Red Cross reporter quickly to the call for aid. John C. Thornton, of the national disaster relief division, who was at Norfolk, Va., said representatives had been sent for duty at Elizabeth City, Morehead City, and Wilmington.

In preparation for the blow, the Red Cross dispatched three men from Washington to Raleigh yesterday and asked all coast regions in the State to be ready for relief.

STEAMER IN STORM GRIP AT MOREHEAD

Battleship New Mexico Sends Vessel to Aid of Unidentified Ship

Philadelphia, Pa., Sept. 16.—(AP)—The Philadelphia Navy Yards today received a wireless message stating that the battleship New Mexico had ordered the Kalim to go to the assistance of an unnamed steamer at Fourteen Foot land light. It is believed the steamer is carrying a cargo of fourteen foot land bank, seventeen miles up Delaware, not far from the Delaware Capes.

There is shallow water in that vicinity, and the unidentified steamer may be aground.

The New Mexico is at Delaware breakwater adjusting its compass preparatory to a sea trial following her modernization at the Navy Yard. The battleship left Philadelphia yesterday and was attended at the breakwater by a tug.

CALE STRIKES VA. SEABOARD

Cape Henry Lashed By Hurricane; Blow Of 55 Miles an Hour Recorded

Norfolk, Va., Sept. 16.—(AP)—Whirling out of the tropics, a hurricane swept the Virginia coast today leaving behind it a wide wake of destruction in the Carolinas.

The center of the storm had passed Cape Hatteras and the swirl of its winds were lashing at Cape Henry and the Virginia coast.

Along the seaboard there was a steadily rising gale. It reached a velocity of 65 miles an hour at the Cape before 10 o'clock, and the peak was due here at noon.

A blow of 55 miles an hour was recorded in the city proper, and weather bureau officials said it would increase steadily. Whipping the tides ahead of it, the weather bureau at Norfolk warned that the peak of the storm would bring with it the unprecedented high of August when Willoughby Spit was inundated and other sections of the city were flooded in water waist deep.

SIX FEET OF WATER COVERS WATER FRONT

Flood From Rising Rivers Sweeps Over Business and Residential District; Residents Seek Higher Ground; Boats Operated in Streets of City on Rescue Mission; Tide Highest On Record; No Loss Of Life Reported

New Bern, N. C., Sept. 16.—(AP)—Property damage running into a total of thousands of dollars resulted from the tropical storm which lashed New Bern last night, but there were no lives lost and no injuries.

Hardly any industrial plants in the city escaped damage from wind and water, while a three-quarter mile section of the bridge over Neuse River, one of the longest in the State, was carried away.

The tide was the highest on record here, and water came into the city for two blocks from the river, flooding streets on the waterfront, business houses and first floors of many residences. Motor and rowboats were operated in the streets of the city to remove residents from buildings surrounded by water.

Breaking late yesterday, the wind increased in fury during the early hours of the night, blowing a fifty-mile gale at night and at times reaching a velocity of 60 to 70 miles an hour.

Trees were uprooted, and lights along the waterfront were demolished and buildings damaged.

Neuse River bridge, connecting link between here and Bridgeton, on Federal Highway No. 17, went out about 1:30 o'clock this morning. Two stalled cars reported to have been on that section of the bridge were carried away, but the occupants must have made their way to safety.

Sharp winds were still blowing here today, and water was high and rose in the river, but the danger of further damage had passed.

DRINKING NEGROES IN FORD KILL SCHOOL CHILD ON ROAD
Aberdeen, N. C., Sept. 16.—A model T Ford, driven by a negro woman, accompanied by four negro men from Ashley Heights, ran into Doris Allred, aged nine years, and her little cousin, Berline Allred, both white, on Highway No. 70, about one mile from Aberdeen as the little girls awaited the coming of the school bus Friday.

Berline was killed instantly; her neck broken and both legs broken, and Doris was badly hurt, suffering a fractured skull and two broken legs. She was carried to the Moore County Hospital at Pinehurst and doctors there hold out a slight chance of her recovery.

The funeral for Berline Allred will be held tomorrow afternoon. The place of the funeral has not yet been decided.

After running into the children the car ran into a light-post, knocking down the post and smashing up the car, then the occupants left the car and ran into the woods nearby. The woman and two of the men were captured soon after the wreck, and after searching the country for miles, the remaining two men were captured near Fort Bragg reservation. All of them were taken to Carthage and thrown in jail.

In the car was found a half gallon fruit jar of liquor, and a negro working for the father of one of the little girls witnessed the accident and said they were driving recklessly as they came up the highway from Ashley Heights.

T. B. ATMORE SPEAKS HERE

Member State School Commission Addresses Members of Kiwanis Club

T. B. Atmore, of Washington, member of the State School Commission, addressed members of the Kiwanis club, members of the college faculty and principals of county schools at the regular meeting of the club here last night.

The speaker told of what was being done regarding the operation of schools this year under legislation passed by the last general assembly, and while regretting that more money could not be spent on the schools, he expressed hope the curtailed funds would not cause any great hardship.

The program was in charge of Dr. R. S. McGeachy and Rev. E. L. Hillman, presiding.

Following the presentation of guests, Judson Blount rendered a solo number dealing with changing conditions of the present time. He was accompanied by Mrs. Ray Tyson.

Mrs. William Webb delighted the clubmen and their guests with the singing of two numbers peculiar to the negro race with guitar accompaniment.

Mr. Atmore, who represents this district on the State School Commission, gave a graphic portrayal of how the state was attempting to run the schools on \$20,000,000 less than they did a few years ago, and while refusing to prophesy the result of the experiment, he ventured the opinion other states would follow in the footsteps of North Carolina in an effort to reduce the cost of education in the face of decreasing taxes.

In attempting to provide for a uniform state school law on the \$16,000,000 appropriated by the Legislature, the speaker said three avenues were open to them—reduction of teachers' salaries, spending less money, consolidation and reduction of workers.

He expressed regret that teachers salaries could not have been increased, but declared this impossible in the face of the amount of money appropriated for running the schools.

However, he thought North Carolina teachers probably would be able to get by as well as those in some of the other states, which although offering higher salaries, had failed to pay off and in many instances issued scrip which was exchanged for about half value.

He told of the many delegations he had received since the new school law became effective, and while some had real sound ideas to offer, others presented only absurd suggestions based almost entirely on selfishness.

Caution was advised all ships in the patch of the storm of gale proportions and blowing at 75 miles an hour at Hatteras. Unless there should be a change, the Bureau said, the center would not pass near the capital, which expected high winds.

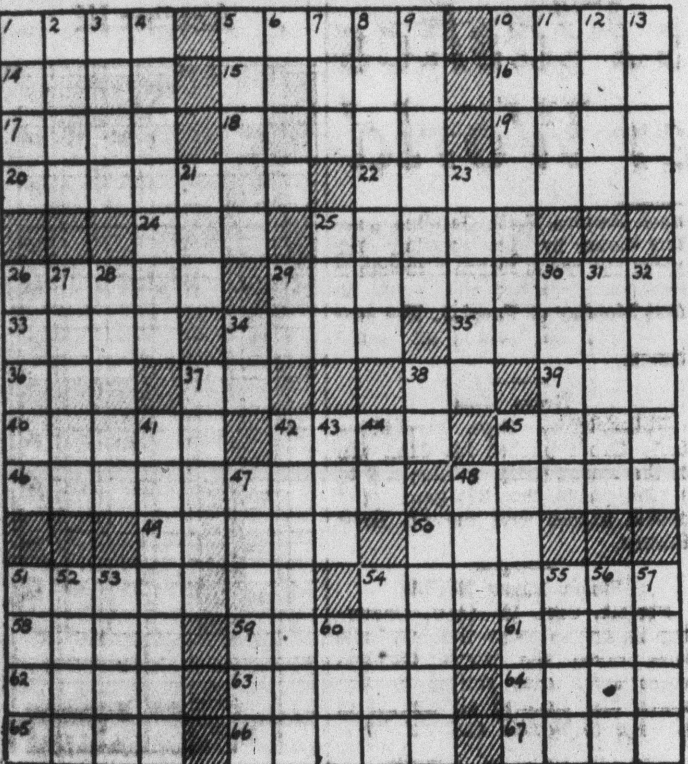

With reduction of acreage assured for 1934-1935, and with the Federal Government stepping in for the first time since tobacco growing began in this country we confidently expect prices to strengthen as the season progresses.

The flue cured tobacco acreage up to now has been uncontrolled and uncontrolled. Every thinking person will welcome the Federal Government's assistance in regulating the acreage in all the flue cured tobacco growing states in accord with domestic and export requirements.

Growers in foreign countries are constantly increasing their own production. Exports of flue cured tobacco from the United States to foreign countries have been steadily declining. Consequently, the government knows our only hope for improved prices is control of production.

MORGANTON BANKER KILLED IN COLLISION

Lenoir, Sept. 6.—Carl Anderson, 19-year-old Lenoir County youth, was held under \$2,500 bond here today on a charge of manslaughter in connection with the death earlier today of James A. Claywell, 52, cashier of the First National Bank of Morganton. Anderson gave the bond for his appearance at a preliminary hearing in the Recorder's Court on Tuesday.

Claywell and H. P. Jenkins, assistant cashier of the bank, were returning home from a bankers' meeting here in the latter's car. They collided with an automobile driven by Claude Anderson, 19, near Lenoir, shortly before midnight.

Claywell received a fractured skull and died an hour later in a Morganton hospital. Ira Peague, companion of Anderson, was brought here in a semi-conscious condition and the extent of his injuries had not been determined. Anderson was dismissed from a hospital after treatment for minor injuries. Jenkins received a broken rib and injured his knee.

Although details of the wreck had not been learned publicly, Sheriff J. C. Tolbert, of Caldwell County, said a charge of manslaughter probably would be brought against Anderson. Claywell is survived by his widow and four children. He had been employed by the bank for thirty years.

WHITEVILLE TEACHERS GET ANONYMOUS NOTES

Whiteville, Sept. 16.—(AP)—An investigation is under way here into anonymous letters received by teachers of the Whiteville high school advising them where to board and not to board.

The letters were signed "Mary." The Whiteville News-Reporter, weekly newspaper here, described some of the remarks about boarding places as "almost libelous."

"When the writer of the notes could think of nothing else to say," the paper declared, "he or she said that the reason teachers should not board with one certain lady was because she lived up a dark street."

The letters were postmarked Whiteville and were written in a very legible hand.

PRISONERS SAW WAY FROM IREDELL JAIL

Statesville, Sept. 16.—(AP)—Officers today sought four prisoners who sawed their way from jail here after one of five who escaped returned to tell police how the break occurred.

Ernest Kerr, negro, was at liberty only half an hour before he came back to tell authorities that Will Miller, negro helper at the jail, furnished saws so that the five might escape Wednesday night.

Miller was charged with complicity in the escape while police still sought the four fugitives, one of whom is Earle Blythe, 22, charged with holding up M. B. Stewart at his filling station near here.

Stewart was robbed, bound hand and foot and left in a dazed condition July 27. Blythe has been in jail here since August 8 waiting trial.

The others who escaped were Earn Alexander, Will Hunsucker and James Turner, all negroes.

Pickle Receipts

The following are some pickle recipes you might like to use this fall: Stuffed Bell Pepper Pickle.

4-1-2 pints of chopped white cabbage (1 medium sized head); 2 doz. bell peppers, green; 1 gal. spiced vinegar; 3 tbs. white mustard seed; 2 tbs. celery seed; 1-4 cup salt. All measures level.

Sprinkle cabbage with 1-4 cup salt and allow to stand for 4 hours. Squeeze dry by placing in muslin bag and twisting tightly. Thoroughly mix with the cabbage and mustard and celery seed.

Select sweet bell peppers of uniform size, cut off the top with the stem, remove every seed, stuff peppers with the cabbage, replace top and stitch firmly with needle and coarse thread.

Place stuffed peppers in stone jars, pouring over them enough boiling spiced vinegar to cover thoroughly. (Remove spice bag from the vinegar after 3 weeks). Allow peppers to remain in vinegar 6 weeks before packing in commercial jars. Use fresh spiced vinegar for packing. Process in jar 15 minutes.

Pickles Which Do Not Require Long Brining. Sliced green tomato pickles, chow chow, and Dixie Relish do not require long or careful brining as do cucumbers, and for that reason are more easily made.

The person inexperienced in pickle making is advised to begin with this type of pickle. Sliced Green Tomato Pickle.

1-2 gal. sliced green tomatoes; 1 pint onions, sliced; 1-2 tsp. ground black pepper; 1 small red pepper; 3 tbs. white mustard seed; 2 tbs. celery seed; 1 lb. brown sugar; 1-2 tbs. allspice; 1-2 tbs. cloves; 1-2 cup salt. All measures level.

Sprinkle sliced tomatoes and sliced onion with salt. Let stand 4 hours in separate bowls. Place each in a thin muslin bag and squeeze gently until juice is removed.

When ingredients are prepared, place in porcelain kettle, mixing with them the mustard and celery seed, sugar and pepper. Cover with good vinegar (11-2 pints) to which the spiced tied in a bag have been added.

Boil slowly until quite soft and tender. This pickle is not good if removed from the fire before the tomatoes are tender.

After cooking, pour into jars and seal while hot. Be careful to use a liberal amount of the vinegar in which pickle was cooked when packing.

DURHAM INDUSTRIES REPORT BIG PAYROLL

Durham, Sept. 16.—Durham industries swelled pay rolls to an upward swing during the week ended, reaching \$223,899.27, setting a new mark for the year and surpassing all weekly pay roll figures since 1929. The Durham chamber of commerce reported that this figure is only \$1,200 under the peak of September, 1929.

New Books

By JOHN SELBY New York. (AP)—Among the three or four Americans now writing who really understand the negro race and psychology should certainly be named Roark Bradford. Another would be Julia Peterkin.

Mr. Bradford has done a new type of thing in his "Kingdom Coming," which is to recreate a comparatively familiar section of American history through the medium of the negro himself. The period is that just preceding and including the Civil War, and the territory covered is Louisiana, with New Orleans and the upstate plantations.

The young Grammy grows up with the talk of freedom in his ears. His father makes the break, and is killed. And Grammy follows the traditional paths of young slaves, has also the yearning for freedom, and then quite suddenly attains it. But freedom consists of life in a New Orleans concentration camp, and New Orleans takes away the girl Grammy loves and precipitates a final tragedy that is among the most affecting in recent books.

Big Prize. What is called the largest prize ever offered by a publisher for a novel just has gone to Janet Beth, a young Englishwoman, for her "No Second Spring." The prize is \$20,000 and the book that earned so much money is a very pleasant study of the effect upon a sensitive woman of the old-fashioned fire and brimstone doctrine—and attitude toward life.

The story is laid in Scotland; inevitably the ideal of a freer life is represented by a wandering artist, who almost but not quite comes between fragile Allison and hard, thundering Hamish. There is a feeling of quiet competence about Miss Beth's work that must have impressed the judges considerably for the story itself and the psychological problems posed are not particularly original nor, in this day of freedom, particularly moving.

Book shelves are groaning this week under a heavy load of fall publications. Tiffany Thayer has a new novel, one of his most serious, and in many ways one of his best. He calls it "One Woman," although it is a newspaper story and not exactly in what has grown to be considered the Thayer "tradition."

And Hugh Walpole has at last concluded the Herries series with "Vanessa," the love story of Vanessa and Benjie, the family rogue. Vanessa was, it will be recalled, the beauty of the family, and the story of her love is among Mr. Walpole's best efforts in the field of romance. Sheila Kaye-Smith is restating that dismal condition of English agriculture in "Gipsy Waggon" and very pleasantly.

Place everything on the table and let everyone select according to taste. You might serve one hot dish, such as chopped meat cooked in green peppers cut open, and hot rolls, buttered, are good. Then have a dish with radishes, olives, hearts of artichokes and whole tomatoes filled with celery and covered with salad dressing. Another dish can contain cold sliced meats, and another potato salad, and another cold stew. Cream cheese and pickled beets look attractive on a plate. For dessert a ice home-made layer cake and coffee.

Five minutes extra for getting-up time. If you are the one to arouse the household in the morning a very kindly procedure is to allow five minutes for the waking-up process, particularly with children. This keeps the shock from being too abrupt. Orange juice can be squeezed the evening before, which will allow the housewife her extra five minutes.

Things Not To Do Don't serve cucumbers without putting in ice water for an hour or two or three before—unless you like them limp. Don't peel fruit until ready for use—unless you do not object to its becoming slightly discolored. Don't cut freshly made cake until it cools—unless you do not mind if it is unattractive.

Bake Potatoes in Skins When a potato is baked in its own skin the moisture in the potato supplies the steam that makes the texture of the vegetable soft and mealy while preserving the flavor. And it's a simple way to prepare it.

Cheese Balls With Salad Cream cheese or cottage cheese fashioned into small rolls, spread with salad dressing and sprinkled with broken nuts making a pleasing salad accompaniment.

SPORT SEANTS By ALAN GOULD

In connection with the current alacrity of the sporting craft to give Babe Ruth the well-known "hail and farewell," if not actually to bury his baseball career altogether, I happened to come across the following letter to the sports editor of The Associated Press.

It was written on hotel stationery and dated November 11, 1922. It read in part: "Monday night (November 13th) I expect to meet some of the newspaper boys at the Elks Club. I appreciate what the fellows have done for me in a tough year and want to thank them face to face."

"I didn't see any need of a committee in this connection put the following have appointed themselves: Damon Runyon, Bozeman Bulger, Sam Crane and Monitor Daley.

"This may seem a particular stunt for a ball-player to do but please be there. (Signed) BABE RUTH."

Premature The reason I am bringing this up now is because at that time, eleven years ago with Ruth not yet thirty, many of the "newspaper boys" were starting to sing the swan song for the big fellow.

They said he couldn't possibly last at the pace he was going. He had begun to taste prosperity and collect big money for the first time in his career. The Yankees had been swept to the top of the American League on the power generated by Ruth's big bat. He had set a new all-time record with 59 home runs in 1921.

In sort, Ruth had risen like a sky-rocket and was about to come down like one, in -922, from the combined effect of inevitable reaction and his own youthful unsteadiness. Money simply meant something for him to get rid of or spend on pleasant companions or bet on the horses. Beer was something to enjoy copious quantities of in genial company. The bright evenings were meant to illuminate the evening—a simple fact that the Babe was quick to appreciate.

So it wasn't strange that 1922 was a bad year for Ruth. He looked particularly bad in the world series. He was the target of criticism. He was a bit bewildered as thing began to topple around him. Fortunately he had enough friends to help put him back on the right track, and that was what the meeting on November 13, 1922, was all about.

Tears in His Eyes That night, after a friendly dinner and cigars, it was Jimmy Walker, then State Senator Walker, who put into words what was on everyone's mind, who summed up the Babe's waywardness and gave him the picture of what the "dirty-faced kids in the street" would think if Ruth "threw them down."

It was, as it turned out, an historic occasion for one and all, especially the Babe, who had tears in his eyes and meant it when he promised to turn to the right. He did. With one or two lapses he made it stick for eleven years and who's to say, in the face of his own words, that he won't be back swinging again next spring.

FRAUDS IN BELGIAN DOLE SHOWN BY CONTROL LAW Brussels.—(AP)—New legislation affecting the payment of the dole has led to the tracking of numerous frauds.

Out of a total of 175,000 unemployed submitted to control within the first three months' operation of the law, 20,000 were found unentitled to the dole, another 62,000 to a reduced dole, and 1,500 were prosecuted for fraudulent statements.

(Continued from page one) Further threat of storm damage, it was officially declared, passed at 2 p. m. today, said J. J. Murphy, in charge of the local weather bureau.

Storm Damage Mounts New Bern, Sept. 16.—(AP)—A wild hurricane, which battered the Morehead-Beaufort area throughout last night, roared up the Atlantic Coast today leaving a trail of wreckage in its wake. Damage is estimated at upwards of \$2,000,000.

Lieut. Doot of the Coast Guard estimated the damage in New Bern alone was in excess of \$1,000,000 while city and county officials in Morehead City and Beaufort said it would exceed \$500,000 there. Power plants in many communities were put out of commis-

ston and at Morehead and Beaufort it was doubtful if light and power facilities could be restored for several days.

The storm claimed two lives as a seaman was swept off the motor ship Sun by high seas off Cape Hatteras yesterday and a negro fisherman was drowned at Roanoke Island.

The effect of the storm on hundreds of miles and thousands of people in the sound country could not be determined at once because of disrupted communication. No word has been received of the fate of scores of communities in the main land and fear was expressed for fishing villages along the Carolina banks.

New Bern and Wilmington were the only cities with which communication had been established this afternoon.

Approximately 120,000 people lived in the counties most affected by the storm.

The wind reached a velocity of 75 miles and hour here, while the Coast Guard at Morehead said it attained a velocity of 90 to 100 miles an hour there, where the barometer fell to 28.86.

Plan Hearing on Tobacco Tax Washington, D. C., Sept. 16.—(AP)—Progress toward a marketing agreement through which higher prices would be paid for flue-cured tobacco, today resulted in the farm administration officials asserting they expected a public hearing on the proposed tax next week.

At a conference yesterday between farm administration officials and representatives of flue-cured manufacturers, the latter expressed themselves as in agreement with a request of the administration that higher prices be paid for tobacco when the markets de-open in North Carolina and South Carolina.

B. Tutson and other officers of the administration's tobacco section gave a definite proposal to flue-cured buyers. These were accepted in substance, but the manufacturers promised to draw proposals of their own and give them to the Farm Administration.

The continuation of informal conferences led farm officials to feel most difficulties had been settled, and the way was open for public hearing on market agreement next week.

It would set the prices which ought to be paid for flue-cured tobacco, and if accepted would probably solve the price problem for this year.

To Establish Office Raleigh Washington, Sept. 16.—(AP)—The department of agriculture plans to establish an office in Raleigh to cooperate with flue-cured tobacco growers. The plan was discussed between buyers and representatives. J. Y. Joyner of La Grange and Tucker Watkins, of South Boston, Va., former officials of the old Virginia-Carolina Cooperative association, will be placed in charge of the office, it was said.

Fruit Preserver Tested Rio de Janeiro.—(AP)—Citrus fruit exporters near here are experimenting with a preservation liquid which its Spanish inventor, Ortiz Cabezas, claims will maintain fruit in good condition several weeks with refrigeration.

Summer Doubles Vitamin Madison, Wisconsin.—(AP)—Summer butter is approximately twice as rich in vitamin A as that produced in March and April, experiments at the University of Wisconsin show. When cows are turned into pasture there is a sudden increase in vitamin content lasting through the summer and even into the winter.

HILLSBORO DISCUSSES ITS OWN WET PROBLEM Hillsboro, Sept. 16.—The question of water or no water was ardently discussed at a town mass meeting here Thursday night called by the aldermen to discuss the proposal that a water works system be provided for the town. No definite step was taken and the meeting adjourned until more information could be secured about costs. At present Hillsboro has no public water supply and residents are dependent upon their own wells and pumps.

LUMBER MILLS IN EAST MAY BE CLOSED DOWN New Bern, N. C., Sept. 16.—Unless the lumber market improves appreciably during the next week or two, with more orders received by the mills, there is a possibility of lumber mills in this section closing down at least temporarily or operating on a greatly restricted basis, it was stated here Friday by lumbermen.

Under the lumber code of the National Recovery Act, wages for many mill workers here were about doubled, though work hours were greatly reduced. There has not been a corresponding advance in prices to take care of increased costs, mill men say, and there has been a decline in new orders. No new orders are being received now, it is reported.

Robert G. Turnbull of the Rowland Lumber Company, the largest in the region, stated that his entire plant will be closed temporarily the middle of next week. If orders justify, the planing mill may be opened later. All other lumbermen were hopeful that the situation would improve, with new orders received, but they all admit that the situation is critical.
