KELLYS SENTENCED TO LIFE IN FEDERAL PRISON

Gunman and Wife Found Guilty Of Kidnaping By Jury In Oklahoma City

BOTH SILENT AS VERDICT IS READ TO THEM

KELLYS DRAW LIFE IMPRISONMENT

Late News Flashes From Over World

Other Members of Urschel Kidnaping Gang Sentenced to Pen Earlier in the Week; Jury Reaches Decision an Hour After Receiving the Case; Daughter of Mrs. Kelly Smiles Strangely as Sentence is Pronounced

The maximum sentences were pronounced by Judge Edward S. Vaught, 11 days after the capture of the Kellys and other members of the kidnap gang and only three days after they went to trial.

Thus six of the nine persons convicted of the \$200,000 kidnaping conspiracy had been ordered to prison for the rest of their lives. Also under life sentence are Harvey Bailey, the jailbreaker, Albert Bates, Kelly's actual aid in the kidnaping and Mr. and Mrs. R. G. Shannon, operators of the Paradise Texas, kidnap farm where Urschel was imprisoned, Mrs. Shannon is Kathryn Kelly's mother.

Federal agents have perfected plans to take the Kellys by airplane to the Atlanta Federal penitentiary. His wife is to serve her sentence in the Woman's Federal prison in West Virginia.

The jury's verdict was reached last night after deliberation of only one hour. Under the court's instructions, it was sealed and returned, and the court opened it today.

The Kellys received the verdict and sentence without changing expressions. In the row of spectators, Pauline, 13-year-old daughter of the convicted woman, smiled strangely.

The accused entered the room under guard and sat at the counsel table facing the judge.

James H. Mathers, defense attorney, filed motion for a new trial. It was overruled. "Have you anything to say before sentence is pronounced?" Judge Vaught asked the prisoners. "No, sir," Kathryn replied. Kelly shook his head.

MORE COTTON CHECKS HERE

Farm Office Announces Receipt of 805 Checks For \$40,228.68

According to reports coming from County Agent E. F. Arnold's office, he has received to date 805 checks from farmers who plowed up cotton which totalled \$40,228.68.

On receipt of checks at the county agent's office the farmer is immediately notified that his check has come and requested to call for same.

There are still 400 farmers whose checks have not been received at the office here at this time. However, the department at Washington has promised to have those in within the next few days.

ASSAILANT OF GIRL LYNCHED

Ladeville, Oct. 12.—(AP)—A negro arrested yesterday for questioning in connection with the slaying of Miss Louisiana LeRose, 15-year-old white girl whose body was found in a field, was taken from the Ladeville jail here today and lynched by a mob of unidentified men.

The negro, whose name was not disclosed after his arrest, was seized by the mob and hanged from the girder of the bridge over the Bayou LaFourche.

When early risers in the community saw the body at dawn and officers cutting it down, they found a roughly written note pinned to the clothing warning all persons against "attacks on women of the section."

So stealthily did the lynchers move on the jail and seize the prisoner after midnight that no one in the small town was awakened. Authorities said they were investigating the manner in which the negro was removed from jail. The body of the LeRose girl was found amid sugar cane of an outlying plantation Monday. She had been beaten and apparently had been dragged through the leaves of the cane for some distance but had not been criminally assaulted.

POLICE HALT KHAKI MARCH ON CAPITAL

Pistols and Knives Seized in Raid on Khaki Shirts of America

Philadelphia, Oct. 12.—(AP)—Loaded pistols and a number of knives and clubs were seized by police today in raids on the headquarters of the Khaki Shirts of America while members of the organization were massing for a march on Washington.

Twenty-one prisoners were taken in the raid and police said the group nipped in the bud a plot to storm the army of the 11th regiment of national guards and seize ammunition stored there.

In the meantime, police were searching for Art J. Smith, self-styled commander-in-chief of the Khaki shirts. It was estimated several hundred members of the group had mobilized for the trip to Washington and were waiting for Smith.

In announcing plans for the journey sometime ago, Smith said it was their intention to install President Roosevelt as dictator of the United States.

Police Inspector John Driscoll, who conducted two raids, was quoted as saying he heard some of the men saying they would have it out with the communists when they reached Washington.

PUSH DRIVE FOR MEMBERS

Legion Post Here Paints Large Sign Showing Progress Of Campaign

The American Legion membership drive which got underway October 1, was being carried forward with full steam ahead today and indications were that every man who carried a gun in the world would be enrolled within the next several days.

To show the world how the campaign is progressing a giant sign has been painted on the side of R. E. Harris Company's store, corner Evans and Fourth Streets, giving the names of the officers and members. The names of new members will be placed in the order in which they are received and the entire roster will be contained in the advertisement when the drive comes to a close the end of the month.

Four teams are engaged in the new membership canvass, and as there is a feed at staves, highways and hedges will be scoured in an attempt to bring into the fold as many former service men as possible.

Under agreement the two teams losing the contest will be required to provide the free feed.

It was decided at a recent meeting to organize the Legion into a battalion with four companies, J. B. Kittrell is battalion commander in charge of the offensive. The company commanders are Captain P. BAD MONEY APPEARS HERE

Counterfeit \$10 Bill Makes its Appearance in Greenville Business House

The appearance of a counterfeit \$10 bill here recently today caused bankers to warn the public to be on their guard against spurious money in the future.

The bad bill was discovered by bankers when it was presented in a deposit of a local business firm. The depositor, however, did not know where he got it from and officers were handicapped in their investigation.

Counterfeit money has appeared in the city from time to time during the last several months. Only a short time ago one of the bad \$10 bills was passed here and the investigation conducted by bankers in cooperation with the federal government resulted in the arrest of a man who is now being held in jail in another city awaiting trial.

Numbers of counterfeit quarters have appeared here at different intervals, but officers so far have been unable to trace their origin. Speaking of the counterfeit \$10 bill, J. H. Waldrop, cashier of The Greenville Banking and Trust Company, said the spurious bills were more easily detected with age because they faded and did not hold their color like government money. However, when new they fool the inexperienced observer but may be detected almost immediately when carried to the banks.

WILMINGTON REALTORS GO AFTER RENT DODGERS

Wilmington, Oct. 12.—The Wilmington Real Estate Board at its monthly meeting yesterday moved to put a stop to "rent dodging" by passing a resolution forbidding the members of the board to rent properties to tenants who have vacated houses and buildings of other members while indebted to them.

Secretary W. H. Hill said the resolution called for the members of the board not to rent to a delinquent tenant, until the original tenant is paid. A similar agreement has been in effect for some time. All board members have been requested to support the resolution.

NEGROES ASK PROTECTION FROM CUBA

Threats of Assault Bring New Problem To Troubled Government Today

Havana, Oct. 12.—(AP)—Negroes crowded to meet the protecting arm of the government today in fear of what leaders described as a hateful and bloody crusade against them.

On the claim that white women had been molested a delegation of negroes told President Grau San Martin agitators were urging an assault before nightfall.

As President Grau moved to meet the new problem, rumors spread that friction was developing between the army and navy.

Although denying there were any noteworthy difference, army and navy leaders met with the president in conference which Juan Rivera, commander-in-chief of the navy did not attend.

WEED SALES STILL LIGHT

Local Market Expected to Sell Out This Afternoon About 3 o'Clock

Sales of bright leaf tobacco continued light on the Greenville market today, due mainly to the chilly weather which has prevailed over the community the last few days.

With the coming of slightly warmer weather today indications were that sales would be some heavier during the concluding day of the week tomorrow.

The market yesterday sold 705,468 pounds of bright leaf for \$105,676.92 at an average of \$14.69 per hundred pounds. The average was the same as the day before on over a million pounds of weed.

About a million pounds of leaf was on the floors of the various warehouses today with indications that sales would be completed about 3 o'clock.

The price situation has shown a pronounced improvement this week and Monday saw the establishment of the highest average price of the season. With the quality of the offerings improved at this time, and with prices higher, it was expected sales during the coming week would be considerably heavier during the week providing weather conditions are favorable.

In connection with the government's effort to bring higher prices to tobacco growers, the administration has announced that any plan decided upon will be effective as of September 25 and that "parity" payments will be made to farmers who have sold their crops. This will apply not only in the Carolinas but in Georgia and Florida.

With this point definitely cleared up farmers can go ahead with the marketing of their tobacco now without having to worry about whether they will share in the government plan if they sell before the agreement is made public.

DESIGNATE PROJECTS FOR ROAD IMPROVING

Wilson, Oct. 12.—The board of commissioners of Wilson county in special session Monday afternoon recommended to the State Highway Commission that Wilson county's allotment of \$79,000 from the Federal highway appropriation be spent on one of two projects and designated a first and second choice project.

Project No. 1 will be the improvement of highway 2 from Contentnea creek bridge to the town limits and from the town limits on the north end of same highway to the junctions of highways 40 and 42. The Rock Ridge road was designated as project No. 2. The architect work for improvements to the county jail was awarded to Benton and Benton, local architects.

TWO HELD FOR 'LEAF' THEFT

Negroes Bound Over To County Court After Arrest Here Tuesday

Two negroes were being held here today for trial in the next sitting of county court on a charge of stealing tobacco.

Robert and Theodore King of the Winterville community, were taken into custody by local officers Tuesday shortly after they had offered for sale 400 pounds of tobacco alleged to have been stolen from the farm of Louis Stocks near Winterville.

The arrest came after the tobacco had been sold and the negroes had cashed the check. Warehousemen, it was said, became suspicious of the couple, and advised police who took the negroes in charge shortly after they had received payment for the weed.

Chief George Clark said the men immediately turned over the money they had received for the tobacco and confessed they had taken the leaf from the Stocks farm.

They were given preliminary hearing and bound over the next sitting of county court.

EMPLOYMENT HELP FOR N. C.

Ten Permanent Offices to be Set up in Various Sections of The State

Raleigh, Oct. 12.—Ten permanent employment offices in North Carolina through the cooperation between federal government and state and local authorities have been assured, A. L. Fletcher, Commissioner of Labor, reported today.

In addition, there are fine prospects offices will be established at three other places.

The ten offices now assured are at Asheville, Charlotte, Gastonia, Salisbury, High Point, Durham, Goldsboro, Rocky Mount and Wilson, Fletcher said.

Wilmington, Beaufort and New Bern are likely to get branches of the service.

The offices are now being set up under the Waggoner-Teyser act which provides for nation-wide system of re-employment offices with the federal government matching dollar for dollar all state and local appropriations for such purpose.

FOUR POWERS TAKE ACTION EARLY TODAY

America and Three Other Powers Seek To Prevent Assault On Nationals in German Territory; Concern Manifested by American Embassy Over Recurrence of Nazi Molestation

Berlin, Oct. 12.—(AP)—Four powers have served notice on the German government that assault on other citizens must cease or the most serious consequences concerning their relations with other countries with the Reich might result.

William Dowd, American ambassador, this morning received late instructions from Secretary of State Cordell Hull, while the Spanish and British embassies and Dutch legation were similarly advised to make representations.

Meanwhile, concern was manifested on the information that Hull demanded promised apprehension of offenders and declare there had been needless delay. He added "We are doing all possible to hasten the prosecution of the cases."

NEW PASTOR FOR BAPTISTS

Rev. J. A. McIver of Wilson Accepts Pastorate of Immanuel Baptist Church

Rev. J. A. McIver, pastor of the Five Points Baptist Church at Wilson, has accepted the pastorate of Immanuel Baptist Church here. It was announced by officers of the church today.

Mr. McIver was in Greenville today conferring with members of the congregation preparatory to taking over his duties next Sunday morning when he will preach his initial sermon.

The minister, his wife and three daughters, will move here within the next week or so and will make their home at the Baptist parsonage on Third street, in College View.

He will succeed Rev. W. H. Covert, who resigned last spring. The church since that time has been without a pastor.

Mr. McIver, a native of Texas, was with the Wilson church for two years, during which time the membership was doubled. Before going to Wilson he was pastor at Louisville for six and a half years, and at Tarboro for three years.

He received his A. B. and M. A. degrees from Bailey University, Waco, Texas, and obtained his T. H. M. from the Baptist Theological Seminary, Fort Worth, Texas.

Although born in Texas, Mr. McIver said his people were from this state. He has a number of relatives high in the religious and educational life of the state at this time.

After the conference here today, the minister returned to Wilson. He will return to Greenville Sunday in time to preach his initial sermon at the 11 o'clock hour. Although the subject of his first sermon had not been announced, it was to be made known in the regular church announcement Saturday.

AGREEMENT TO BE RETROACTIVE

The question of whether or not any government-tobacco agreement will be retroactive so as to benefit growers who have already sold a part of their crop seems to have been settled by an Associated Press report yesterday to the effect that the government has announced whatever agreement is signed will be retroactive not only as to the North and South Carolina belts but as to Georgia and Florida as well.

While it was the general impression here from the beginning that the agreement as to parity prices would be retroactive, developments about a week ago placed the matter as uncertain.

This latest report to the effect that the agreement will be retroactive places the growers in a better position to know what to expect and they may go ahead with their selling with the assurance that they will get a square deal in the end so far as the government is concerned.

AN APPALLING TOLL

When some catastrophe strikes, resulting in the death of one or more persons, the public is awestricken, but when 88 lives are snuffed out in North Carolina during one month as a result of automobile accidents, little attention is paid to that. During the month of August that number were killed in this state, and in addition 500 were injured. The death toll from automobile accidents each year is greater than that sustained in most wars; but that is looked upon as a part of the daily routine and causes little surprise. And surely, it has but little effect in making the driving public more cautious.

THREE ARE ARRESTED BY FEDERAL OFFICERS

Rocky Mount, Oct. 12.—A local recreation parlor proprietor, a man from Littleton, and one from Smithfield today were under Federal bonds of \$1000 each on charges of receiving stolen goods from interstate shipments in the early part of the summer. The men, T. C. Robbins of this city, B. L. Reeves of Littleton, and Leonard Woodward of Smithfield, were arrested here by U. S. Marshal Crowe and W. S. McKinley, special agent of the Department of Justice, and arraigned before U. S. Commissioners in Wilson and Roanoke Rapids.

Robbins was taken before U. S. Commissioner Isear at Wilson, where he waived preliminary hearing and was placed under \$1000 bond. Reeves also was placed under \$1000 bond as he waived preliminary hearing at Roanoke Rapids. Woodward, already under state charges in connection with receiving stolen goods from Atlantic Coast Line box cars and Eastern Carolina warehouses, plead guilty before U. S. Commissioner W. H. Parker at Roanoke Rapids, and his bond was placed at \$1000.

The men will appear at Wilson Monday at a session of Federal court.

ZEBULON MAN FOUND IN HOME SHOT TO DEATH

Wendell, Oct. 12.—B. A. Horton, formerly a resident of Wendell, who recently moved to the neighboring town of Zebulon, committed suicide yesterday morning by shooting himself. Indications were that he fired the fatal shot at 11:30 a. m. He was found dead shortly after that time in his home.

Coroner L. M. Waring investigated the death and pronounced it a clear case of suicide.

Mr. Horton, who was 58 years of age, was a member of one of the leading families of this section, being the son of the late Mr. and Mrs. H. R. Horton of the Ephzibah community.

attempt to coordinate policies and methods of the administration's two major recovery agencies was made today by Hugh S. Johnson, NRA administrator, in an extensive conference with farm law administrators Secretary Wallace and George Peck.

He refused to say whether the group had reached any decision. In a recent public address he asserted "There is a distinct movement to rouse farmer antagonism to the NRA on the ground that anything done for workers before prices are raised to pre-war relations to other prices is unfavorable to agriculture." Today he said: "We have been going along pretty fast and we have to check up and see that we are both moving in the same direction."

Reject Strike Settlement

Washington, Oct. 12—(AP)—The national labor board disclosed today that W. T. Weir, head of the National Field Company had rejected the board's proposal for settlement of a strike of workers in the company's plant at Weirton and Clarksburg, W. Va., and Steubenville, Ohio.

Martial Law in Indiana.
Sullivan, Ind., Oct. 12—(AP)—Indiana national guards established virtual martial law in Sullivan county today.

After three blasts had shaken this city early today Brigadier General D. Wray Deprez conferred with local officials and then issued regulations forbidding any assemblies except on permission from military authorities.

The regulations also directed the closing of all business houses, theaters and other public places at 9 p. m. and established a 10 p. m. curfew after which all persons must be off the streets and highways in the county.
