## FARMERS WILL WAGE BATTLE AGAINST RATS

### County - Wide Rat Killing Campaign to Be Staged on November 17th

Farmers of Pitt county will enlist on November 17 for a one-day drive against the rat, mankind's most destructive mammal.

Many thousands of dollars loss every year is caused by rats in Pitt county and rats are found on almost every farm. Rats will destroy or consume property worth at least two dollars for each rat yearly. Rats cause disease and menace health. No one wants these pests about the premises.

E. F. Arnold, county agent, is directing the local drive. The campaign will be conducted according to a plan perfected by the Biological Survey of the U. S. Department of Agriculture. This department has developed a bait that is much more effective than that used in previous years.

The bait will be distributed from the following points in the county: County Agent's office at Greenville, Tormae Bros., at Farmville, J. B. Pierce's at Ayden, M. O. Blount's at Bethel, and Stokes & Conleton's at Stokes.

The method used will make it easy for everyone to get rid of his rats with little effort and expense. Three kinds of bait will be furnished—namely, fresh hamburger, fish and cereal—so that all rats will find at least one of them to their liking. To each of these three baits will be added the new raticide, powdered red squill. If the baits are used according to directions, they will not normally kill dogs, cats, poultry or human beings, only rats and house mice. This material has been perfected by the U. S. Biological Survey and is the safest and best rat poison known to science.

Each package of prepared baits contains enough material to rid the average farm or business premises of rats making about 100 small baits. There is nothing more to add, simply expose the baits in small places about the premises that are infested. Full instructions for using baits will be included in every package.

Under a cooperative arrangement the baits will be furnished at whole sale cost, making the special campaign price of 50 cents. Baits will be furnished to anyone in the county, but it is necessary to reserve the bait in advance. To be sure of getting baits, write or telephone the office of the county farm agent.

Baits are highly migratory, so it is hoped that everyone will cooperate to free Pitt county of rats on November 17. Interest your neighbor, talk rats every place you go from now until November 17. The elimination of rats from an entire community can be accomplished only by organized effort.

## RIOTING IN PALESTINE

### Several Killed And Wounded in Clashes Between Police And Arabs

Haifa, Palestine, Oct. 28.—(AP)—One person was killed and 35 were wounded today in two new clashes in this modernized port of Palestine between police and Arabs demonstrating against Jewish immigration.

Haifa, Palestine, Oct. 28.—(AP)—Serious rioting among Arabs demonstrating against Jewish immigration to Palestine resulted in another clash today in which several were wounded, including a British policeman.

Battle lines were drawn between the police and the surging throngs of Arabs in the district around the railway station. Taking steps to avoid a general fight, authorities proclaimed the curfew law to clear the streets. The Arabs, however, attempted to wreck the railroad station to prevent arrival of prisoners arrested in Jaffa in connection with yesterday's outbreak in which at least 13 were slain and many wounded. Police arrived in time to prevent serious damage as Arabs attempted to smash autos and taxicabs.

### WILL HOLD INQUEST IN KILLING OF EIGHT

Lumberton, Oct. 28.—Coroner D. W. Biggs, of Robeson county, announces that an inquest will be held in Lumberton on Friday, November 3, 10 a. m., to investigate the truck collision in which 8 people from the Deep Run community of Lenoir county met their death and 4 were injured last August 22. The truck loaded with tobacco bound for the Fairmont market, ploughed into the side of a Seaboard passenger train.

### Hungary Jails Communists

Szeged, Hungary.—(AP)—Mostly small merchants and farmers, 55 out of 59 persons tried here for formation of a communist "cell," were sentenced to genuine cells for terms ranging up to three years.

## CALL GENERAL STRIKE CUBA MONDAY NIGHT

### Workers to Strike as Protest Against Continued Clashes With Troops

Havana, Oct. 28.—(AP)—The federation of labor today called a general strike throughout Cuba at midnight Monday as a protest between troops and workers. The strike period is fixed at 48 hours but provision is made for extending it should the circumstances demand it.

Buses did not appear on Havana streets this morning, the drivers striking as a protest against the arrest of two officials of their union. This was considered as a preliminary of the general strike. Meanwhile the newspaper Diario de Larina which had been affected by the strike, appeared on the street and found heavy sales. There had been no disorders at the plant, the edition said. Employees of the newspaper slept in the building last night, fearing an attack.

The gas and electric light companies set noon today as the deadline for compliance with their demands and threatened to strike, leaving the city without lights and gas thereafter.

## SAYS BEE WAS CAUSE OF FATAL ACCIDENT

Salisbury, Oct. 28.—A coroner's jury sitting here this afternoon decided that the accident which caused the death of R. V. Surratt on Sunday, Oct. 8 near China Grove, was unavoidable. The testimony of Thomas R. Litaker taken as a deposition at the Lower hospital where he is still confined from his own injuries was to be the effect that a bee struck him in the eye causing temporary blindness and that he did not see the Surratt car until his car struck it. Mr. Surratt, who was a special agent, division of investigation, U. S. Department of Justice attached to the Charlotte office, was riding with Mrs. Surratt on his way from Greensboro to Charlotte when the cars met on the highway near China Grove. He was killed almost instantly and Mrs. Surratt was painfully injured. Mr. Litaker was badly hurt.

### SUSPECT FUL PLAY IN DEATH OF NEGRO

Whiteville, Oct. 28.—A rigid investigation into the death last Saturday night of Homer Shipman, Negro of the Western Prong township section, has resulted in the deduction that he was murdered, and afterwards placed on the highway where an automobile driven by Rich and Barkley, local young man, passed over the body during the early hours Sunday morning or late Saturday night. At the present time eight Negroes are being held for action of the grand jury, and a coroner's jury found that the Negro came to his death by being murdered and placed on the highway.

### Prevents Foreclosures

Washington, Oct. 28.—(AP)—Home Owners Loan Corporation said today its activities prevented 2,488 foreclosures on urban property valued at \$9,903,920 during the week ending October 20.

The new total for foreclosures avoided were given at 22,832. Individual loan applications tentatively approved by the home office were 68,220 with a total value of \$244,082,233.

North Carolina approvals numbered 157 totaling \$366,711.

## PUBLIC WORKS MASS MEETING BE HELD HERE

### State Engineer Will Be Present to Give Facts as to Government Loans

The State Advisory Board of the Federal Emergency Administration of Public Works has arranged for a regional mass meeting to be held in Greenville on Thursday November 2nd at 11:00 a. m. at the Shepherd Memorial Library.

In view of the announced policy of the Federal Administration to make allocations of the entire \$3,300,000,000 public works appropriations by January 1934, the State Advisory Board considers it desirable that three or four additional mass meetings be held immediately with public officials at strategic points in the state for further discussion of the objectives and opportunities of the Public Works Program.

When allocations from this fund have all been made the State Board does not want any public officials of North Carolina to be able to say that they were not fully informed regarding the eligibility of projects or the favorable financial terms offered.

Other regional mass meetings are being scheduled at Wilmington, Gastonia and Greensboro. H. C. Baitly State Engineer will be present and preside over the meeting.

## TO BOOST SIZE OF FUND FOR PUBLIC WORKS

### May Ask Next Congress to Increase Fund to Five Billion Dollars

Washington, Oct. 28.—(AP)—A boost in the \$3,300,000,000 public works fund is being considered by President Roosevelt and five billions is the new figure mentioned in some administration quarters. Secretary Ickes, public works administrator favors the \$1,700,000,000 increase. He feels that many communities may have to be turned down otherwise, so rapidly have requests for funds mounted, but President Roosevelt has not decided what additional if any he will ask of congress. Pending decision he is holding up next year's fiscal program.

To date \$2,105,216,526 of the \$3,300,000,000 public works fund has been allotted to federal and non-federal projects throughout the country. About one fourth of the amount allotted has been withdrawn from the treasury.

### PRISONERS ONCE TORTURED BY A RHINOCEROS "WRAP"

Washington.—(AP)—A political prisoner in ancient China sometimes was wrapped in the hide of a freshly-killed rhinoceros, reports Carl W. Bishop, archaeologist of the Freer art gallery of the Smithsonian institution. As the hide dried it contracted and slowly crushed the victim.

He has found one record of the year 681 B. C., which tells of a prisoner wrapped in a rhinoceros hide and sent to an adjacent state. He arrived at his destination "with his hands protruding from the ends of the roll."

### Dry Report

Raleigh, Oct. 28.—(AP)—United Dry Forces of North Carolina this afternoon reported to the Secretary of State that they had received \$2,904.88 in contributions and spent \$2,590 in their effort to prevent North Carolina from joining the repeal ranks of the states Nov. 7.

## Liquor Control As Others Do It

Heisingfors, Finland.—(AP)—Finland plagued by liquor smuggling during its experience with national prohibition, finds this illegal traffic still its worst problem in a new "wet" era.

Illegal trade in liquor grew by leaps and bounds in the long years of prohibition. It suddenly collapsed when prohibition was repealed on April 5, 1932, only to rear its head again.

Finland's legal alcohol trade is centered in a monopoly company, in which the state has absolute control. It has the sole right to manufacture alcohol, which it sells at retail in its own stores.

It has also the sole right to carry on trade in liquor for consumption on the premises, though it can grant this to private restaurants. Likewise, it can grant rights of manufacture to private firms.

In every community there is an inspector appointed for supervising the traffic in alcohol, and some places have temperance boards.

Intoxicants are allowed to be sold retail freely, except to minors, to soldiers unless they have permits from their officers, or to intoxicated individuals or non-intoxicant persons in their company.

Personal limitation, one of the essential points in the Swedish law, is not contained in the Finnish legislation.

The alcohol company may grant serving licenses to individuals, companies or cooperative societies for any kind of intoxicants, the advisory board deciding the terms and conditions of serving.

## TOBACCO MEN IN WASHINGTON AGAIN TODAY

### Discuss Benefits For Farmers of Flue-Cured Tobacco Areas

W. Z. and Hubert Morton of the local tobacco market are in Washington today in company with other tobacco warehouse representatives from Eastern North Carolina to confer with officials of the Agricultural Adjustment Administration regarding the making of the recently signed tobacco agreement retroactive in order to be of benefit to growers who had disposed of a large portion of their crop prior to the signing of the agreement. The warehousemen were called to Washington for study of the matter and to give the department the benefit of the views of the warehousemen in the matter.

While in Washington Mr. W. Z. Morton will likewise make a report to the government as to the working of the NRA code approved for tobacco warehousemen prior to the opening of the tobacco season. Today's visit to Washington is the ninth Mr. Morton has made in the interest of the tobacco farmers and warehousemen of this section within the past few weeks.

The delegation visiting Washington today is headed by E. V. Webb, Kinston, president of the Eastern Carolina Warehousemen's Association. Mr. Webb declared that it was the understanding before the tobacco agreement was promulgated that it would be retroactive. Since that time the opinions in the matter apparently have been divided and it is to clear up this phase of the matter that the tobacco men have been called to Washington.

Mr. Webb asserted that a new deal for tobacco farmers was assured by the marketing agreement. Never again will they be required to accept less than "living" prices for weed, he said, unless they decline to cooperate with the government. They indicated their willingness to cooperate when they signed acreage reduction contracts almost unanimously, he stated.

## TO GO AFTER VIOLATORS OF N. R. A. CODES

## NASH COUNTY YOUTH IN CRITICAL CONDITION

Jones sustained a severe cut in the neck and probably internal injuries, attending physicians at the hospital said. He was still suffering from shock today, however, and a complete examination had not been permitted.

No charges have been brought against the occupants of either vehicle and Williams declined to express an opinion as to who apparently was at fault.

## GOLD PRICES MOVE UPWARD

### Today's Price of \$31.82 per Ounce is \$1.25 Above World Figure

Washington, Oct. 28.—(AP)—In spite of a decline in the London gold price, the administration today placed domestic quotation at a new high of \$31.82, six cents an ounce above yesterday. The London figure dropped from \$31.10 yesterday to \$30.50 at the close there today a decline of 53 cents. While yesterday's domestic price of \$31.76 was 66 cents above the world figure today it was \$1.25 above.

### Allot Funds

Washington, Oct. 28.—(AP)—The Public Works Administration today allotted \$6,107,225 for 52 non-federal projects in 25 states, saying it would provide estimated 40,000 man months of direct employment and 80,000 indirect employment.

to force any of it on us.

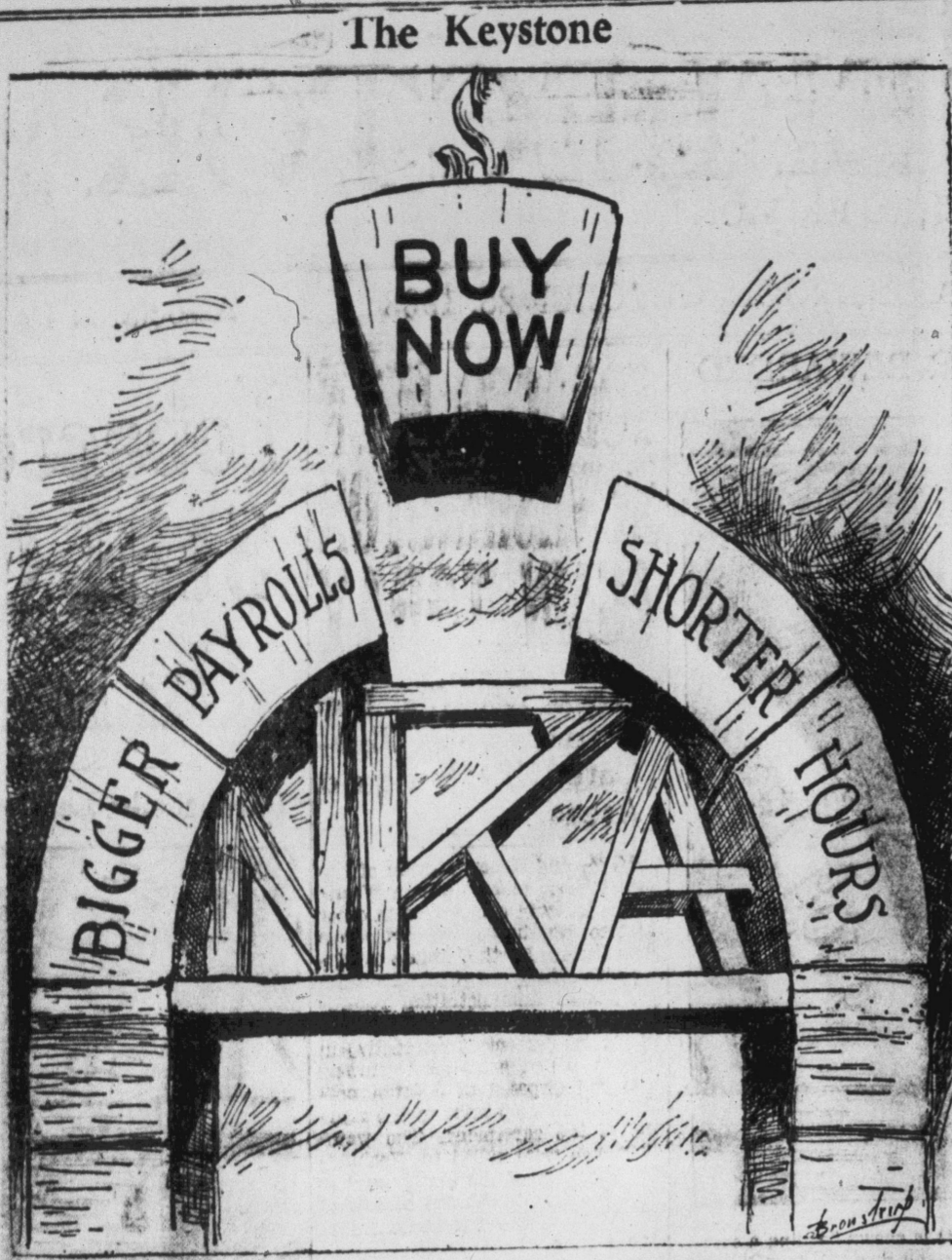
Let's have a little action

THE TOBACCO FARMERS' ARCH ENEMY

(Elizabeth City Independent)
The arch enemy of the tobacco
farmer is the Federal Government
with its paternalistic gestures on
the one hand and its outrageous
tax on the cigarette on the other
hand. Remove the six cent-re-
venue stamp from every package
of cigarettes, give the American
consumer a decent package of cig-
arettes for a dime, and production
of machine made cigarettes would
likely double within a year. Not only
would the demand for the farmer's
tobacco be doubled and leaf tobacco
prices boosted by the accelerated
demand, but thousands of now un-
employed men and women would
be brought into the cigarette factories
to make a large part of the 80 bil-
lion cigarettes now being rolled by
hand.

The Federal Government collects
\$1.80 on every pound of fine-cured
tobacco that enters into the manu-
facture of cigarettes. And then gov-
ernment theorists, and the follow-
ers of Mr. Josephus Daniels raise
hell, not with the government, but
with the tobacco companies, that
get actually 51-2 cents out a pack
of cigarettes that the government
gets six cents out of. More than
\$300,000,000 of the government's in-
ternal revenue comes from the cig-
arette. "A way the government has
of making the South pay for the
war" is a way Mr. S. Clay Wil-
liams of the R. J. Reynolds Tobacco
Co. has of stating it.

SEEK SERUM FOR HORSES TO HALT EASTERN PLAGUE

Washington (AP)—The Depart-
ment of Agriculture is seeking a
serum to combat unusually numer-
ous cases of infectious equine en-
cephalomyelitis, sometimes called
"sleeping sickness" that have been
reported in recent months in east-
ern states.

The disease affecting the brain
and spinal cord of horses and mules
has often been called forage poi-
soning, staggers, Kansas-Nebraska
horse plague and cerebrospinal
meningitis.

The disease is caused by an in-
visible virus, similar to one which
produces a horse disease in west-
ern states where an anti-serum has
been developed with good results.

## N. Y. Stock Market

New York, Oct. 28.—(AP)—The stock market, along with grain and most other commodities, shifted about today and prices generally pointed downward. Trading was extremely dull.  
Another increase in the gold price of 6 cents an ounce to \$31.82 failed as a stimulant, and the close was easy. Transfers approximated only 480,000 shares.  
The announced failure of government and steel corporations to get together on prices for rails tended to cool speculative ardor and the small increase in the gold rate was disappointing to some who had expected a more substantial raise. The London gold price was lower, to approximately \$30.44 from yesterday's \$31.10. The dollar rallied in early foreign exchange dealings. Wheat dropped 2 cents a bushel at one time and recovered somewhat on government purchases. Bonds mixed. Purchases were at a standstill and the ticker tape was silent for minutes at a time. While there was virtually no short selling, there were few buyers present.

## TAR HEELS SET FOR FRAY WITH GEORGIA TECH

Chapel Hill, Oct. 28.—The Carolina gridders have put in the most intensive week of practice of the season and appear set to give Georgia Tech a brilliant battle in the feature event of a Homecoming celebration here today which will be the biggest and most colorful held here in years. The kickoff will be at 2 o'clock.

The Tar Heels, who have broken even with the Tornado for the past four years and who are intent on avenging last year's loss, have been scrimmaging by afternoon to develop more power and returning to the stadium at night to polish up their attack and defense in long drills under the floodlights.

The Ramblin' Wreck looked like Tech's national championship team of 1928 (which Carolina played a whole of a game) in smothering Clemson 39-2 and in defeating Auburn. Conference championship last year 16 to 6. But the Kentucky and Tulane games proved that the Tornado could be stopped by a strong line and a good punter.

Carolina hopes are running high as a result. For the Tar Heel line played its best defensive game of the year in limiting the high powered Florida offense to five first downs last year. And their own attack has been showing lots more punch and power in practice this week.

The Tar Heels will also be in much better shape physically than when they faced Florida. Julian Frankel has resumed his regular place at left end. Elmer Barrett and Emmett Strickland are recovered from injuries, leading extra reserve strength at tackle. And Don Jack-

son, star halfback, is back in form and going great along with several old heads and two newcomers in the ball carrying role. Woolen and Snyder.  
This will be the first game since Vanderbilt in which the big veteran Tar Heel line headed by the stars, Barclay, Collins, Kahn and Brandt has run intact and carried top strength. It will also be the first game since Davidson in which the Tar Heel forwards, who average 185 pounds, have not been outweighed several pounds to the man.
