SIX STATES VOTING ON PROHIBITION REPEAL ISSUE

N. C. DRYS THINK STATE TO STAY DRY

Only Three of Six States Voting Today Needed to Make Repeal of Dry Law Actuality; Both Drys and Wets Lay Claim to Victory in North Carolina

(By The Associated Press)

Voters in a half dozen widely scattered States today were inscribing their answer to whether thirteen years of national prohibition shall end next month.

Of almost equal importance to a large portion of the electorate is New York City's three-way mayoralty contest in which Tammy Hall's long reign is at stake.

Elsewhere in the count of the off-year November election horizon—city and State elections—political observers hope to gain sentiment with an eye to Congressional campaigns next year.

Confidence that the balloting in Pennsylvania, Ohio, North and South Carolina, Kentucky and Utah would climax this administration's campaign to restore liquor was expressed by Postmaster-General Jas. A. Parley, who also brought the national administration a bit closer to the New York race with a last-minute open appeal for the election of Joseph V. McKee.

Wet organizations forecast anti-prohibition sentiment in at least three of the six States voting—all that is now necessary to assure elimination of the Eighteenth Amendment from the National Constitution—while dry organization captains said there were good chances for halting the hitherto unbroken wet parade.

All other voting expressed themselves today that actual repeal would not materialize until the first week in December.

All were to elect delegates to State conventions, December 5 and 6, which will ratify or reject the new Constitutional Amendment repealing the Eighteenth Amendment.

Repeal leaders in North Carolina predicted that in the count today would show the Tar Heel State, bone-dry for a quarter of a century, in the anti-prohibition column, already containing 33 States that have voted for repeal of the Eighteenth Amendment.

But dry spokesmen countered with the prediction that today would record an interruption in the hitherto unbroken march of State after State in the repeal brigade, and that his State would not be one of the three needed to erase prohibition from the Constitution.

Walter Murphy, of Salisbury, member of the State House of Representatives and generalissimo of the anti-prohibition forces, asserted that not more than fifteen of the State's one hundred counties would vote dry. But from Kale K. Burgess, director of the United Dry Forces, came the assertion that prohibition had excellent chances to defeat the proposal for calling the convention, which would be equivalent to endorsement of the Eighteenth Amendment.

Upward Swing Of Gold Prices Halted Today

Washington, D. C., Nov. 7.—(AP)—The upward swing price of newly-mined domestic gold halted at least temporarily today when a Reconstruction Finance Corporation price of \$32.8 an ounce was set for the metal, reporting no exchange for private quotas.

The price came in the fact of dispatches from London telling of gold weakness which had developed there. The London opening slipped off from 129 shillings, 11.12, or a reported drop of one shilling and 10-12 pence. The United States equivalent of the London price was \$31.8, on a basis of sterling.

New York, Nov. 7.—(AP)—Maxim Litvinoff, Soviet commissar for foreign affairs, arrived today for his momentous conversations with President Roosevelt, expressing the hope that "the establishment of normal relations between the Soviet government and the United States would not bring actual disamament."

"We shall negotiate no treaties while we are here," the Russian Foreign Minister told interviewers who met him down the bay on the liner *Porengia*. From there he was taken in a special tug to Jersey City to catch a special train for Washington.

LIGHT VOTE INDICATED IN ELECTION HERE

Both Drys and Wets Lay Claim to Victory in Balloting Here Today

Opponents and proponents of prohibition went to the polls here today to vote on proposed repeal of national prohibition. Although interest has been of the campaign leading up to election day, indications were that a fairly large vote would be recorded here, although comparatively light in contrast to the tremendous vote recorded here in the Presidential election.

Although wet and dry organizations were set up in the county over a month ago, the campaigns have been marked by little of the ballyhoo that featured the burial of Jern Barleycorn several years ago.

Most of the campaigning has been done on the side of the drys. This was marked by public meetings and speeches at which the evils of strong drink were held up before public gaze along with the good results claimed to have been obtained through passage of the national prohibition legislation.

While the wets have been working diligently, they did so quietly. No public meetings were held, but sentiment was tested out in virtually all communities by those using their influence for a return of whiskey.

Balloting was being conducted in all precincts of the county. In Greenville voters went to the courthouse where ample facilities to take care of the ballot were set up.

FAIL TO REACH AGREEMENT ON BRITISH DEBTS

Roosevelt Announces End War Debt Negotiations With British Ready To Pay

Washington, Nov. 7.—President Roosevelt today announced the end of the British war debt negotiations without an agreement but with payment of \$7,500,000 by Great Britain on its December 15 installment.

This token payment will be paid in American currency in lieu of the \$117,000,000 in December under existing agreements.

The president announced that in view of the part payment he would not regard the British government as in default.

This was the attitude taken last June at which time the British paid about ten per cent of the amount due and that in silver at the rate of 50 cents an ounce to the amount of \$11,000,000.

In his statement today Mr. Roosevelt said the debt negotiations were concluded without prejudice until certain factors in the world industrial and monetary problems became more clarified.

He revealed that he had been assured by the British government that it continues to acknowledge the debt without prejudice and asserting its right to present the matter for readjustment on December 13 when it will give tangible expression of this acknowledgment by the payment of \$7,500,000 in United States currency.

With the increasing number of thefts of tobacco reported from various sections of the county, officers reported today that the home of J. J. Summerell, on Fifth Street, was entered Sunday night and an overcoat stolen.

Although a complete check of the premises was made in the belief that other articles might have been taken, Chief of Police George Clark stated today the only other thing touched was a half gallon of peach brandy which had been on the table in the dining-room of the home.

After consuming part of the beverage, the officer said the thief or thieves left the remainder in the jar container and apparently departed through the rear of the house where they made their entrance.

Although other clothing was hanging near the overcoat, the thieves did not molest this, merely taking the overcoat which they probably thought might come in good with lower temperatures being predicted for the week.

Chief Clark stated the theft of tobacco was widespread over the county, but that none of the thieves had been apprehended recently. Sometime ago several thieves were picked up and sent to the roads on such charges, and an effort was being made to send others along the same route.

COUNTY COURT IS IDLE TODAY

C., Nov. 7.—Farmville is this week busily engaged in preparing for a much anticipated event, and the entire citizenry is, as the custom is here, in the promotion of any project attempted with high purpose, displaying a fine spirit of enthusiasm and uniting their efforts in making the Golden Weed Jubilee, which will be held here by the fourteen tobacco markets of the Bright Leaf Belt on Friday, November 10, the most enjoyable occasion of its history.

GROWERS ARE PLEASED WITH UPWARD TREND

Market Paid Out \$309,470.72 on Sale Of 1,438,868 Pounds Of Leaf Here Yesterday; Price Situation Reported Strong Today; Offerings Expected to be Heavy From Now Through Holidays

Tobacco prices continued to bound joyously upward on the local tobacco market yesterday and the highest price levels of the season were recorded, it was revealed today in the official report of K. W. Cobb, supervisor of sales.

The market averaged \$21.48 per hundred pounds on the sale of 1,438,868 pounds and for which farmers were paid a total sum of \$309,470.72.

The average was exactly a half cent higher than the previous high mark recorded the later part of last week and was received with unrestrained joy by the thousands of growers who market their tobacco here from day to day. The previous high mark was \$20.98.

The price situation has continued to develop strength since the reopening of the markets from the enforced holiday some time ago, and the improvement yesterday drew prices still nearer to the parity promised by buyers in the conference with government representatives.

Prices on virtually all grades showed an upturn yesterday and the situation was described as similar as the market continued selling operations today.

Hundreds of farmers from a radius of many miles were on the market yesterday and were hearty in their expressions of approval of the fine spirit of co-operation in evidence on all sides here. Some of the growers had never sold their tobacco here before and they expressed astonishment at the tremendous facilities for moving the crop from day to day.

Reports over the week-end indicated that Greenville not only led the belt from the standpoint of prices but continued to blaze the pathway in the matter of poundage. The record of the largest bright leaf market in the world captured by this market three years ago was given a decided boost last week as the total poundage figures reflected gains on the nearest rival for this honor.

Sales which have been comparatively heavy since the resumption of work after the holiday were expected to continue heavy through the Thanksgiving holidays and by that time the lead both in price and poundage was expected to be far in excess of what it was today.

Gathering near the city limits 11 automobiles containing 50 farmers armed with baseball bats, axe handles and clubs found one camp site deserted, but with a fire still burning.

The group left with the intention of going to Lamar to advise Sheriff Ripley that they planned to keep the highways open themselves unless he took proper action to do so.

Reports were that members of the St. Louis Milk Producers Association intended to run the blockade but a search failed to locate any milk trucks.

Sub-freezing temperature had the effect of removing the pickets from the highways.

Vilence Flares Up in N. Y. New York, Nov. 7.—(AP)—Vilence and disorder accompanied today in the municipal election voting with fusion forces threatening to demand protection of national guards troops from gangs of marauding thugs.

One man was stabbed a score of election workers blackjacked and beaten and an entire election board arrested as voters balloted in one of the stormiest elections in general elections in which Tammany is fighting for survival and national political influences are exerting strong outside pressure.

Assemblyman F. L. Huackenburg telephoned chief police inspector John O'Brien from fusion headquarters that a request for troops would be forwarded to governor Herbert Lehman unless widespread disorders were quelled "within 15 minutes."

A police alarm was sent out in Brooklyn for a squad of thugs who stabbed Geo. Bernette, a workman for candidate Joseph B. McKee and manhandling workers and watchers at various polling booths.

Added to the increasing number of arrests for illegal registration was the entire election board of the 29 election district, which was jailed on charges of permitting votes to be cast by persons allegedly unqualified.

Lindbergh in Holland Amsterdam, Nov. 7.—(AP)—Col. and Mrs. Charles A. Lindbergh returned to Holland today, making a safe landing near Wallhaven airdrome when unfavorable flying conditions prevented them from continuing to Geneva after a flight over Belgium and France in a heavy fog.

NEW ORLEANS COTTON New Orleans, Nov. 7.—(AP)—Cotton opened steady with Liverpool spot much better due to the improved condition of the pound sterling. American gold was unchanged to \$32.84. First trading here showed gains of one to three points at prices improved after the start, mainly on the good staples.

December started at 9.36 and March 9.80, or four to eight above yesterday's close.

The market ruled quiet all morning, but there was some price fixing orders and some buying of the March positions by Liverpool, but as wheat turned lower cotton gradually declined until December dropped to 9.30 and March to 9.53, or 6 to 7 under the highest and two up down to one up compared with yesterday's close.

At midday the market rallied two to three points from the lows on some further price fixing.

ALLEGED FLOGGER REMAINS AT LIBERTY Rocky Mount, N. C., Nov. 7.—(AP)—legged to have been one of the three men who kidnaped, flogged and robbed E. L. Dawes, Nash County farmer, Thursday night, Dewey Williams today was still at large although representatives of the department of justice had joined with local police in the search.

Police quoted Dawes as saying Williams was one of his abductors. None of the trio had been sighted. P. H. Johnson, Nash deputy sheriff, said.

Captain W. S. Waters, of the Atlantic Coast Line Railroad police, said that department of justice officials had been notified and that they had joined in the search for the three men who took Dawes from his home in Nash County in the night, took him into a forest in Wilson County, stripped, beat and robbed him and left him naked in the woods while they fled with his clothes.

ONE KILLER, THREE HURT. IN AUTOMOBILE MISHAP Hillsboro, Nov. 7.—(AP)—Carl Jeffries, Winston-Salem Negro, was killed and three other Negroes, also from Winston-Salem, were injured when their automobile over-turned yesterday afternoon on highway 10 en route to the Duke-Auburn game in Durham.

Jeffries died shortly after arriving at a Durham hospital. Others treated at the hospital were John Mebane, Rogers Kiser, and Charles Martin. They were discharged after having bruises and lacerations dressed.
