## ARMISTICE DAY CELEBRATED ON SATURDAY

### Judge J. Paul Frizzelle Delivered Address to Gathering Of Ex-Service Men

Declaring President Roosevelt to be a great leader and prophet, and urging the people to follow him, Judge J. Frizzelle, of Snow Hill, Judge of the Fifth Judicial District, delivered the principal address of Armistice Day exercises conducted in the campus building of the East Carolina Teachers College here last Saturday.

The address came as a climax to a program that included a parade from the A. C. L. depot to the college, a barbecue dinner for former service men and the auxiliary of the legion, and a football game in the afternoon in which East Carolina Teachers College trounced Campbell College.

Introduced by President Robert H. Wright of the college, Judge Frizzelle mentioned in a brief way the valor of the American soldiers who fought in the great war to put down German autocracy and compared it to the Revolutionary War when American soldiers for the first time fought to uphold the principles that all men are created equal and entitled to the peace and security embodied under that principle.

It has been necessary for this government to go to war about every twenty-five years to sustain the principle of freedom and equality, the speaker said, and the two great objectives of government at this time are to make the world safe for democracy and war to end war.

Fifteen years after that great war, the jurist said, it is appalling to note that half of the people show no interest in the government of their land and that democracy is unsafe because the people are unconcerned about its stability on election day.

Declaring that knowledge and wisdom derived from extensive education are necessary to give one a clear conception of the principles of government, the speaker referred to what he termed the "recent backward step in education in North Carolina." He deplored the slashing of expenses resulting in crippling school facilities in this State, but expressed hope the mistake would soon be discovered and that sufficient appropriations would be forthcoming to enable the State to return to the high standards of public education enjoyed before the passage of the new school legislation.

He pointed to the distrust in government springing up everywhere—even in Congress—and said belief existed that men high in life of the government do not represent the best interests of the people.

Triumph was paid to Washington, Lincoln and Wilson. They were held up as outstanding leaders of the country. He then called attention to President Roosevelt's efforts to bring a return to the high principles of democracy, describing him as a prophet and builder with peace and vision. He enjoined his hearers to stand by the President in his effort to lift the nation back to the high ground of economic stability and to heed his command, "Follow me."

J. H. Rose, commander of the Pitt County Post of the American Legion, presided over the exercises. Colors were advanced and placed on the stage by members of the local military unit. Divine guidance was invoked by Rev. A. W. Feischmann, pastor of Memorial Baptist Church. A moment's silence was observed for departed veterans and taps were sounded by Dan Wright.

The preamble of the Constitution was recited by the assembly. J. B. Kittrell reported on the membership campaign recently conducted by the Legion, saying the Post had gone over the top in a most commendable manner.

Dr. R. S. McGeachy was awarded the Distinguished Service Cross of the United Daughters of the Confederacy by Mrs. James Edwin Woodard, president of the North Carolina Division of the United Daughters of the Confederacy, assisted by Mrs. J. L. Fleming.

Mrs. Herbert Waldrop, sweetheart of the local Legion, delightfully rendered, "Roses of Picardy," accompanied at the piano by Mrs. G. V. Smith. "Let Us Forget" was rendered by the college Glee Club. A roll call for the dead was made by the commander, after which the singing of "America" and retiring of the colors concluded the exercises.

Taking part in the parade, which ushered in the observance, were the military unit, Boy Scouts and former veterans. The pageant was reminiscent of that first Armistice Day fifteen years ago when millions of men laid down their arms and returned to paths of peace.

Banks and public buildings were closed in honor of the occasion and "Old Glory" danced merrily in the breeze from flag-poles in front of stores and offices in the principle business districts.

## ONLY 25 HOME LOANS CLOSED IN THIS STATE

### 838 Federal Loans Approved But Only 25 Have Actually Been Closed

Washington, D. C., Nov. 13.—(AP)—The Home Owners' Loan Corporation has tentatively approved 838 applications in North Carolina but only 25 loans have actually been closed. It was announced here today. The figures include all loans up to November 9.

Twenty-three of the loans, amounting to \$81,106, were closed by exchange of corporation's bonds for mortgages, and two amounting to \$2,263, were closed on a 50 per cent cash basis.

The corporation rejected 840 applications after appraisals by field agents.

## THREE HURT IN ACCIDENT IN THIS CITY

### Injured When Car Crashed Into Barricade at Lower End Of Pitt Street

Forbes Allen, his sister, Miss Carrie Bell Allen and Miss Louise Allen, daughter of Titus Allen, were seriously injured late Saturday night when their car crashed into the barricade at the lower end of Pitt Street at the site of the old Tar River bridge. According to available information the trio had started across the river and for the time being had forgotten that the highway sometime ago was changed from Pitt to Green Street when the new bridge was built. Allen was said to have cleared the top of the hill at First and Pitt Streets before he realized that the bridge at the end of that street had been removed and the street barricaded. Before he could check the speed of his car on the steep downward the vehicle crashed into the steel barricade and was almost completely demolished.

All the parties were rushed to Pitt Community Hospital where the two young ladies are still confined. Allen after receiving medical attention for a broken jaw was able to leave the hospital.

Miss Louise Allen was the most seriously injured, having suffered a broken upper jaw, other cuts and bruises about the face and head and an arm broken in two places. Miss Carrie Bell Allen received a broken nose and other injuries about the face and head.

They indicated he might be a member of the gang. Two police detectives were wounded in the fight.

## BETHEL MAN IS SHOT TO DEATH

### Argument Over 88 Cents Check Ends in Killing Late Yesterday

Allen Carson, 25, son of Policeman Carson, of Bethel, is held in jail here pending raising \$5,000 bond as a result of the fatal shooting of E. L. Simons, about 25, at Carson's filling station in Bethel yesterday afternoon.

The young man was said to have followed him into the station and he and young Carson had several words over the check as a result of which Carson pulled out his gun and shot Simons. Simon stepped outside the station door where he fell mortally wounded.

The deceased was a son-in-law of Chief of Police Martin, of Bethel, and is survived by his wife and infant child.

Carson is also a married man and has a wife and two children.

## PUBLIC WORKS ENGINEER IS FIRED TODAY

### Tennessee Engineer Had Stated Municipalities Not Expected to Repay Loans

Washington, D. C., Nov. 13.—(AP)—Secretary Harold F. Ickes, of the Interior Department, and Public Works Administrator, today dismissed Harry F. Barry, Public Works Engineer of the State of Tennessee, as a result of the expression of an opinion in a circular letter by Barry that municipalities making applications for loans for projects will not be expected to repay them.

The circular letter, the statement by Secretary Ickes said, was written on a letterhead of the Tennessee Public Works Advisory Board.

In telegraphing Barry, Secretary Ickes said:

"I have before me a copy of your circular letter of October 25, addressed to all civic organizations, expressing your belief that municipalities applying for loans for projects will not be expected to carry out their agreements to repay such loans. Your services as State Engineer are terminated."

## KILLS GIRL AND HIMSELF

### Shoots Girl To Death And Then Puts Bullet Through His Own Head

Gaffney, S. C., Nov. 13.—(AP)—Cole Phillips, 25-year-old farmer, killed Miss Lulu Childers, 19, at her home here today and then fatally wounded himself following a quarrel with the dead girl's sister.

Officers were searching for Phillips on a warrant charging him with slaying the slain girl's sister Saturday night. The warrant was sworn out by Grant Childers, father of the Childers' girls.

Chief of Police H. H. Lockhart investigated the slaying and said that information he gathered was to the effect that Phillips was in conversation with Miss Lulu Childers regarding the trial on charges of assault. Almost immediately, the officer said he learned, Phillips shot the girl through the head with a revolver and she fell dead almost instantly.

Phillips then turned the gun on himself and sent a bullet through the head. He died a few minutes later at a local hospital.

Police said Phillips and Miss Childers had been seen together on many occasions, and could find no apparent reason why he should shoot the girl.

### Gold Prices Still Climbing

Washington, D. C., Nov. 13.—(AP)—A price of \$345 was fixed today Reconstruction Finance Corporation purchases of newly-mined domestic gold, 15 cents higher than Saturday's price. The figure is 46 cents above the London price converted into dollars at the exchange rate.

The exchange rate later moved to \$314. The increase of 13 cents in domestic rates compares with the increased rate of 30 cents in London for gold purchased.

## HOLD WOMAN FOR HER PART IN MASSACRE

### Arrested When Officers Raid Memphis House Seeking "Pretty Boy" Floyd

Memphis, Tenn., Nov. 13.—(AP)—A woman described by police as Mrs. E. B. Connor, under indictment in Kansas City in connection with the Kansas City massacre, was captured here early today.

Federal operators said Mrs. Connor is the woman who telephoned from Hot Springs, Ark., to give gangsters the information which resulted in the massacre in which five were killed and a number of others injured at the union station in Kansas City on June 17th last.

Acting on tip that Charles (Pretty Boy) Floyd, the Oklahoma desperado, was hiding here, police and Federal officers raided a house here today and arrested two women, one of whom they believe is a sweetheart of Floyd.

Police maintained silence on the raid, but the man they were advised was Floyd apparently eluded the net prepared for him.

Officers said they had hoped to arrest Charles (Pretty Boy) Floyd and Verne Miller, the Kansas City machine gunner, but if either had been in hiding they were gone when the officers raided a house in the outskirts of the city.

The arrest of Mrs. Connor was made at 8:30 a. m. C. S. T. Another woman was taken into custody with Mrs. Connor, but police would not reveal her name on the theory that she was not involved in either case.

Willis T. Griffin, chief inspector of police detectives, said he got information some time ago that Mrs. Connor was hiding here and wrote J. Edgar Hoover, chief of the Bureau of Federal Investigation, whose officers assisted in the raid. Griffin said he had been hopeful that either Miller or Floyd would show up here.

The house in which Mrs. Connor was arrested had been under surveillance for several days.

## DEEM ARMS CONFERENCE A FAILURE

### Hungary Joins Italy in Belief Conference Cannot Succeed Without Germany

Geneva, Nov. 13.—(AP)—Italy's conviction that the present Disarmament Conference is sterile without the presence of Germany was backed up by Hungary today.

As a result of Italy's attitude, observers said they believed all present negotiations were doomed to result in failure in their existing form.

The Hungarian government announced the attitude of an observer, and said that it would ignore everything approved since July 15, when Germany accepted the original plan which Premier Ramsay MacDonald of Great Britain laid down as a basis for discussion.

This means that Hungary, like Italy, seems the conference without Germany, as sterile, inasmuch as that government rejects the London and Paris agreements and plans as put forth by Sir John Simon which were submitted to the conference the day Germany quit the League.

### Australian Bunnies Foiled By Line-man's Invention

Sydney, Australia.—(AP)—Ready-made nests for magpies have solved the problem of frequent breakdowns in telegraph and telephone services in New South Wales.

The birds have nested where they pleased among the wires, causing short circuits.

One linesman designed artificial nests which he erected on the cross poles where they could do no harm. The birds immediately moved into the new quarters and not a single breakdown over the experimental stretch of line was recorded in a year.

As a result, the postmaster general proposes to extend the scheme.

### Greek Church Bans Masonry

Athens.—(AP)—The Holy Synod of the Greek Orthodox Church has ruled that no members of the church may be Free Masons. Priests who now belong to the order must renounce it or be unfrocked.

### IOWA BEER CONSUMPTION WOULD FLOAT BATTLESHIP

Des Moines.—(AP)—Iowa revenue officials estimate citizens of the Hawkeye State will consume enough beer to float the proverbial battleship—12,500,000 gallons—during the first year of operation of the Iowa Beer Law.

During the five months in which the State tax has been levied collections recorded by the State treasurer's office totaled \$227,366.51.

At the rate of four cents a gallon tax that figure represents 5,284,162 gallons consumed to date. Total tax collections for the first year are expected to exceed \$500,000.

### DENVER MAN RAISES FISH IN CELLAR OF HIS HOME

Denver.—(AP)—The basement of Stewart Mendum's is always full of water, but like many a home owner, it pleases him.

It's his own doing, in fact, for out here where snow and ice crown the mountains the year around he has set up a basement aquarium where he raises rare tropical fish. He has more than three hundred species, including several unusual labyrinth fish, bluish specimens with long feathery tails and known as fierce fighters.

### Last Week's Prices Highest of Season; Sales Near 49 Millions Mark Today

Published reports on last week's tobacco sales in this belt showed Greenville to still be leading the entire belt in both pounds and prices for the season.

Official figures on the Greenville market showed last week's sales of 7,151,626 pounds for \$141,895.64 averaging \$20.16 per hundred pounds. The figures for the season were 47,478,190 pounds for \$742,973.27 for an average of \$15.64 per hundred.

### FRENCH CELEBRITIES REVEALED IN FIRST REFERENCE VOLUME

Paris.—(AP)—Facts about the French great and near-great are about to be revealed in a book.

A biographical dictionary of some 25,000 men and women active in politics, science, literature, sports, business, and the arts—those who do things or of whom the world talks—finally has been compiled.

A decade ago a small volume appeared giving a few facts about a number who had attained definite celebrity but not until now has there been a comprehensive volume.

Some of the names which have not appeared hitherto are Henri Cochet, Jean Borotra, Rene Lacoste, and Suzanne Lenglen, of tennis fame; Paul Codos, Maurice Rossi, and Dieudonne Costes, who have made aviation history; Andre Maurois, the writer; and Henri Matisse, one of the most successful of present-day painters.

### "OLD DOBBIN" IN A COMEBACK

Round-Ups Put Him in the Farm Feed-Trough Line Ready to Work—And Eat For Prosperity.

Belle Fourche, S. D.—(AP)—A "comeback for Old Dobbin" under the Blue Eagle, foreseen by horse dealers of the agricultural West, is reflected in accelerated activity around horse-flesh marts in these parts.

Rangeland water holes long abandoned are crowded again with myriad flashing hoofs, coral "traps" unused for years are being repaired and wild horse wranglers are finding themselves once more in the saddle.

### Demand Moes Up

For the first time since the World War the demand for horses seems definitely upward, men at the sources of supply say.

Broncs, retired saddle horses, old draft horses, colts, even the burro of Rocky Mountain fame—without exception they're all being rounded up and shipped in all directions.

And some of the better known horse breeders contend there's logic in the returning demand for horse power. The "most sensible" farm relief, they say, will come through a shift in land use, by increasing the area and production of farm horses and mules.

### Eating Up Surplus

"A horse or mule at work on the farm," one horseman states, "consumes annually about 70 bushels of sumac, 15 or 20 bushels of corn, one to one and a half tons of hay and an acre of pasture."

"It is a domestic allotment plan in itself," he concludes triumphantly, "with no cost of administration."

# ECTC TOPS CAMPBELL

The touchdown bringing the Teachers their first football victory came in the third period when after Puckett had run a punt back 18 yards to the visitors' 32, the locals drove to and over the goal. Successful line gains by Puckett, Rogerson and Eason ate up the ground separating the Teachers from goal, and Rogerson went over to touchdown.

Late in the first quarter the Teachers had threatened but Campbell had held for downs at its four-yard line.

The Teachers made seven first downs, one more than Campbell. The visitors did most of their gaining by passes. They attempted 15 punts, completing five and having two intercepted. In the final quarter Campbell turned the air in an effort to overhaul the Teachers and the Humphries-to-Taylor passing combination clicked for an advance of 65 yards, but the threat fell short.

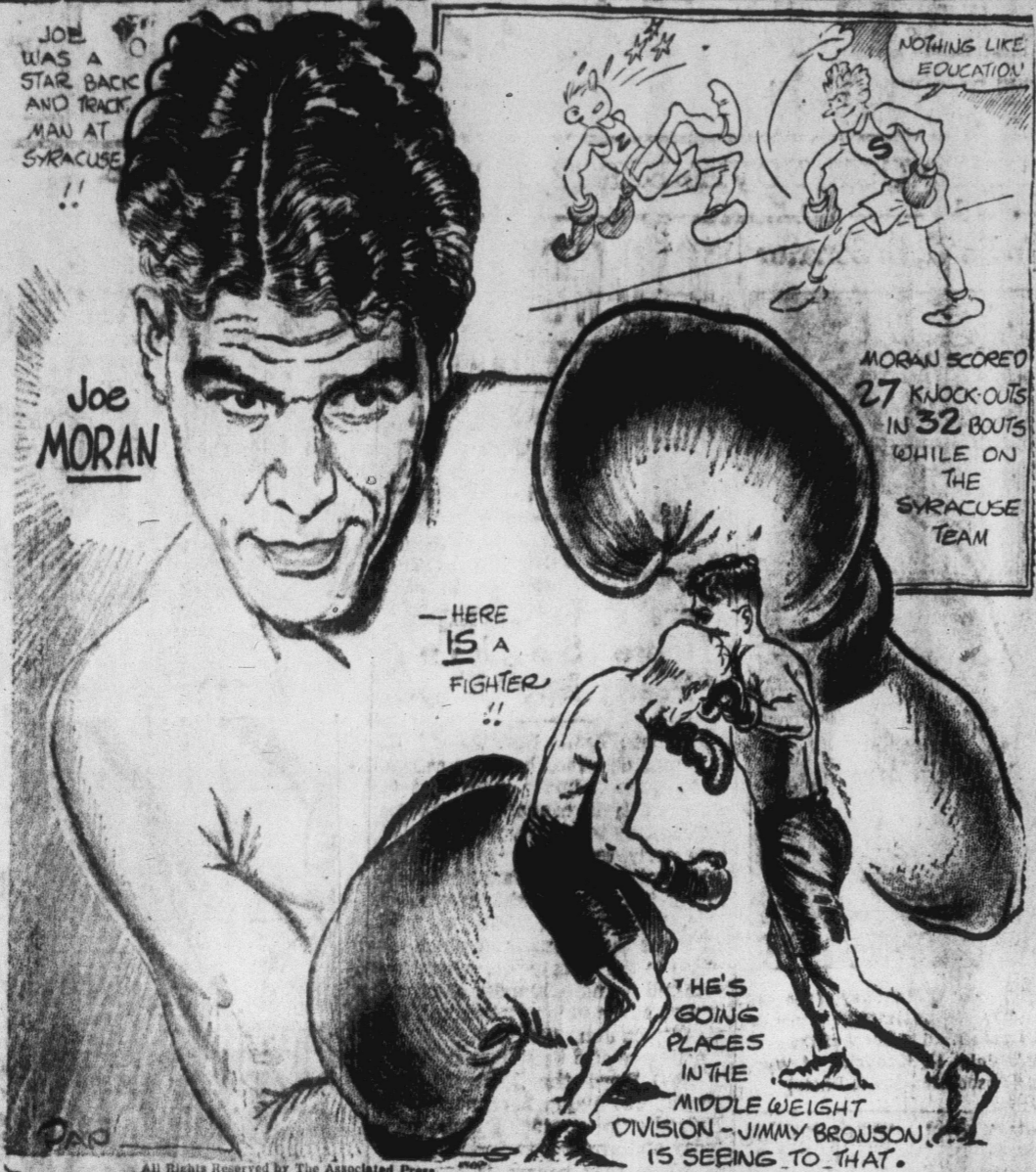
The Teachers made only two passes, completing one and having the other intercepted.

The engagement of Stanley Raymond Harris to manage the Boston Red Sox and the forecast of Mickey Cochrane's selection for the Detroit job not only seem to complete the roster of pilots for 1934, but dispels the idea that Babe Ruth will leave the Big Town, at least for the fulfillment of any managerial aims and ambitions.

Put down as a piece of imagination any suggestion that Ruth would be interested or involved in buying into a big league club, such as the St. Louis Browns.

In the first place the Babe can't write any check big enough to interest the holder of a major league franchise. Most of his important money is tied up. And even if he could, the wife wouldn't let him.

There is well-denied reason for belief that Ruth talked over a proposition to manage Detroit, on a salary and percentage basis, depending on the gate receipts. This may have advanced no further than the conversational stage, but it is intriguing and holds possibilities. It would be interesting to see just how much difference in the "gate" the Babe's presence in a new setting would make.

This would depend, naturally, on how consistently Ruth could take his place in the line-up in 1934 and do the turnstiles. It's a gamble that apparently other magnates are willing now to let Colonel Ruppert take.

**Break For Bucky**  
Harris, with the Red Sox, has the best chance to show his talents as a leader since he left the Washington Senators.

Bucky enjoyed few good breaks with the Tigers and he was limited in what he could work with. Detroit's policy was to develop most of its talents. This not only is a prolonged and difficult process, but is a decided gamble. Nevertheless Harris demonstrated skill and judgment in setting the most out of what he had.

With the latch strings hanging out on the front box at Boston under the Yawkey-Collins program of rehabilitation, Harris will have all the material and encouragement possible. If the Sox swing their possible big deal with the Athletics, Bucky could likely can drive the club into a sustaining position, which is all they ask down East.

## Claim African Bone To Be Oldest Trace Of Early Man

London, Eng.—(AP)—A jaw fragment that an ordinary fist might enclose is the basis of the claim of a young Cambridge scientist that human remains discovered in British East Africa are the oldest known.

The scientist is Dr. J. S. B. Leakey, thirty-year-old fellow of St. John's College, Cambridge University, who has just completed a study of this and other discoveries of man's early existence made by an expedition of which he was the leader.

"For the first time the real ancestors of man have been found," he says.

This jaw fragment had lain, for a million years, according to geological evidence, in the spot where it was picked up in March, 1932, at Kanam near the shores of Victoria Nyanza.

Although that is no older than the Pittsburg skull fragment found in England and the Peking woman skull, the African, Dr. Leakey finds was a true man, homo sapiens, while the others were only "cousins."

**Thigh Bone From Erect Walker**  
In another site were found skulls of modern type, and a portion of a thigh bone formed in such manner that it must have come from a creature which walked erect on two legs.

"The jaw," he explains, "represents a new species, to which I have given the name homo Kanamensis, definitely ancestral to the species to which modern man belongs today. This is true because there are certain characters of the jaw which separate it from one of modern man."

With the fragment were found examples of a crude pebble culture. There were tools fashioned out of water-worn rocks. Also tools made from the jaw-bone of an extinct pig, from remains of mastodons, the first ever found in Africa, from teeth of an extinct animal of the elephant type, and from hippopotami.

The skull fragments were found at Kinera, three miles from Kanam. "These skulls," Dr. Leakey says, "represent man indistinguishable from ourselves except that they belonged to primitive types and are earlier than anything else of the sort previously found."

GOVERNMENT COMES THROUGH

In spite of the uncertainty in minds of some of our people a while back as to whether or not tobacco growers would receive benefits from the portion of this crop marketed before agreement was signed, government is to pay its benefits to these growers, which is good news.

Seeking for the Agricultural Adjustment Administration, of which he is a member, J. Con Lanier, at Greenville Friday night outlined the government's plan of action which provides benefit payments for this year's crop together with benefits on the crops for the next two years provided the growers come

through and sign the new acreage contracts now being prepared by the department. Already the growers are profiting in the way of higher prices since the government agreement was signed and now that they can get still more benefits by signing the new contract, we are sure that no time will be lost once they are given the opportunity to sign.

The plan of benefit payments outlined by Mr. Lanier shows clearly that the government meant business when it promised the growers better prices for agreeing to control acreage in future crops and now the growers may rest assured that their best bet is to keep faith with the government and see to it that these new contracts are signed and carried out.

'Good Neighbor' Aim of Hull Trip To Montevideo

By FRANK I. WELLER Washington (AP)—Peace in the Americas rather than immediate expansion of trade is expected by Washington observers to be the burden of Secretary Hull's "good neighbors" tour, which is to follow the Pan-American conference at Montevideo in December.

The American secretary of state will speak at Buenos Aires, Santiago, Antofagasta and Lima on his return trip up the west coast of South America.

Trade Pacts Sought Consumption of dual trade pacts rather than formulation of a blanket economic policy is the basic idea of the Montevideo conference's agenda. This fits the American administration's Latin-American program.

Negotiations for reciprocal tariff treaties are under way between the United States, Argentina, Brazil and Colombia. Discussions are promised with Mexico and Cuba. In these the administration is desirous of making the recovery program fit the American farm demand for greater export outlet. But since increased import demand in Latin America countries is contingent on broader markets for their products,

can countries show that eight increased their purchases of United States goods over a similar period last year during the first eight months ending August, 1933. At the same time United States purchases declined in nine of those countries. Exports to Mexico and Colombia increased approximately \$2,000,000 and \$3,000,000 respectively, while exports to Cuba decreased about 34-

000,000. Imports from Argentina jumped \$6,000,000 for the eight months, but imports from Mexico dropped \$7,000,000; from Cuba, \$6,000,000; from Venezuela, \$6,000,000; from Chile, \$5,000,000, and from Colombia, \$8,000,000.

Argentina Best Customer Argentina consistently has been Uncle Sam's best customer in Latin America, always buying more than she sold. Her purchases in 1929 ran about as far above \$200,000,000 as her sales exceeded \$100,000,000, but both fell back to around \$30,000,000 and \$20,000,000, respectively, in 1932.

The United States spent almost \$3,000,000,000 for Cuban products each year between 1921 and 1925 compared with little more than \$60,000,000 in 1932, and sales to that country contracted for around \$170,000,000 to scarcely \$30,000,000. Much of the decrease in United States sales to its Latin-American customers has been attributed to withdrawal of United States capital from enterprises developing natural resources of Latin American countries as a result of stagnated world markets.

'Hello, Eare — Universe Calling!'

By HOWARD W. BLESKELEE (Associated Press Science Editor) Holmdel, N. J.—(AP)—A new dream of obtaining power from the stars of the milky way is opened to scientists in the form of radio waves streaming endlessly across space from a source seemingly about 46,000 light-years distant from the earth.

These star rays, electro-magnetic impulses, of a wave length of 14.6 meters, have been identified definitely for more than a year on a receiving set operated here by Karl G. Jansky of the Bell laboratories. These electrical waves might be considered in the light of a potential celestial "power line."

His Indication When Mr. Jansky turns a sensitive directional antenna toward the milky way, the incoming waves show their presence in a faint hiss. This sound increases distinctly if the antenna is pointed south about half way down to the horizon.

This southern point is directly in line with the center of our universe. Off in that direction, 40,000 light-years away, lies a mysterious gravitational hub much of it veiled from telescopes by clouds of dust and gas. A third idea is that the hiss picked up at Holmdel is a secondary radio wave set up in the earth's atmosphere when star radiations strike the ionized layer of air which canopies the entire earth at altitudes of 100 to 300 miles.

CHILD MARRIAGES BARRED BY AUSTRALIAN PROVINCE

Sydney, Australia.—(AP)—The present law which permits girls in New South Wales to marry at the age of 12 and boys at the age of 14 is about to be altered.

The minister of justice proposes to make the minimum age 16 years in each case.
